FIG. 4 is an end view thereof.

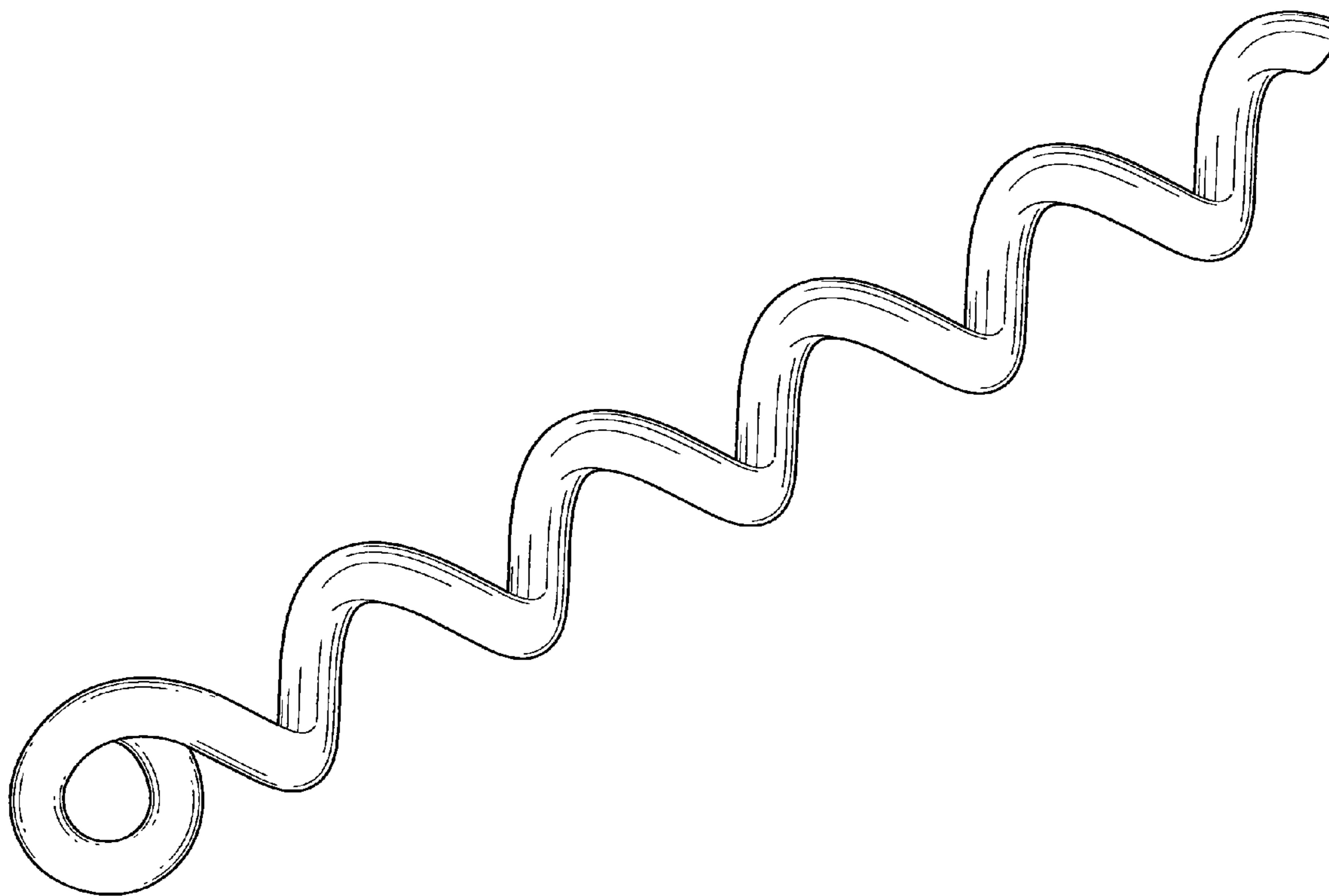
FIG. 5 is an end view thereof.

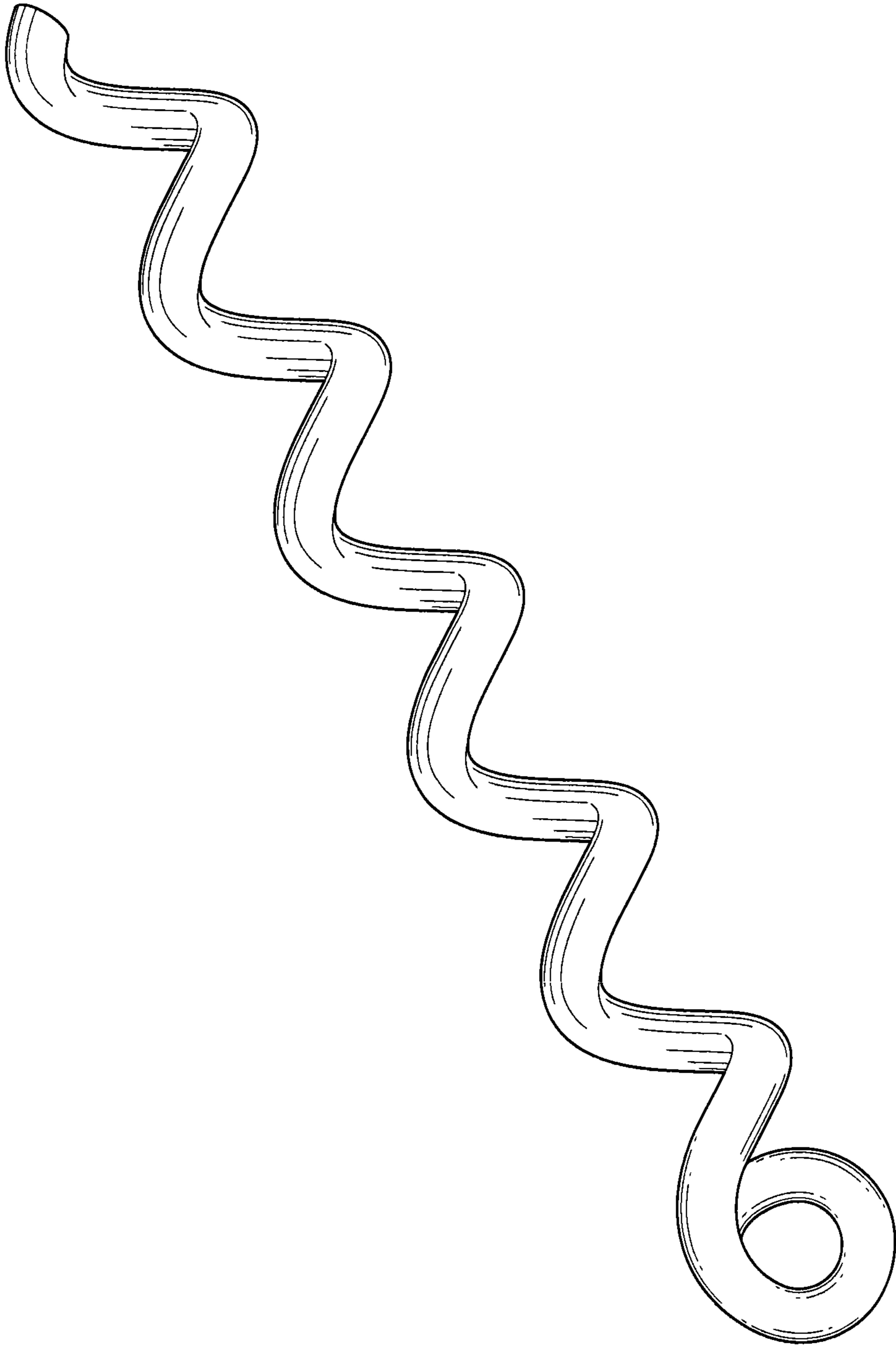

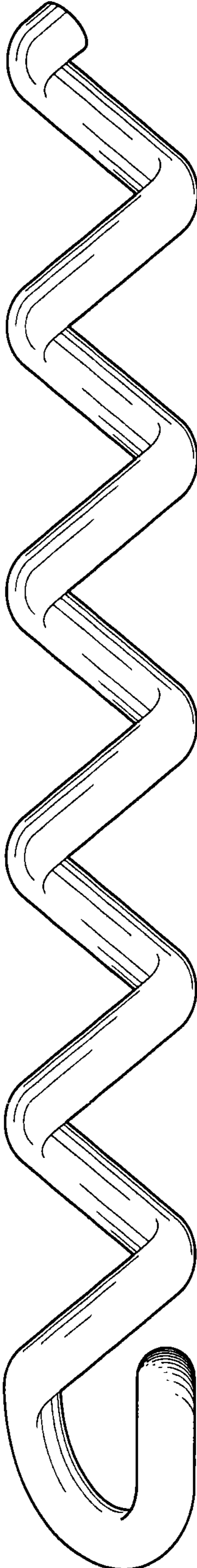

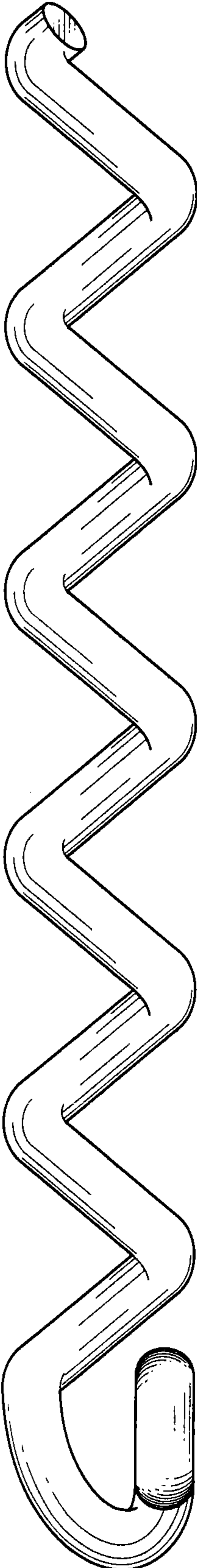

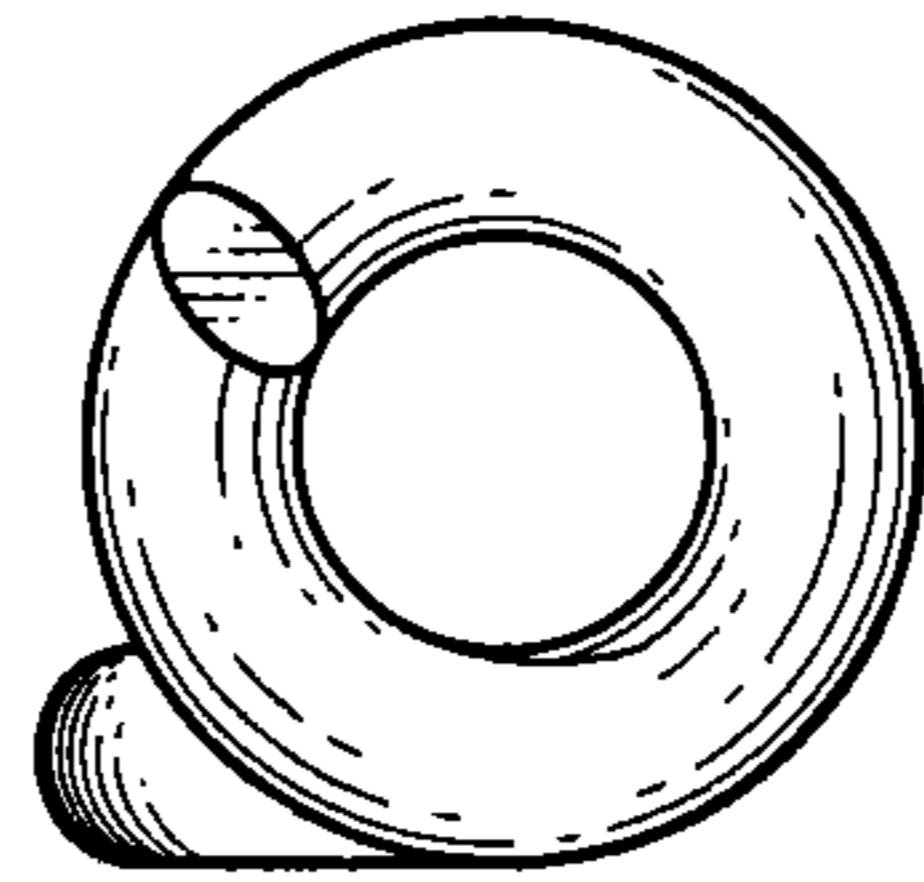

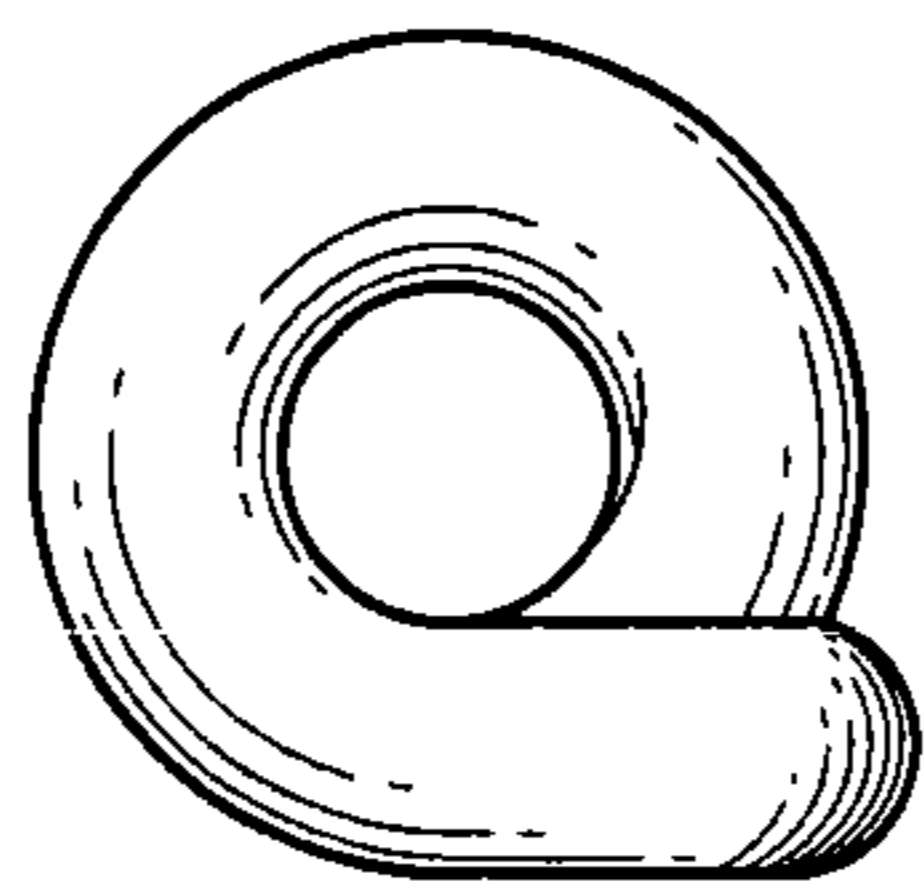

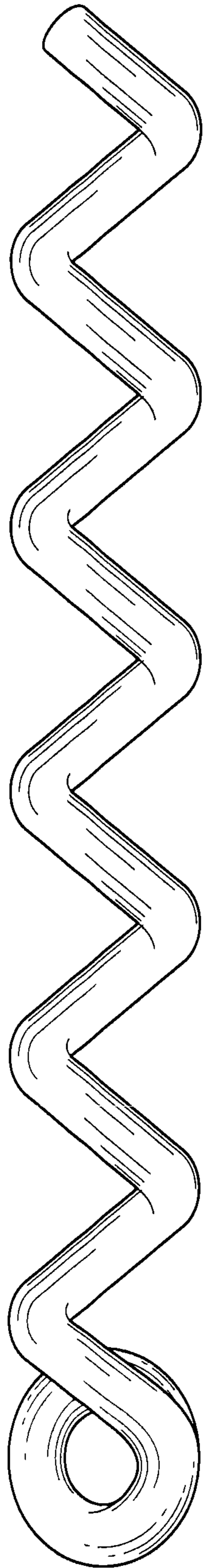

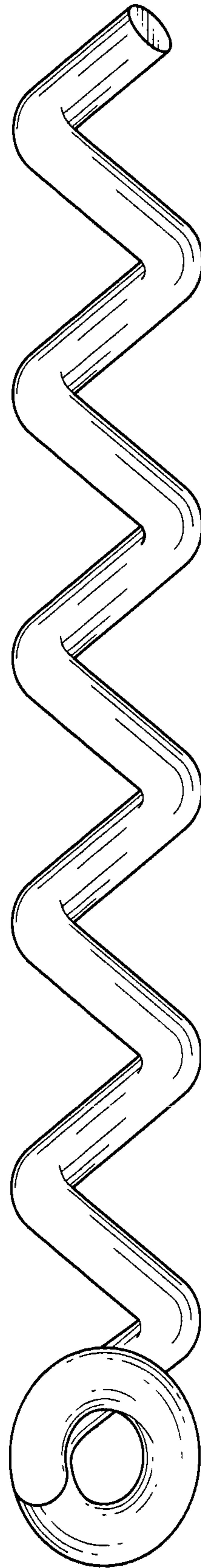
