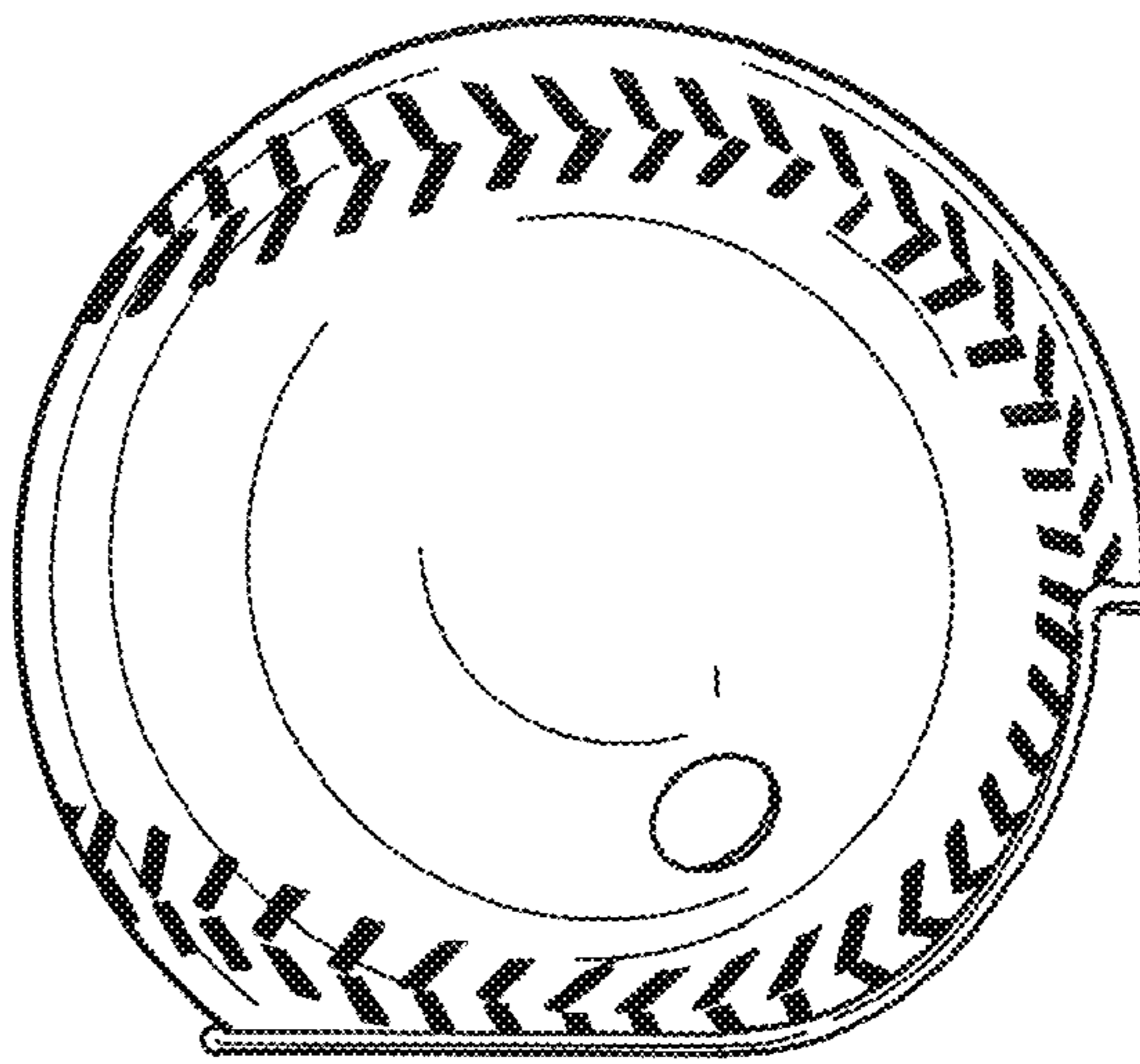
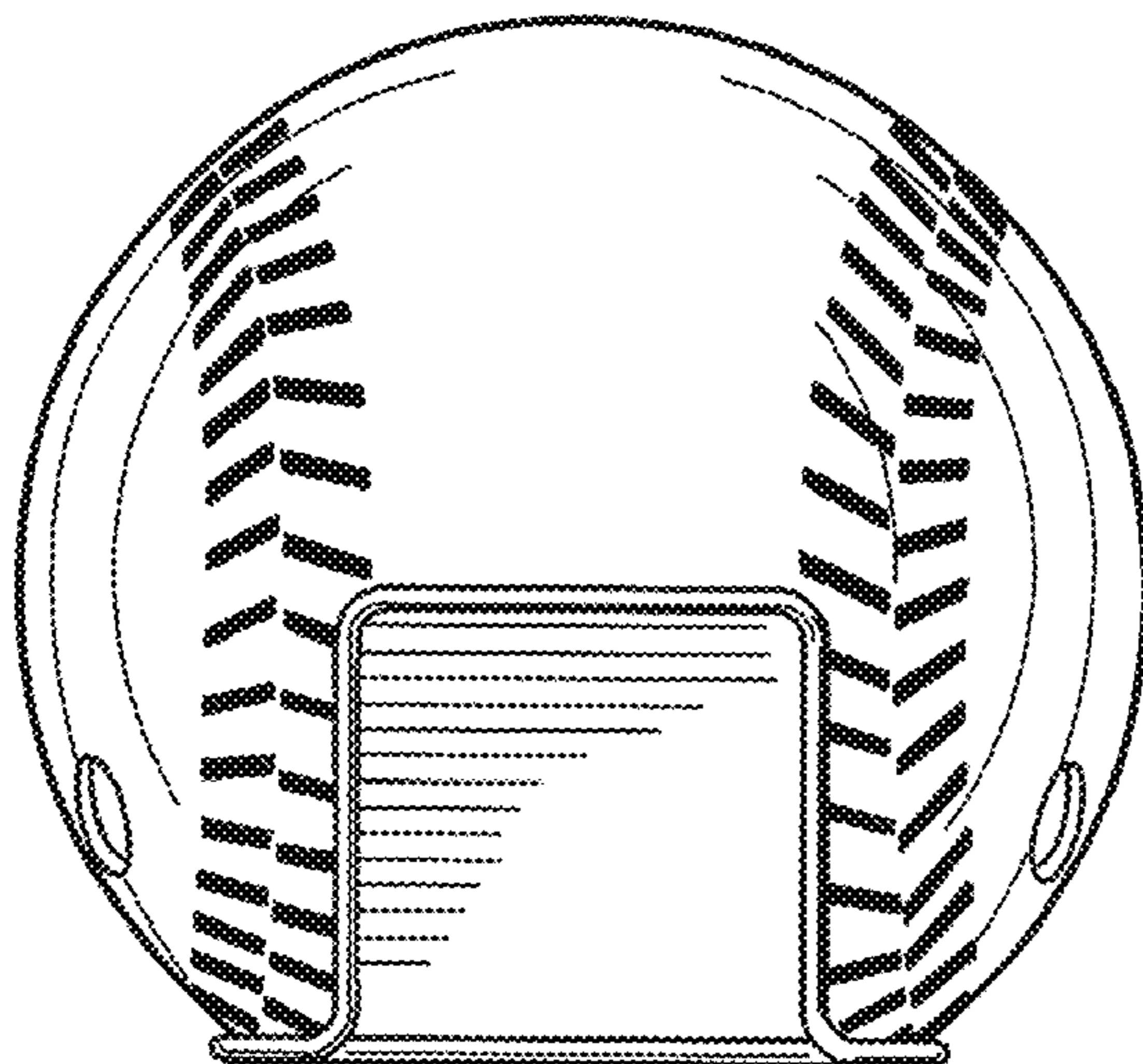
(57) **CLAIM**

The ornamental design for a baseball-simulative novelty headwear, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the baseball-simulative novelty headwear showing my new design;
FIG. 2 is a top plan view, thereof;
FIG. 3 is a left side elevation view, thereof, the partial human figure shown in broken lines representing environmental subject matter forming no part of the claimed design;

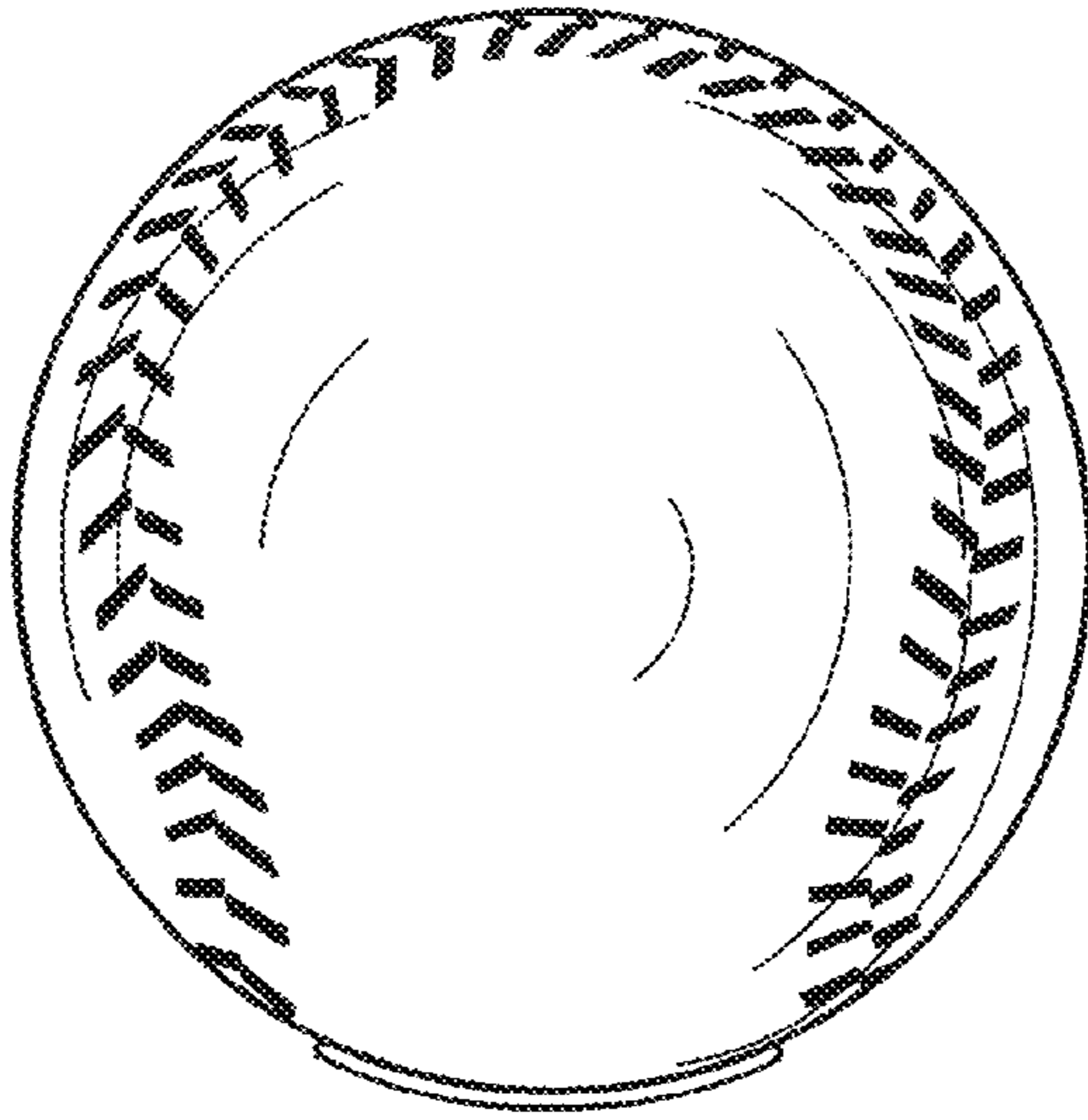

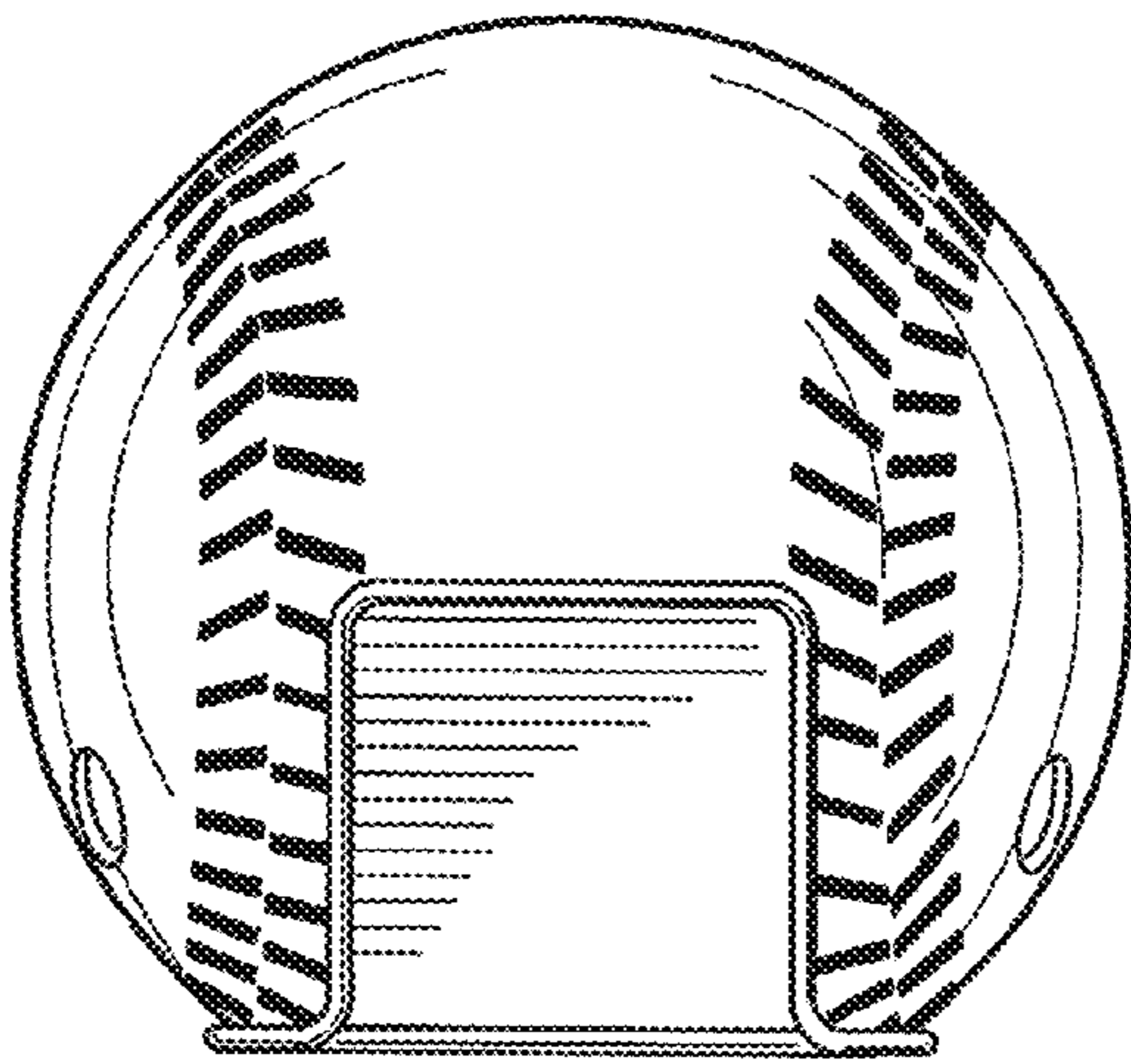

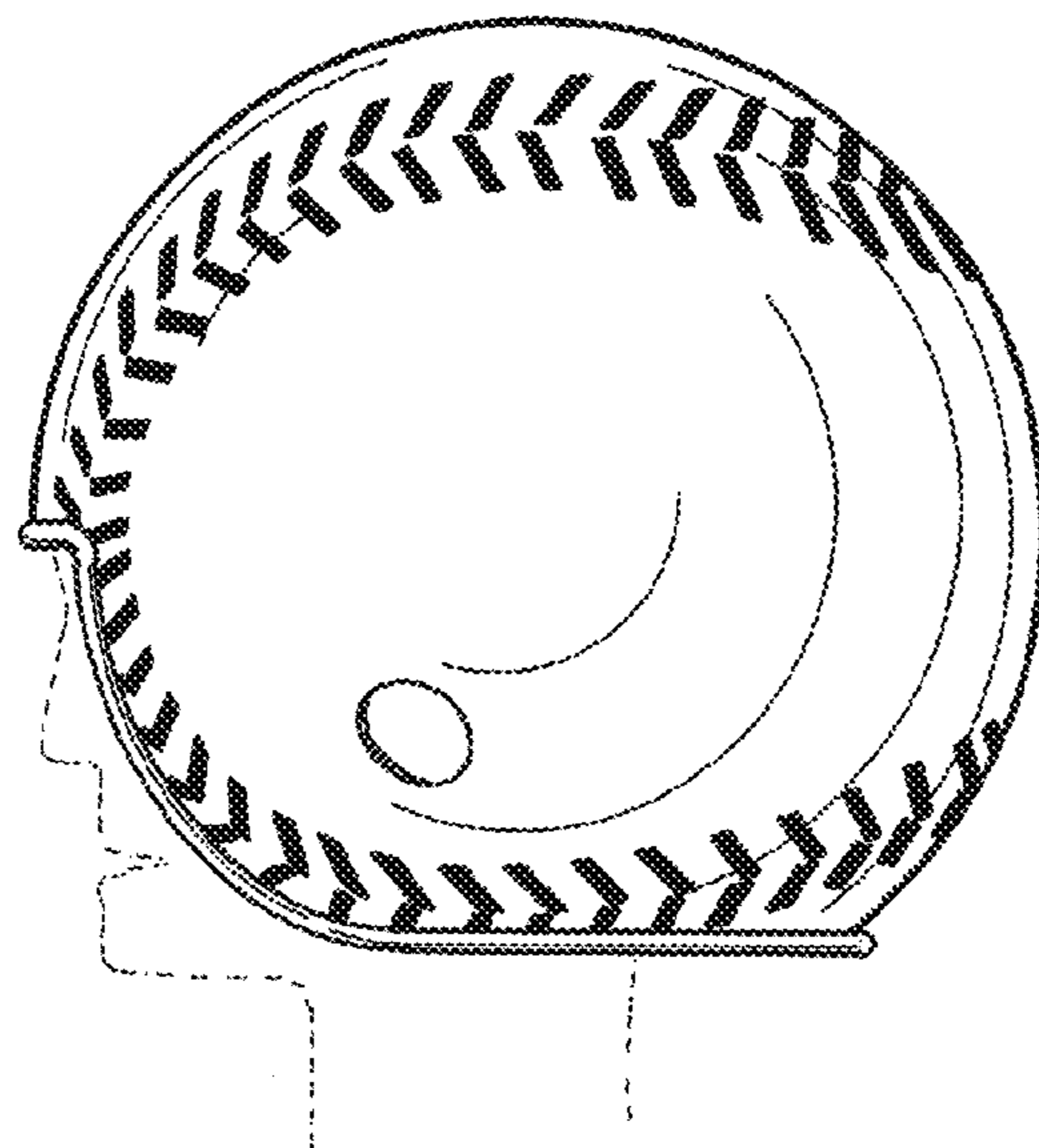

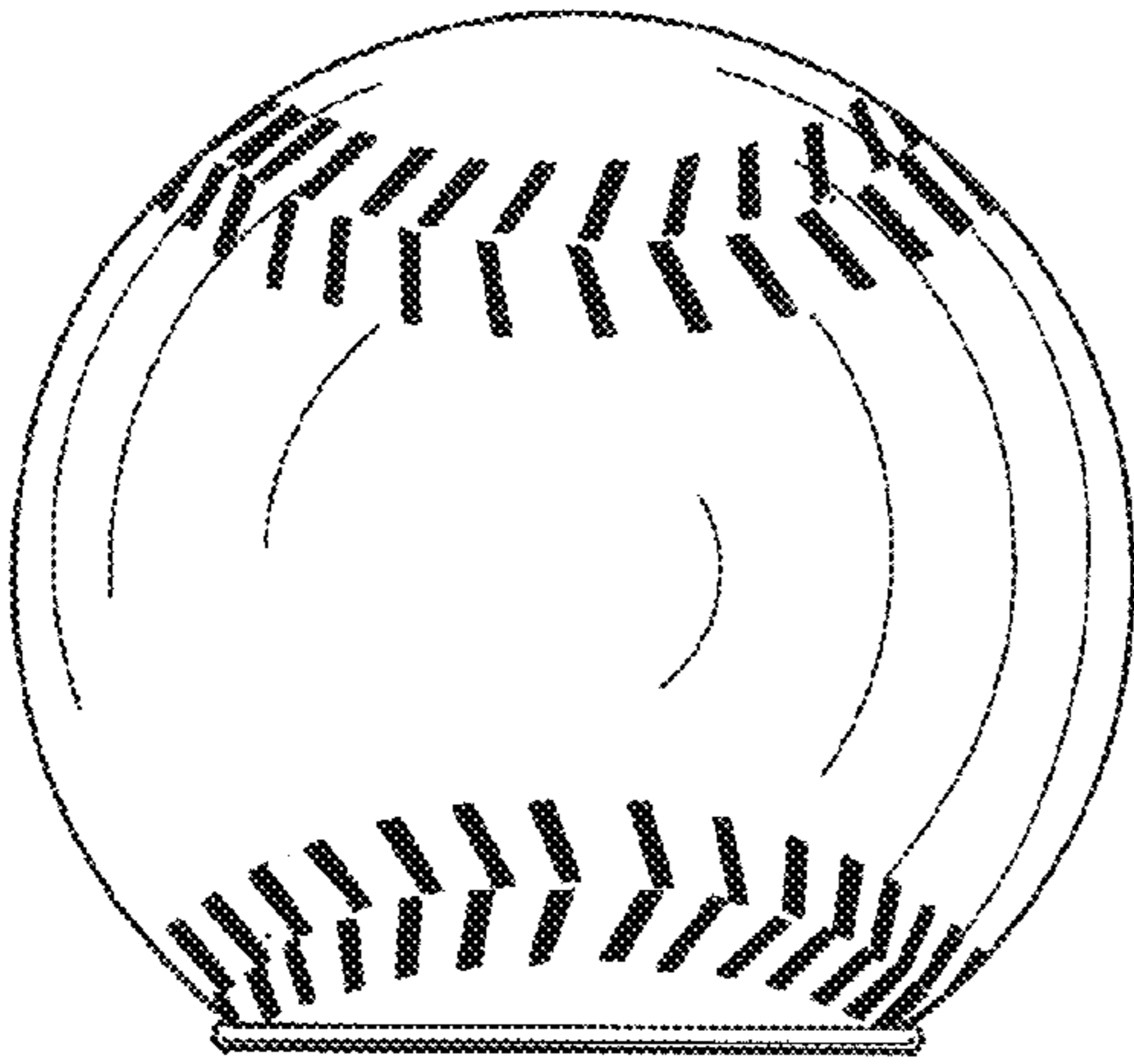

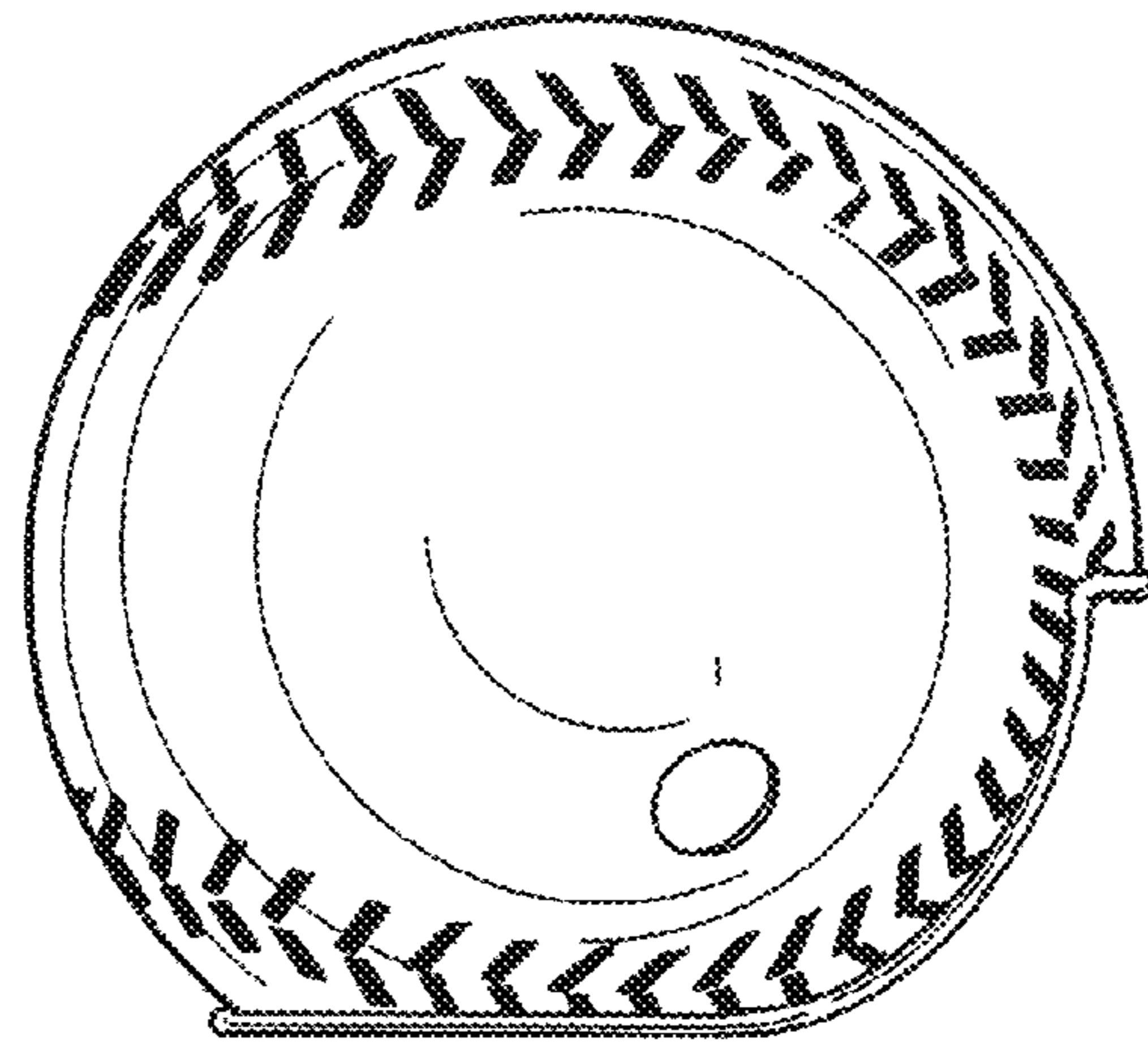

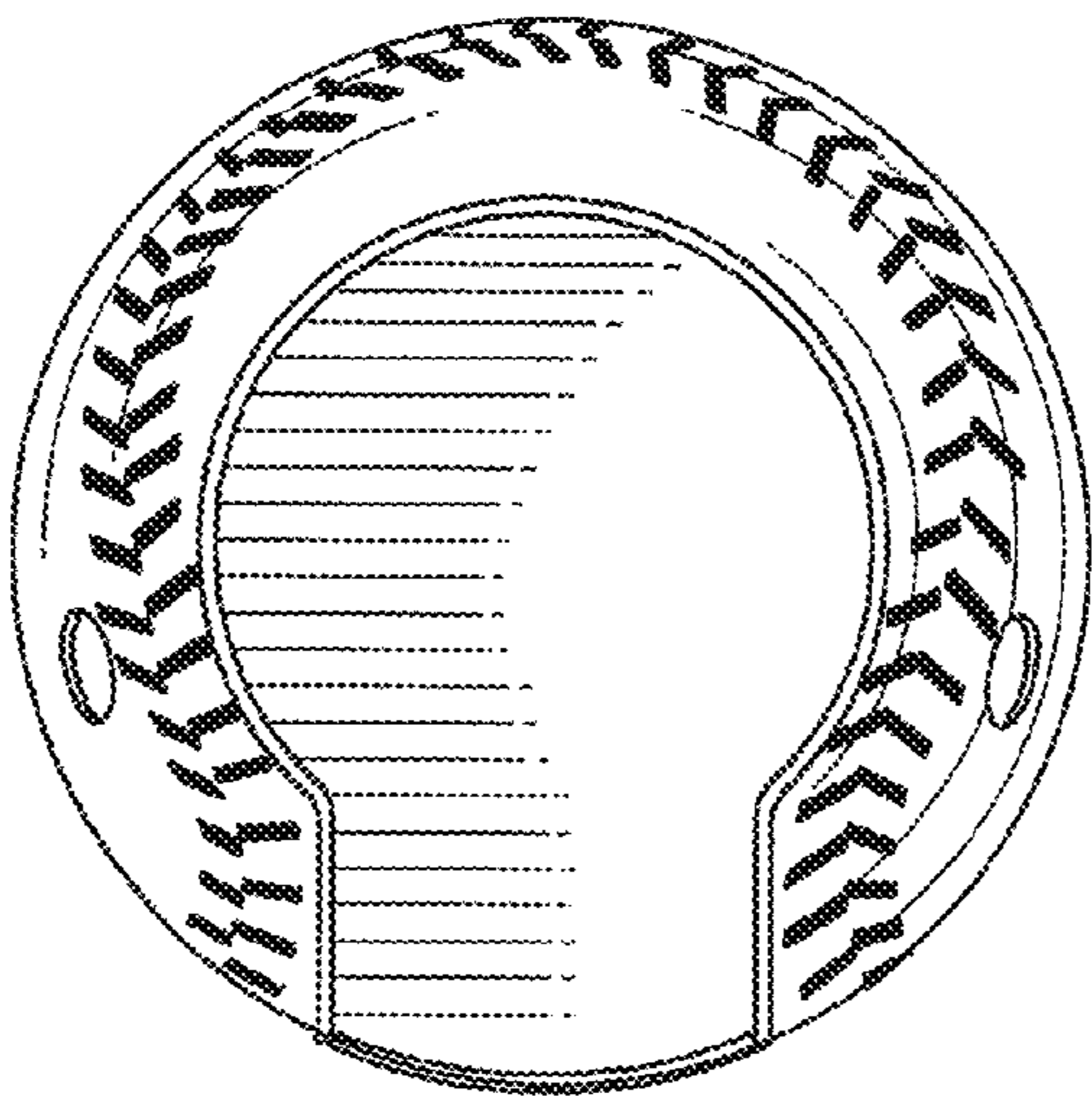
