FIG. 3 is a rear view of the football shaped hat design of the present invention.

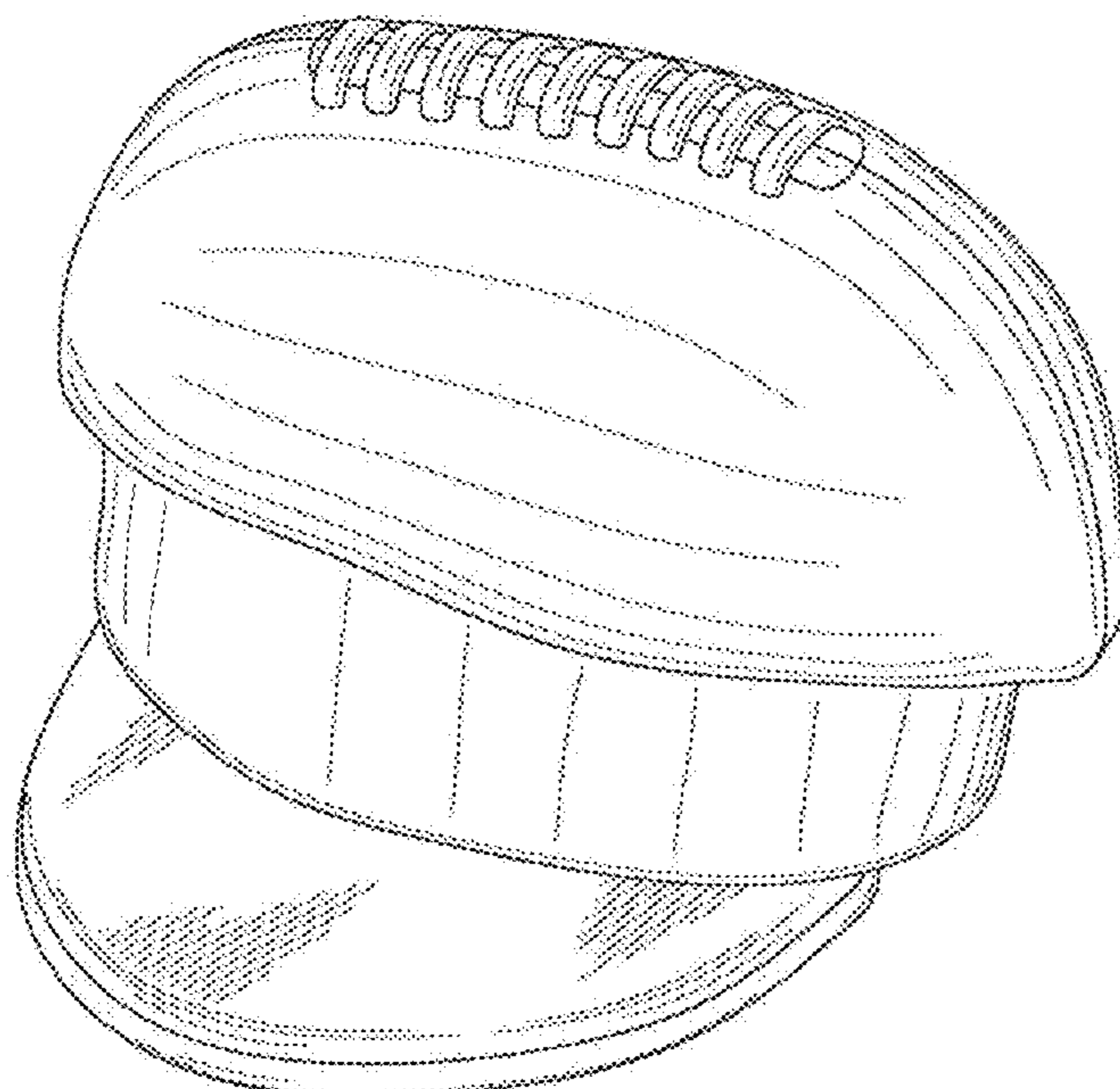
FIG. 4 is a top view of the football shaped hat design of the present invention.

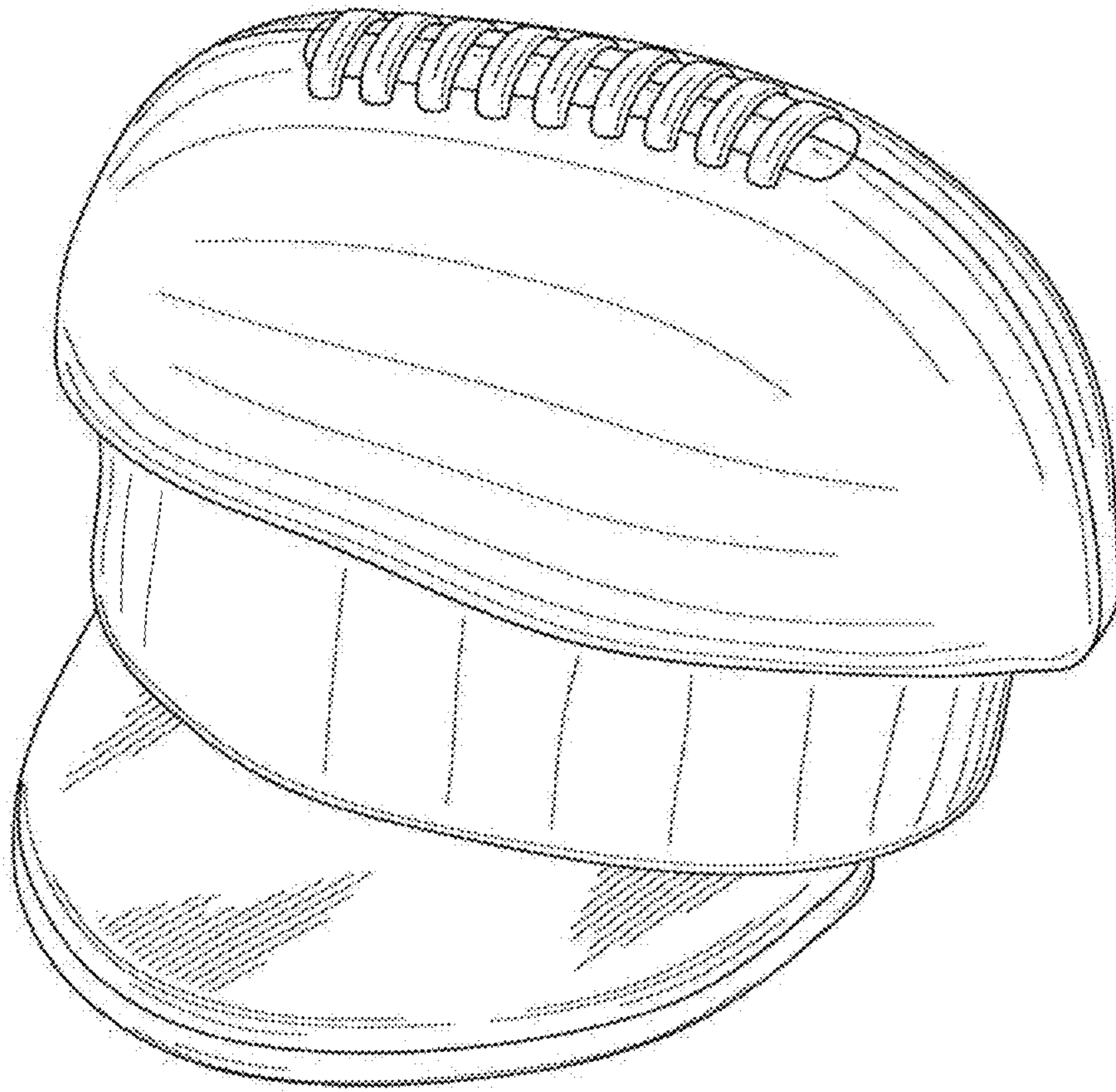

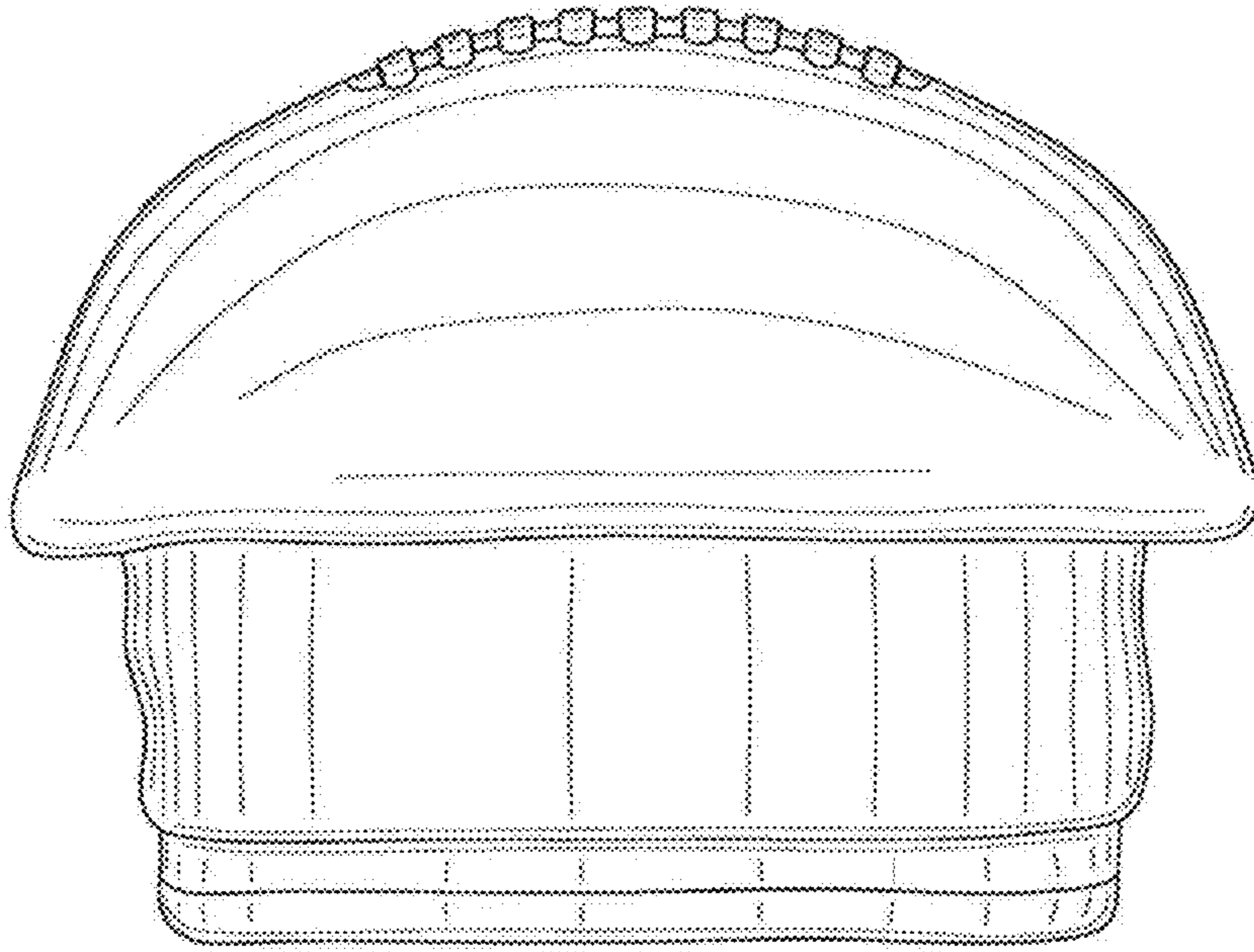

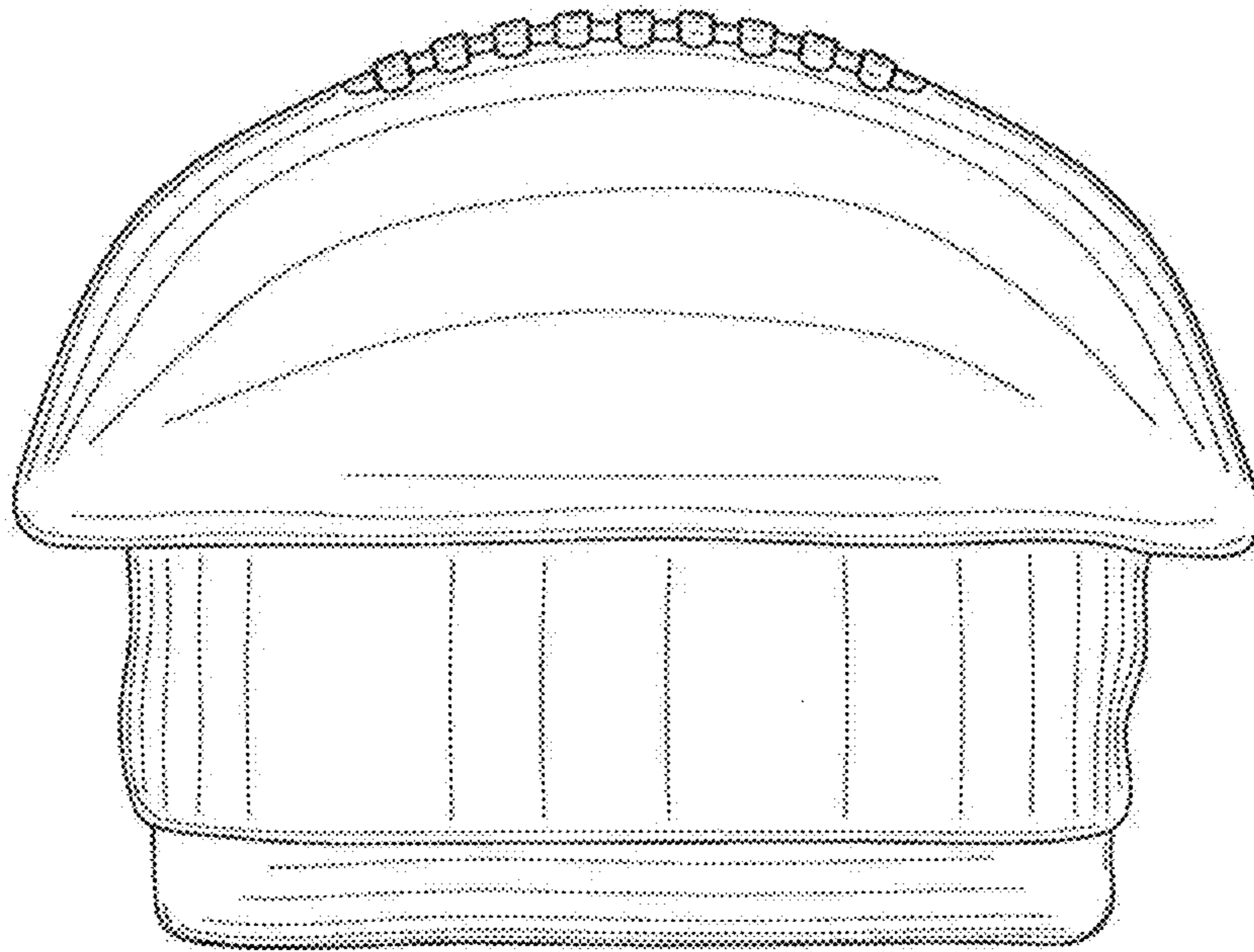

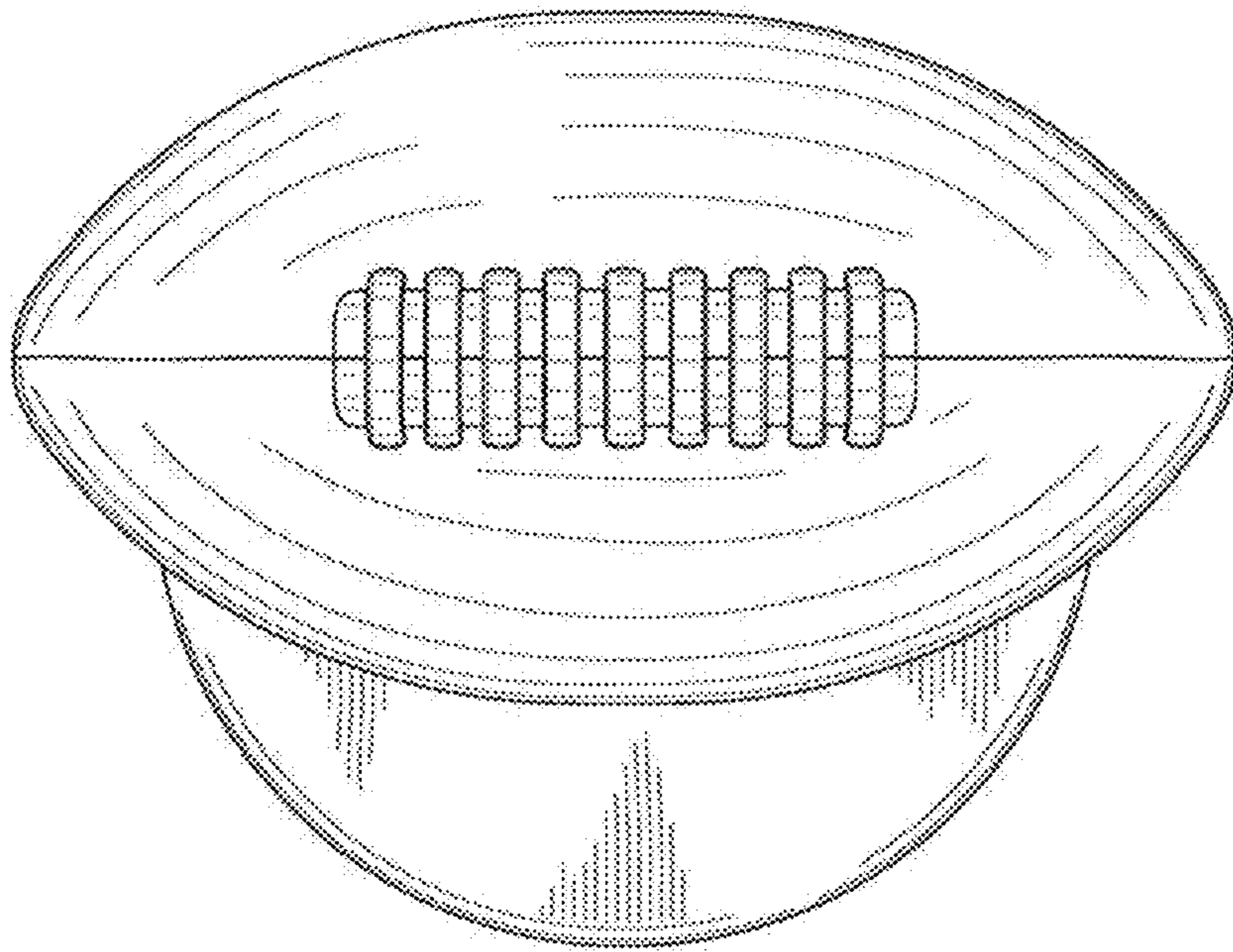

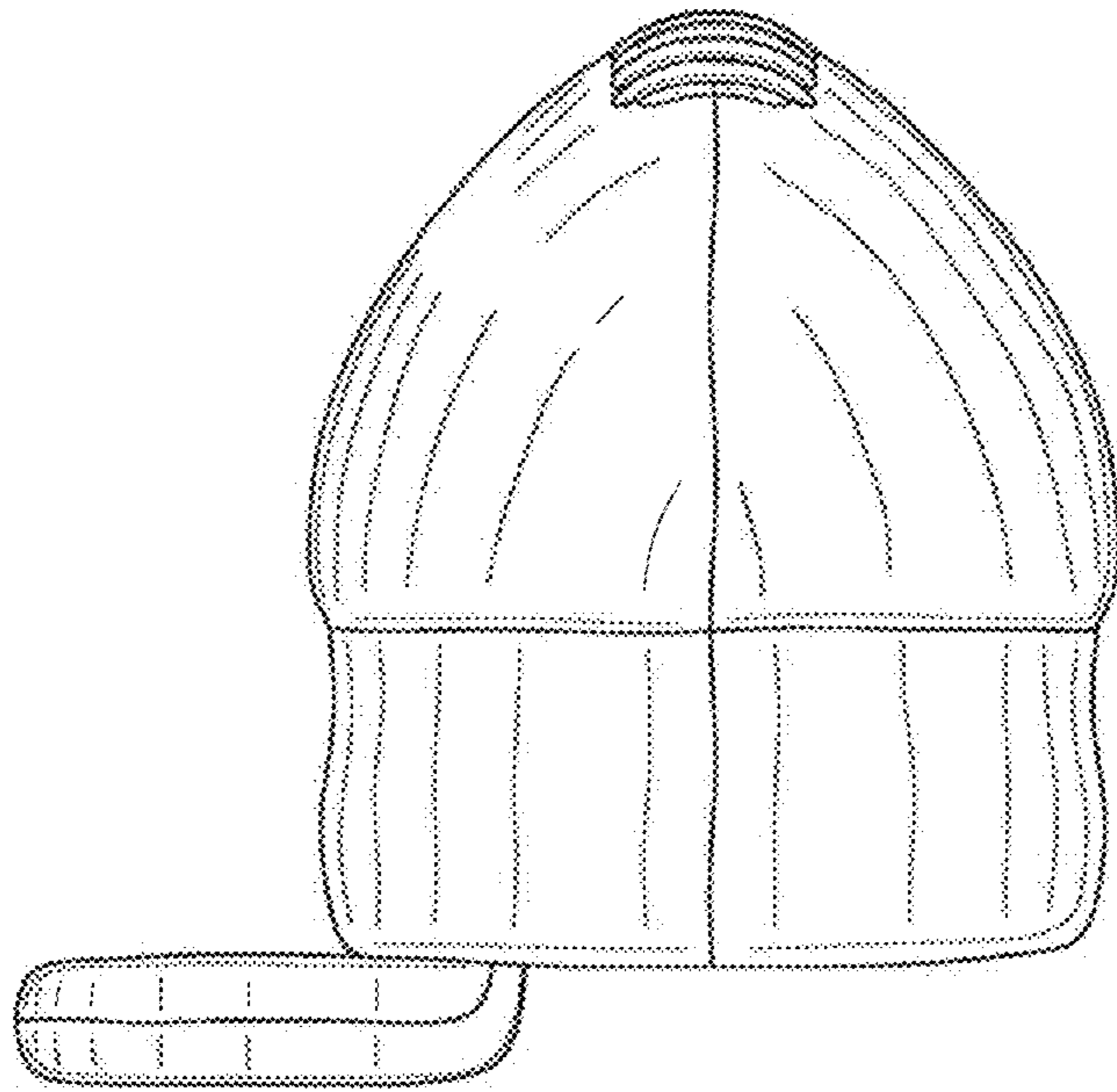

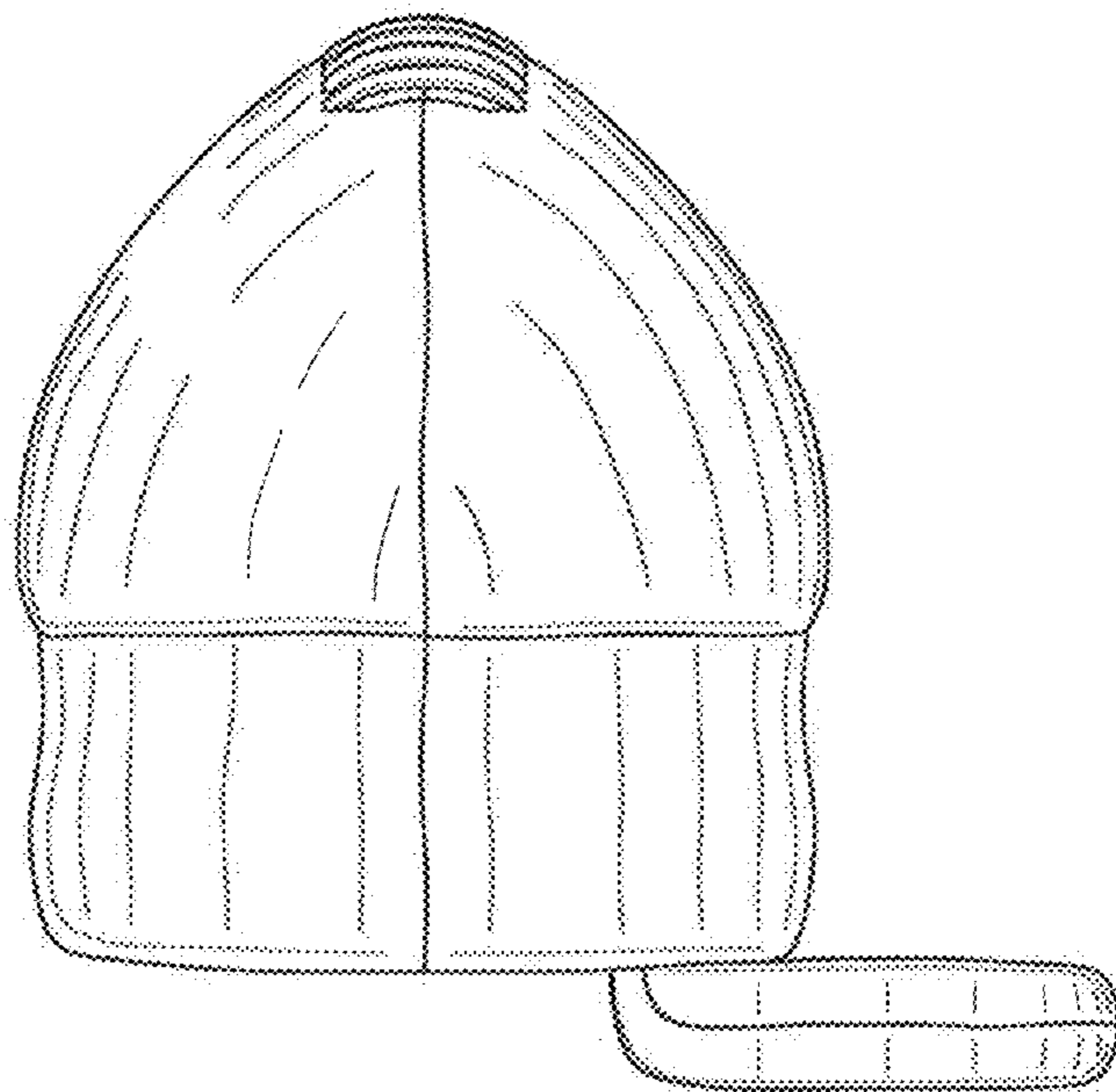

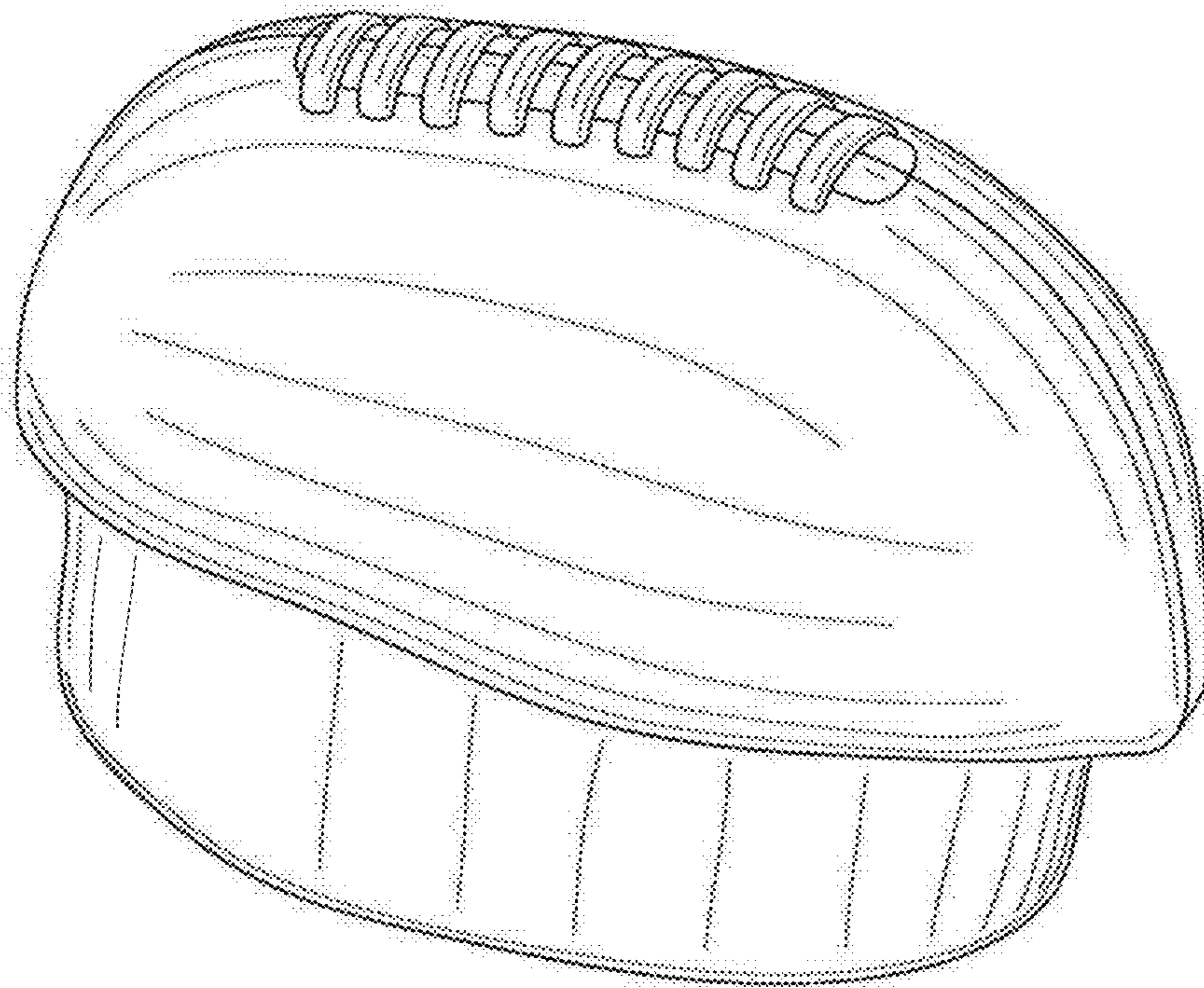
