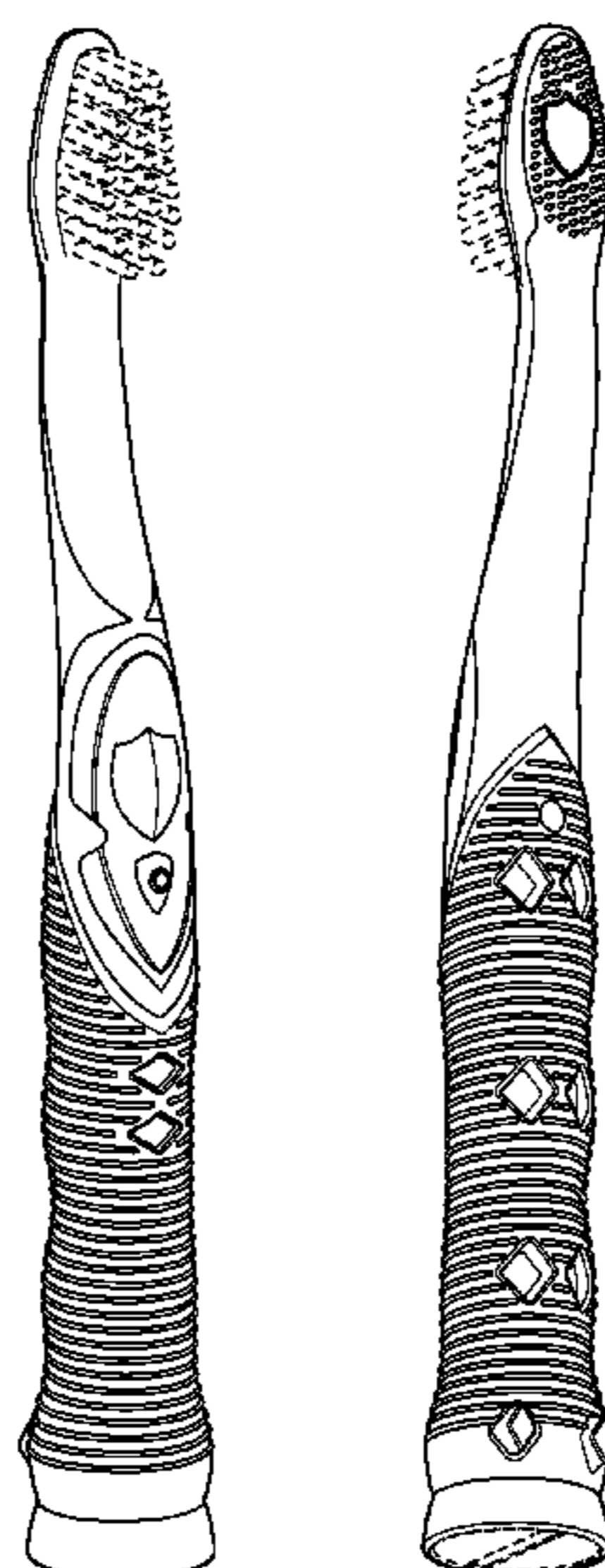
(57) **CLAIM**

The ornamental design for an oral care implement, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of an oral care implement according to the new design;
FIG. 2 is a left front perspective view thereof;
FIG. 3 is a right rear perspective view thereof;
FIG. 4 is a left rear perspective view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a rear view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is a left side view thereof;
FIG. 9 is a top view thereof; and,
FIG. 10 is a bottom view thereof.
The dash-dot-dash broken line shown in FIGS. 3, 4, and 10 represents the bounds of the claim and forms no part thereof and the dashed broken lines illustrate portions of the oral care implement that form no part of the claimed design.

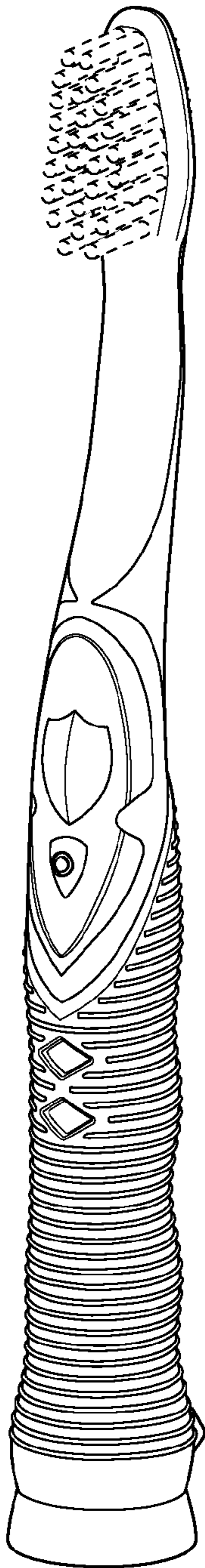

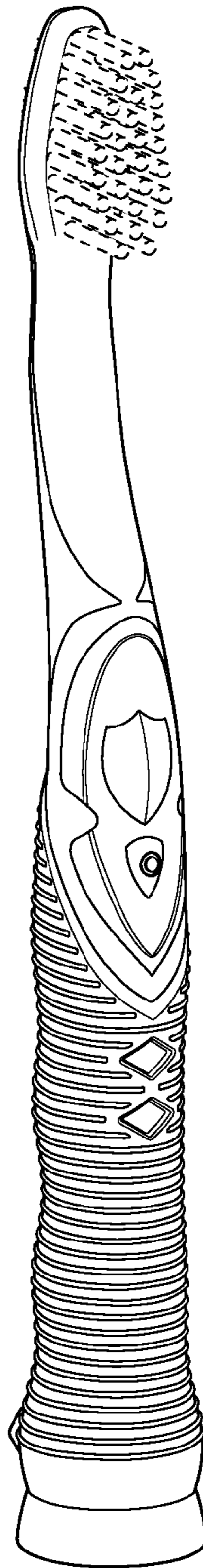

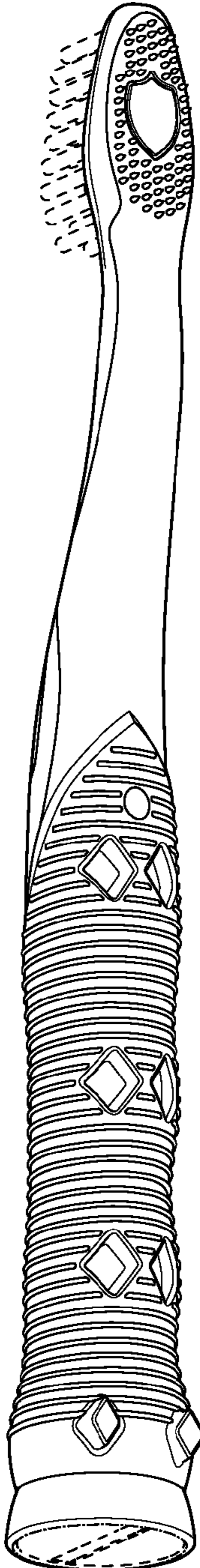

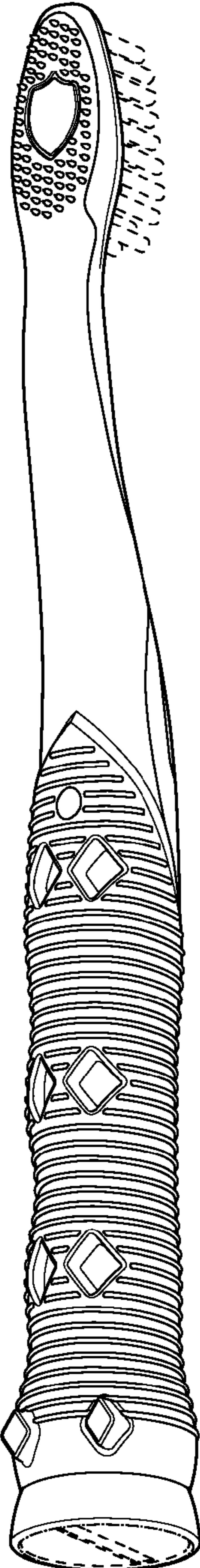

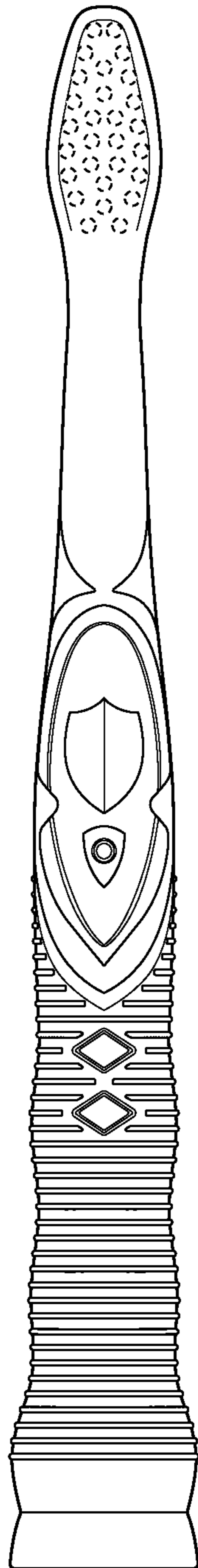

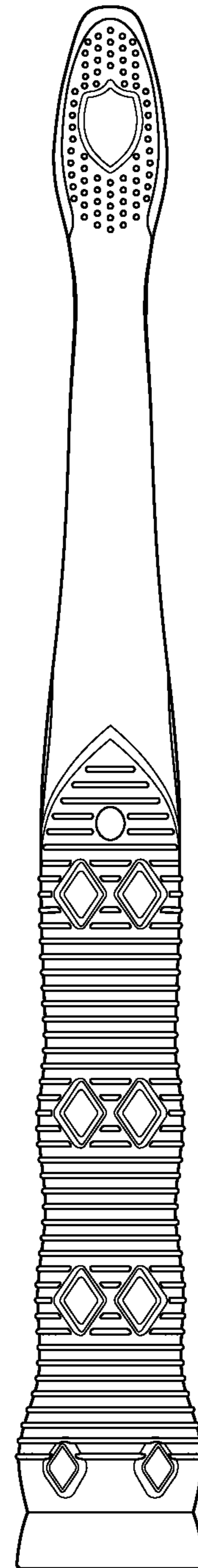

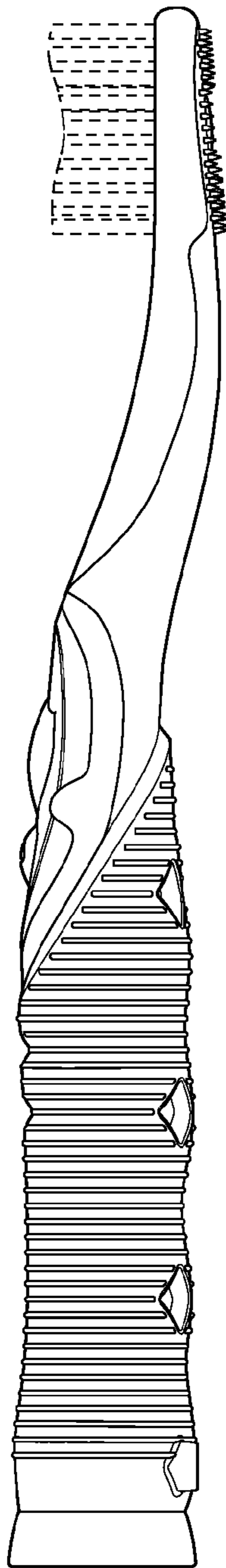

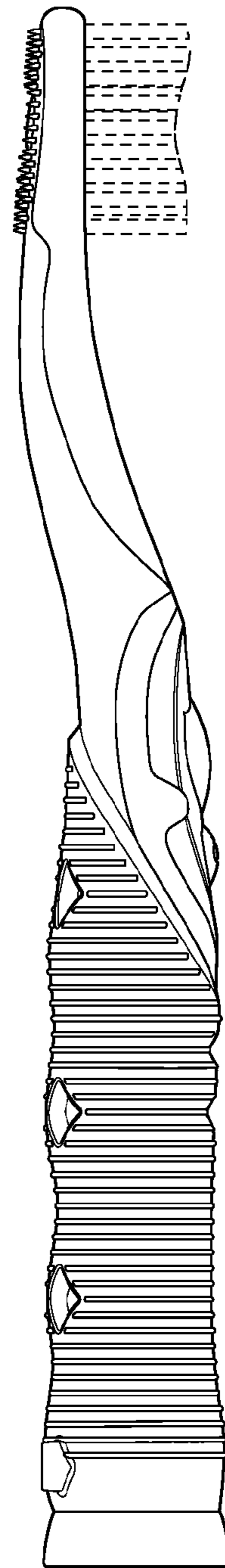

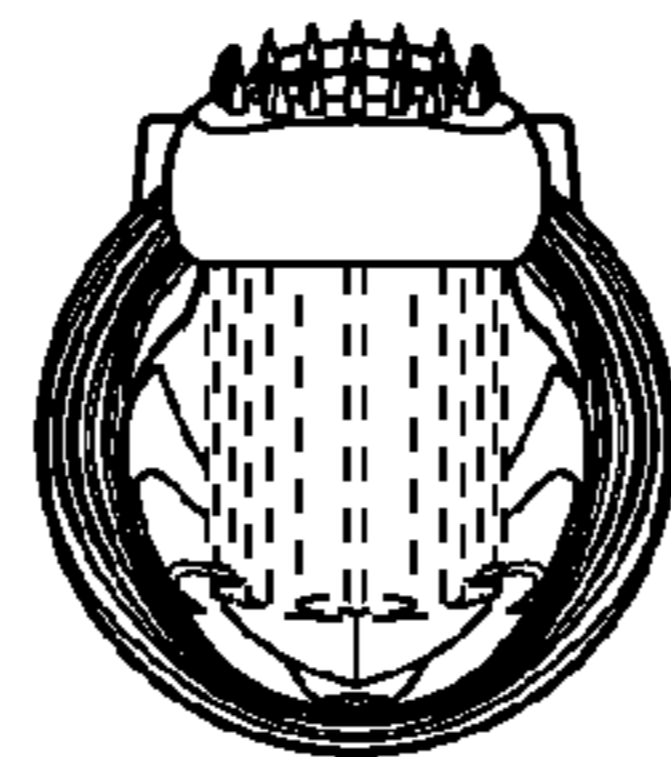

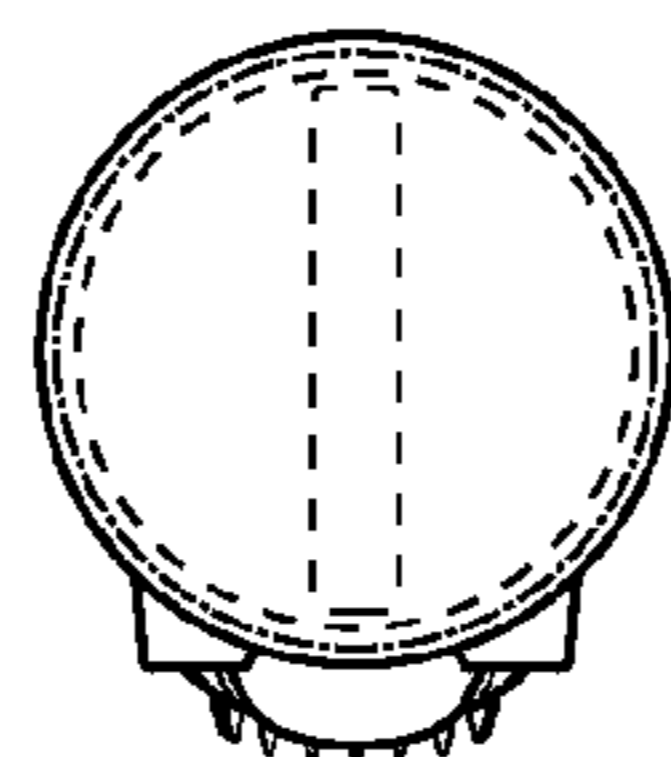
