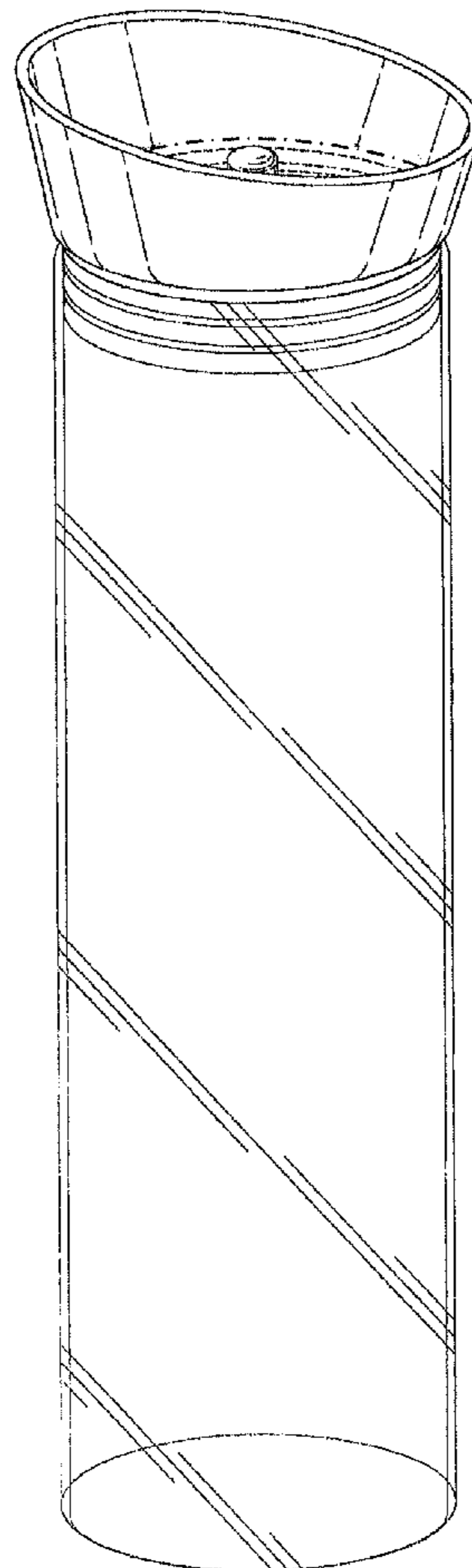
(57) **CLAIM**

The ornamental design for decanter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the decanter;  
FIG. 2 is a right side view of the decanter; the left side being symmetric and therefore not shown;  
FIG. 3 is a rear view of the decanter;  
FIG. 4 is a front view of the decanter;  
FIG. 5 is a top view of the decanter; and,  
FIG. 6 is a bottom view of the decanter.  
The broken lines are included for illustrative purposes only.  
The dot-dash-dot line represents the boundary of the claim.

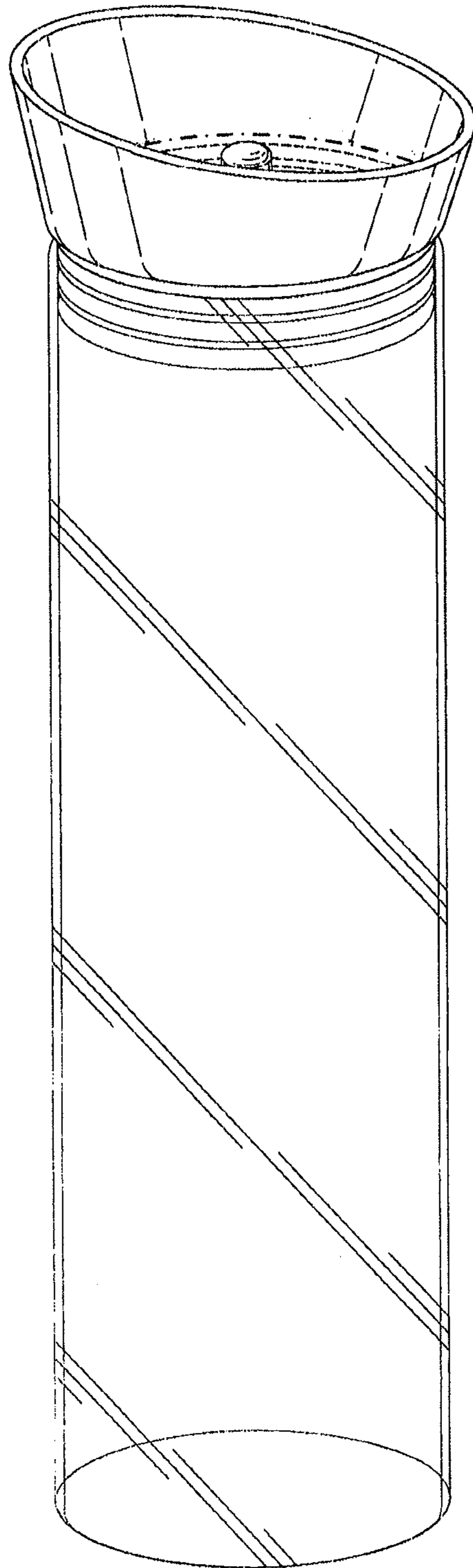

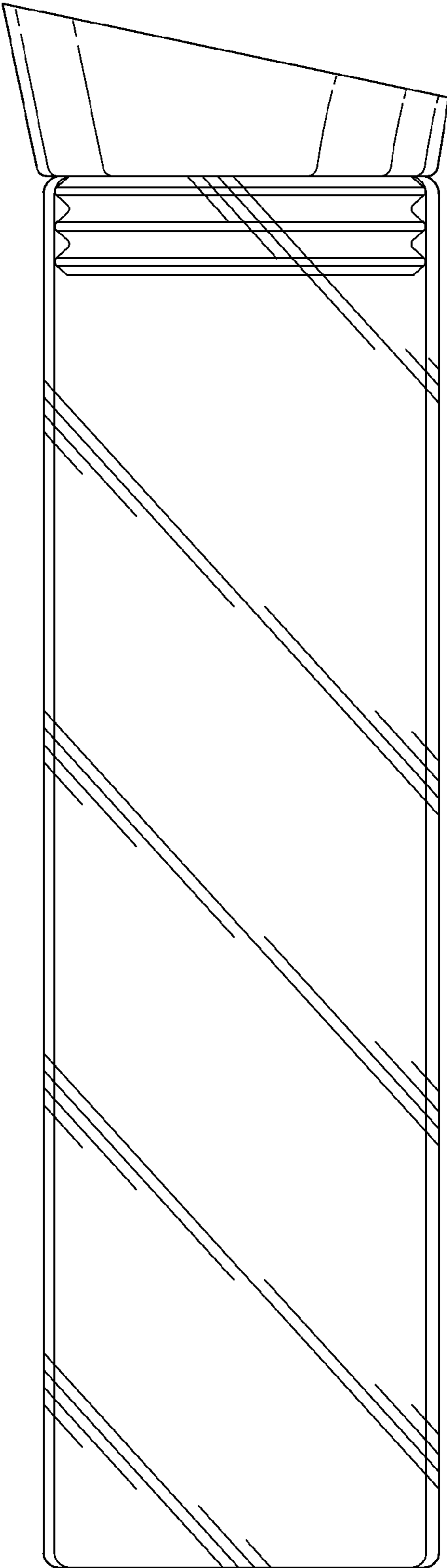

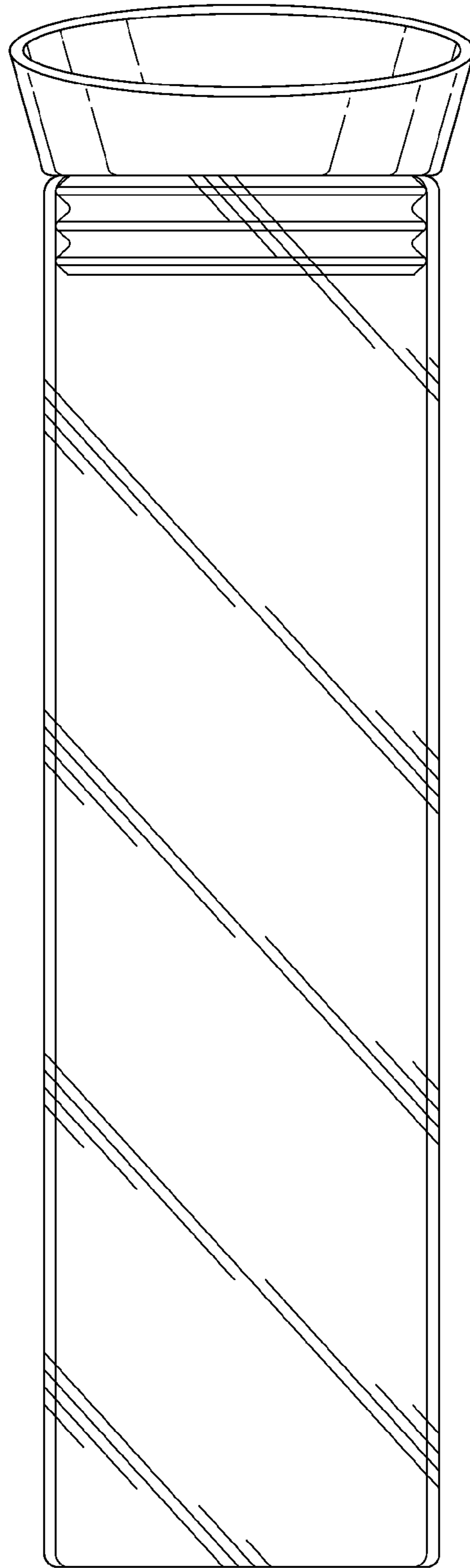

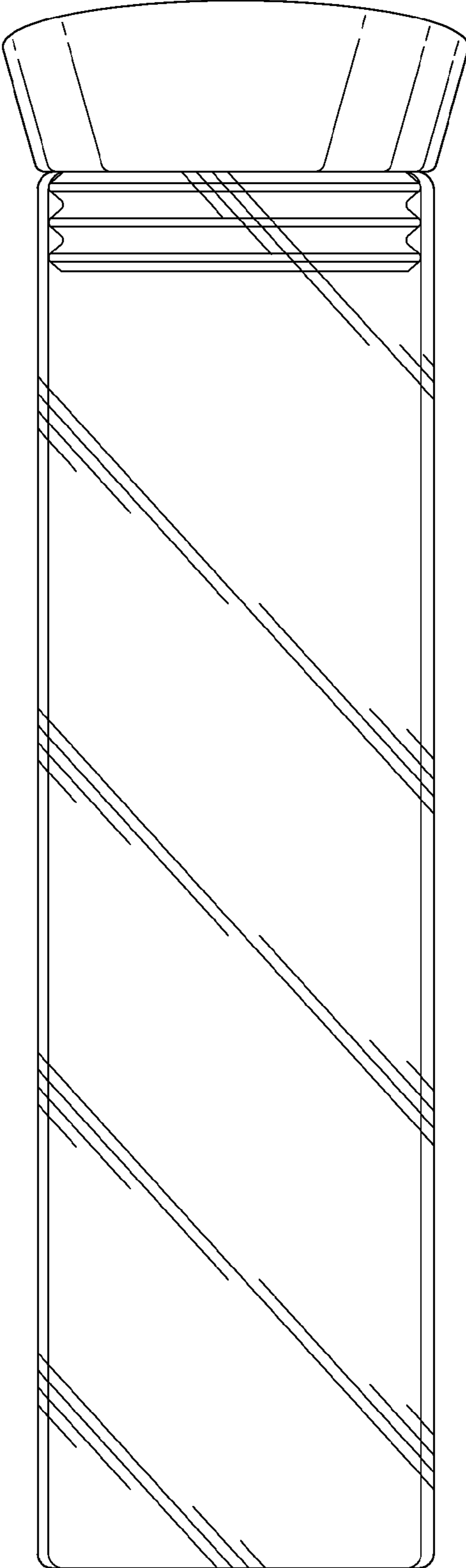

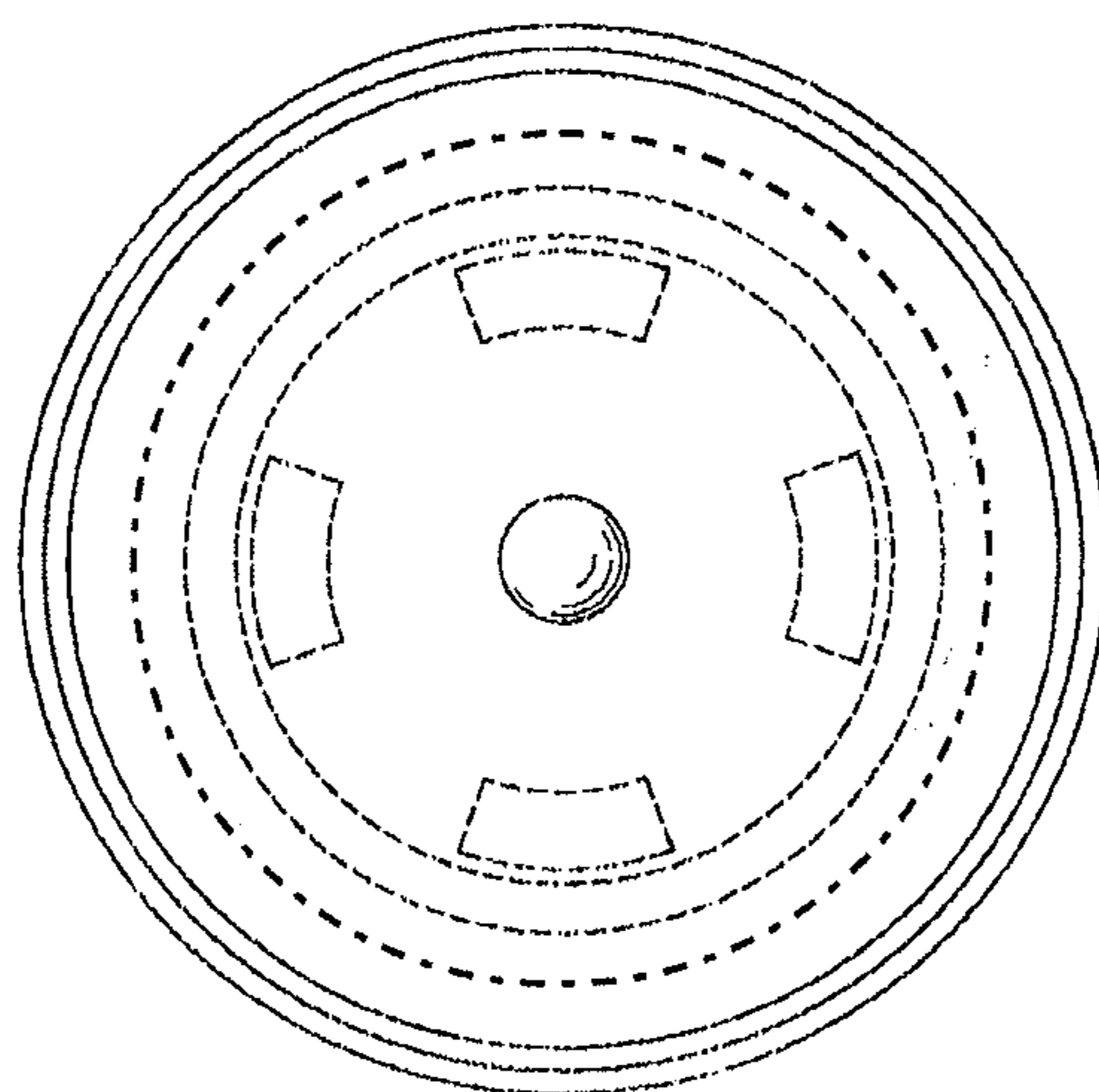

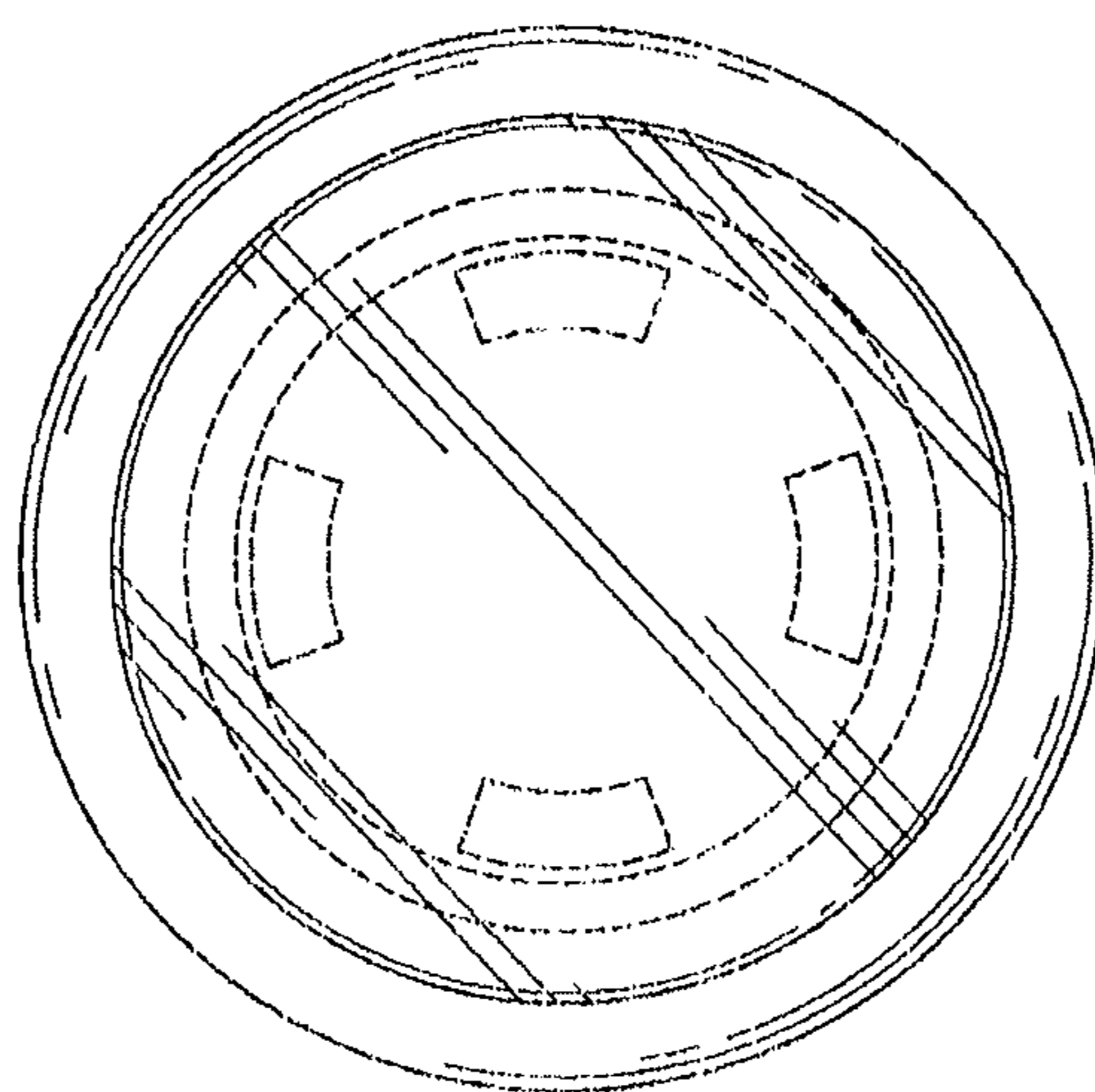
