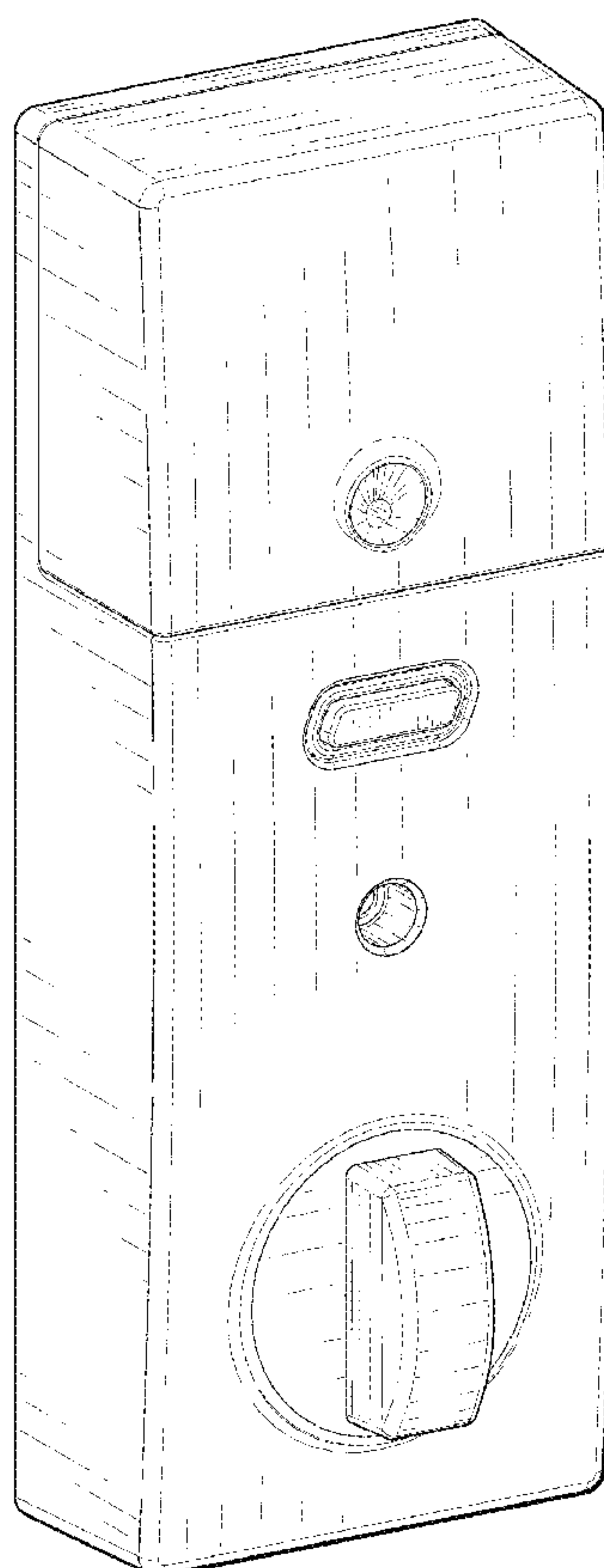
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an upper-left perspective view of a century elec-
tronic lock interior escutcheon showing our new design;

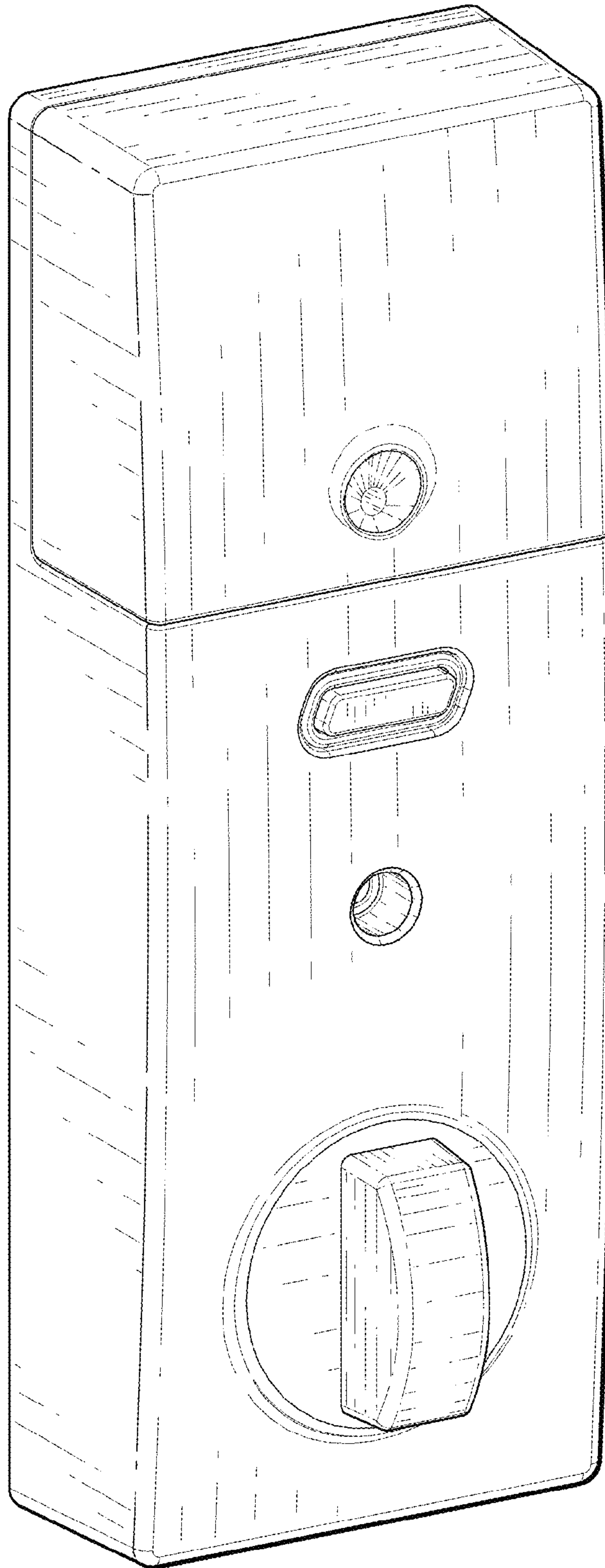

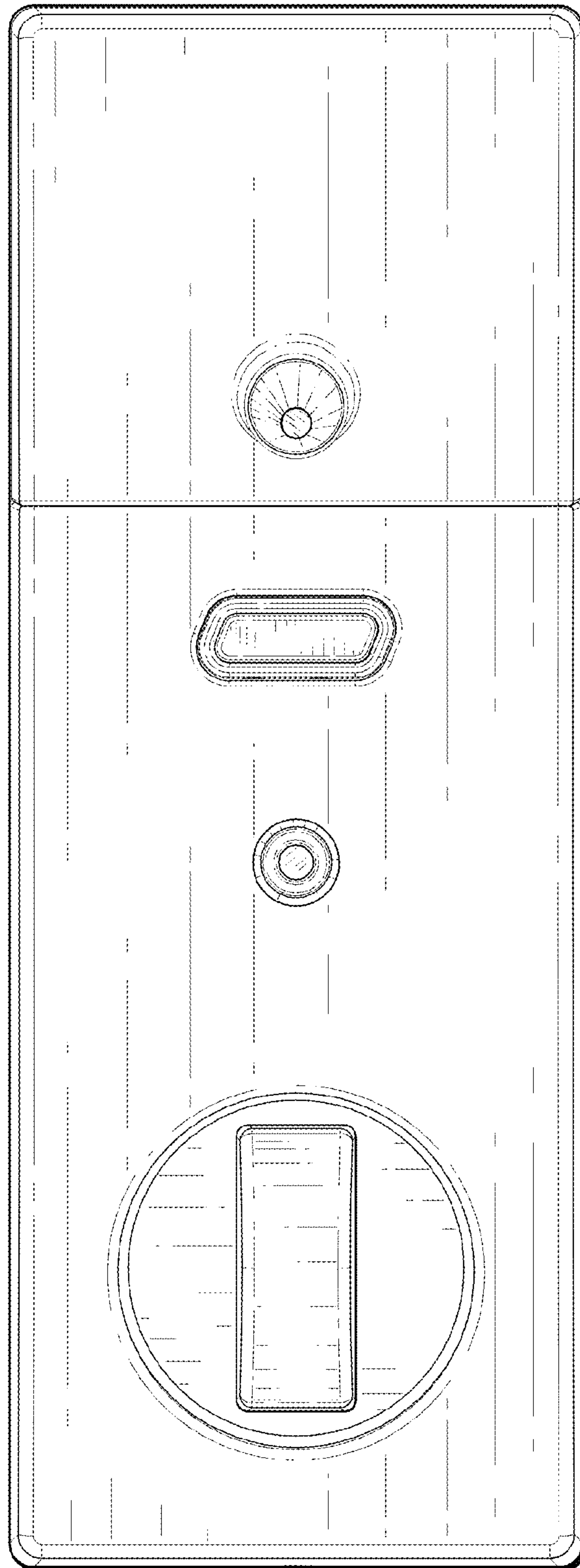

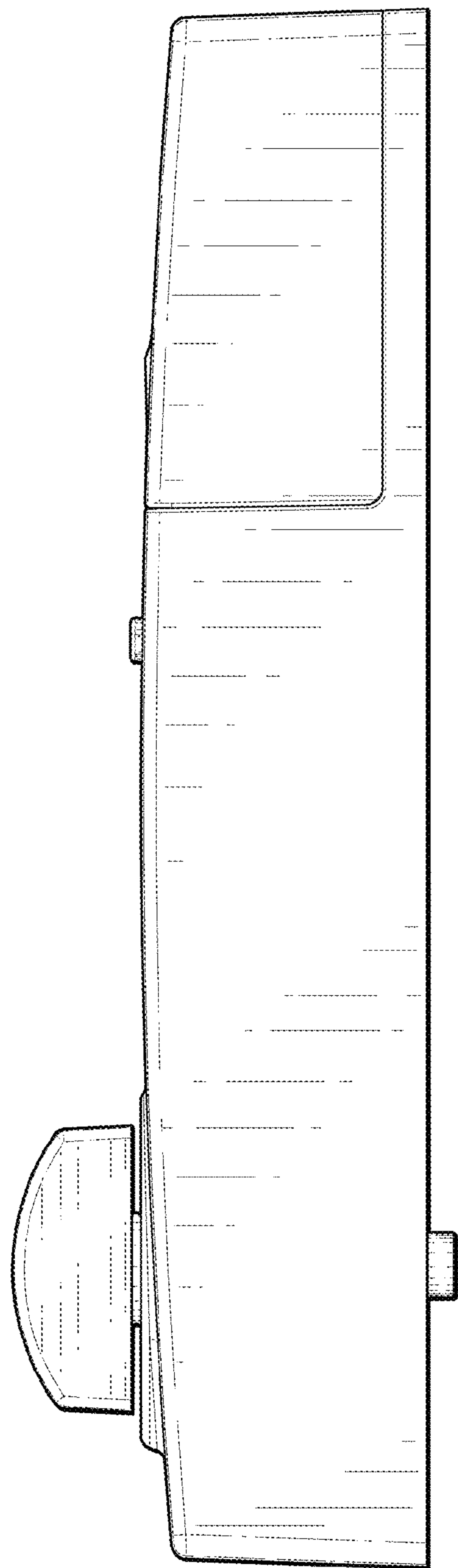

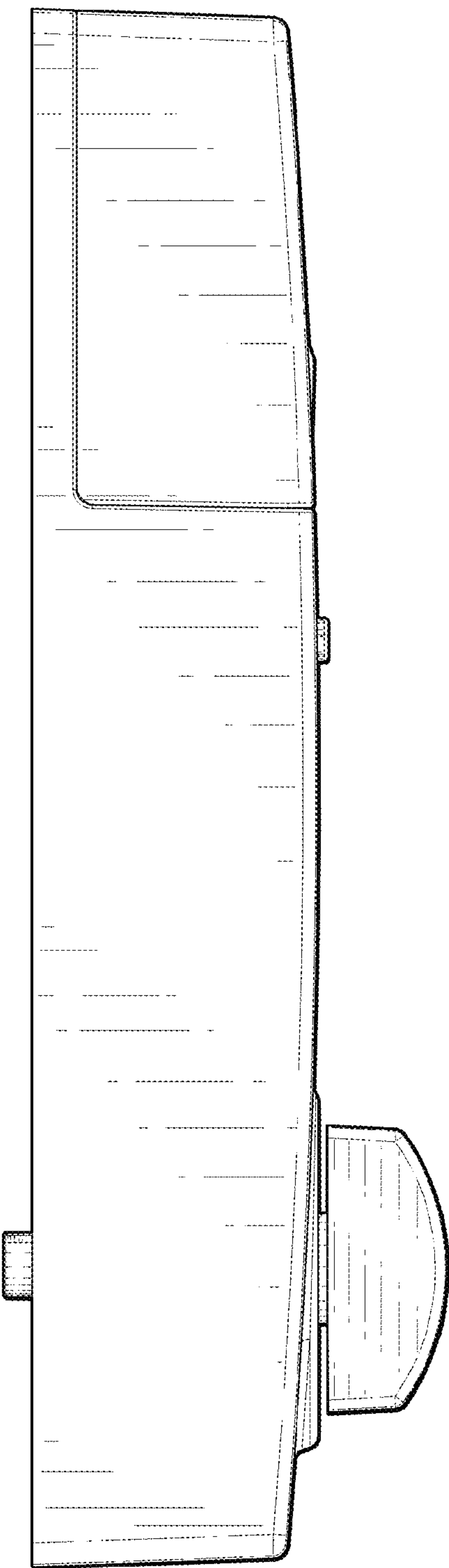

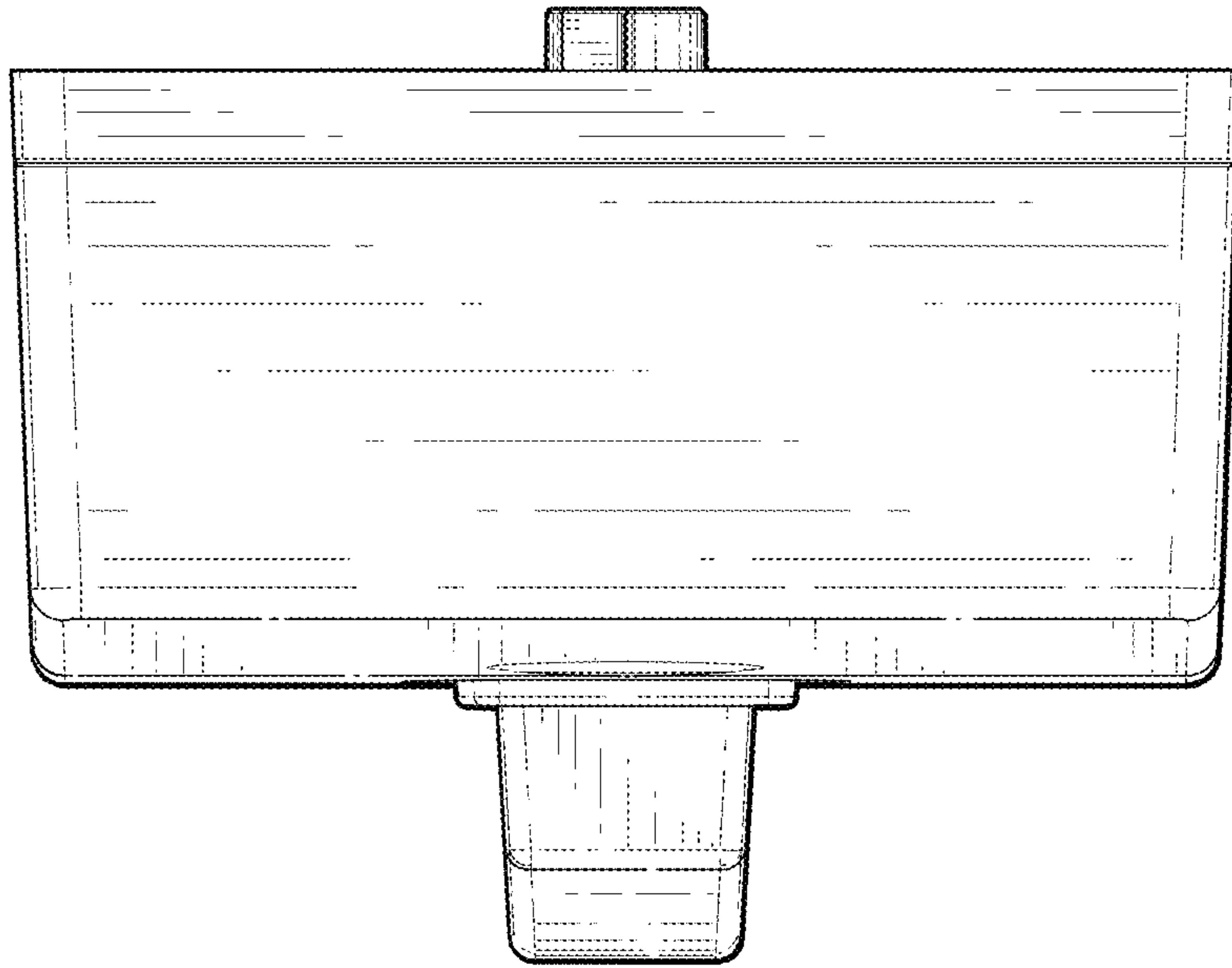

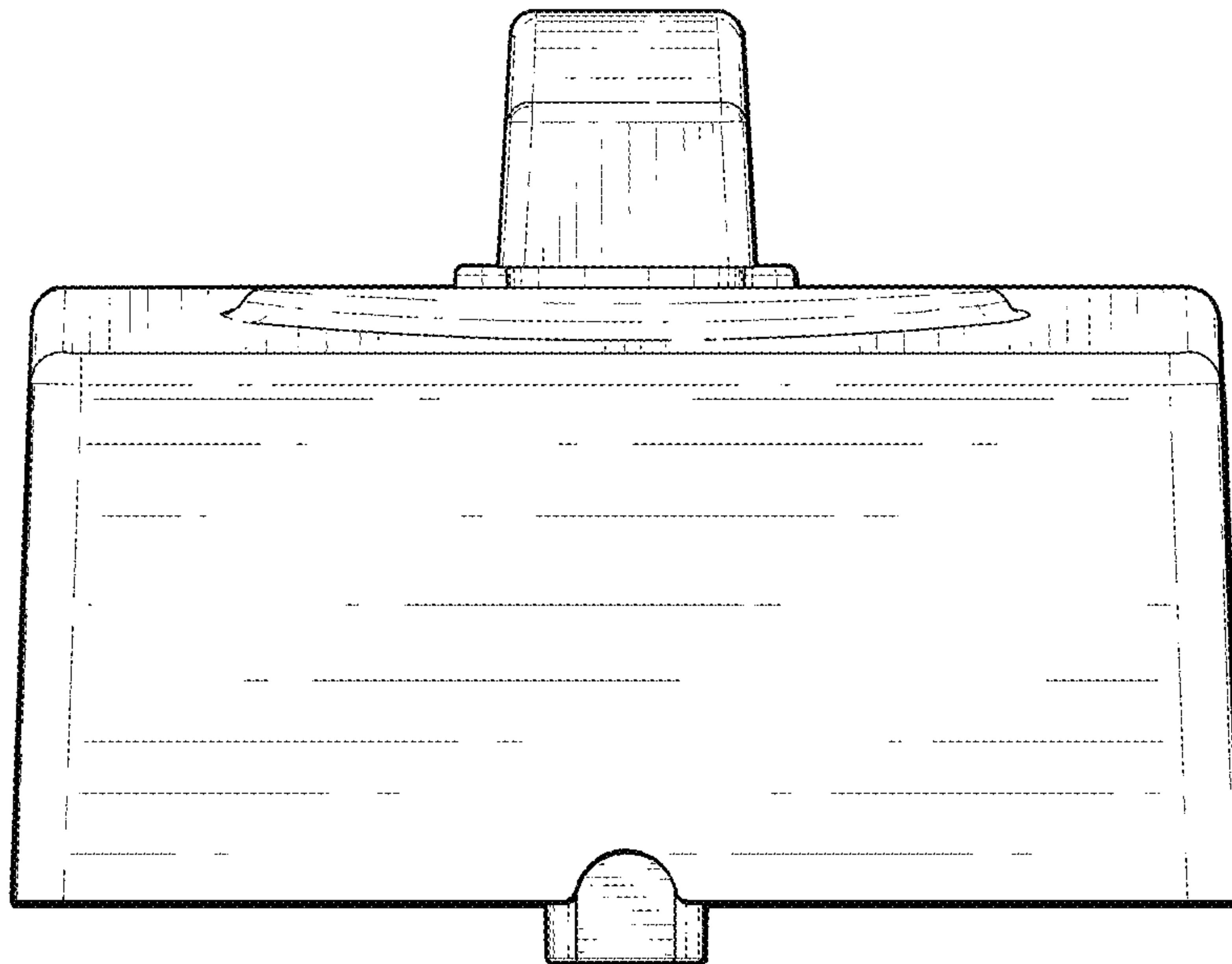
