DESCRIPTION

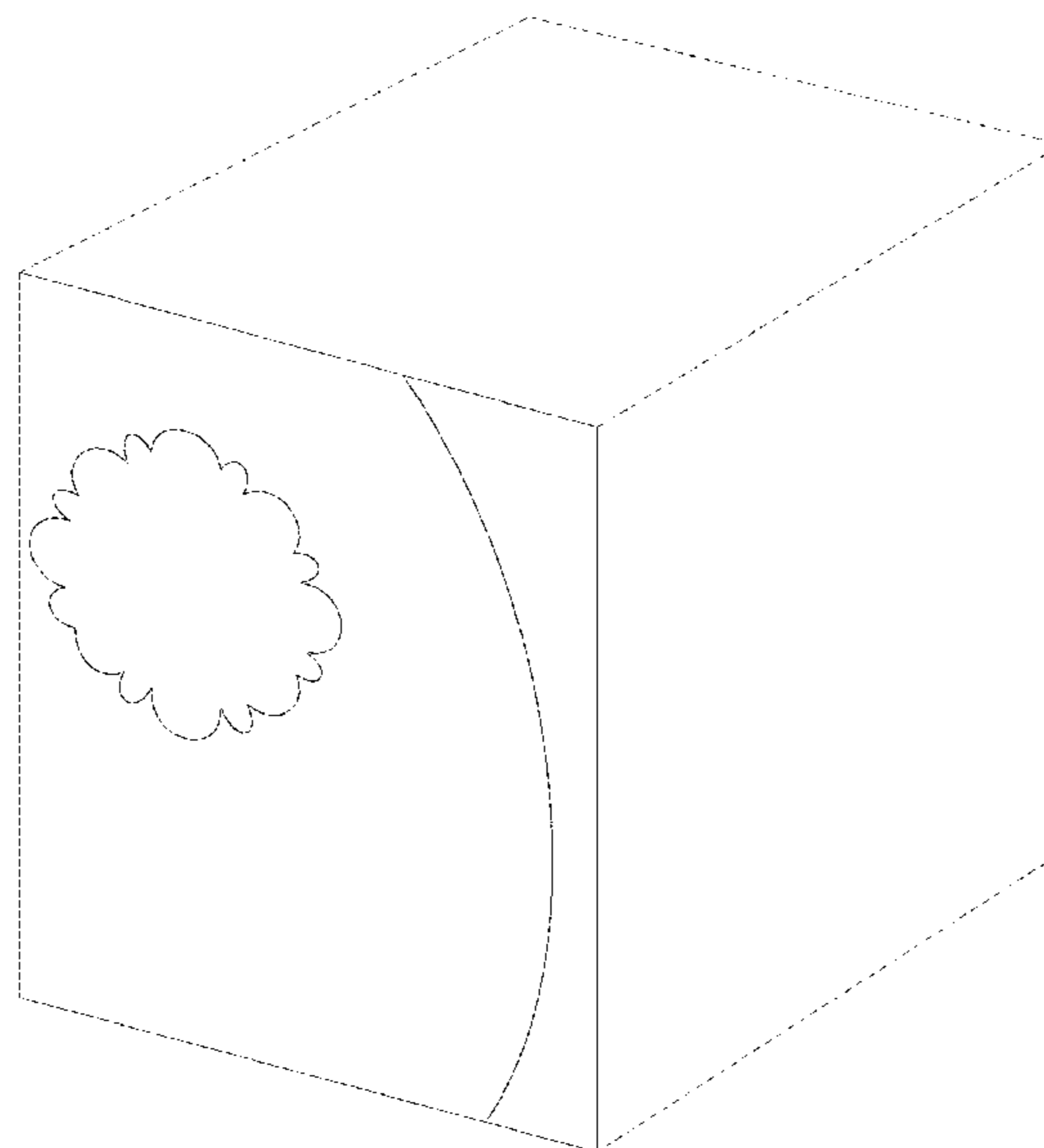
FIG. 1 is a perspective view of a carton showing our new design.

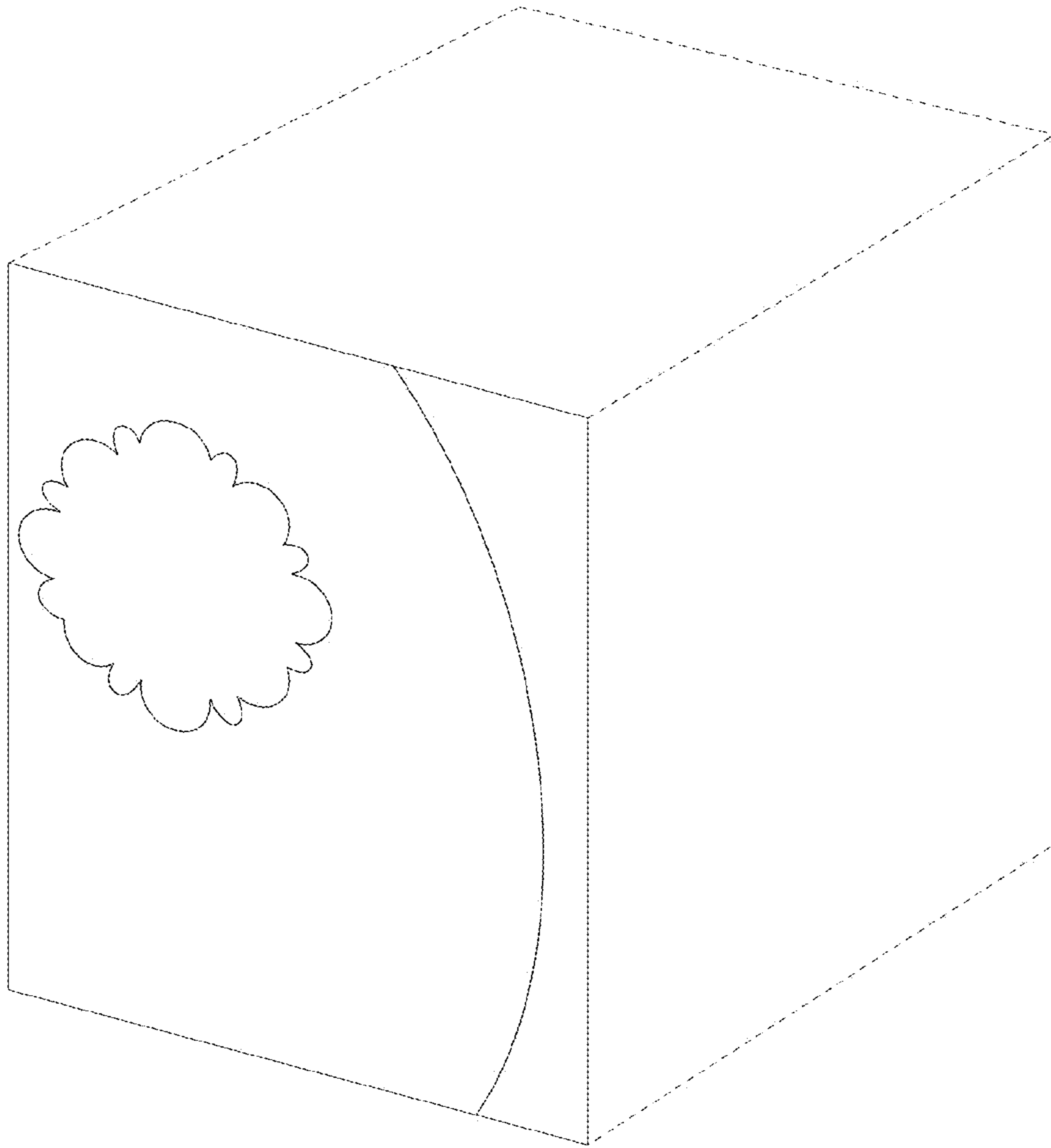

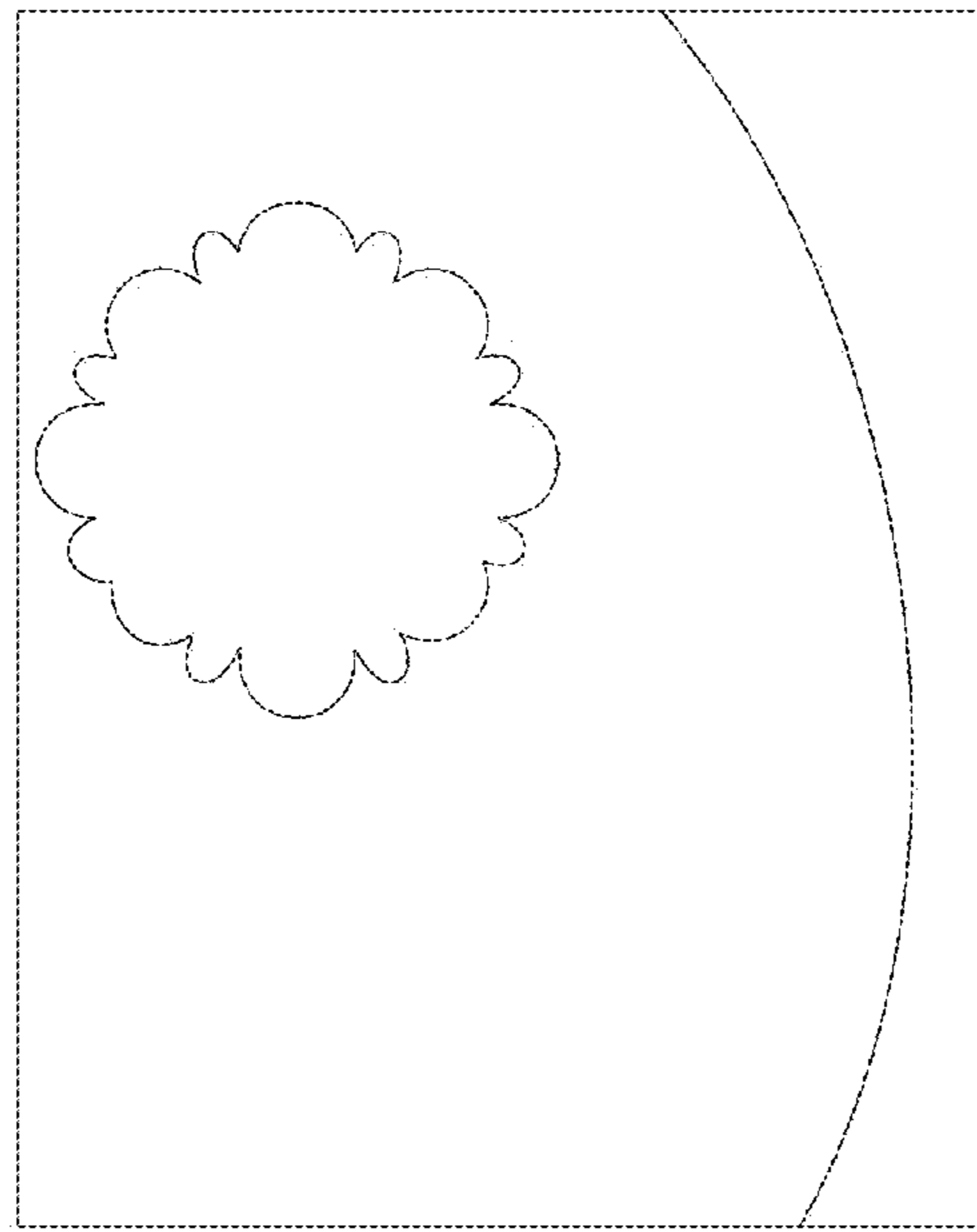

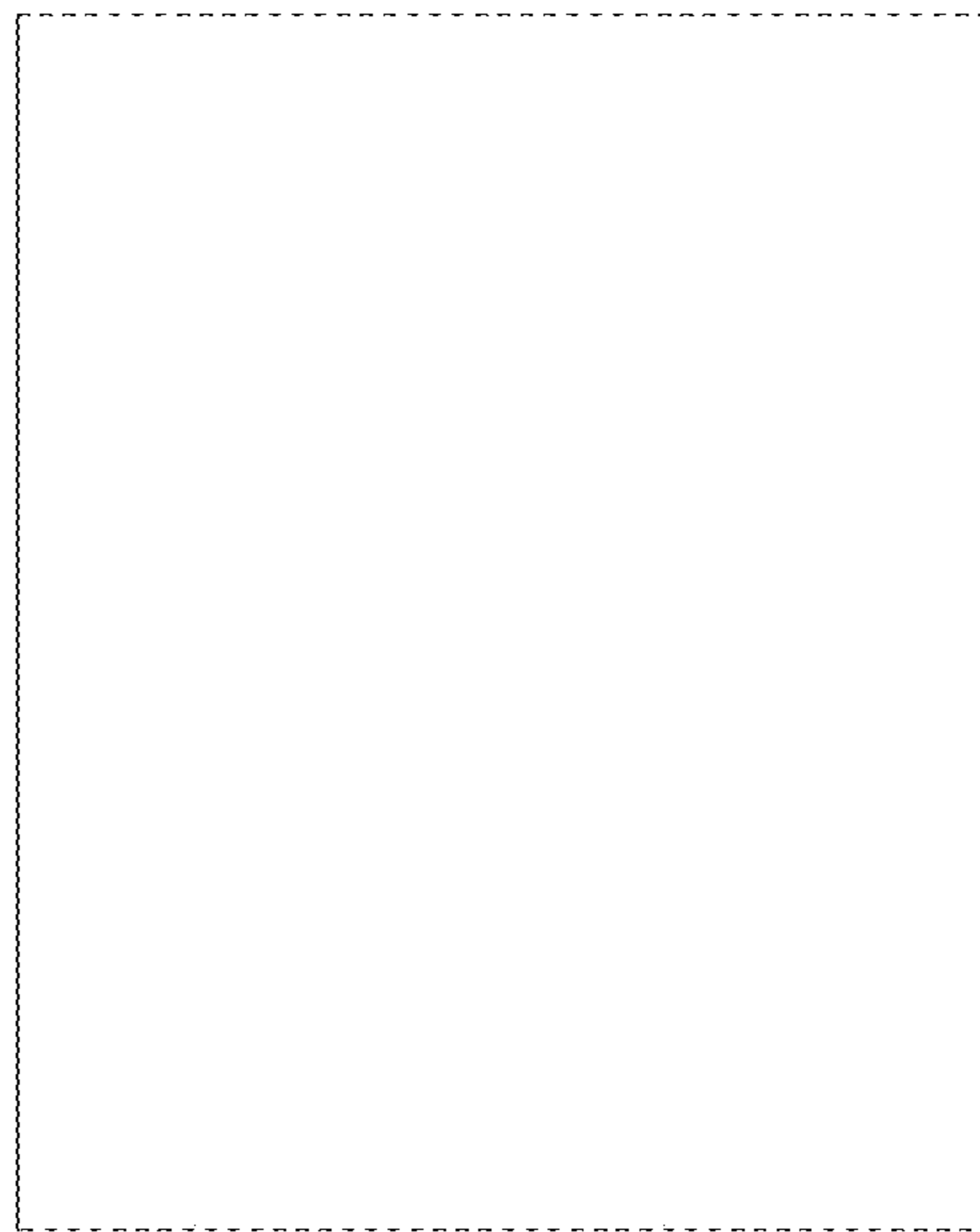
