The ornamental design for a shave preparation container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shave preparation container having a blue cap and blue bands adjacent to the product label showing my new design;

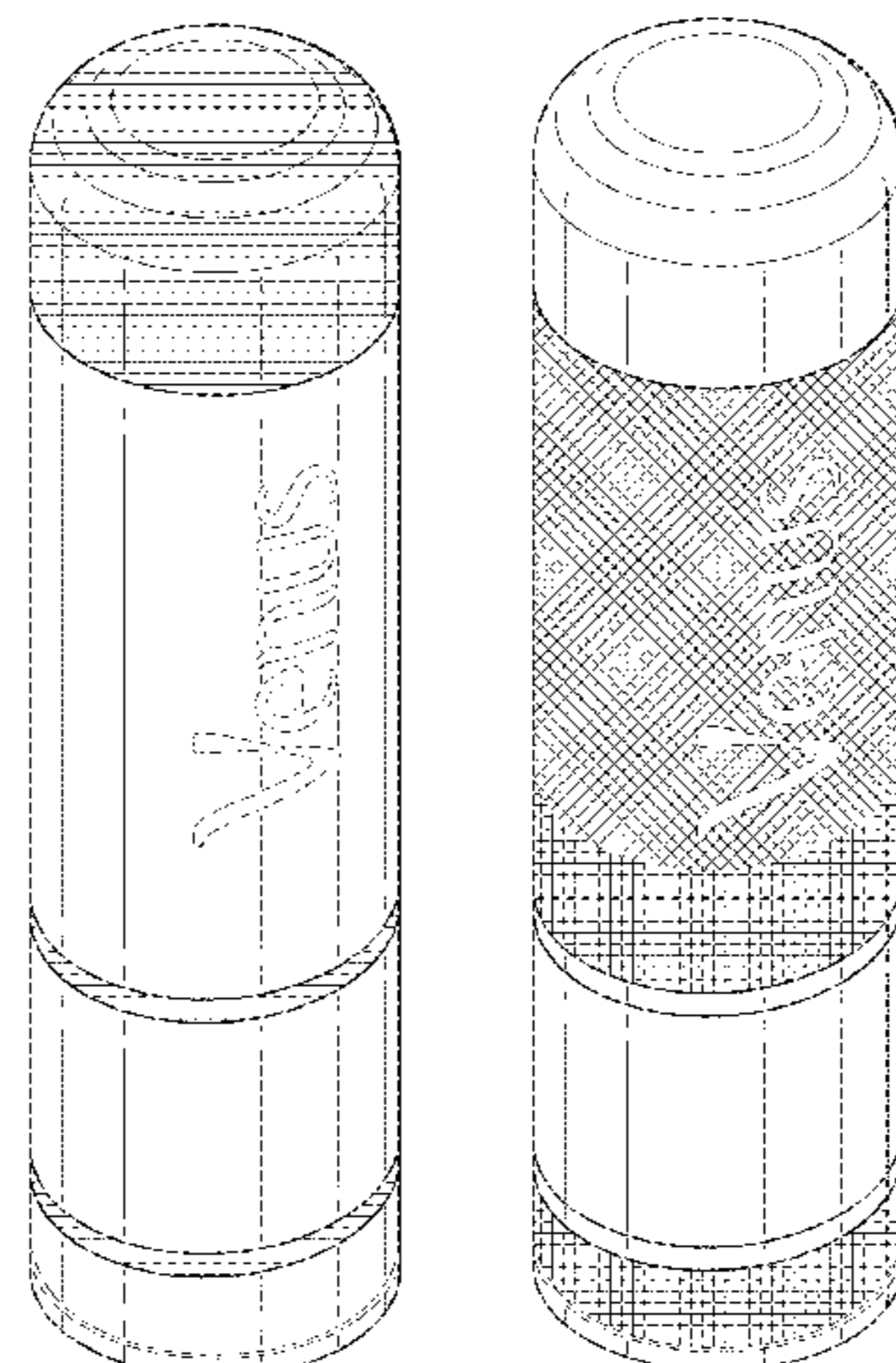
FIG. 9 is a front view of FIG. 8;

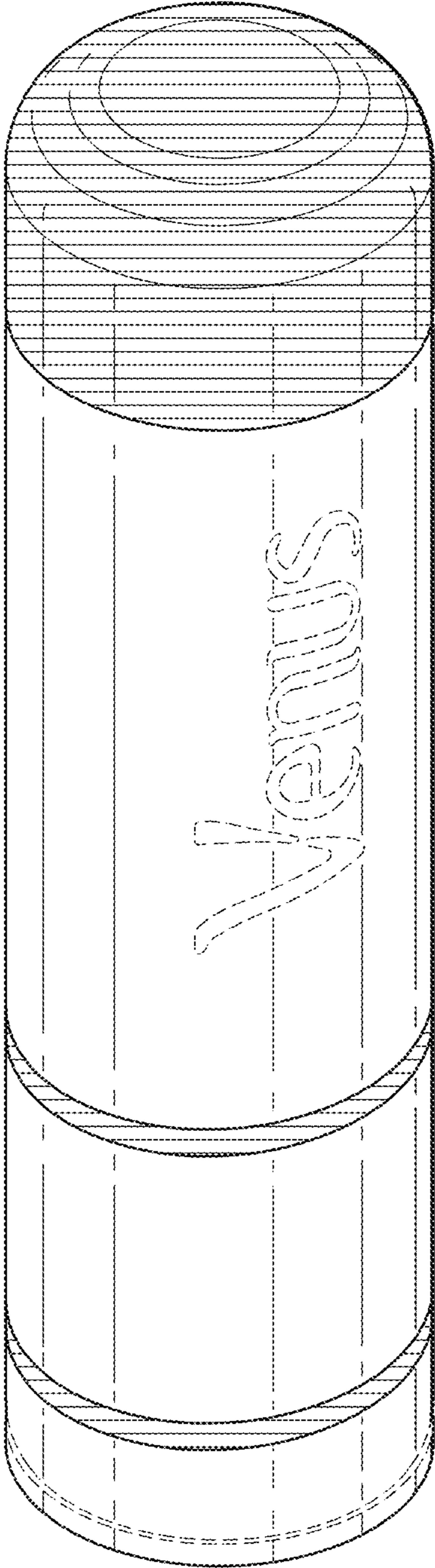

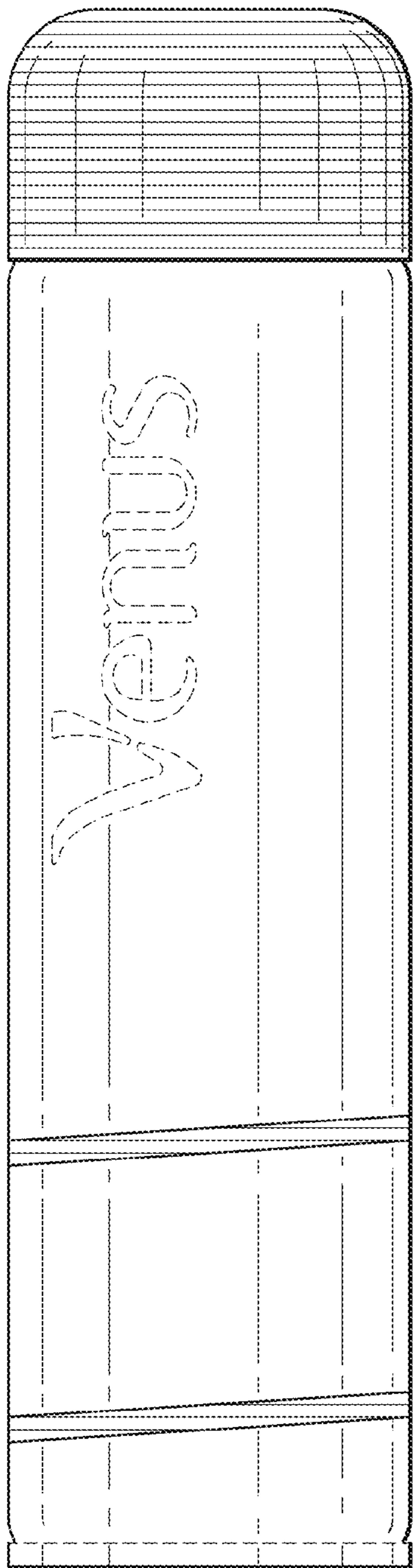

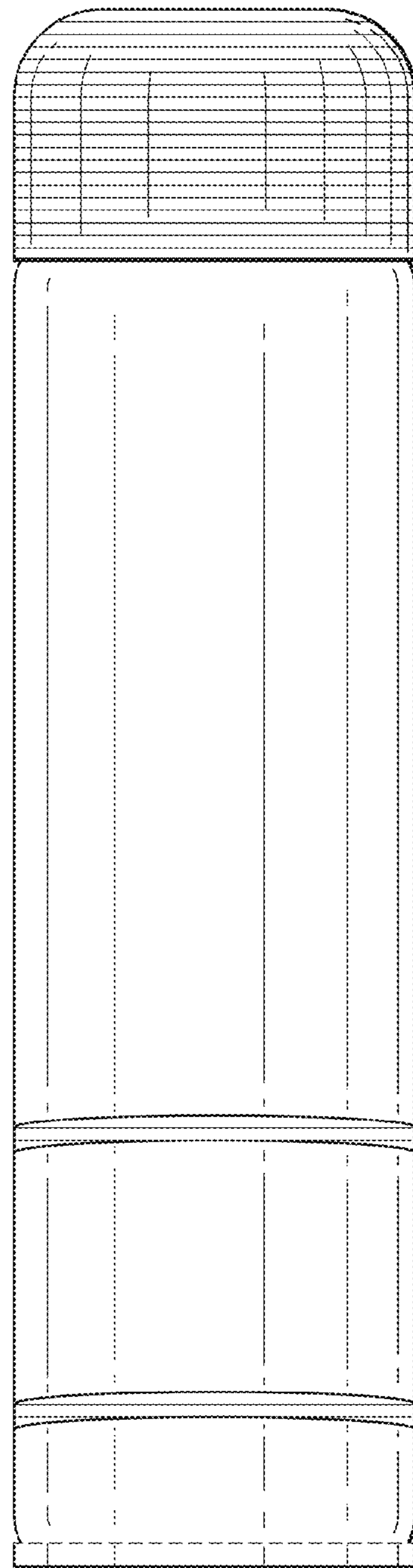

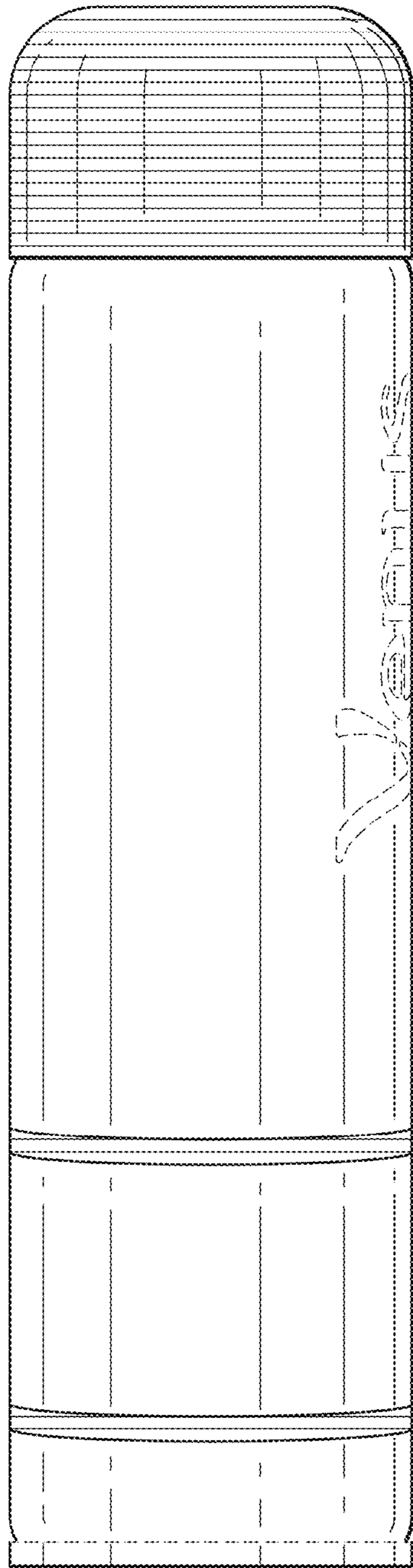

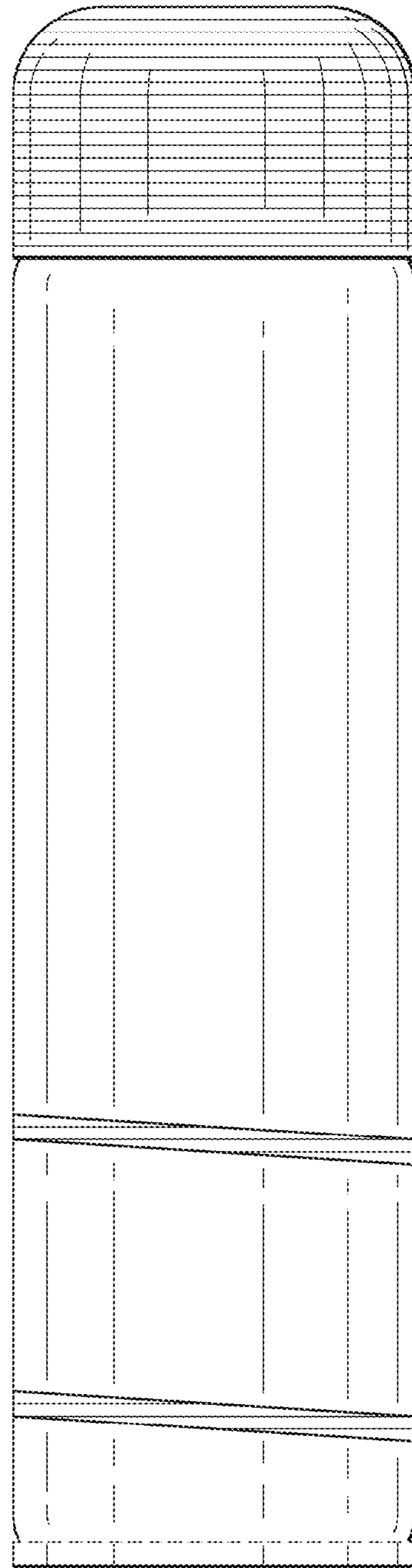

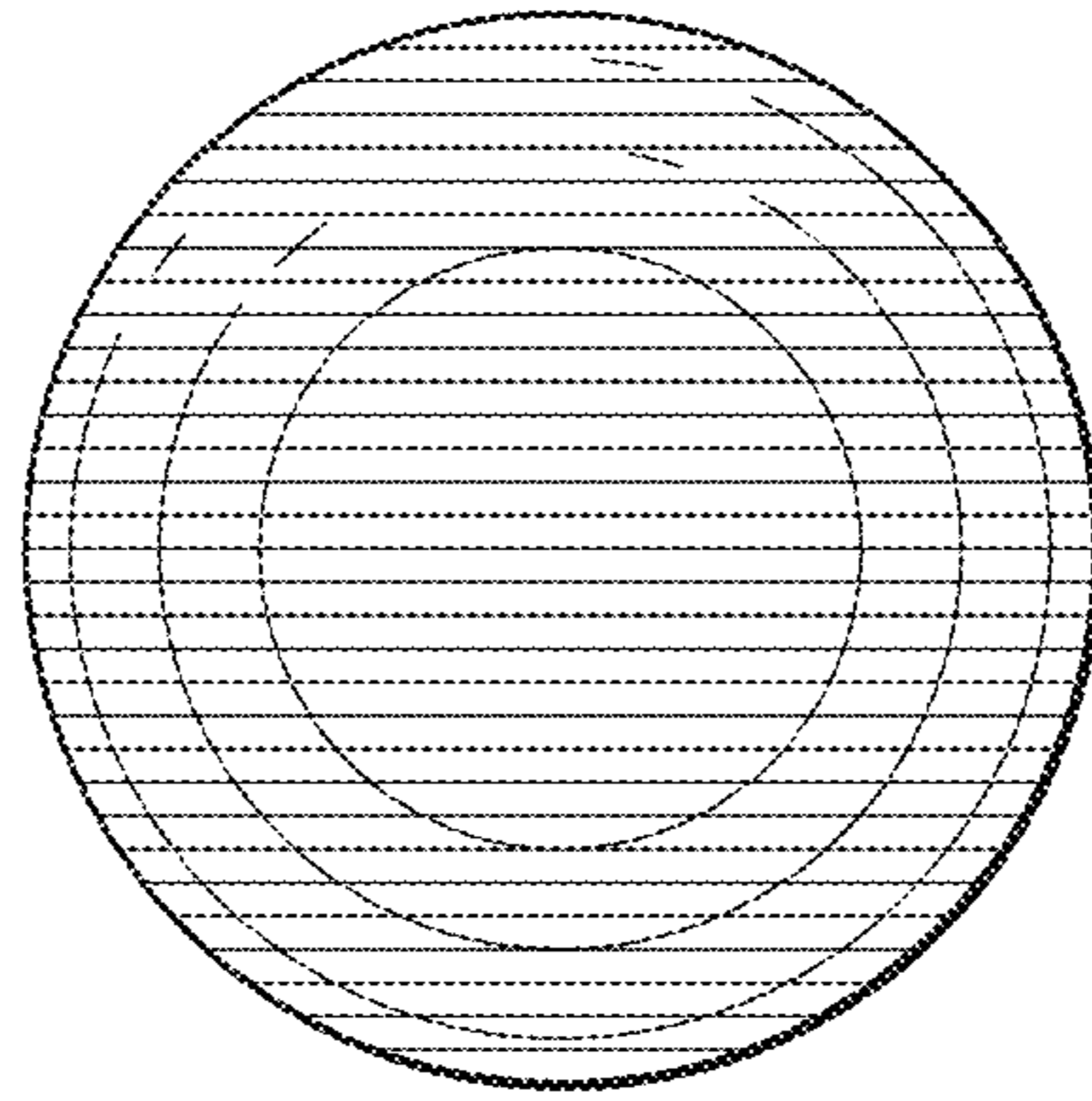

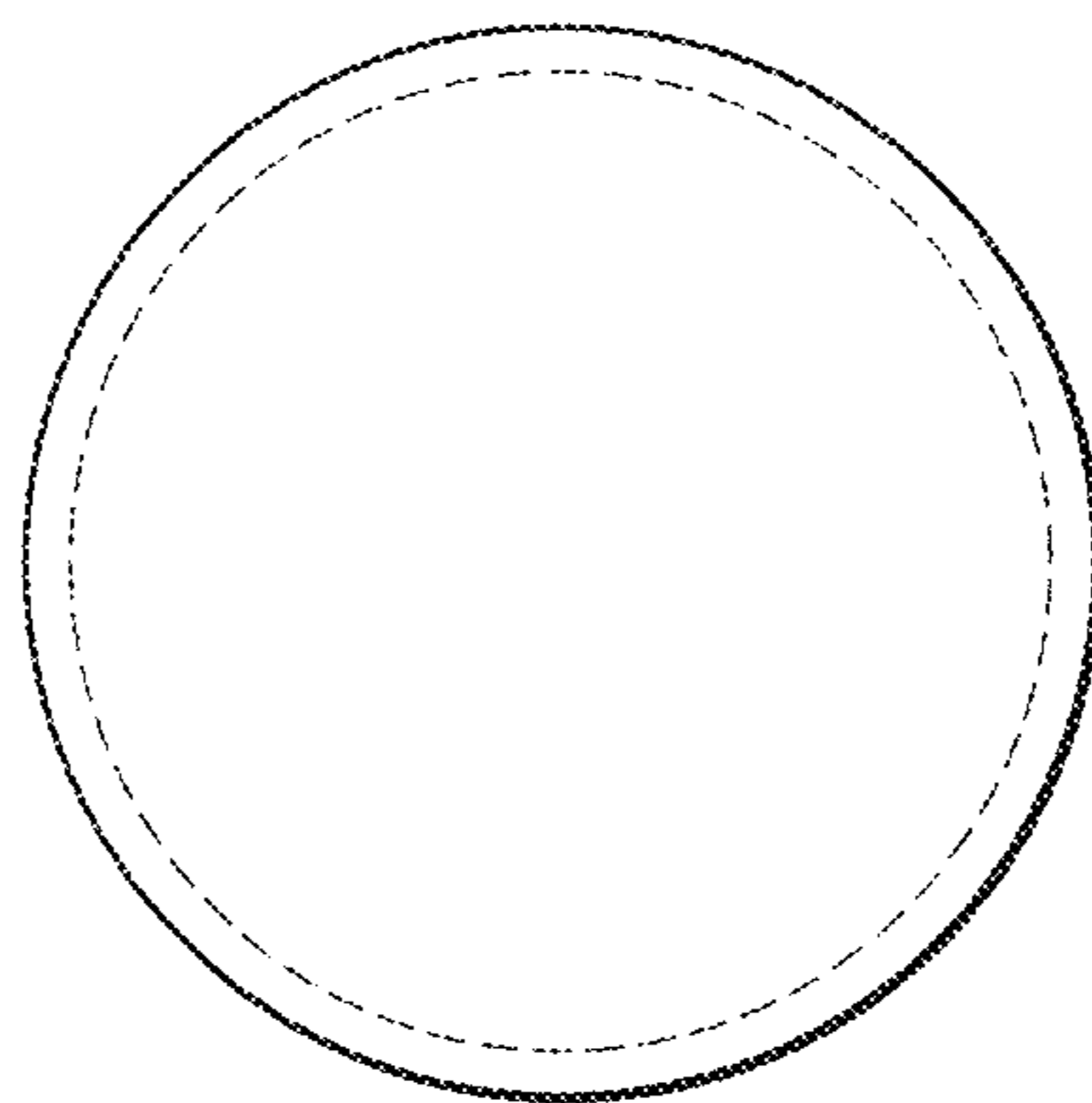

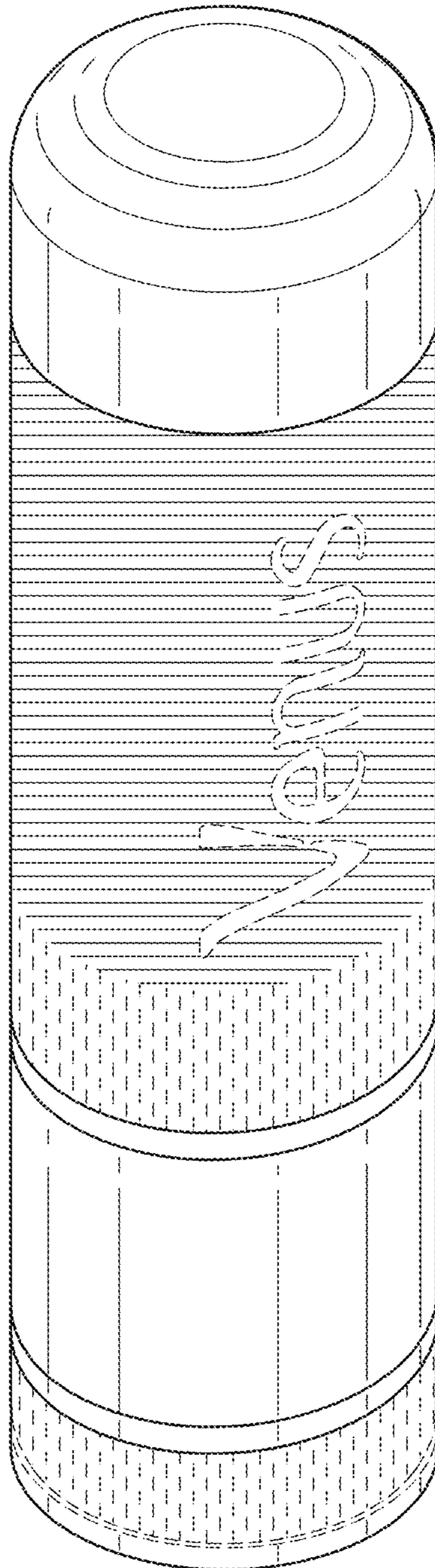

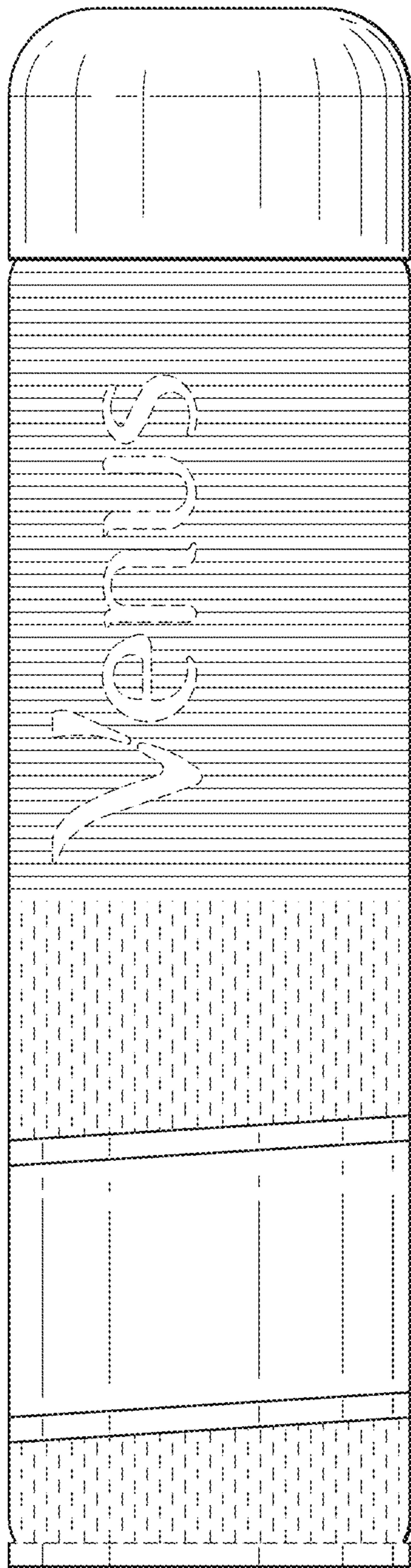

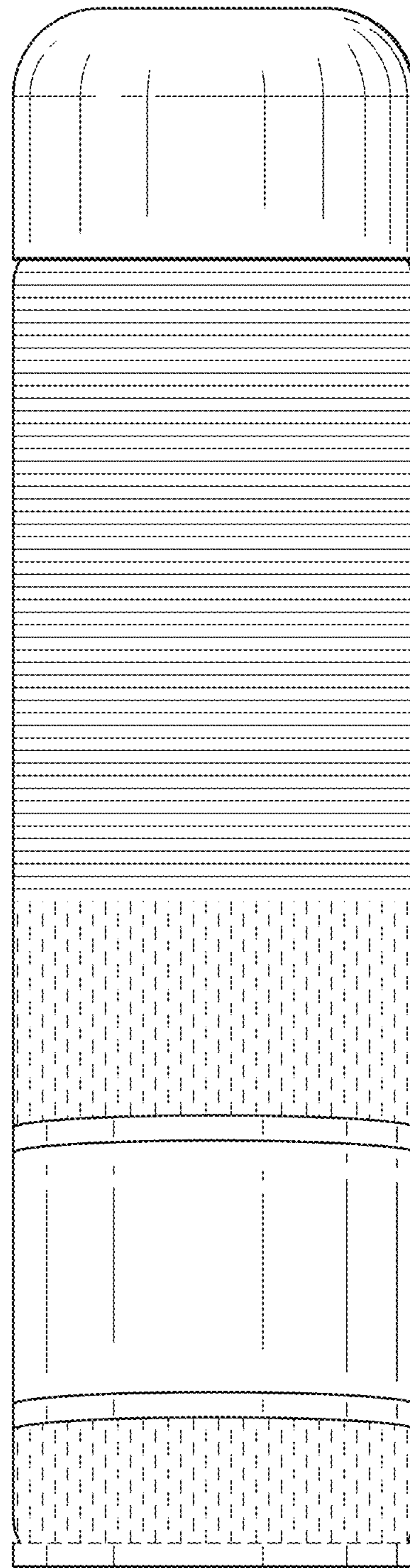

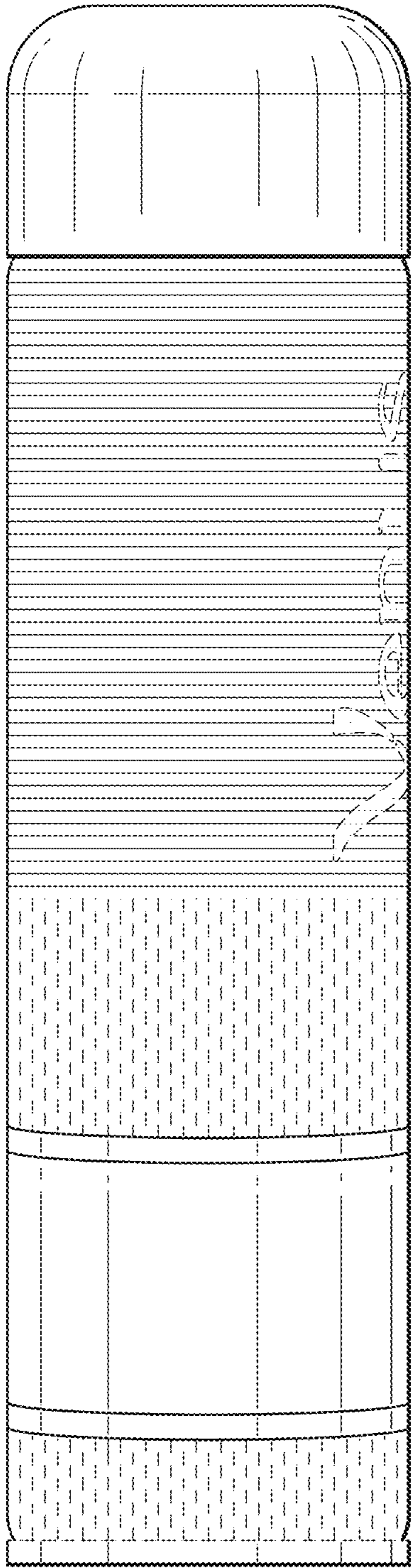

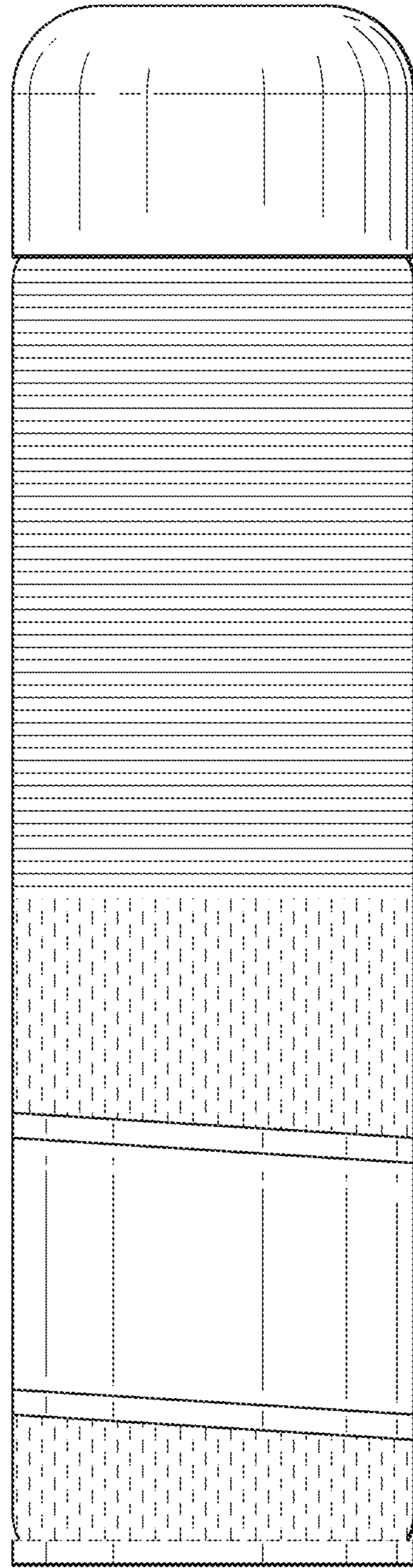

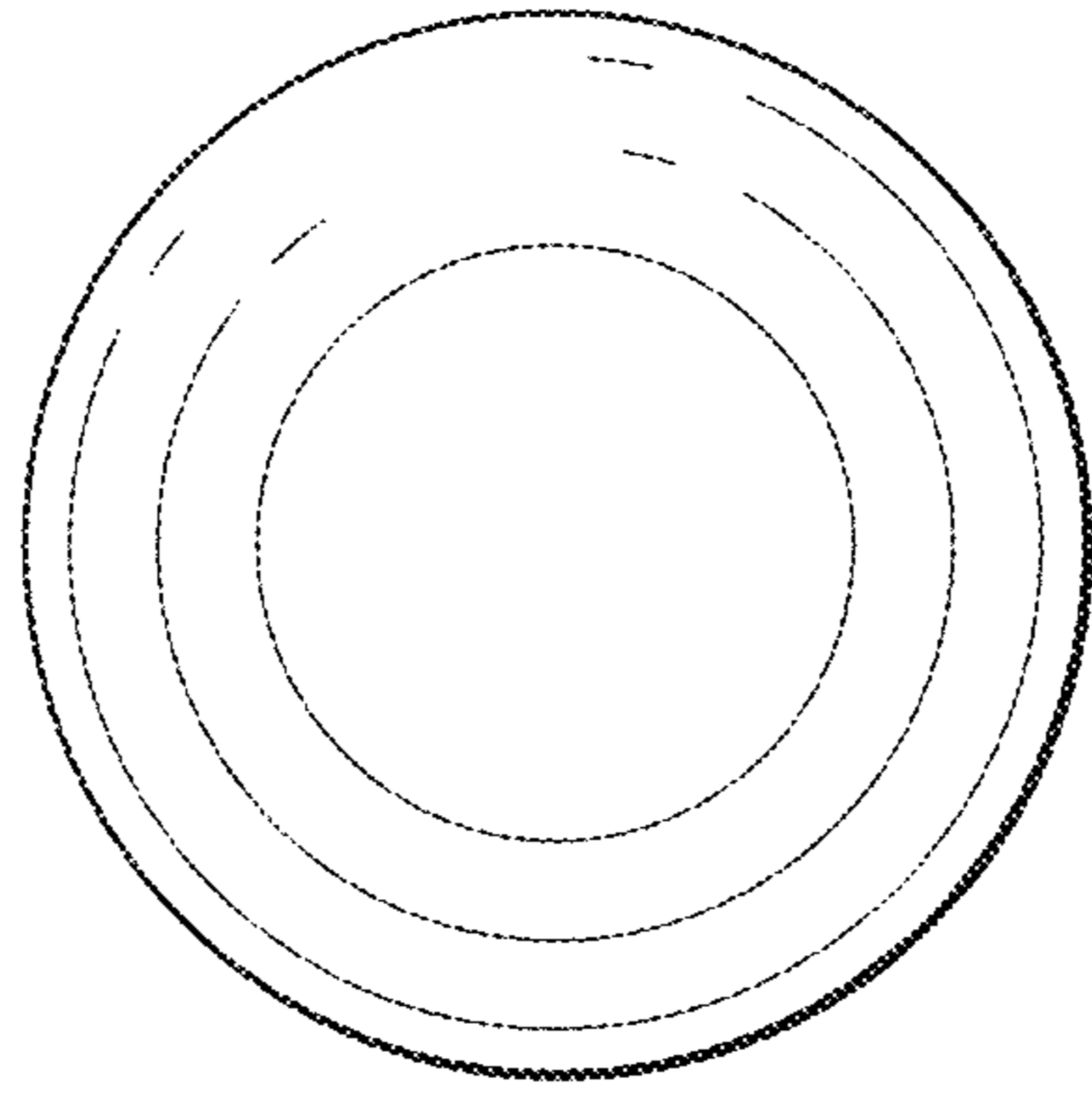

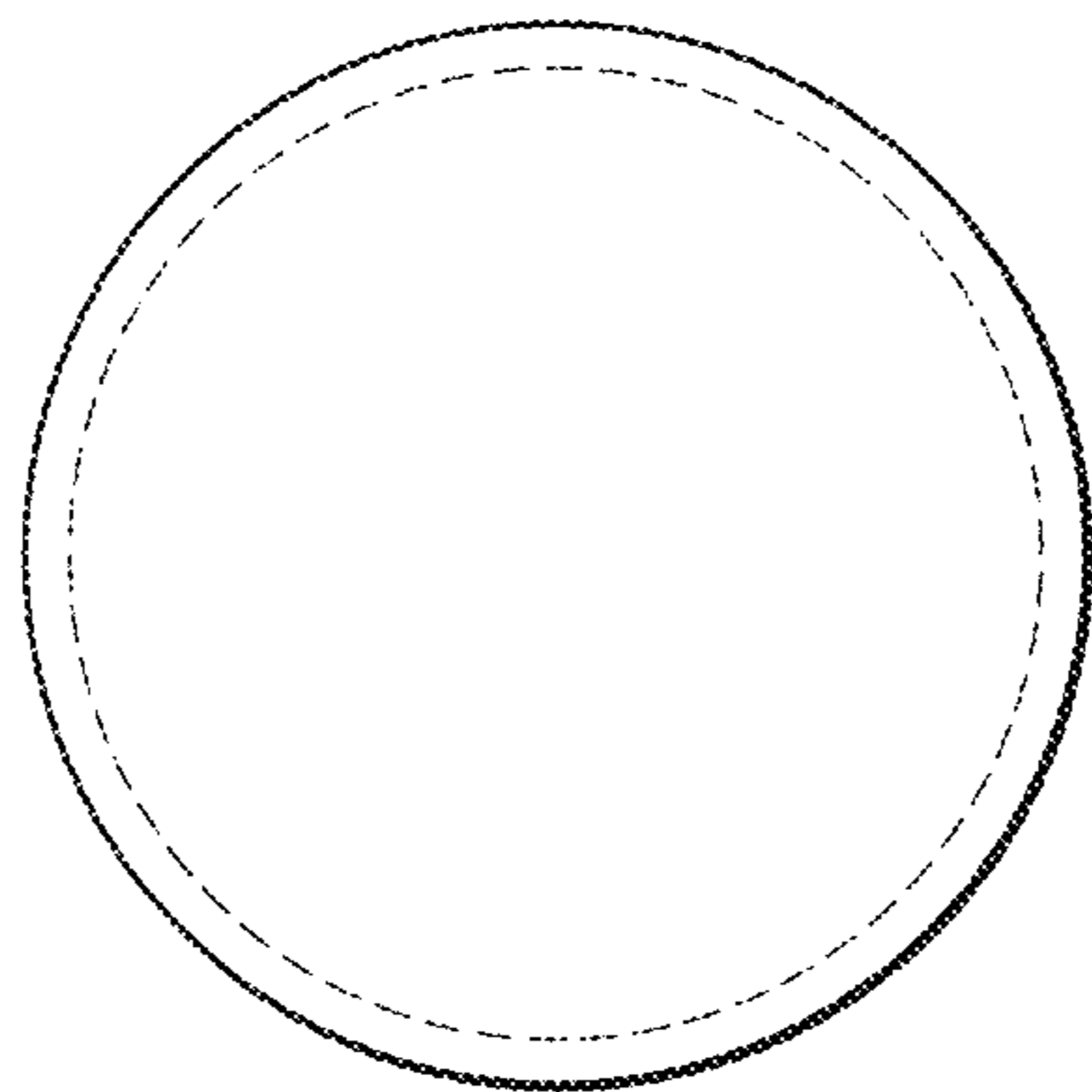

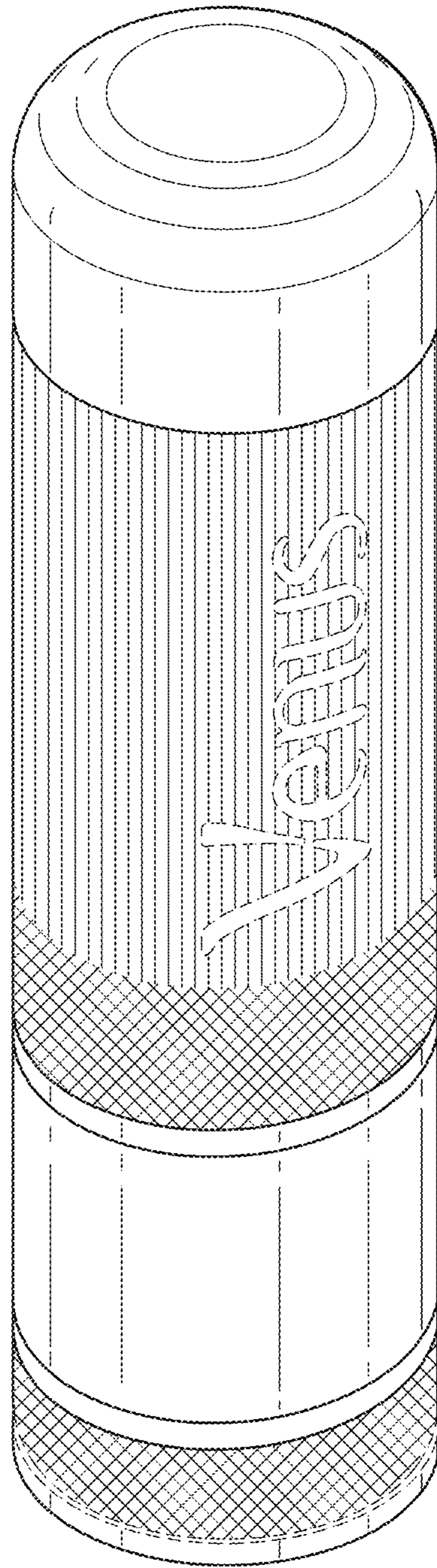

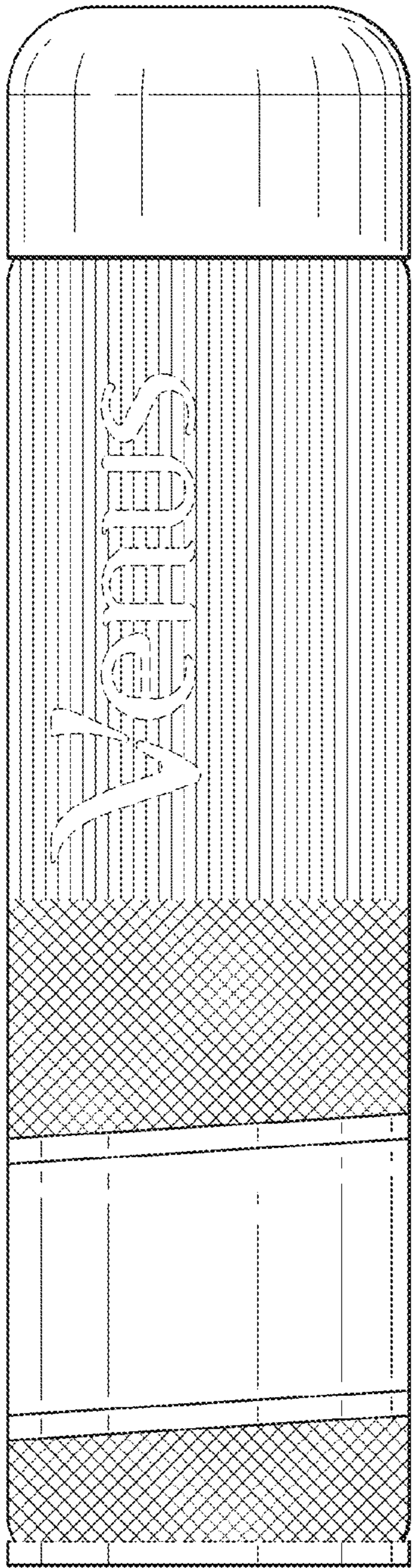

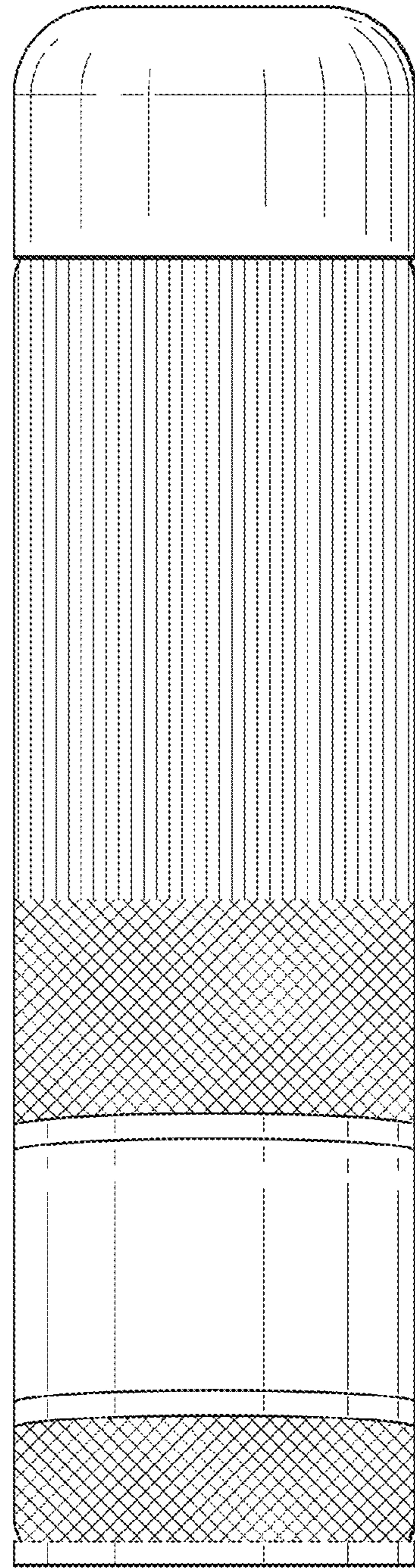

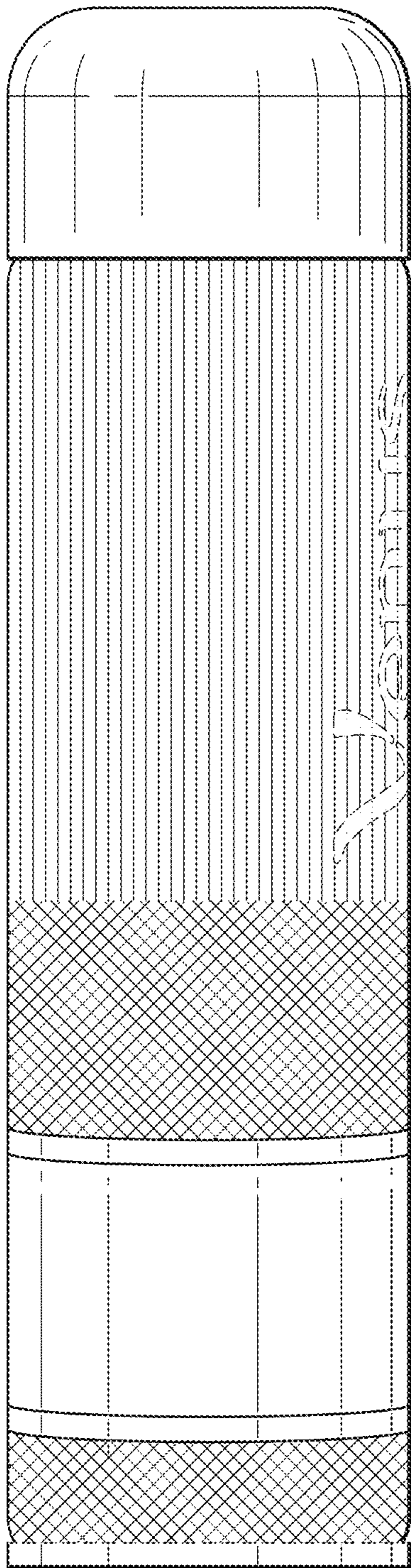

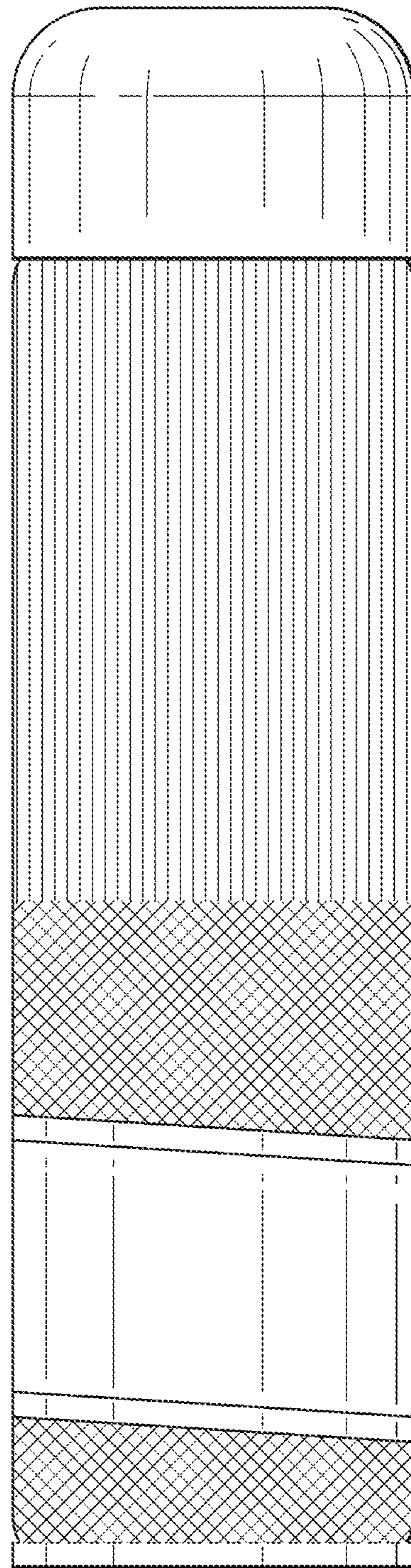

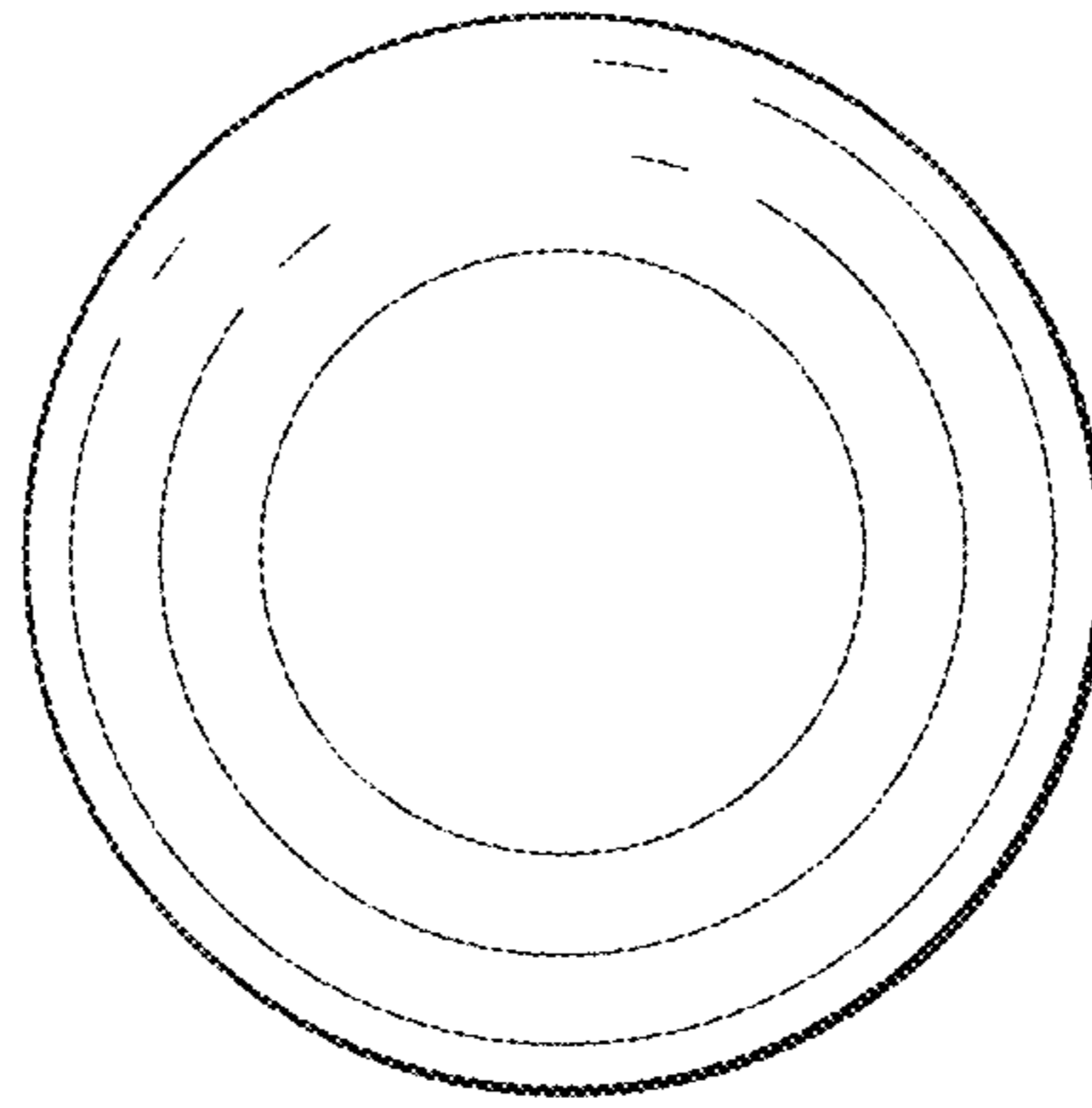

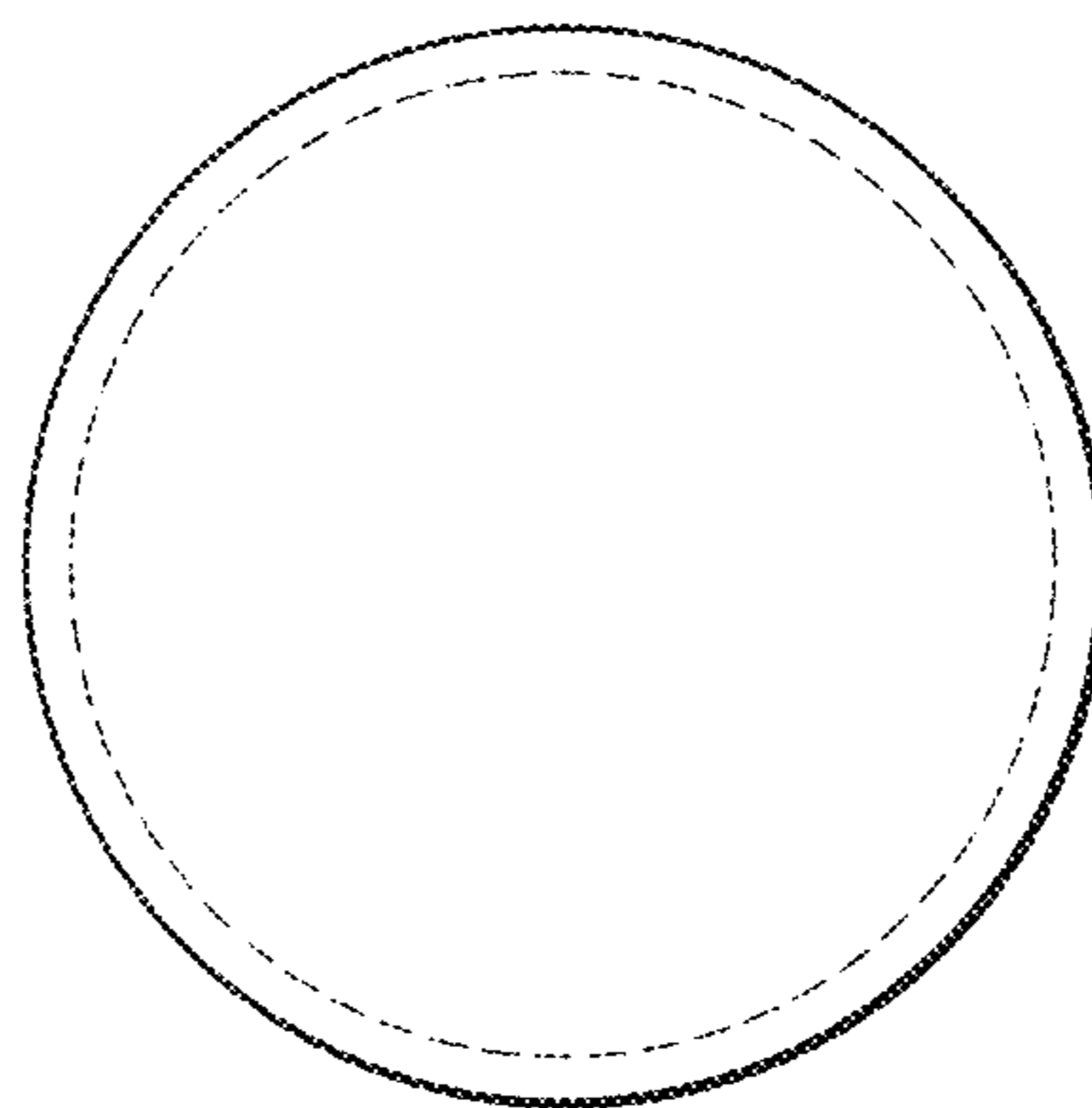

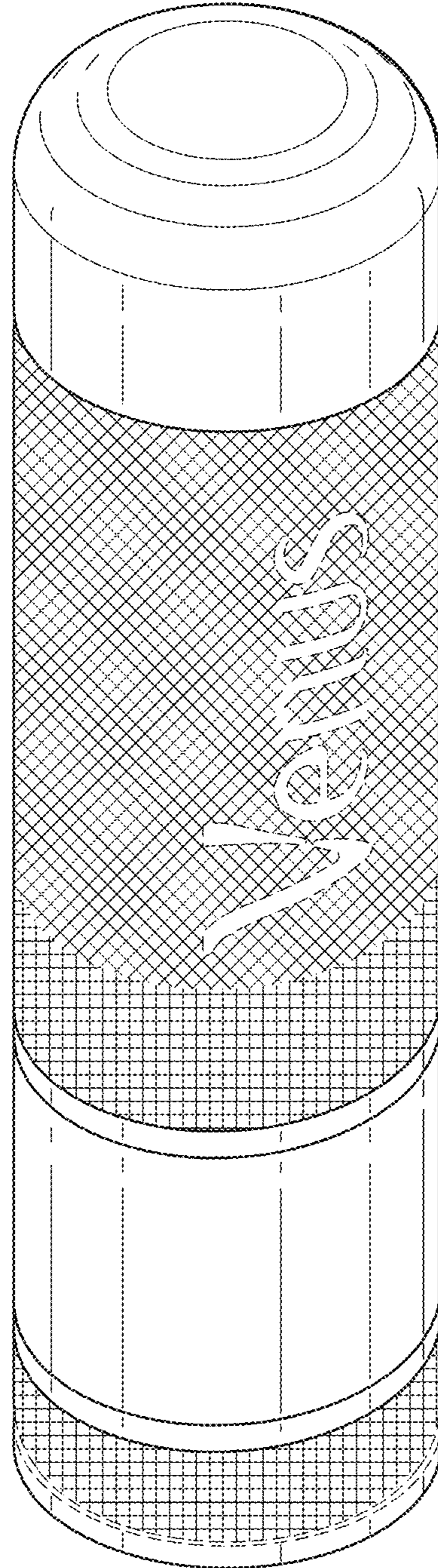

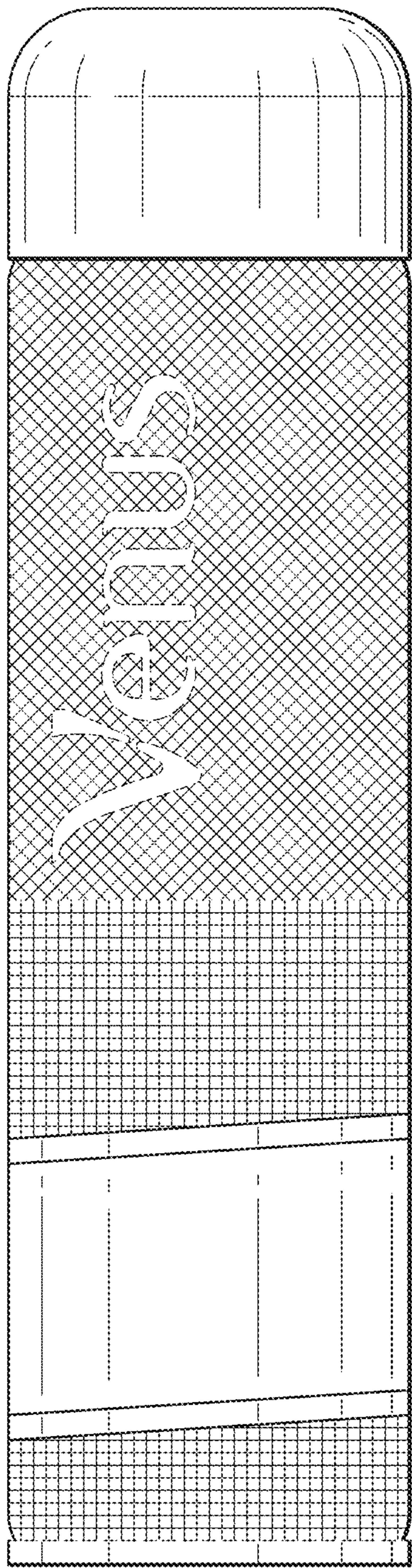

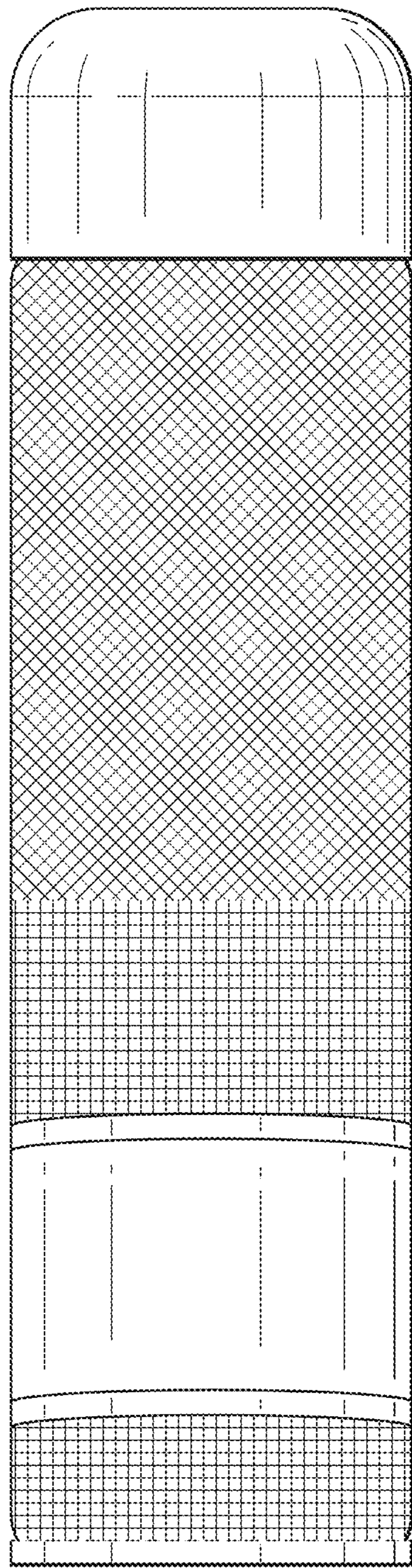

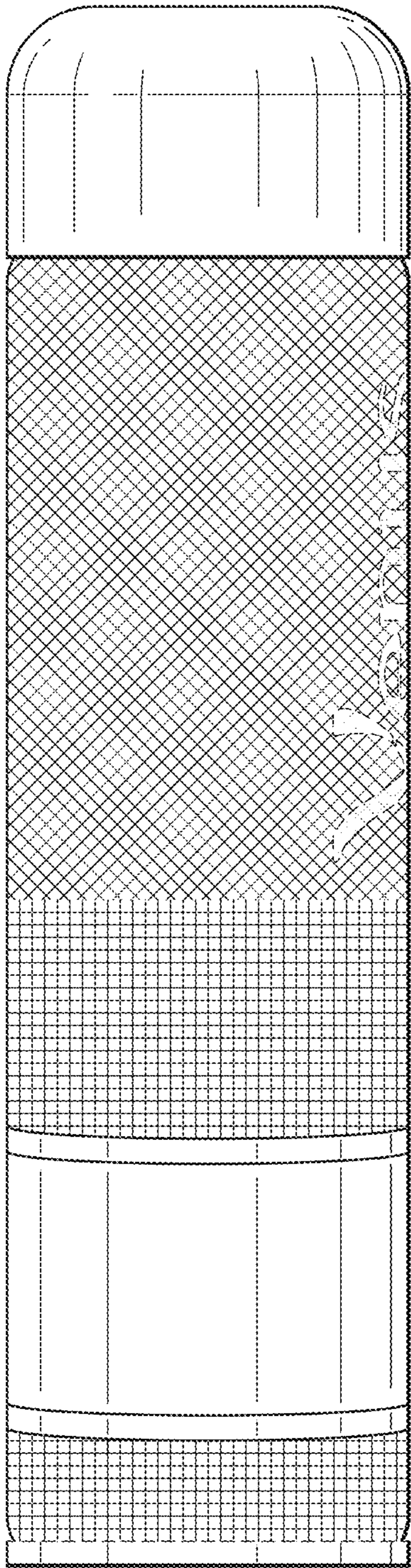

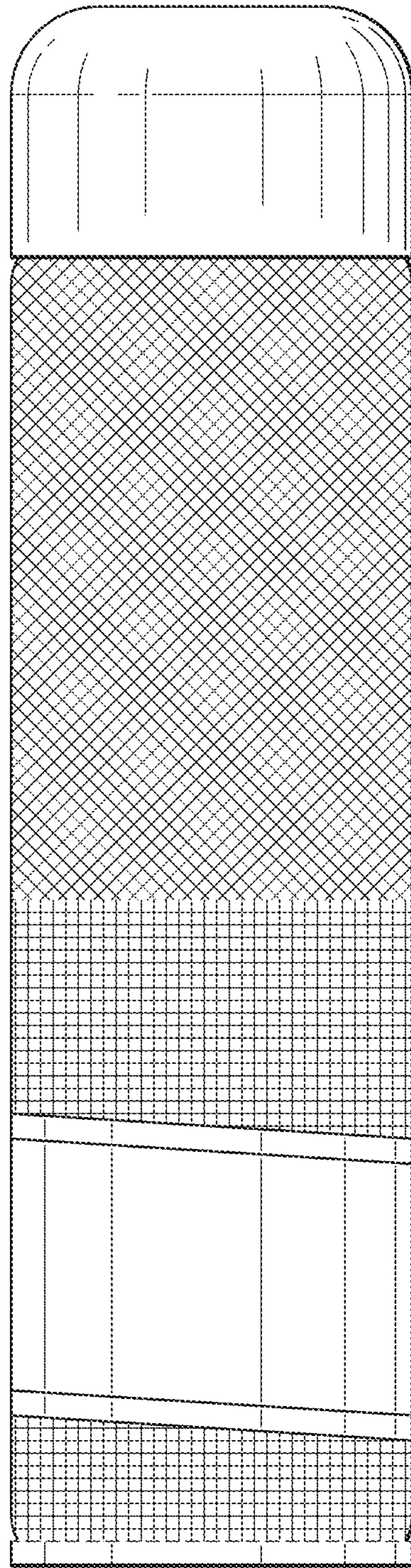

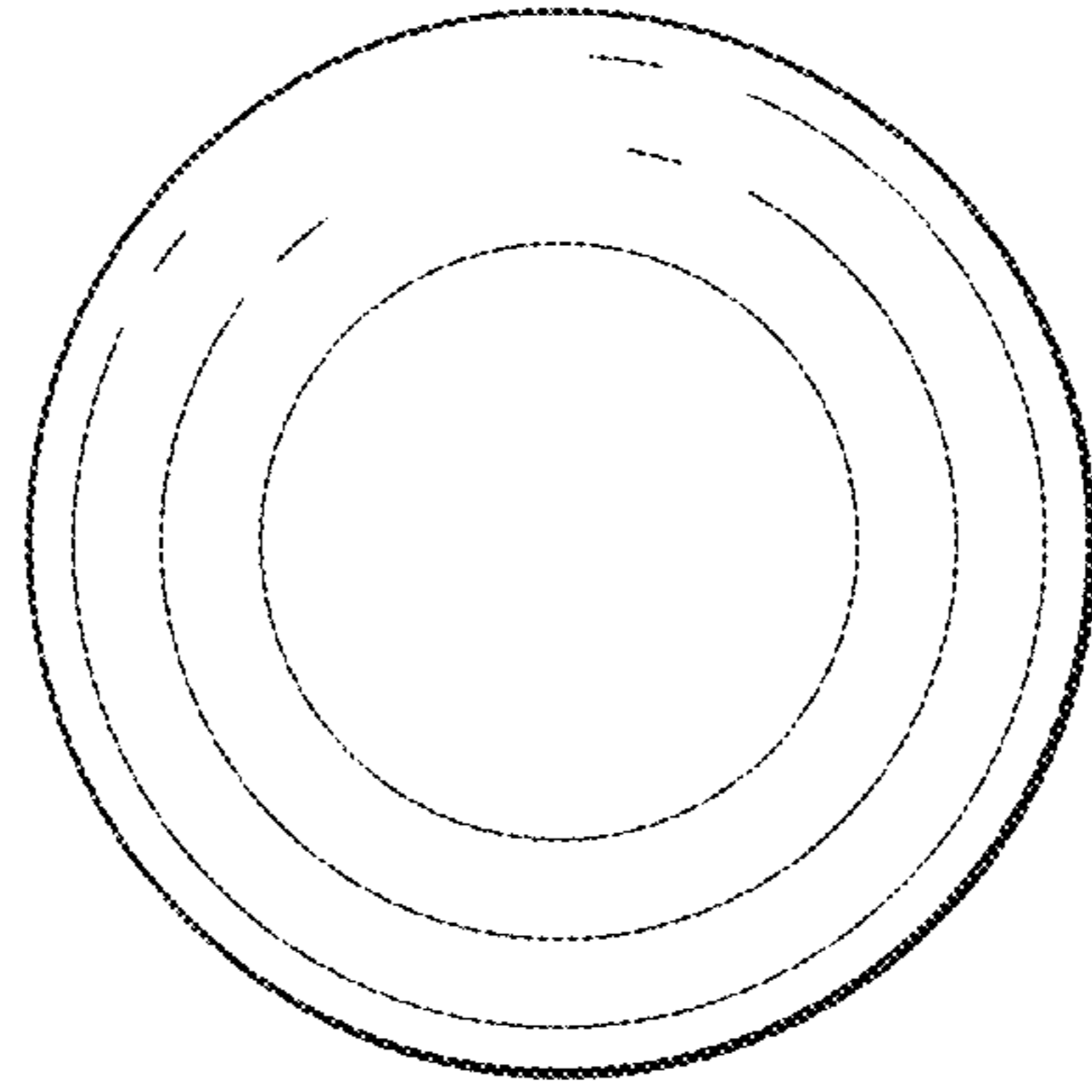

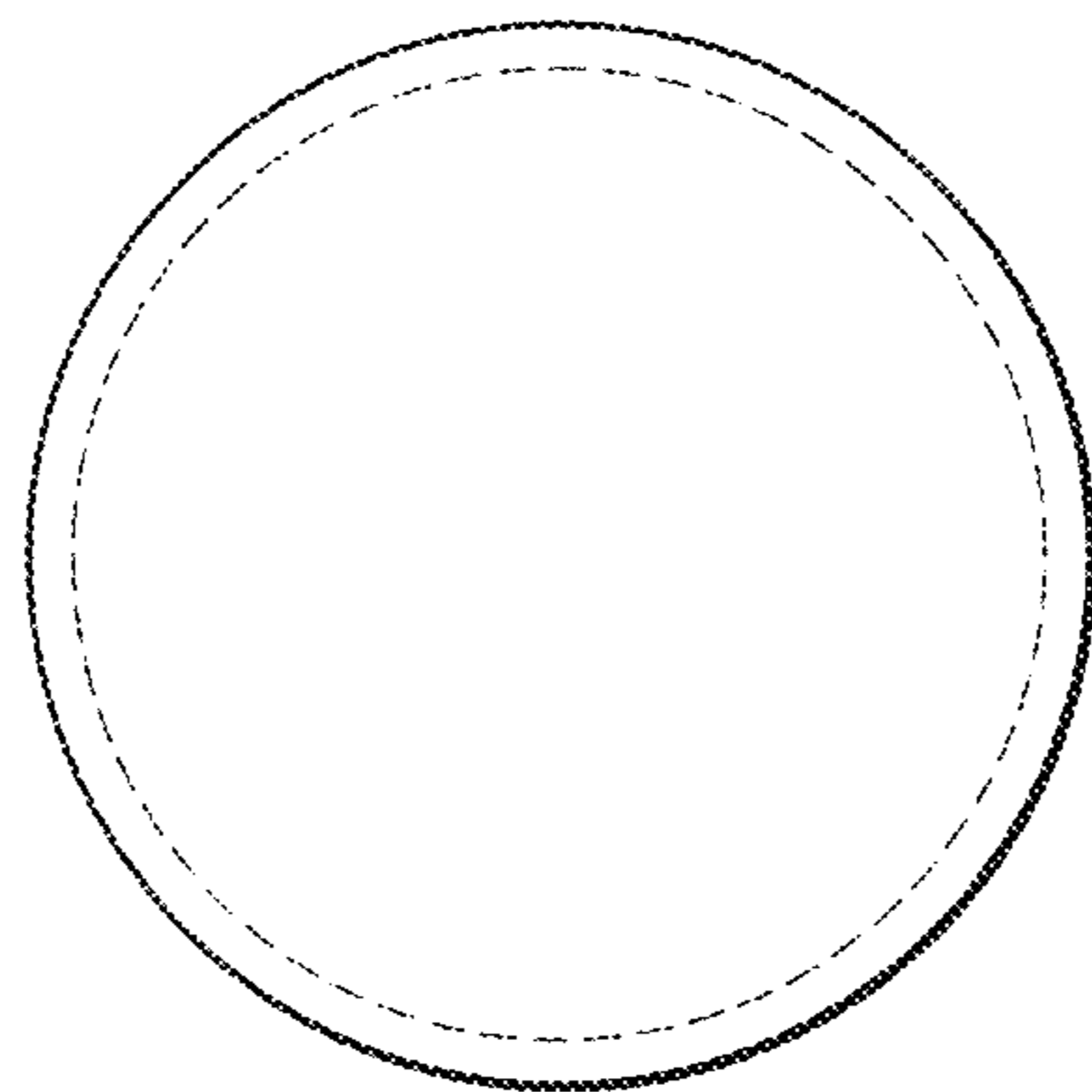
