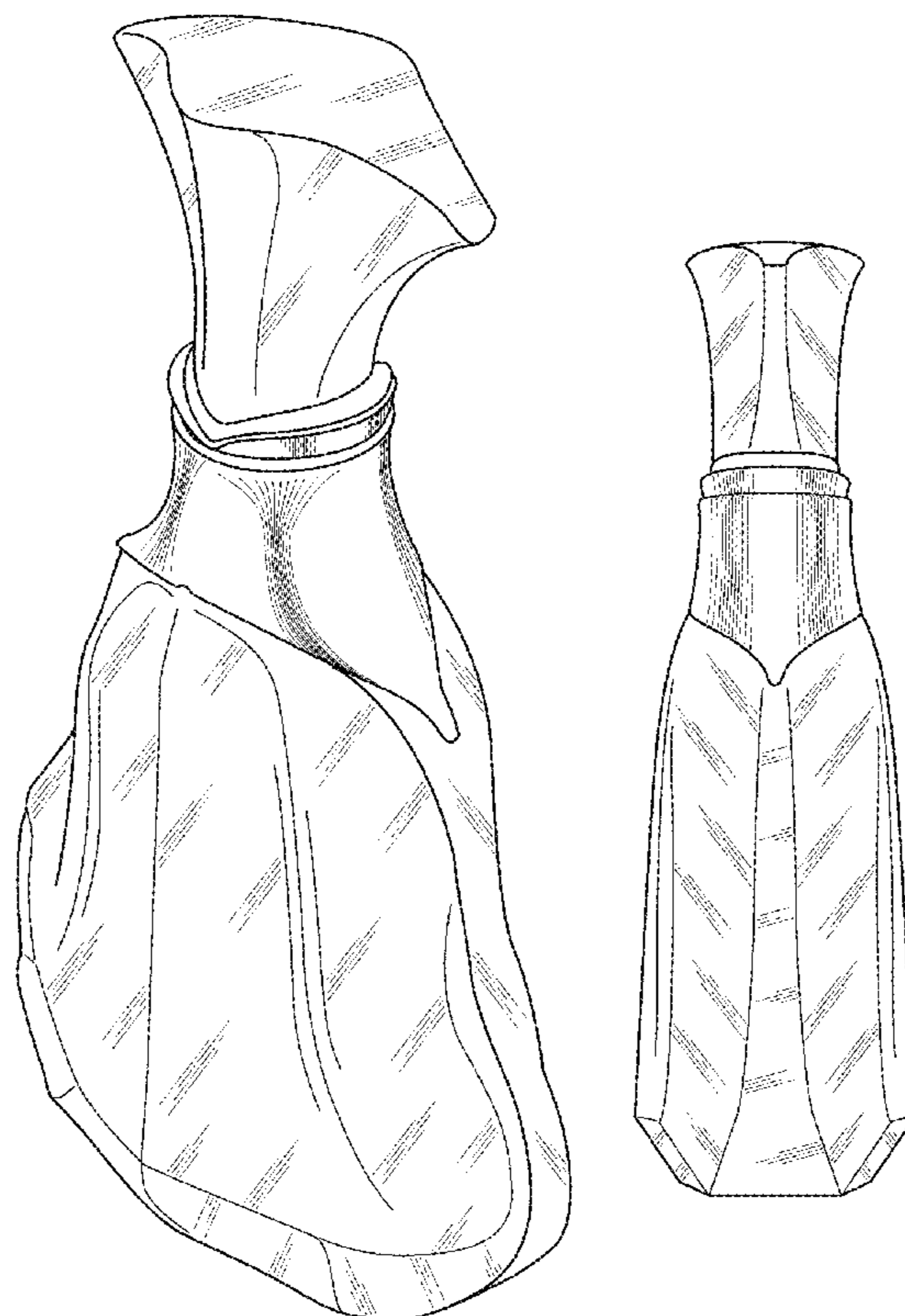

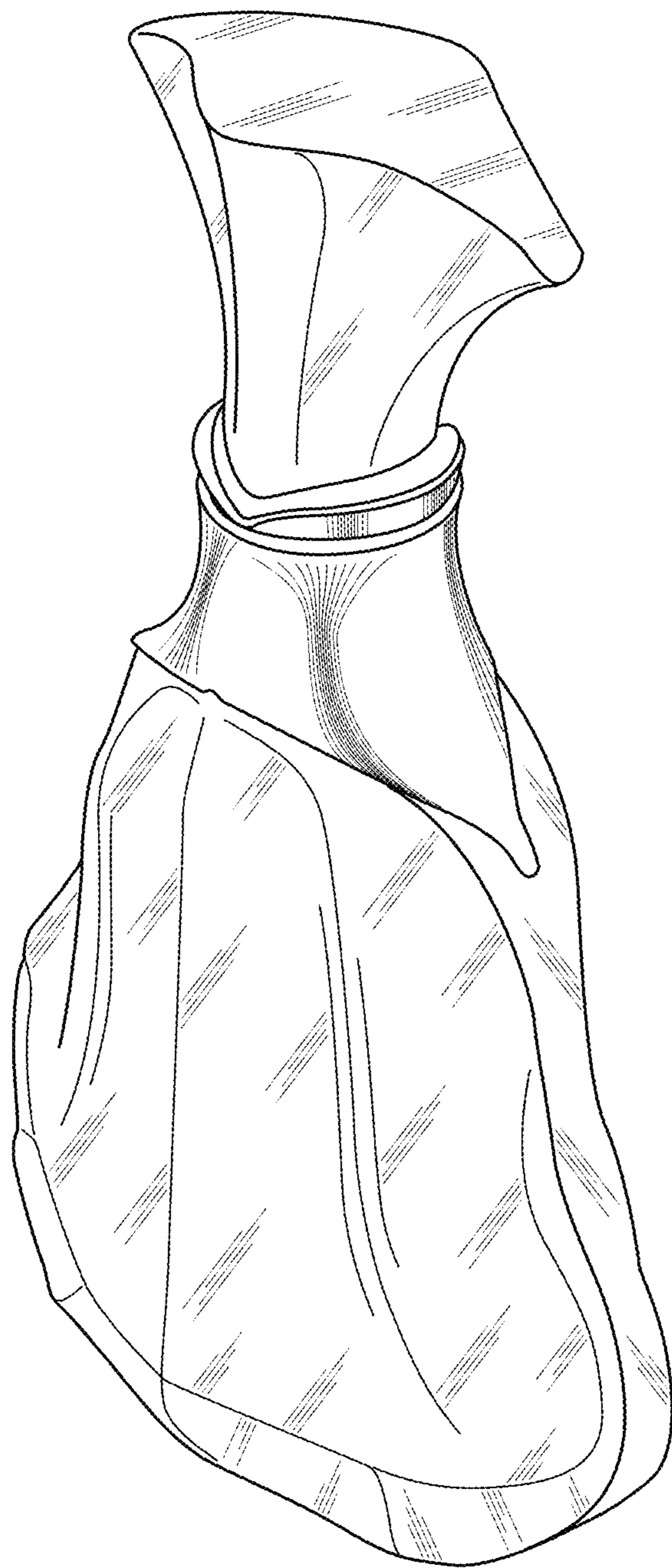
The ornamental design for a decanter, as shown and described.

**DESCRIPTION**

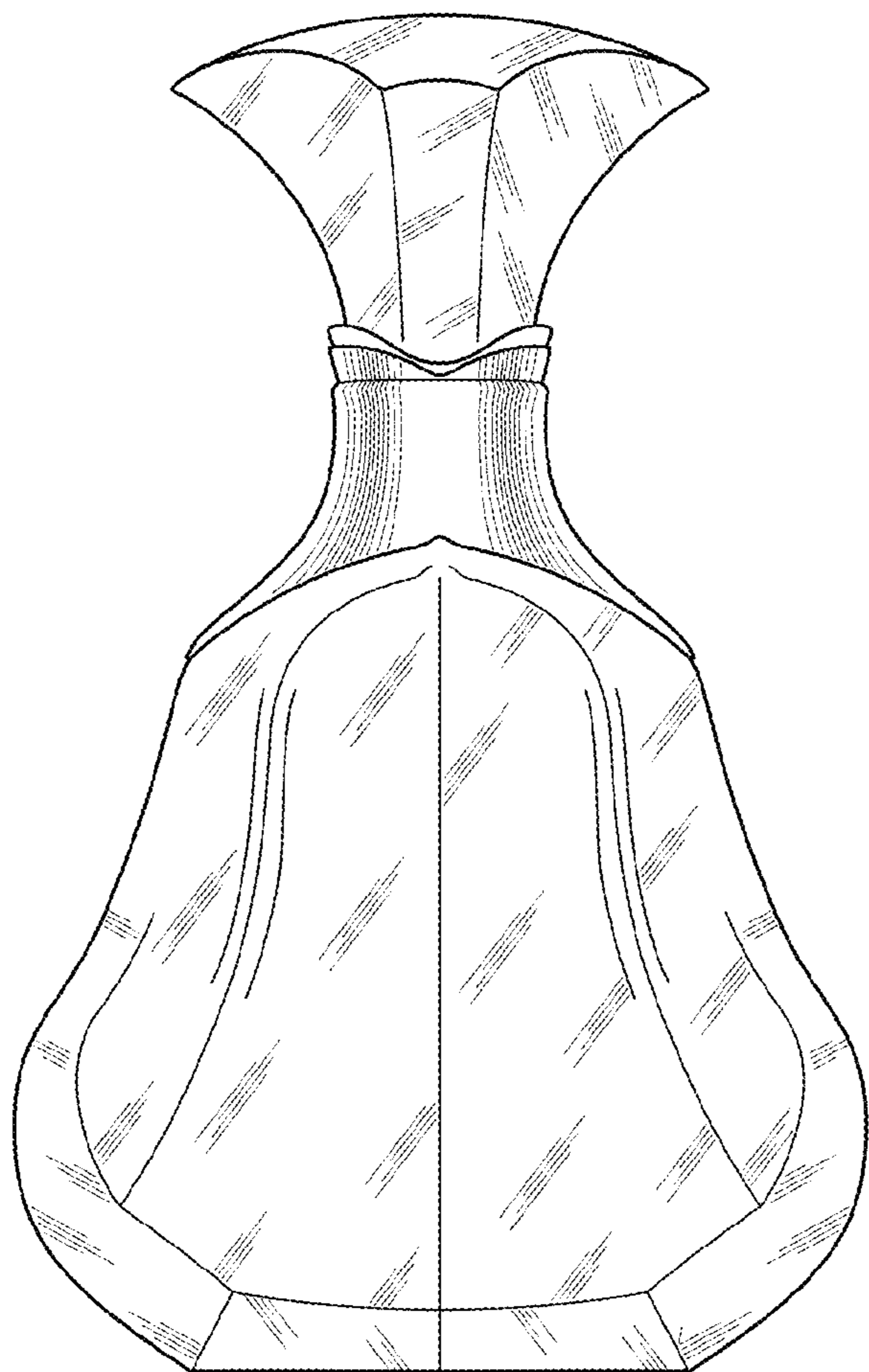
FIG. 1 is a perspective view of a decanter in accordance with my design;

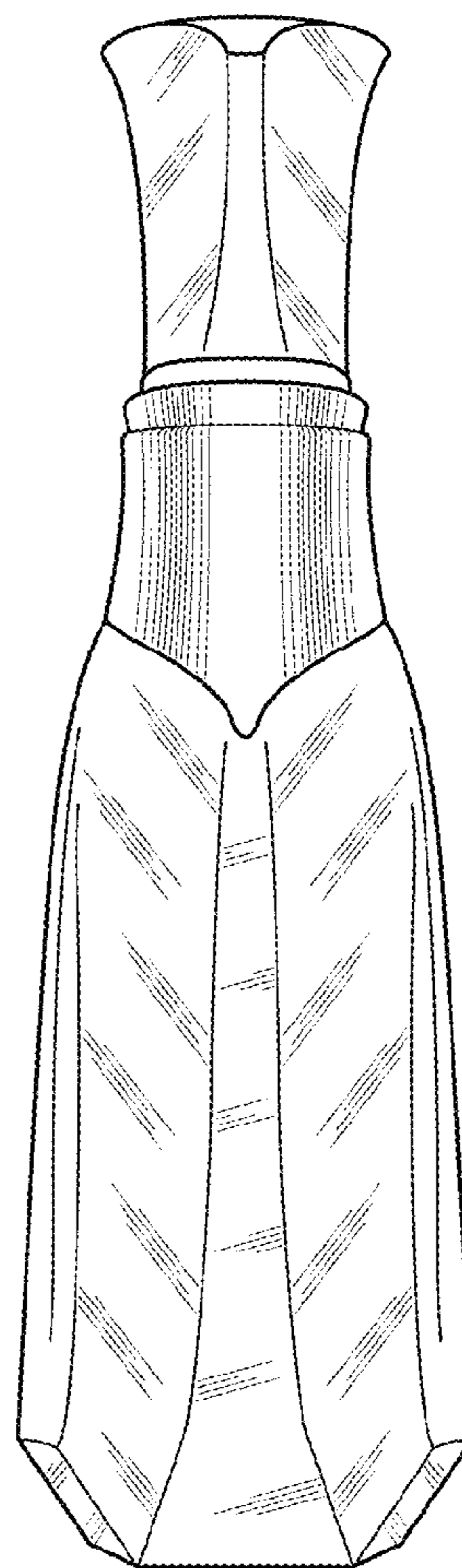




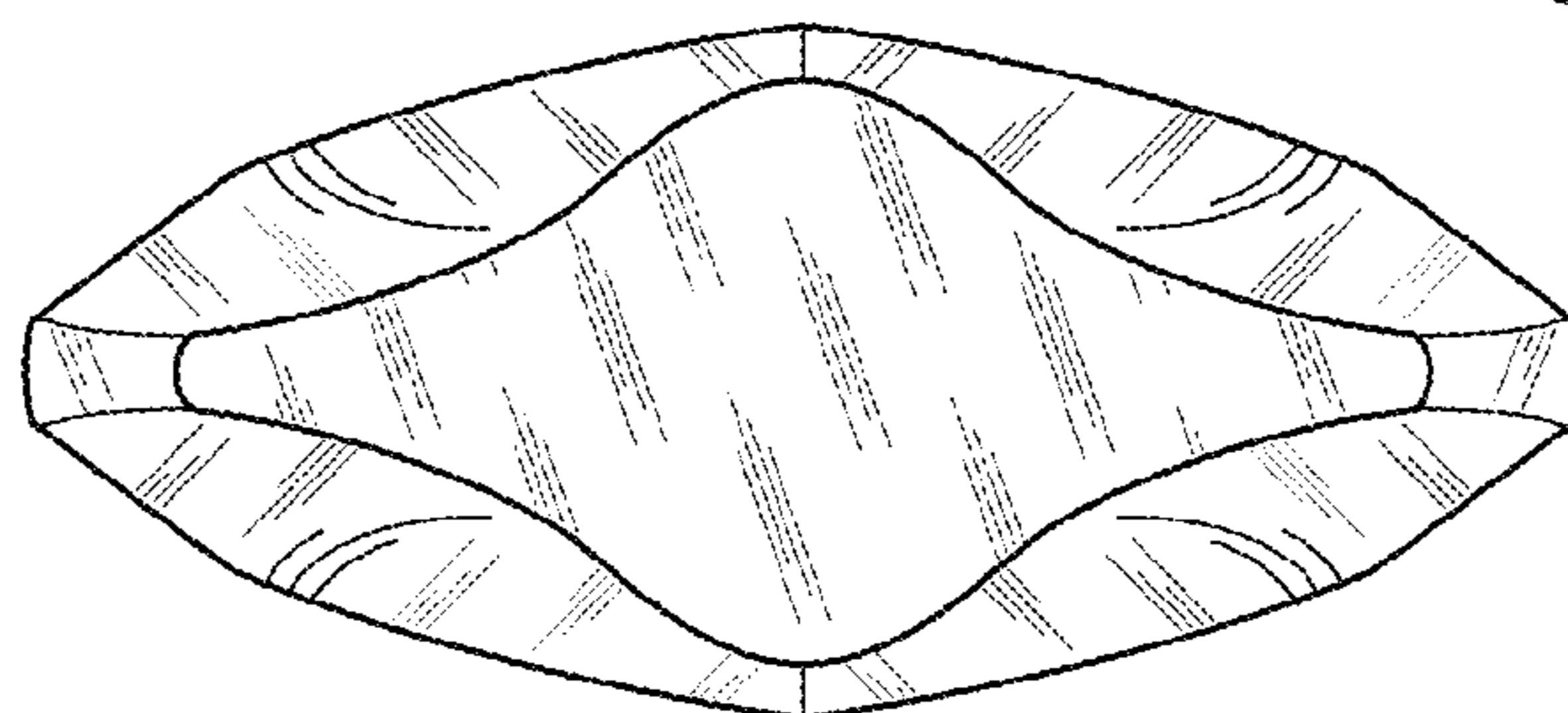

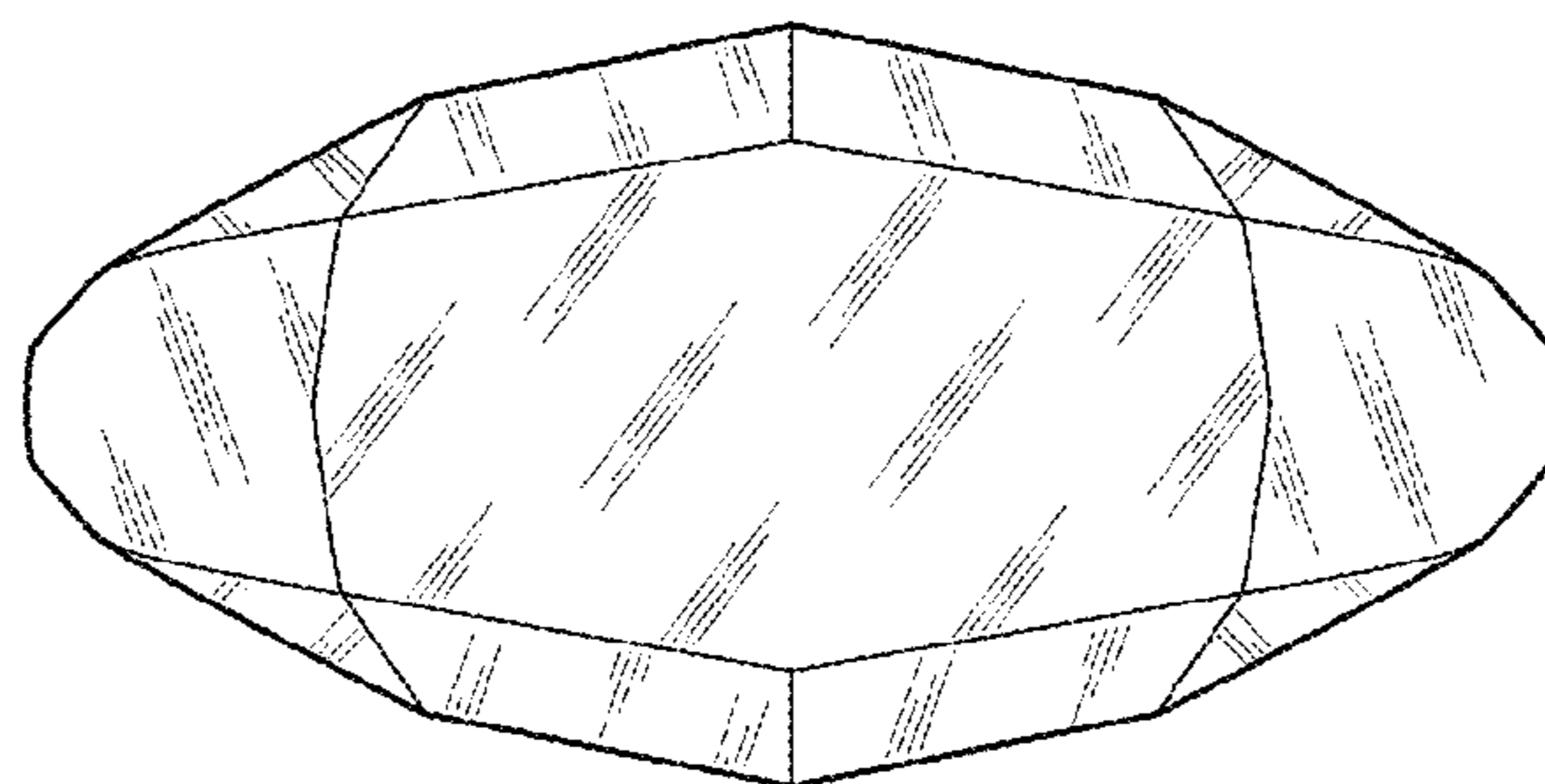
