The ornamental design for packaging for sanitation gloves, as shown and described.

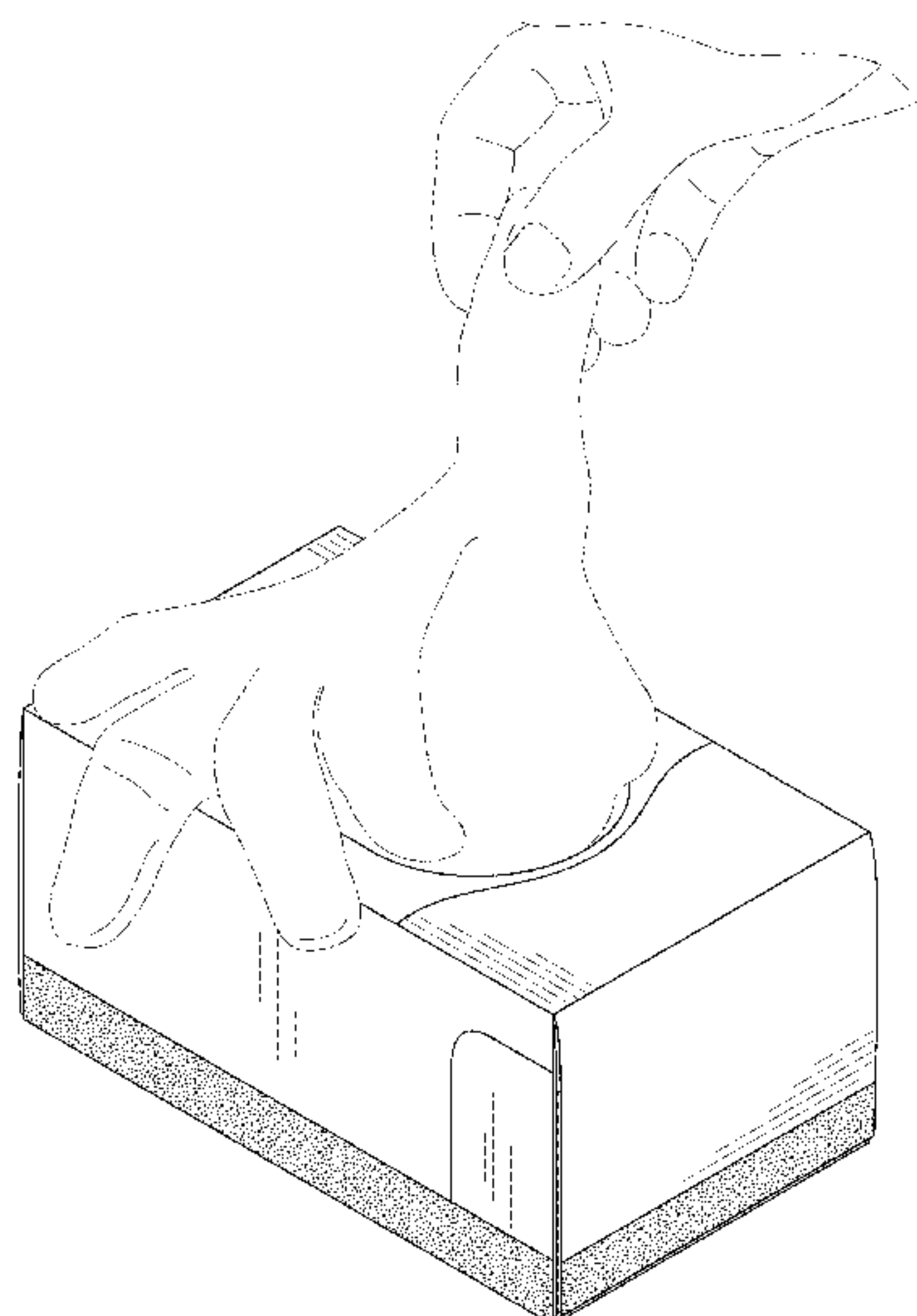
**DESCRIPTION**

FIG. 1 is a front perspective view of packaging for sanitation gloves showing a first embodiment of my new design; FIG. 2 is a front perspective view thereof with the unclaimed hand and glove depictions removed; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a front perspective view of packaging for sanitation gloves showing a second embodiment of my new design; FIG. 10 is a front elevation view thereof; FIG. 11 is a rear elevation view thereof; FIG. 12 is a right side elevation view thereof; FIG. 13 is a left side elevation view thereof; FIG. 14 is a top plan view thereof; and, FIG. 15 is a bottom plan view thereof.

The hand and glove depictions shown in broken lines represent environment in which the design is used and form no part of the claimed design.

The dotted lines shown in FIGS. 9 and 14 represent claimed perforations. The surface stippling represents a contrast of color.

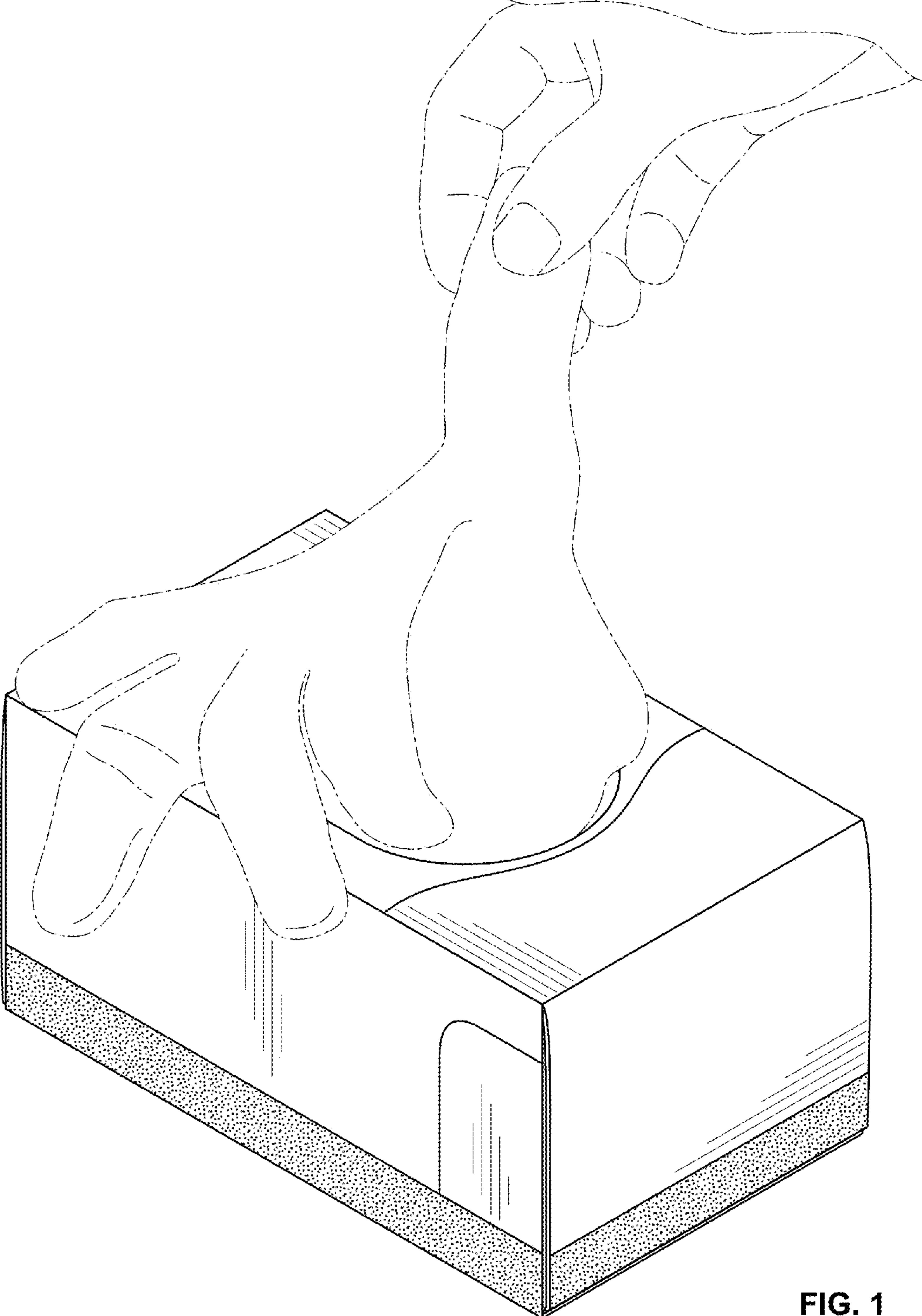

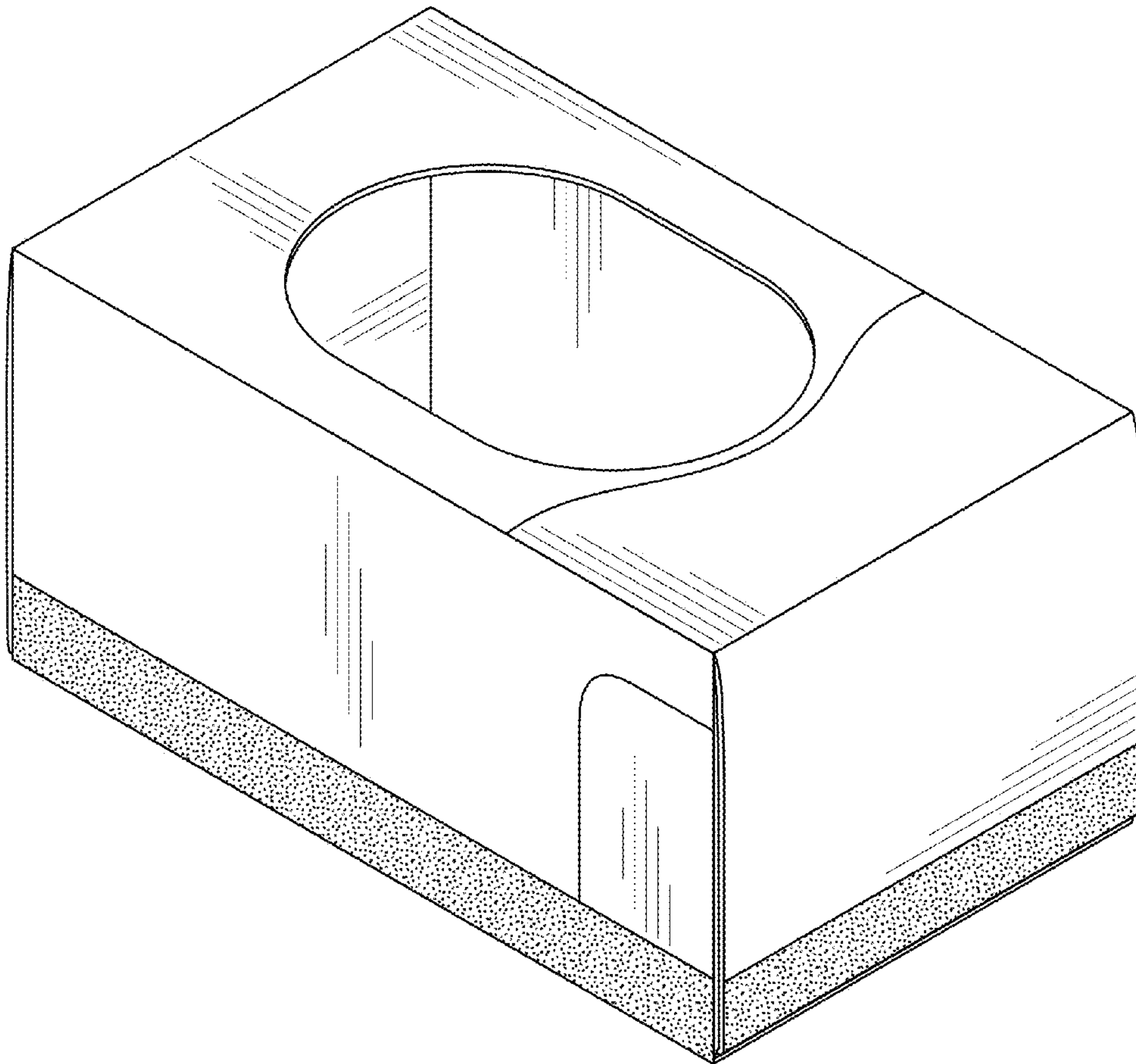

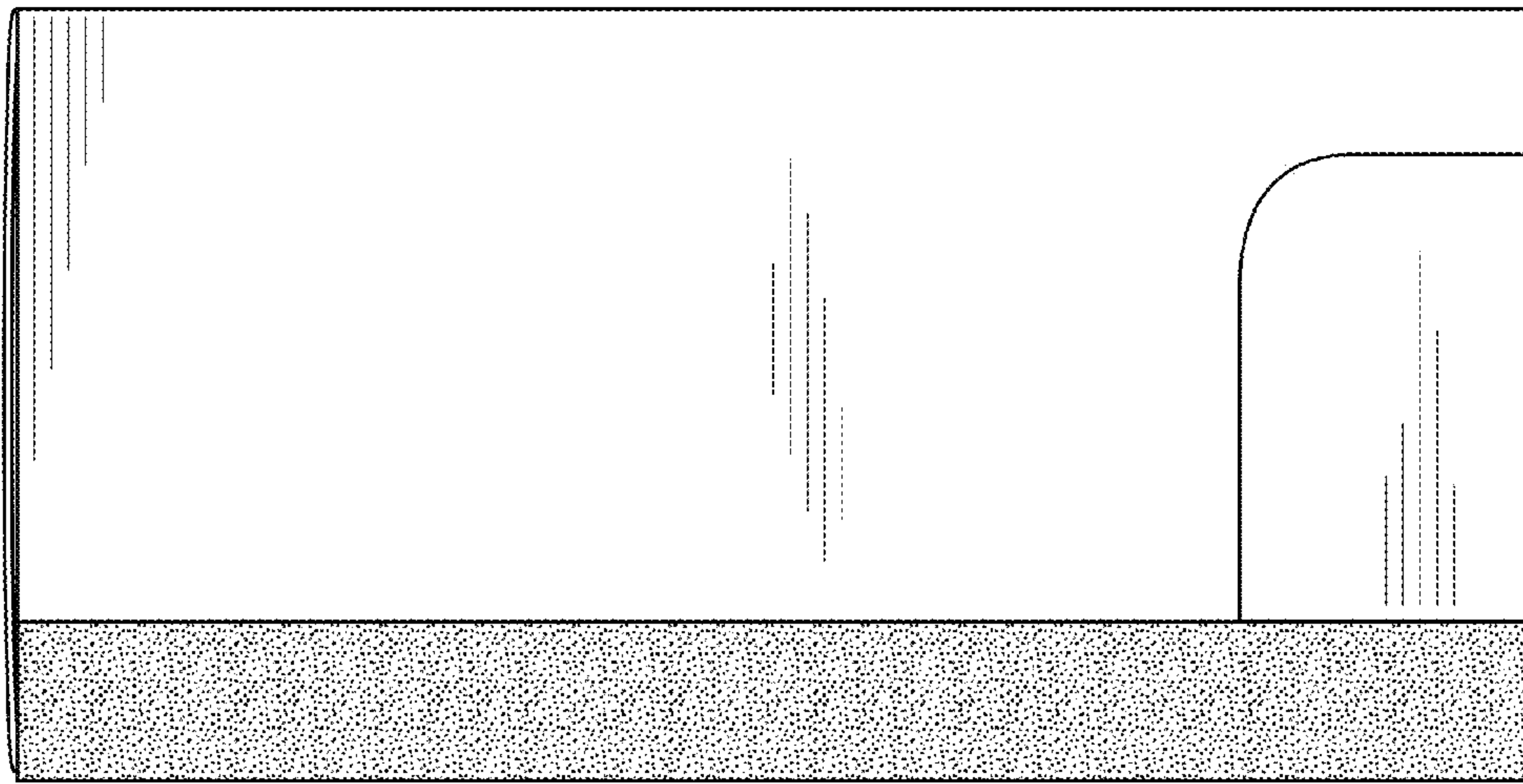

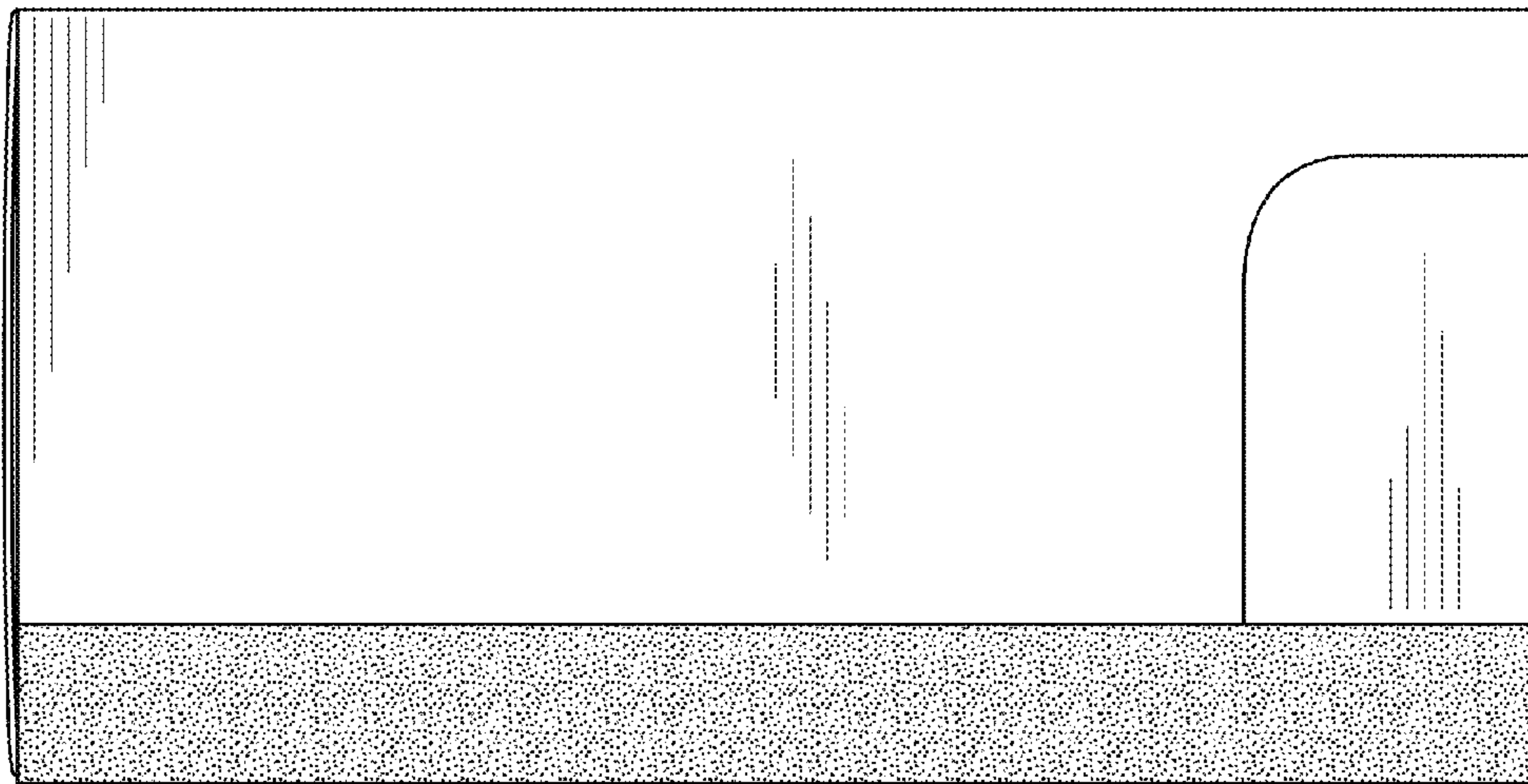

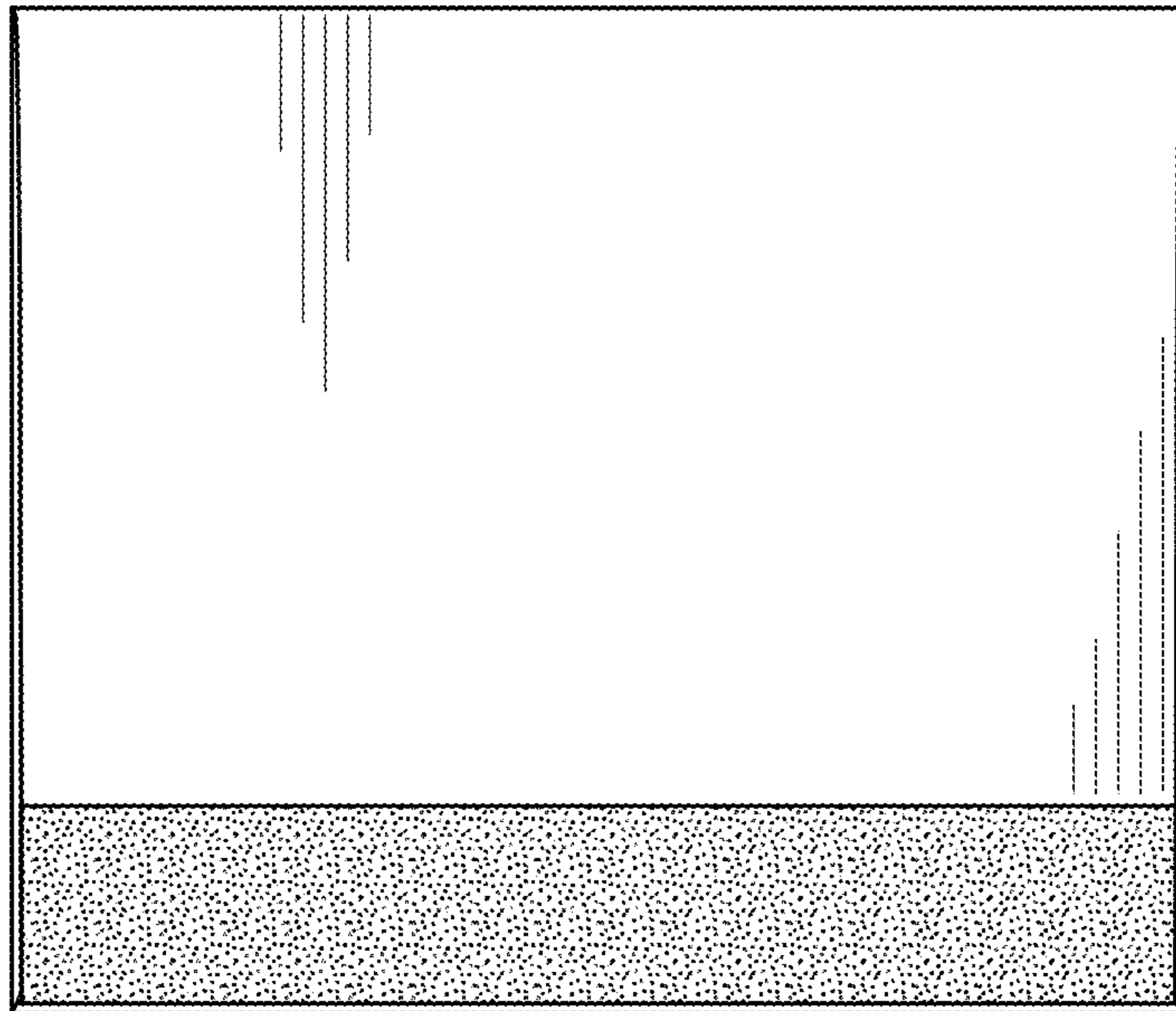

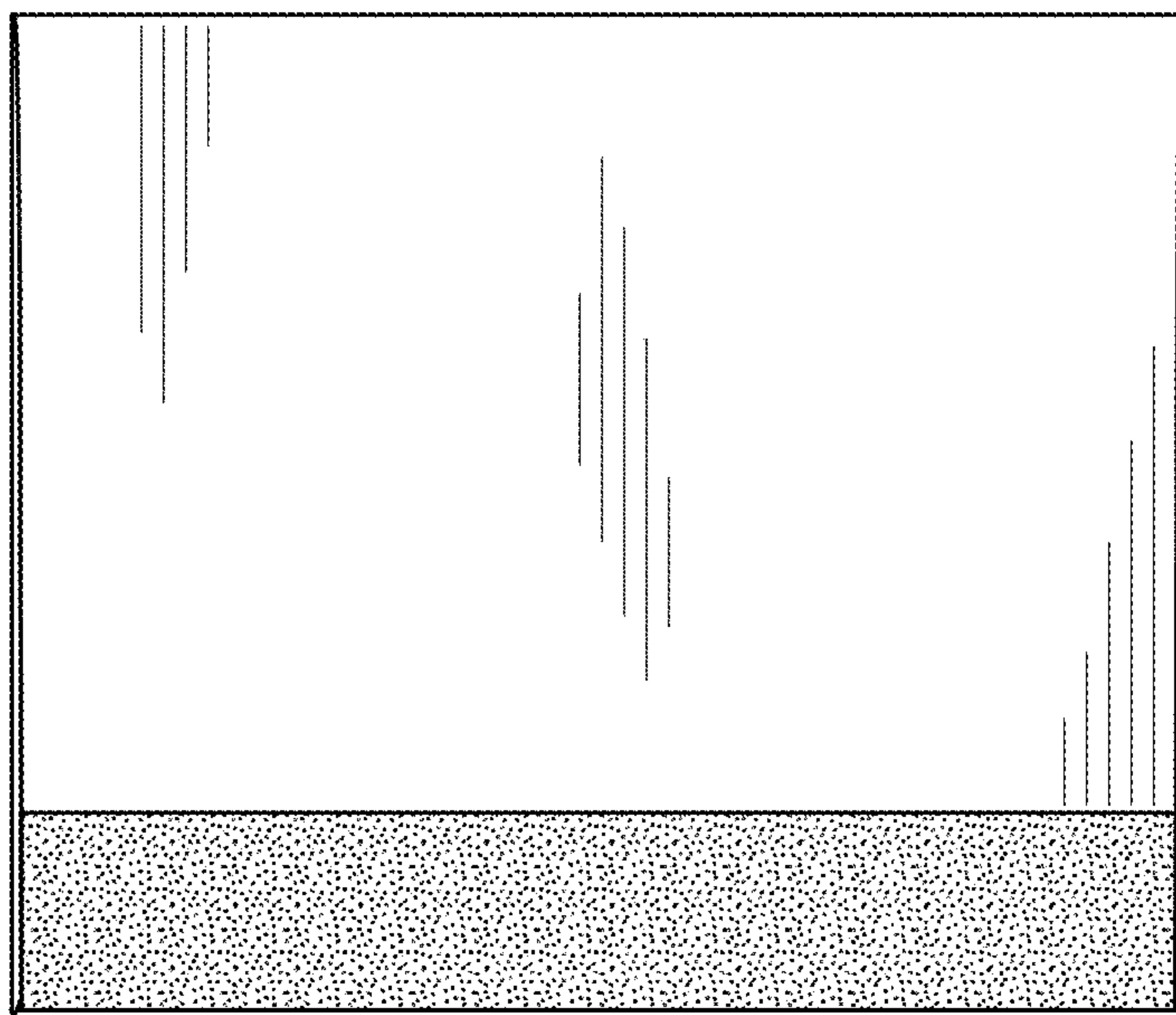

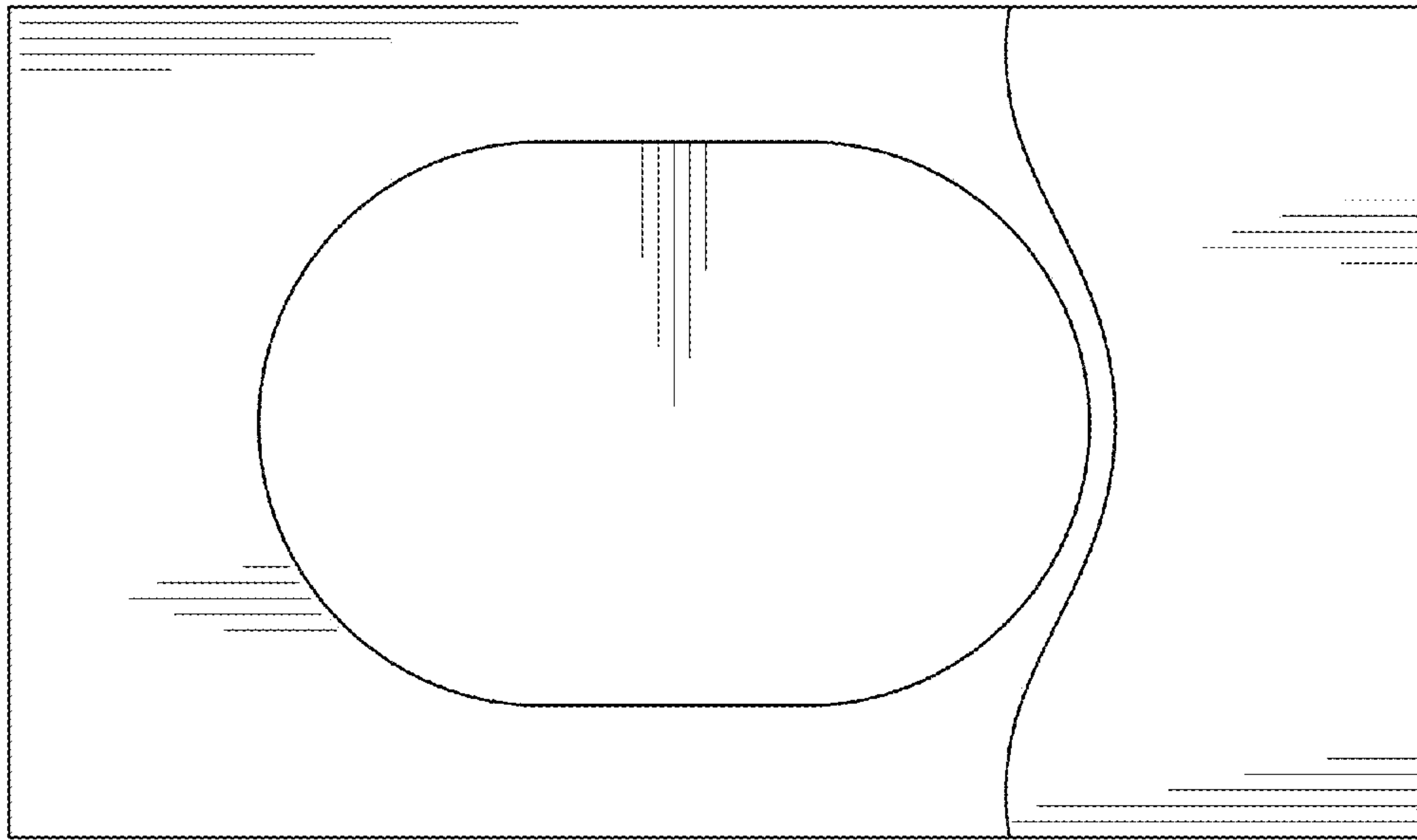

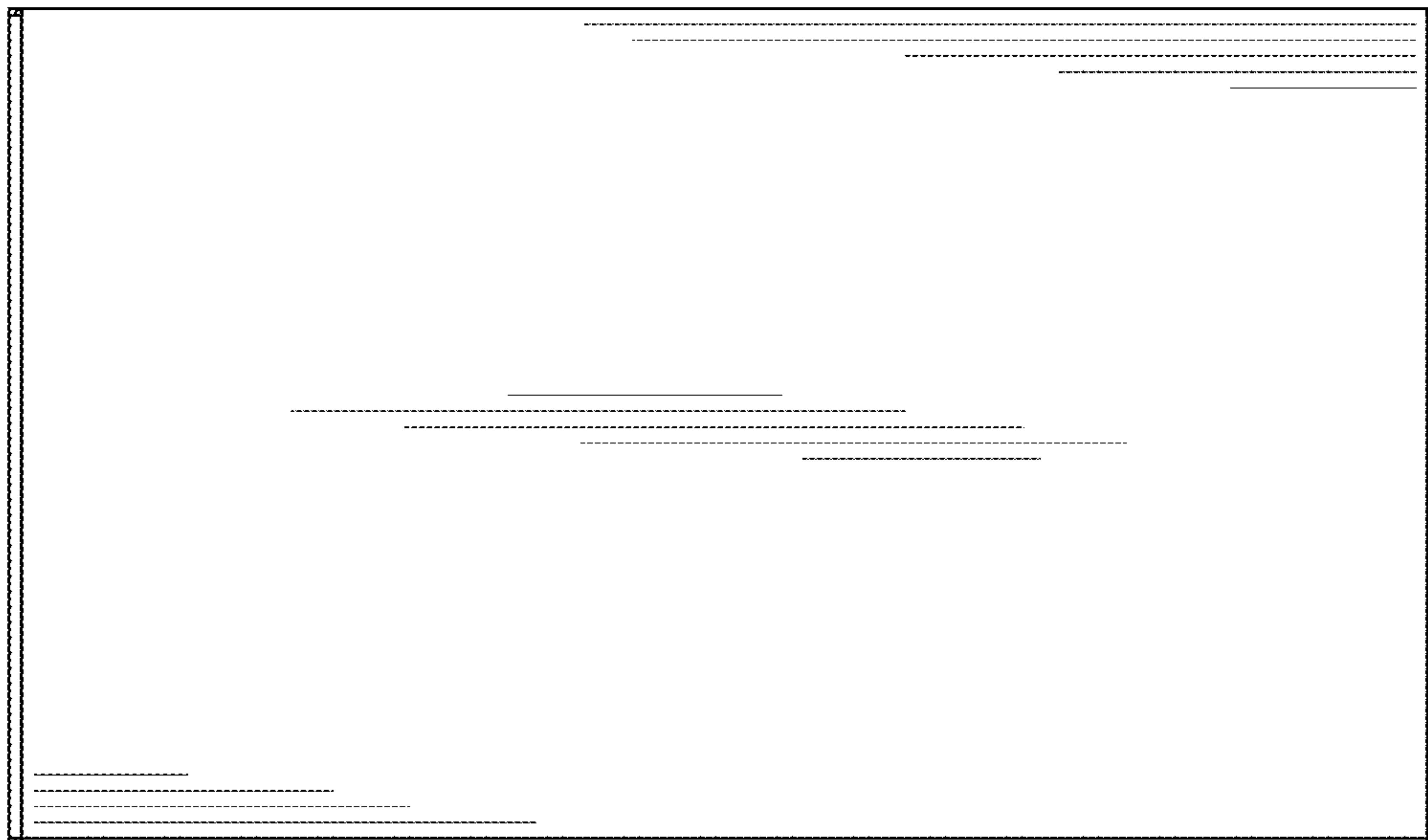

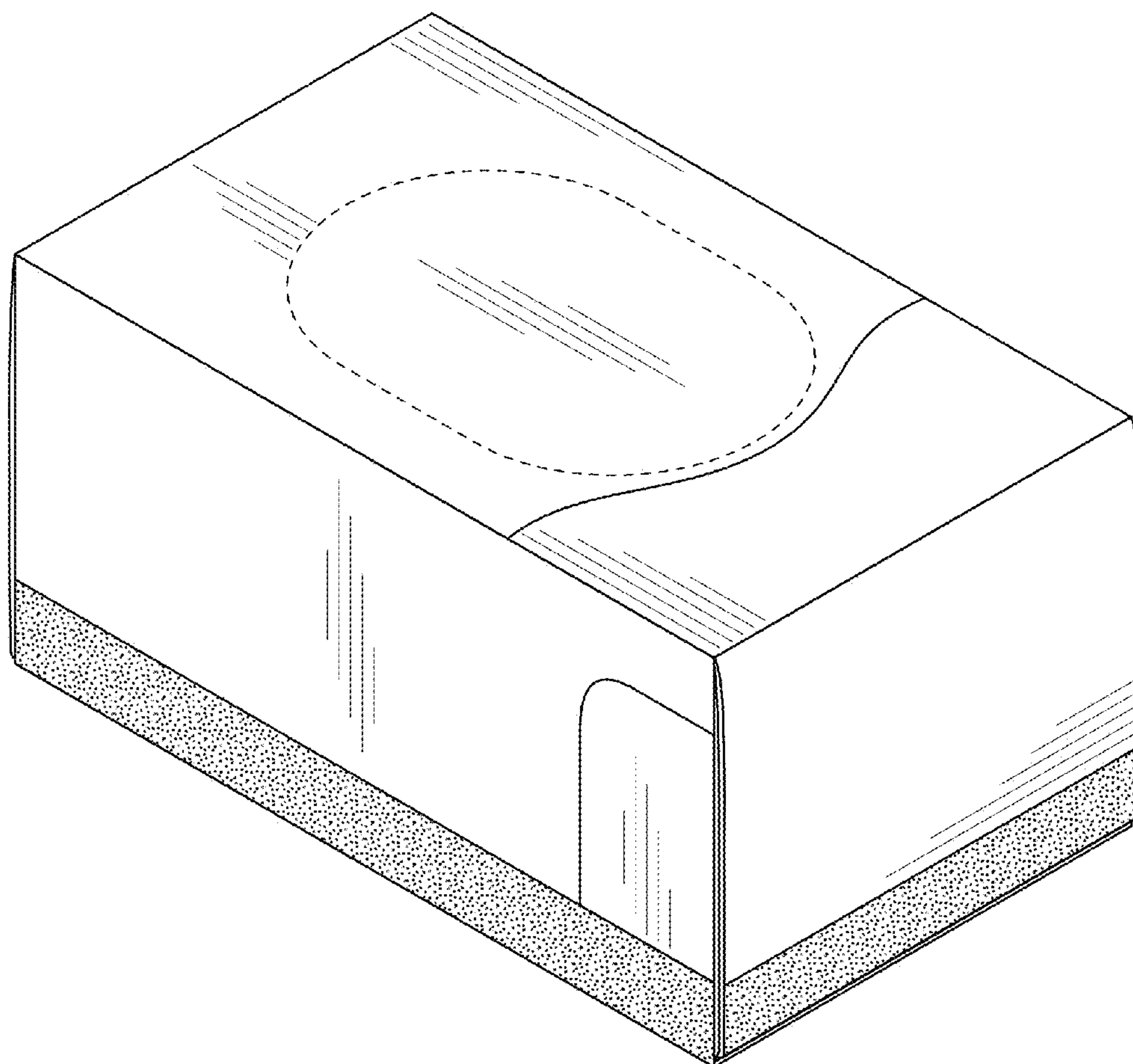

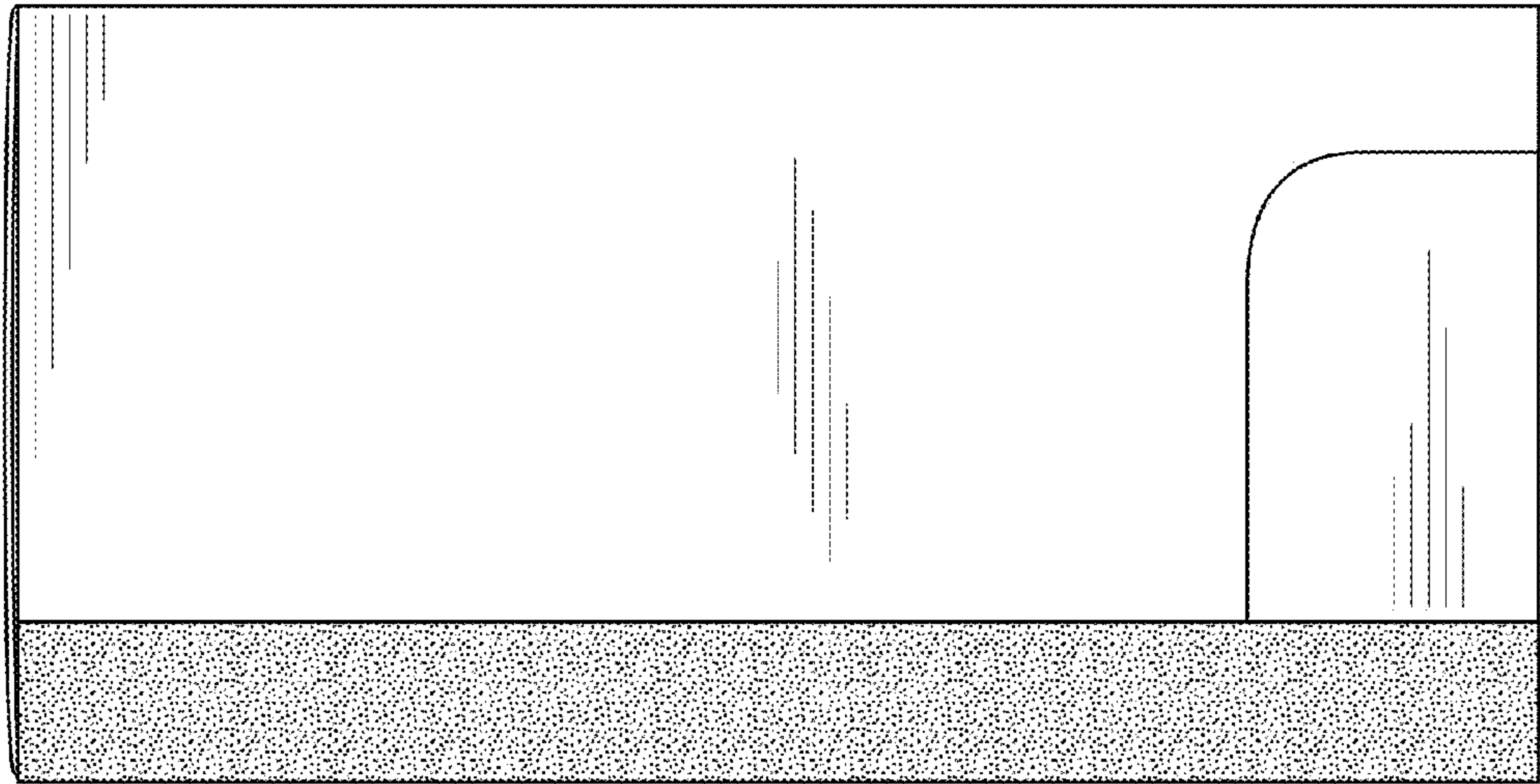

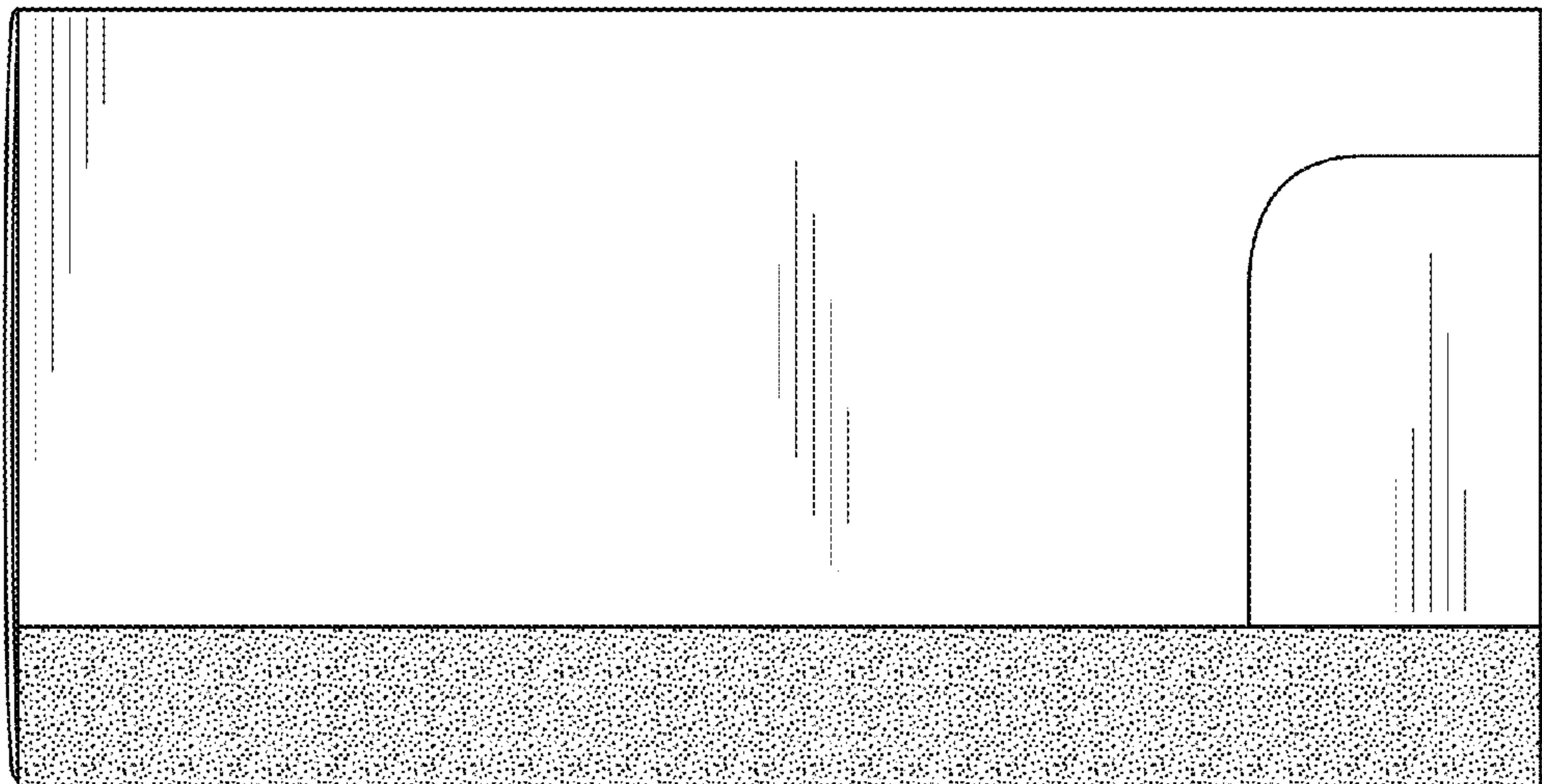

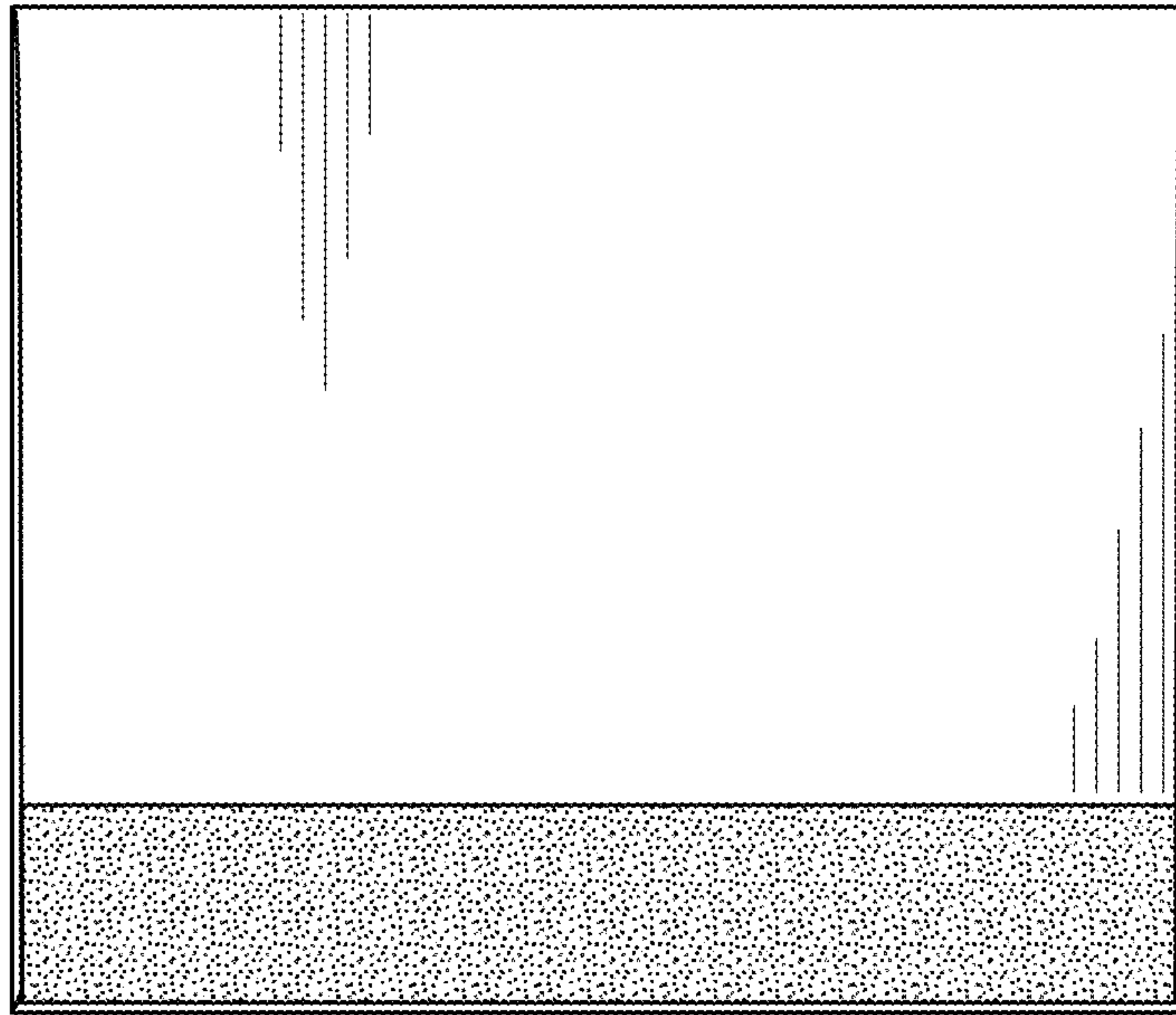

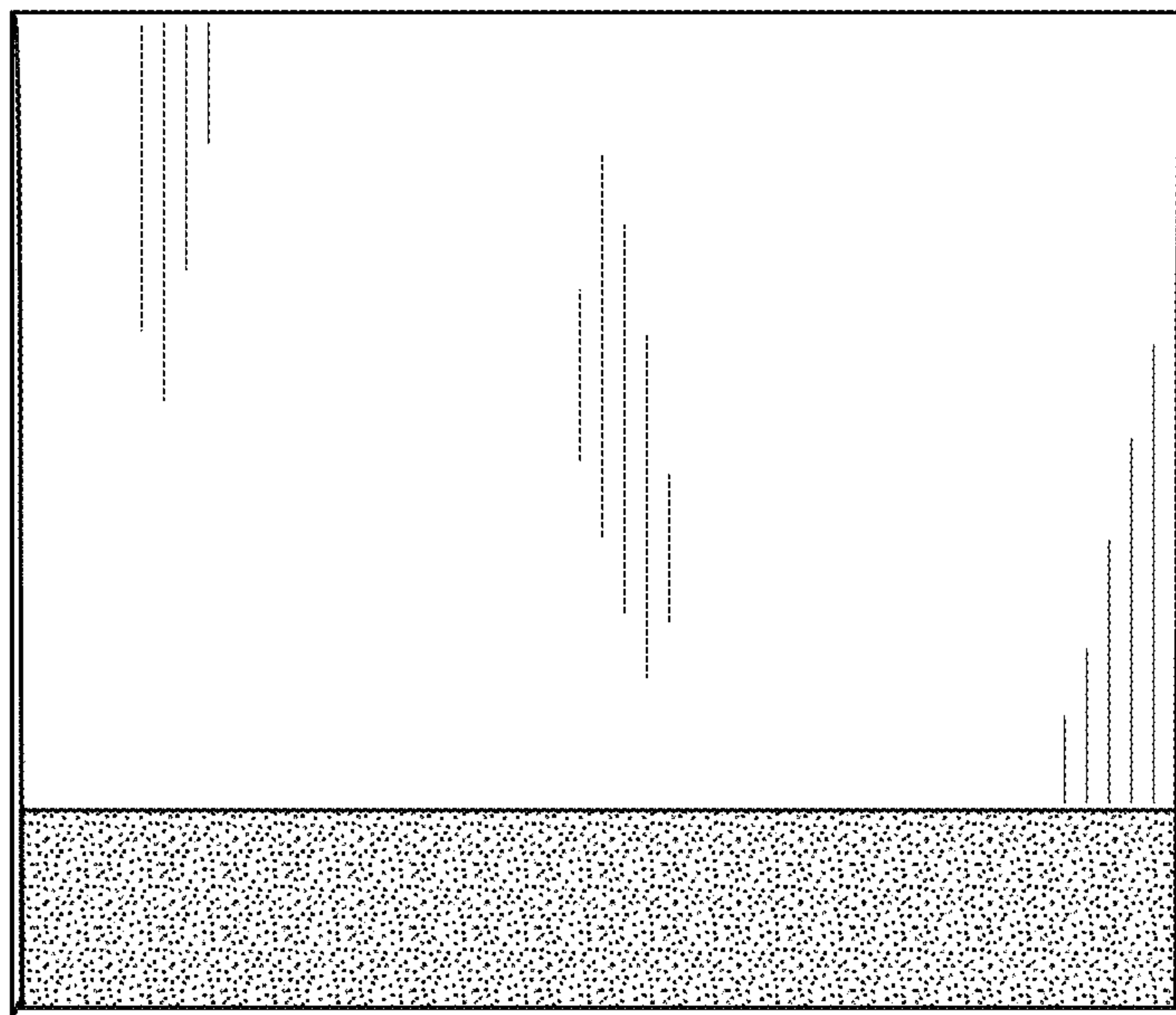

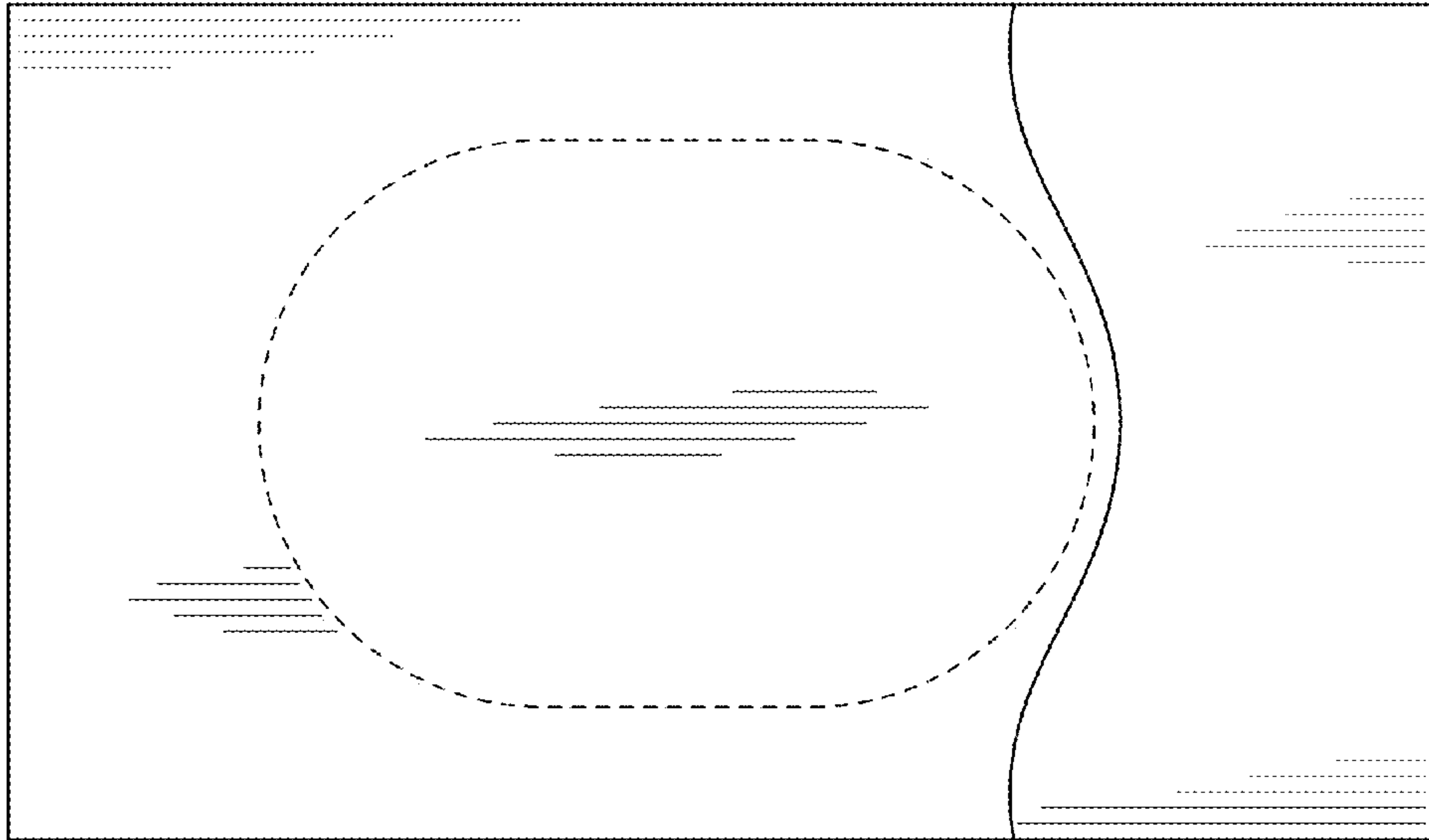

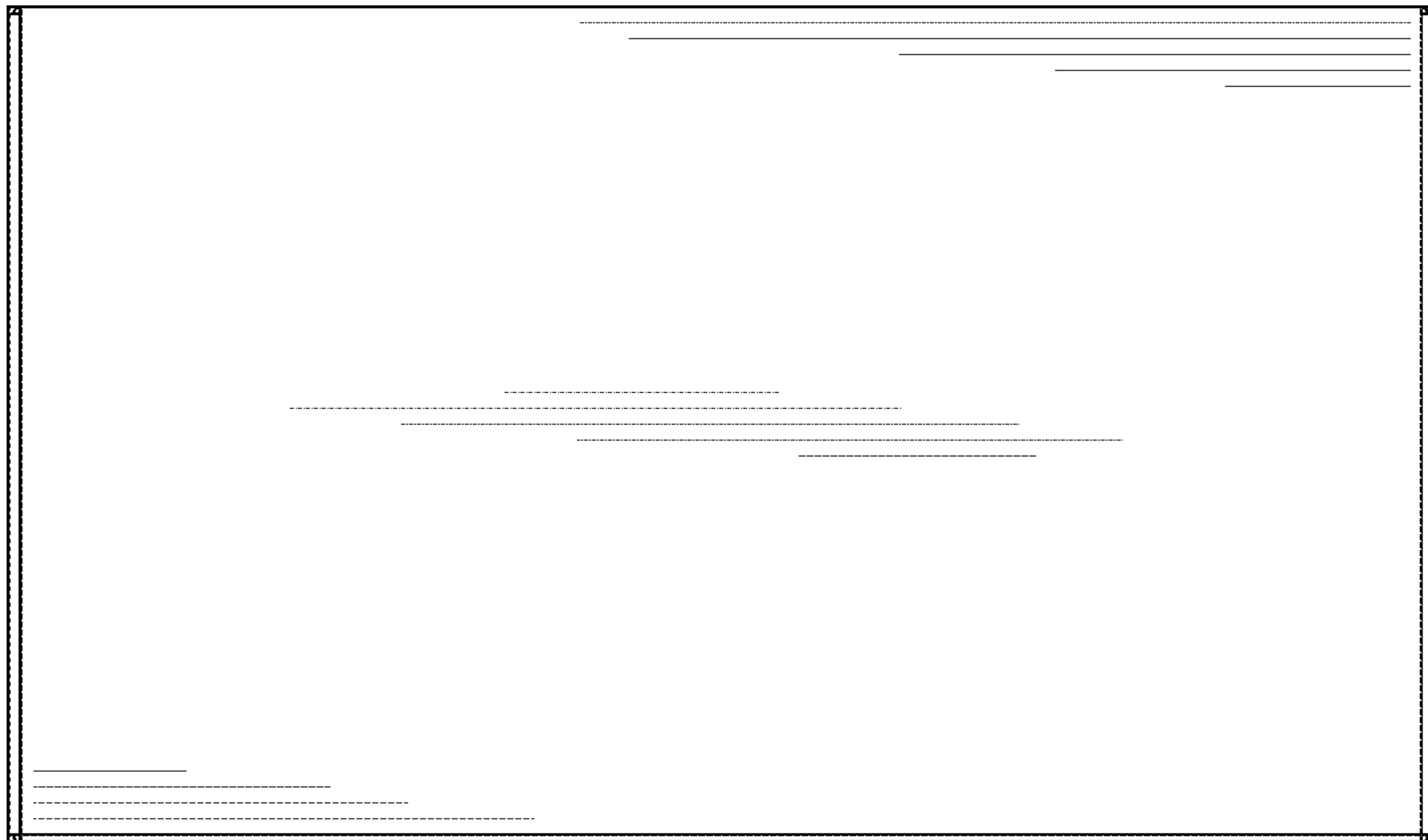
