DESCRIPTION

FIG. 1 is a right side, front and top perspective view of a cork factory cork holder showing my new design;

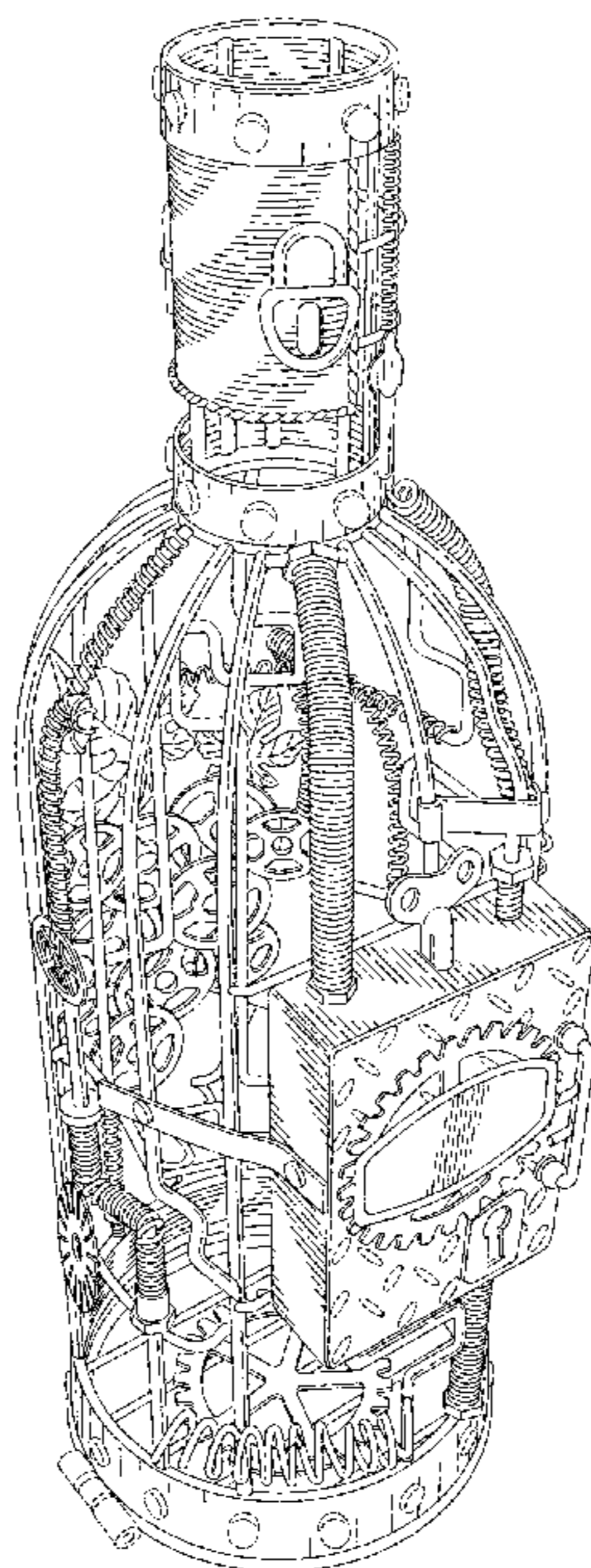
FIG. 2 is a front, left side and top perspective view thereof;

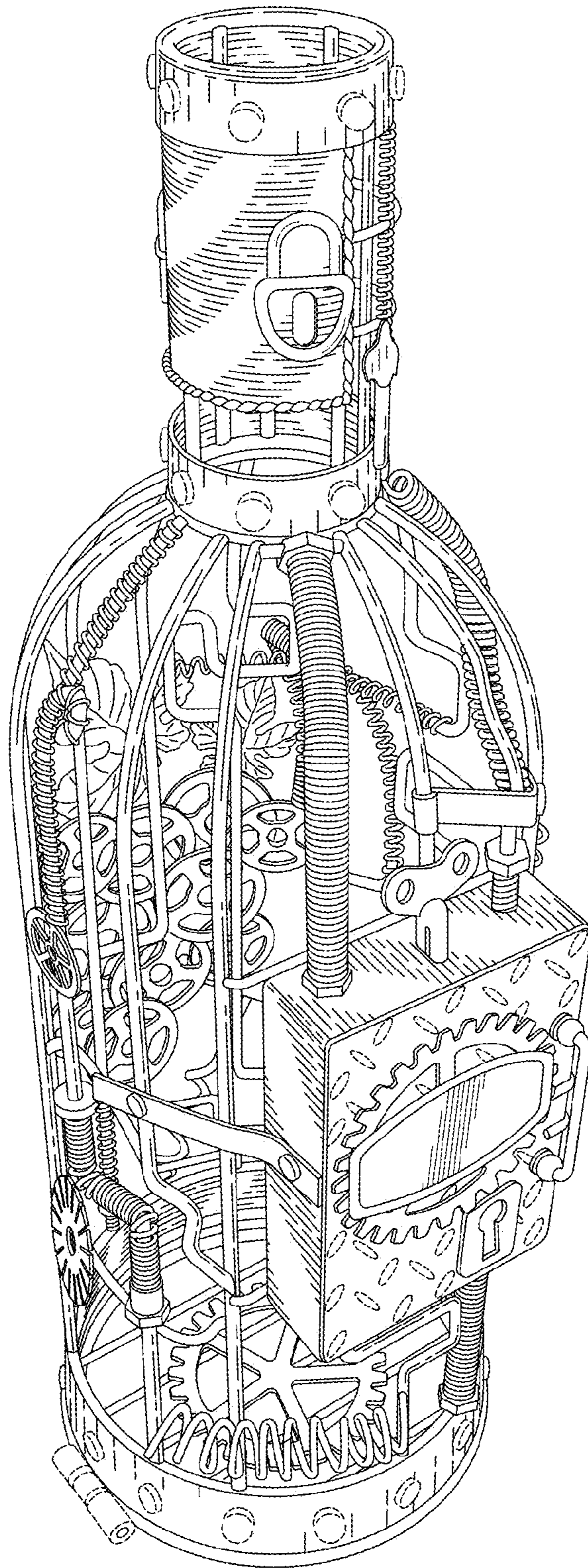

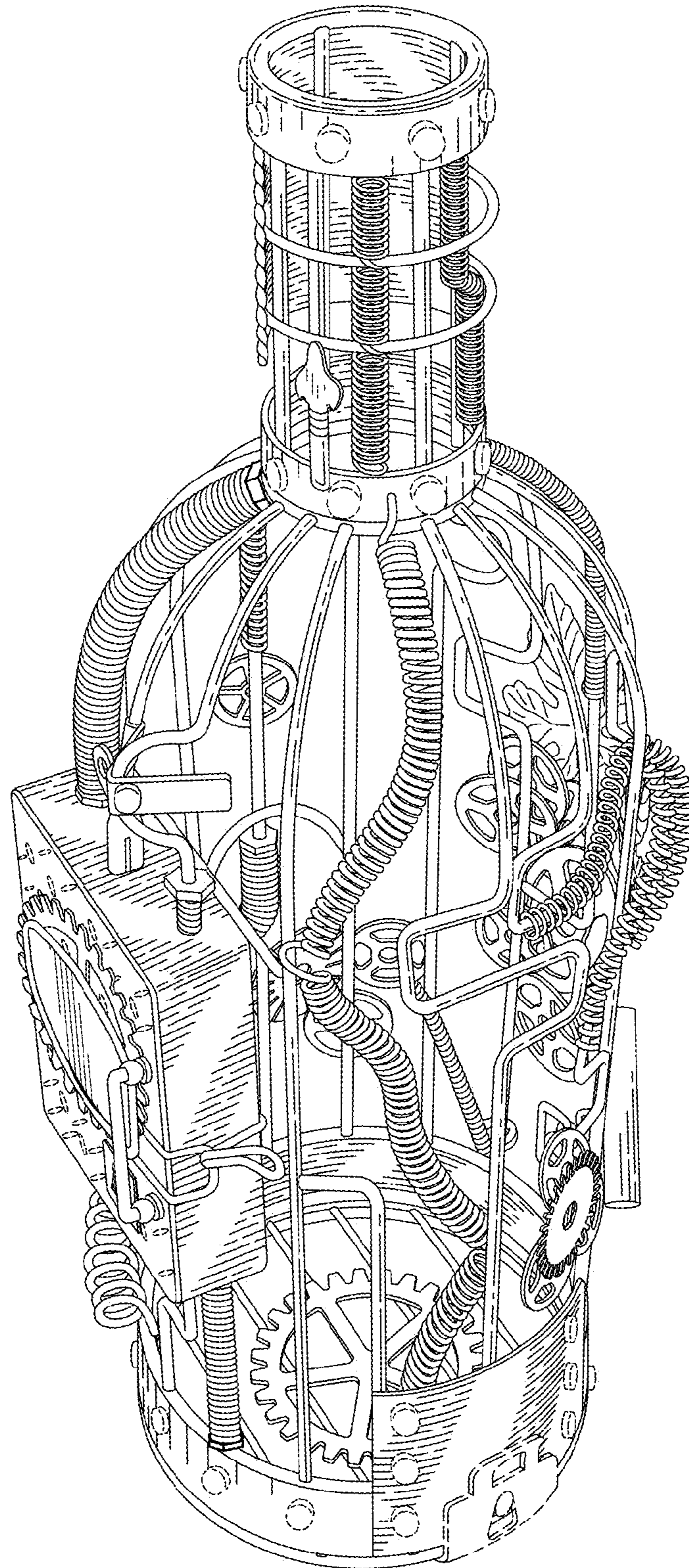

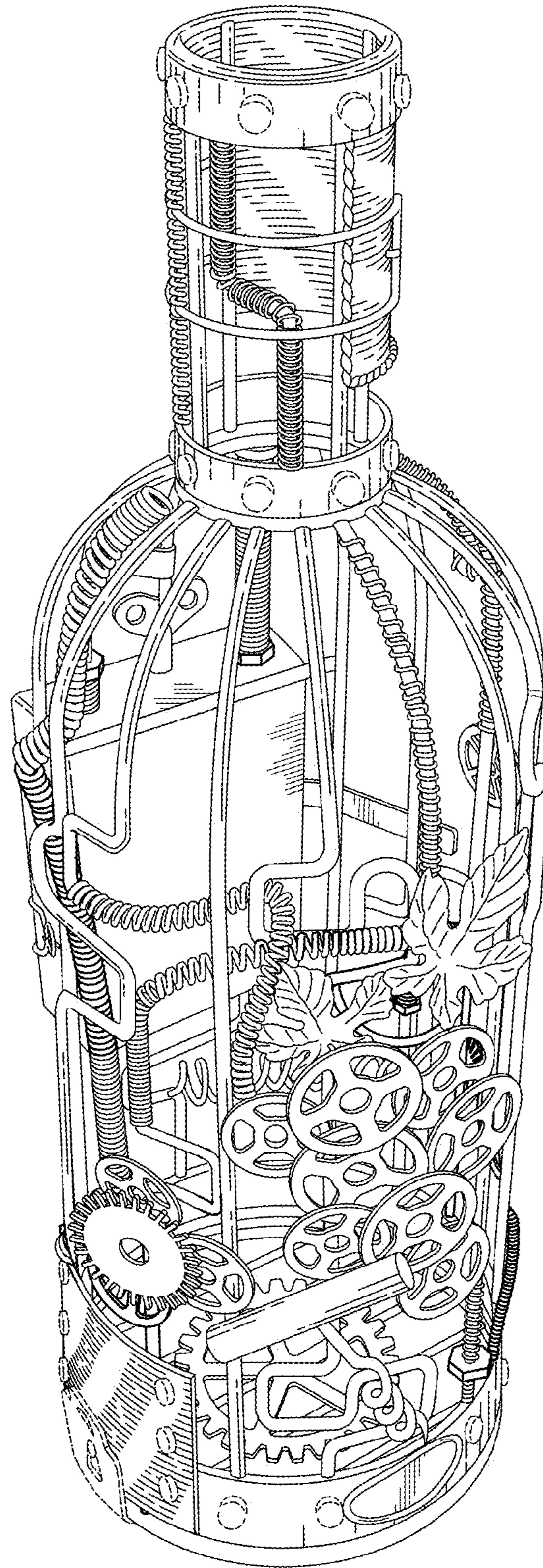

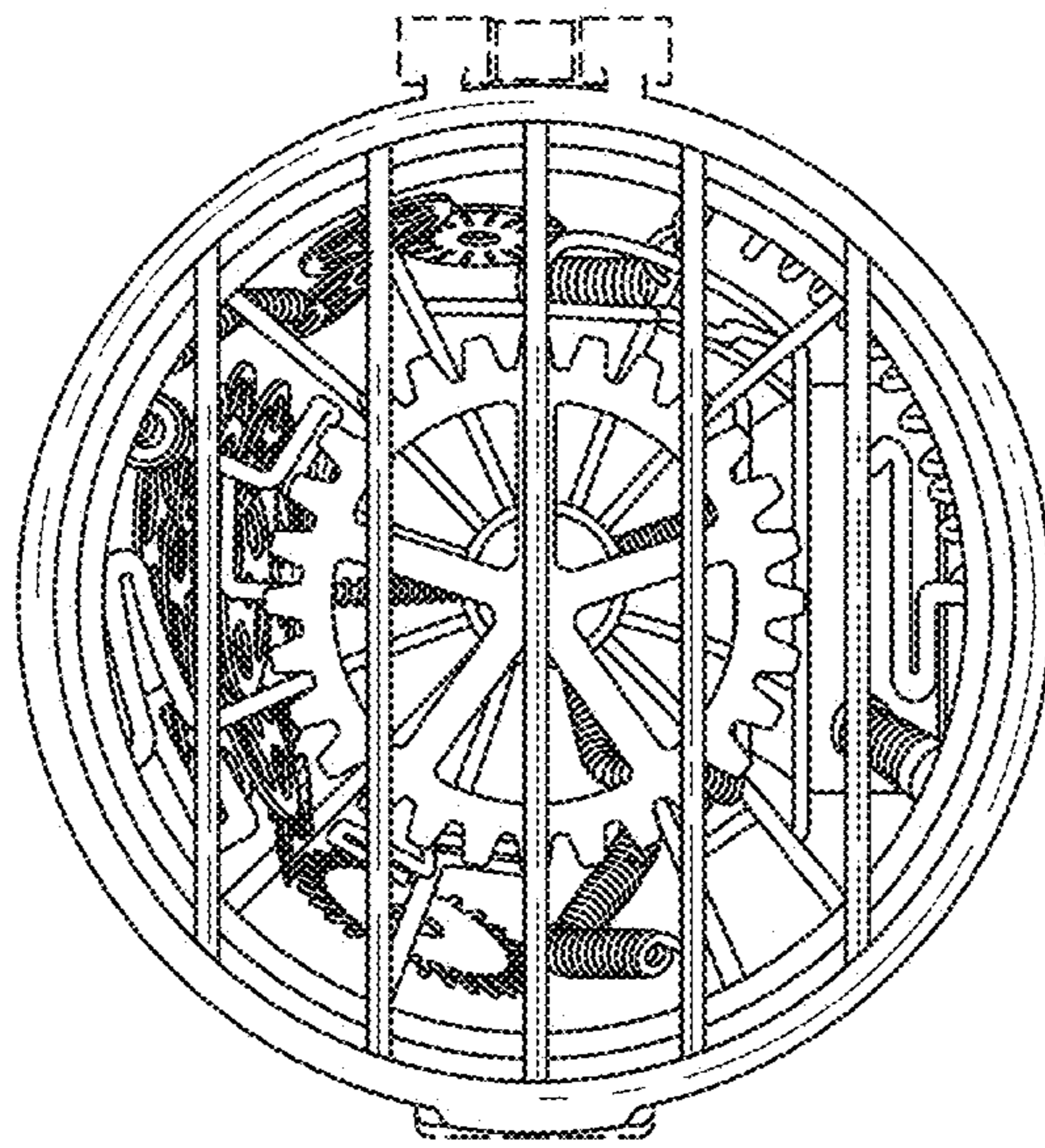
