(57) **CLAIM**

The ornamental design for a recharging terminal for electric vehicles, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a recharging terminal for electric vehicles, embodying the inventive ornamental design;  
FIG. 2 is a front elevation view of the apparatus of FIG. 1, embodying the inventive design;  
FIG. 3 is a rear elevation view of the apparatus of FIG. 1, embodying the inventive design;  
FIG. 4 is a top plan view of the apparatus of FIG. 1, embodying the inventive design;  
FIG. 5 is a bottom plan view of the apparatus of FIG. 1, embodying the inventive design;  
FIG. 6 is a right side elevation view of the apparatus of FIG. 1, embodying the inventive design; and,  
FIG. 7 is a left side elevation view of the apparatus of FIG. 1, embodying the inventive design.

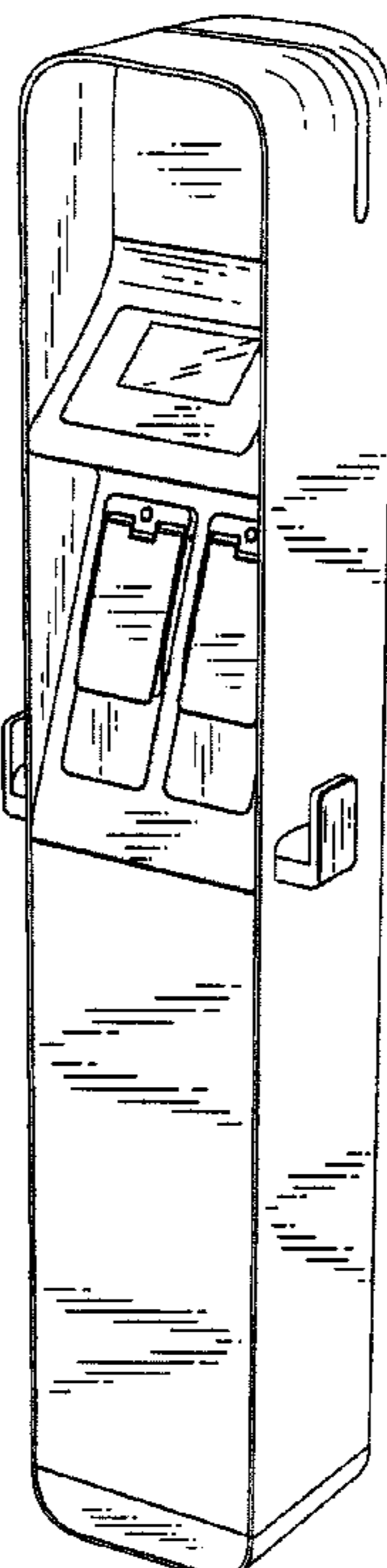

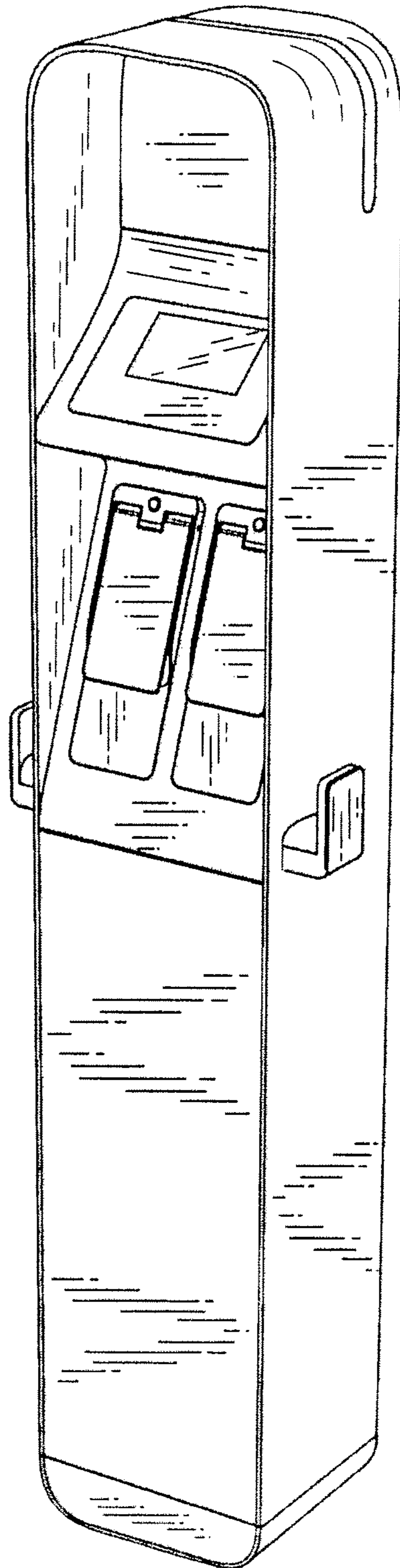

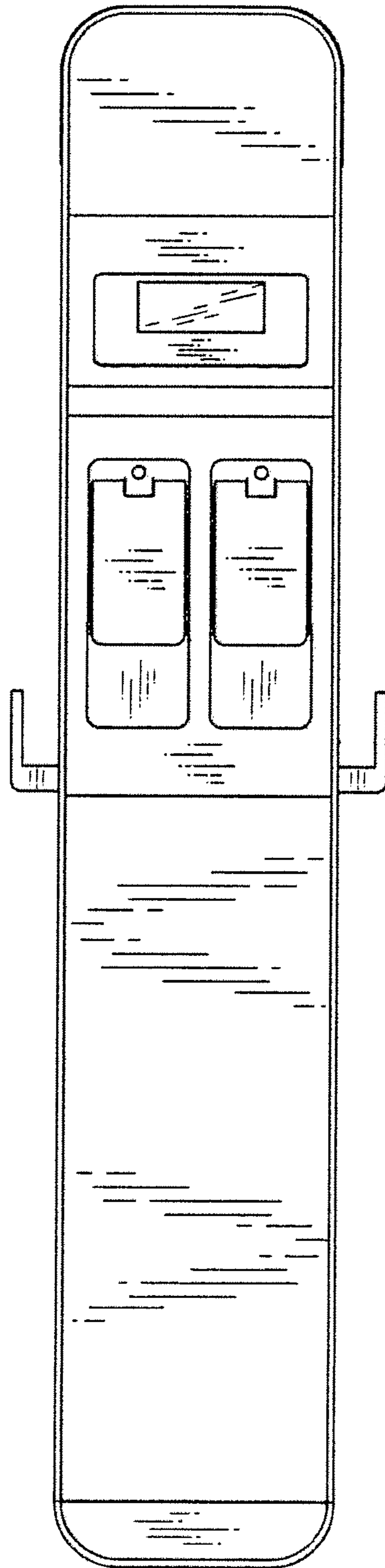

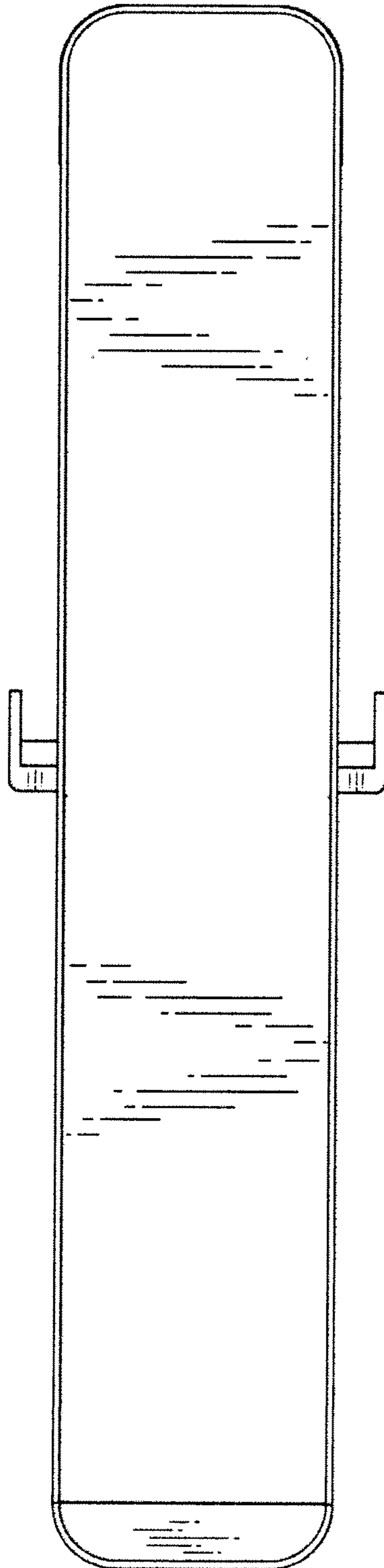

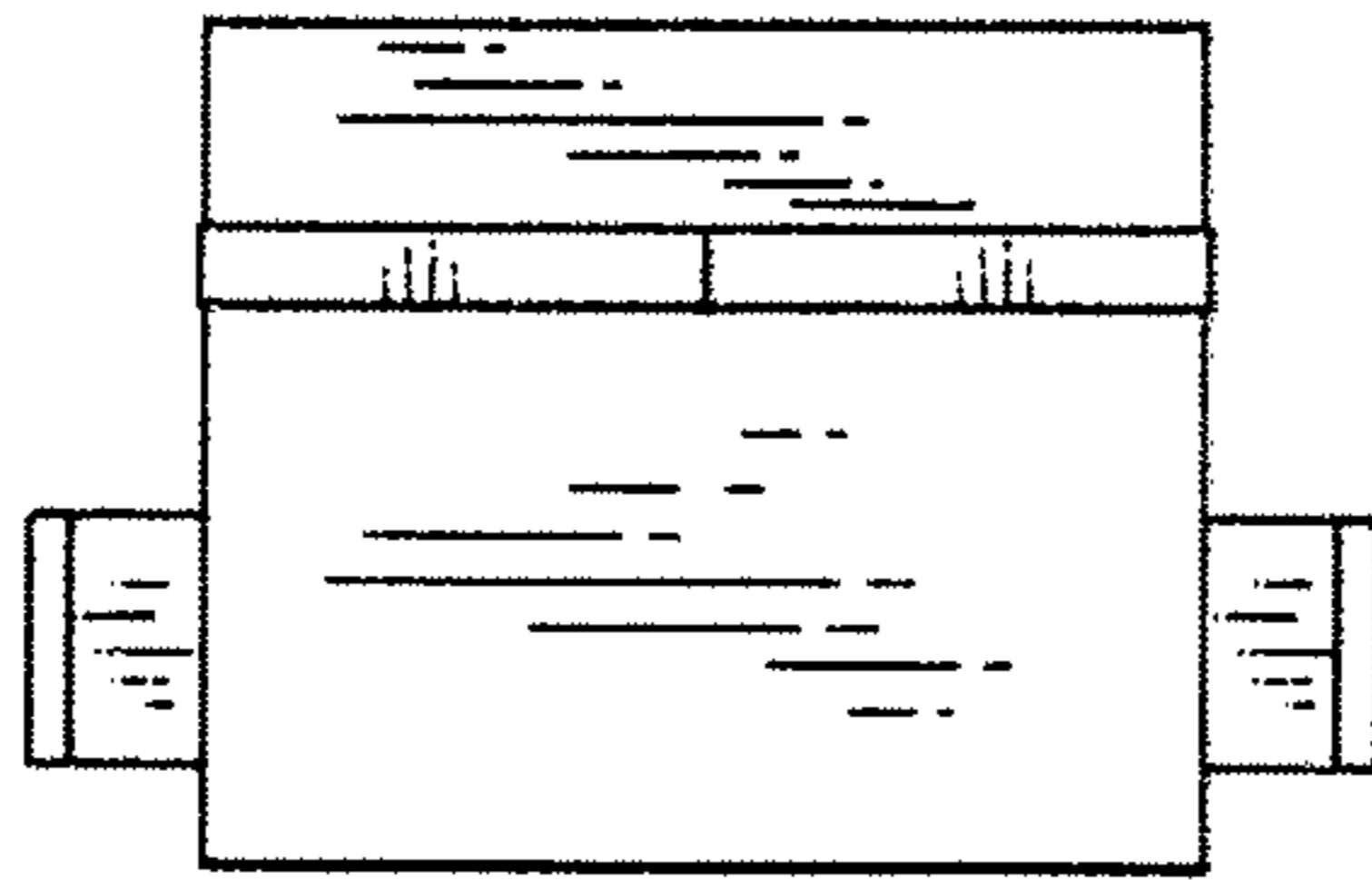

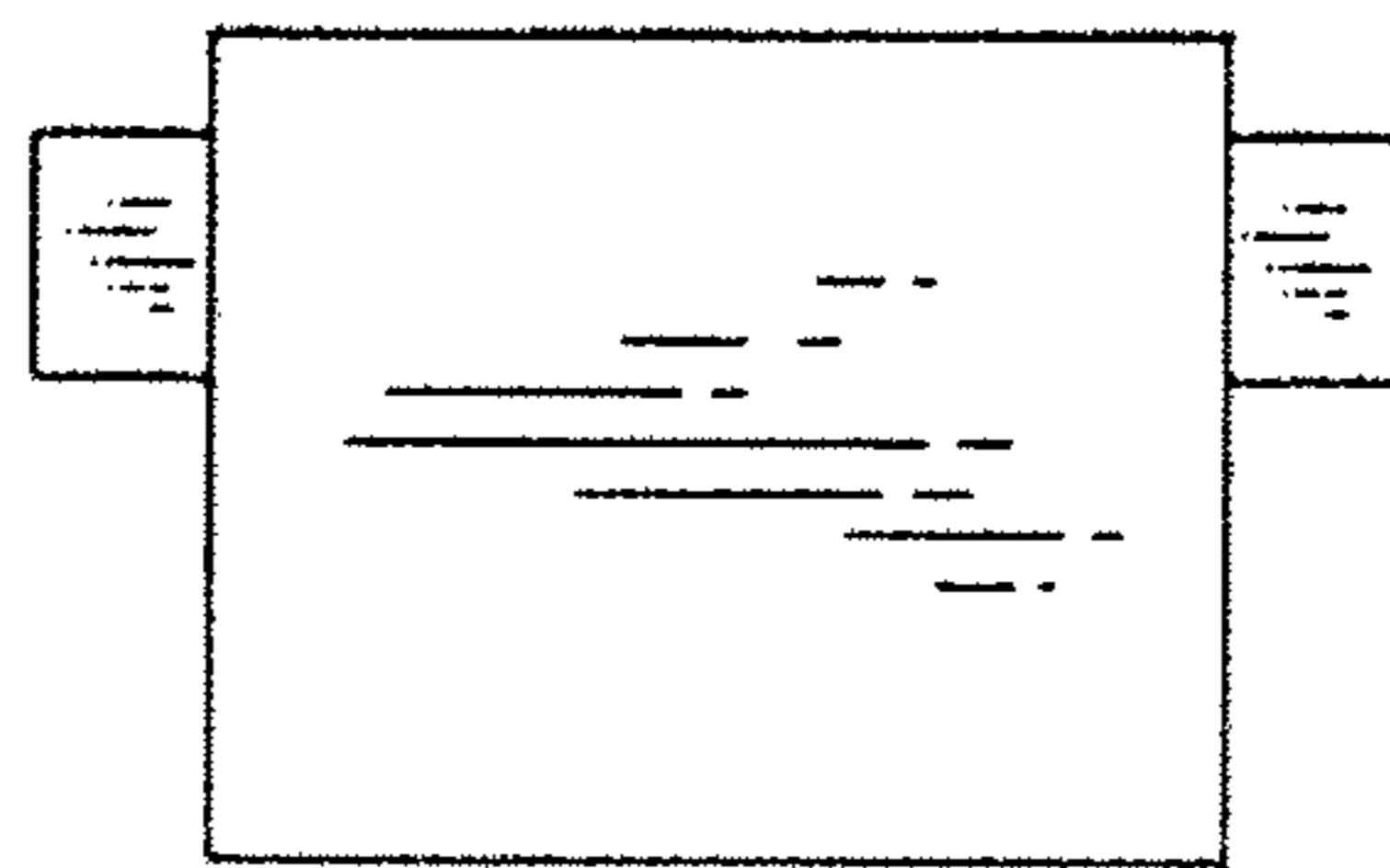

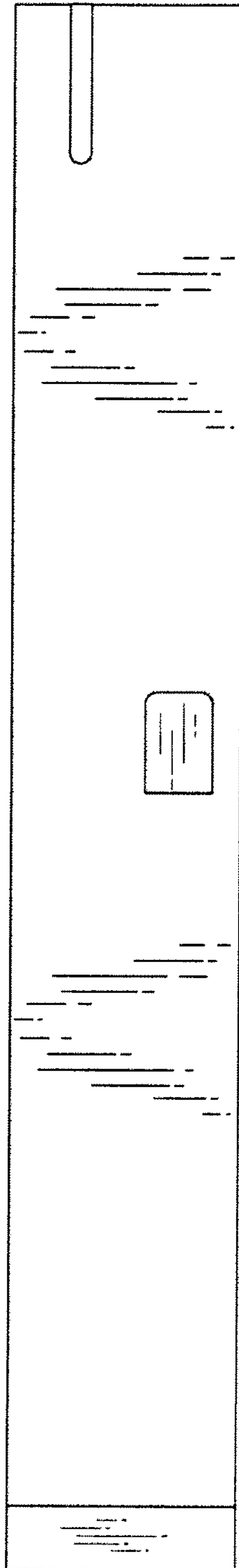
