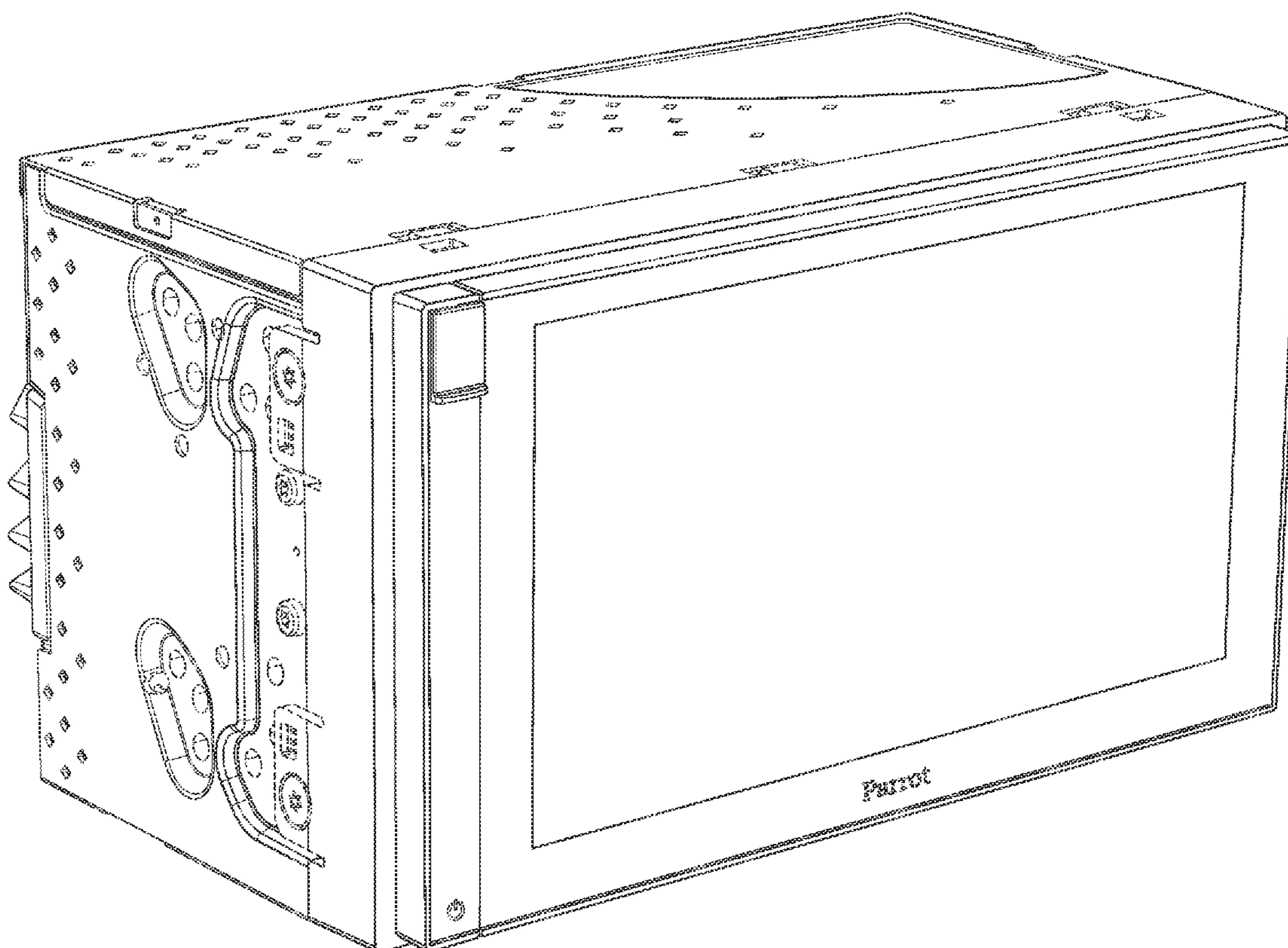
(57) **CLAIM**

The ornamental design for a car stereo with a touch-sensitive screen, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a car stereo with a touch-sensitive screen that has the design.
FIG. 2 is a rear elevation view of the article seen in FIG. 1.
FIG. 3 is a top plan view of the article.
FIG. 4 is a left-side elevation view of the article.
FIG. 5 is a right-side elevation view of the article; and,
FIG. 6 is a front, top, and side view of the article.
The broken lines represent parts of the article that form no part of the claimed design.

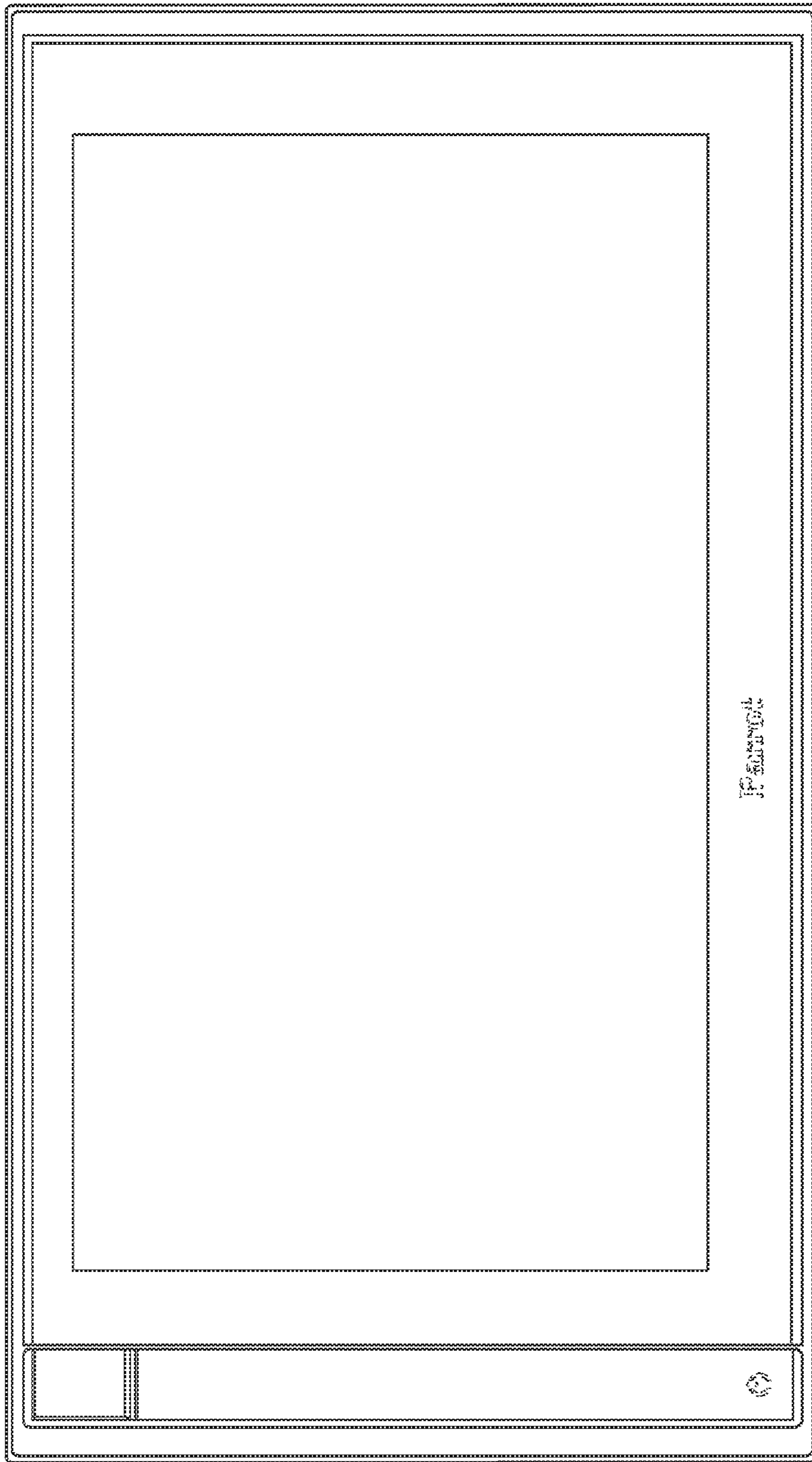

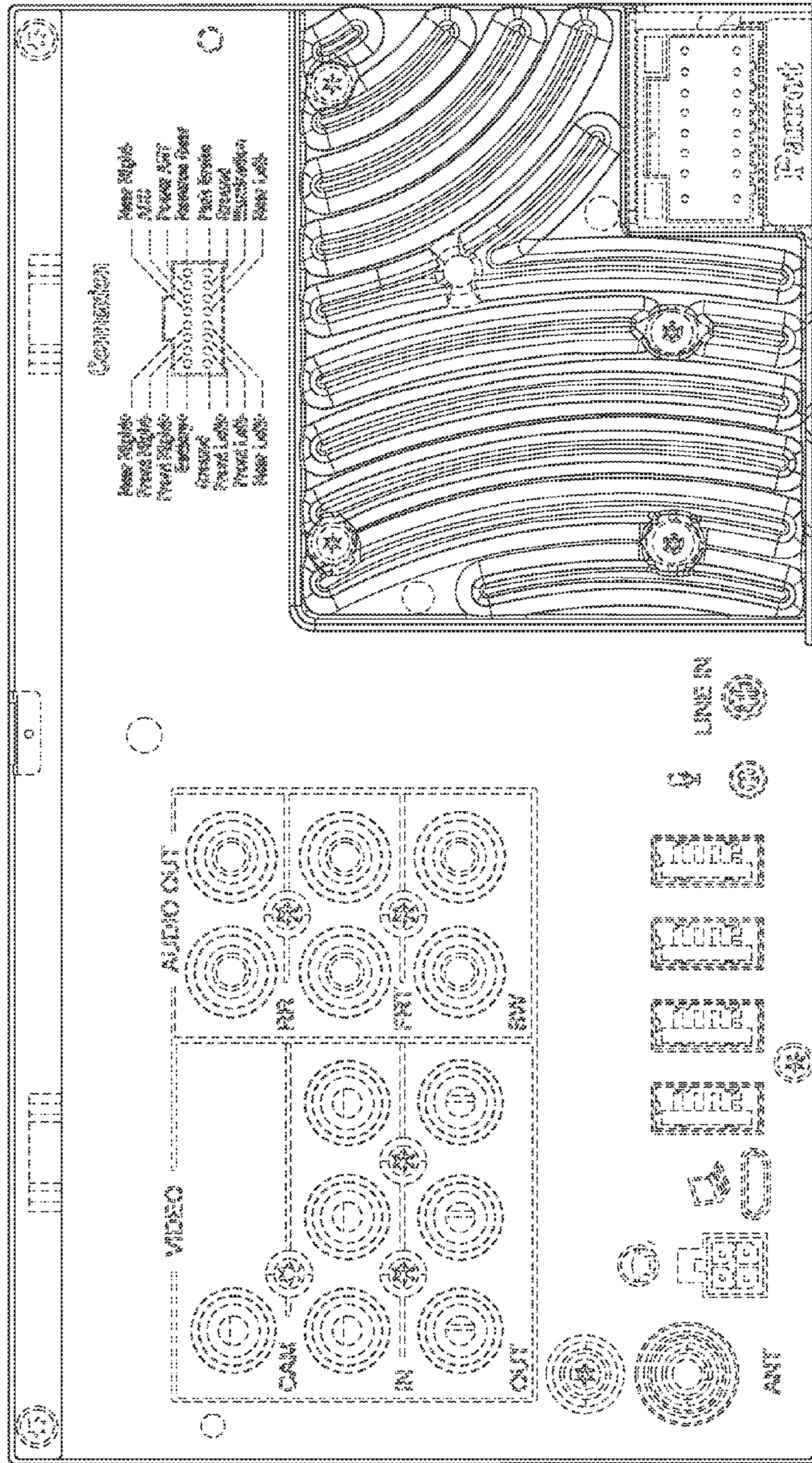

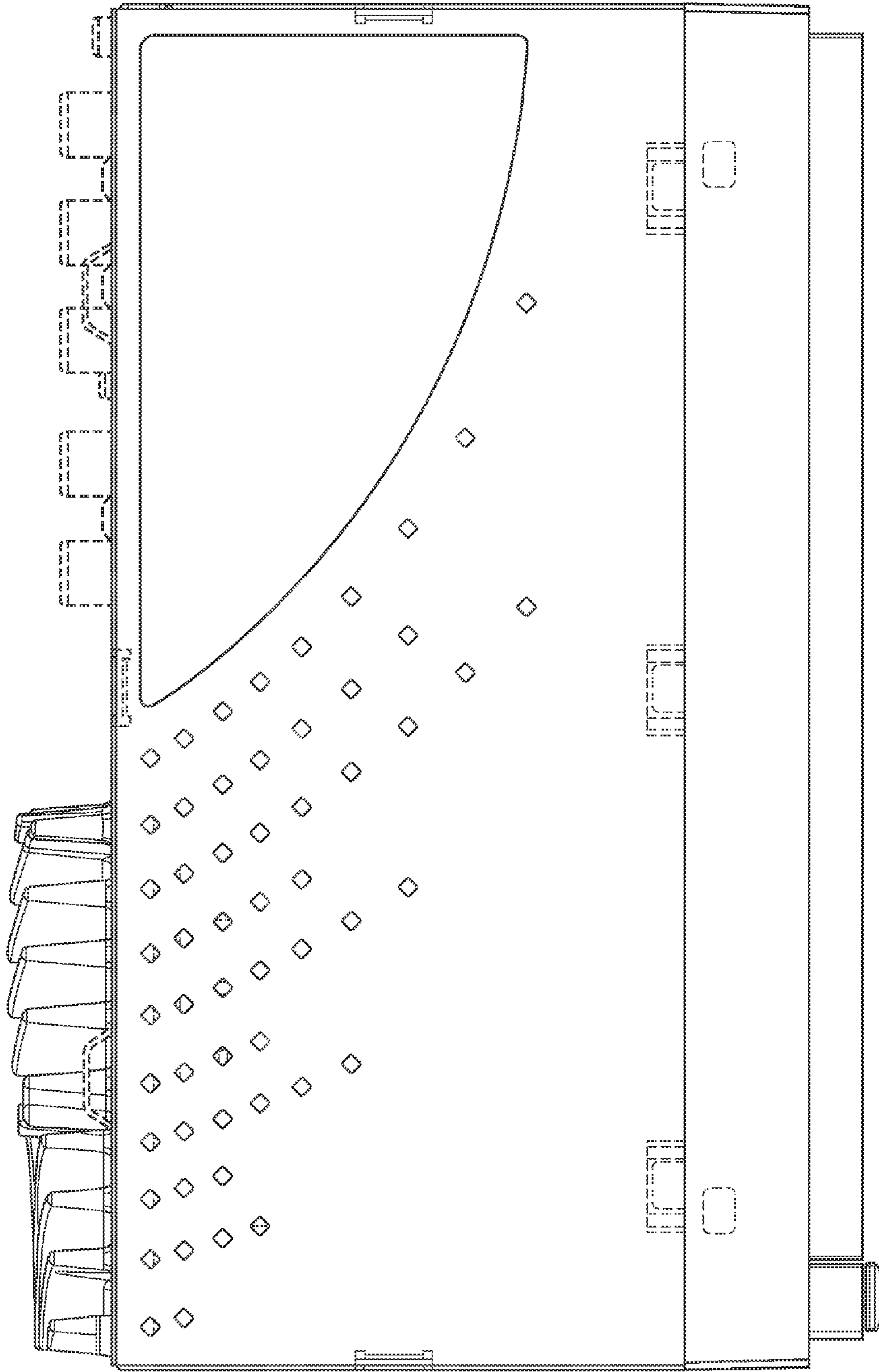

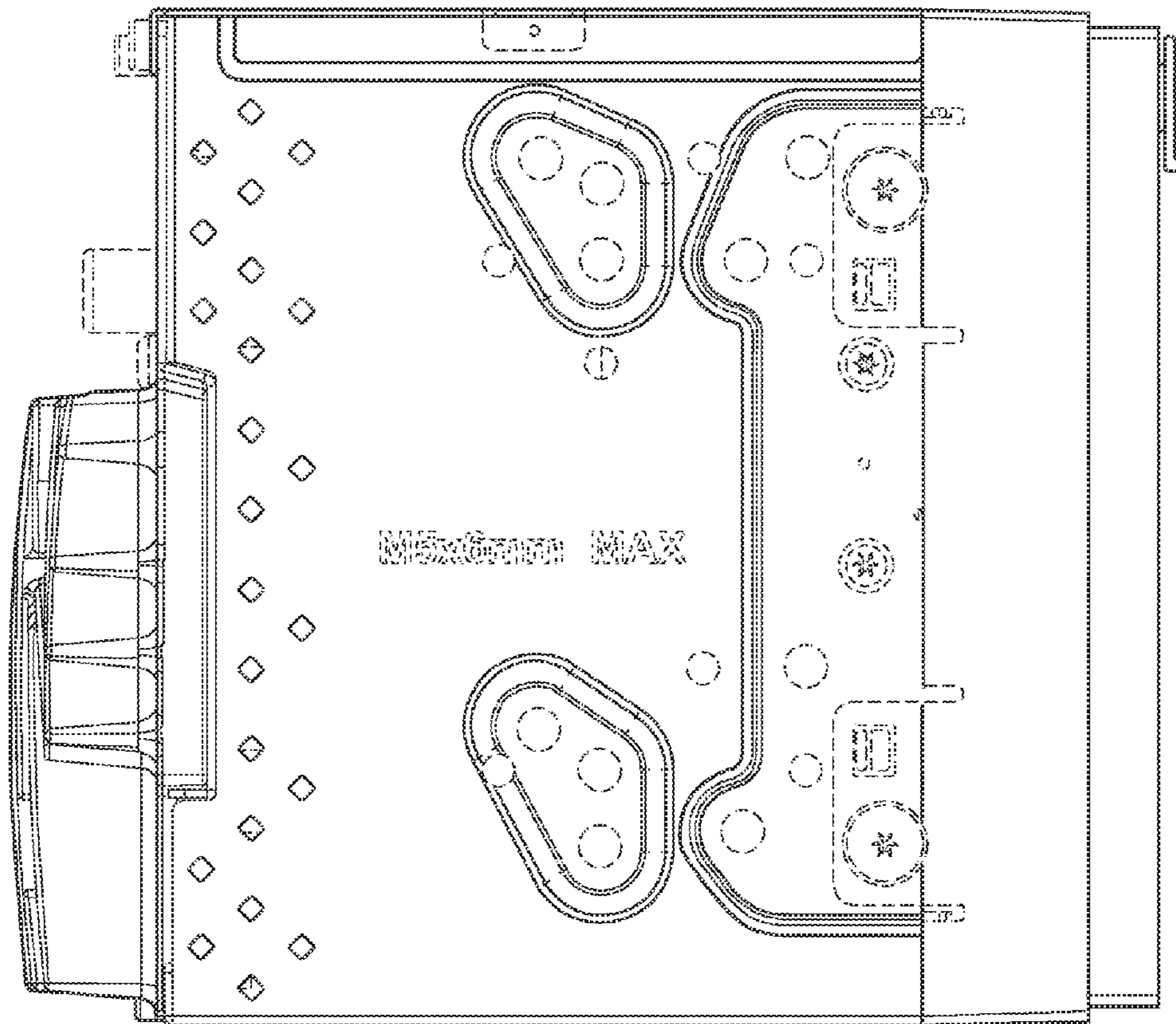

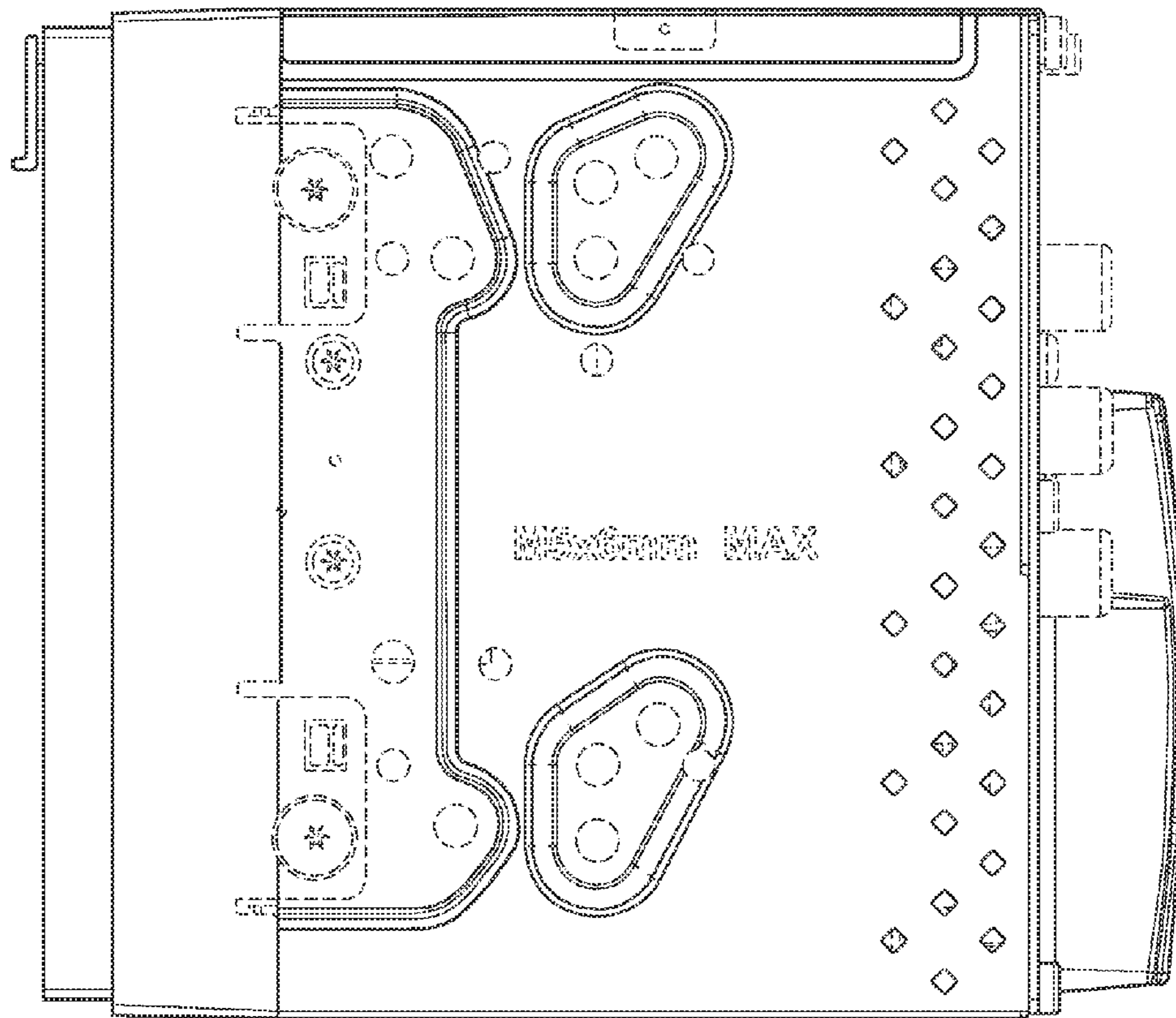

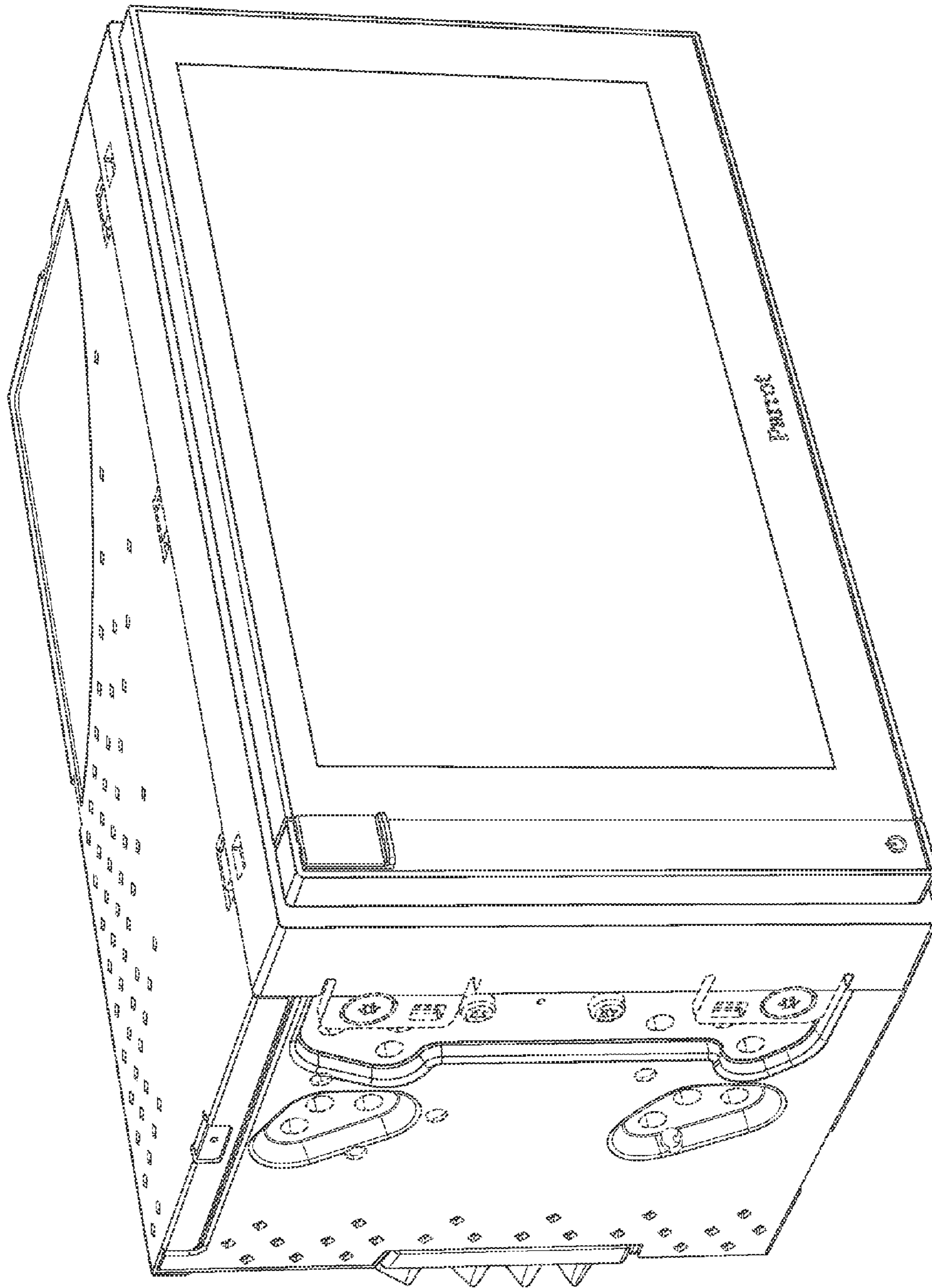
