FIG. 4 is a rear view of the writing instrument of FIG. 1;

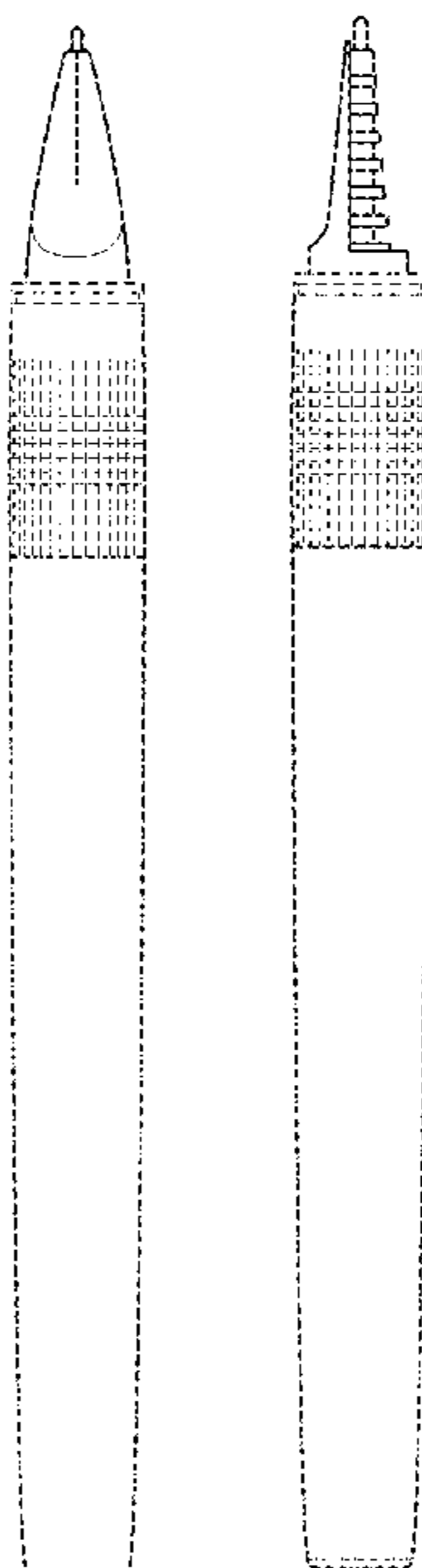
FIG. 5 is a left side view of the writing instrument of FIG. 1;

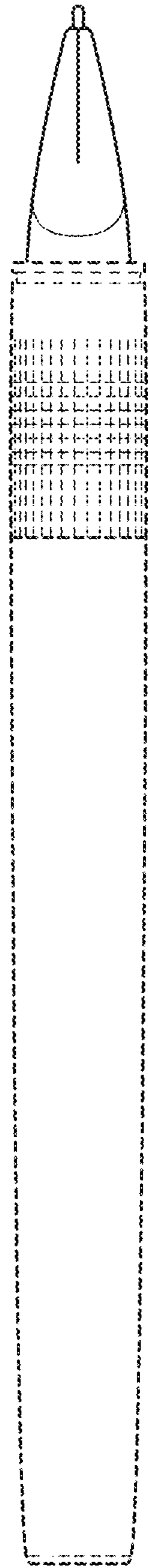

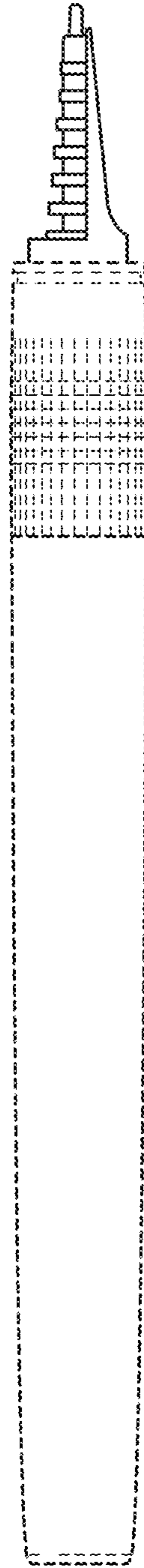

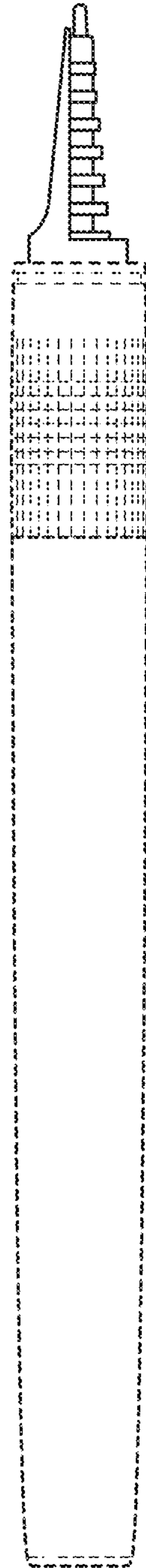

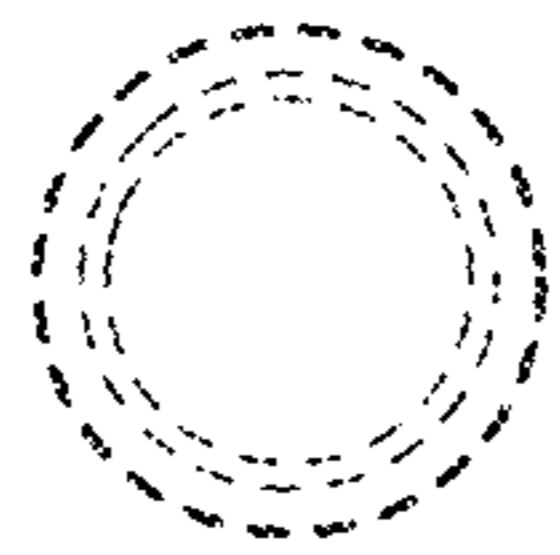

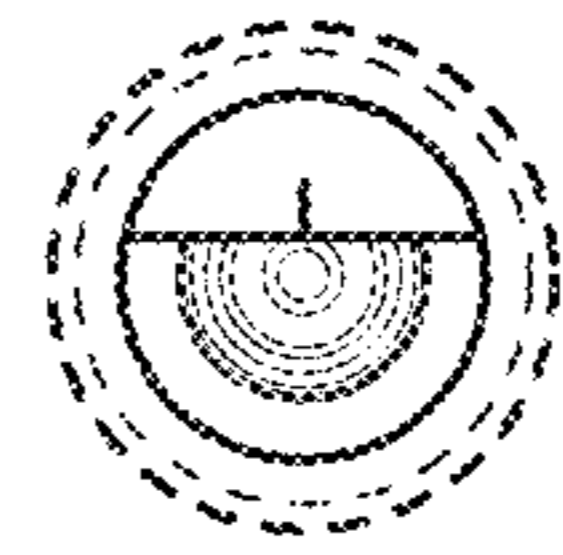
