FIG. 6 is a right side view of the inhaler assist device.

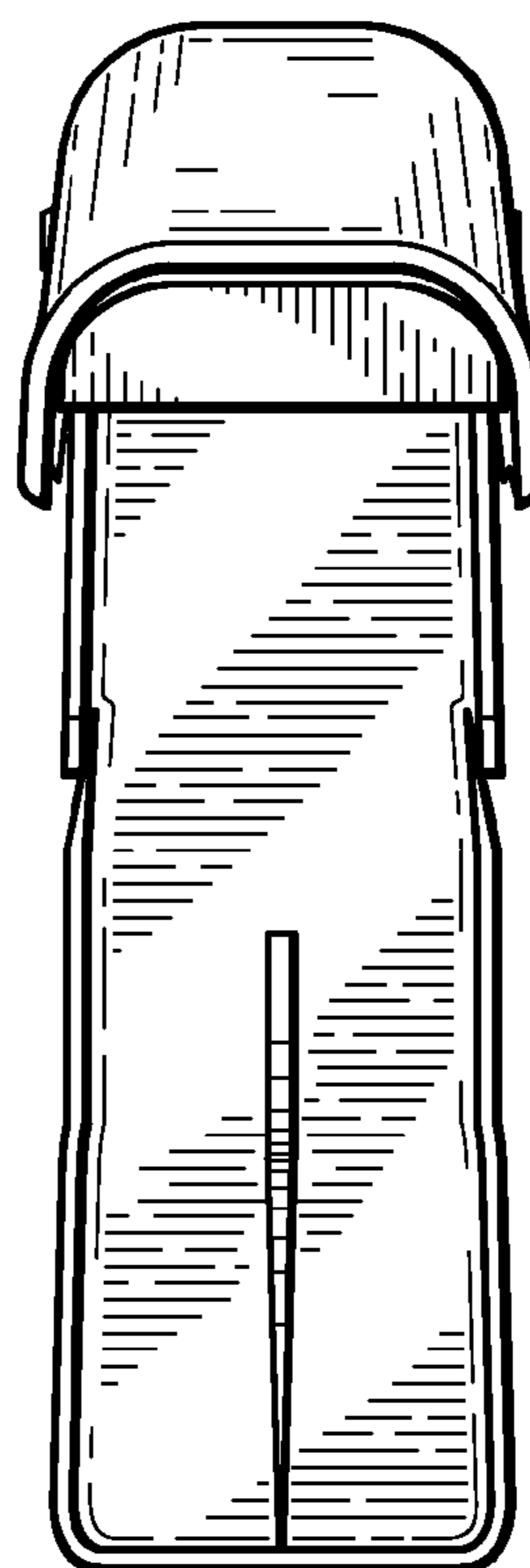
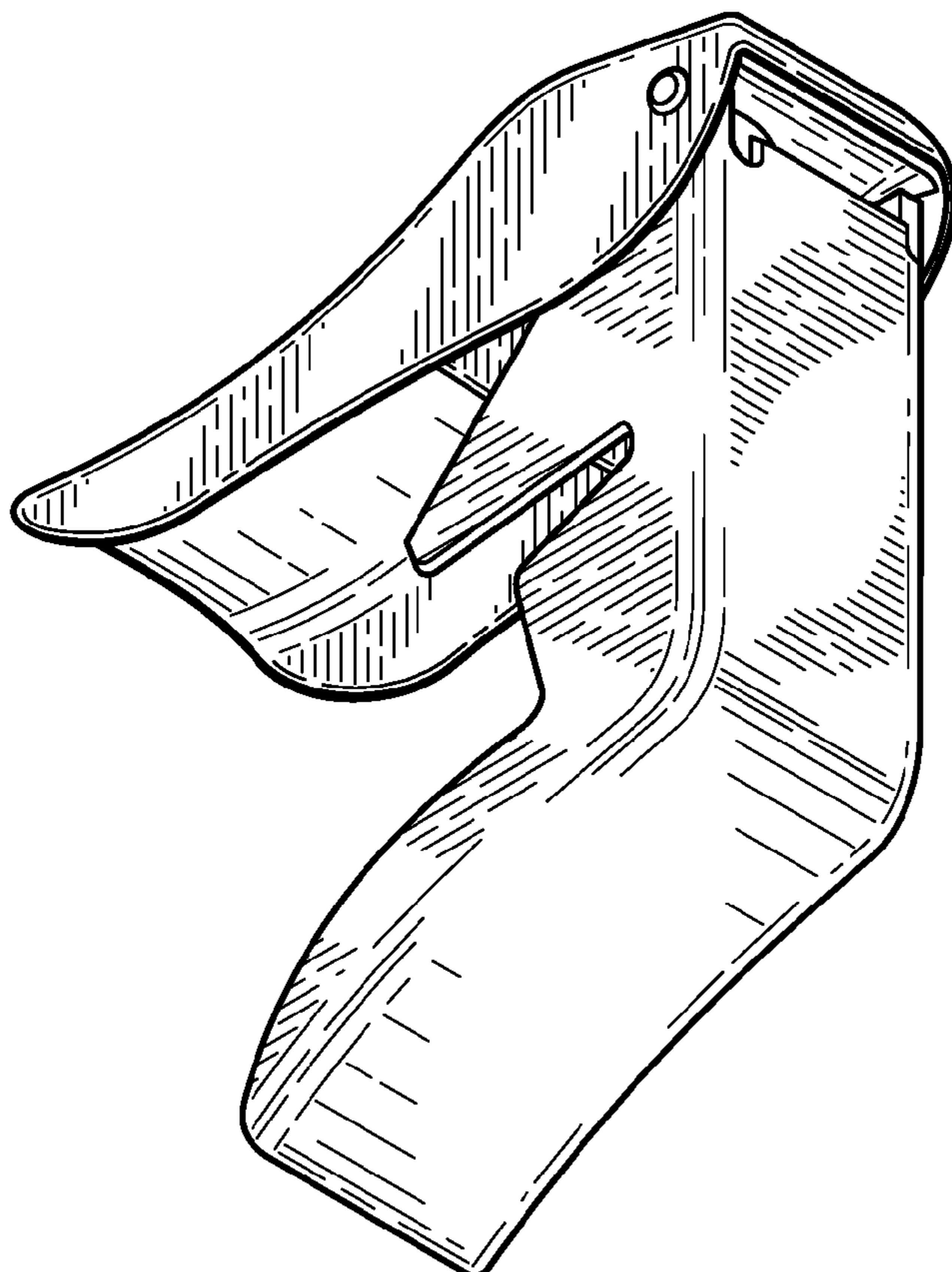
FIG. 7 is a top view of the inhaler assist device.

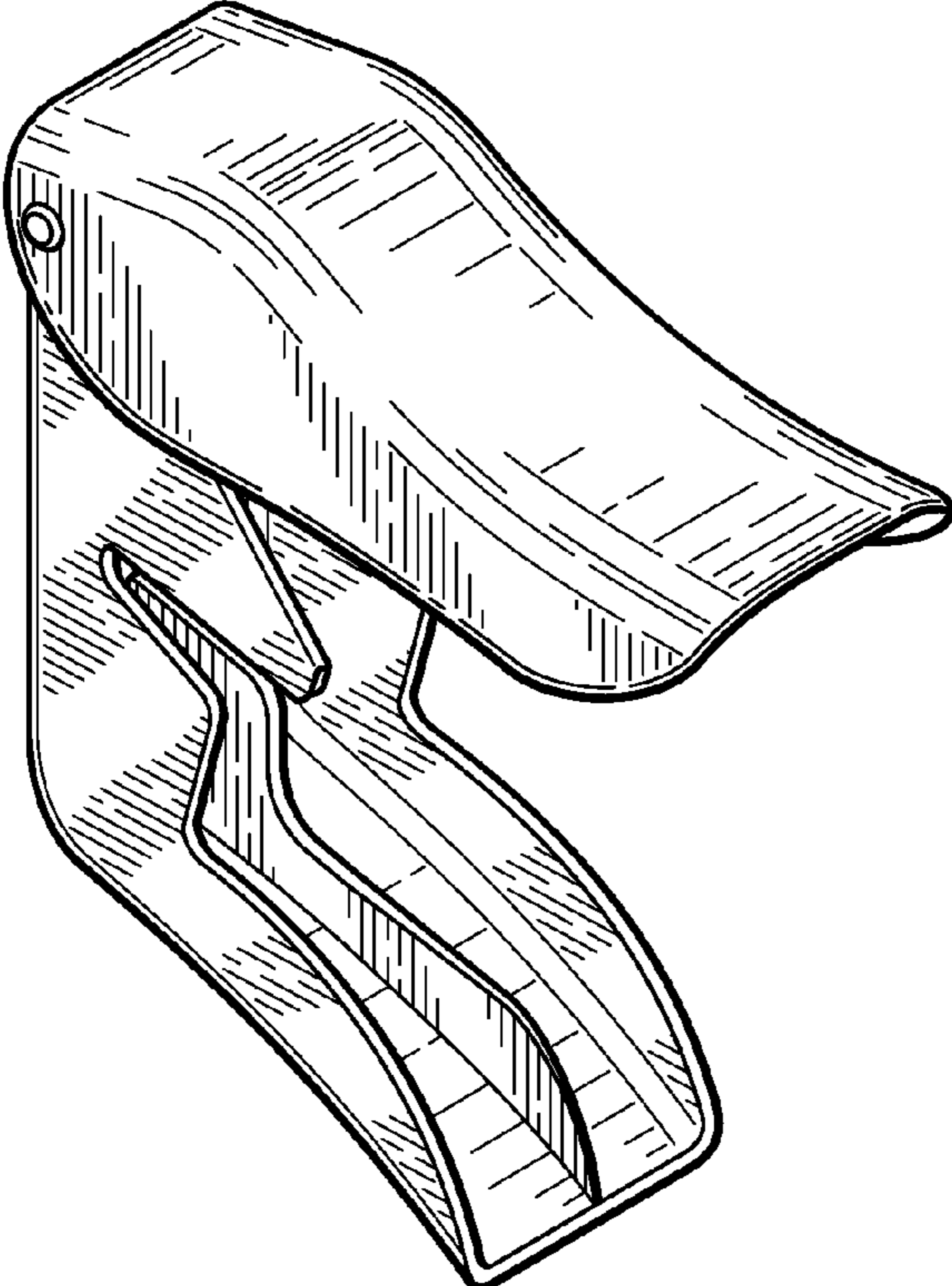

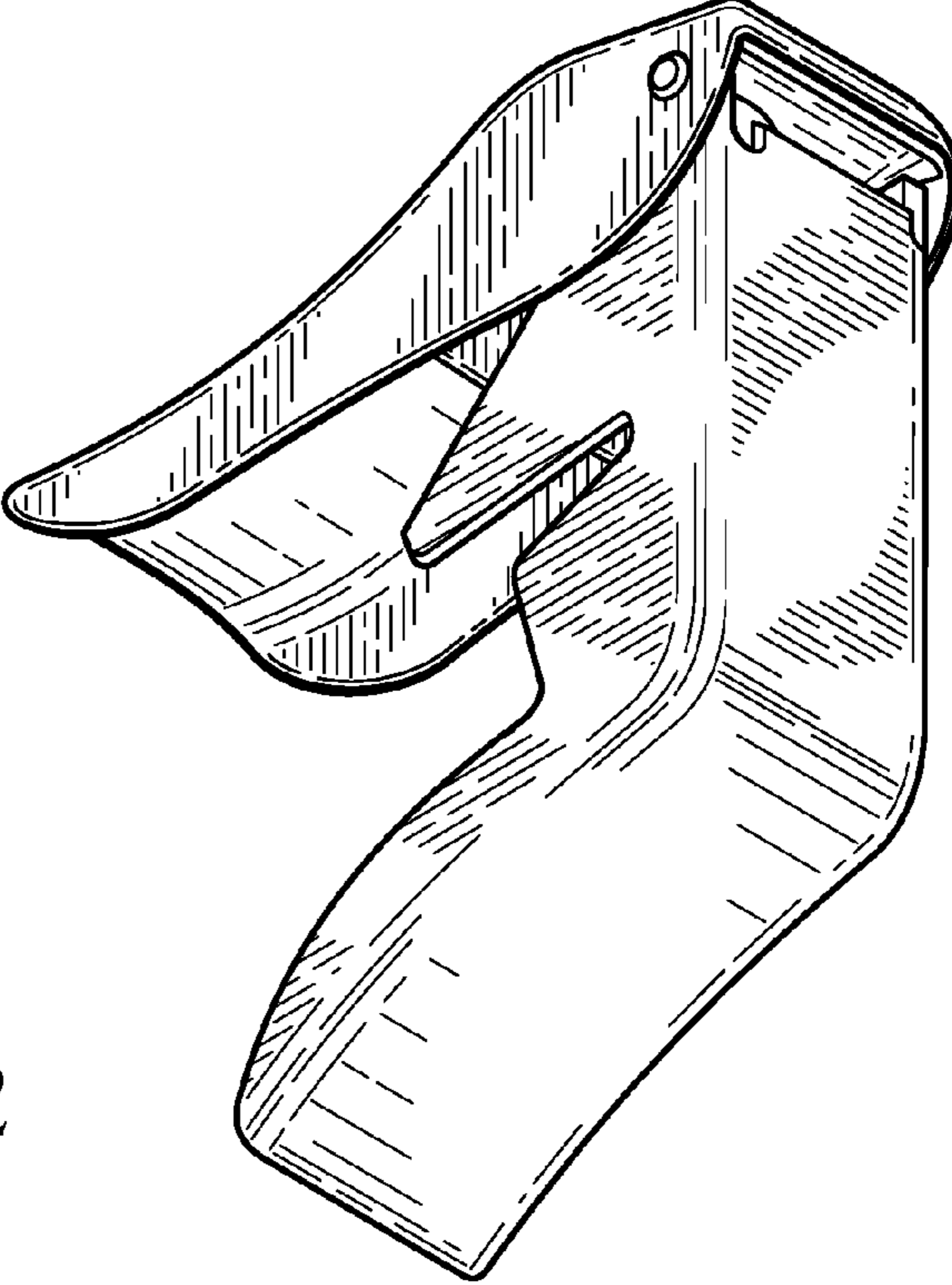

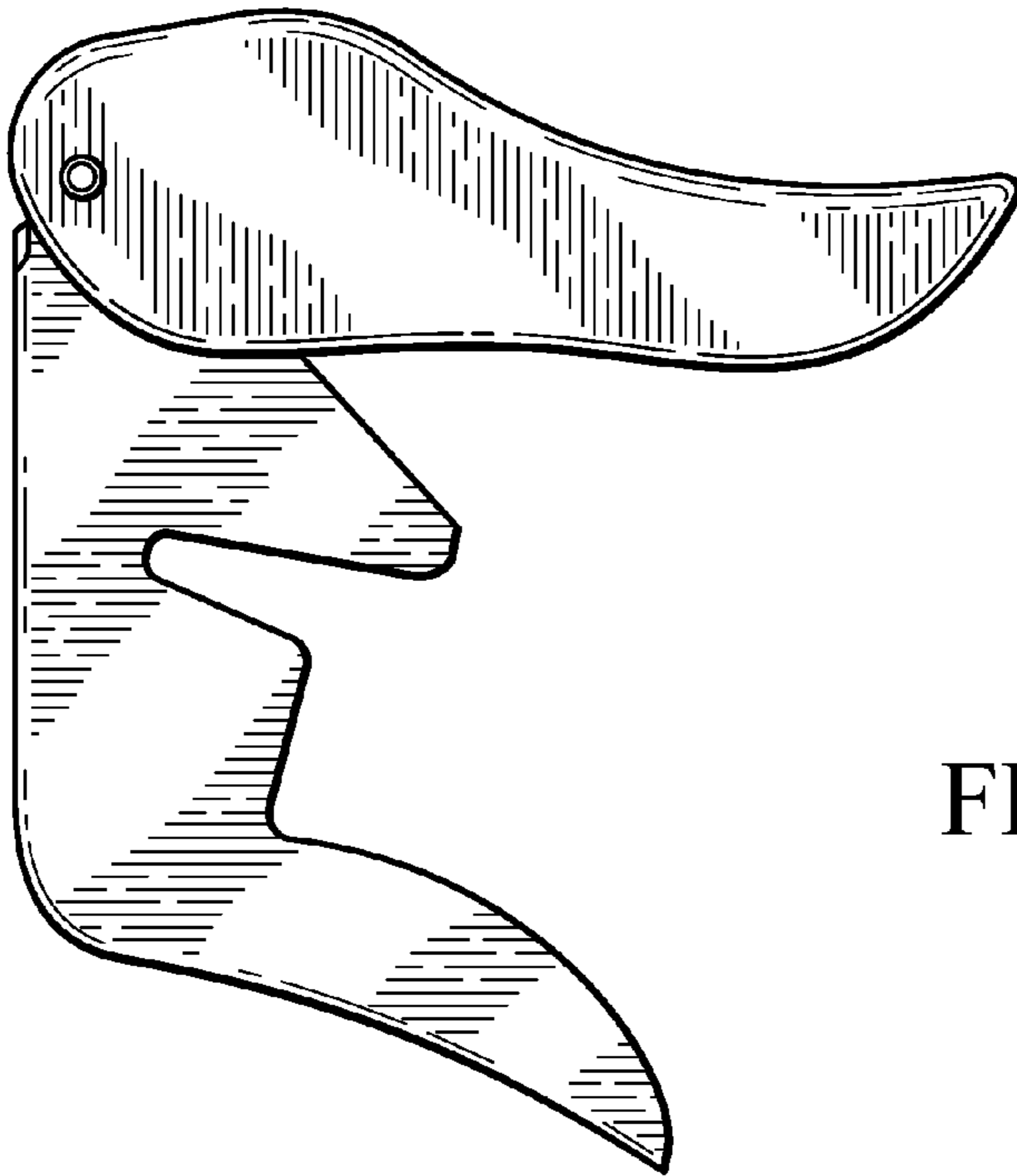

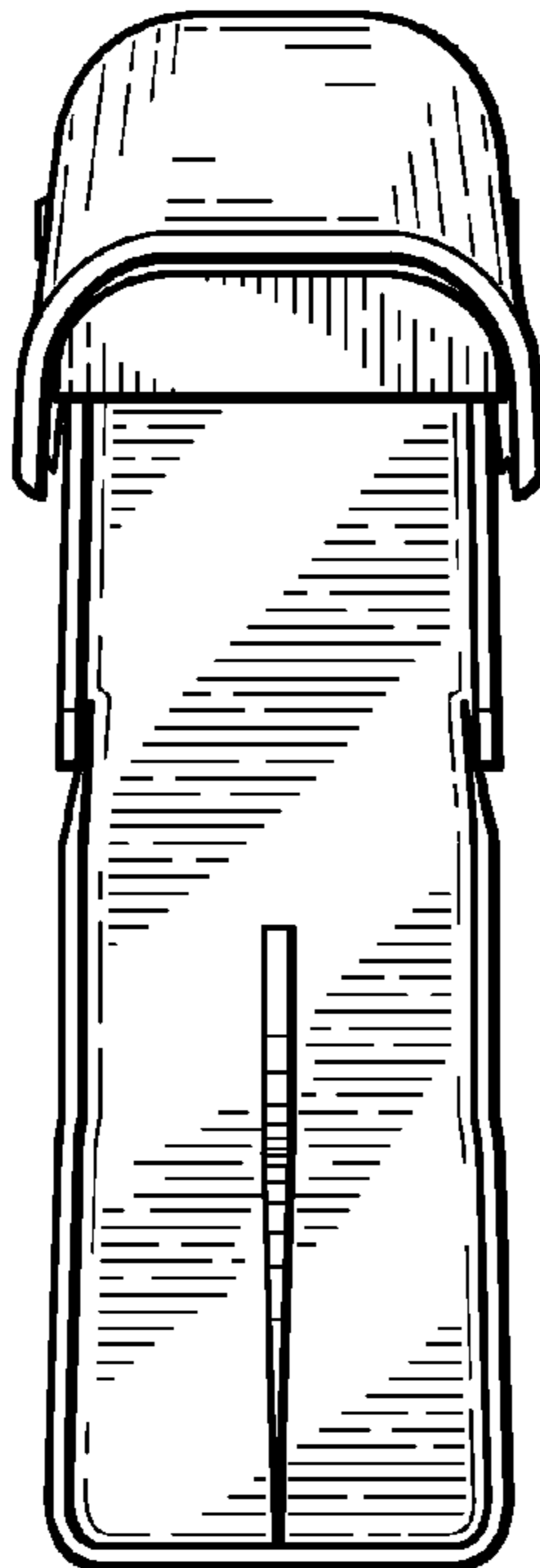

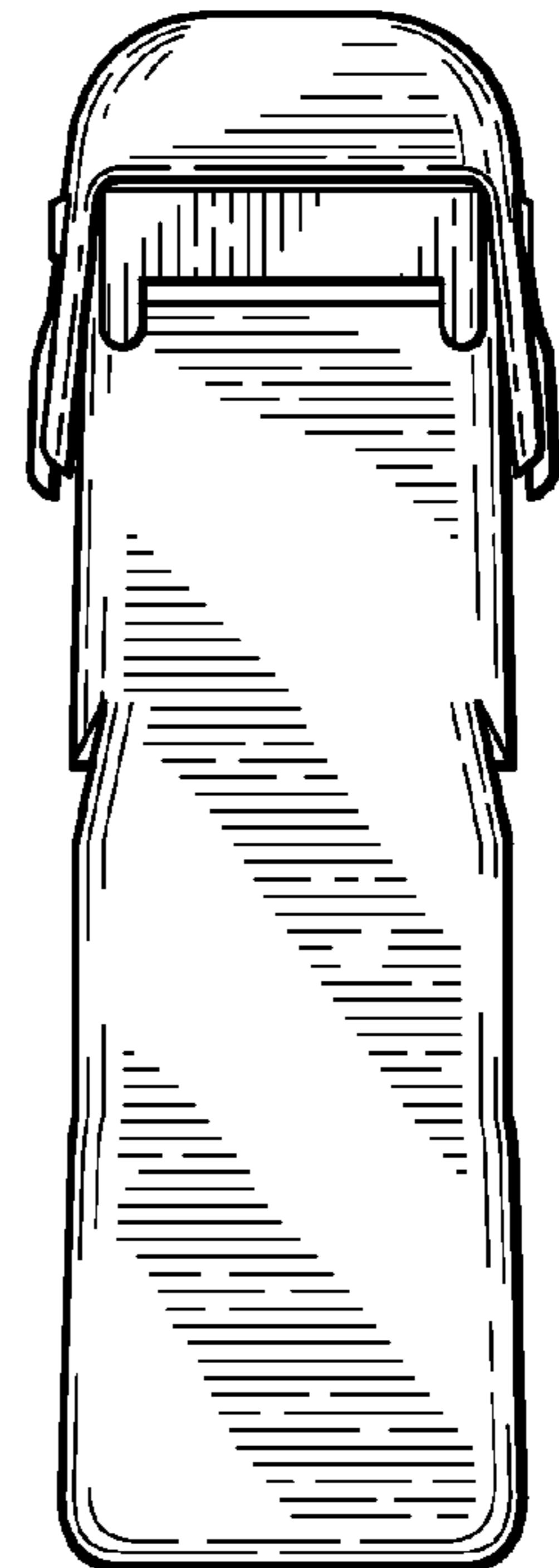

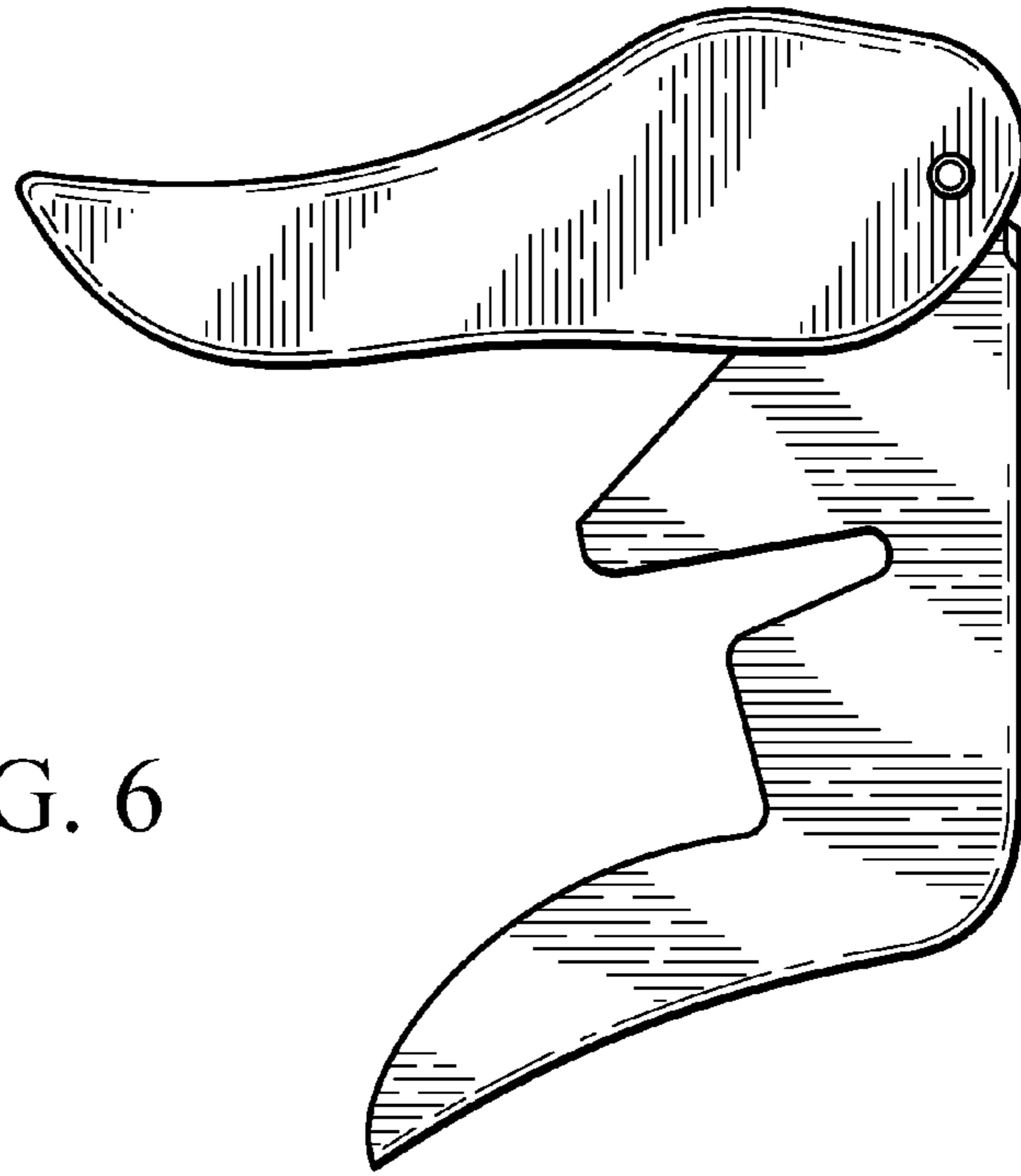

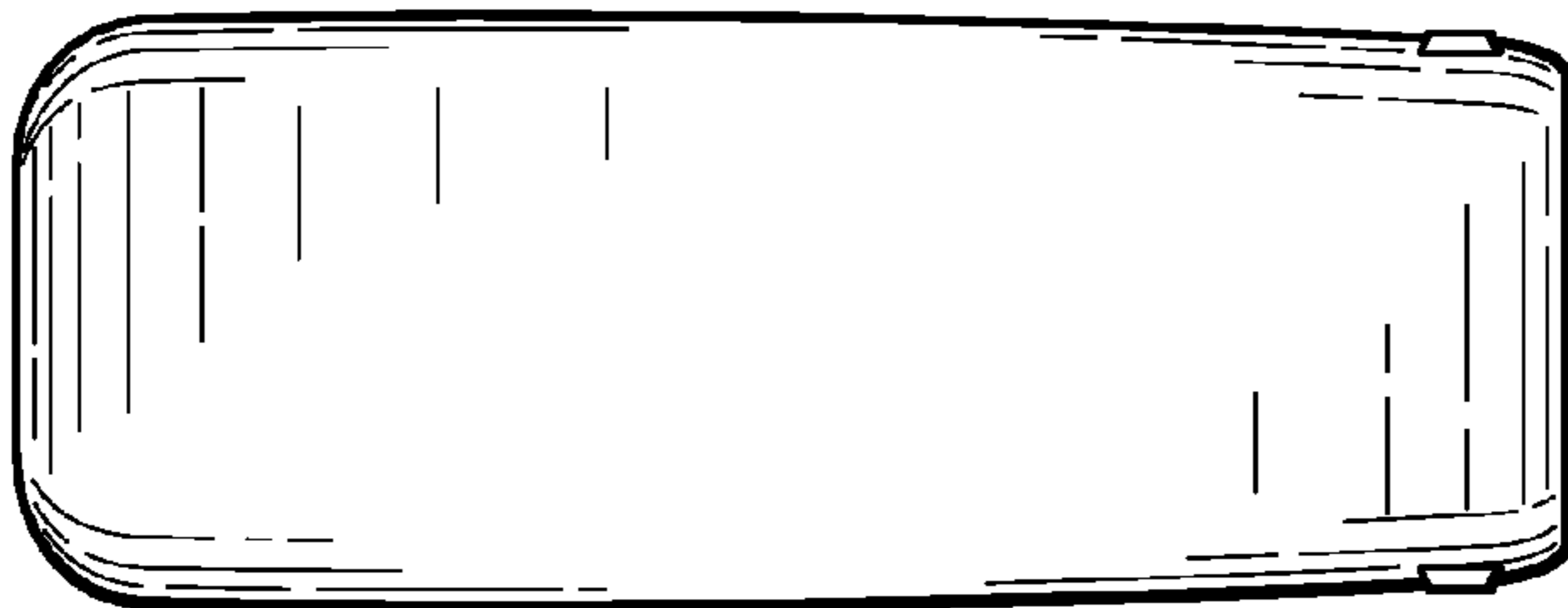
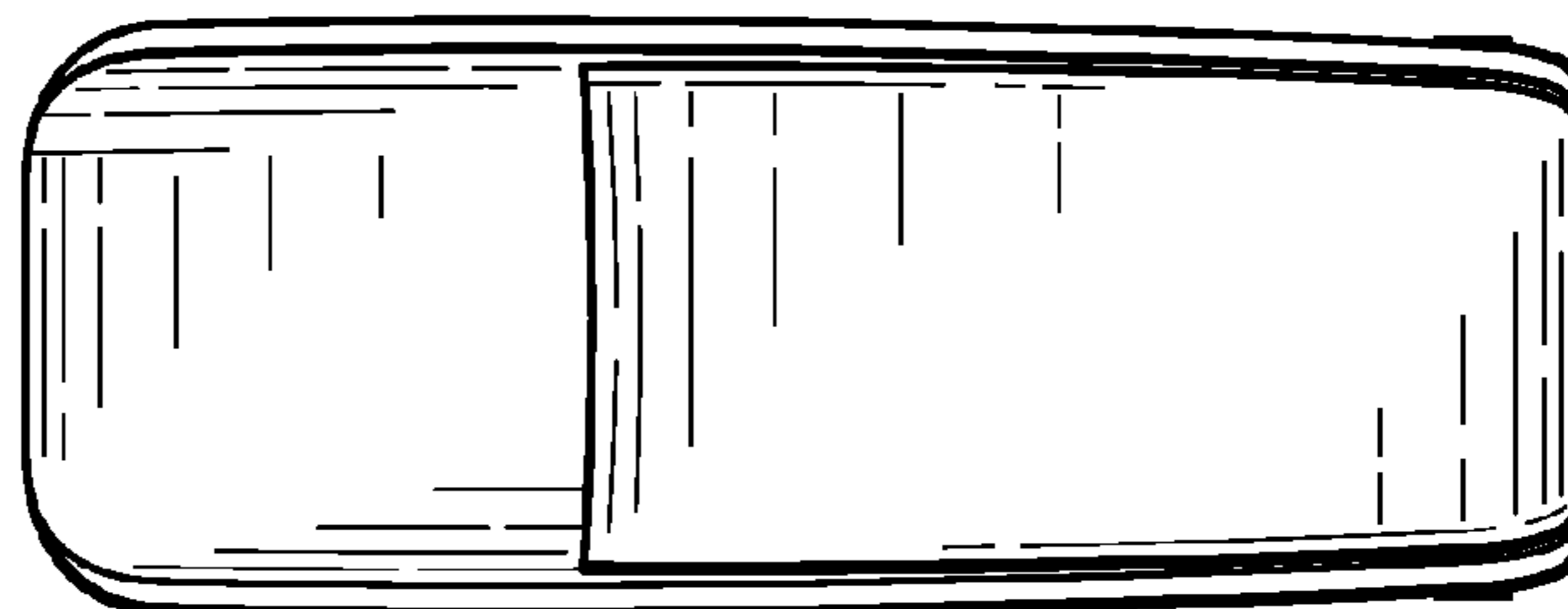

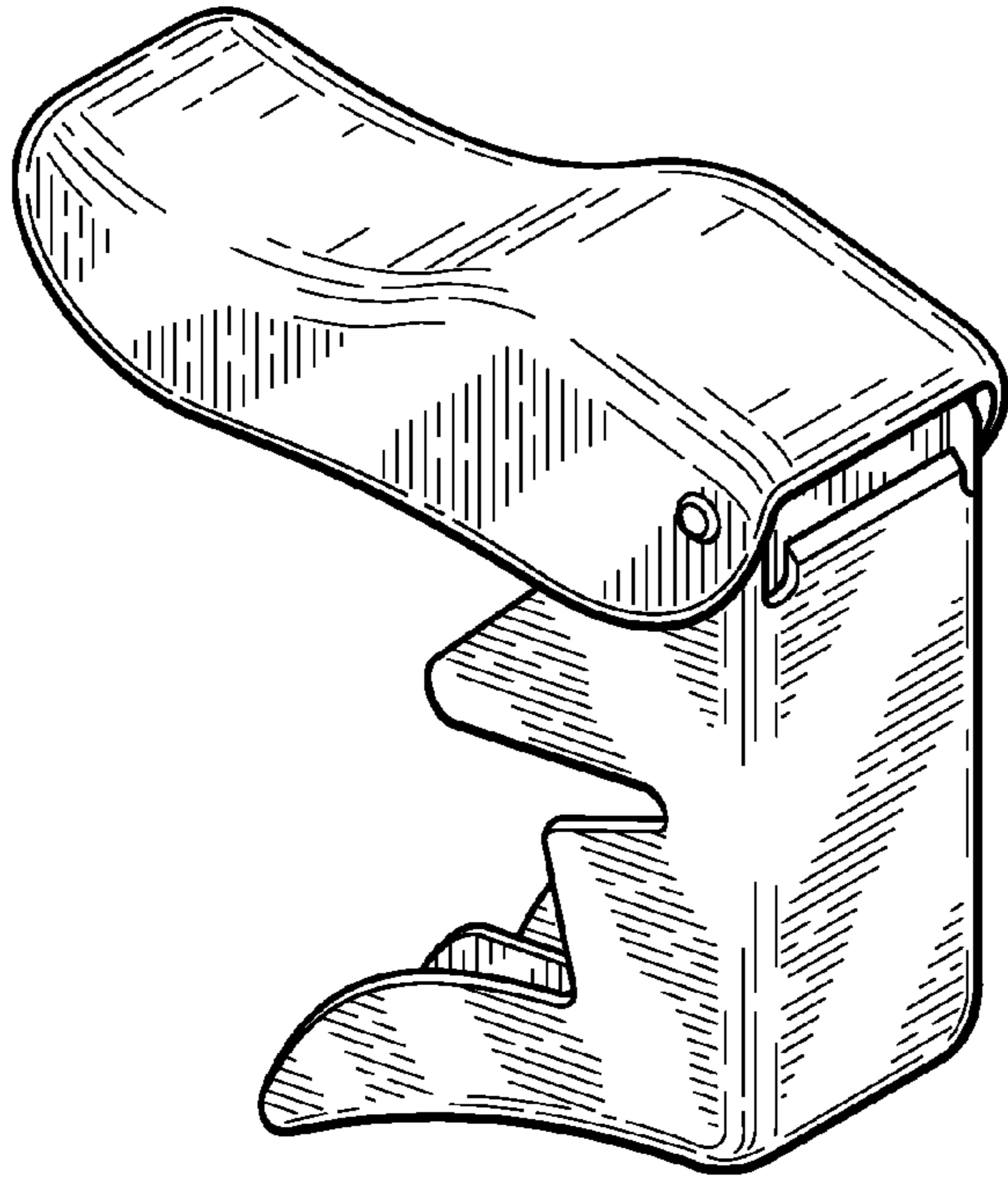

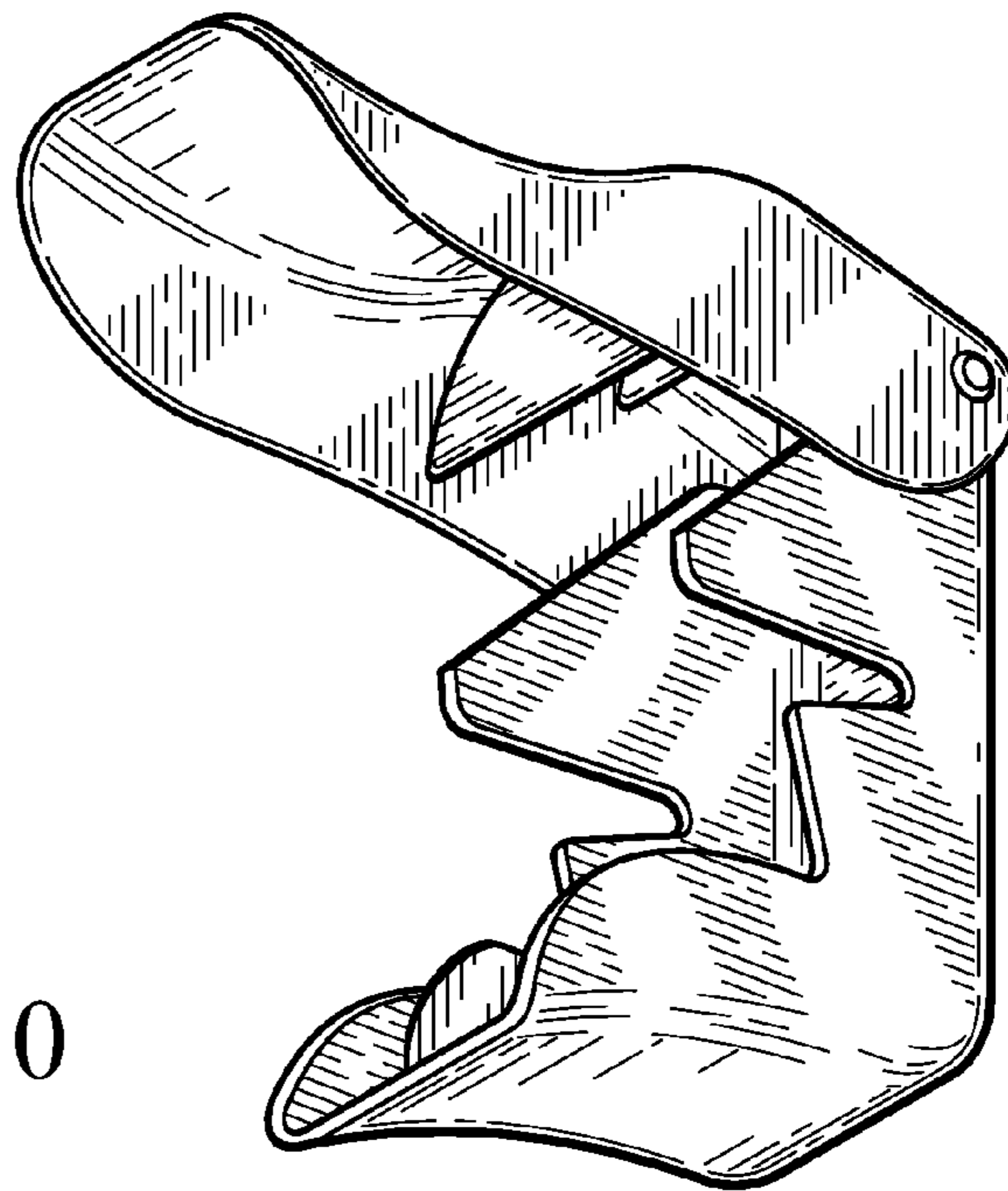
