(57) **CLAIM**

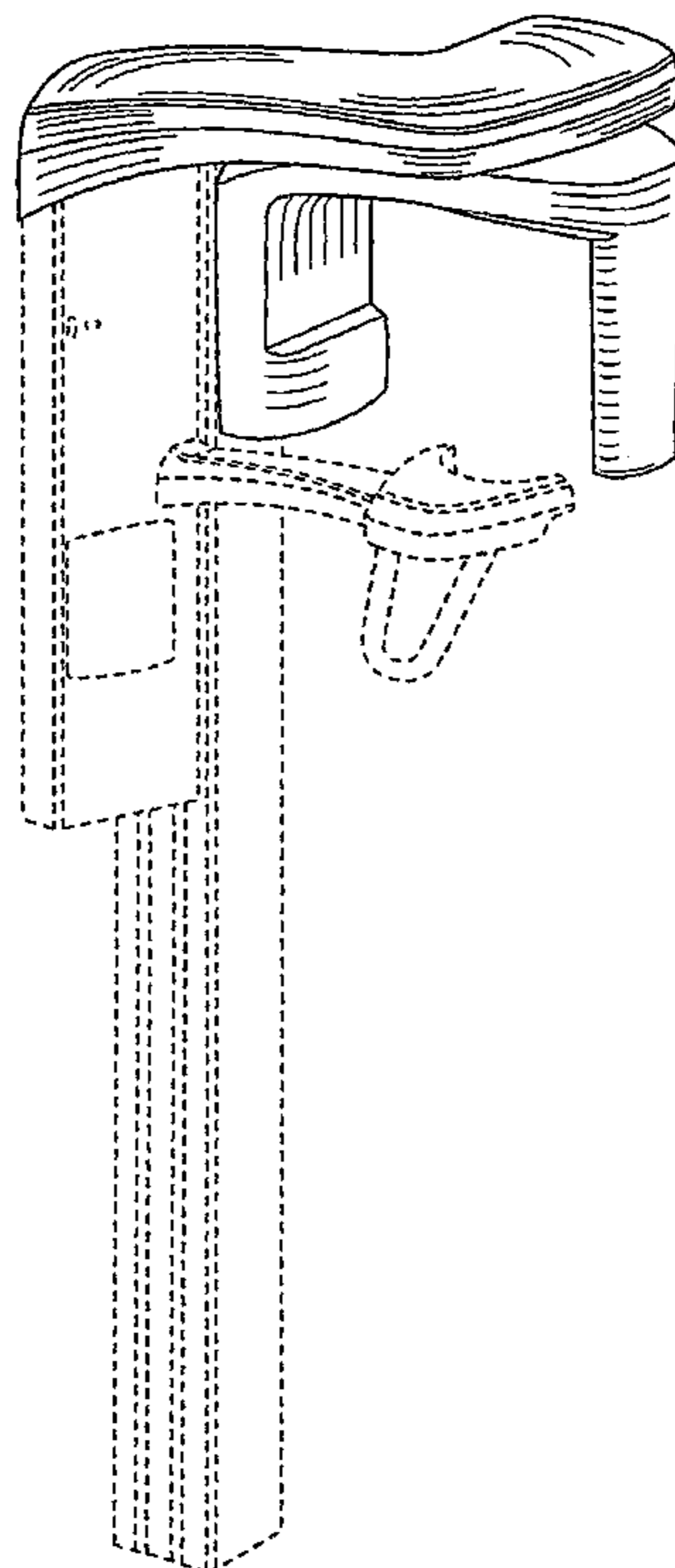
I claim the ornamental design for a dental x-ray machine, as shown and described.

DESCRIPTION

FIG. 1 shows a left side perspective view of a dental x-ray machine of my new design;
FIG. 2 shows a front view thereof;

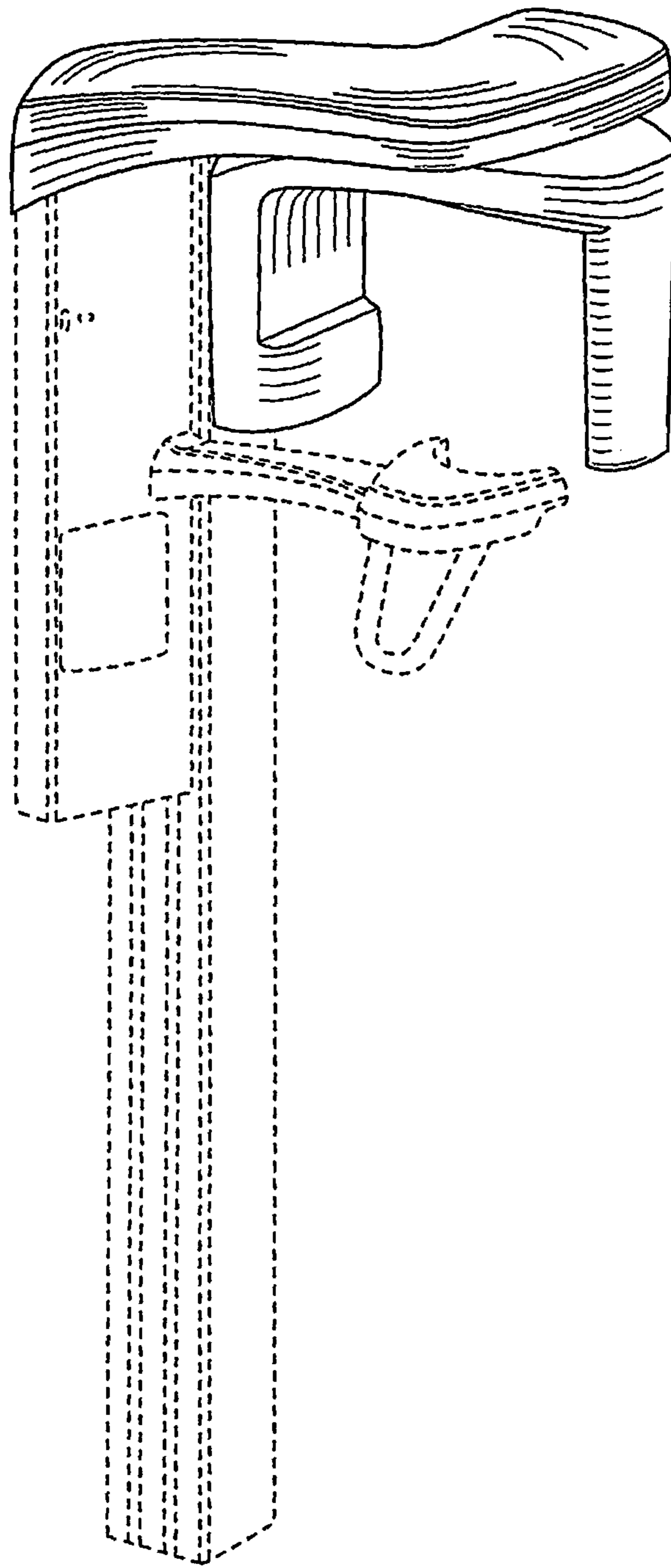

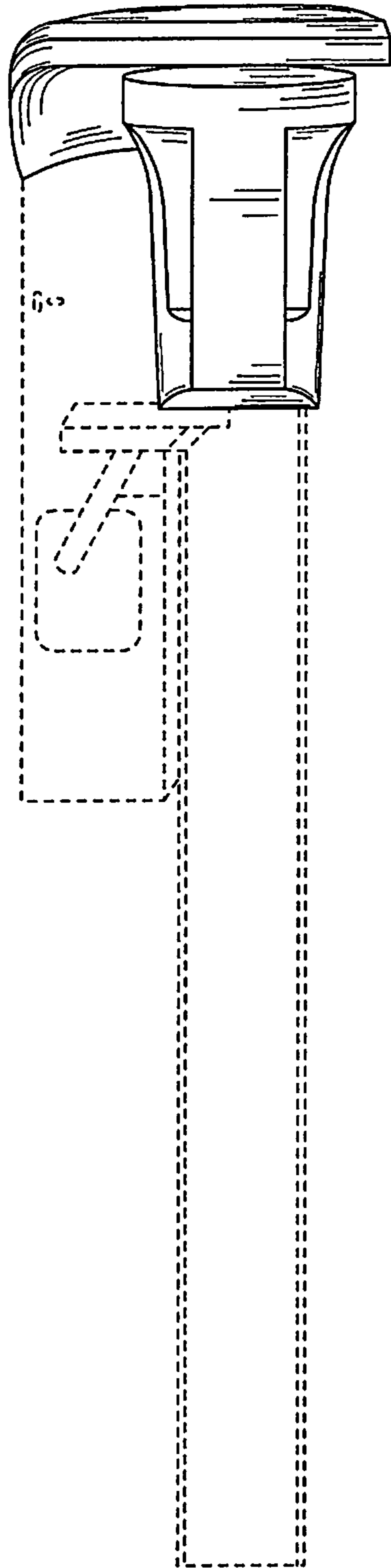

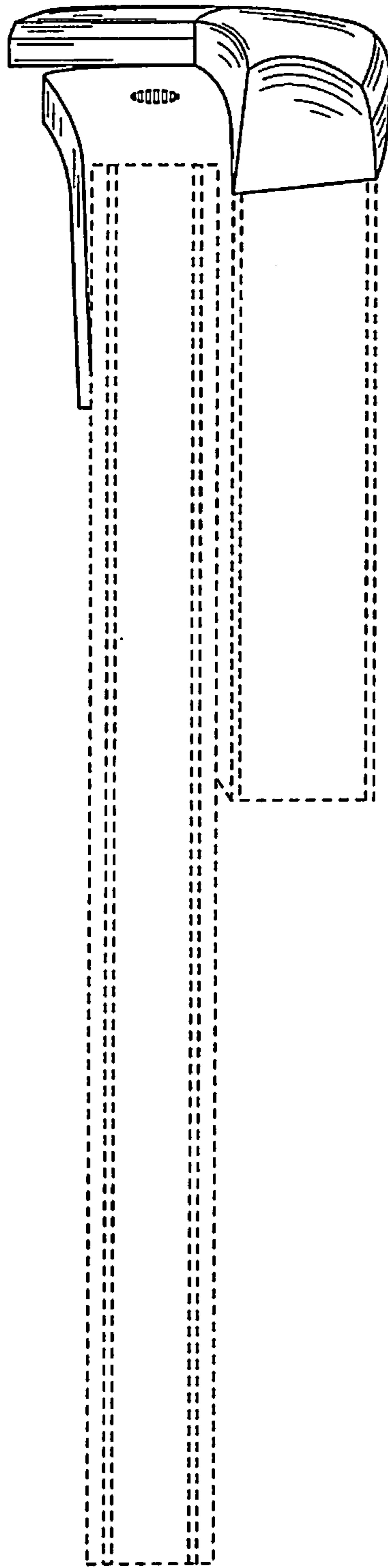

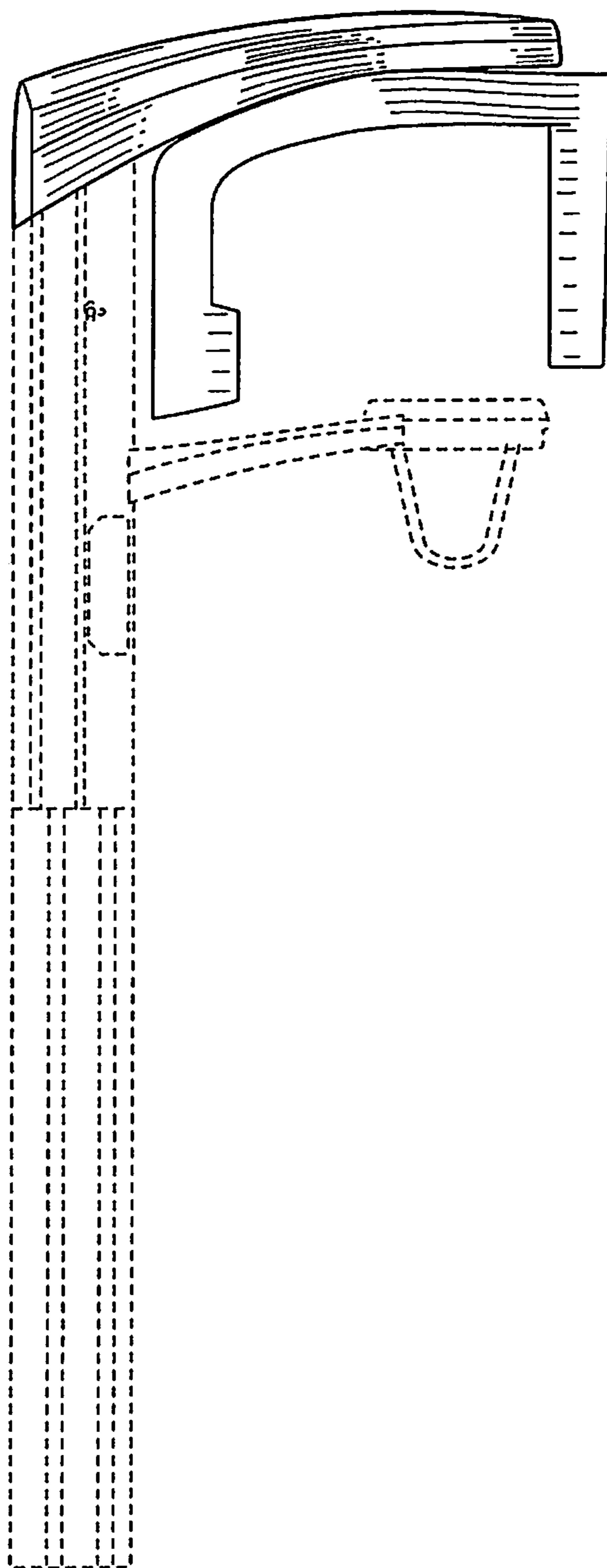

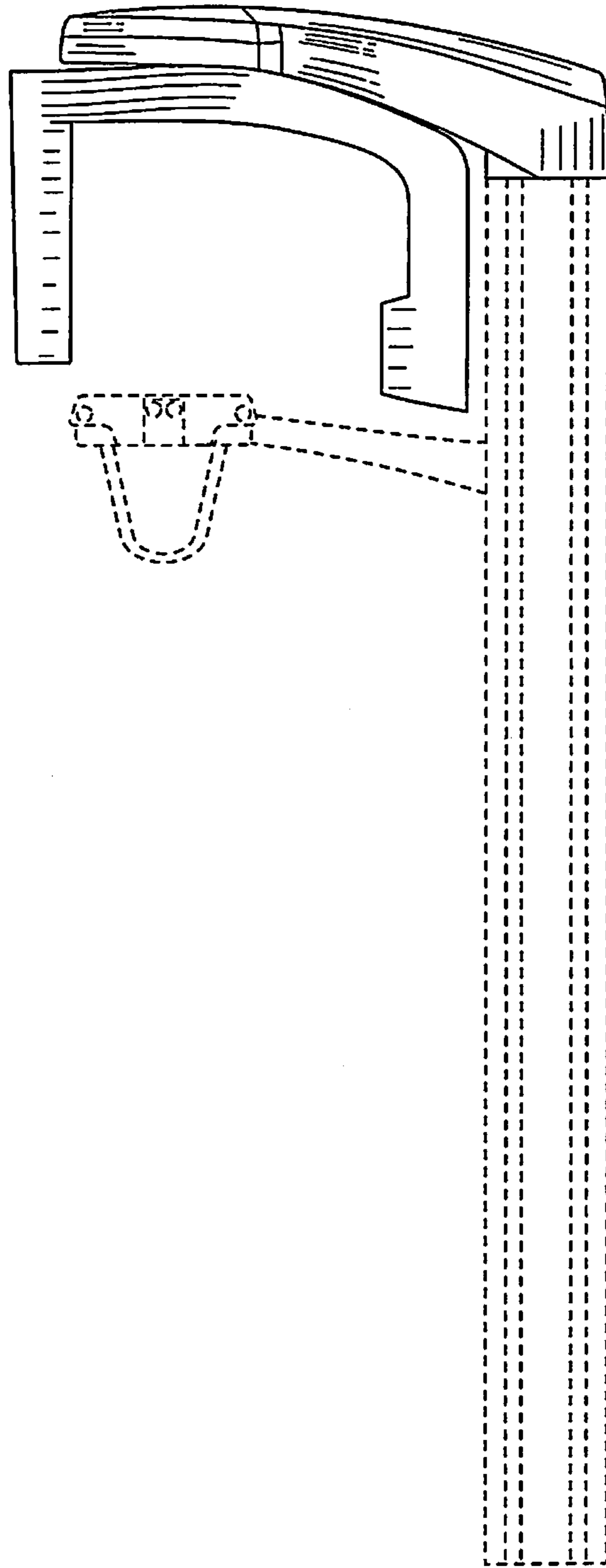

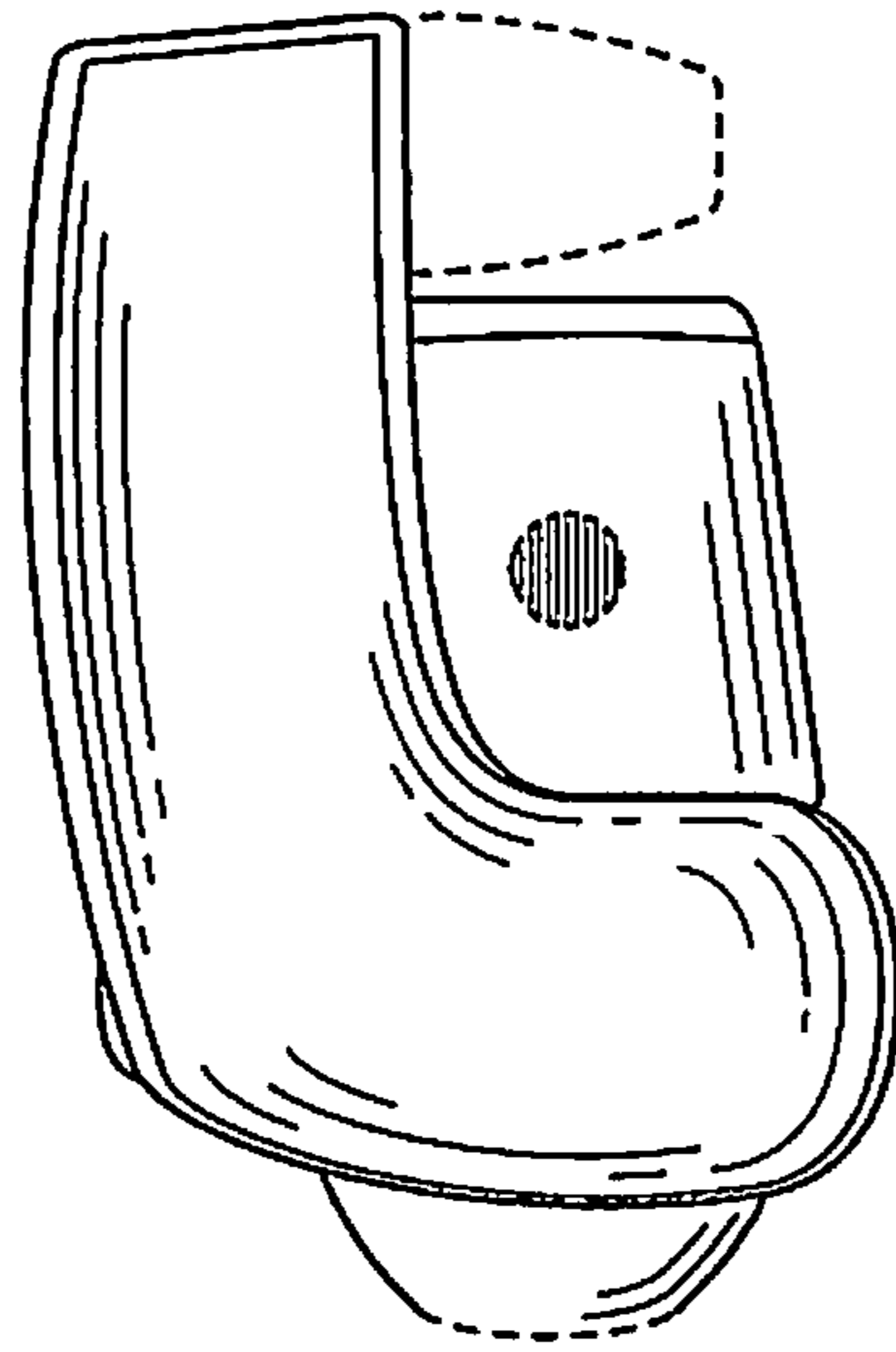

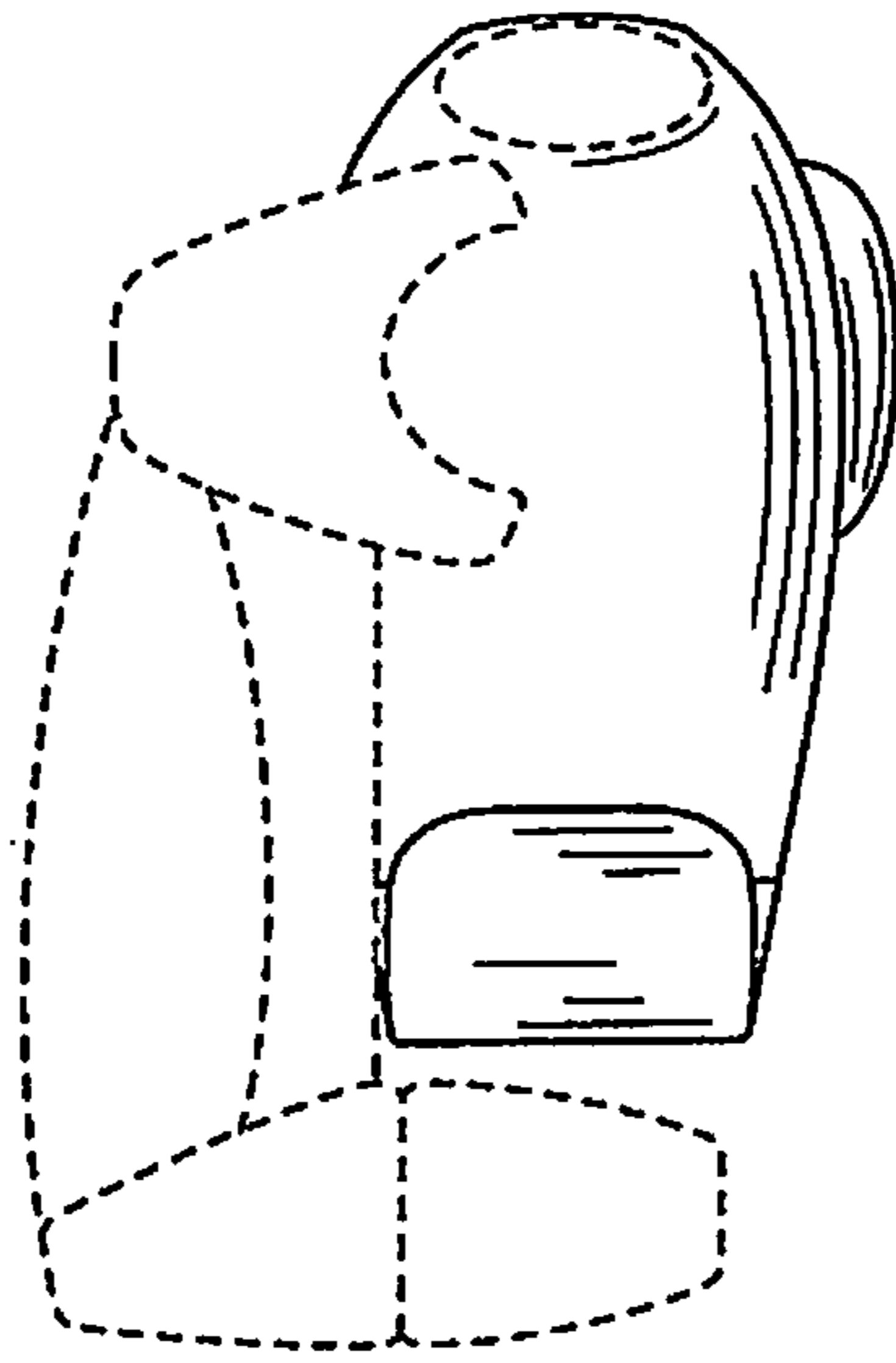
