(57) **CLAIM**

I claim the ornamental design for athletic pants, as shown and described.

DESCRIPTION

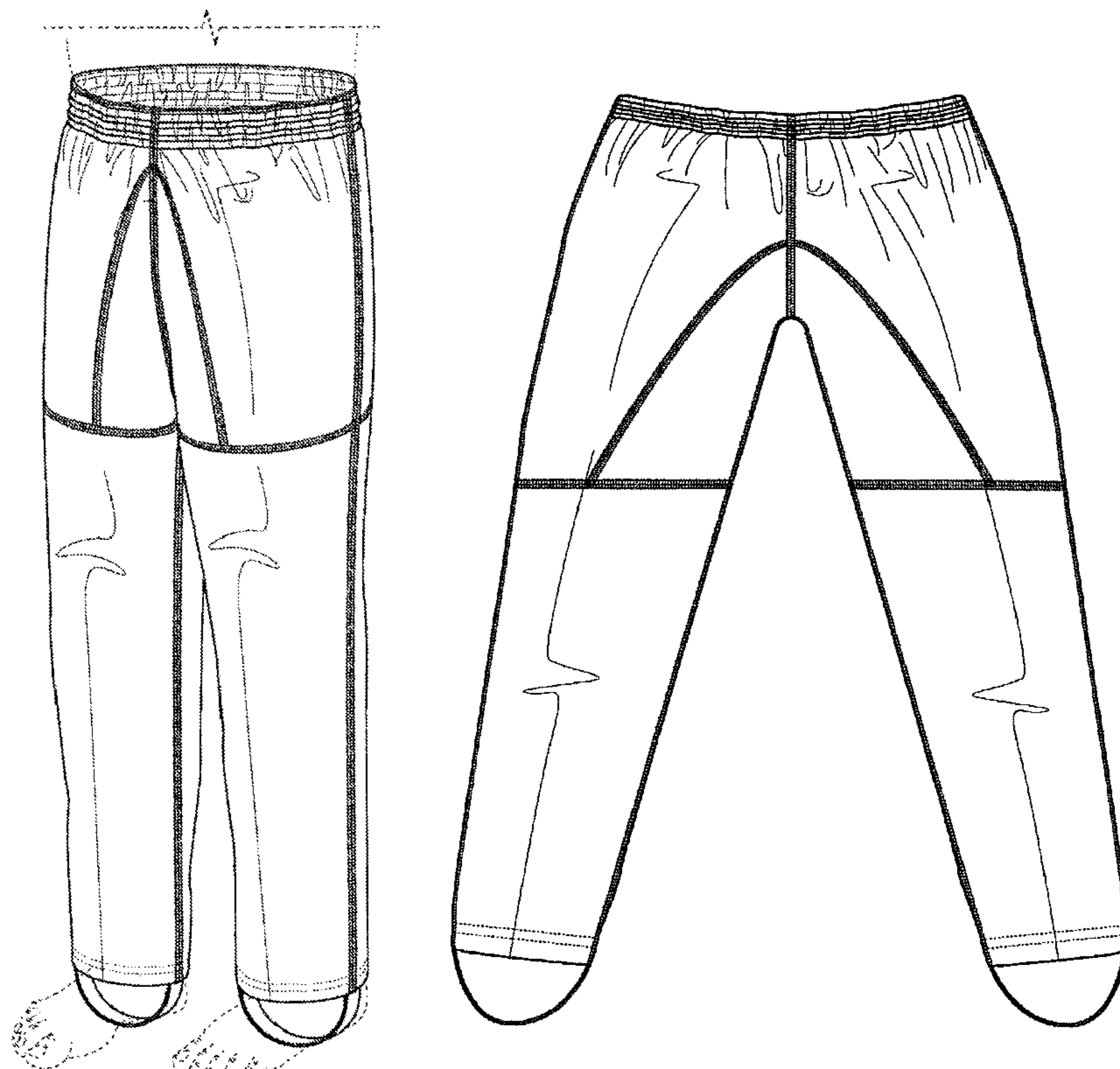
FIG. 1 is a front perspective view of athletic pants showing my new design as being worn;

FIG. 2 is a front view of the athletic pants of FIG. 1, showing the design; and,

FIG. 3 is a rear view of the athletic pants of FIG. 1, showing the design.

The broken lines in FIG. 1, showing portions of the human figure, show the design as worn, and form no part of the claimed design. The remaining broken lines, shown on the athletic pants, represent stitching.

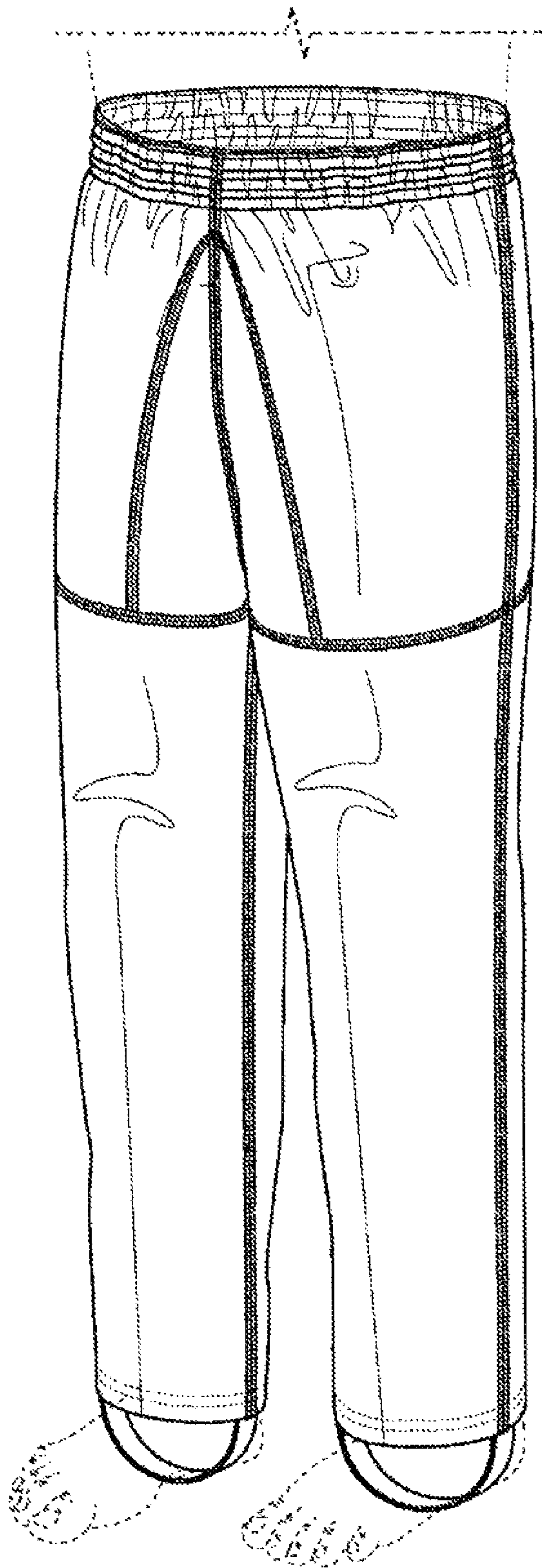

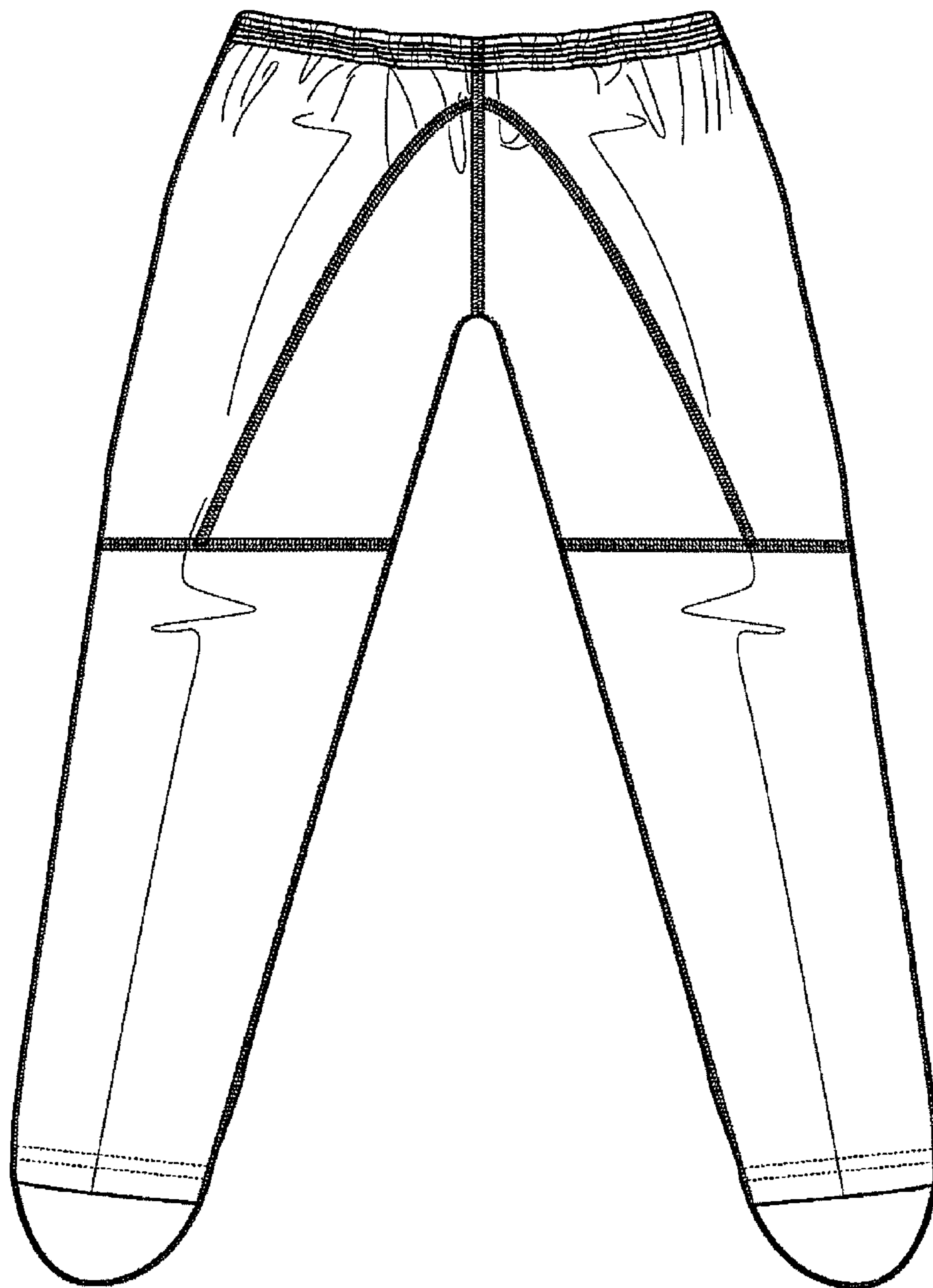

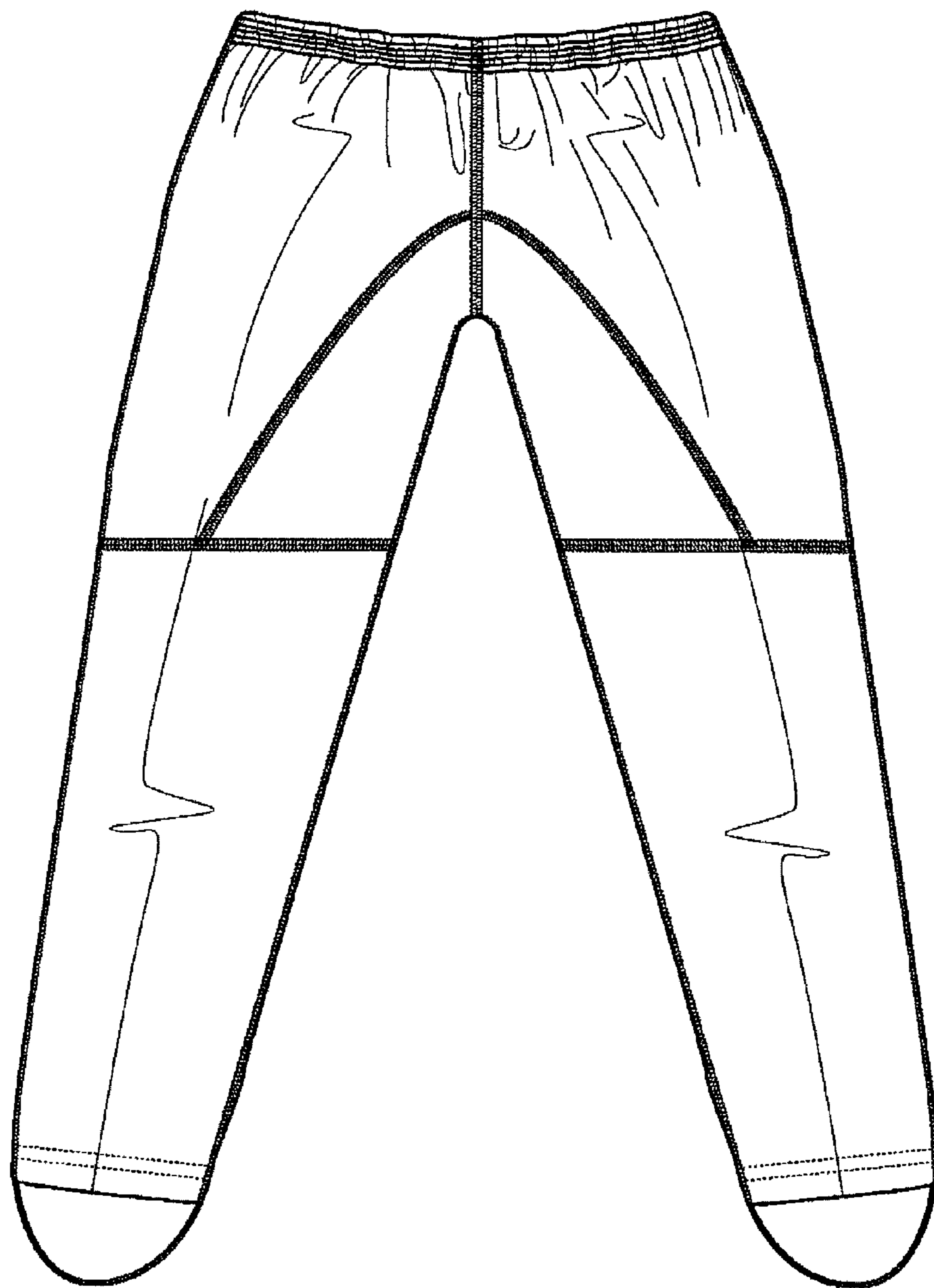
