DESCRIPTION

FIG. 1 is a perspective view of a women's sneaker showing my new design;

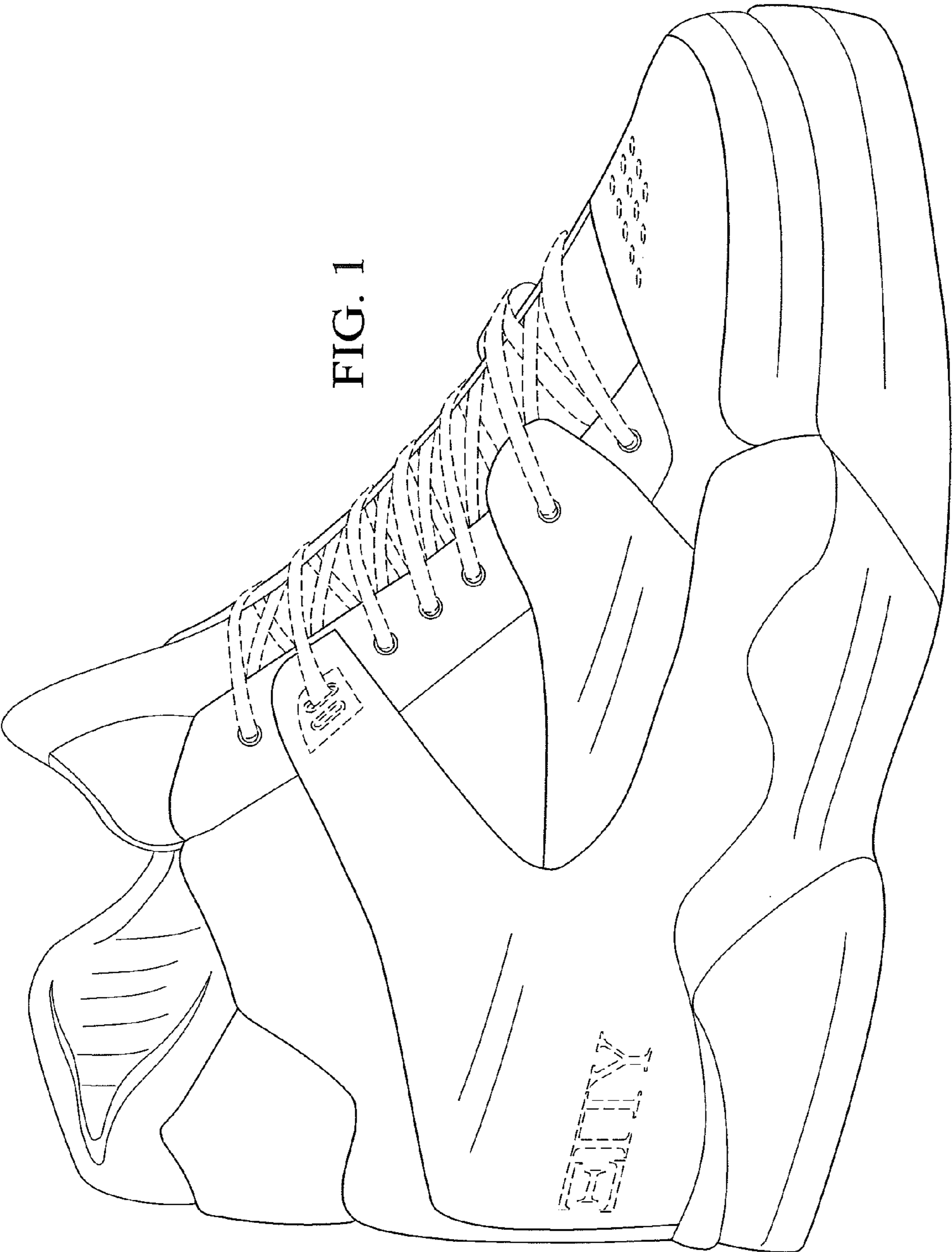

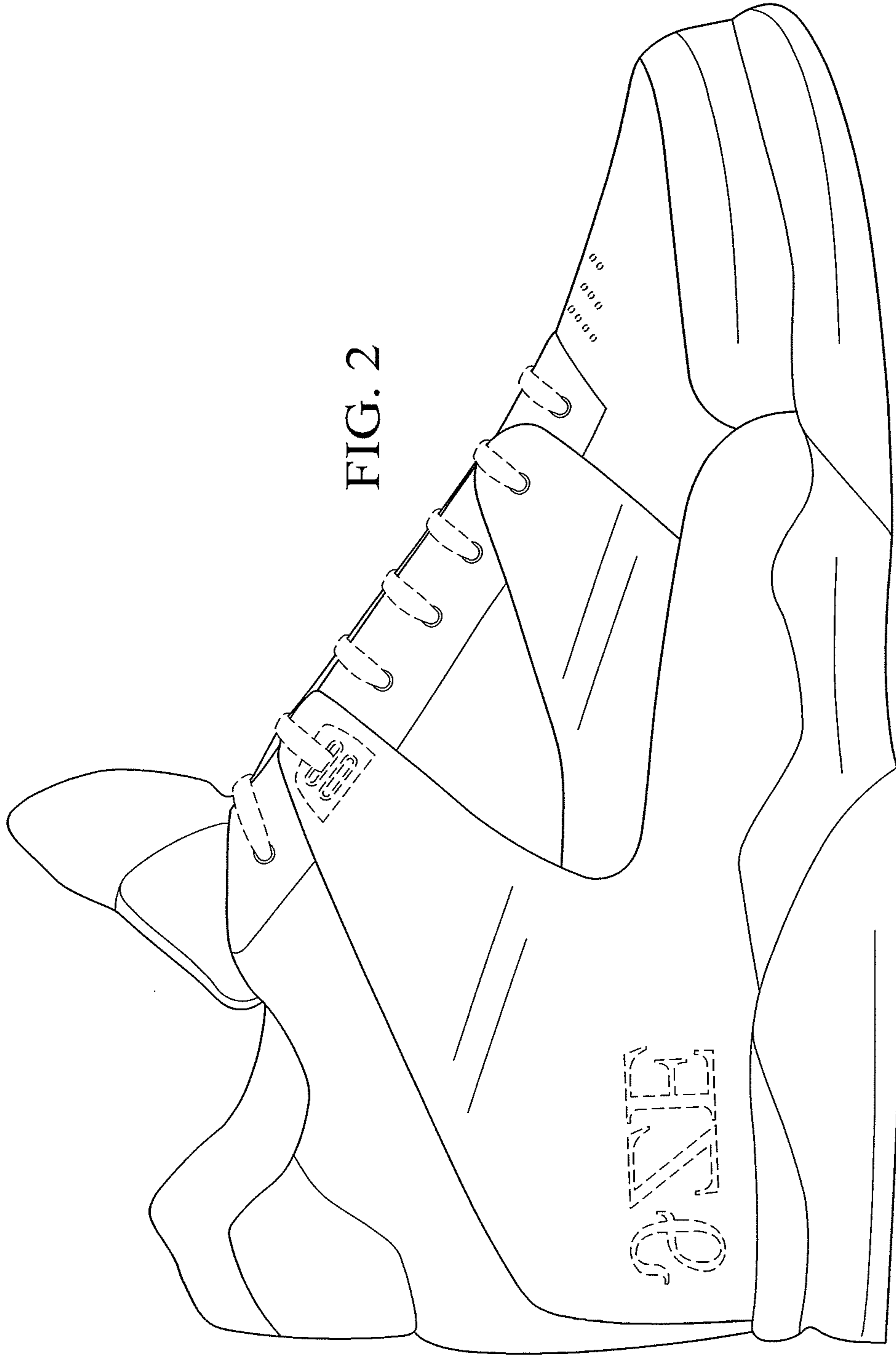

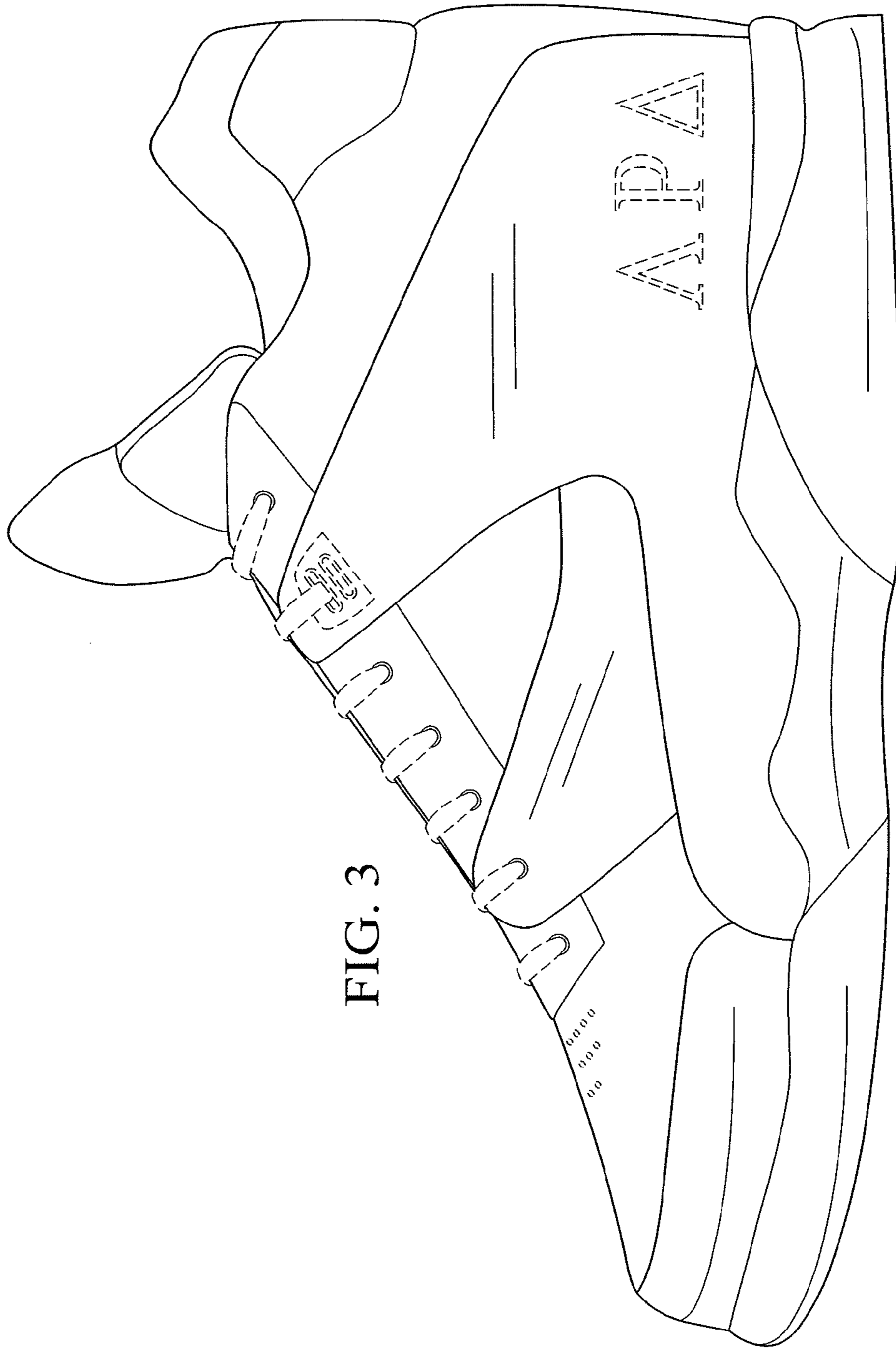

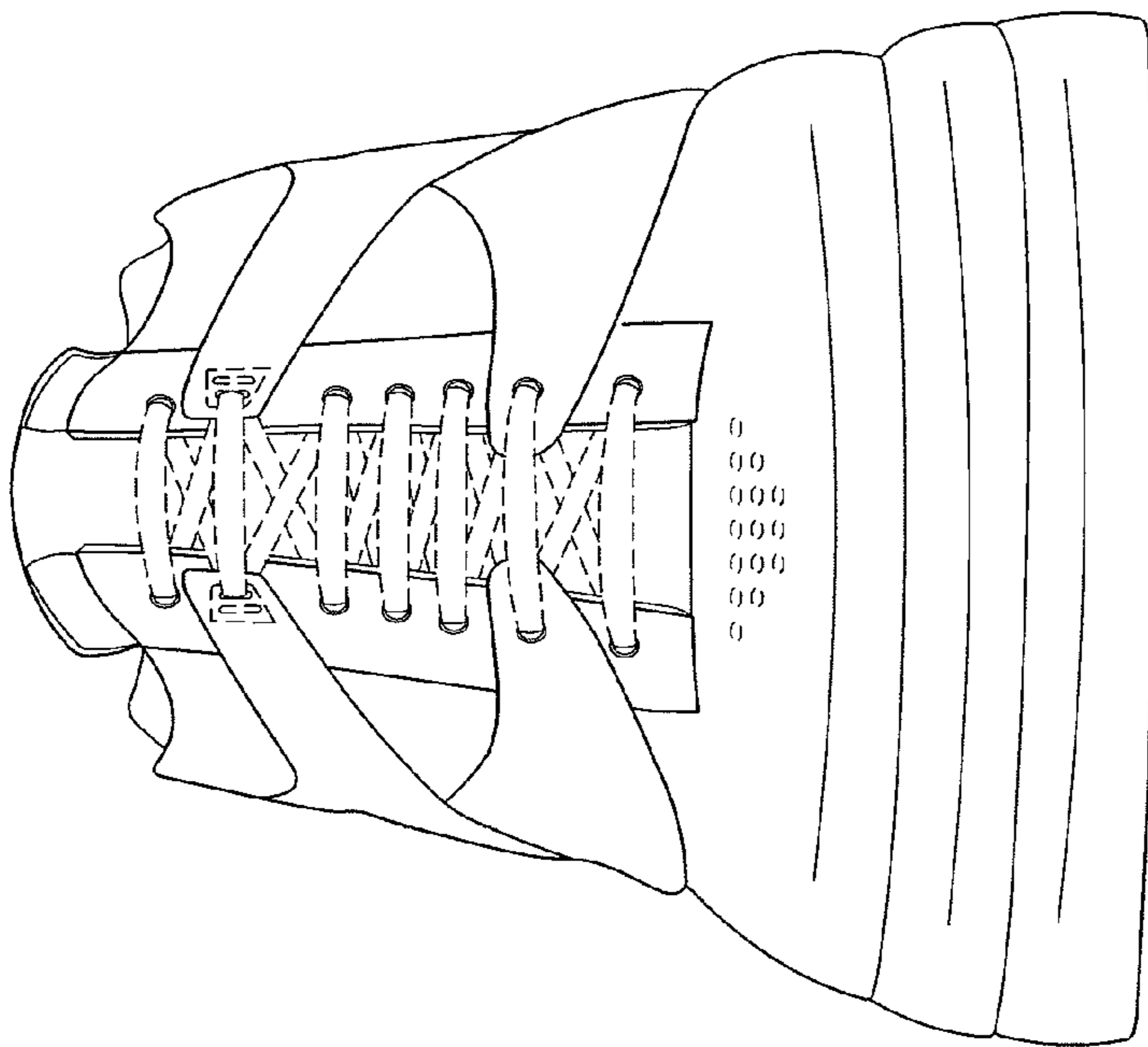

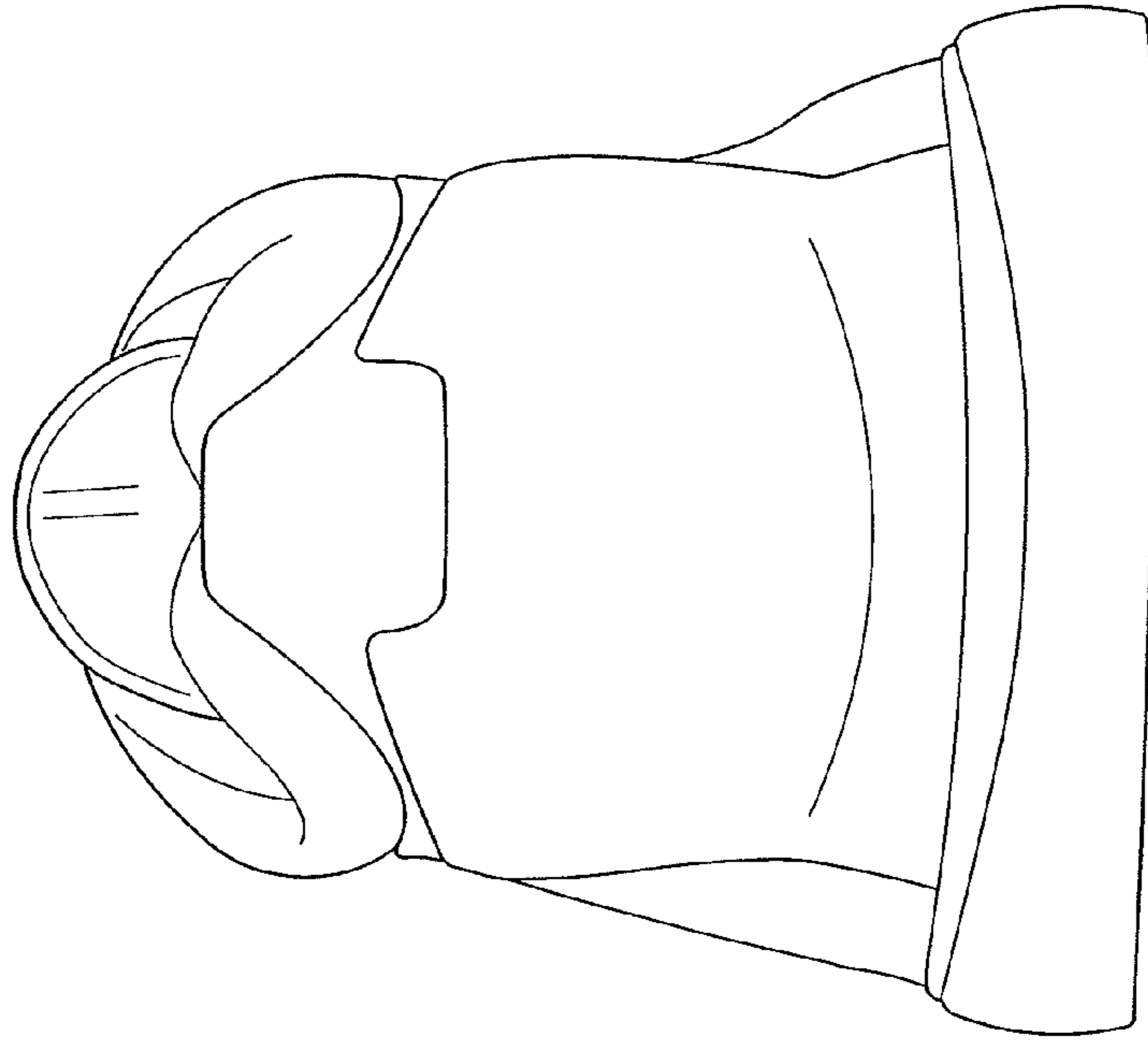

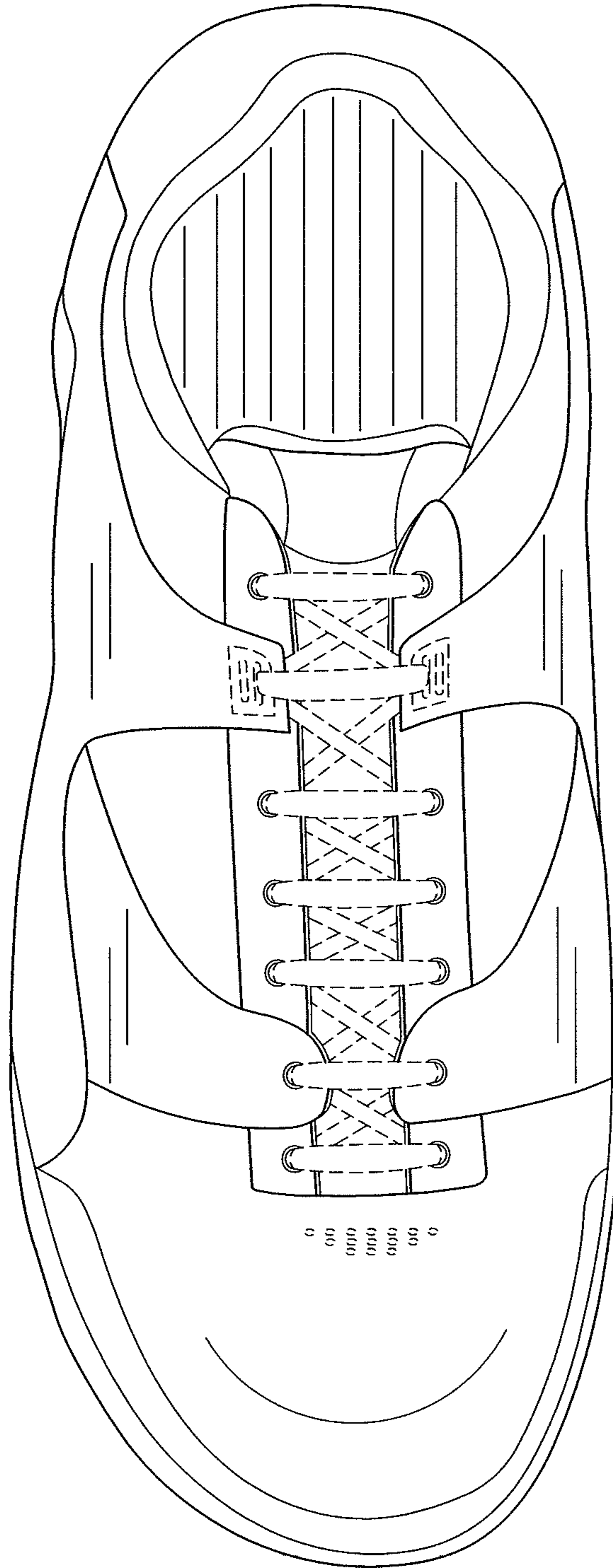
