(57) **CLAIM**

I claim the ornamental design for a footwear outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a footwear outsole showing the new design.

FIG. 2 is a bottom plan view of the footwear outsole showing the new design.

FIG. 3 is a left side view of the footwear outsole showing the new design.

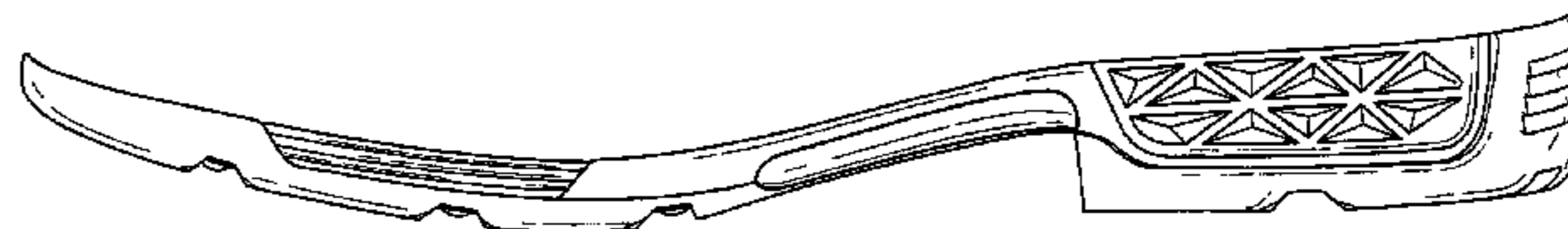
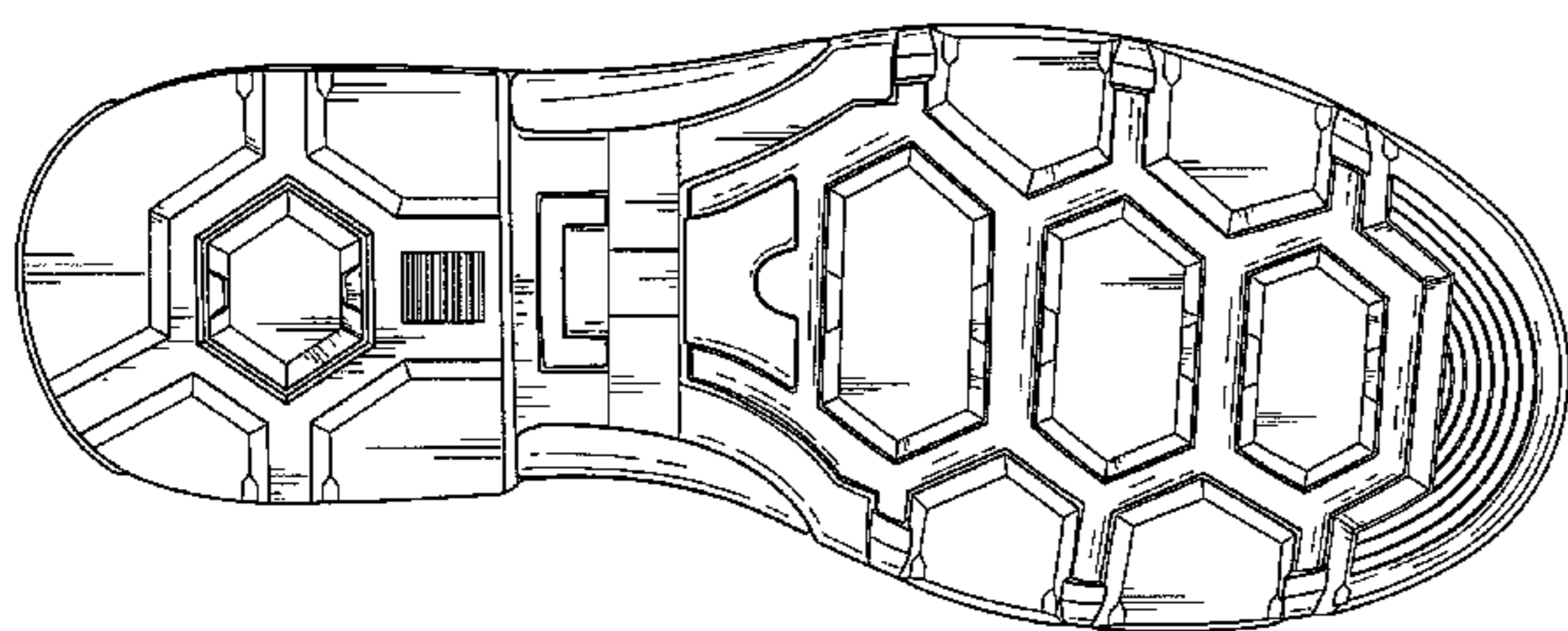
FIG. 4 is a right side view of the footwear outsole showing the new design.

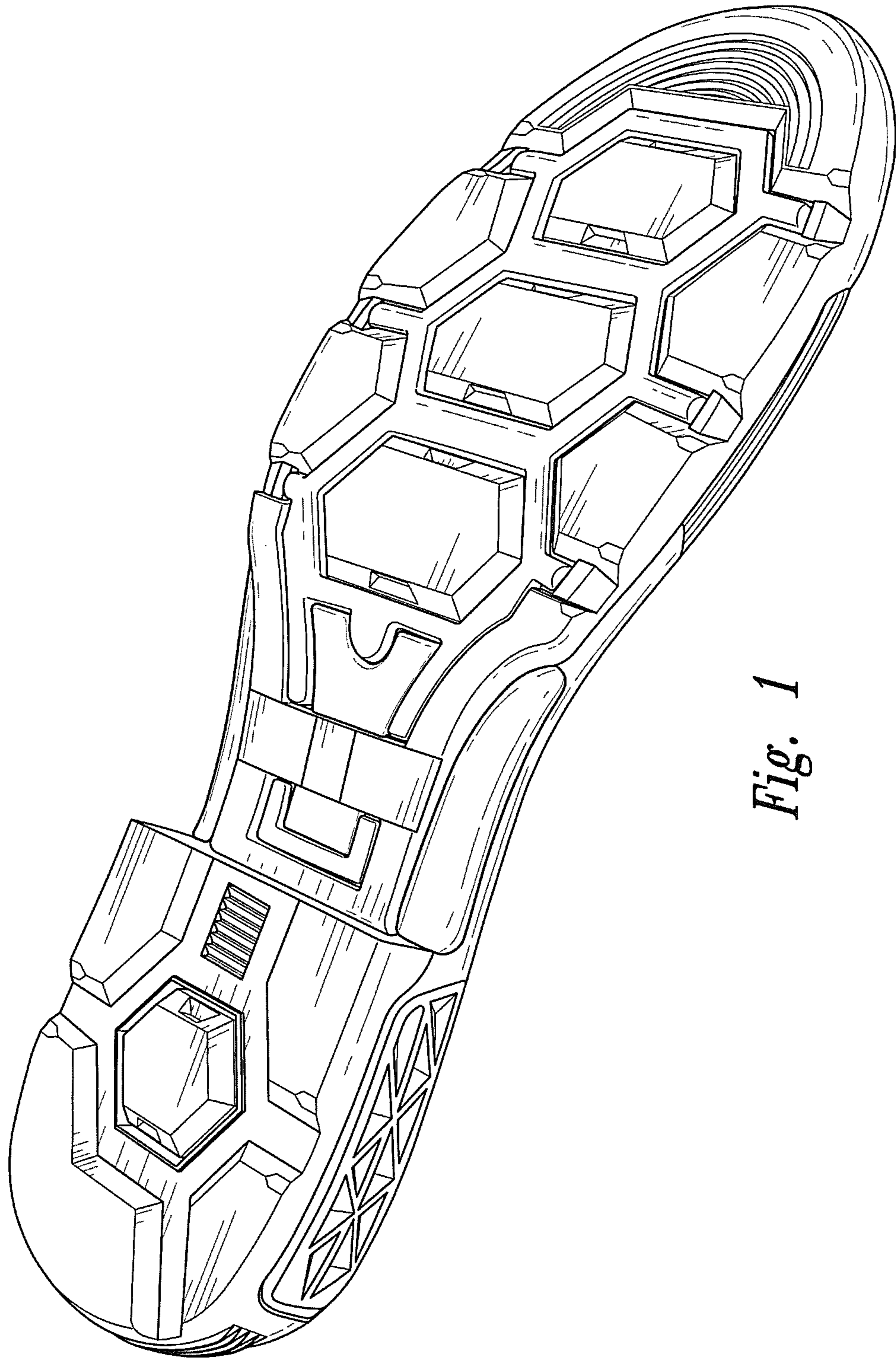
FIG. 5 is a front view of the footwear outsole showing the new design; and,

FIG. 6 is a rear view of the footwear outsole showing the new design.

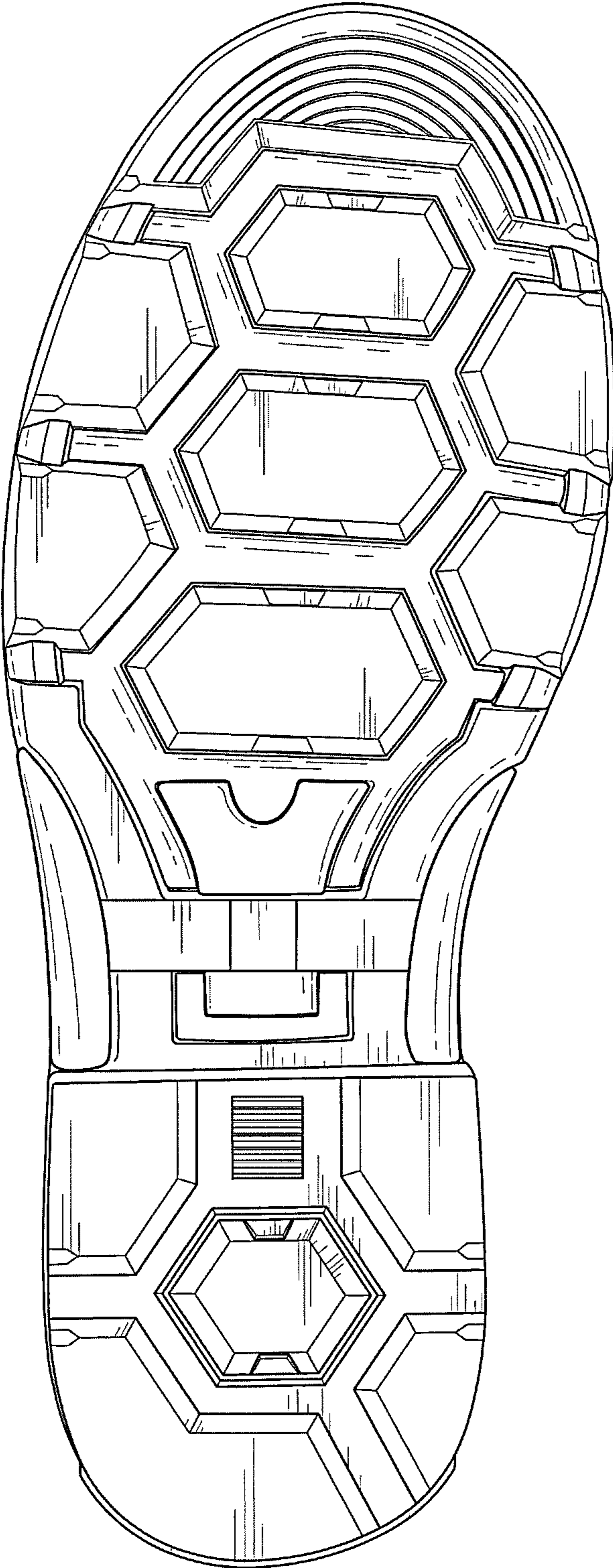
The top surface of the footwear outsole forms no part of the claimed design. The shading lines shown in the drawings represent the approximate three-dimensional contour of the design, and are not intended to indicate surface decoration. The broken line boundaries and the surfaces that they enclose in FIGS. 5 and 6 indicate portions of the footwear outsole that form no part of the claimed design.

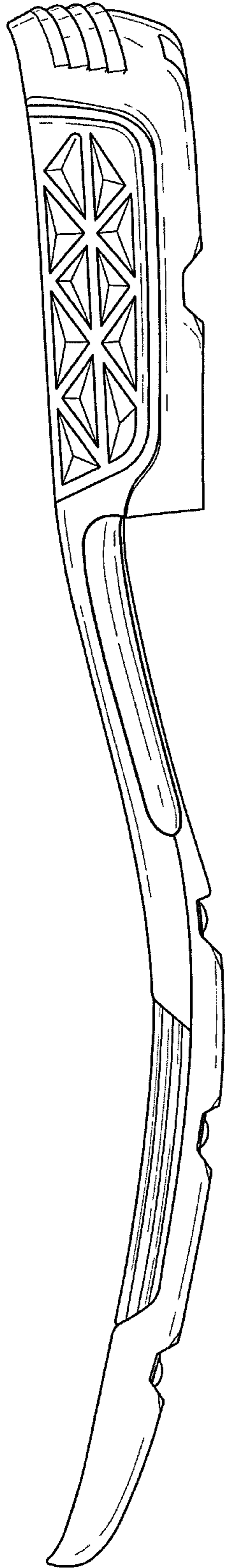




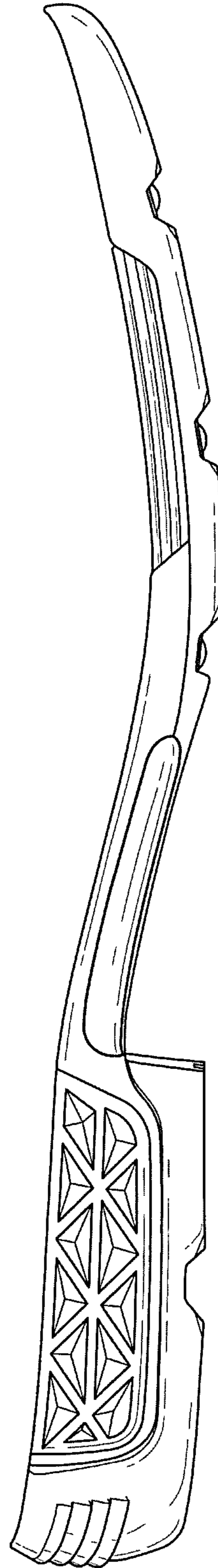

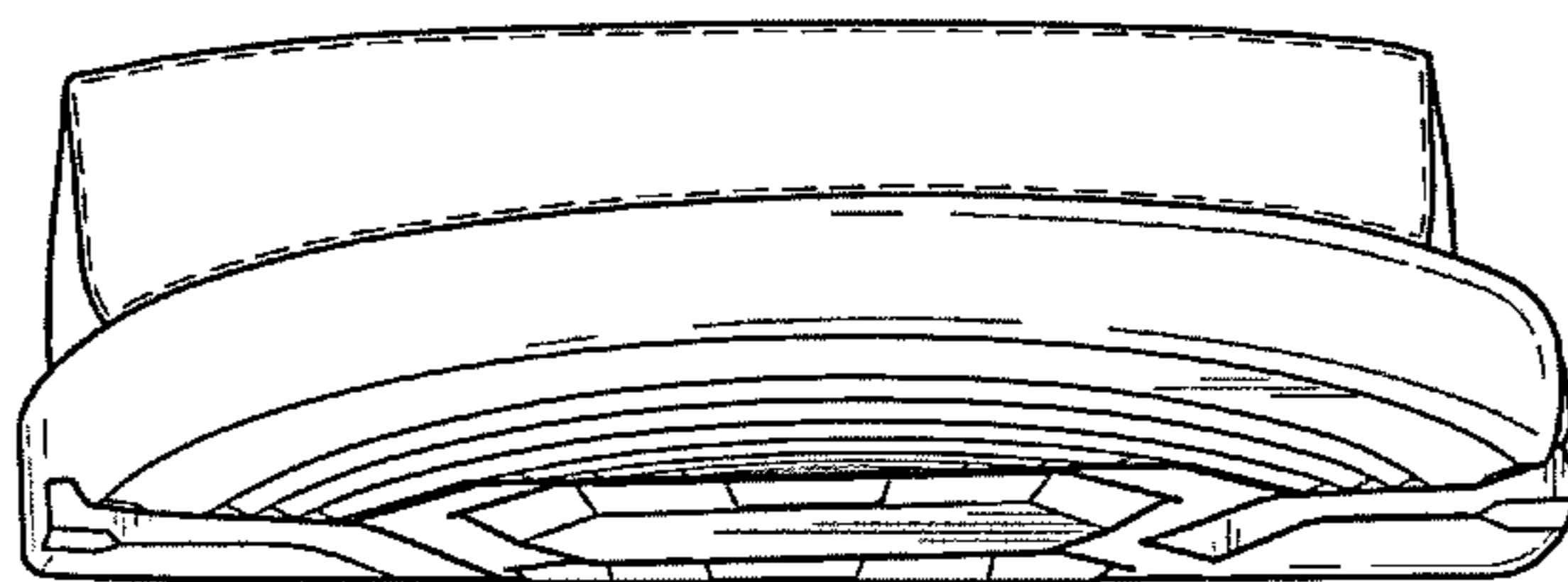

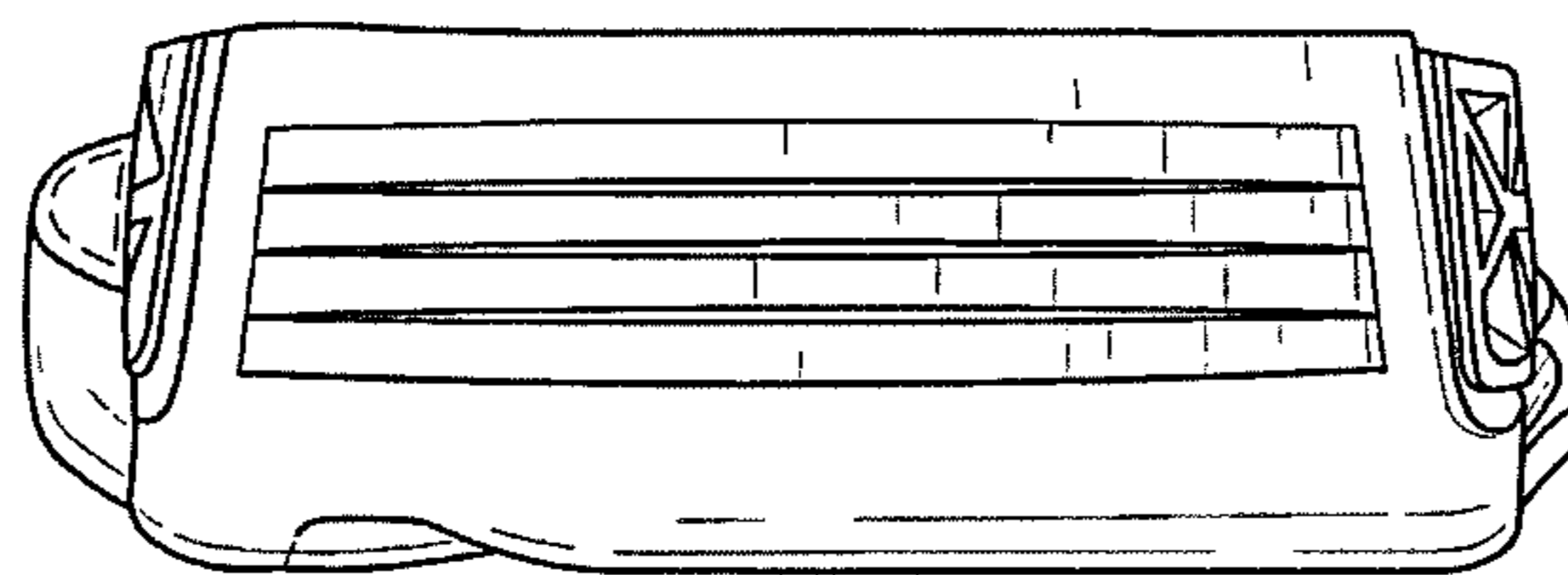
