DESCRIPTION

FIG. 1 is a top plan view of a hair brush showing my new design;
FIG. 2 is a bottom plan view thereof, each of the right and left sides being a mirror image of the shown;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof; and,
FIG. 5 is a cross-sectional view taken along line 5-5 of FIG. 1.

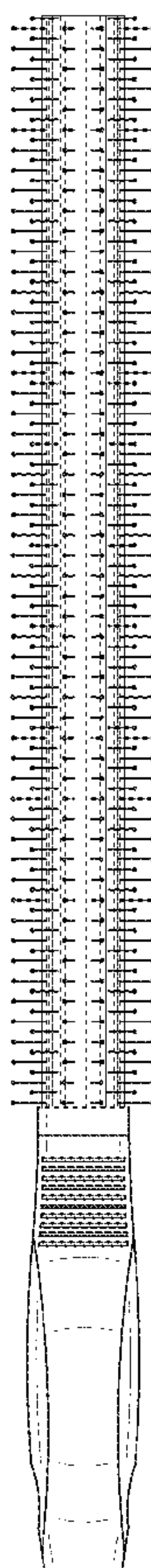

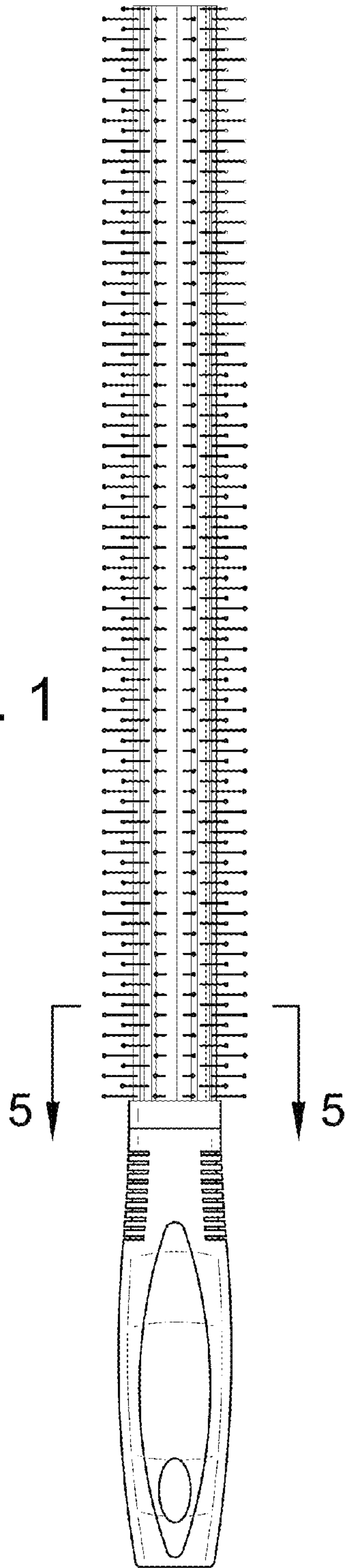
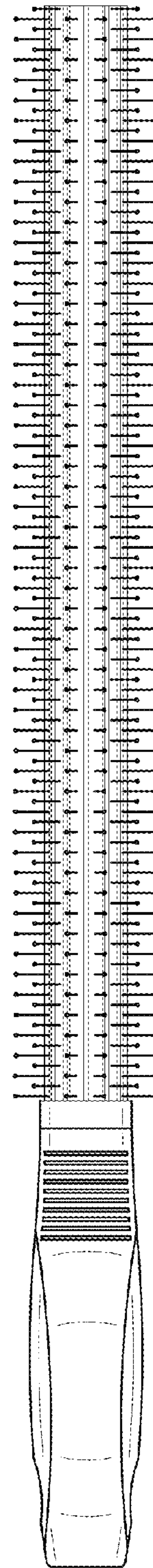

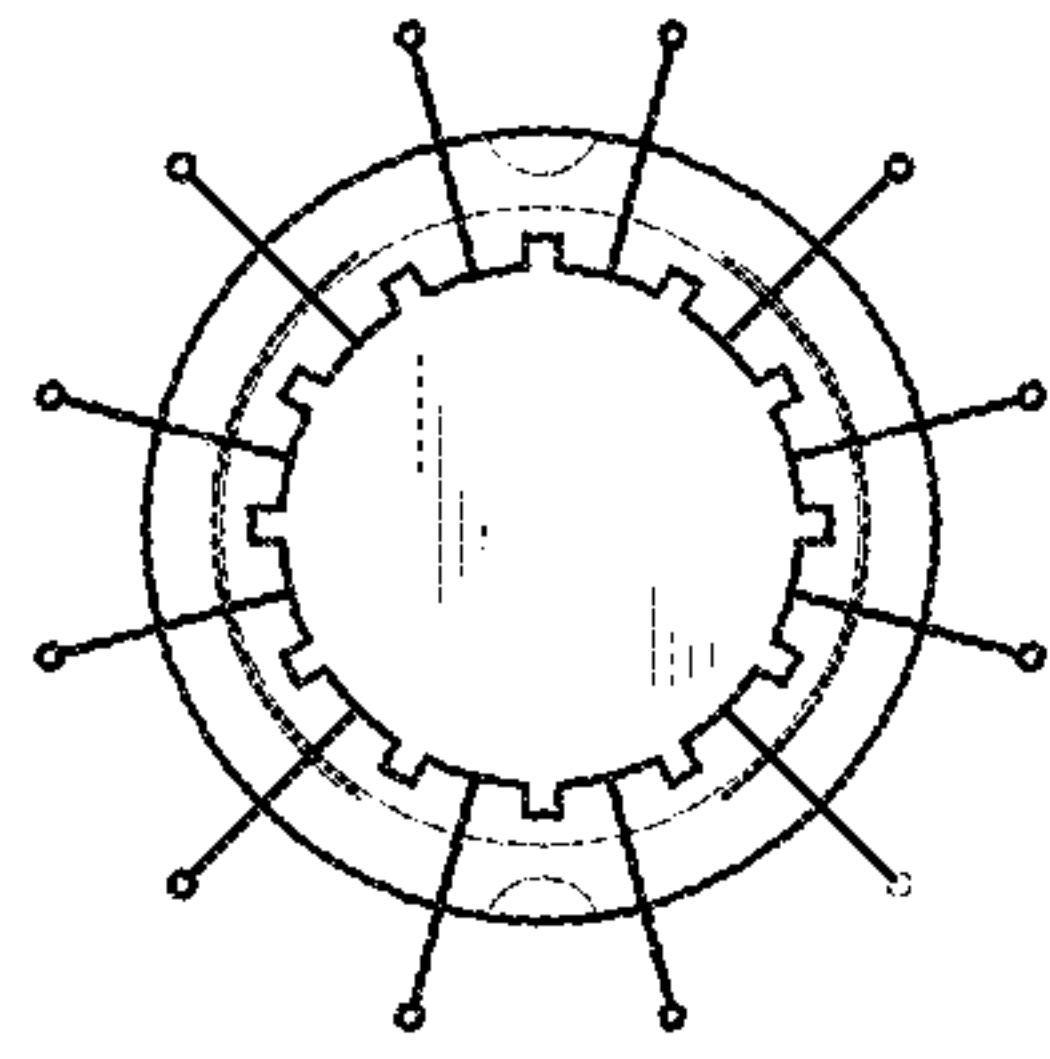

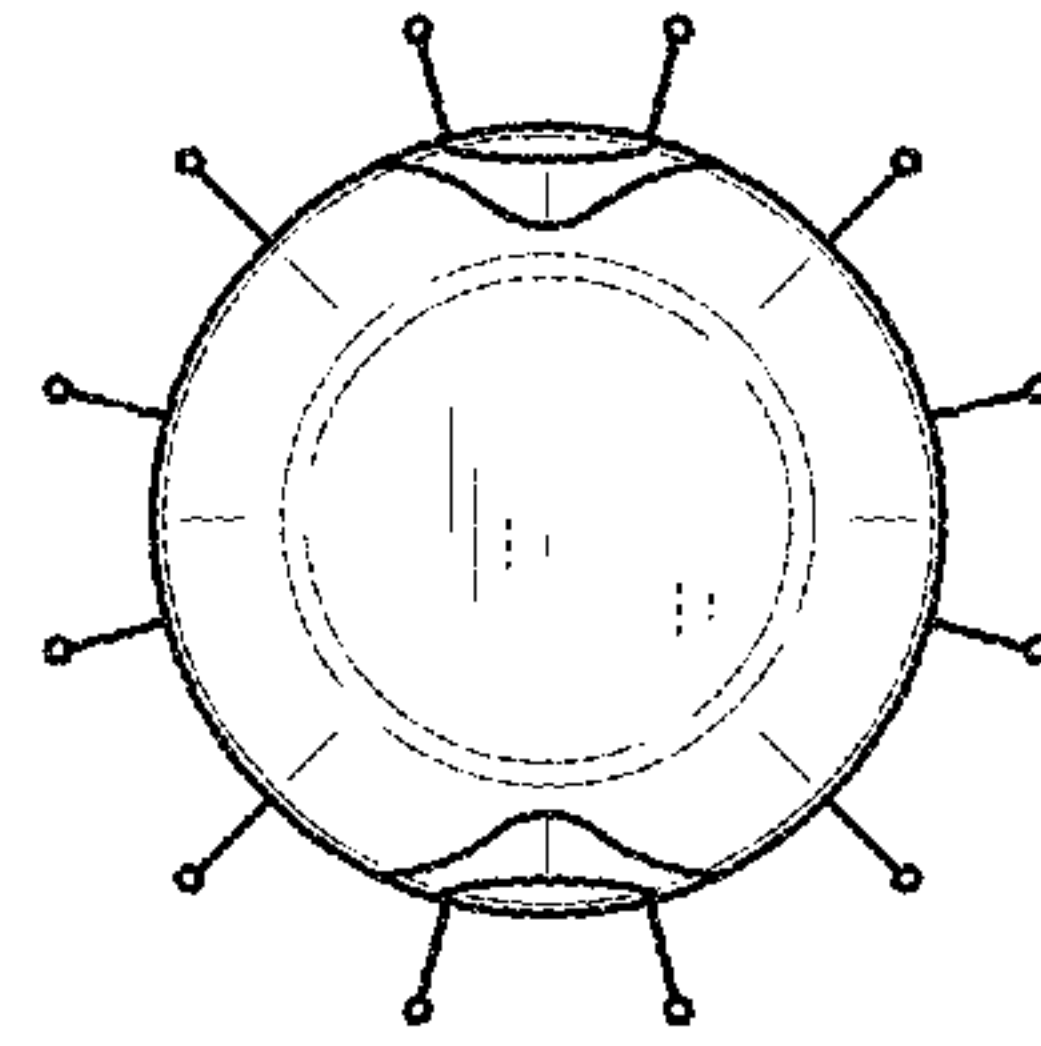

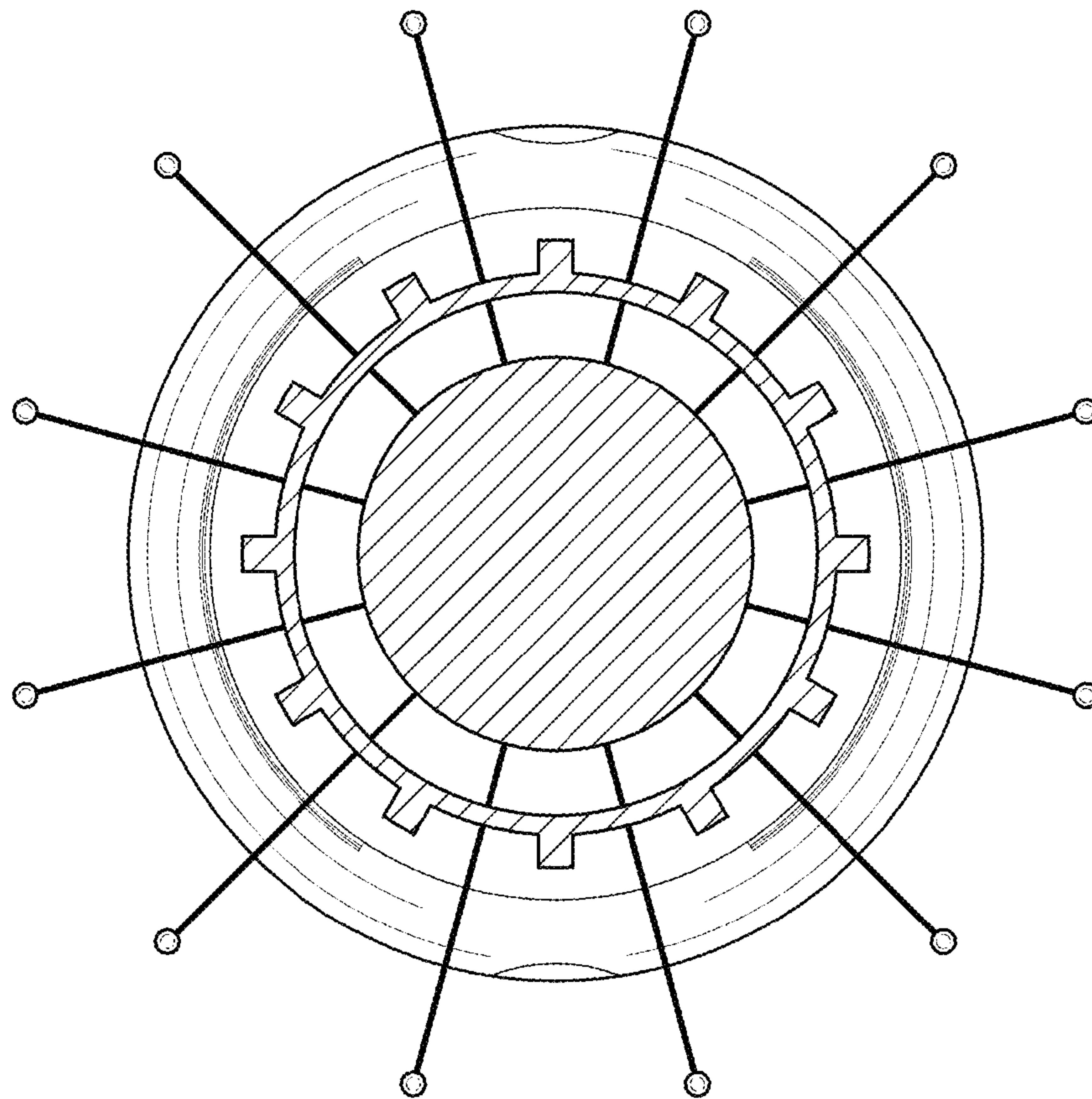
