**CLAIM**

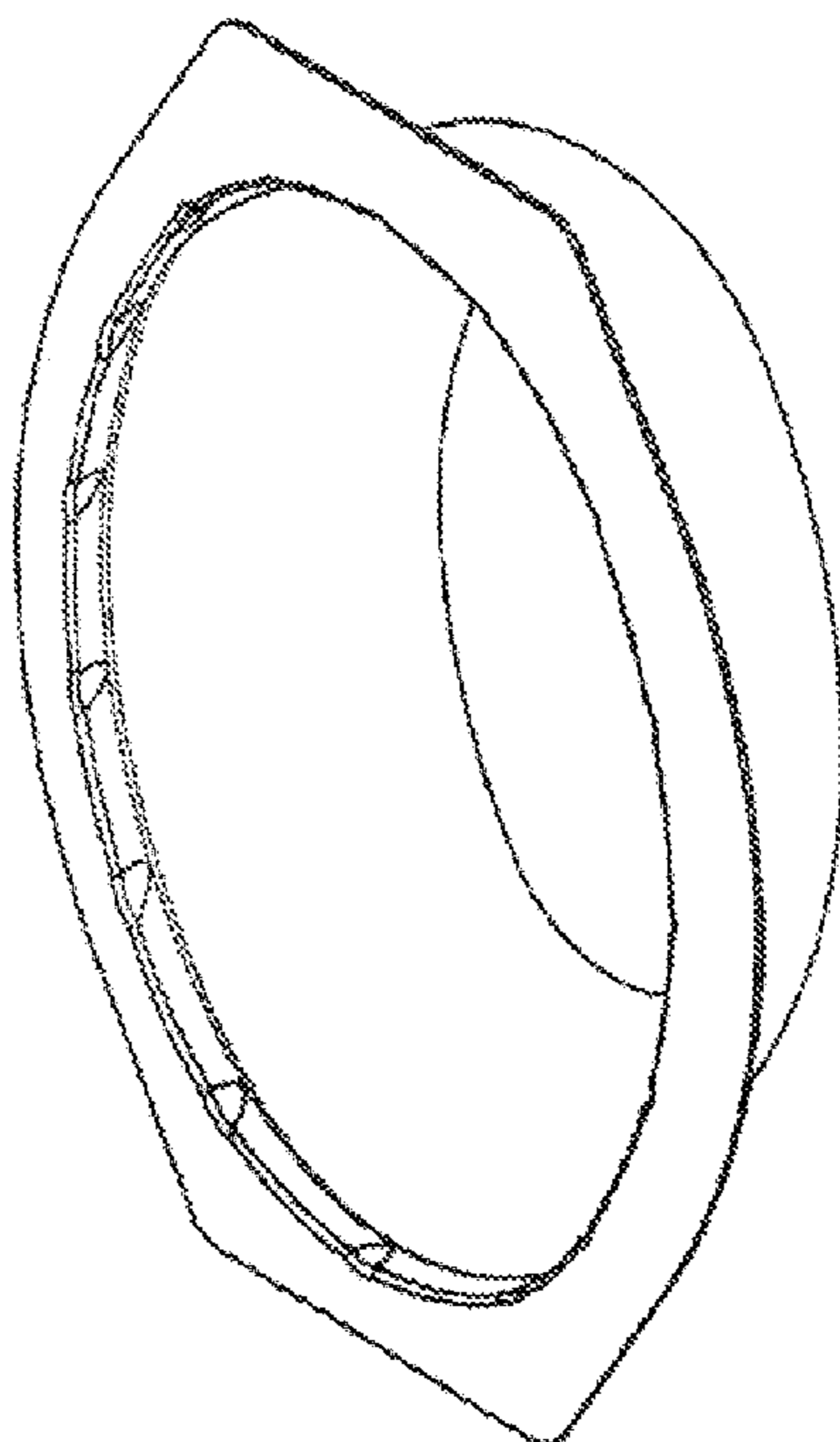
(57) The ornamental design for a rigid ribbed tray, as shown and described.

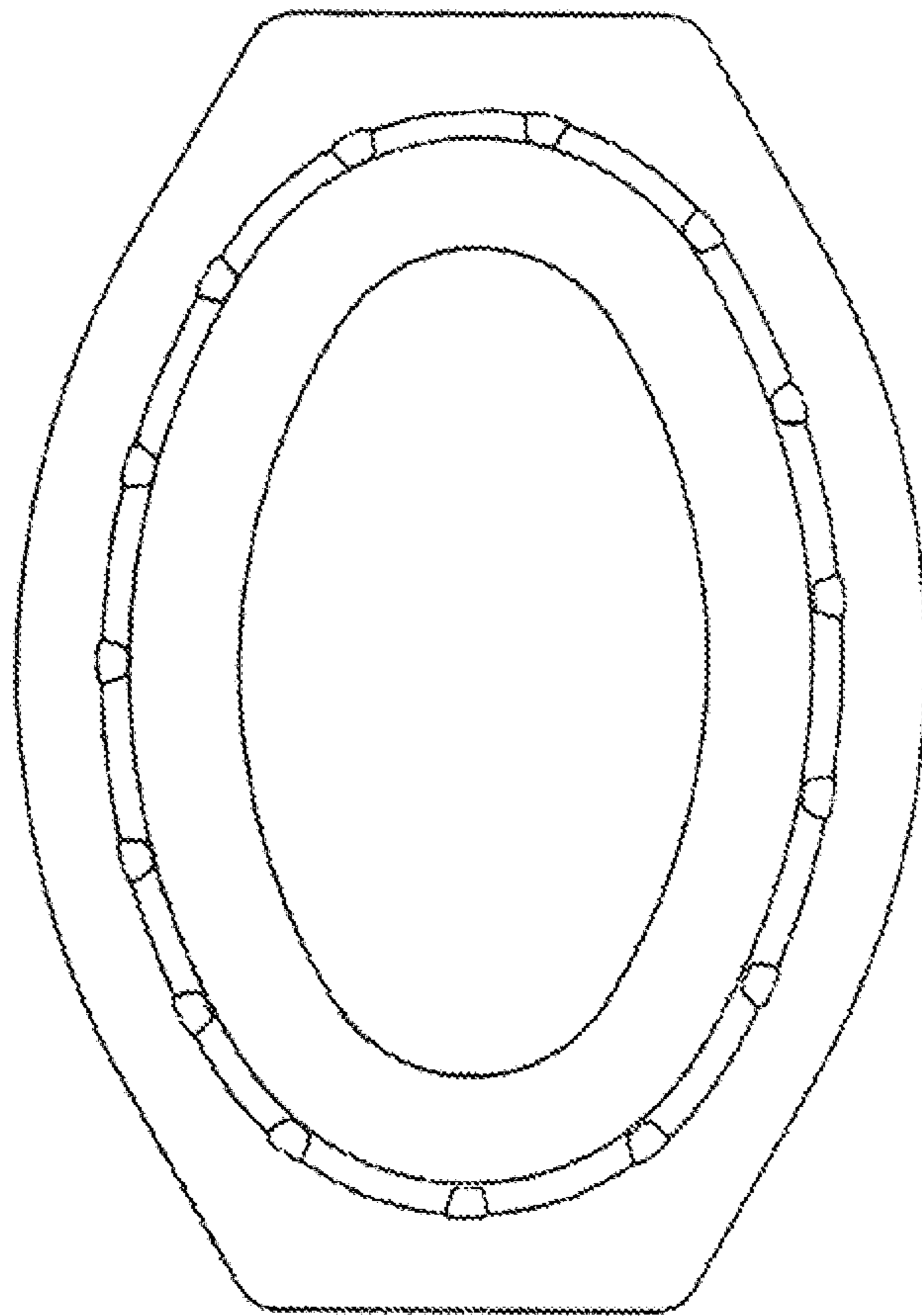

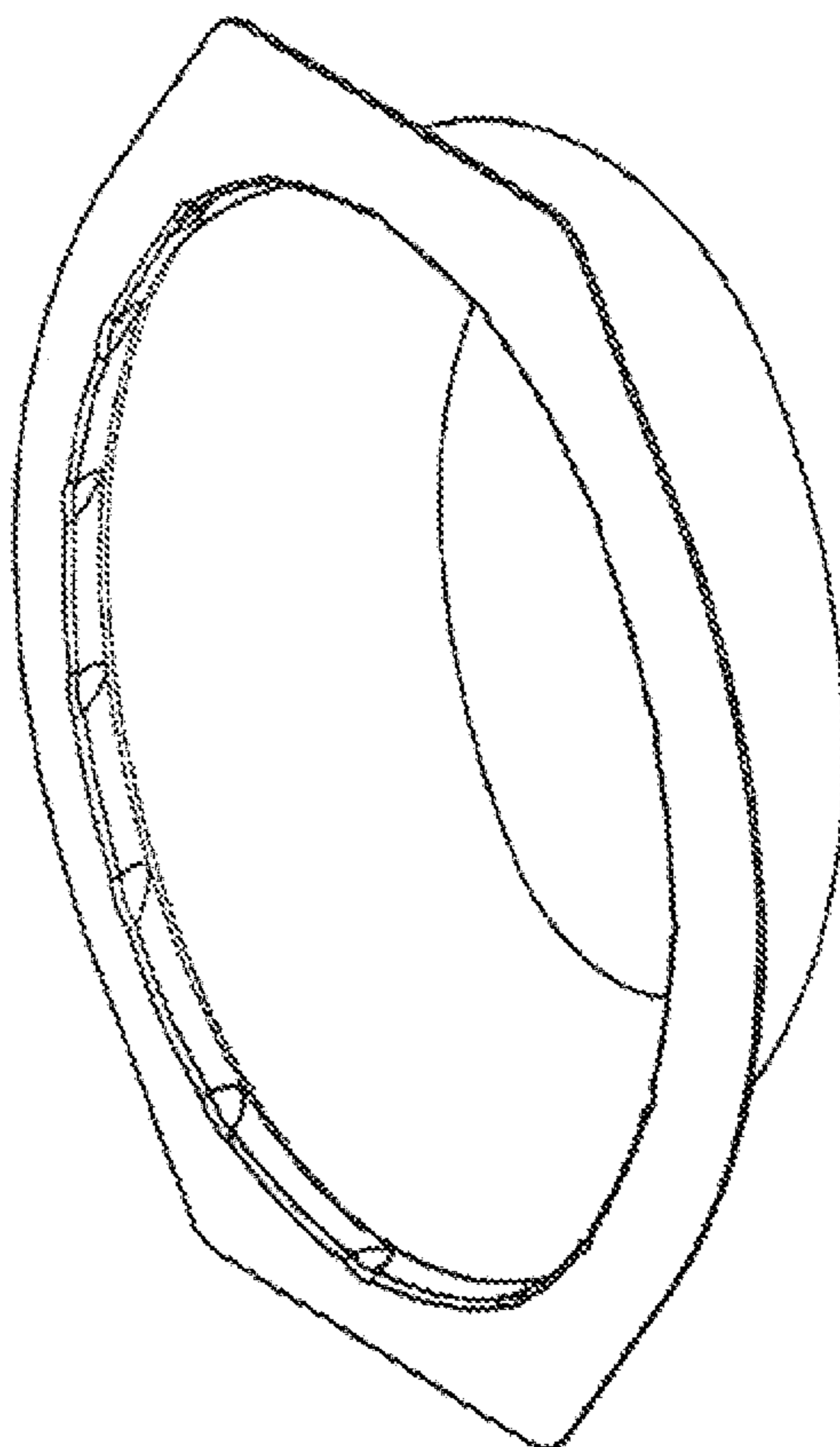

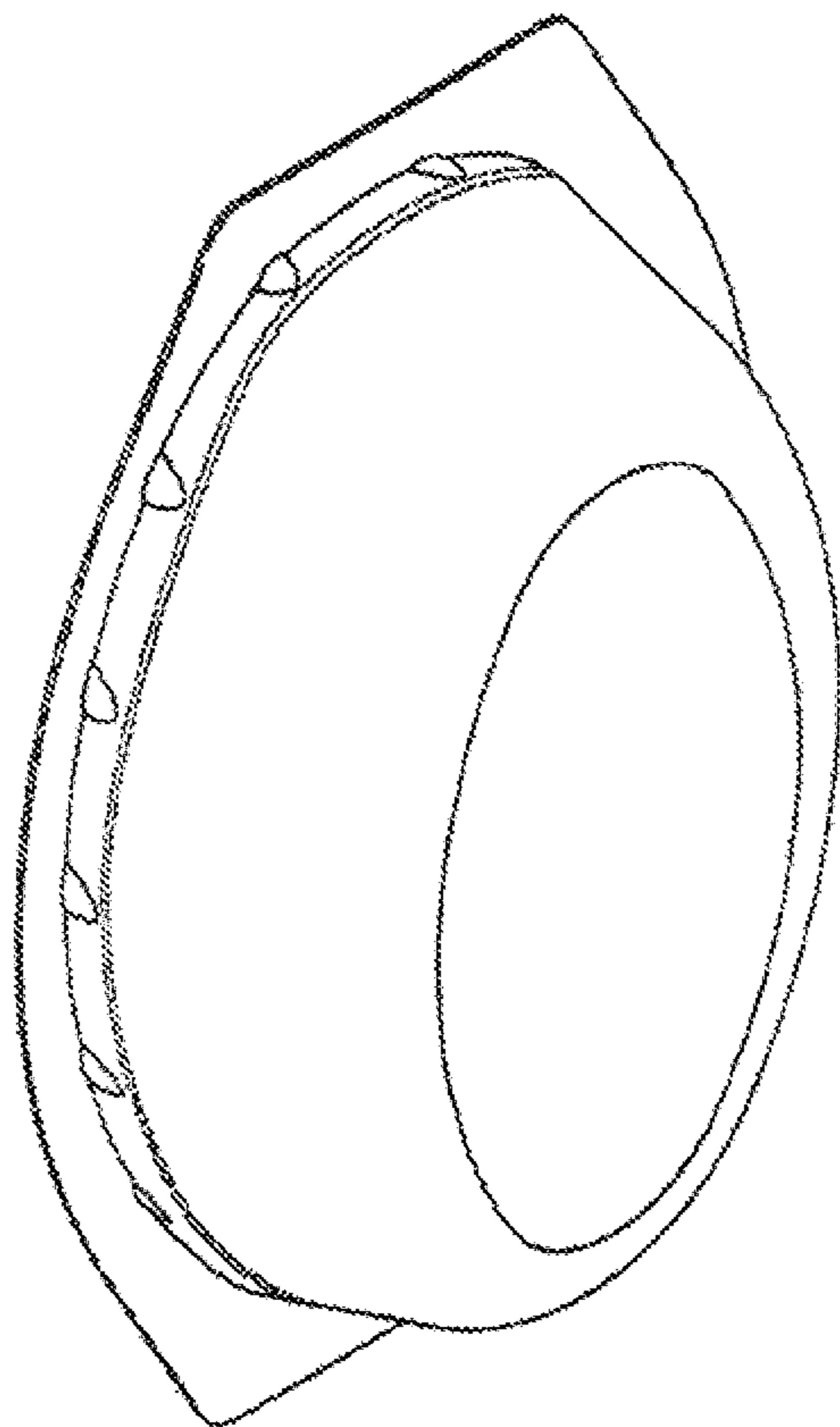
