DESCRIPTION

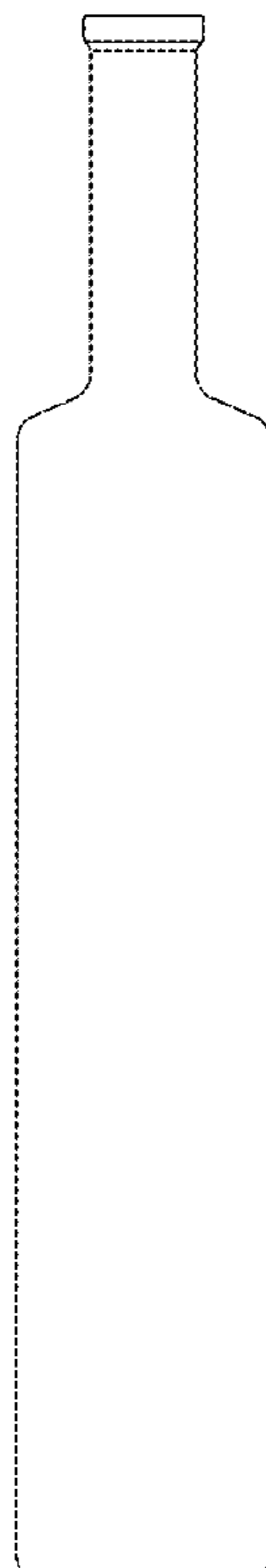
FIG. 1 is a side elevation view of a bottle showing the new design;

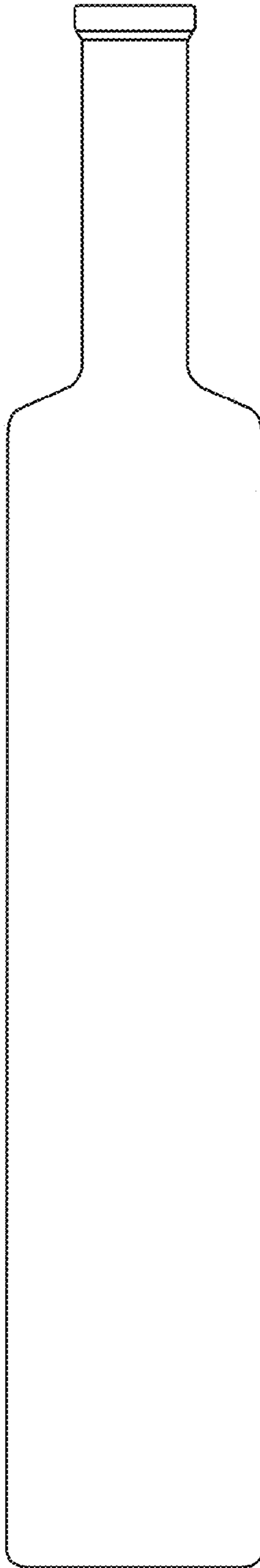

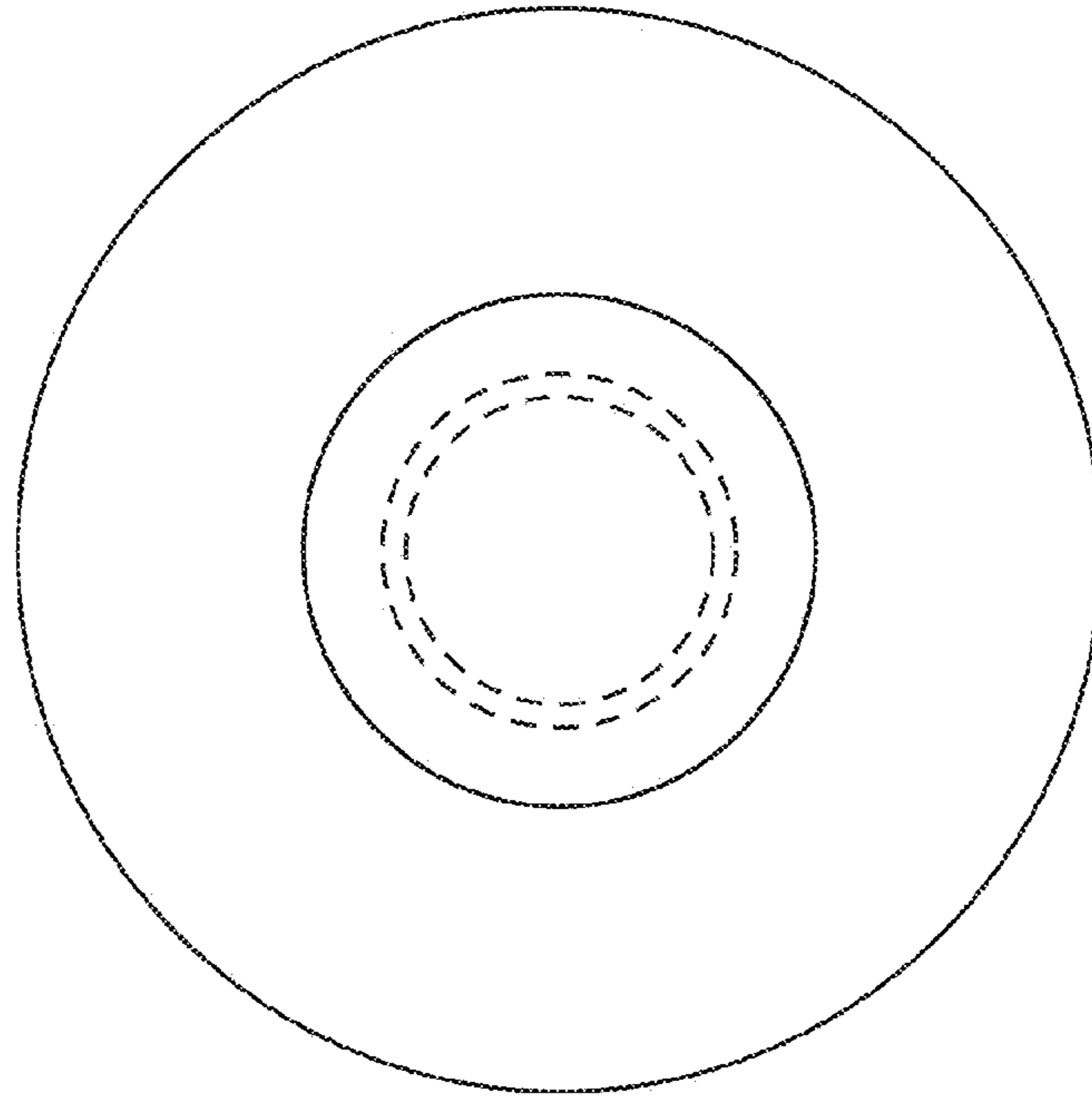

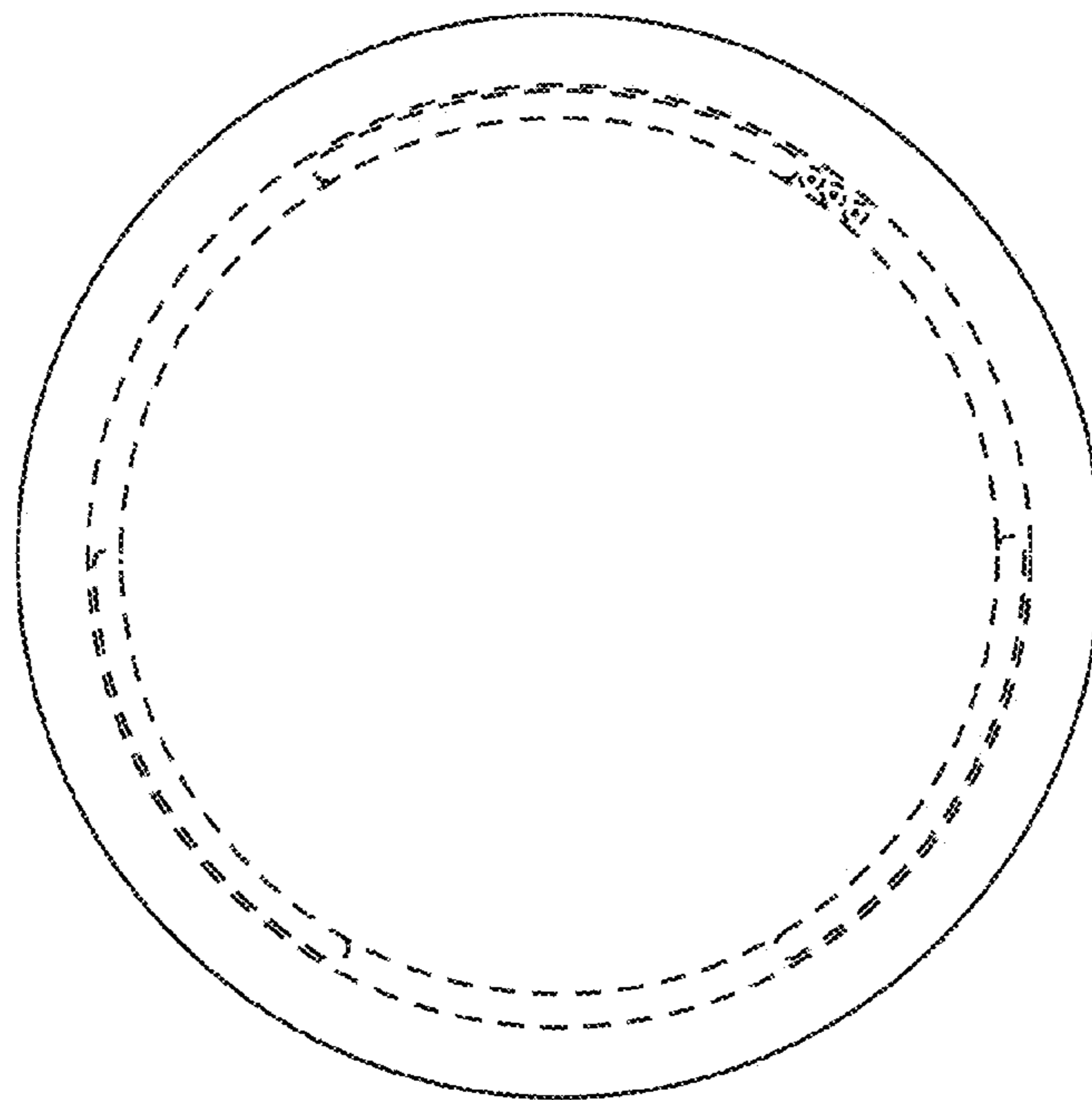
