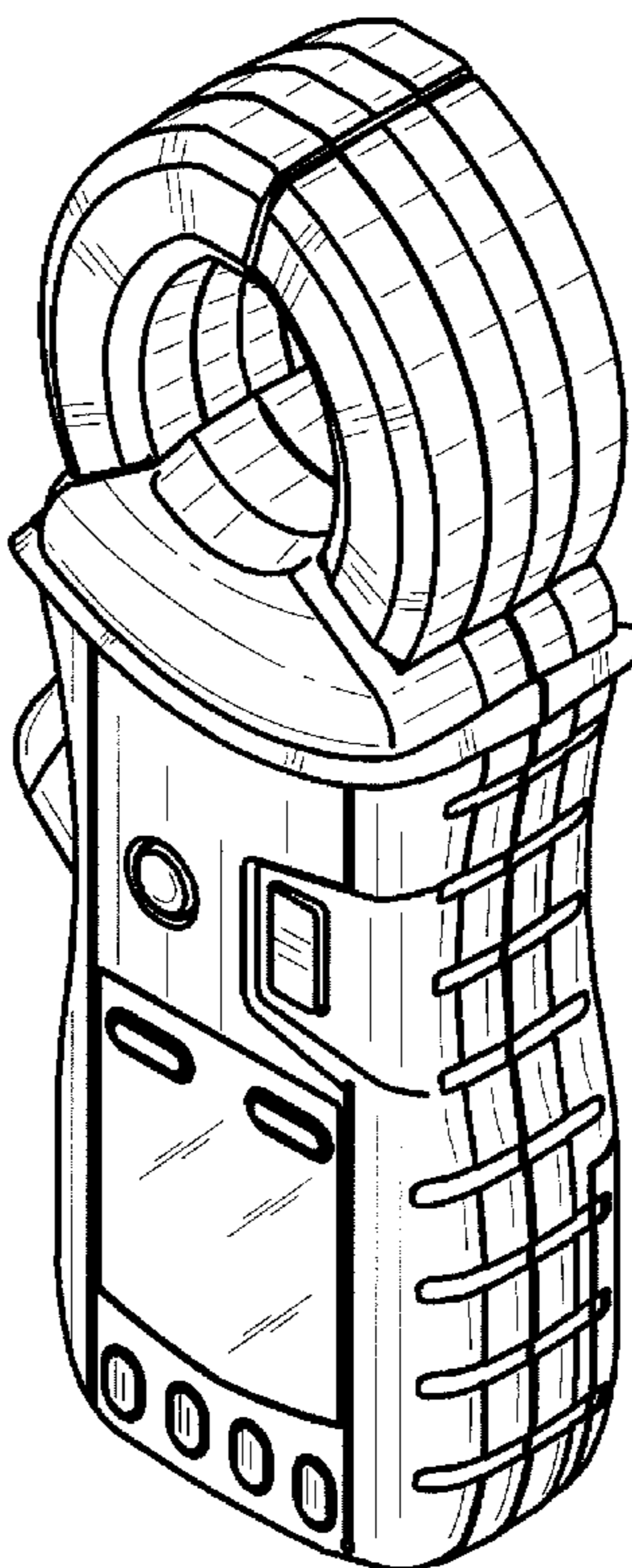
(57) **CLAIM**

I claim the ornamental design for a clamp meter, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a clamp meter, showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a perspective view thereof, showing the clamp part closed; and,
FIG. 8 is a perspective view thereof, showing the clamp part open.

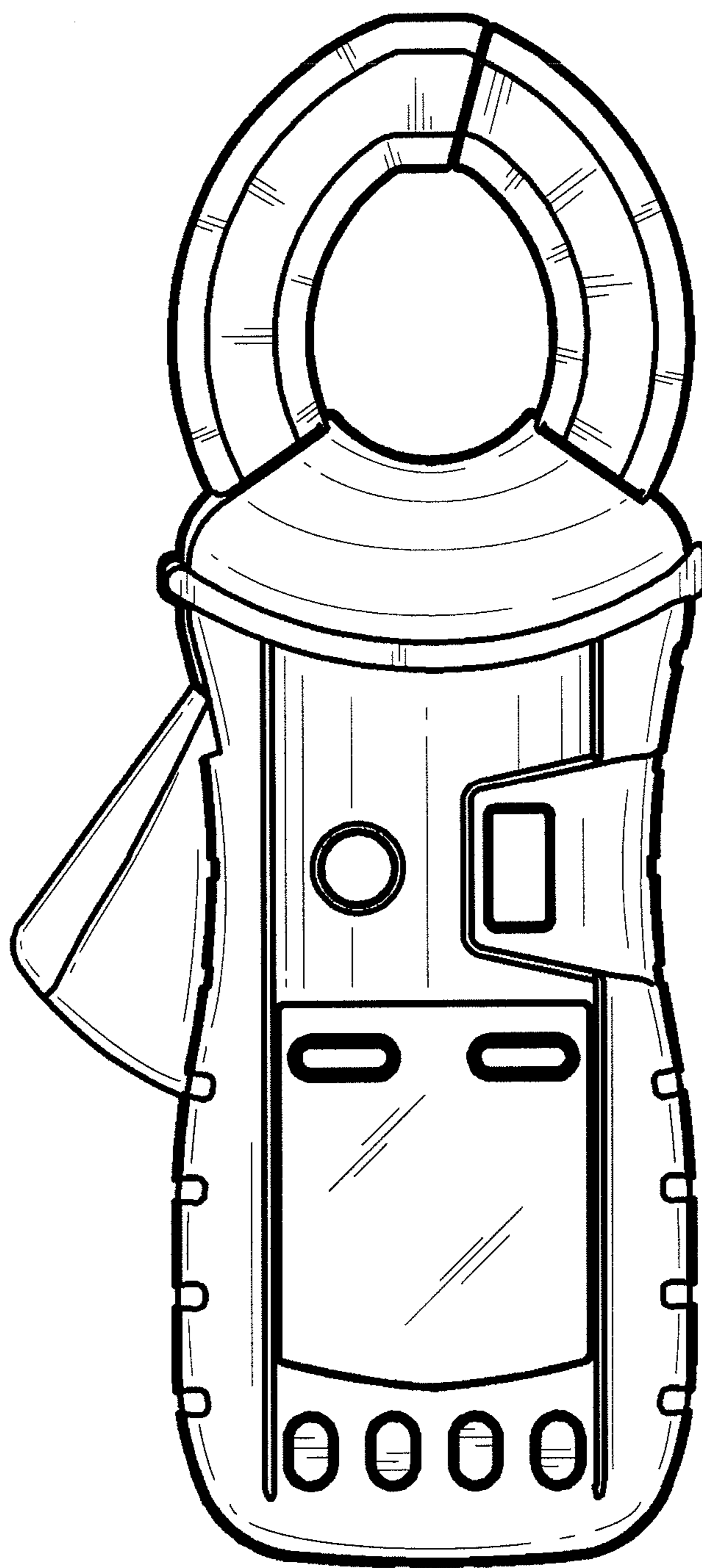

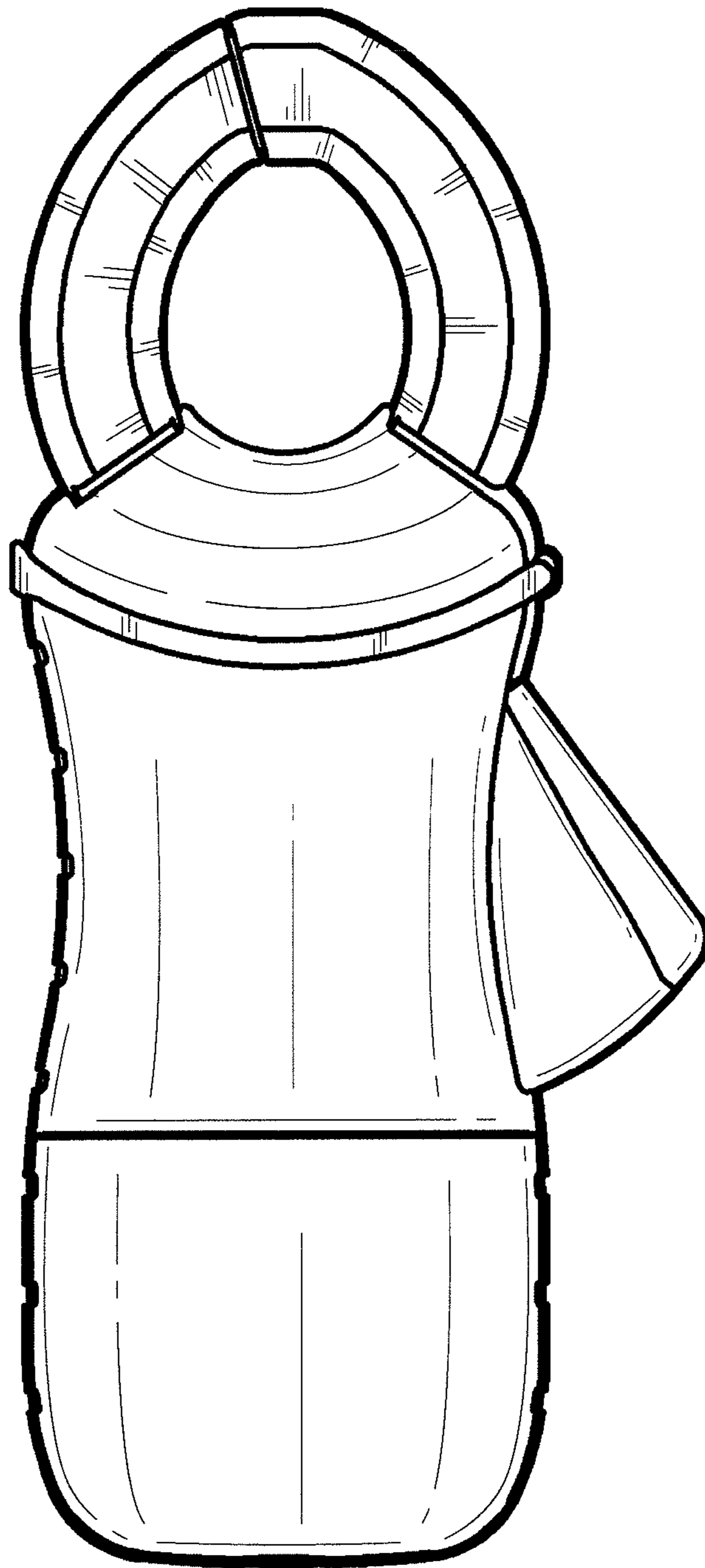

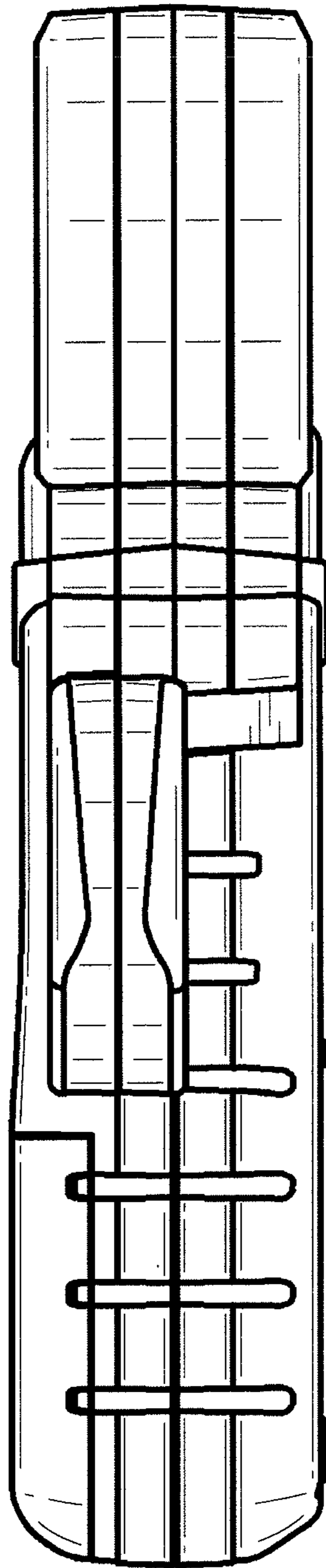

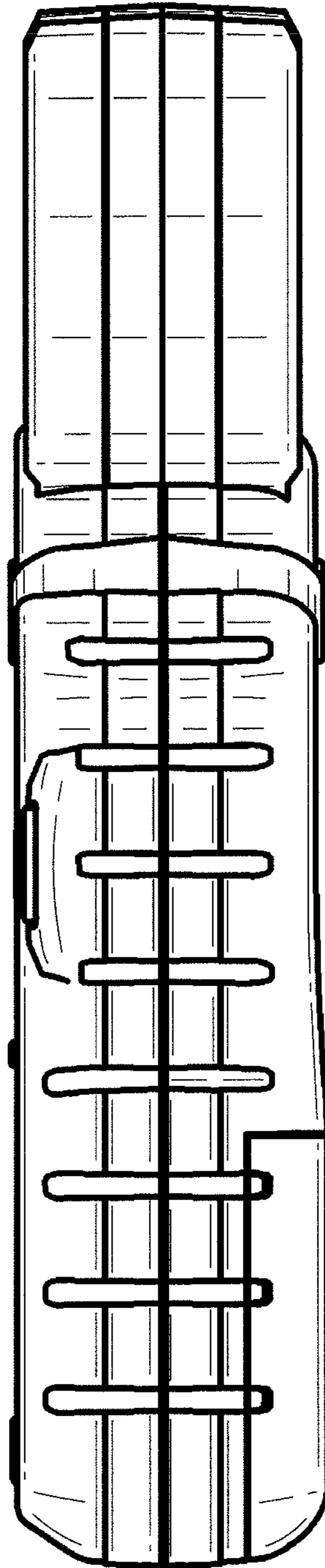

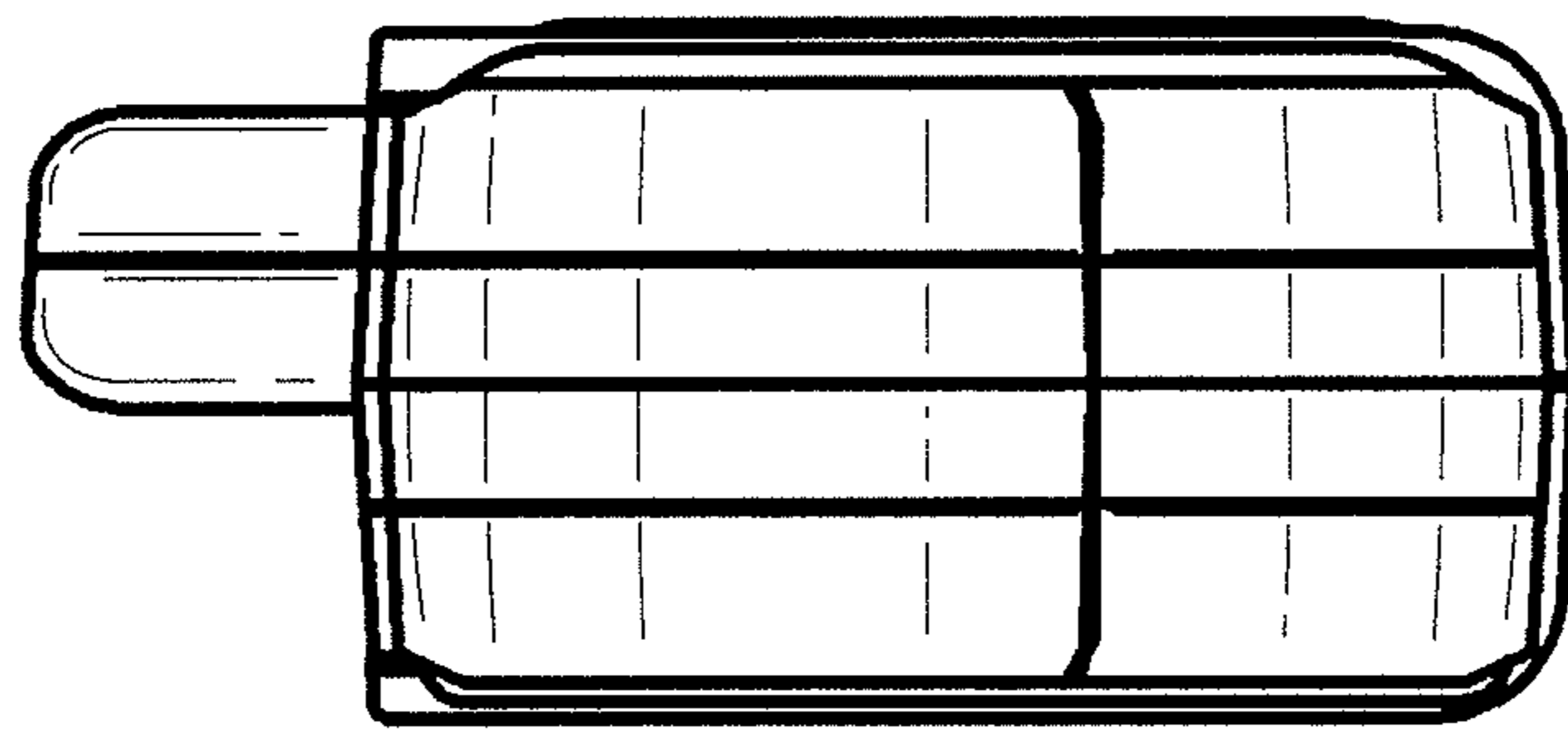

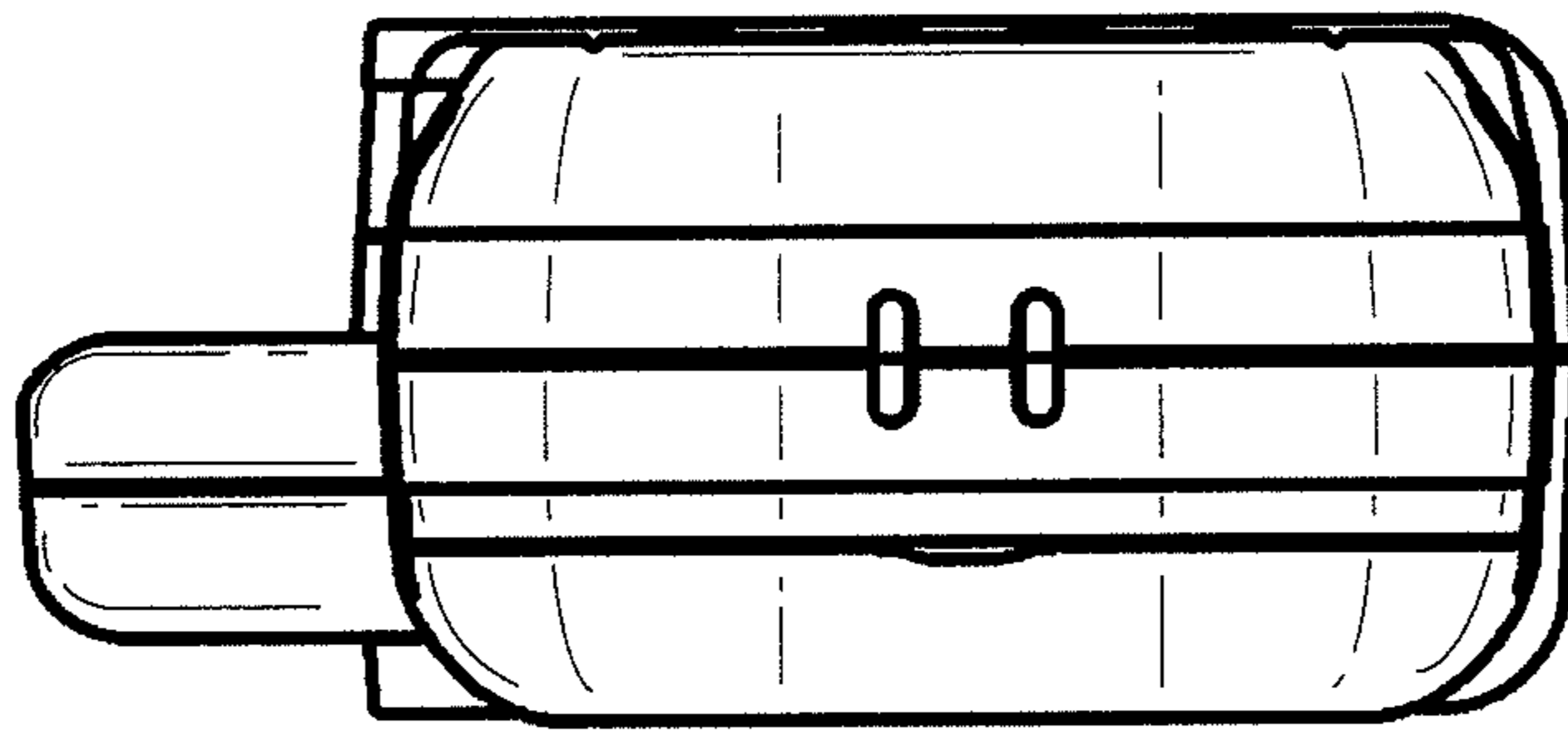

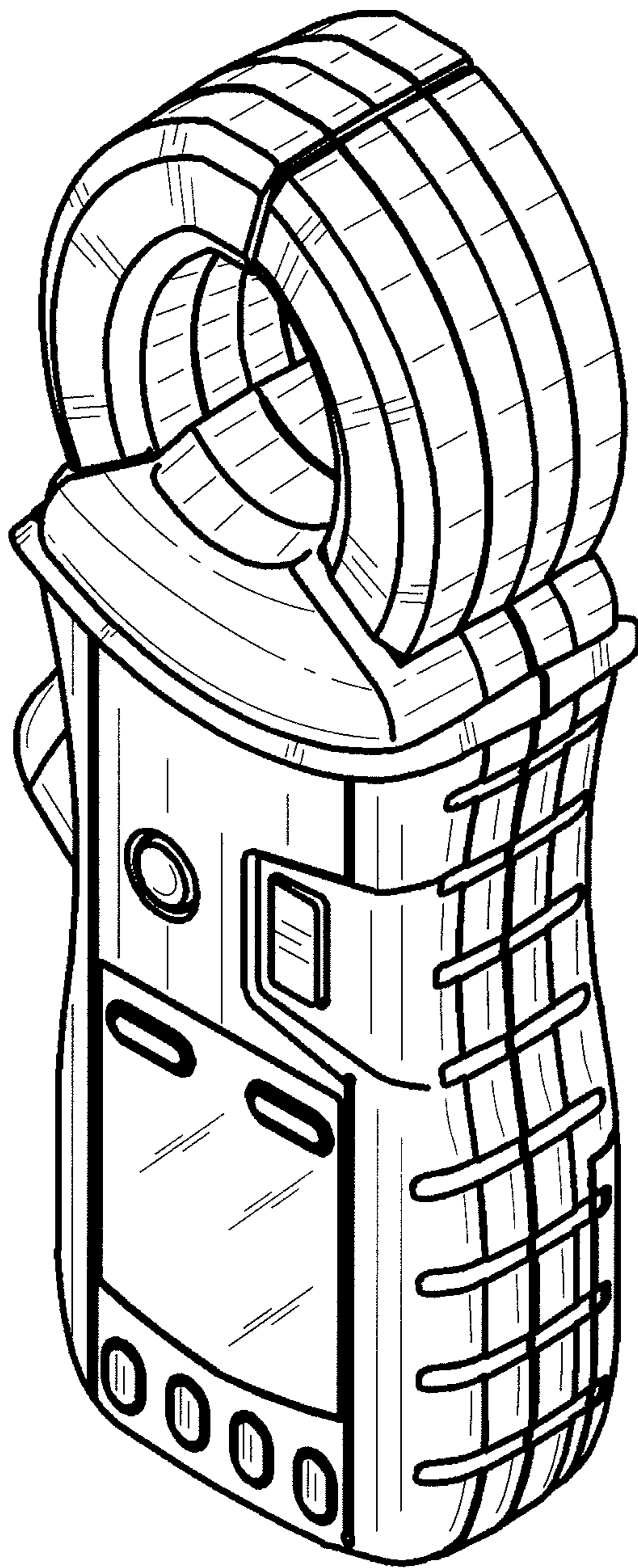

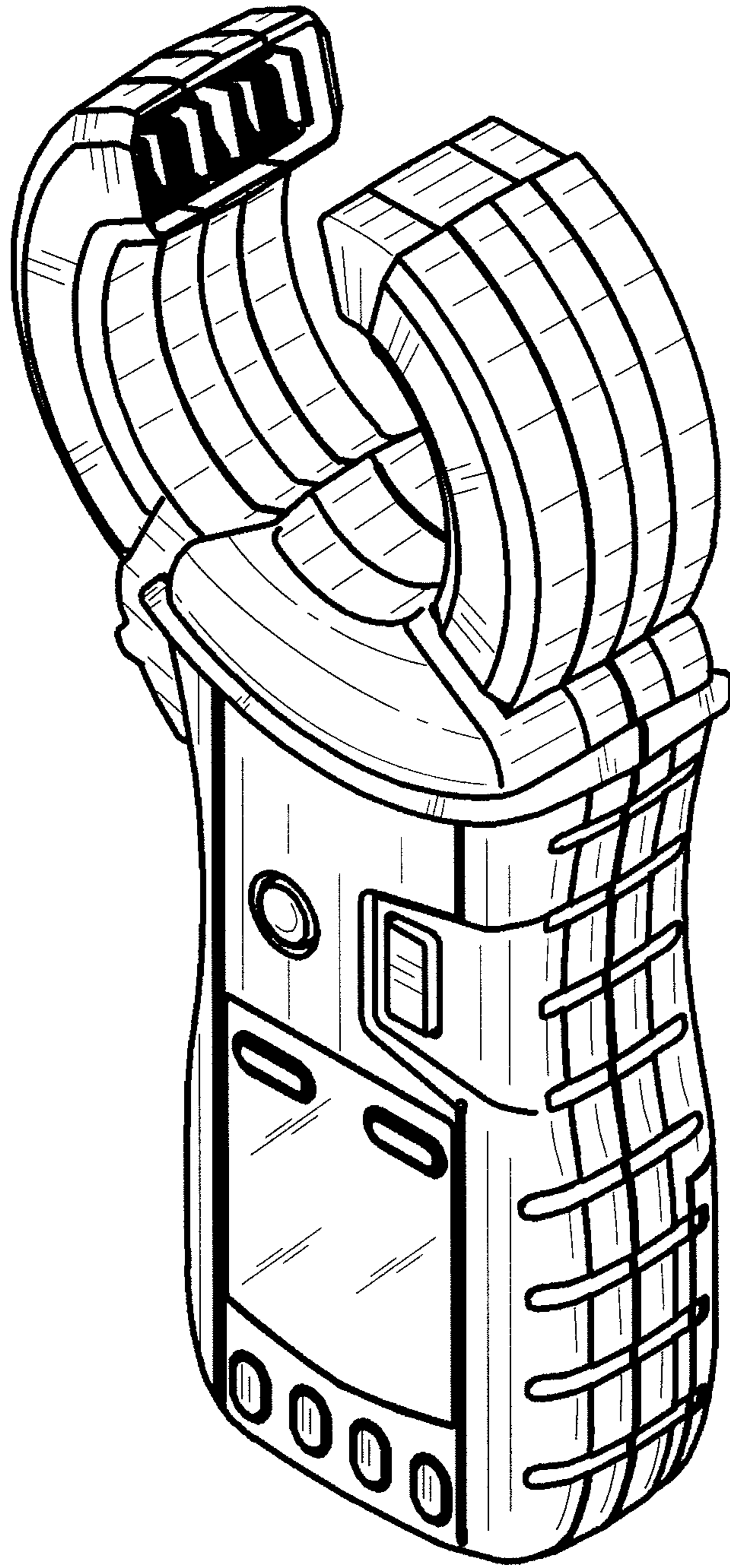
