(57) **CLAIM**

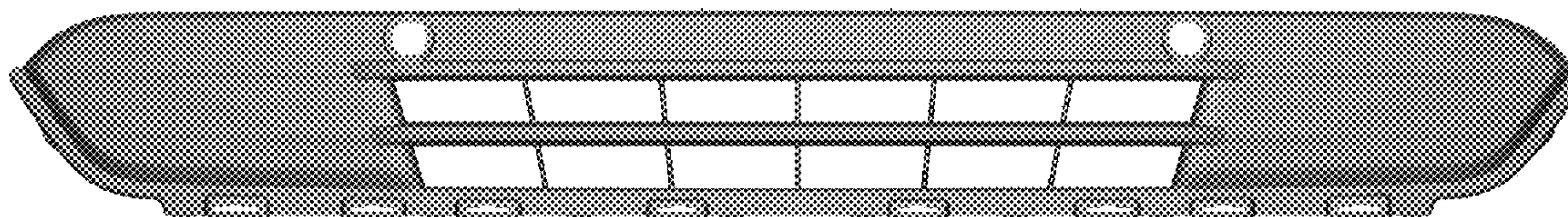
The ornamental design for a vehicle front lower grille, as shown and described.

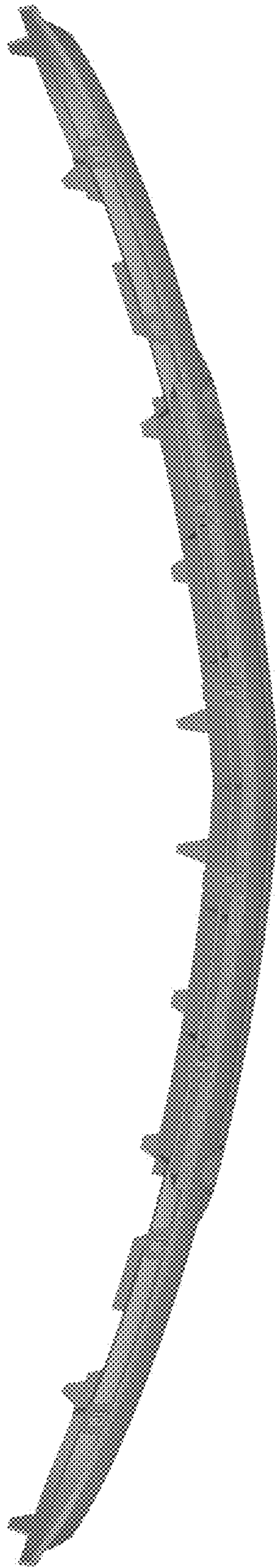

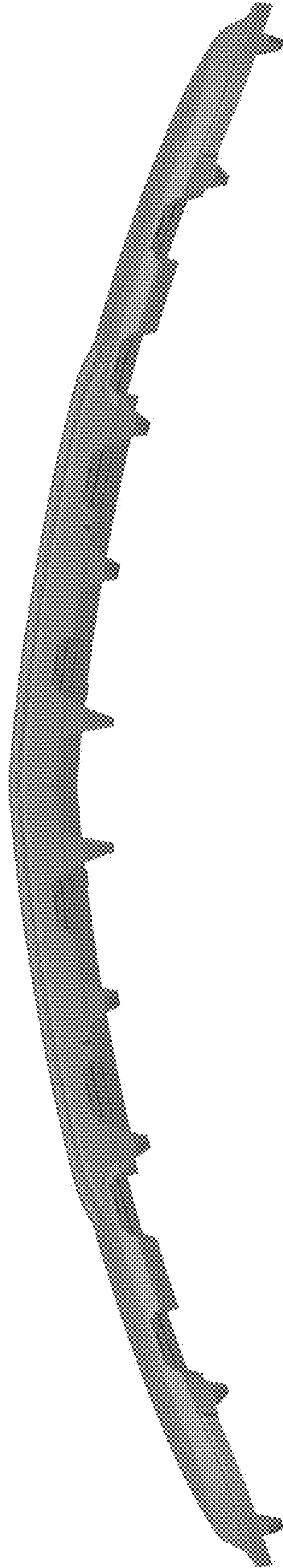

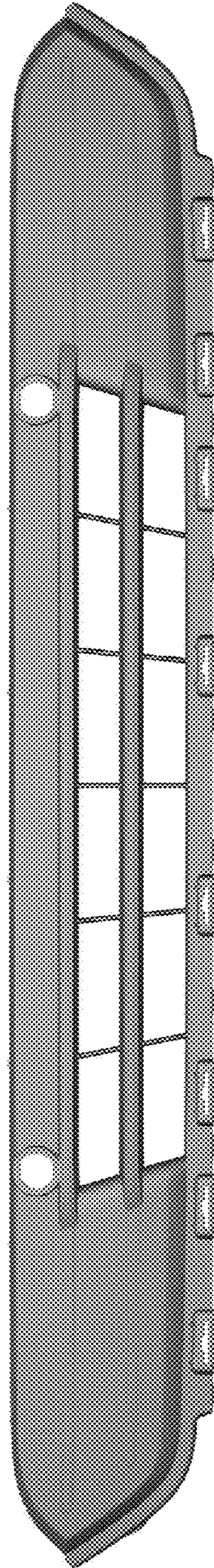

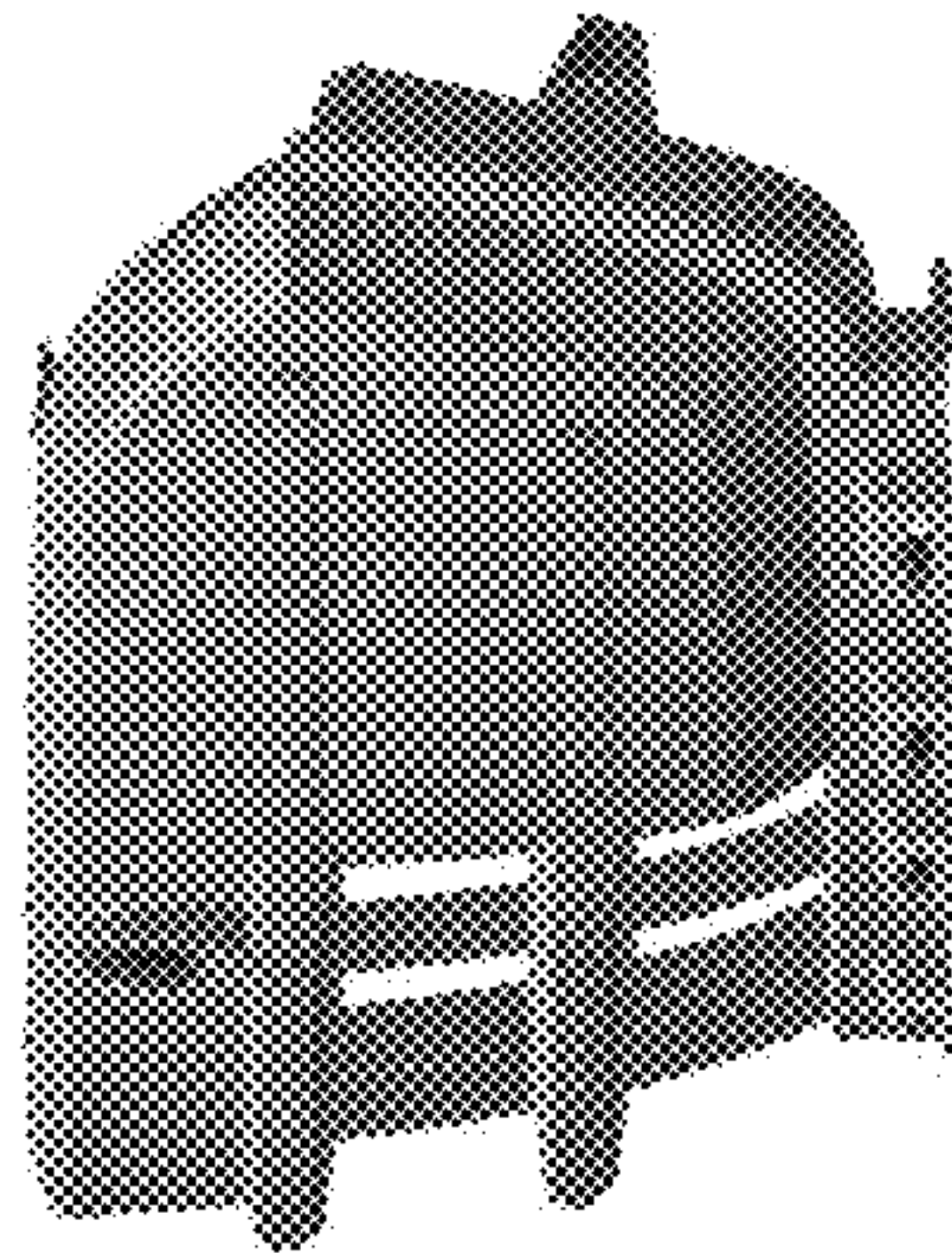

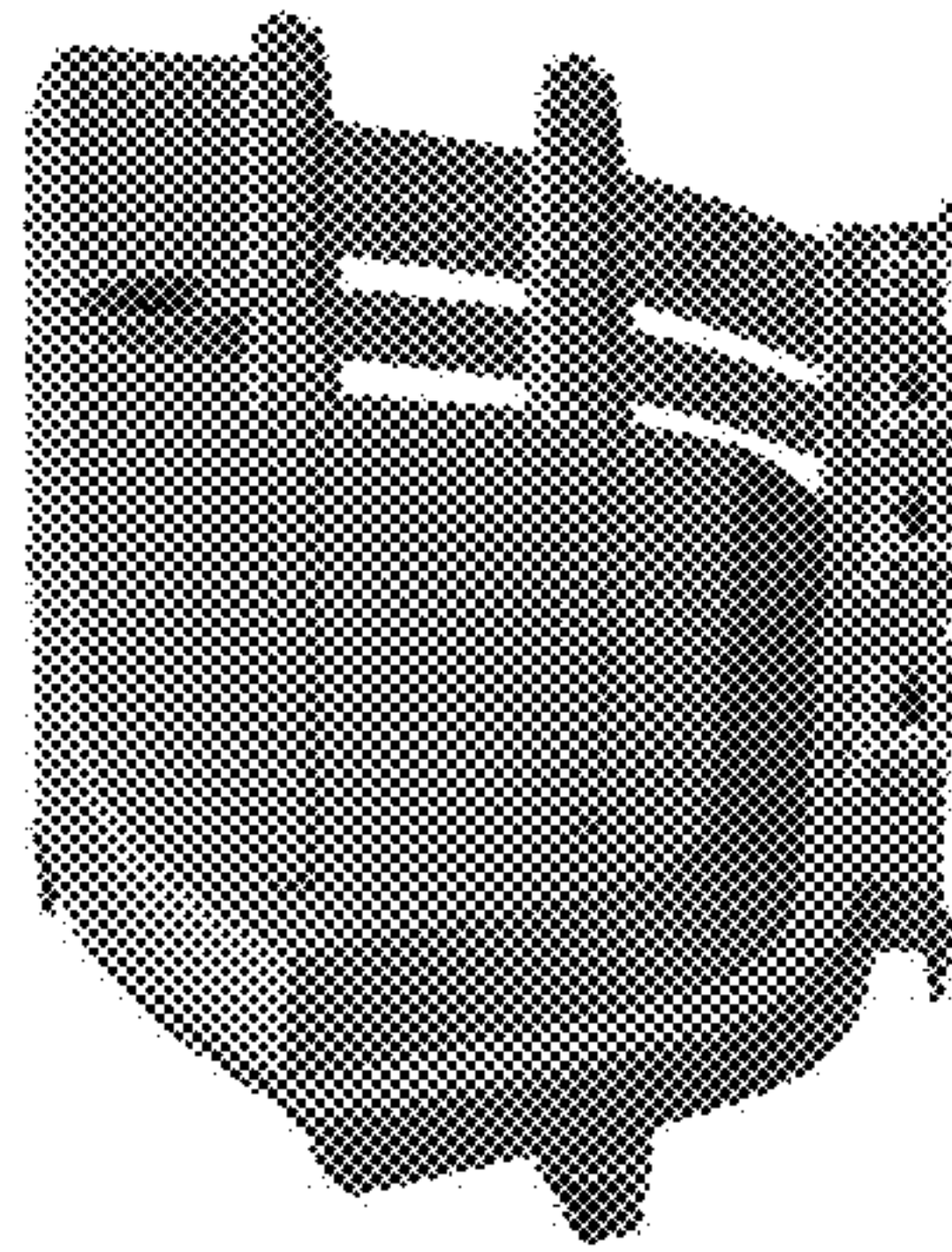

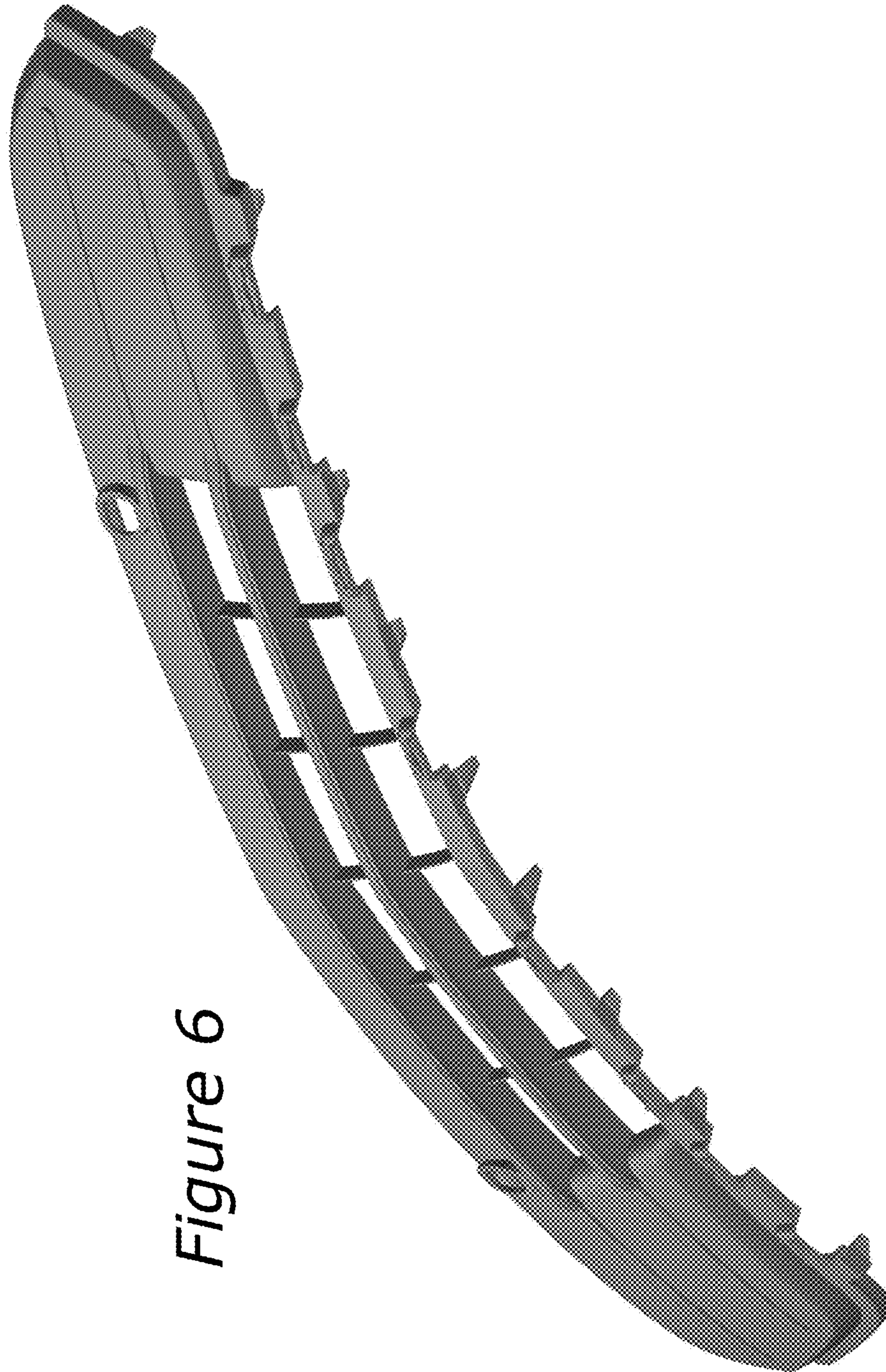
