 FIG. 30 is a front, top, right perspective view of a third embodiment computer showing my new design;

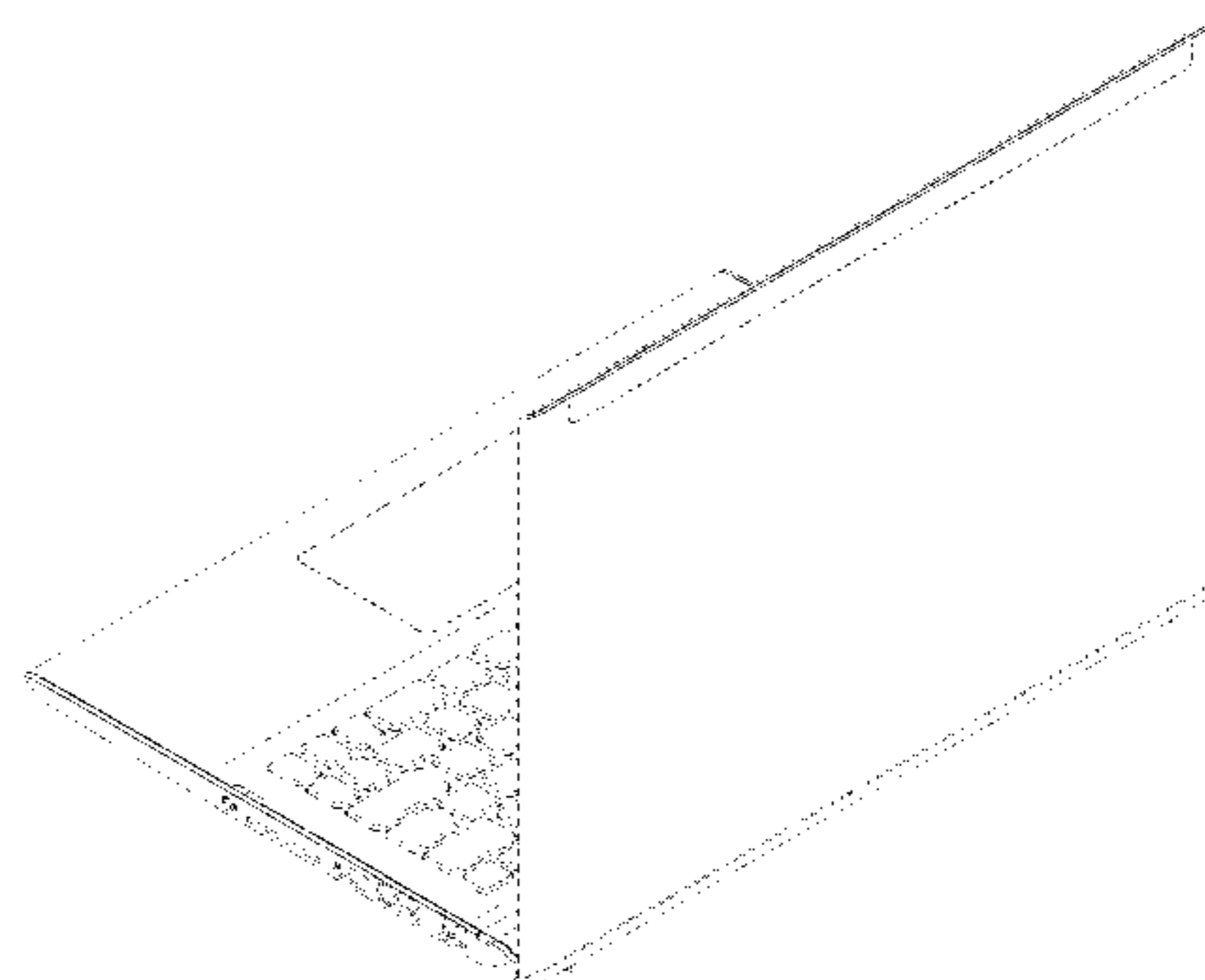
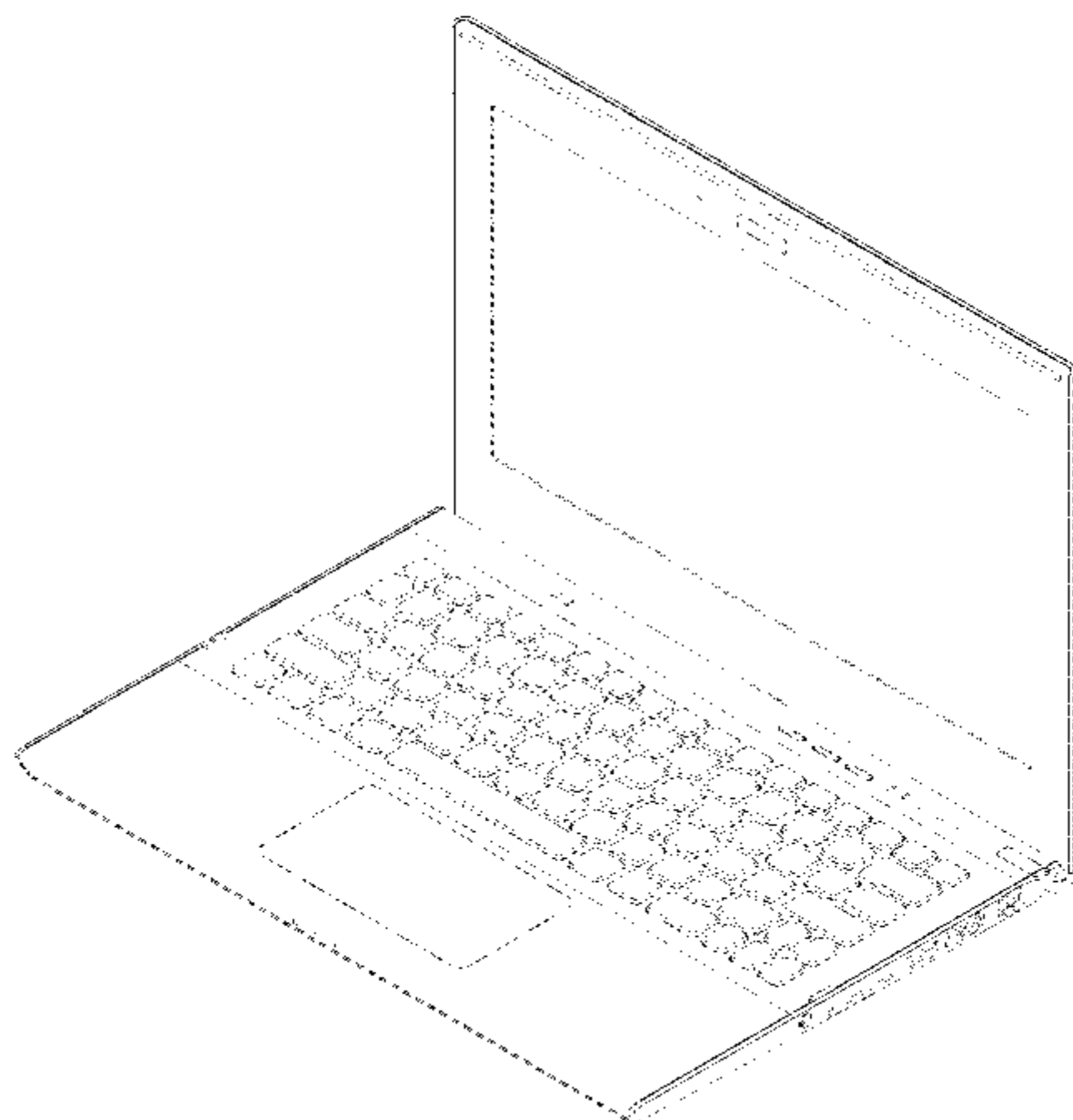


FIG. 31 is a rear, top, right perspective view thereof;

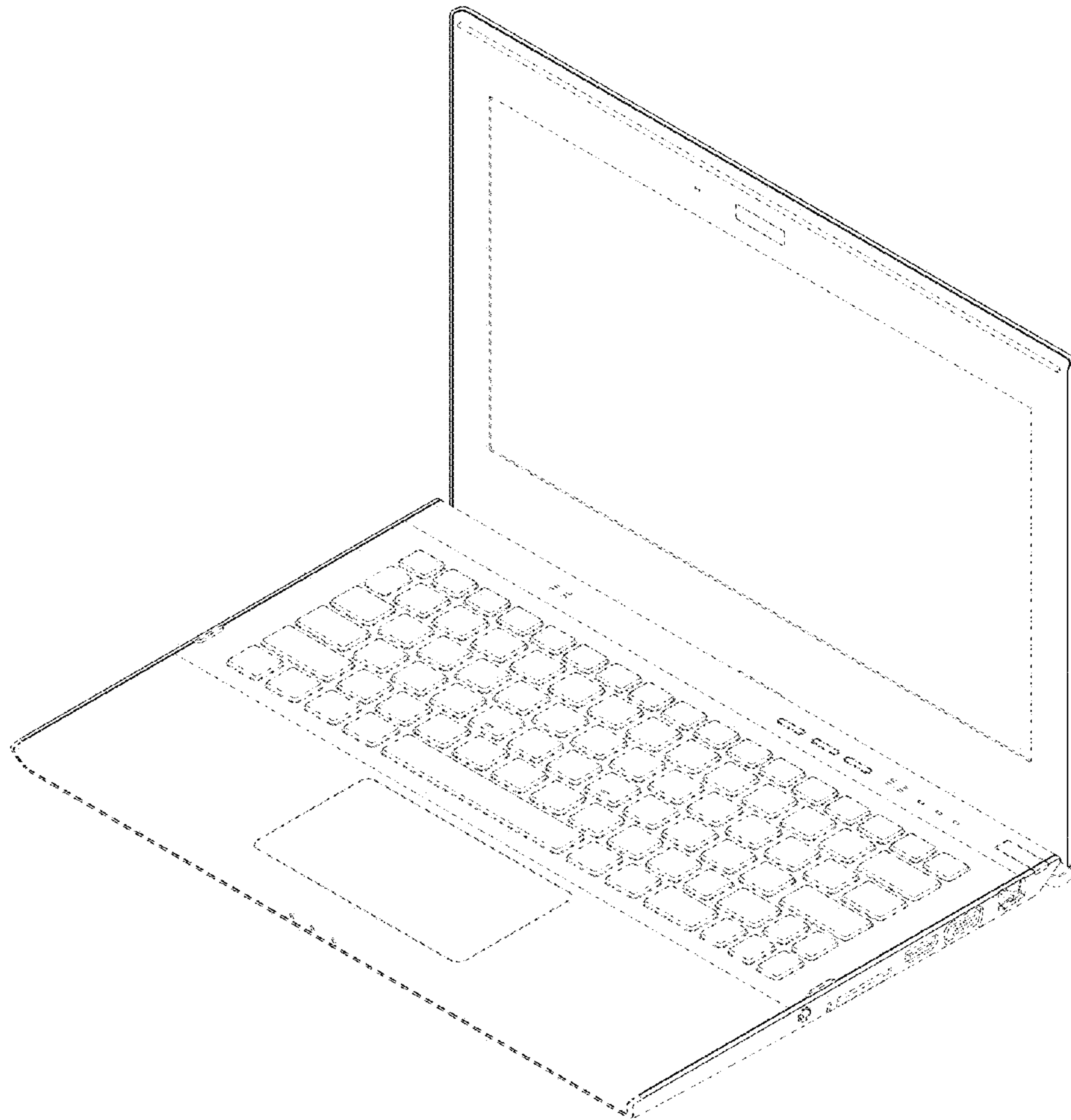

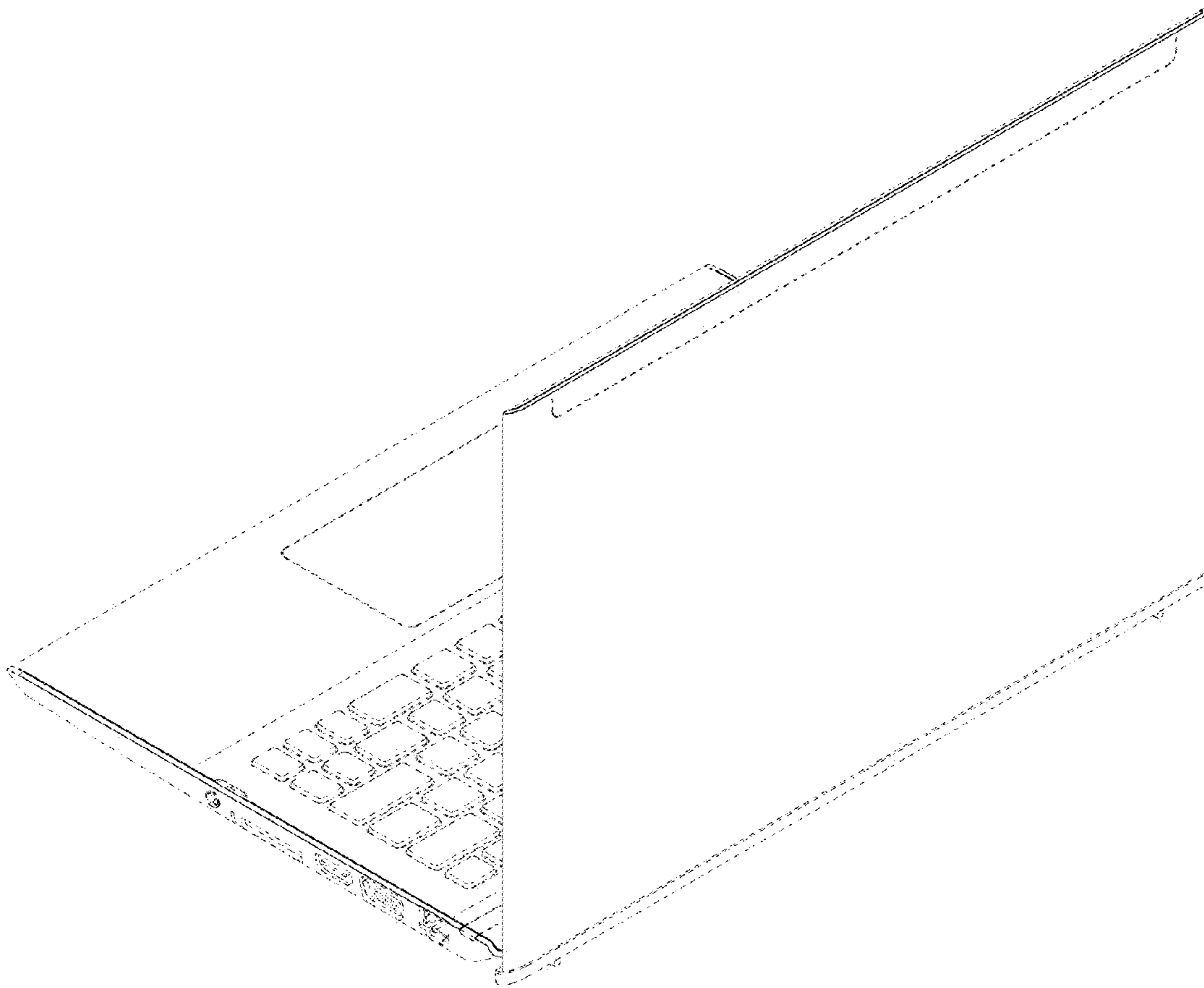

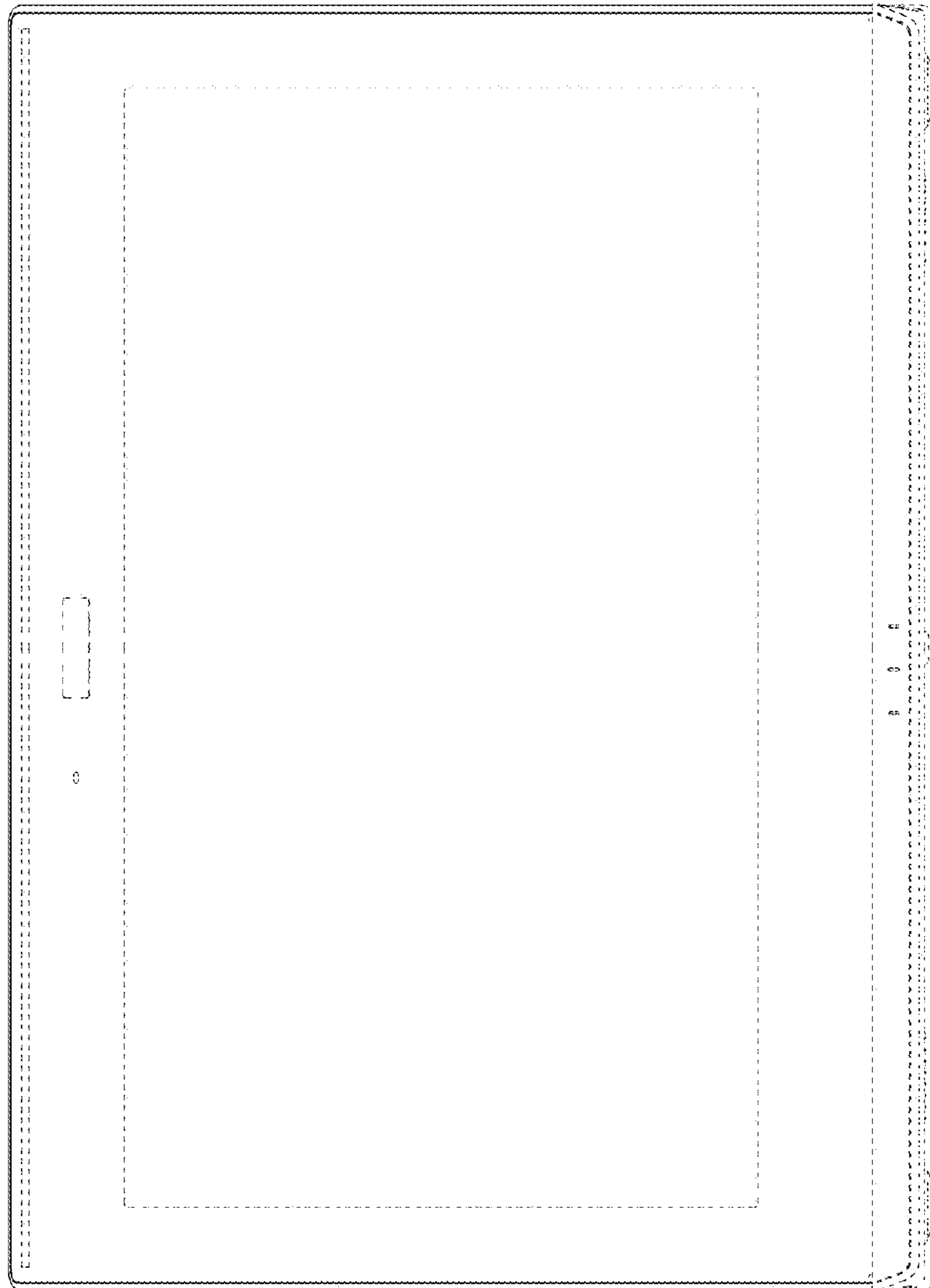

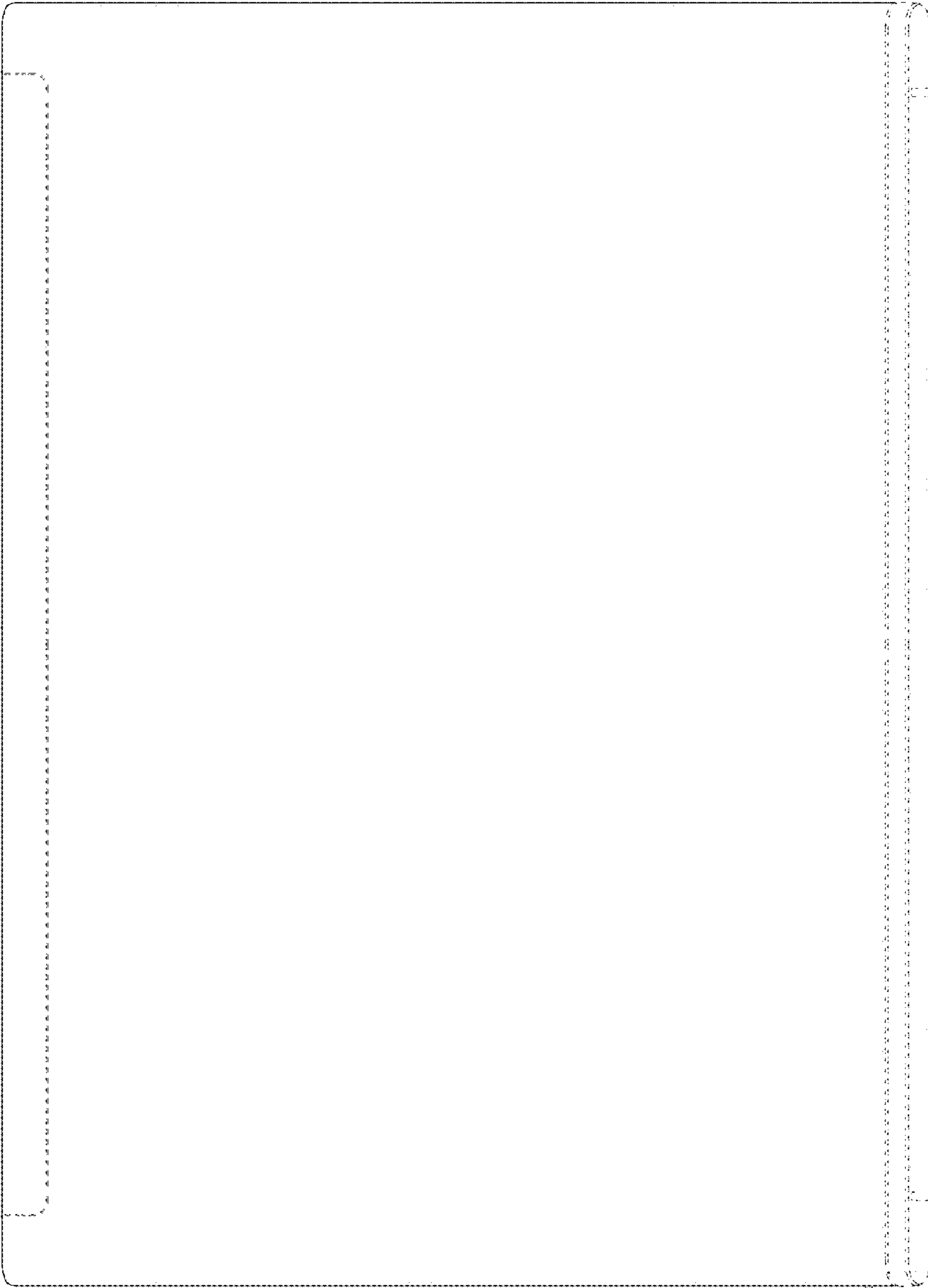

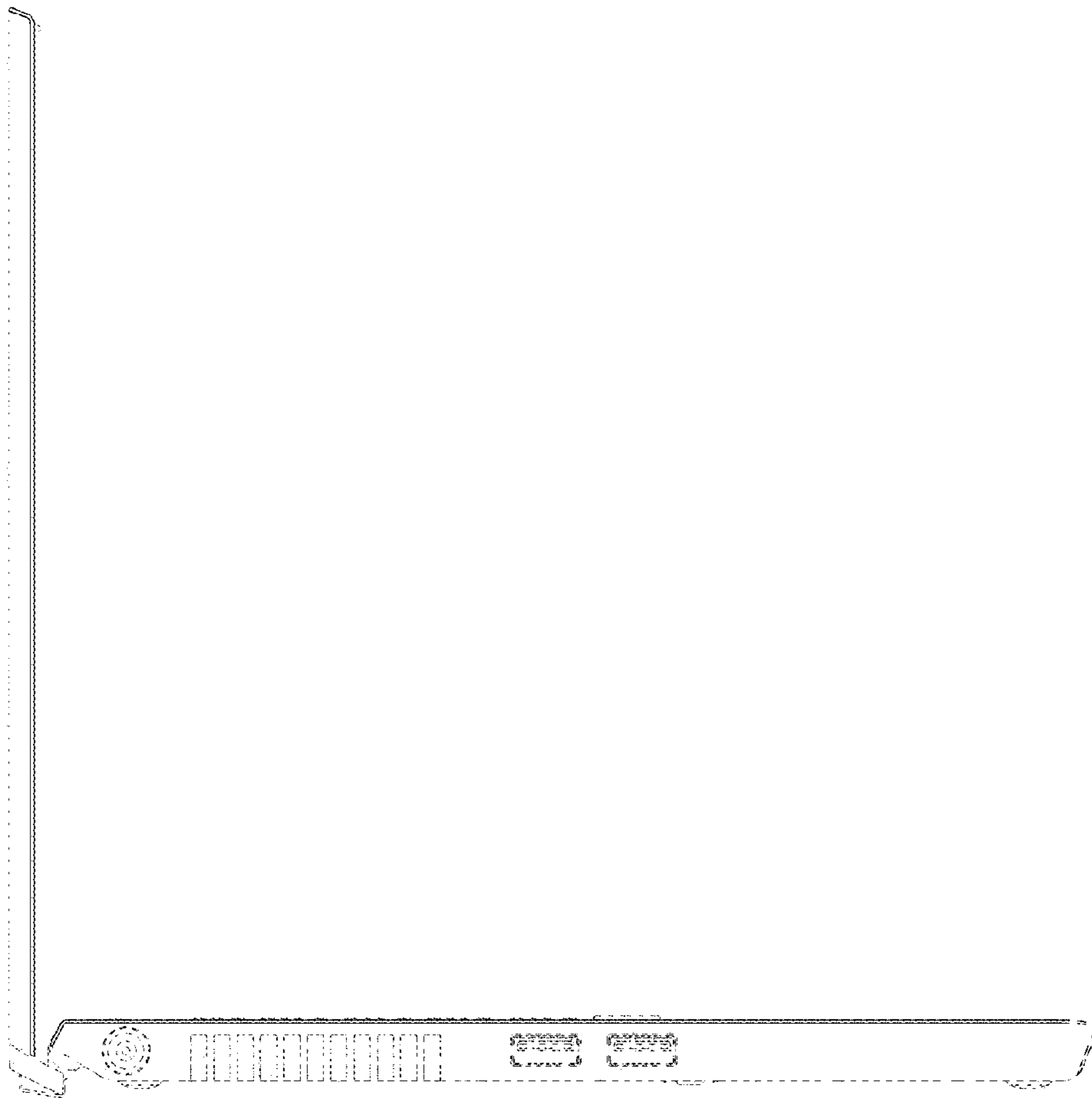

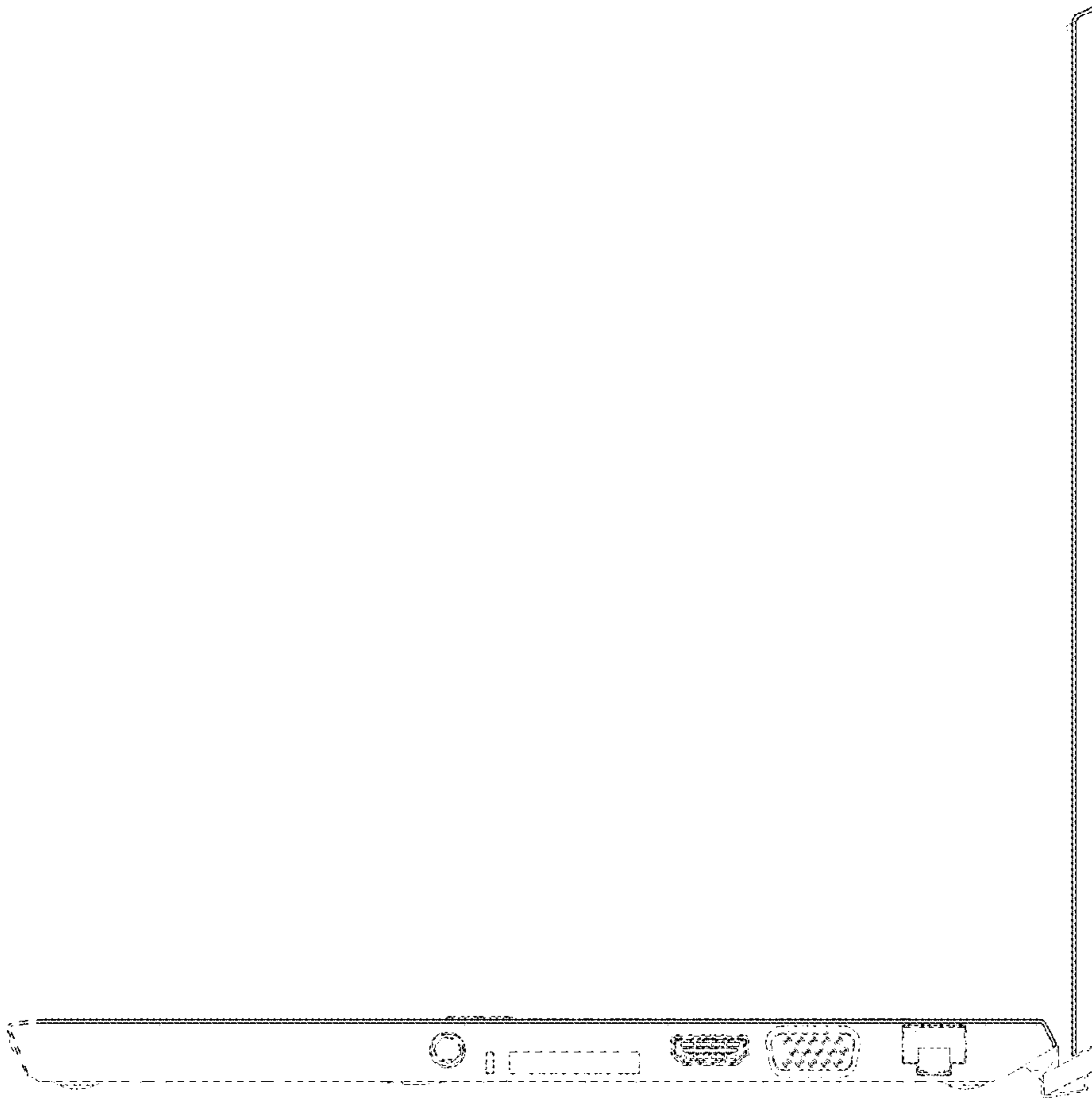

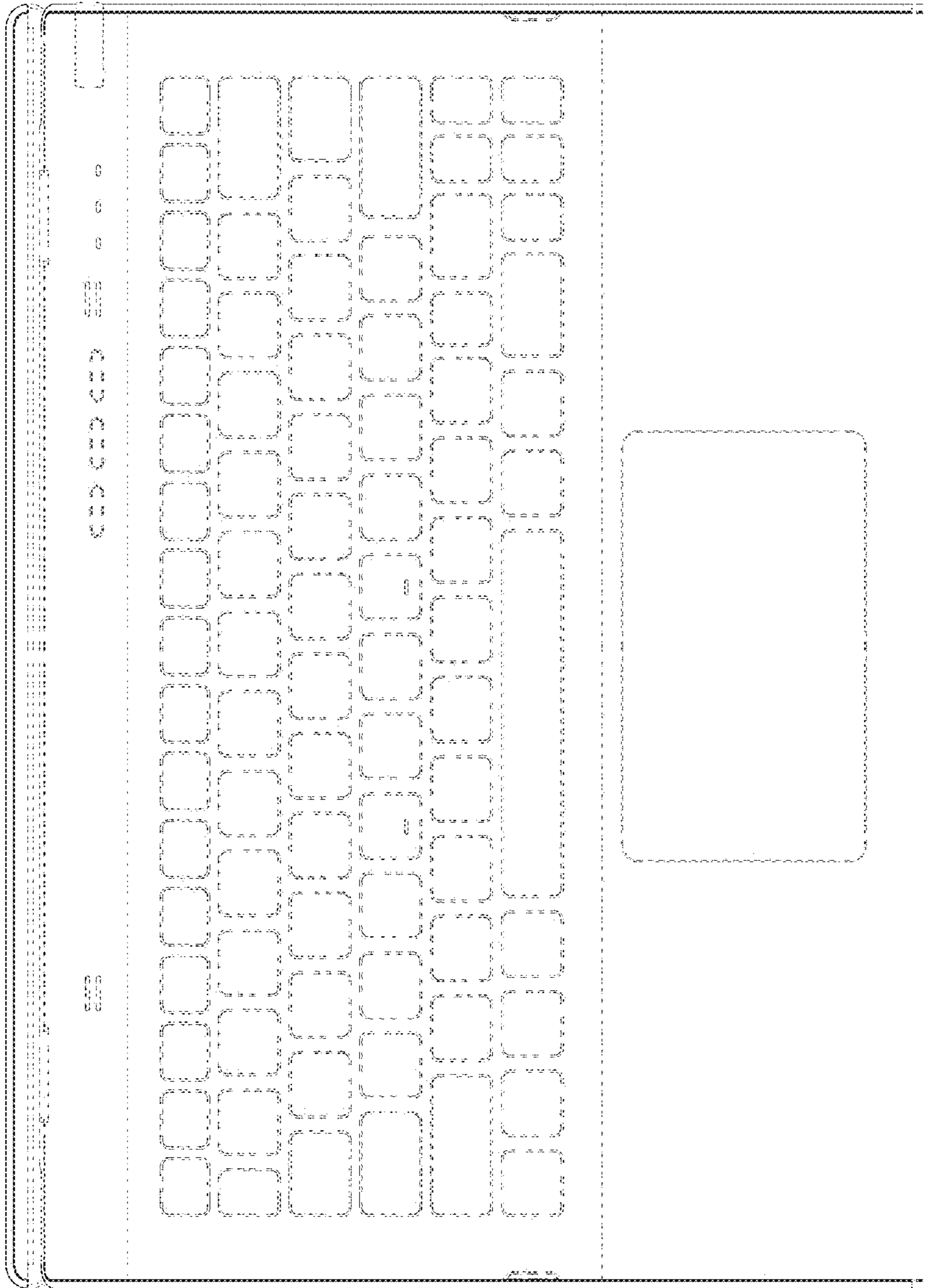

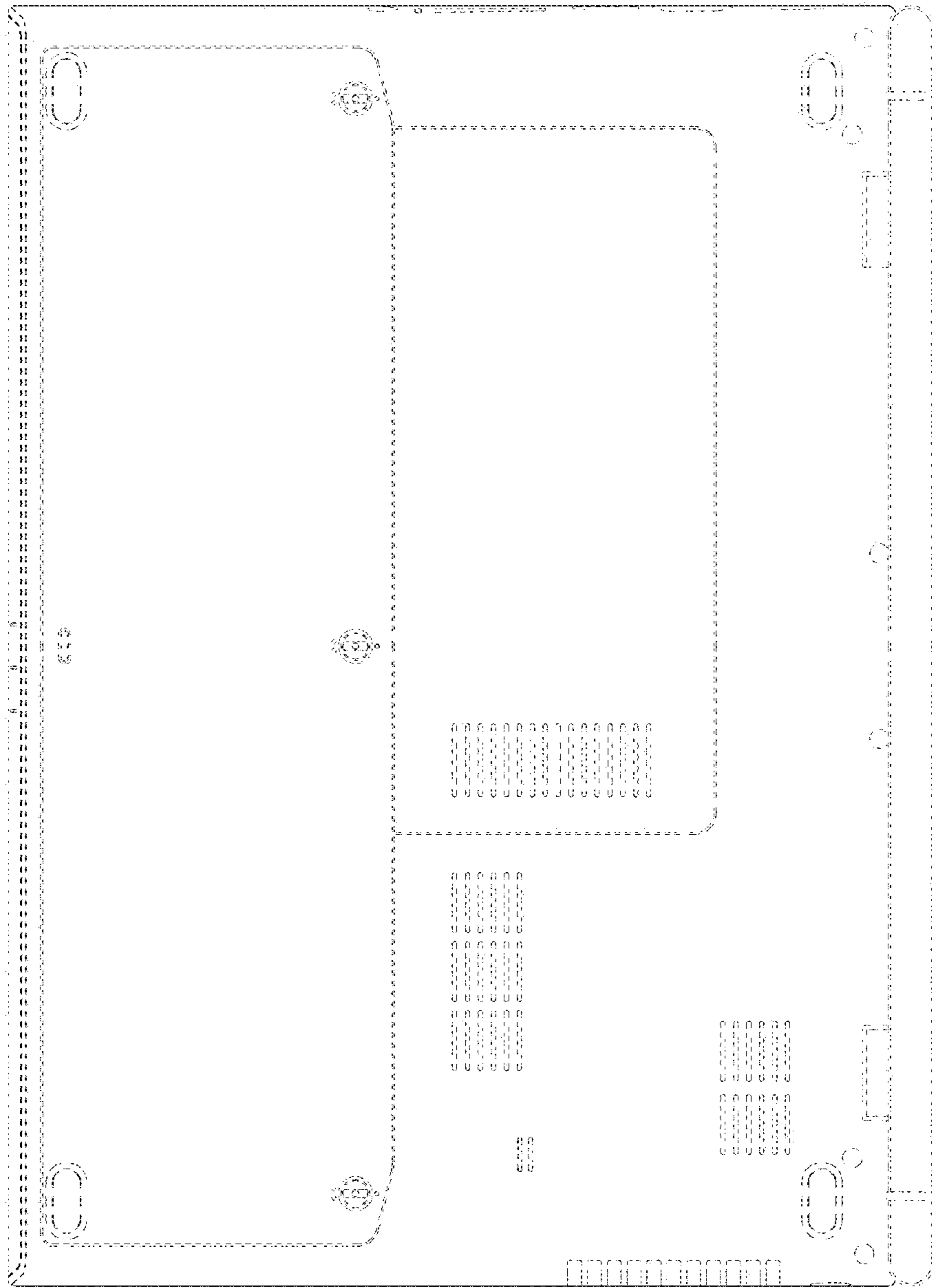

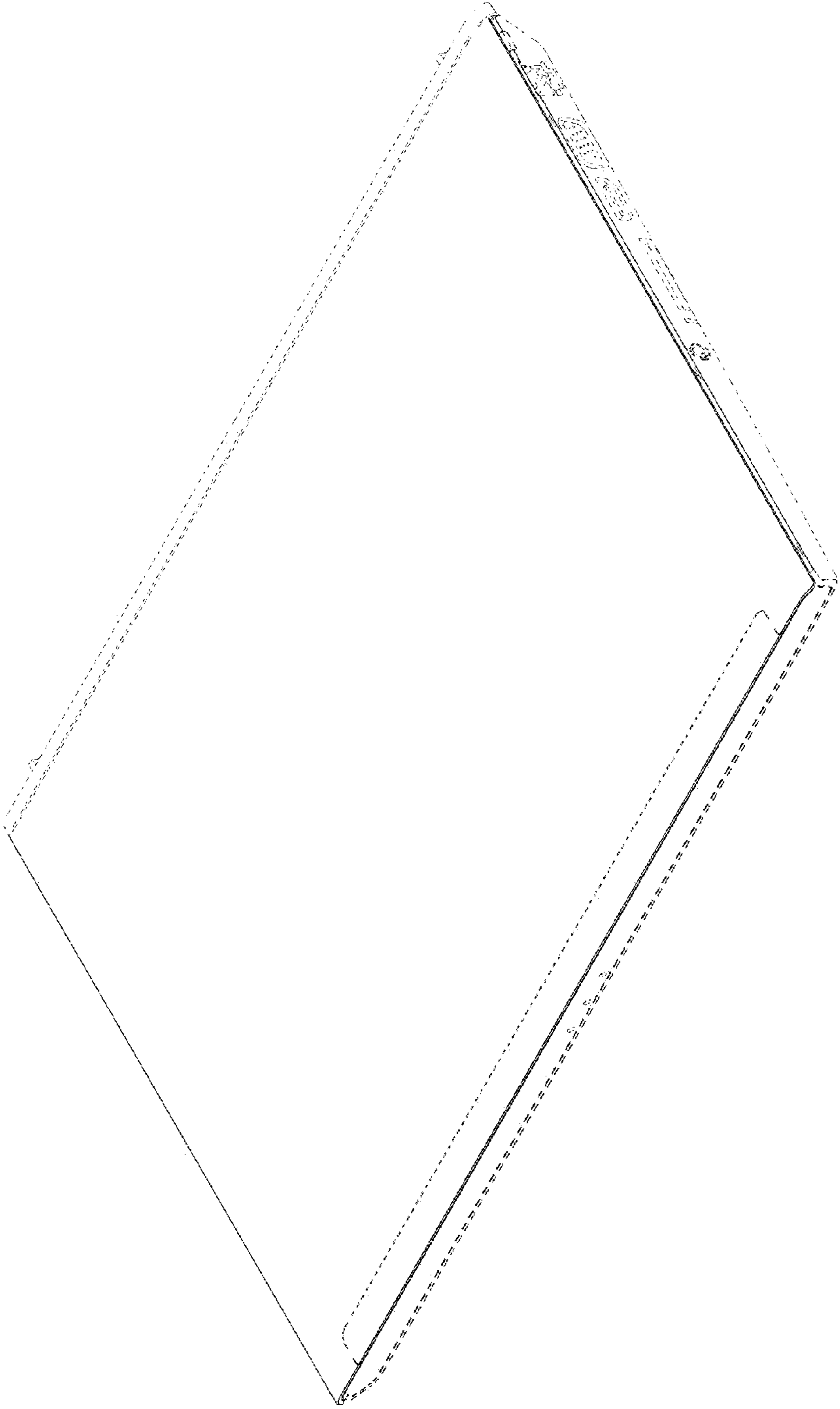

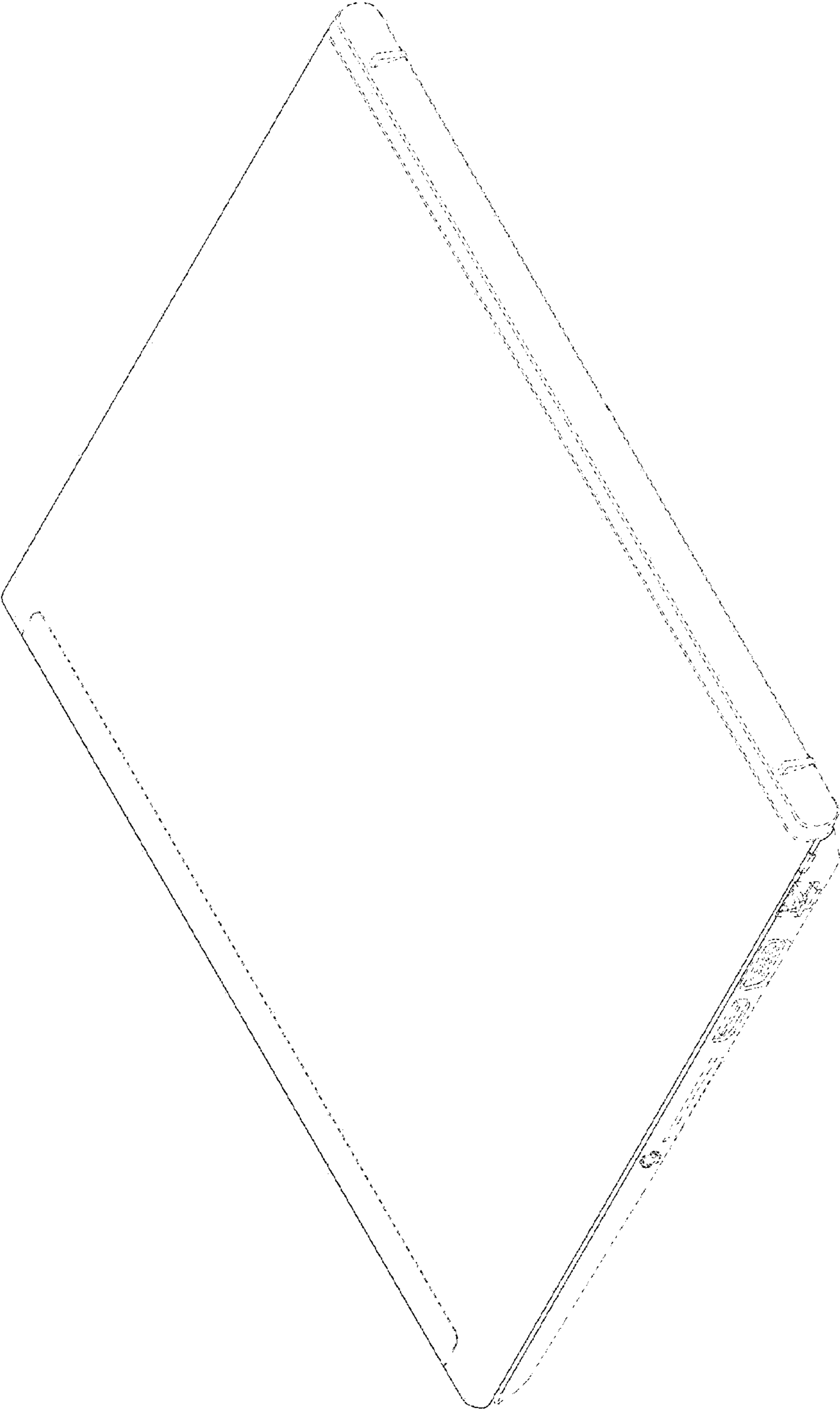

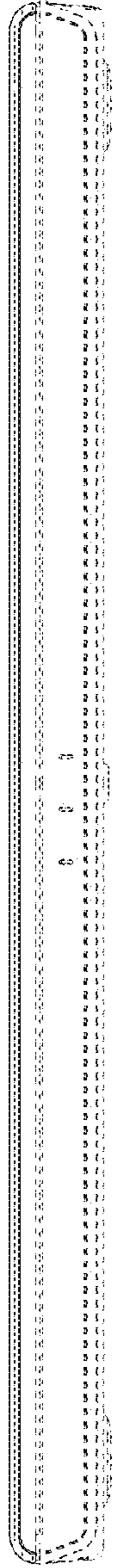

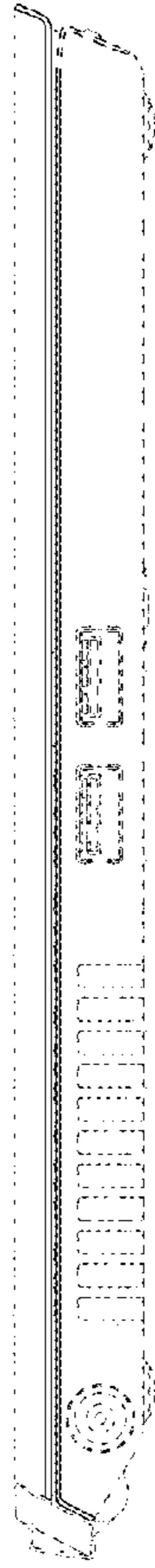

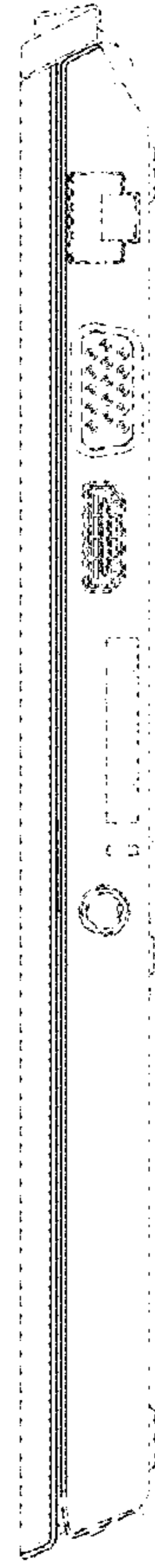

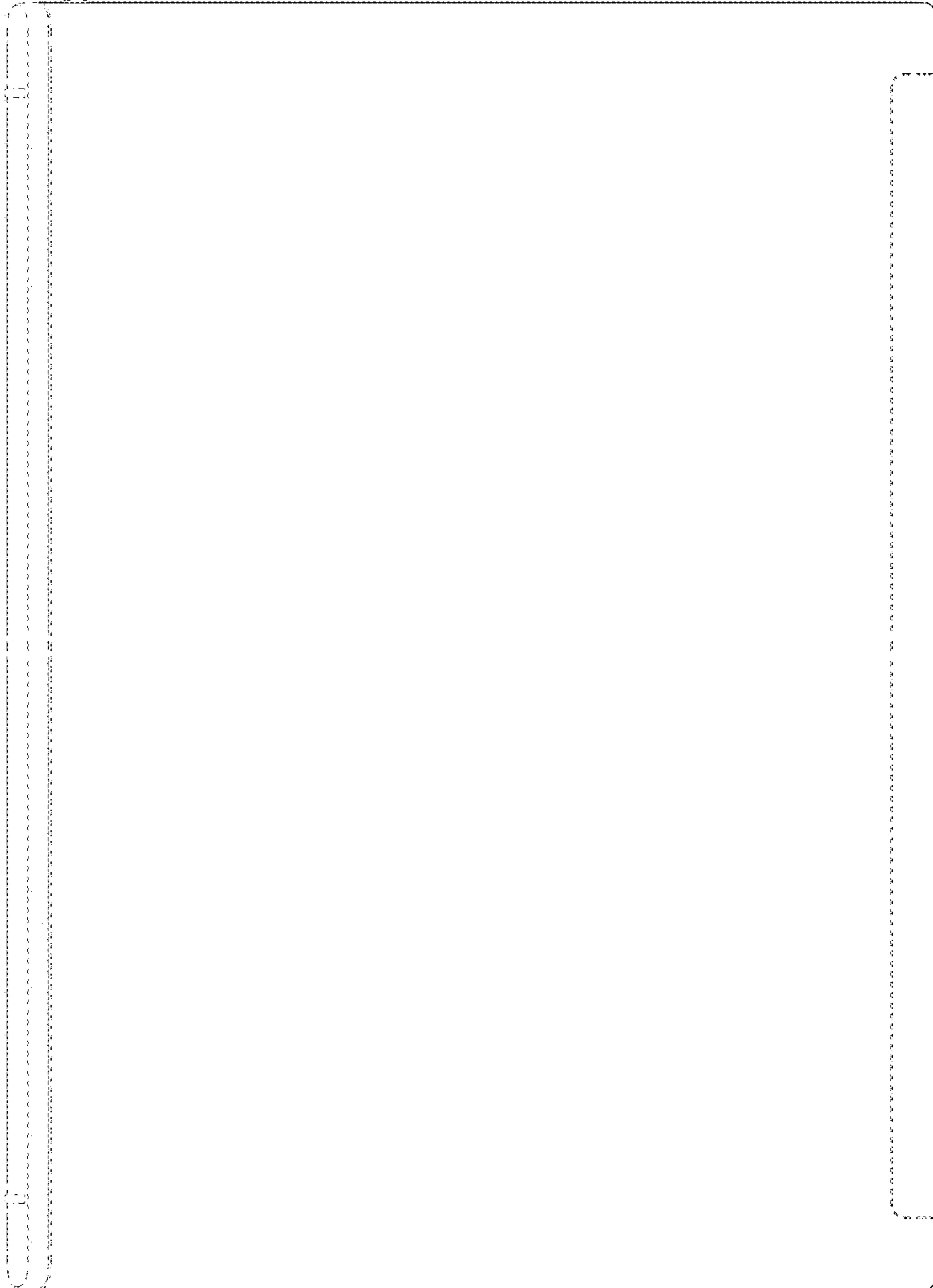

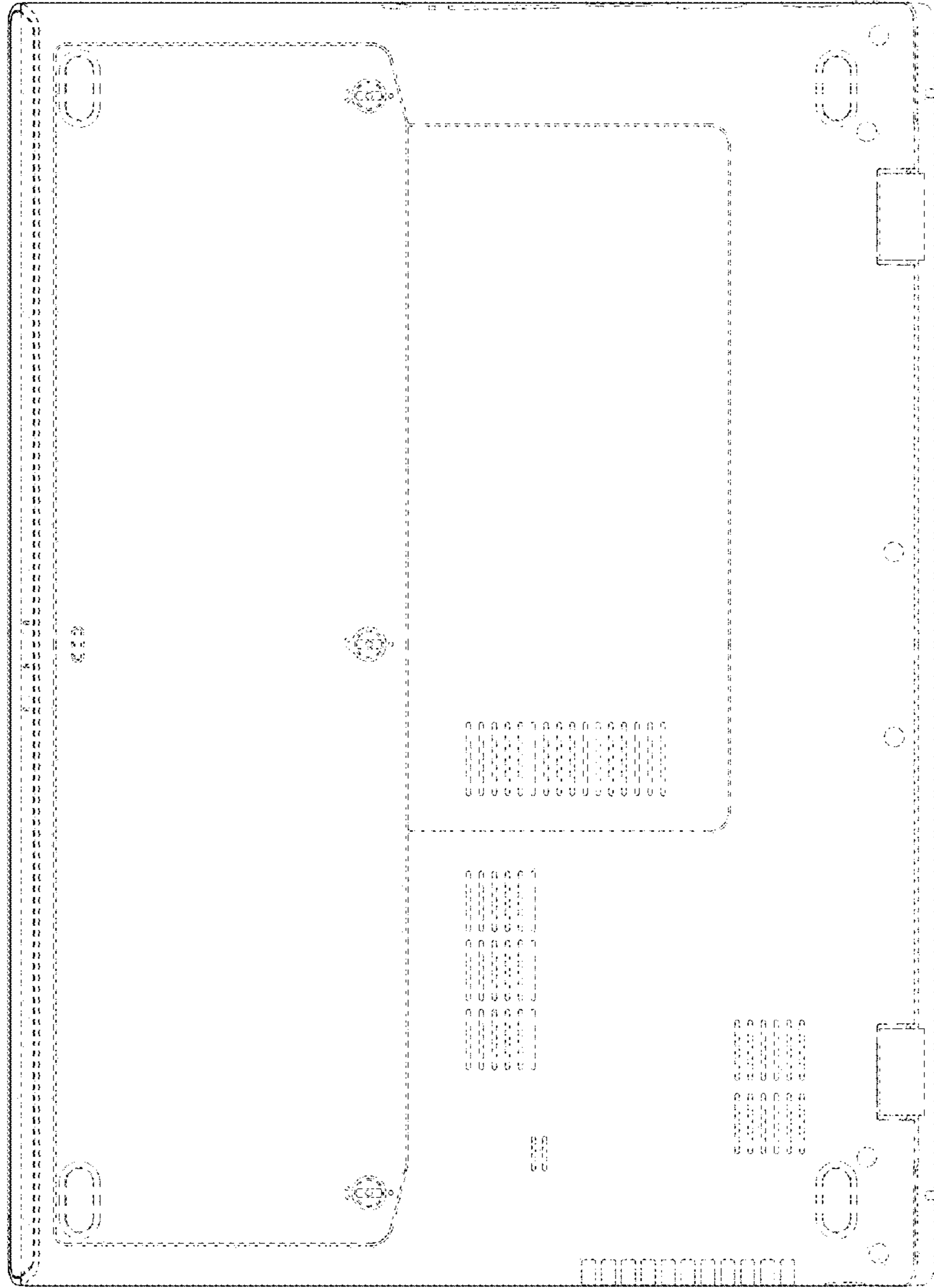

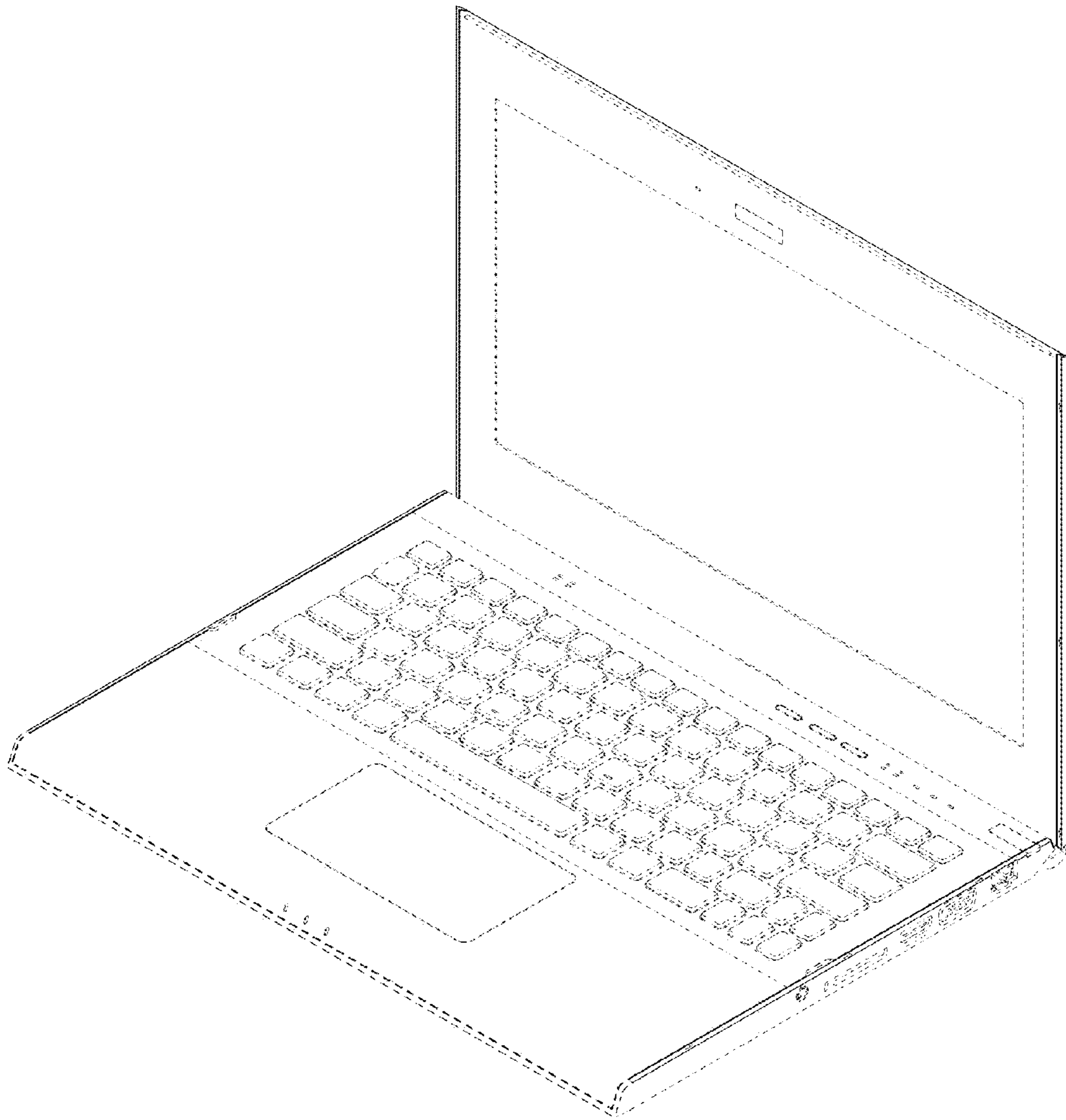

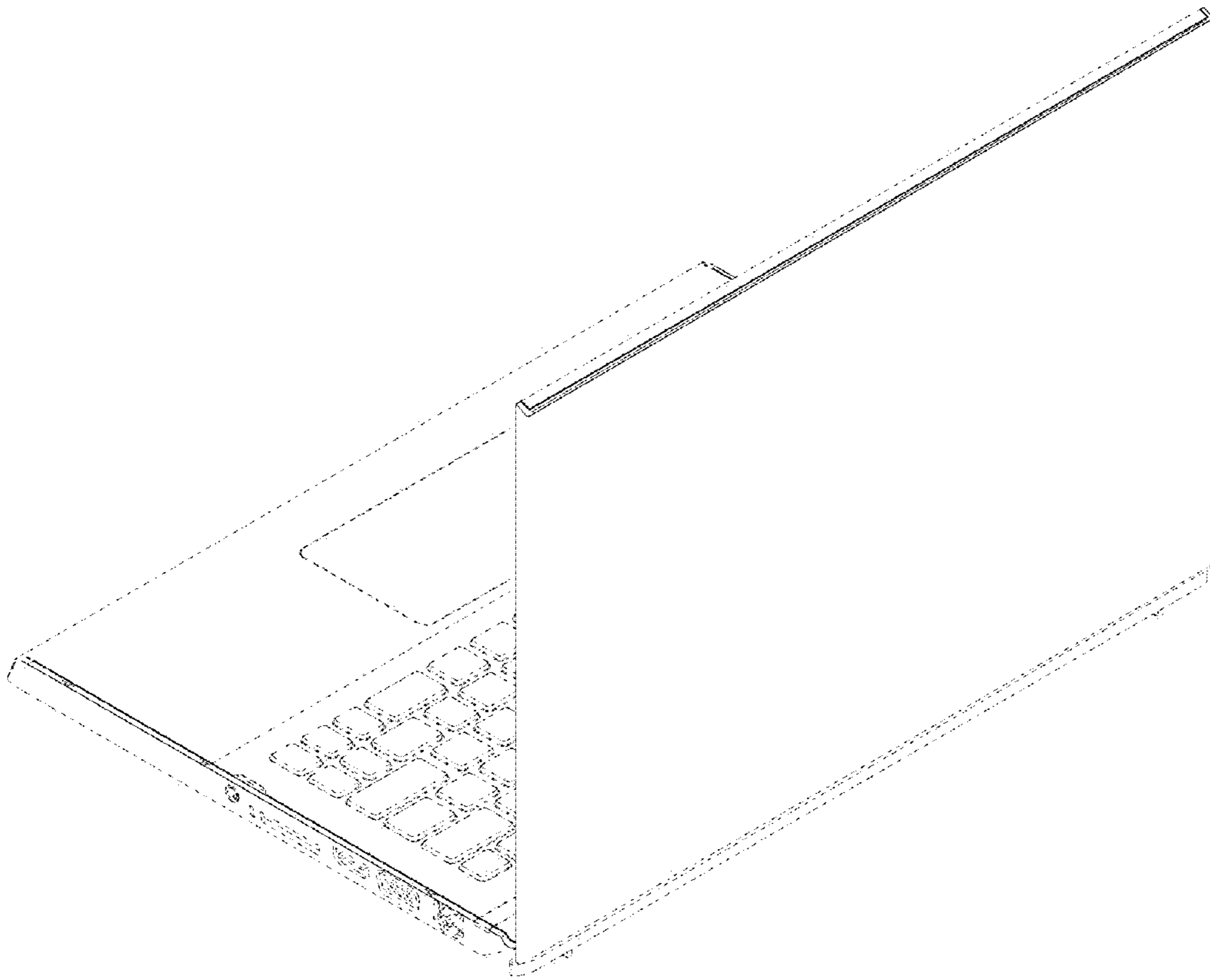

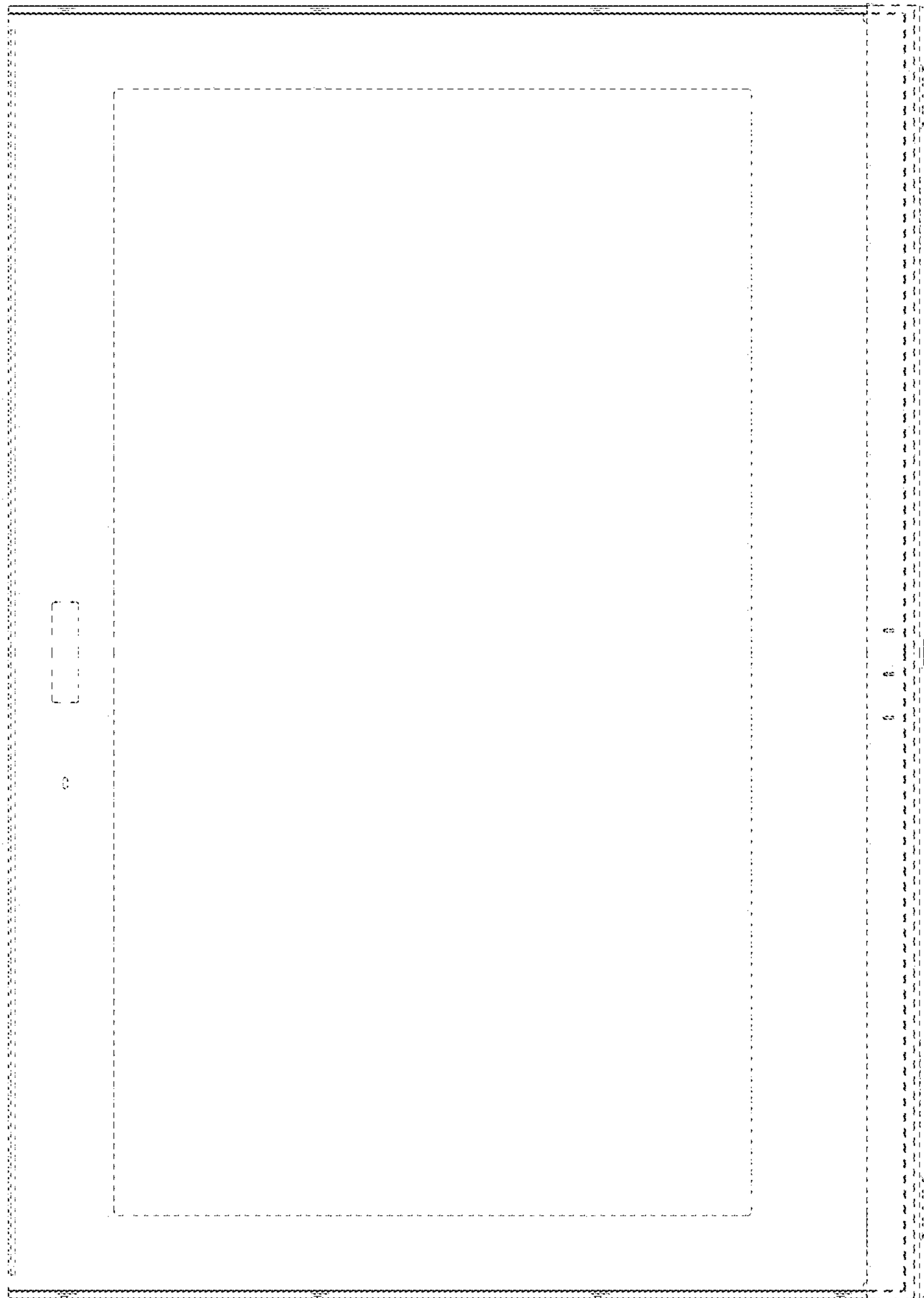

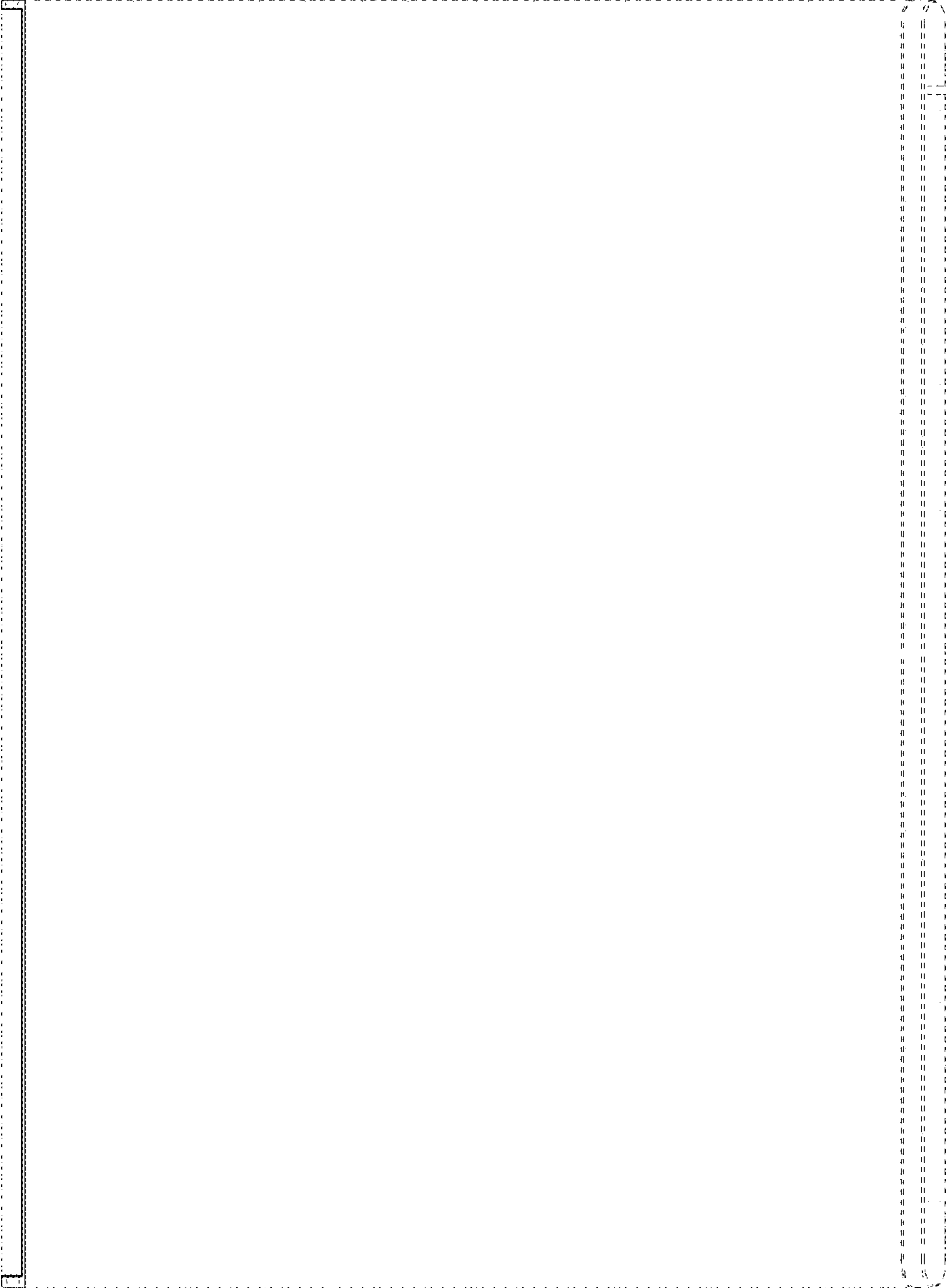

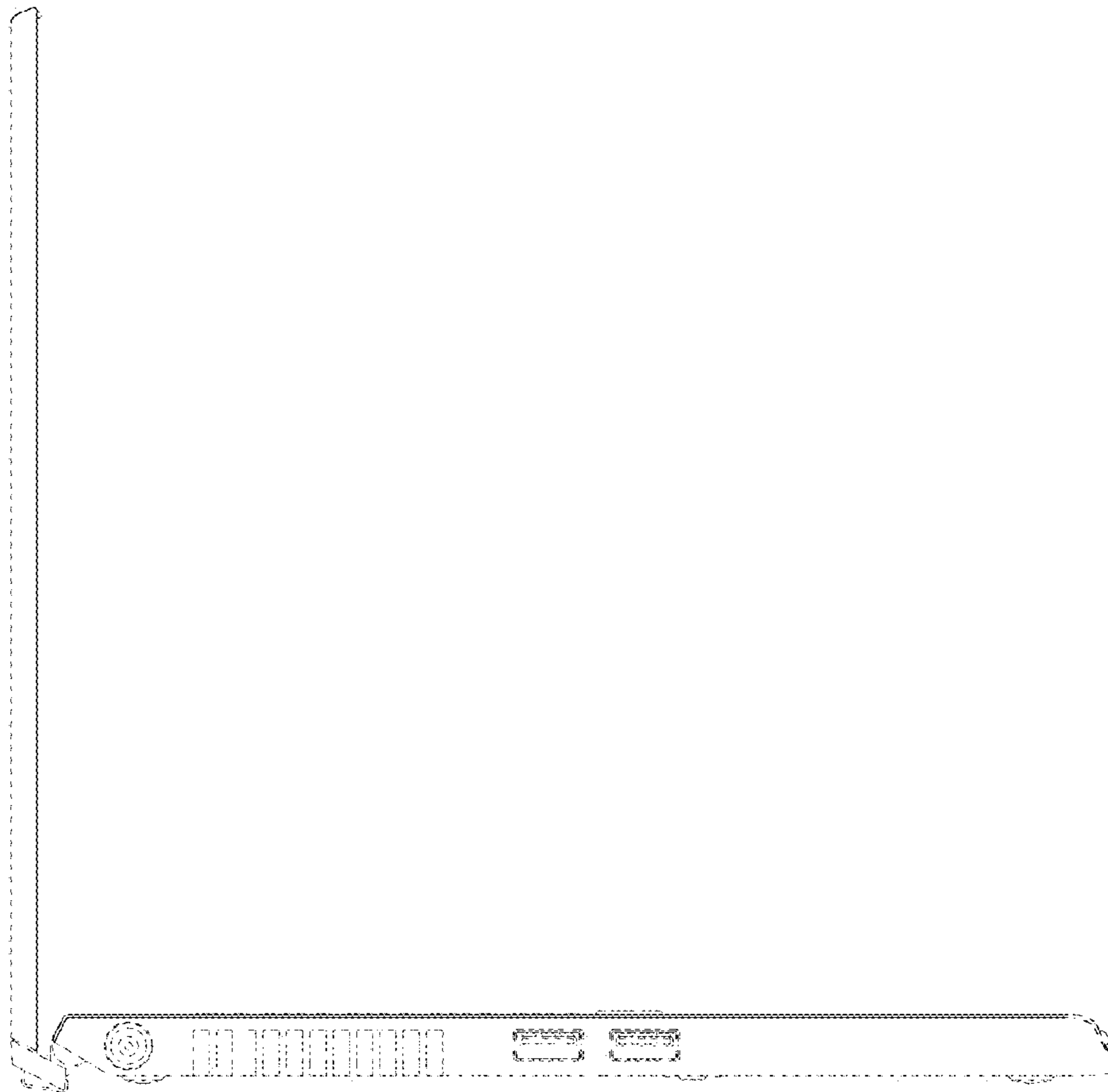

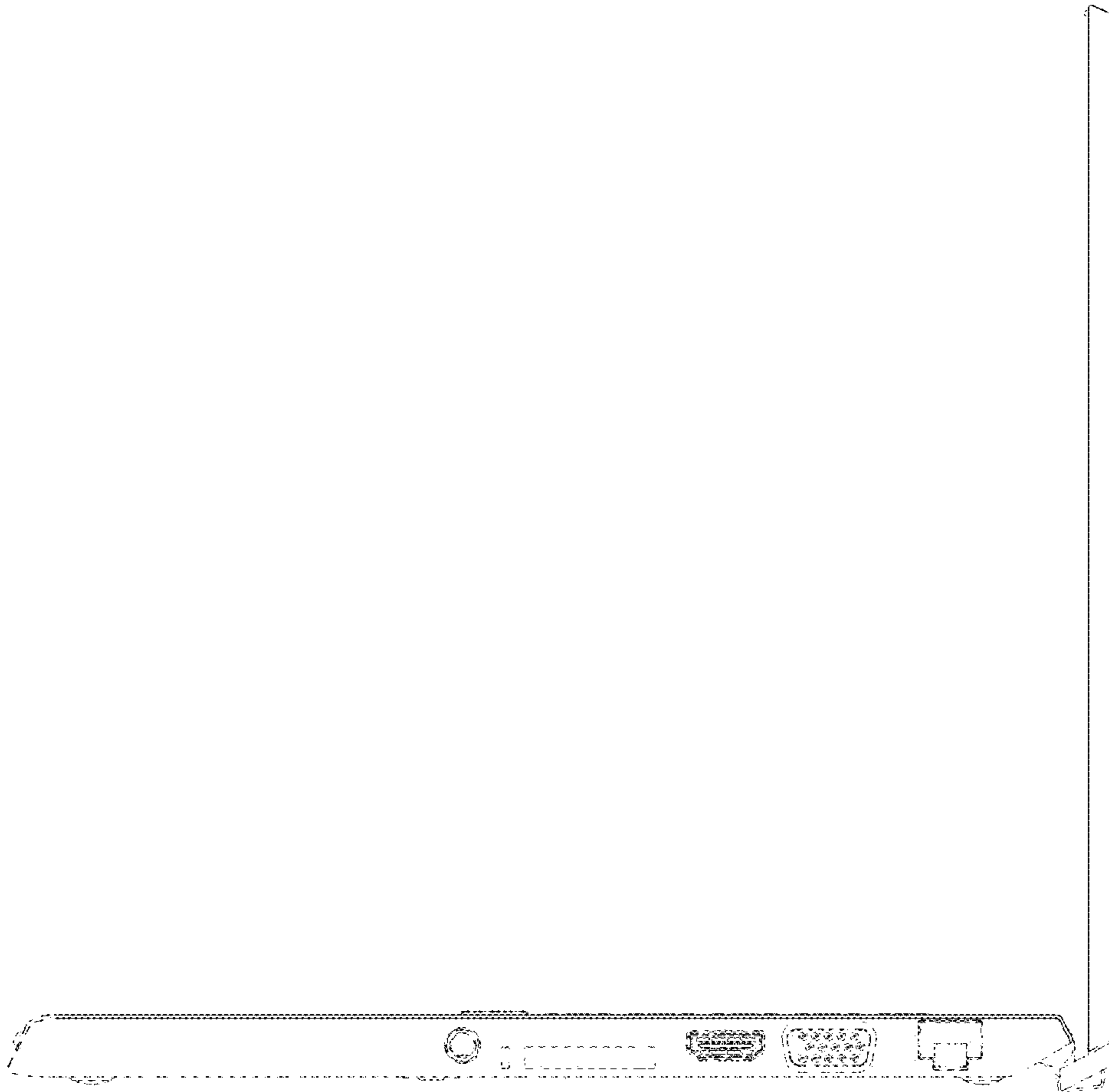

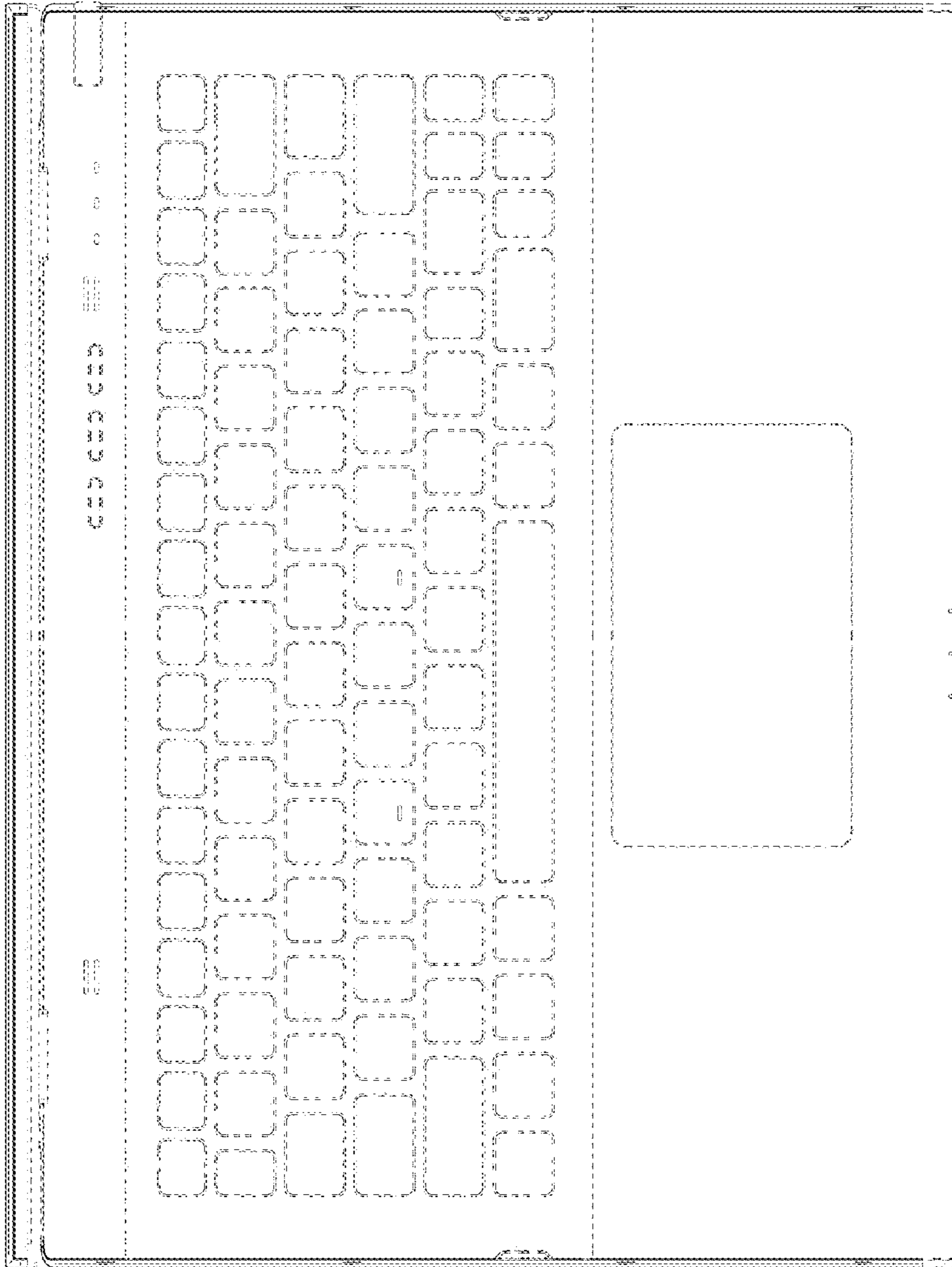

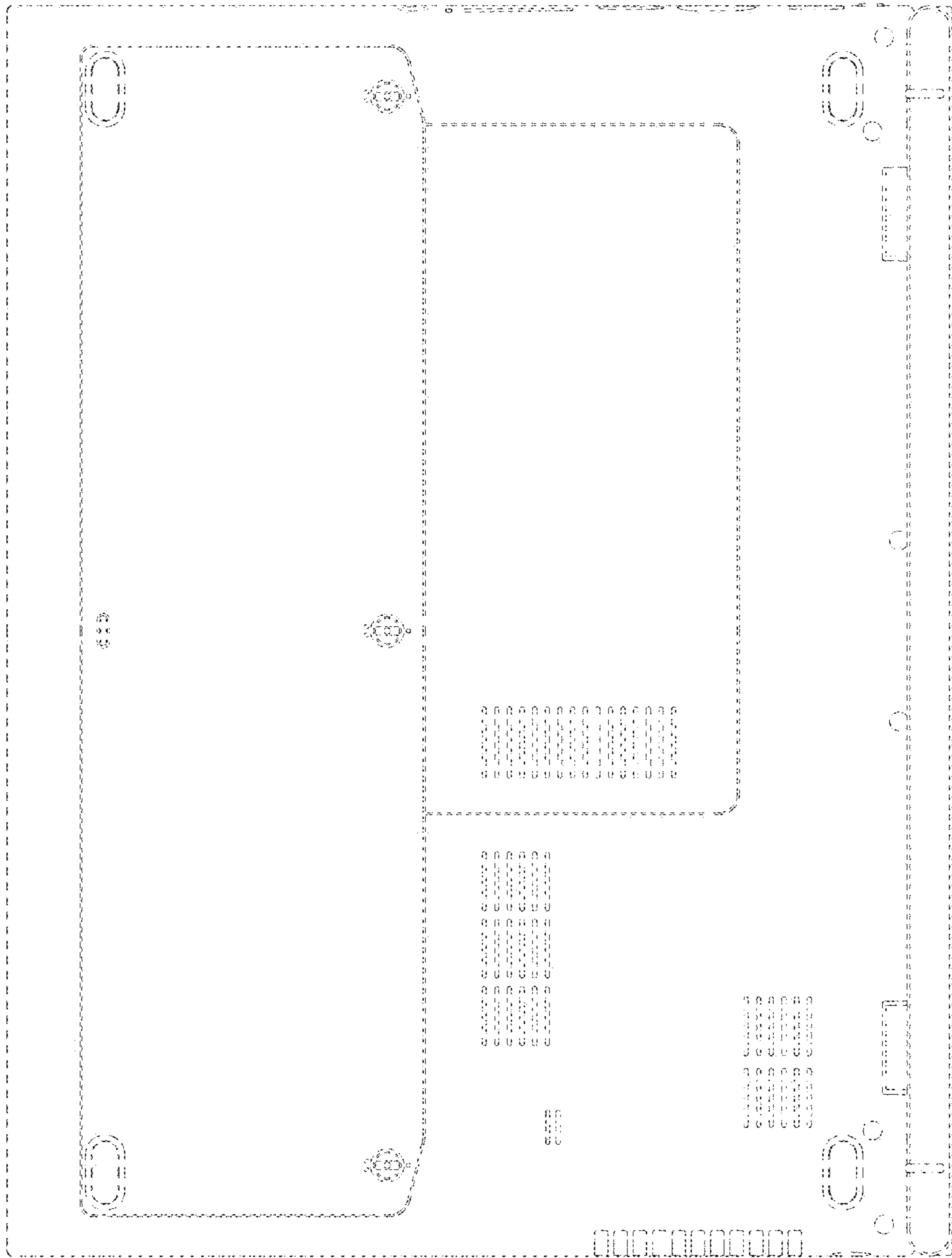

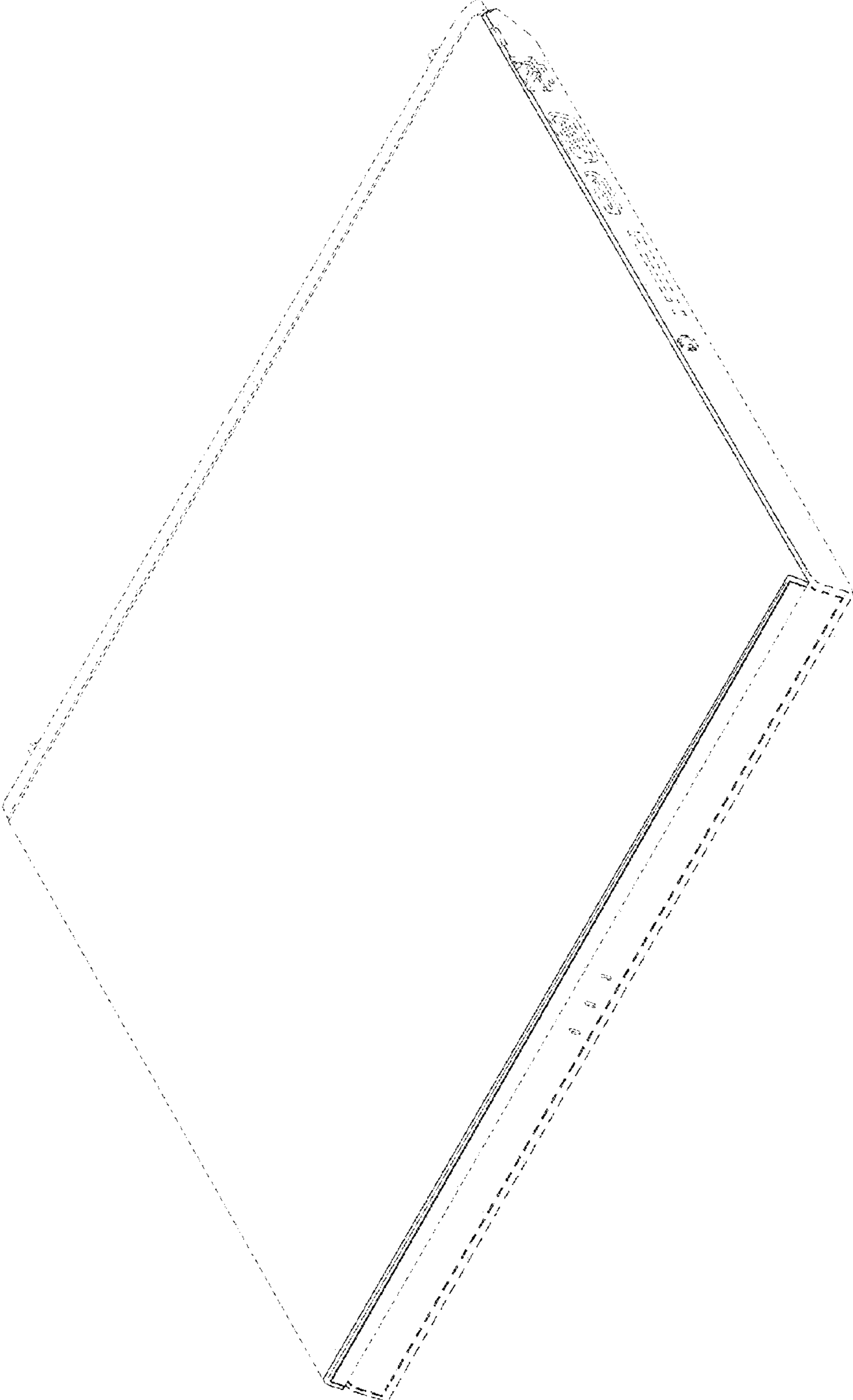

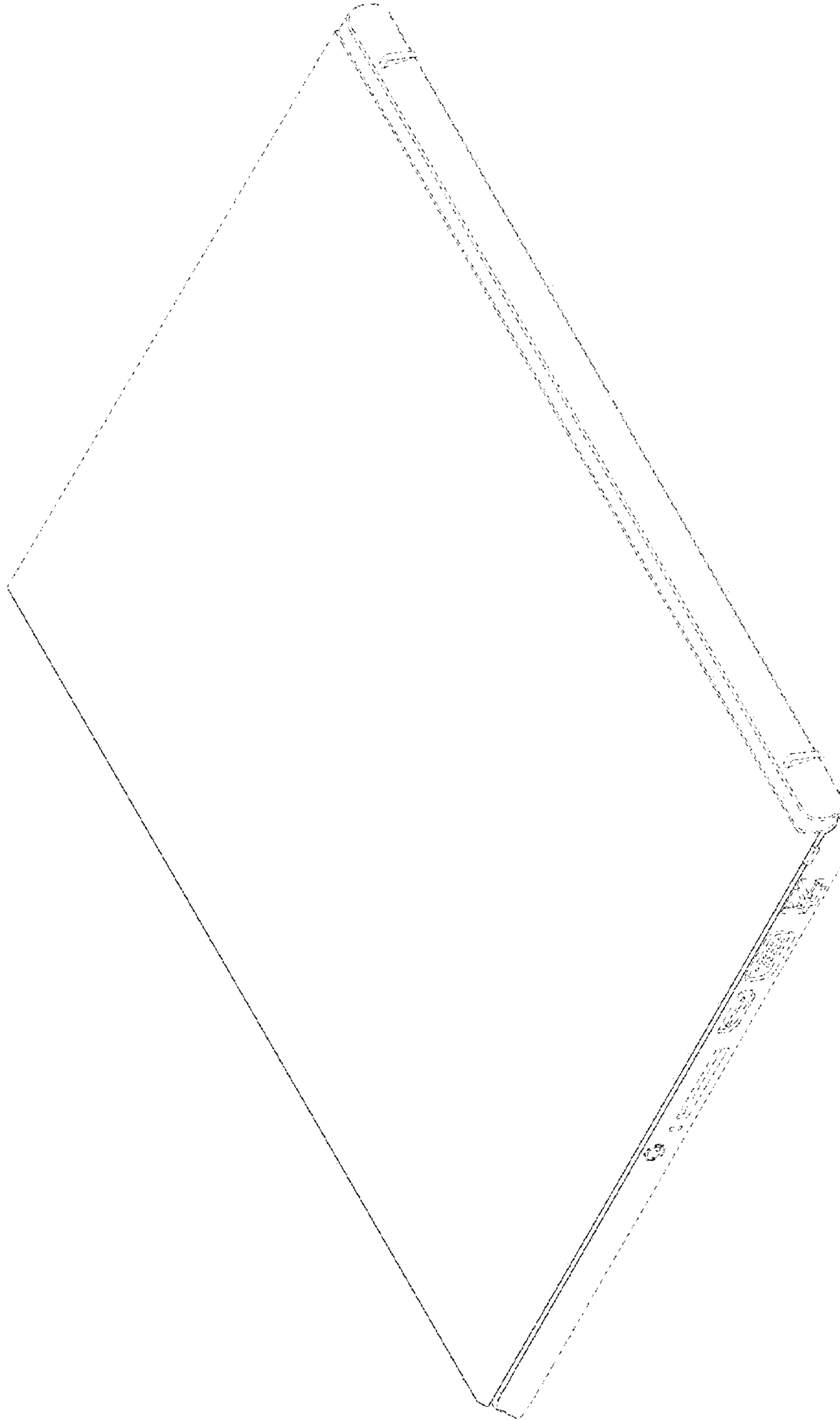

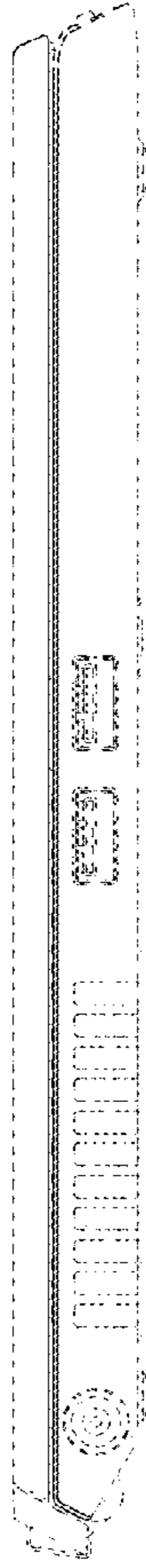

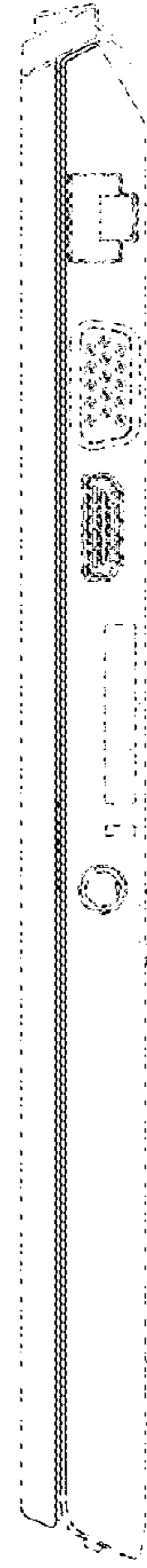

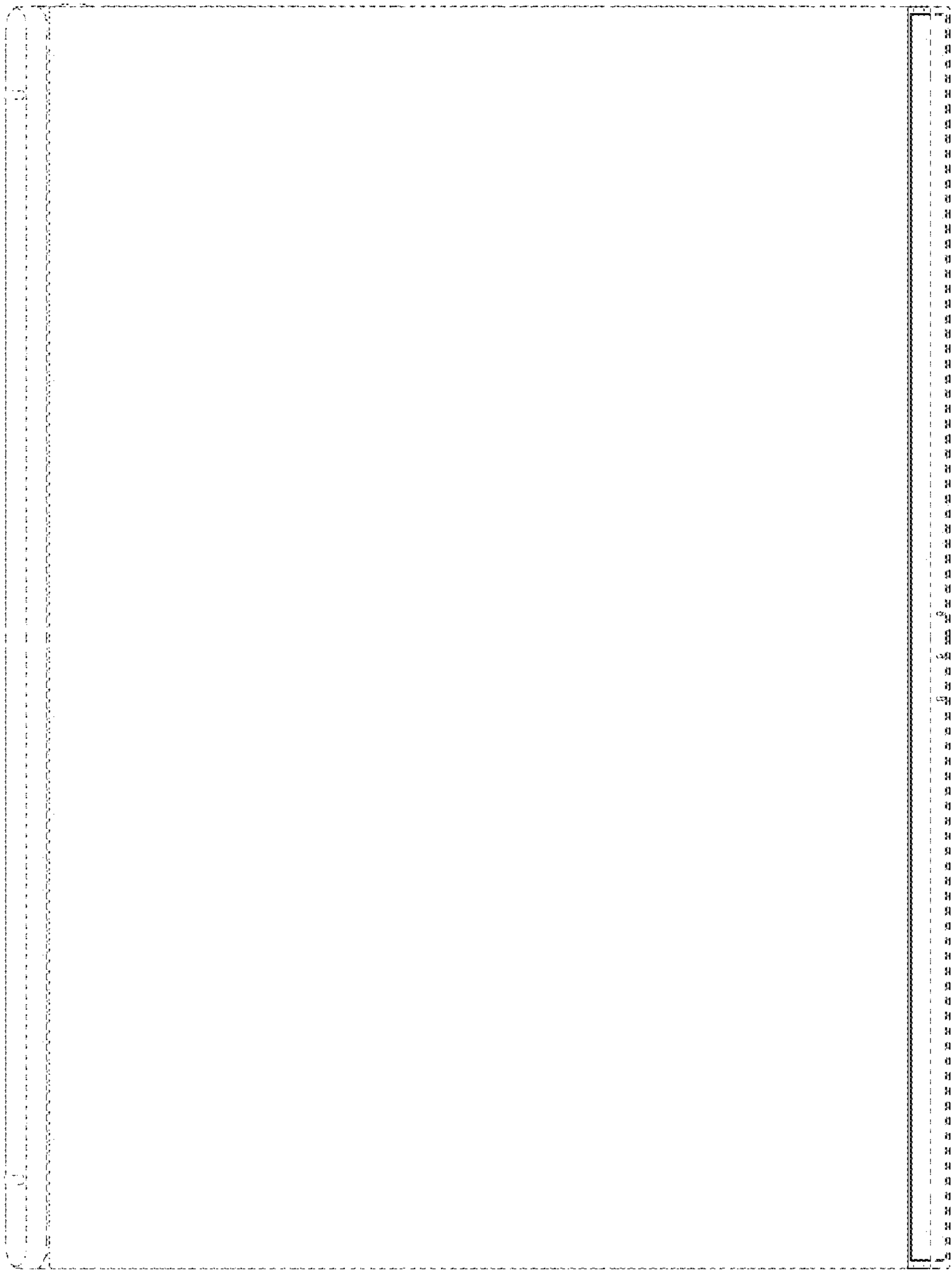

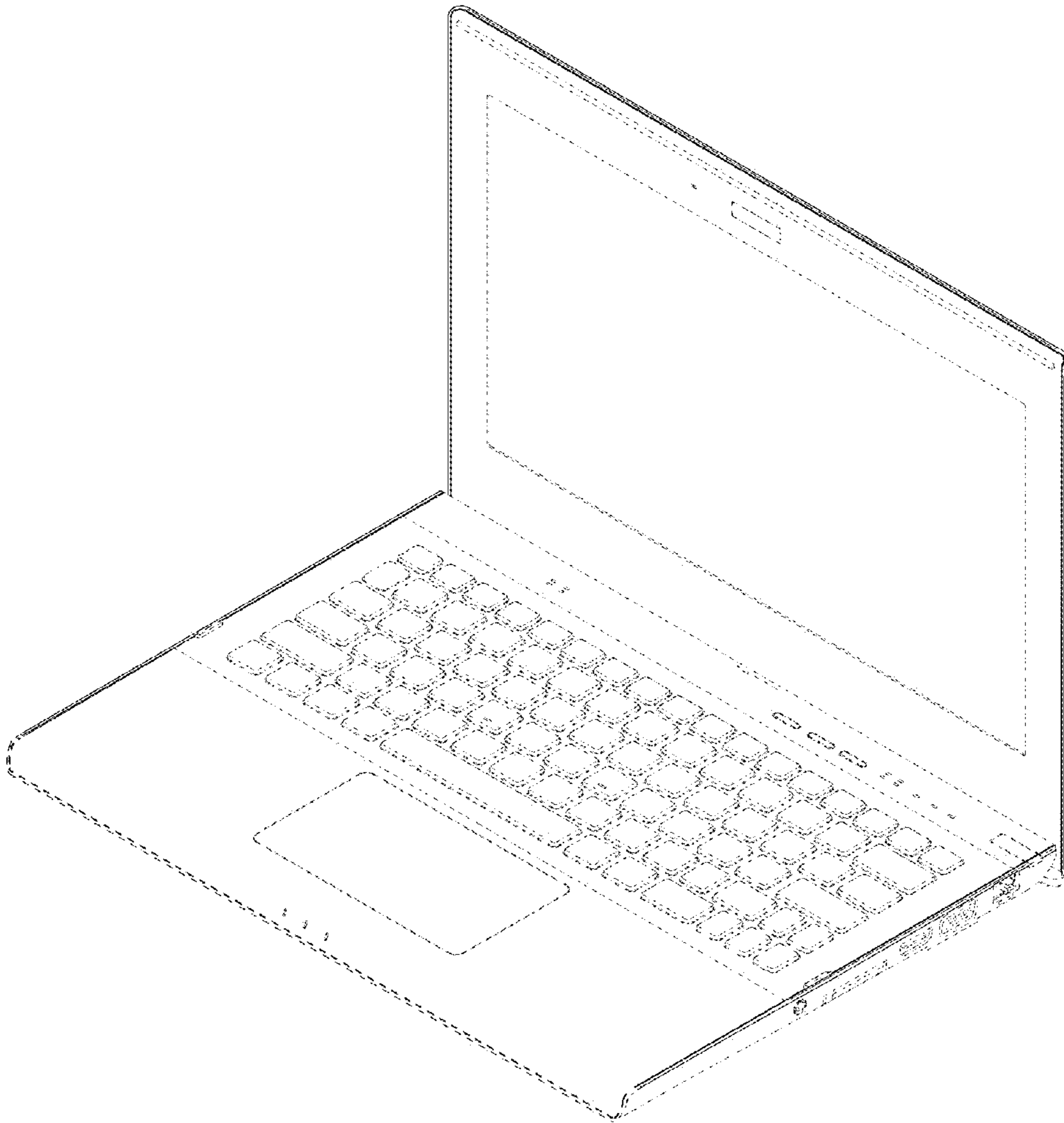

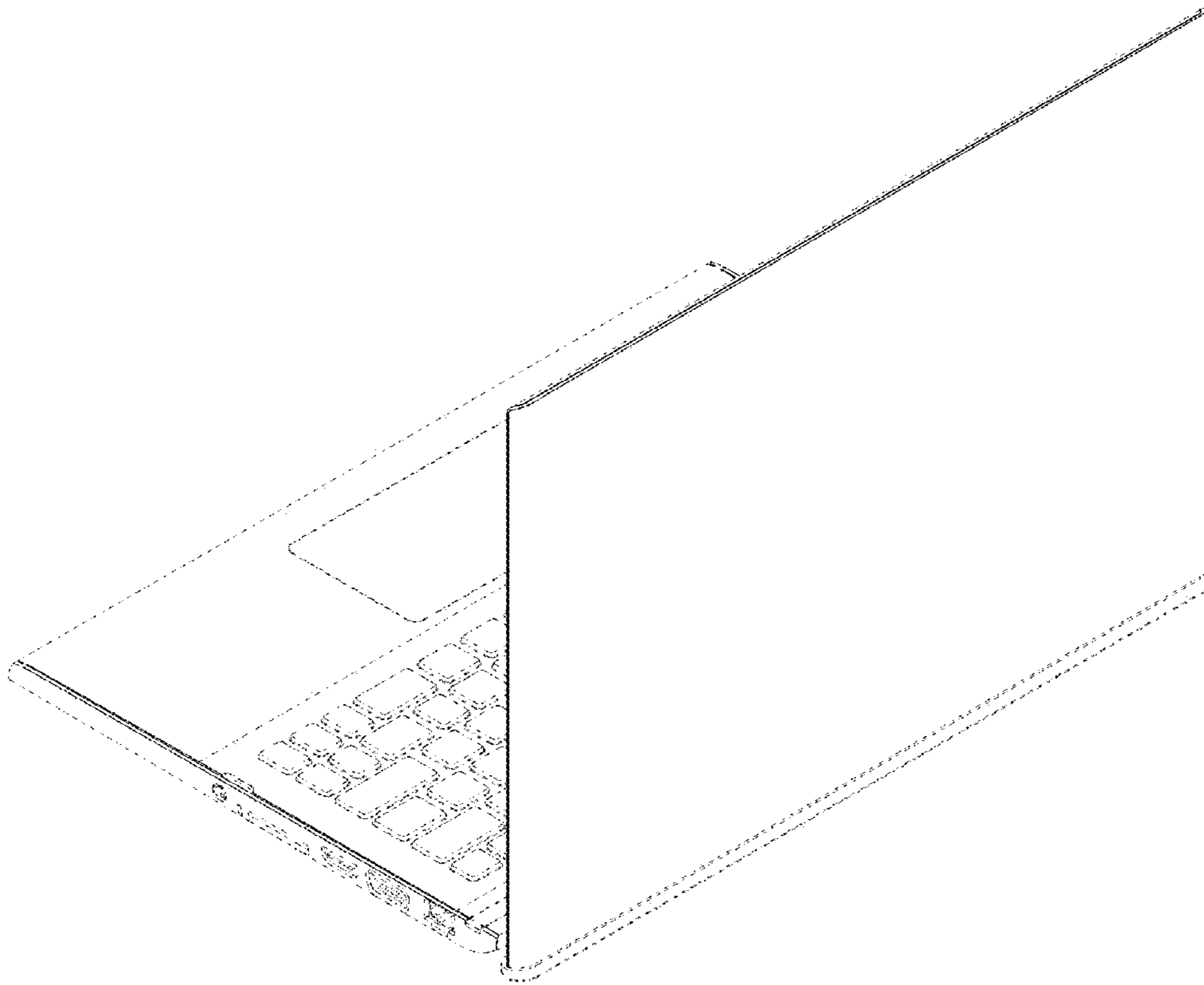

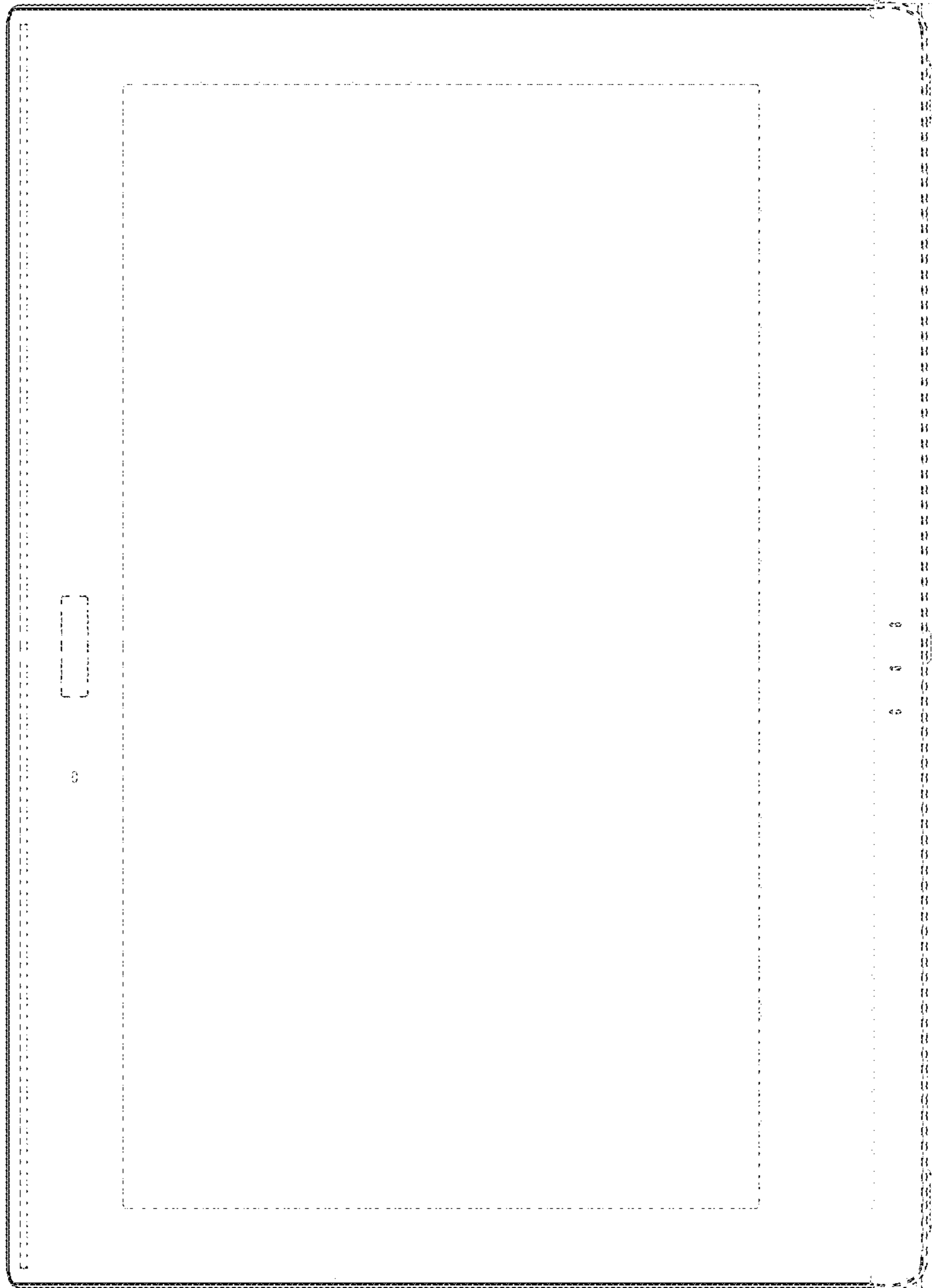

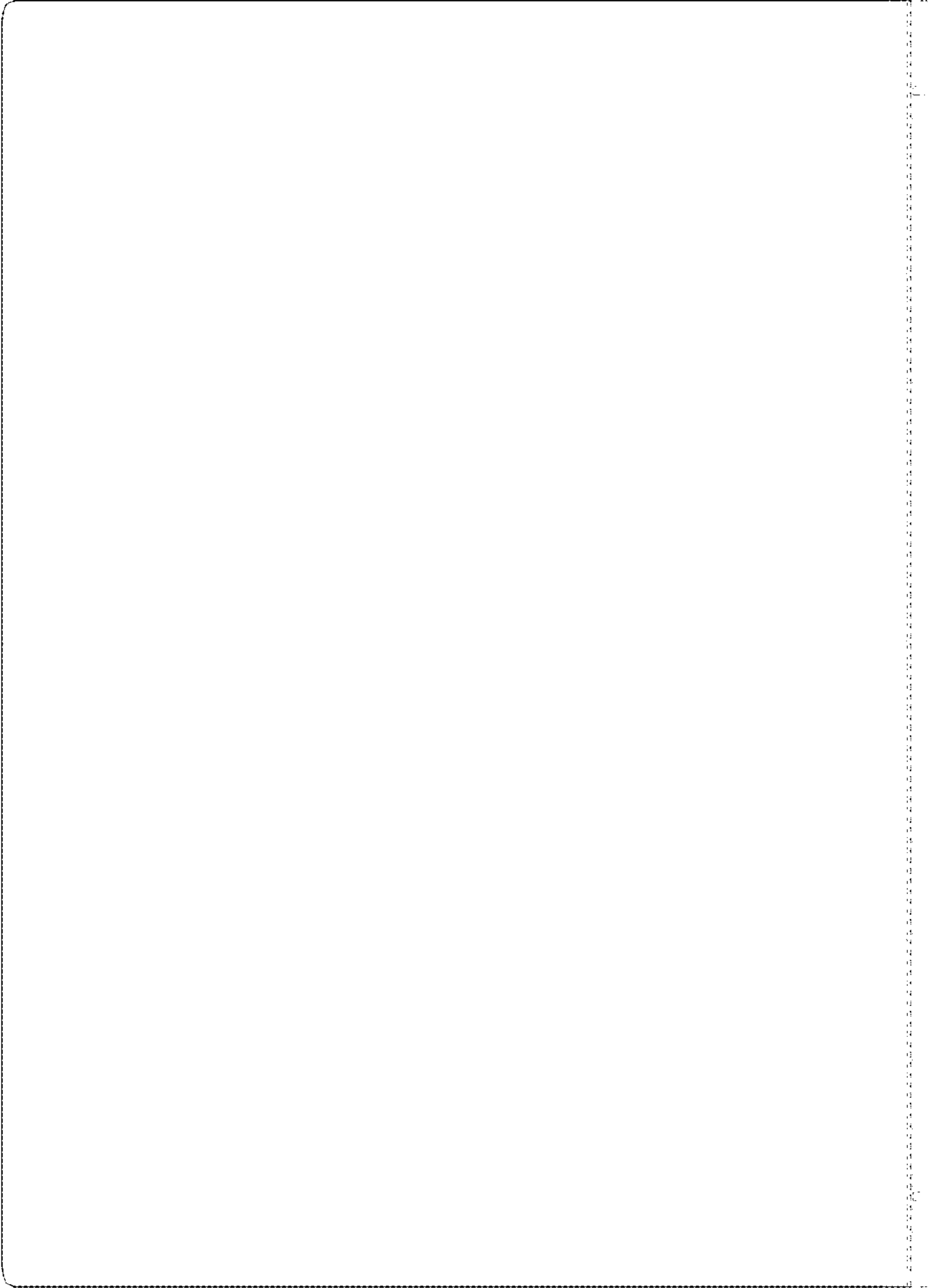

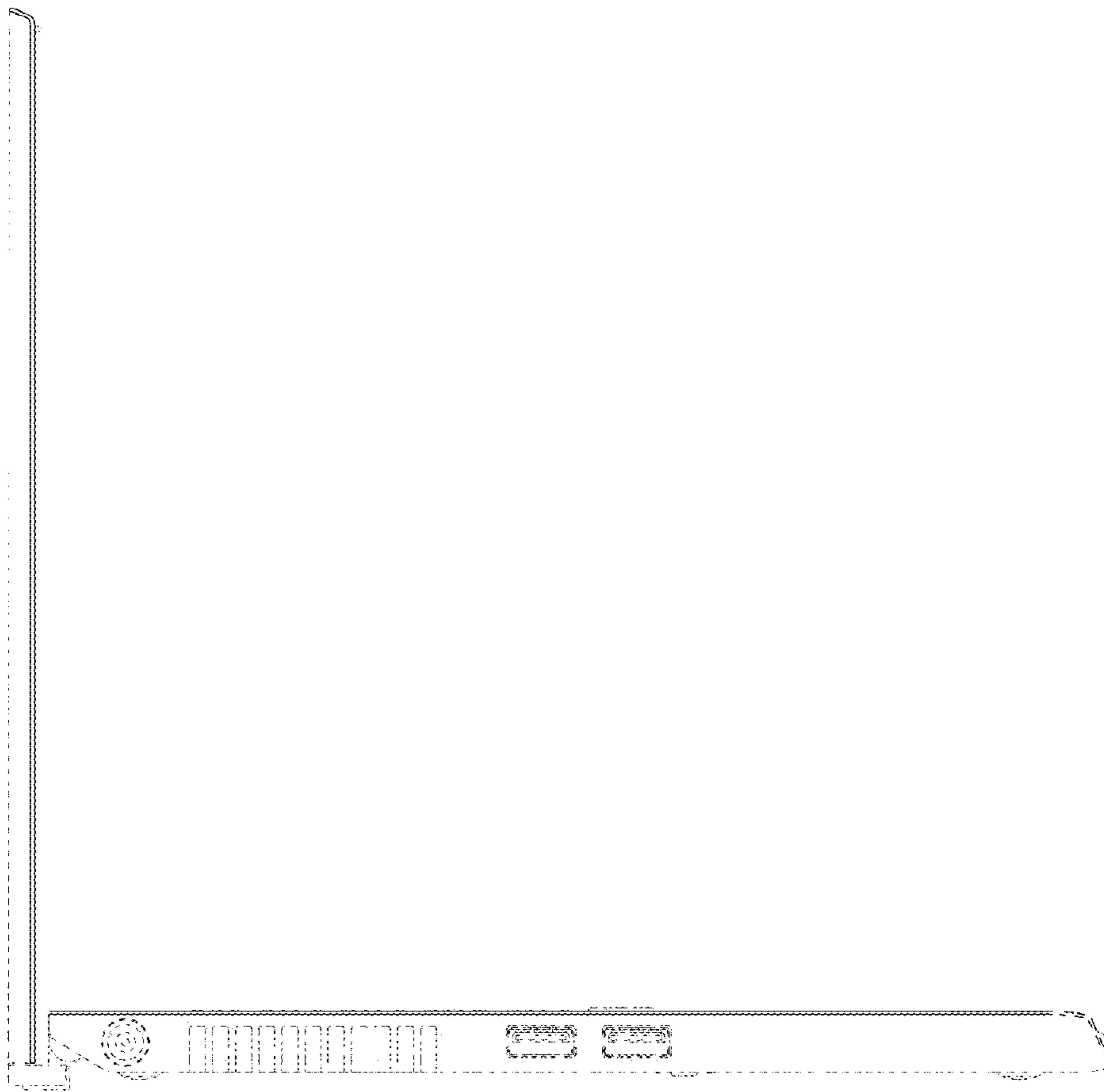

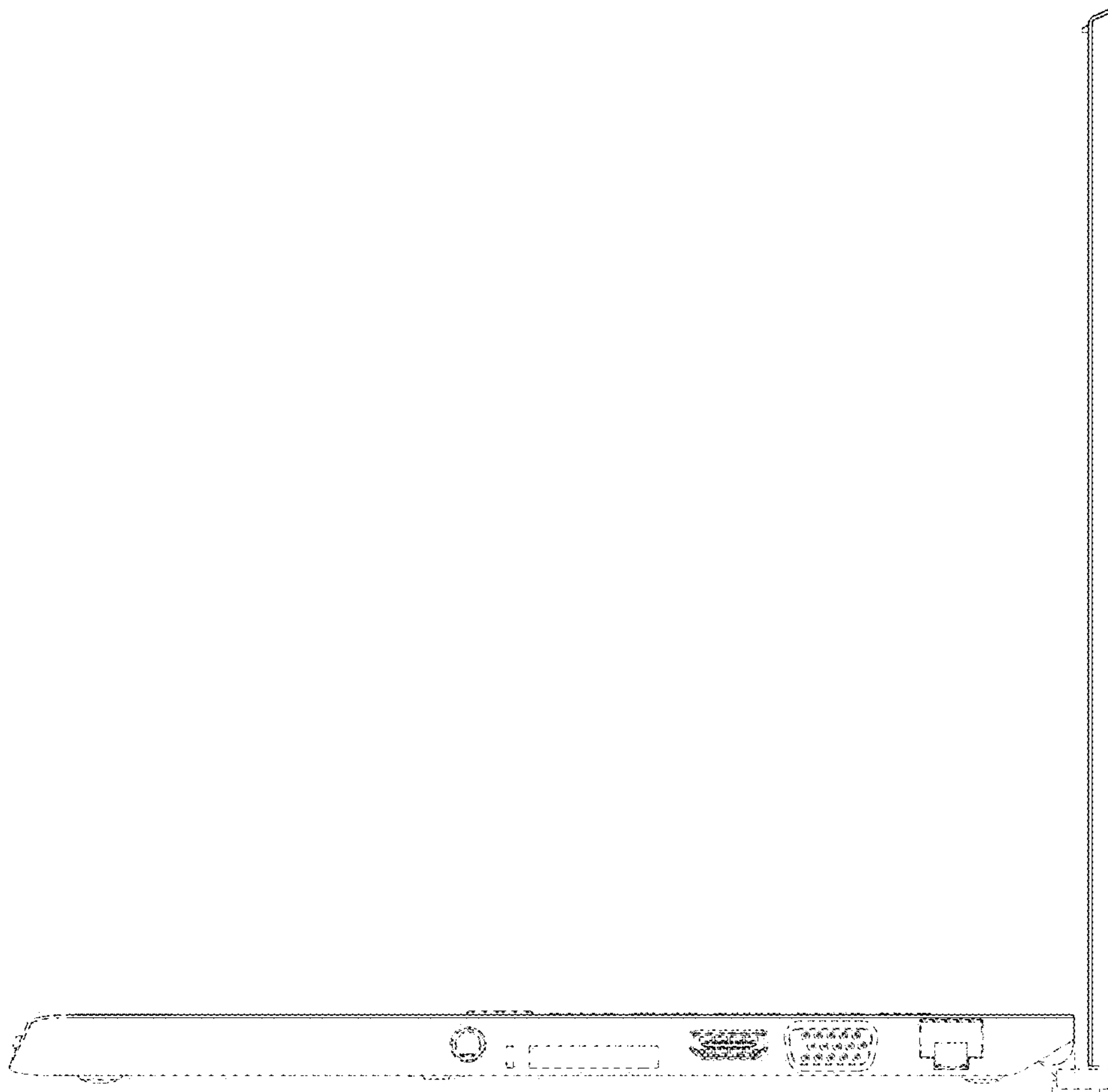

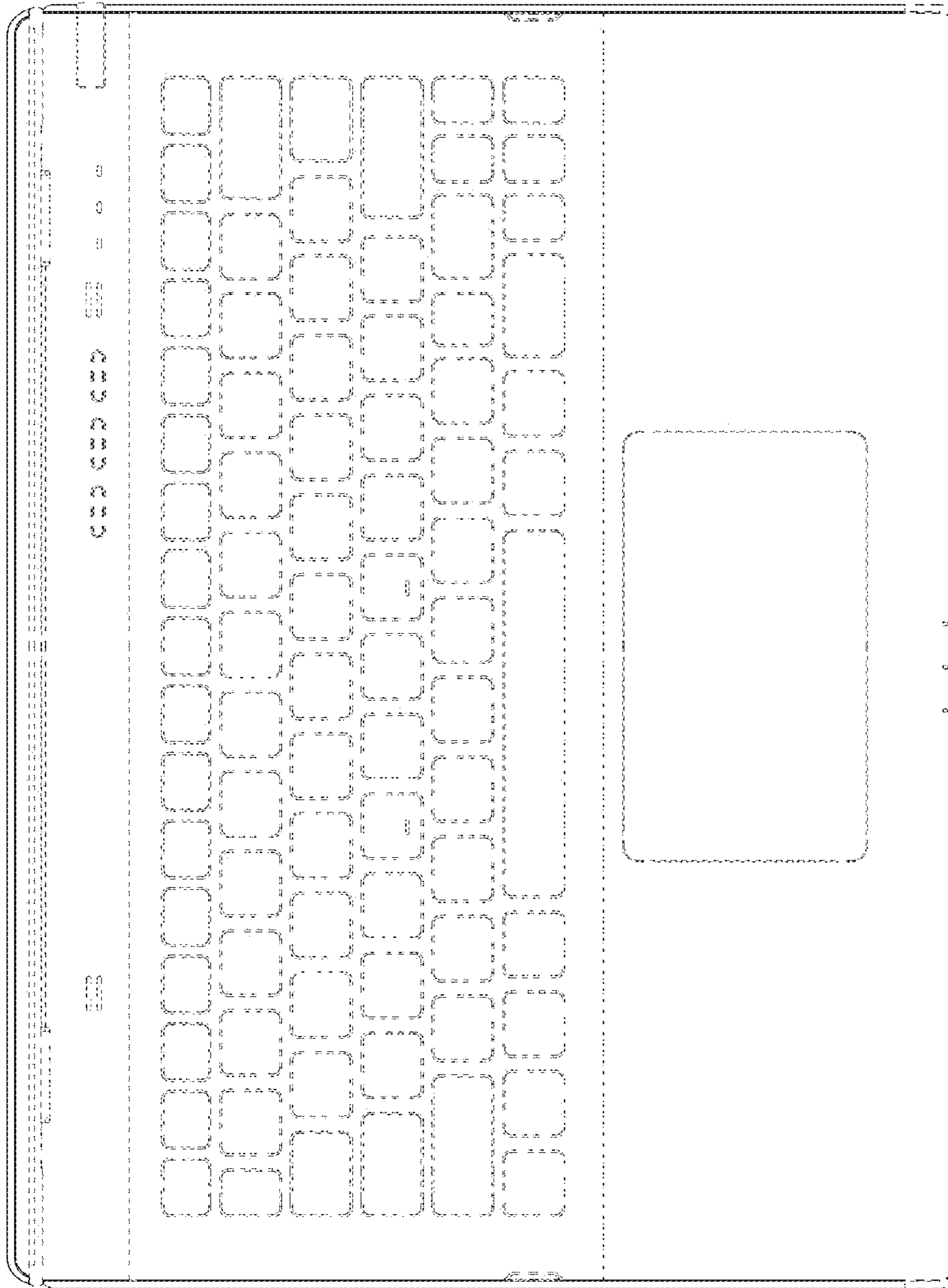

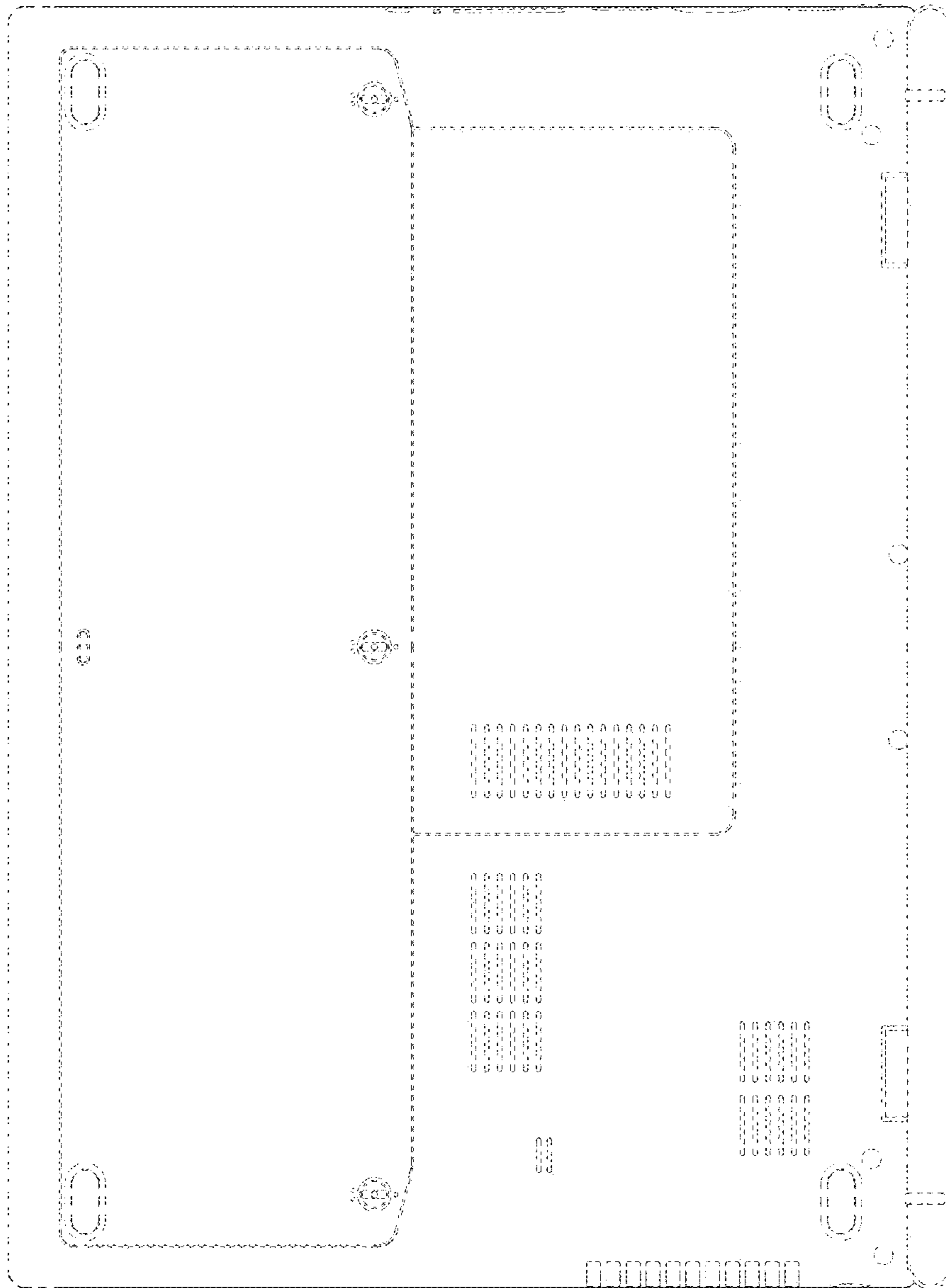

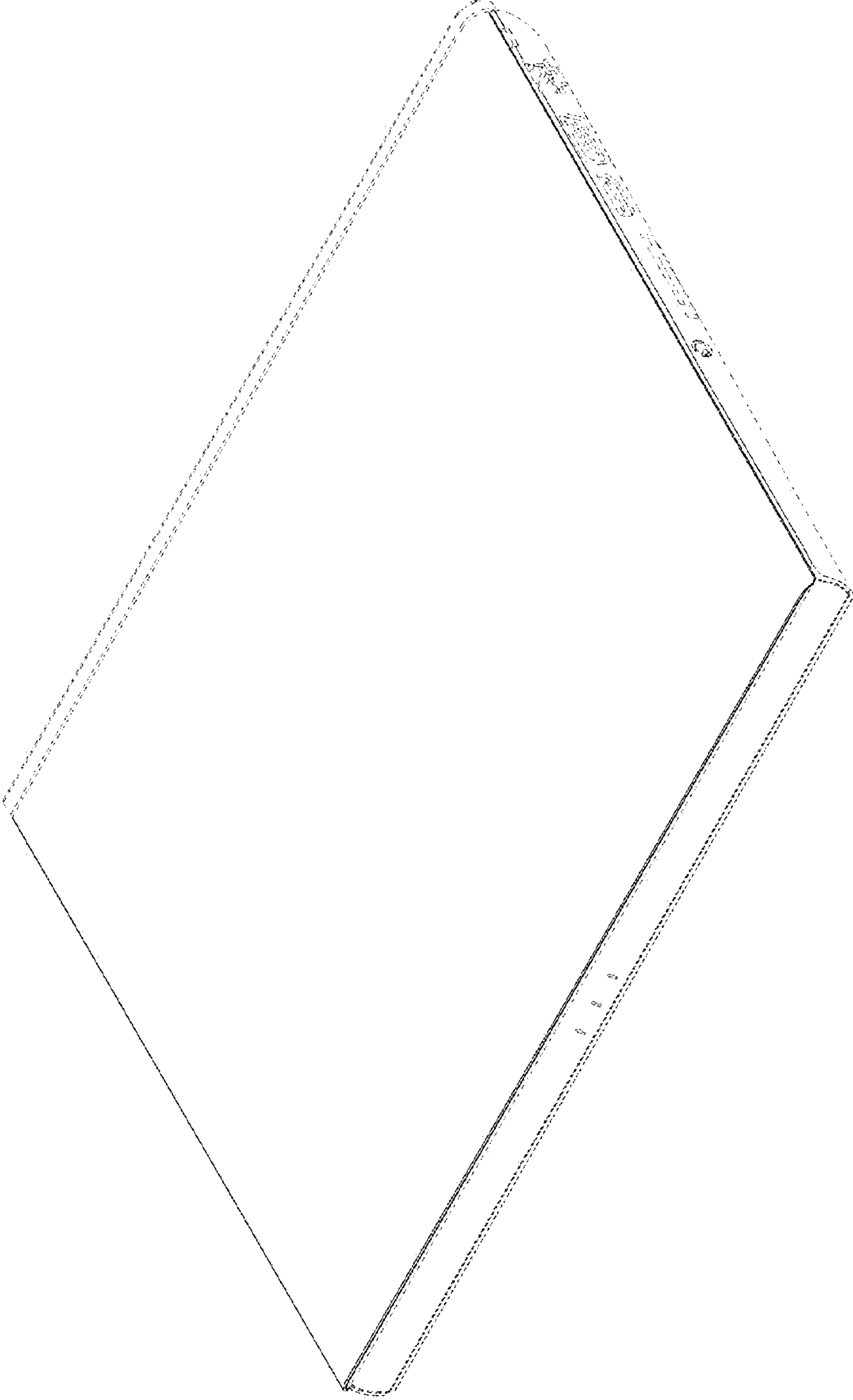

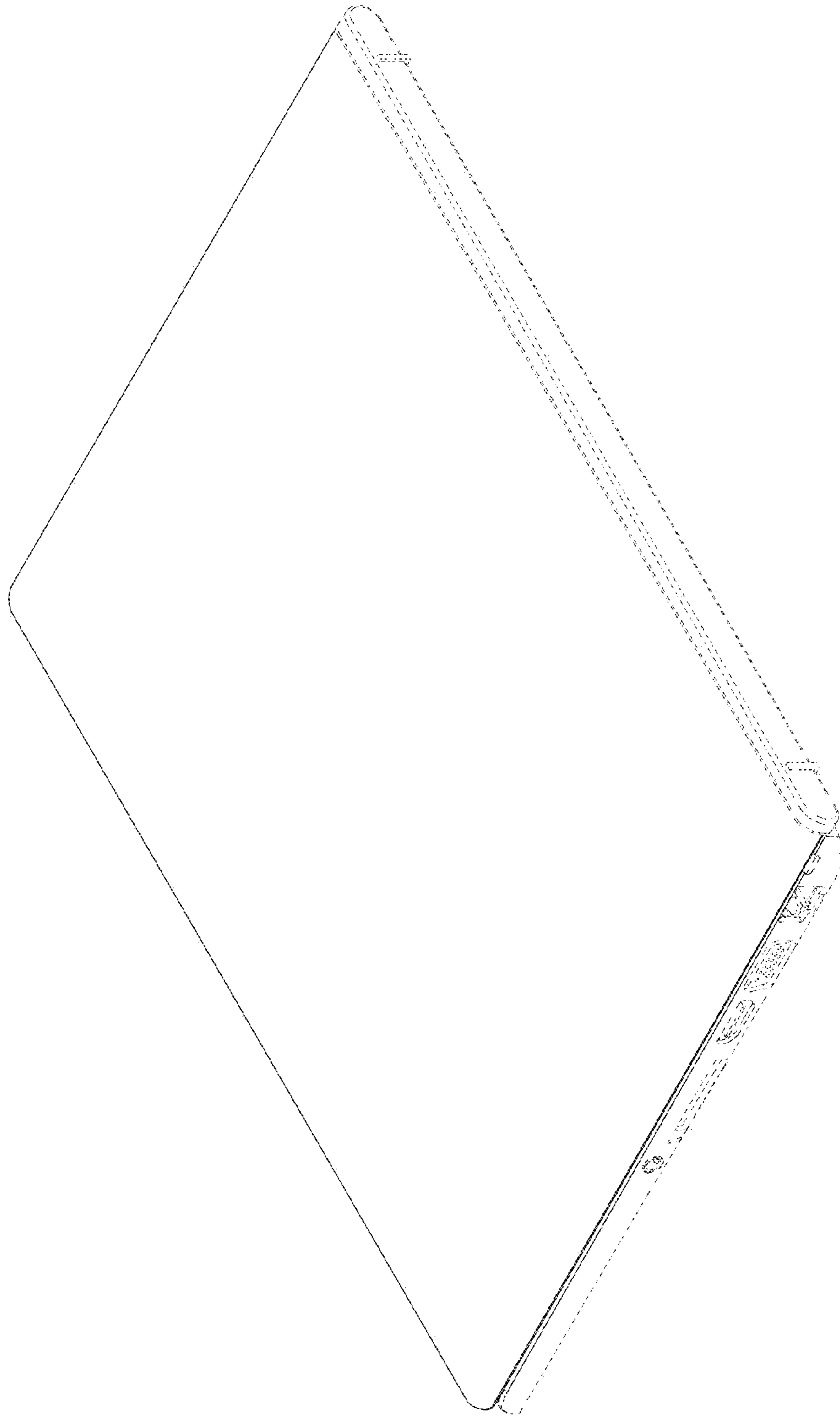

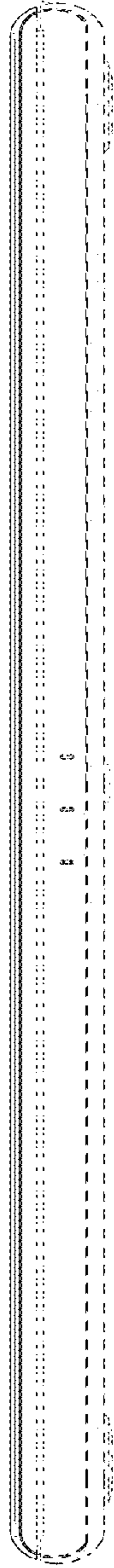

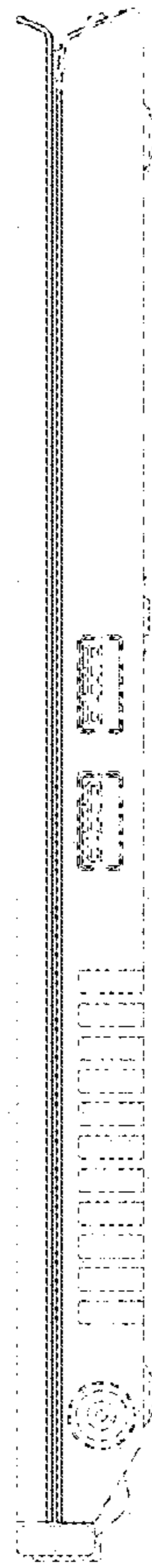

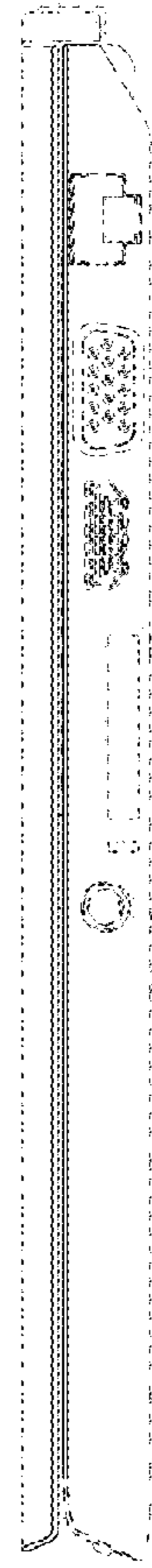

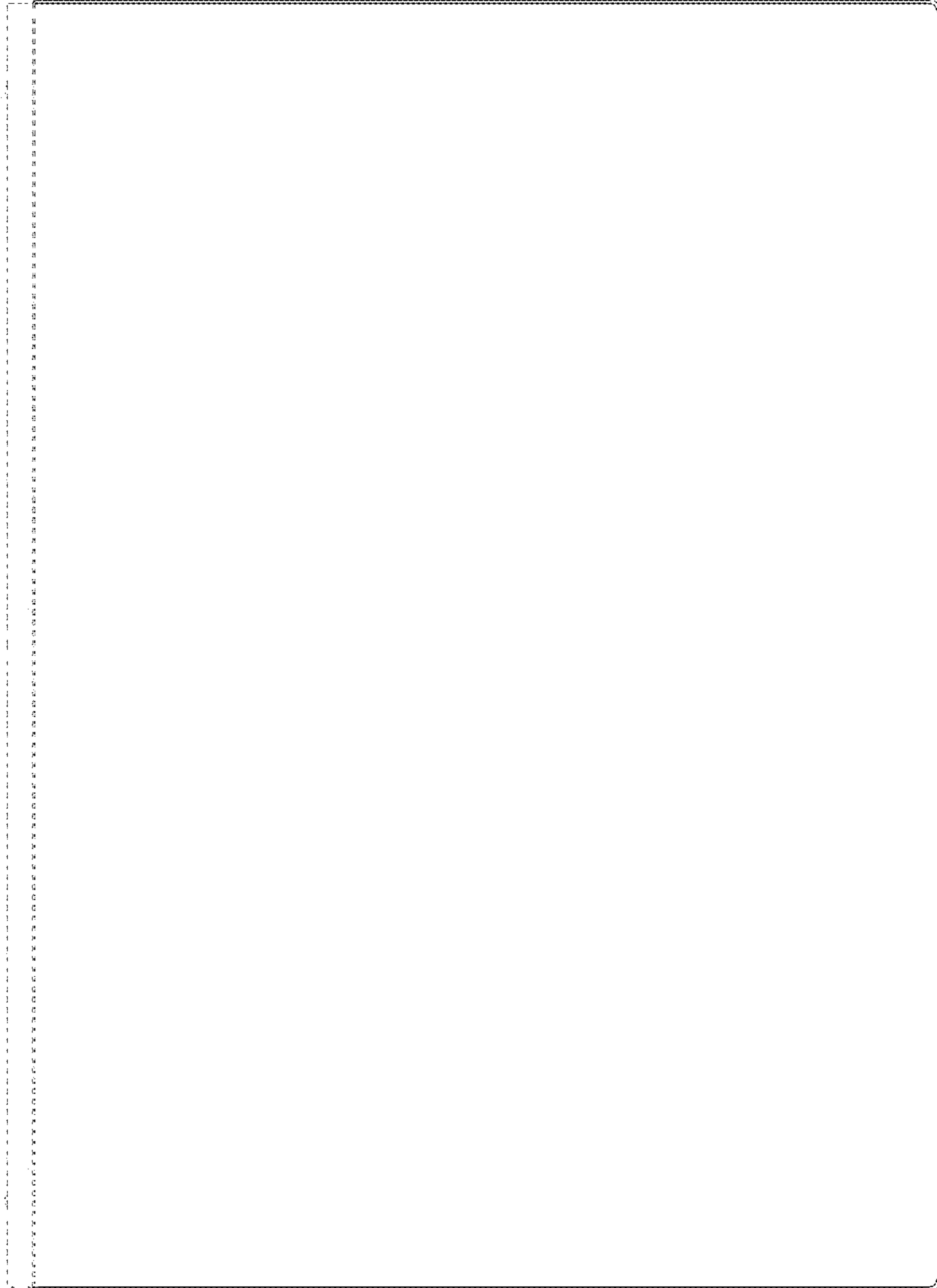

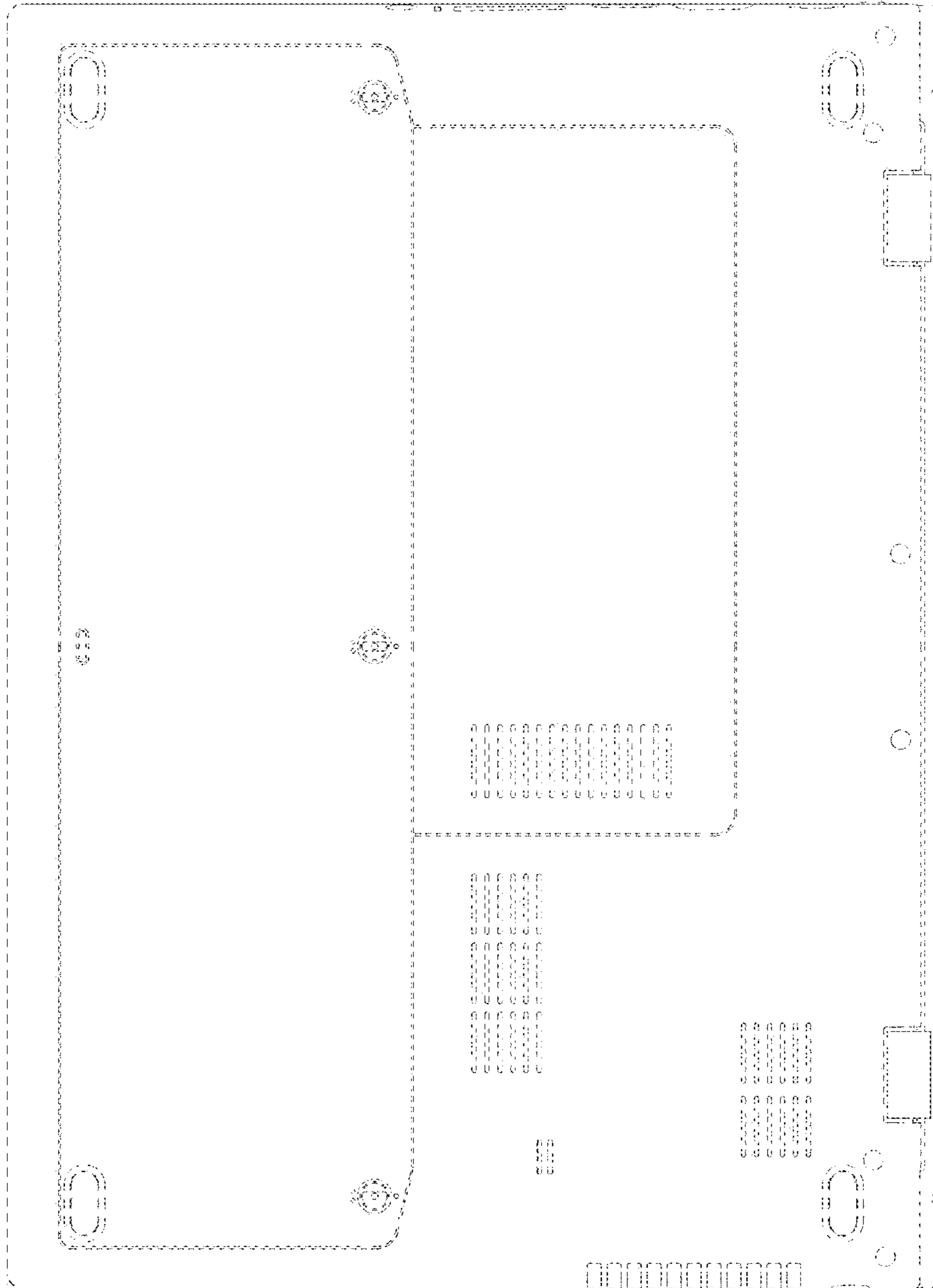

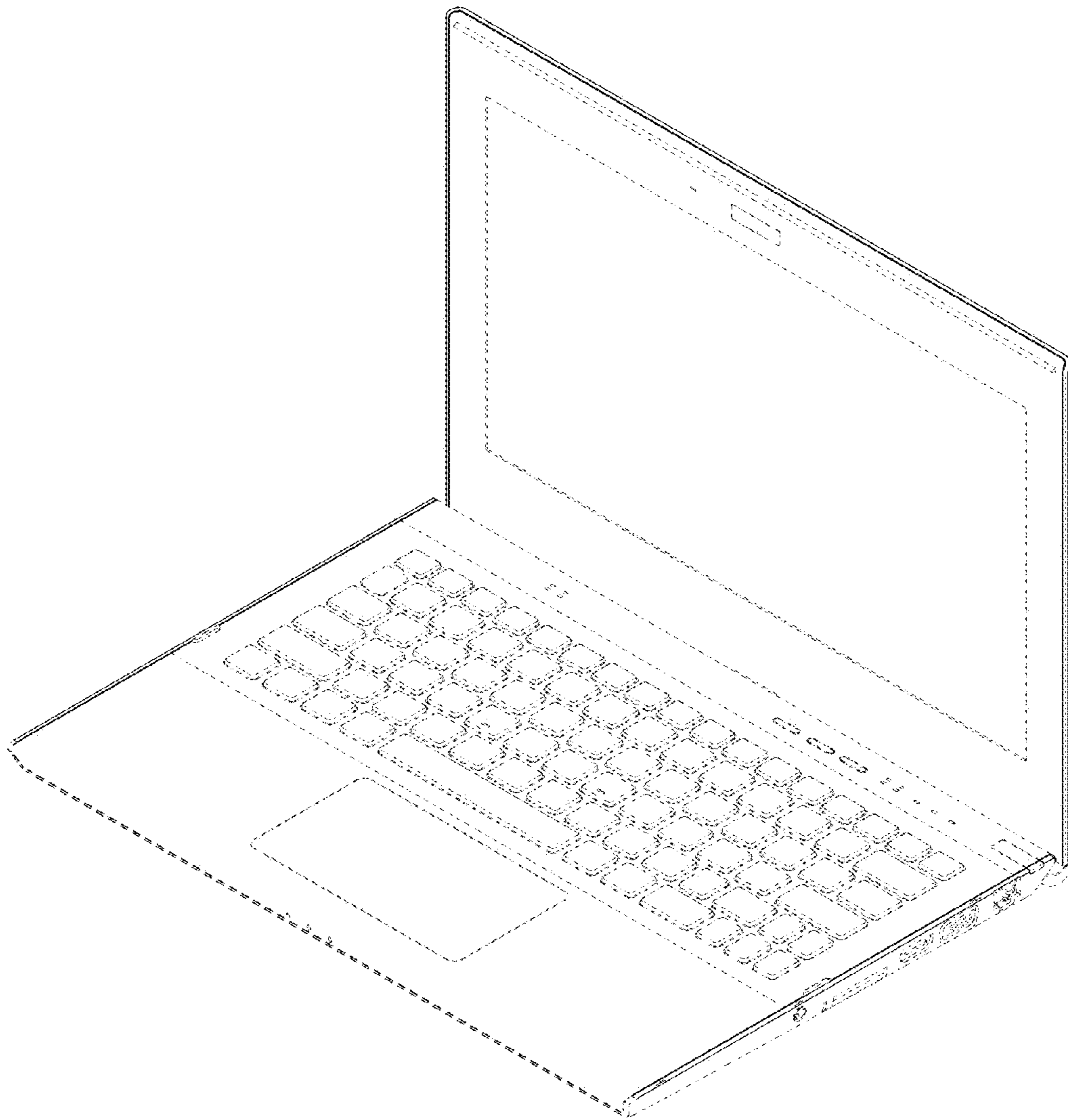

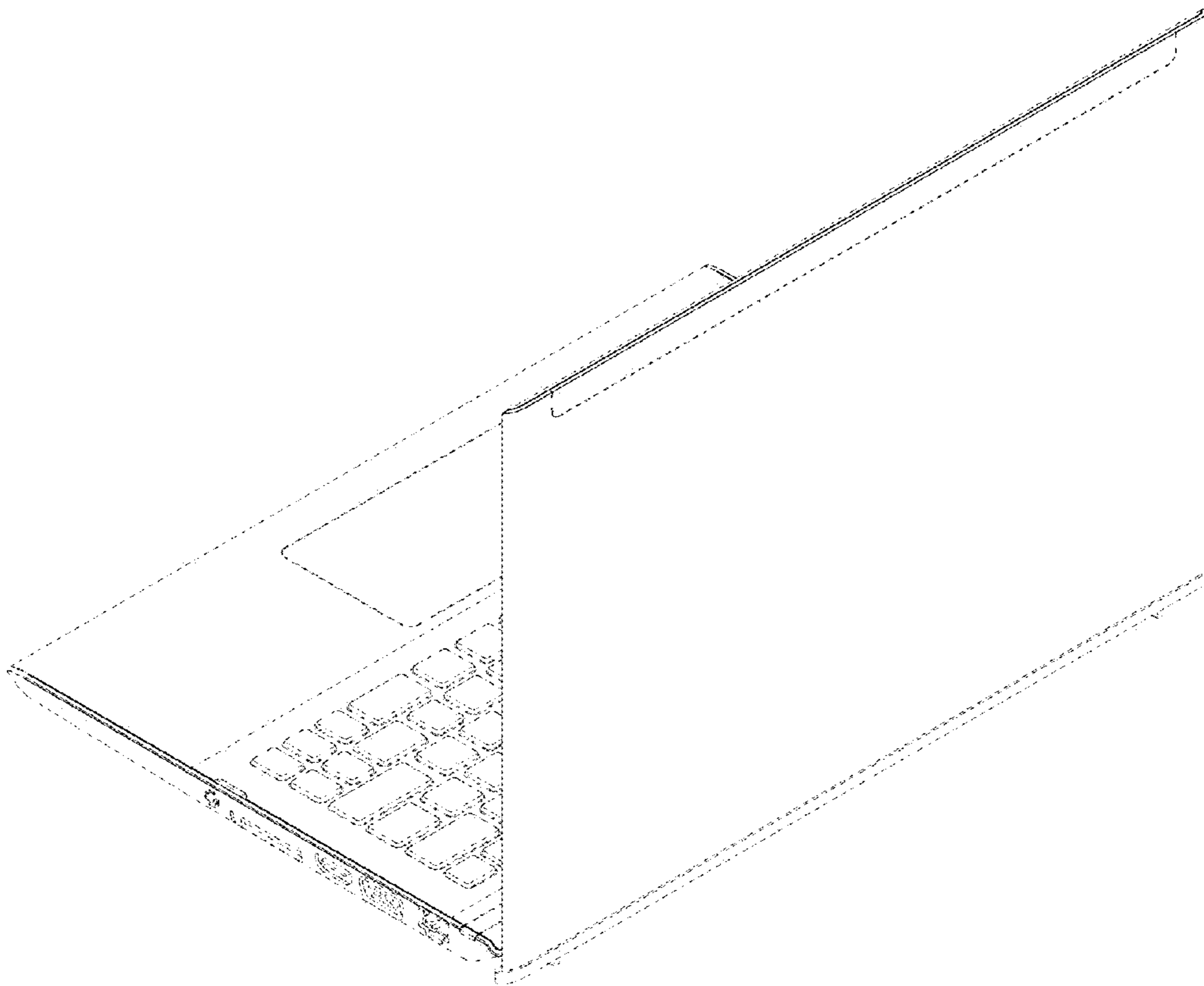

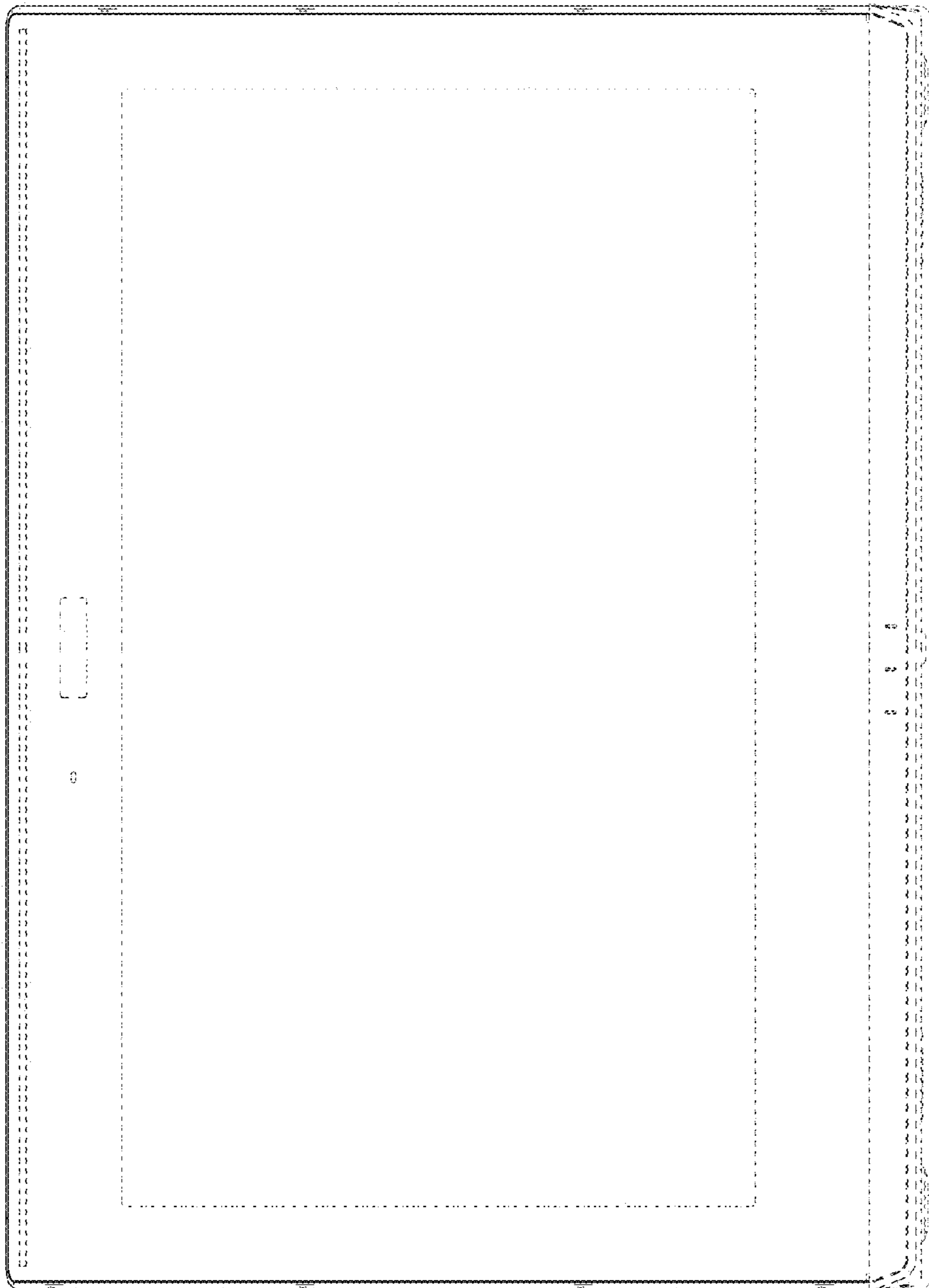

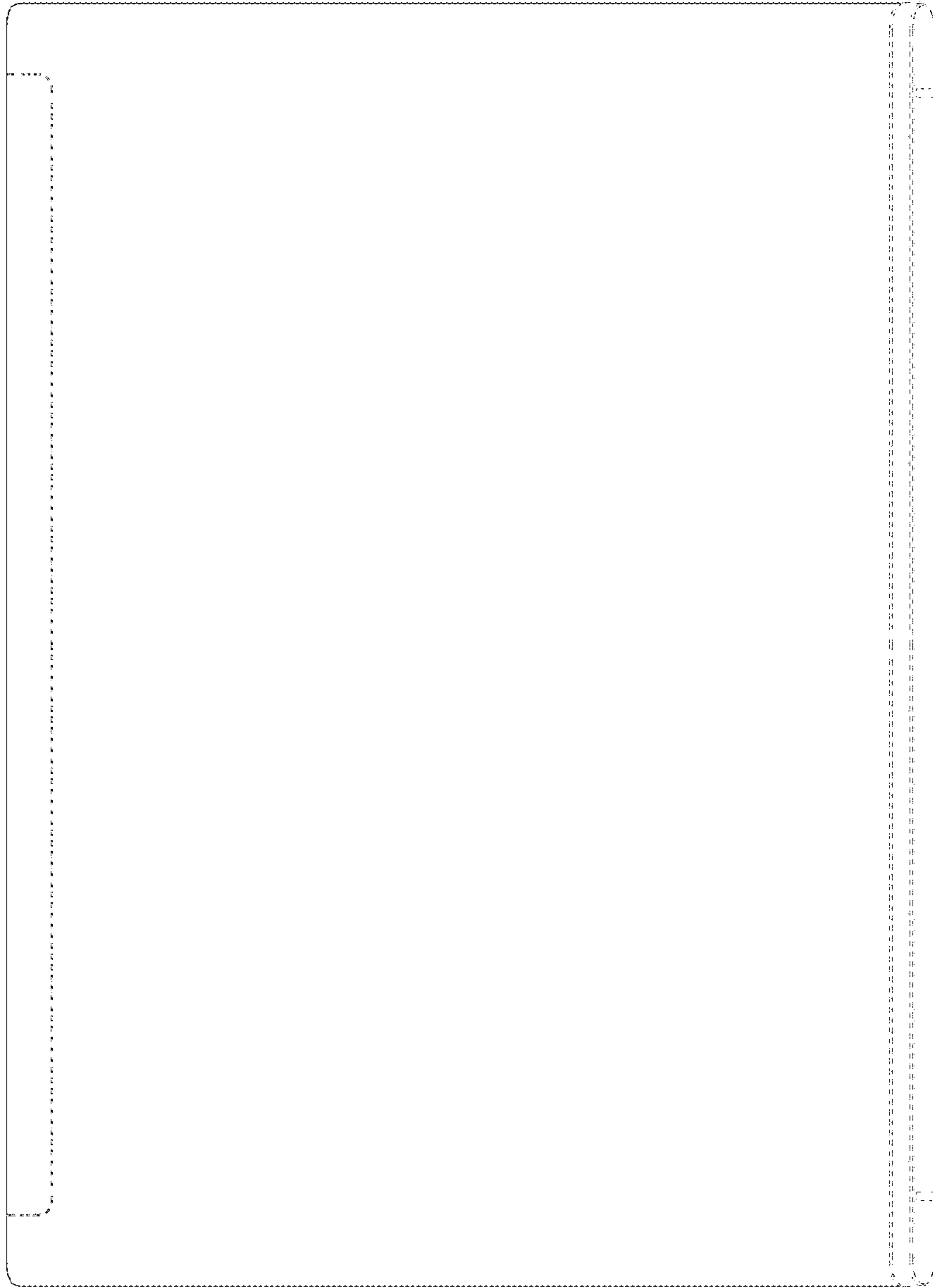

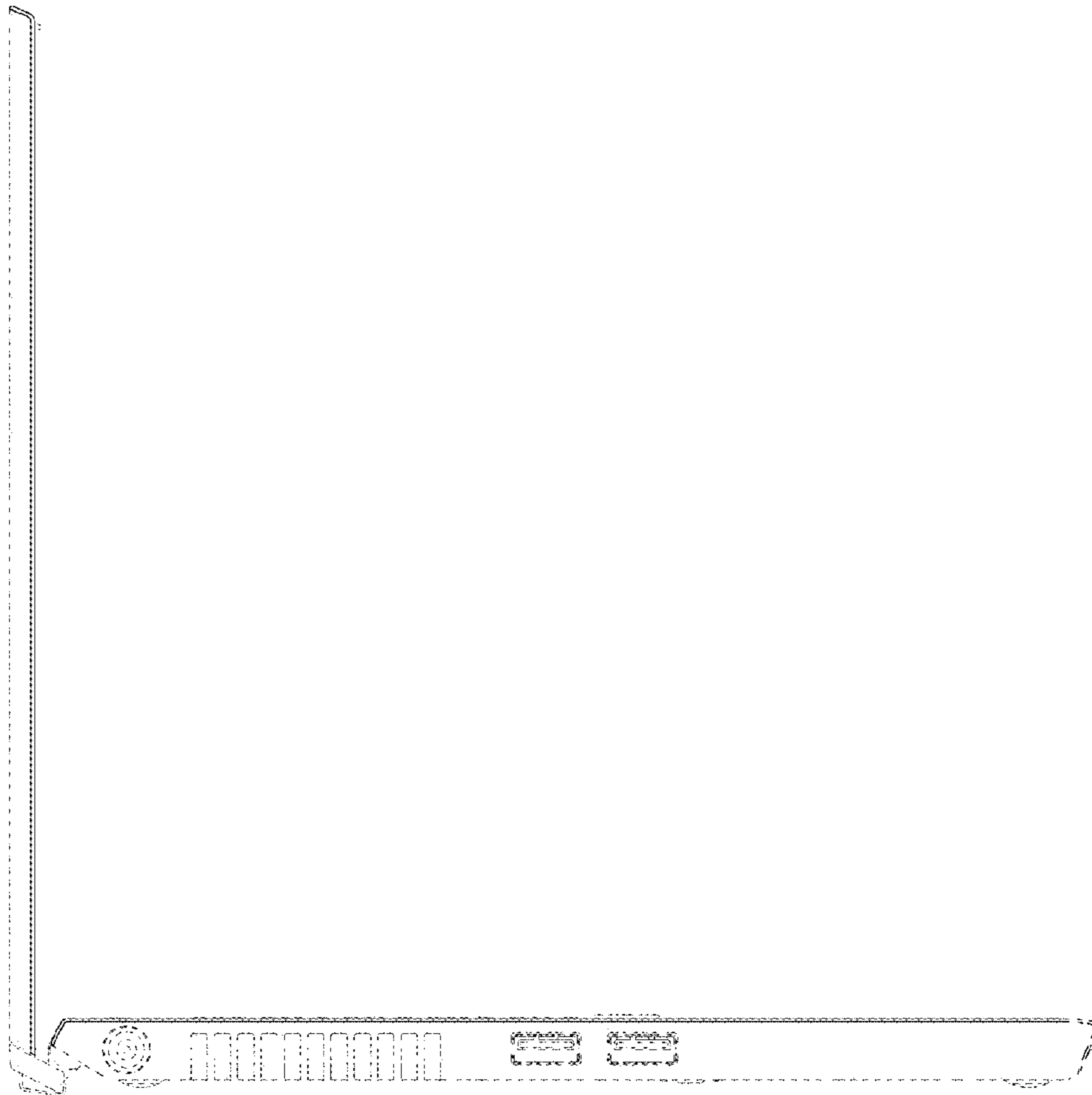

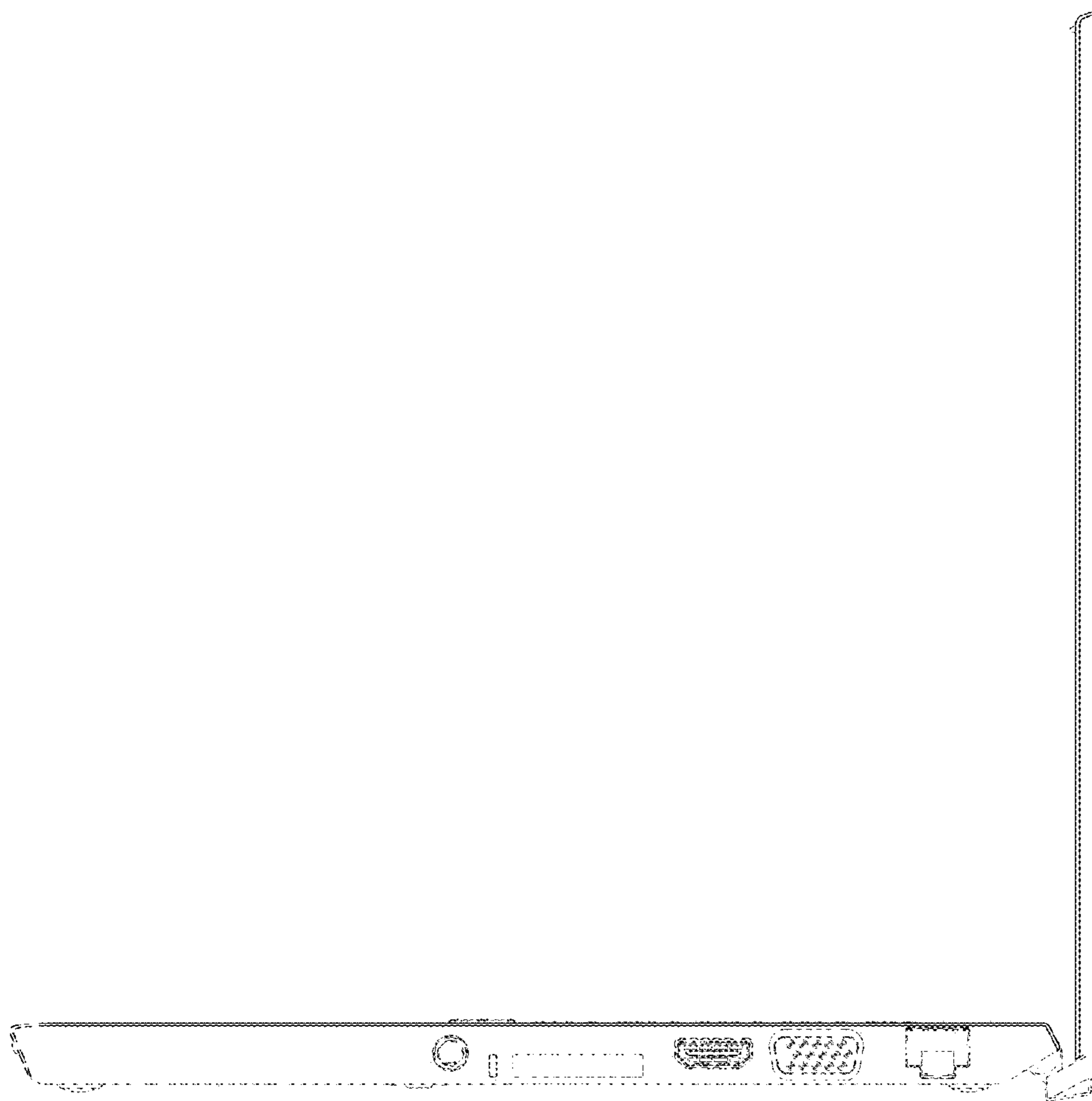

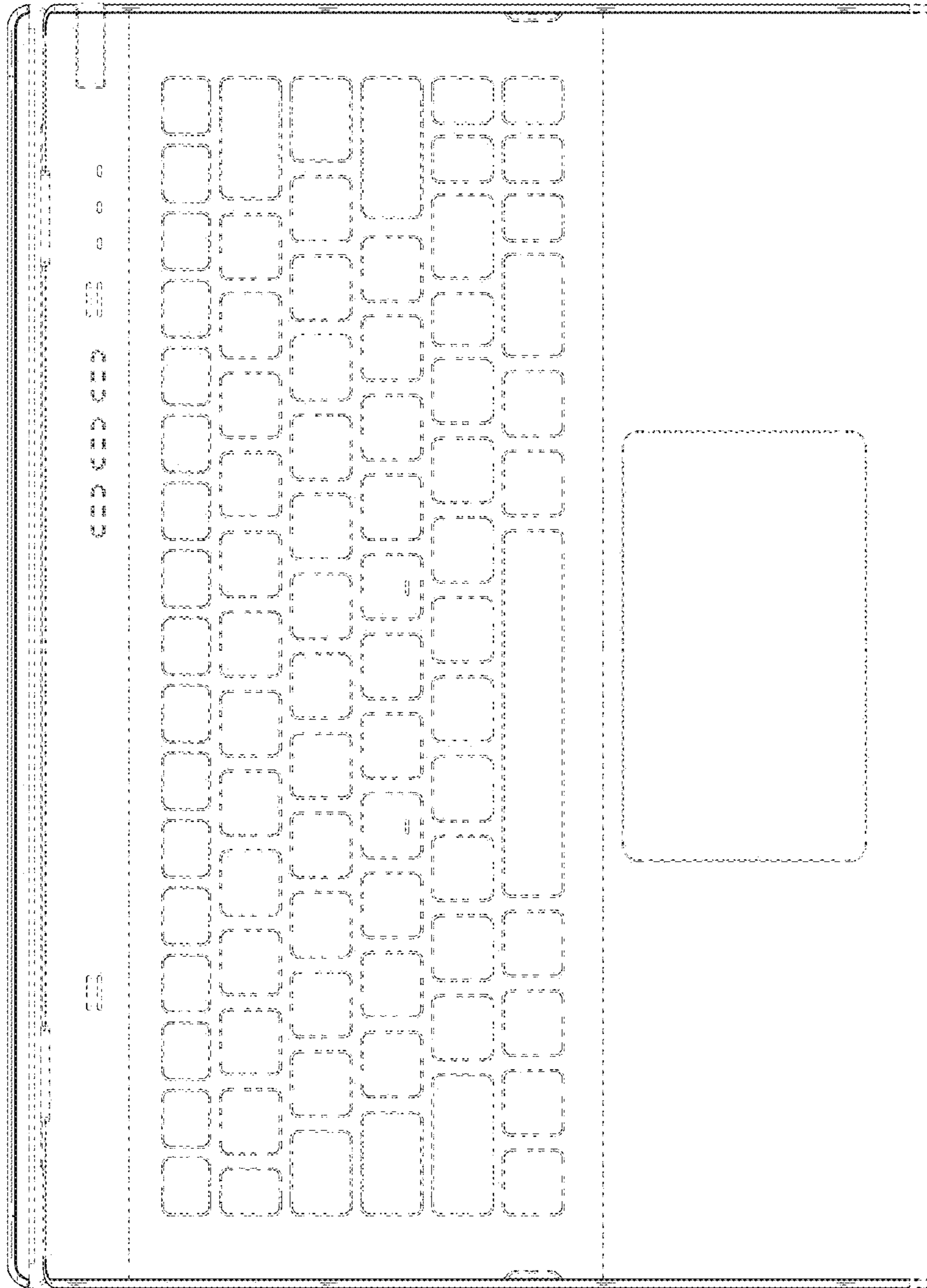

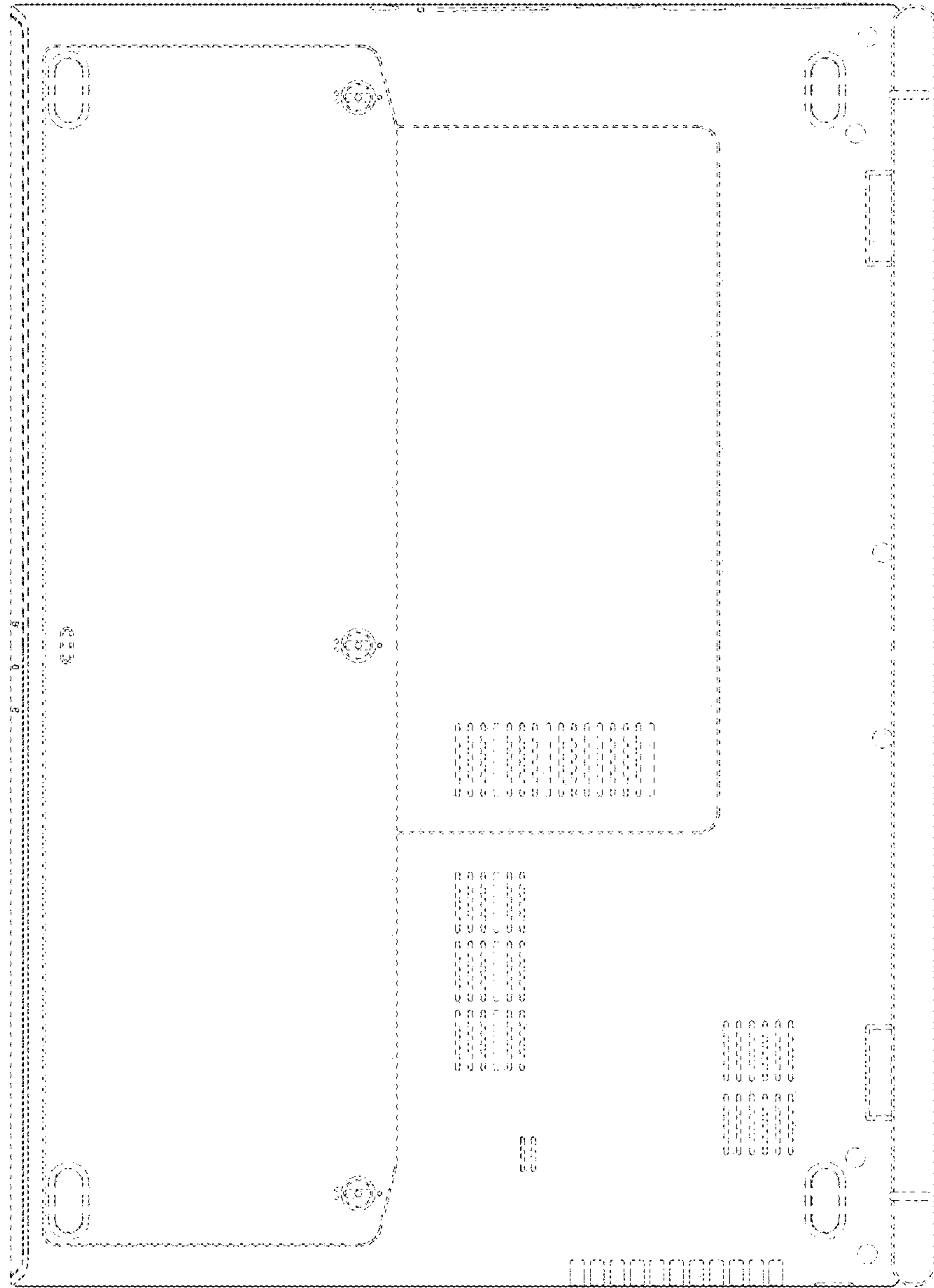

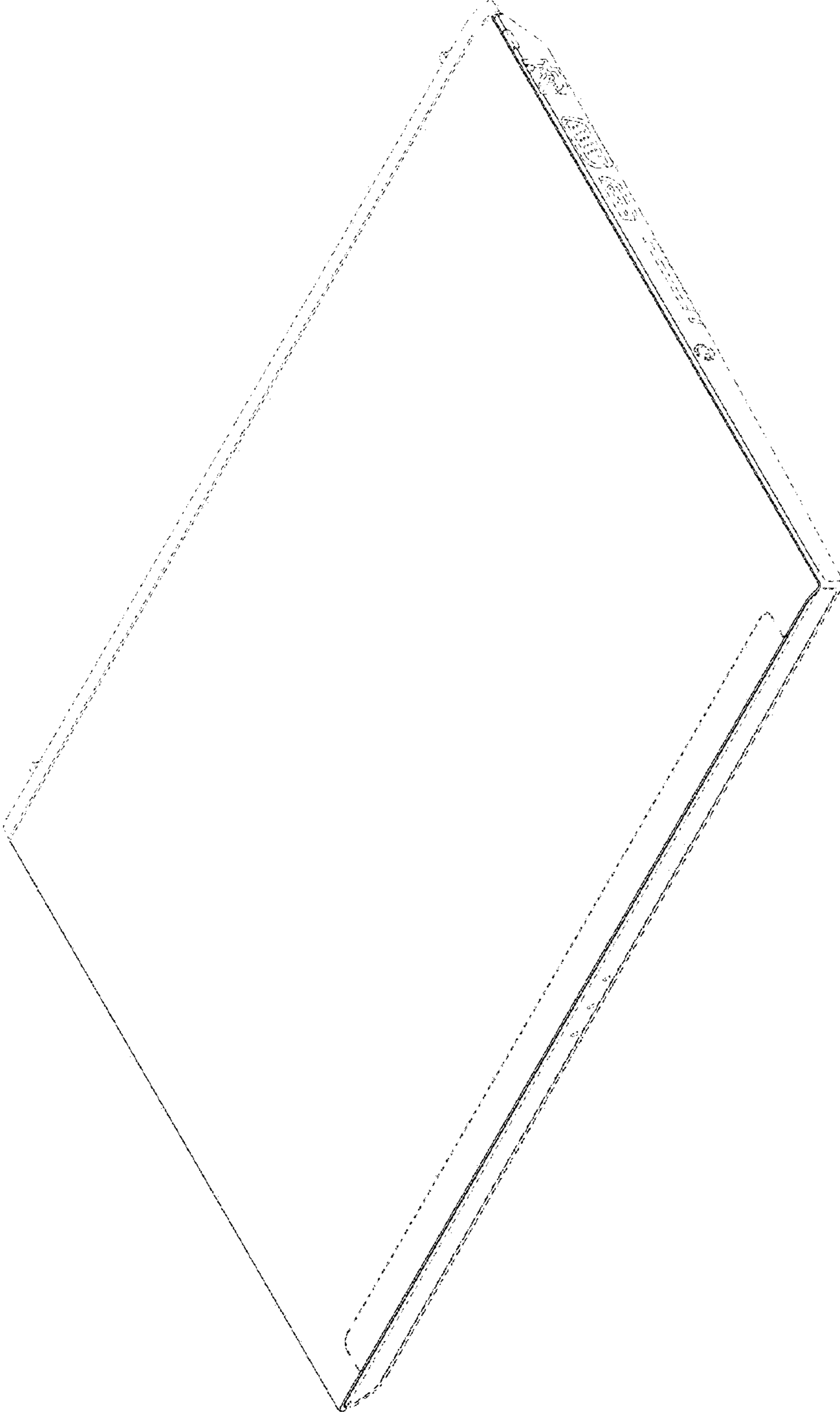
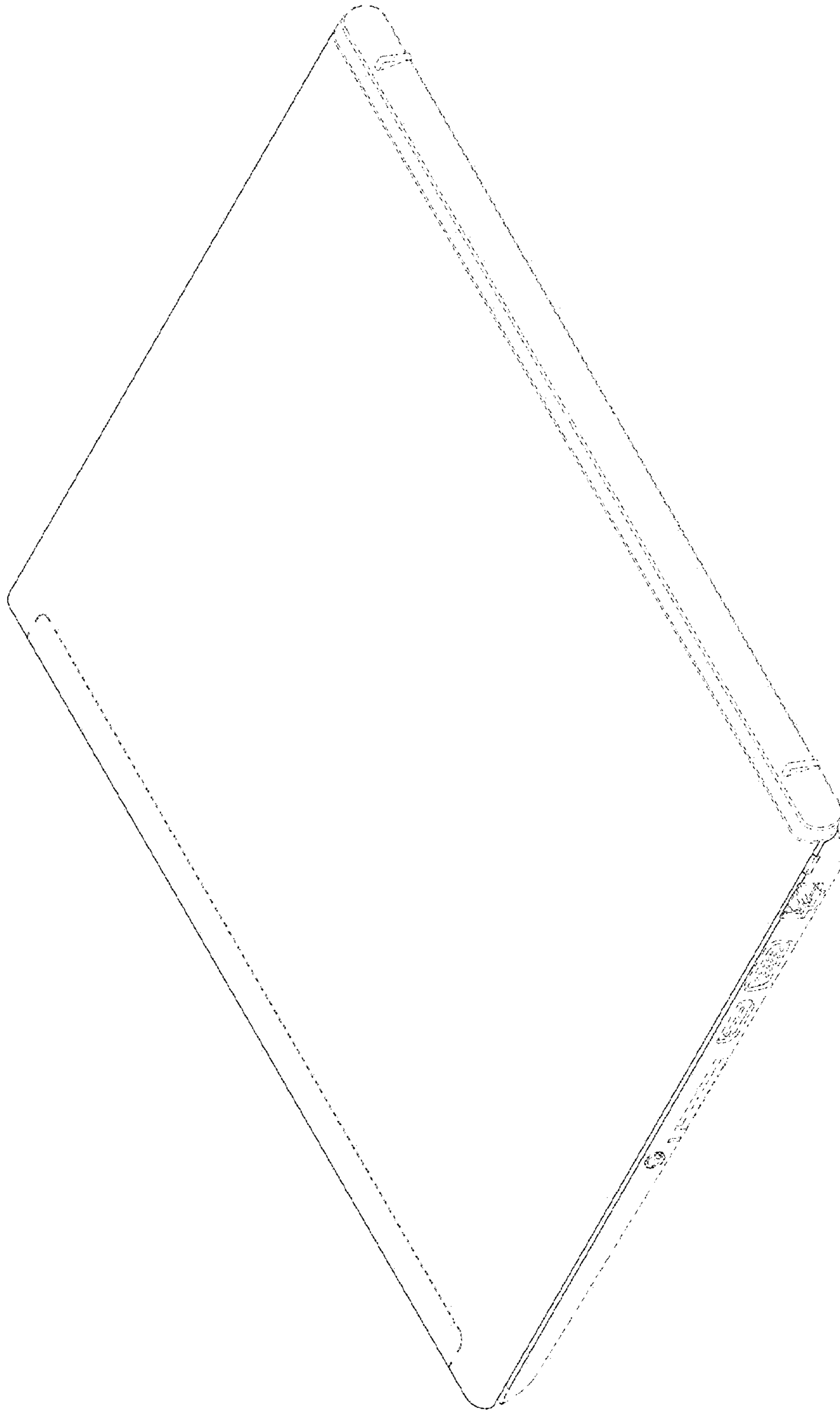

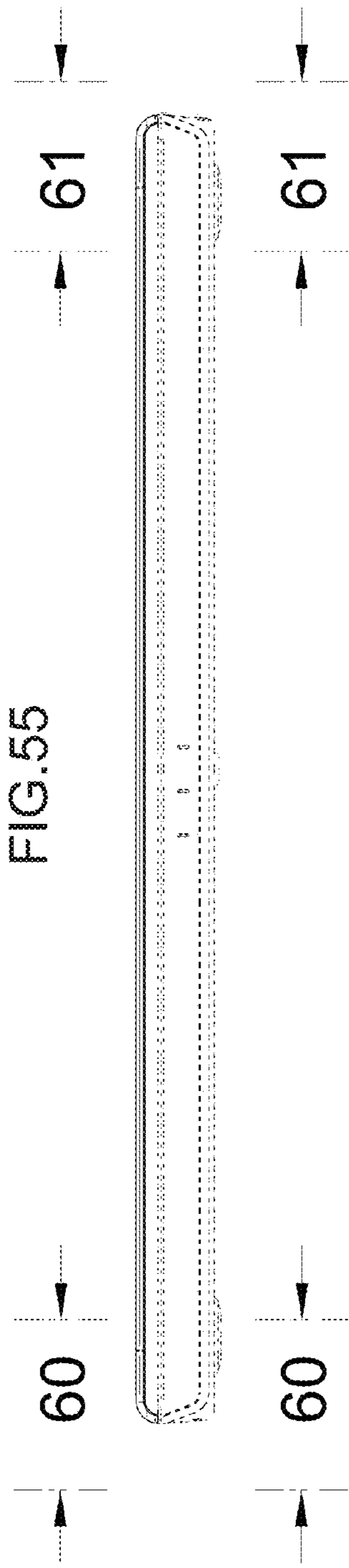

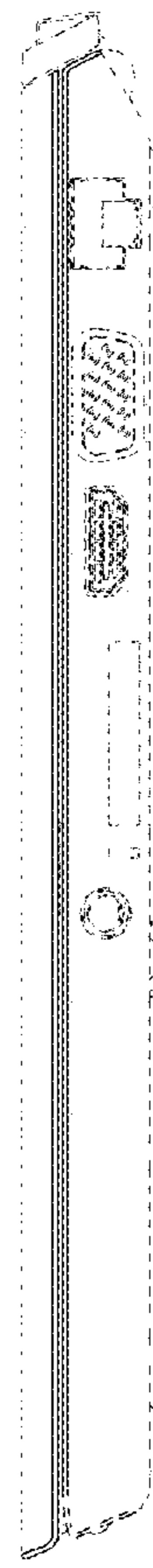

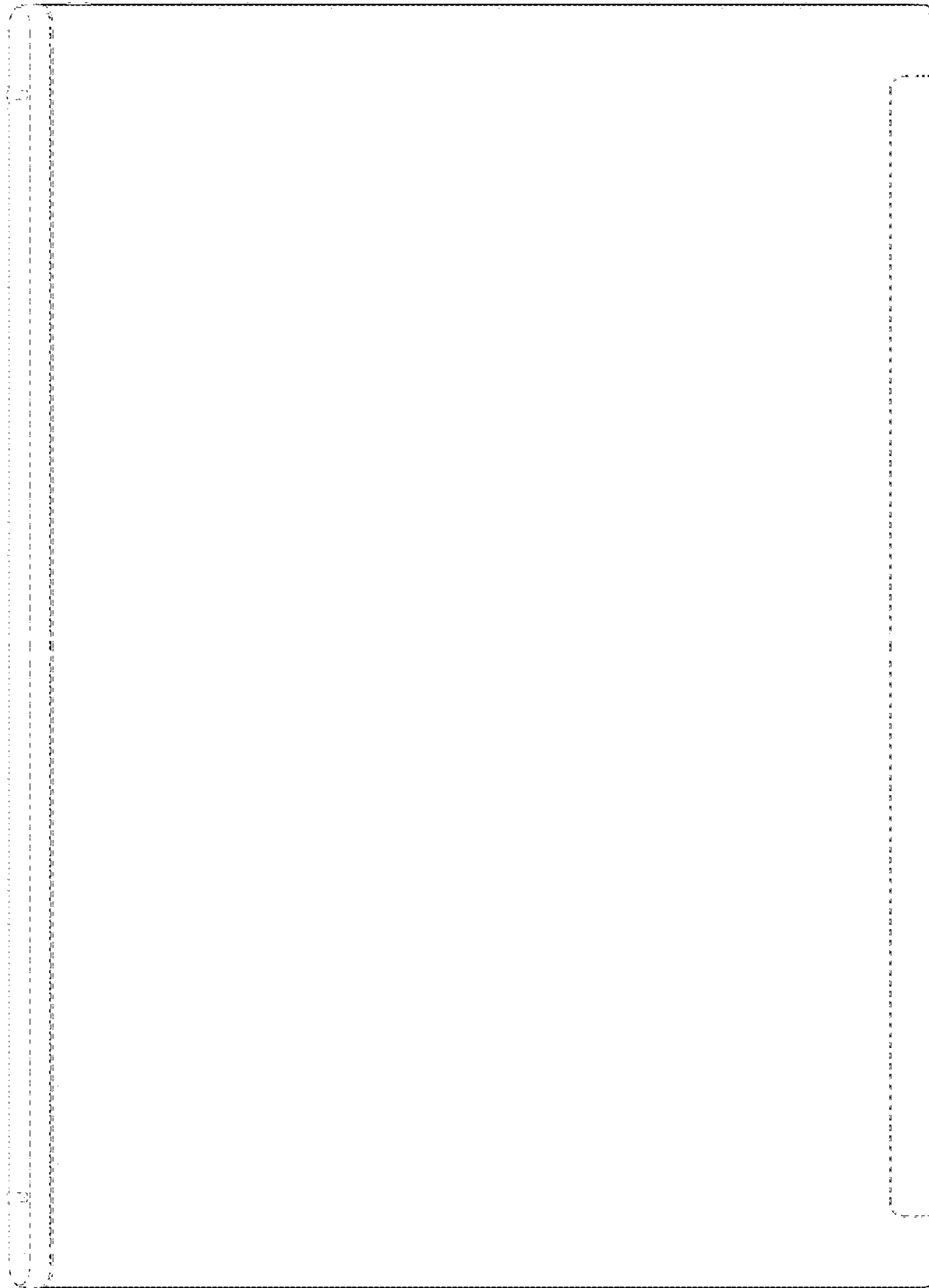

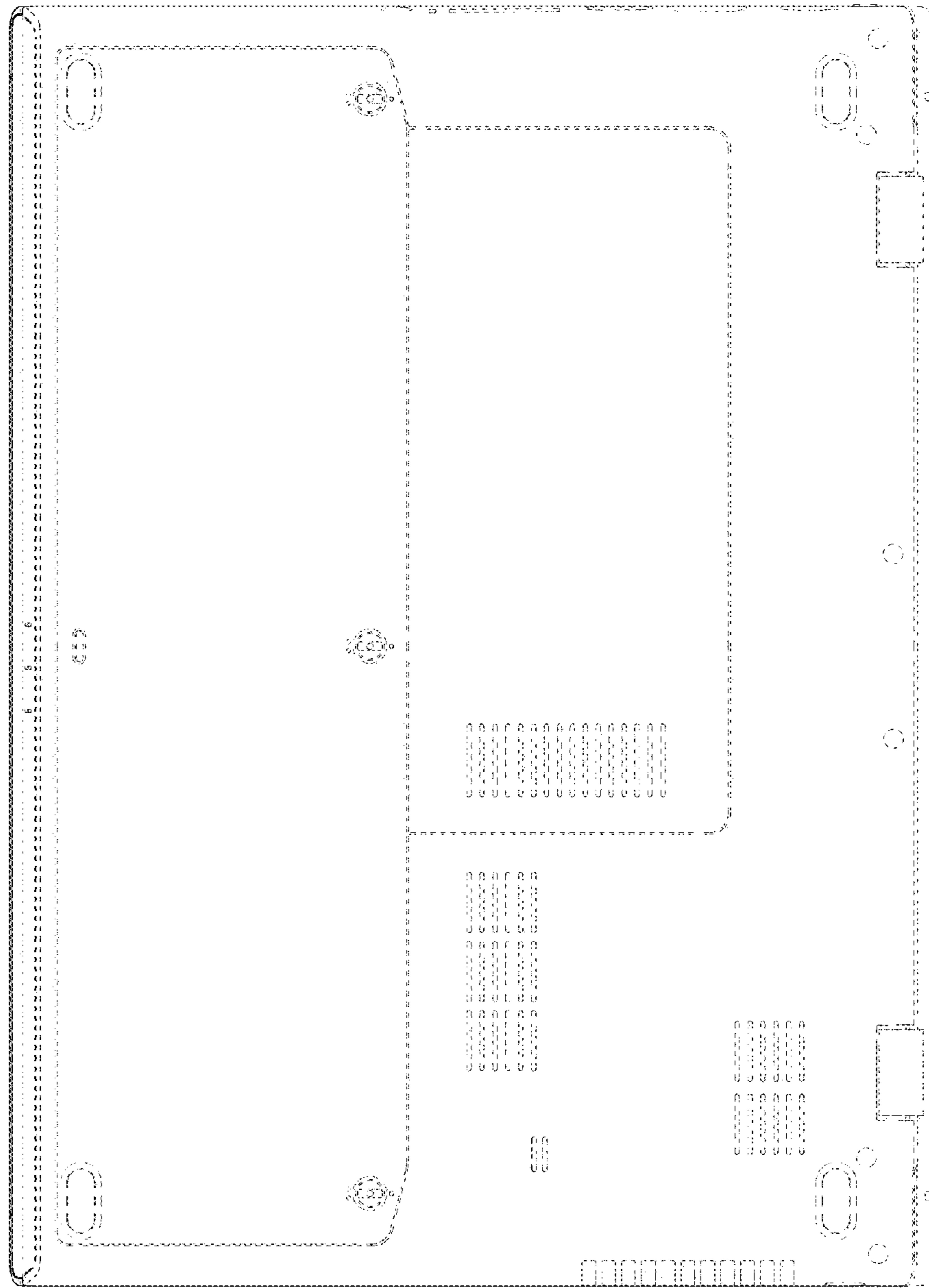

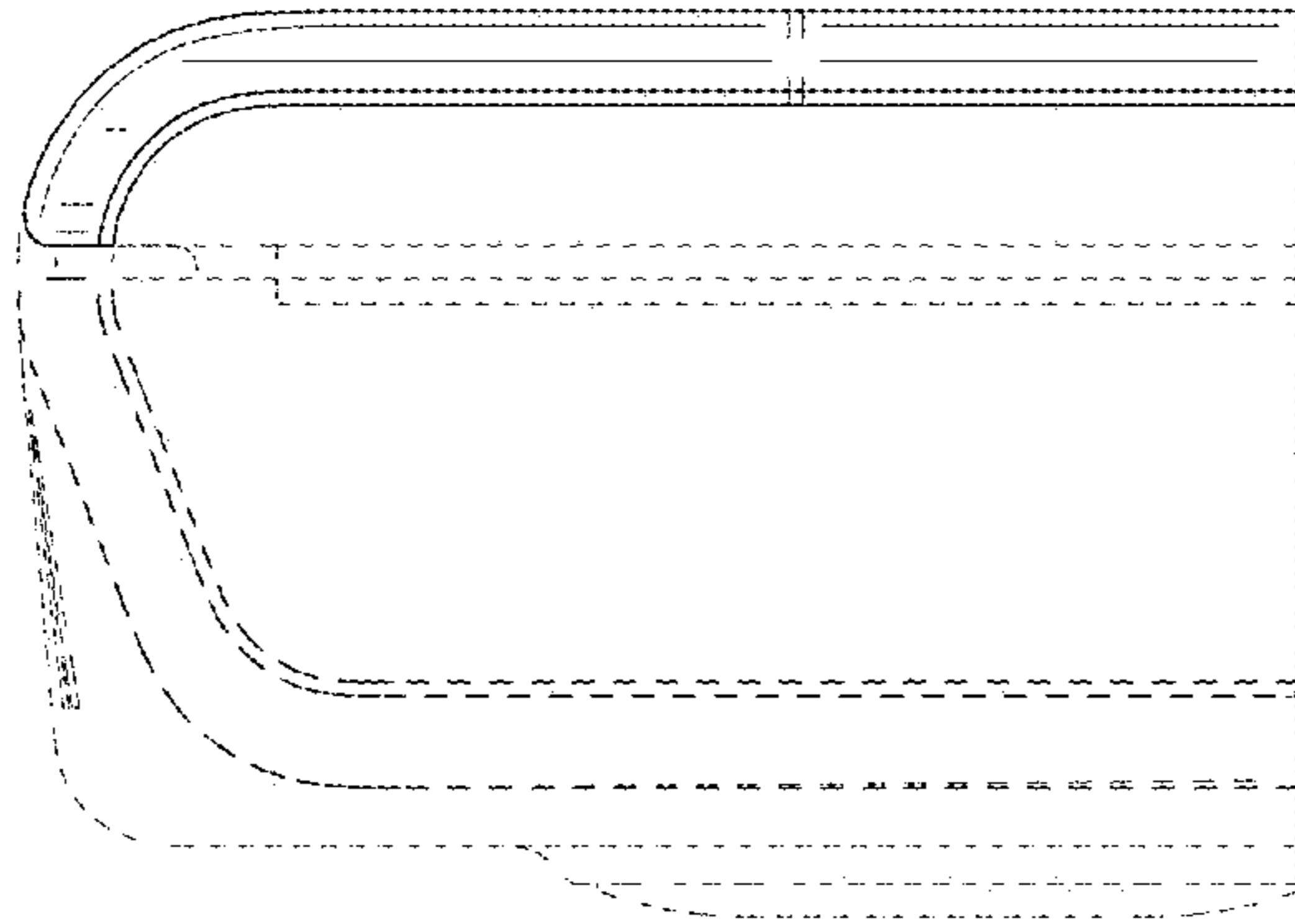
