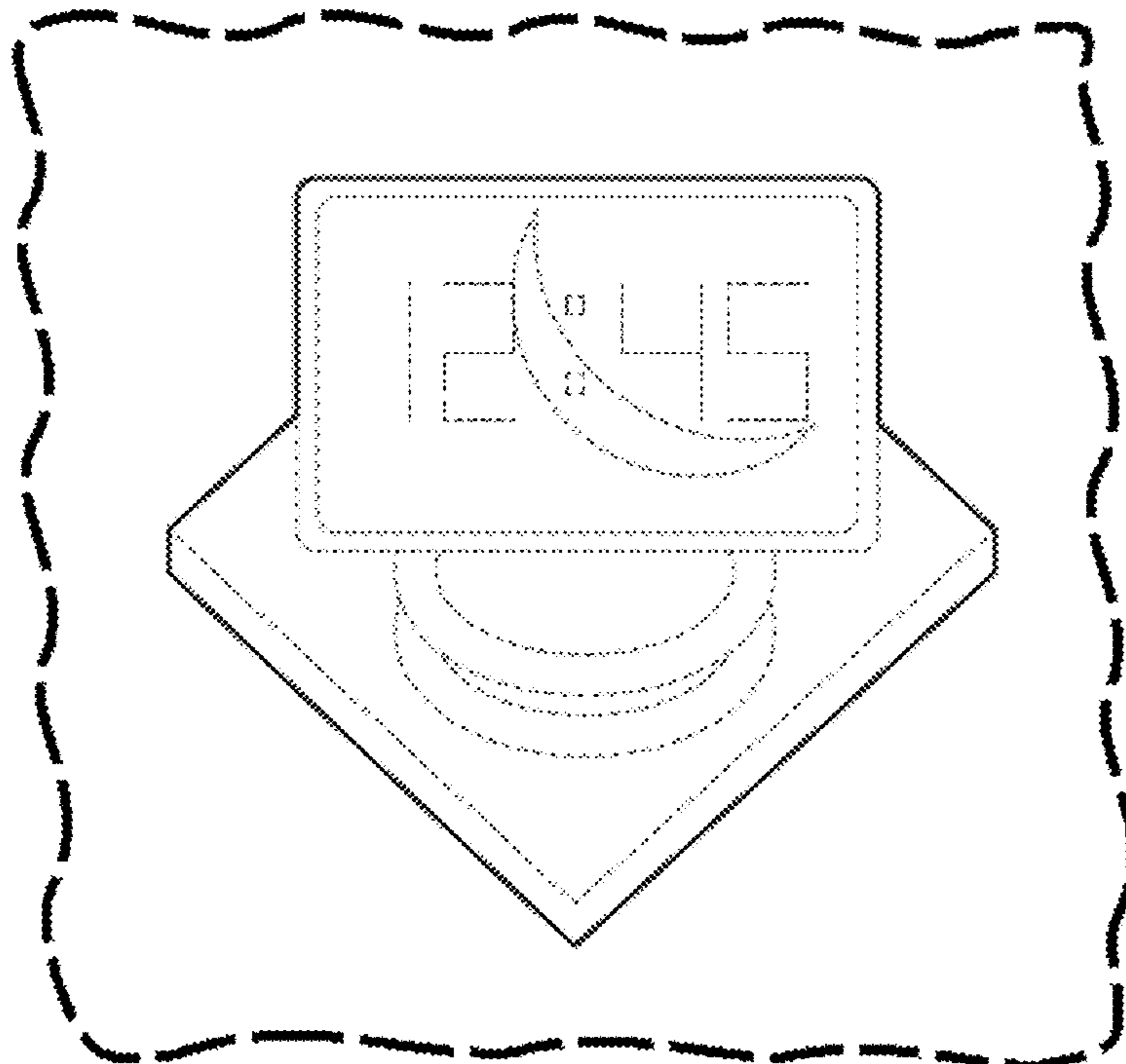
(57) **CLAIM**

The ornamental design for a computing device display screen with computer generated icon, as shown and described.

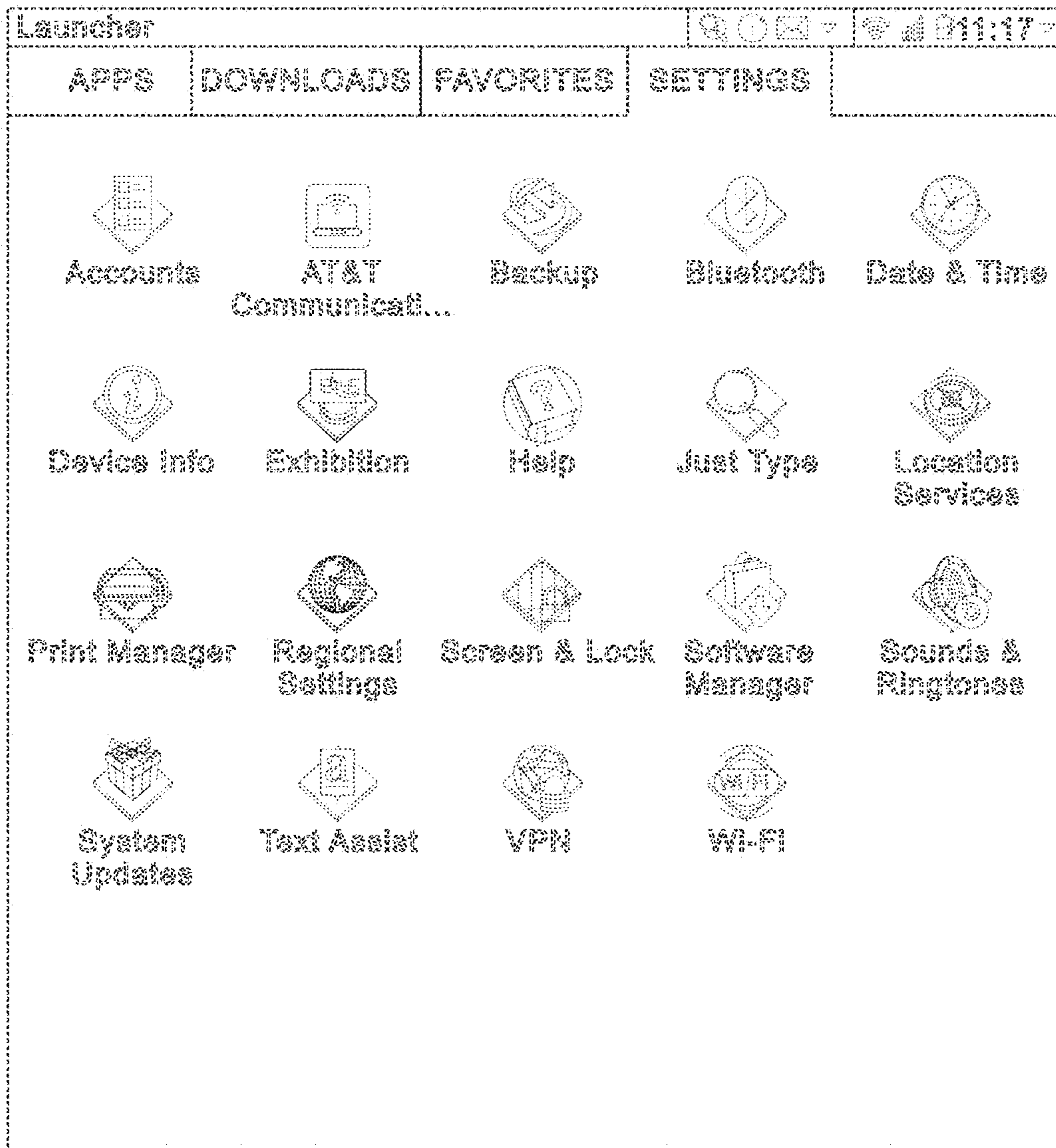

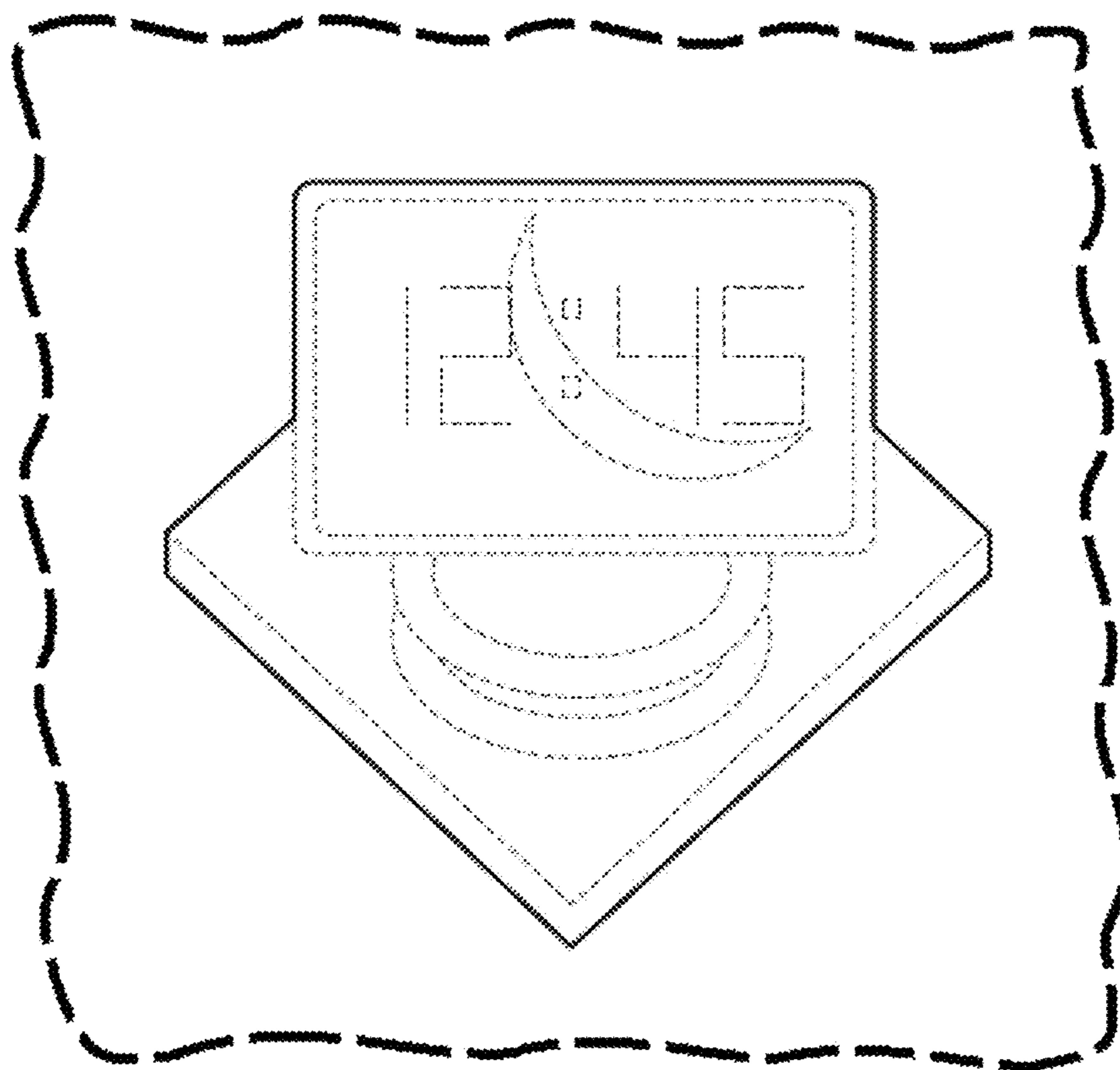
