DESCRIPTION

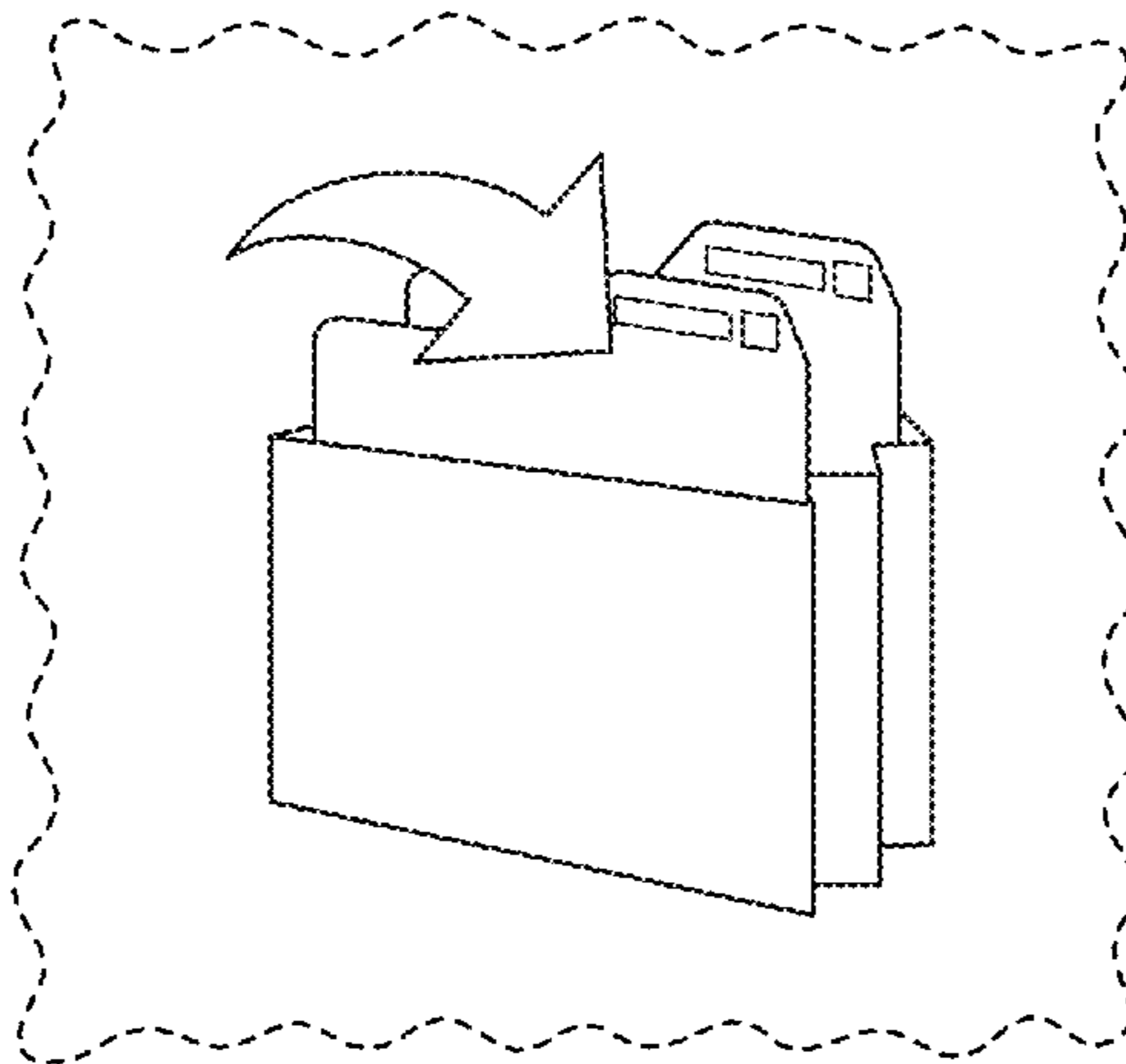
The FIGURE is a front view of a display screen with icon showing the new design.
