(57) **CLAIM**

We claim the ornamental design for a holder for a digital video camera, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a holder for a digital video camera of the present invention;  
FIG. 2 is a front view thereof;

FIG. 4 is a first side view thereof;  
FIG. 5 is a second side view thereof;

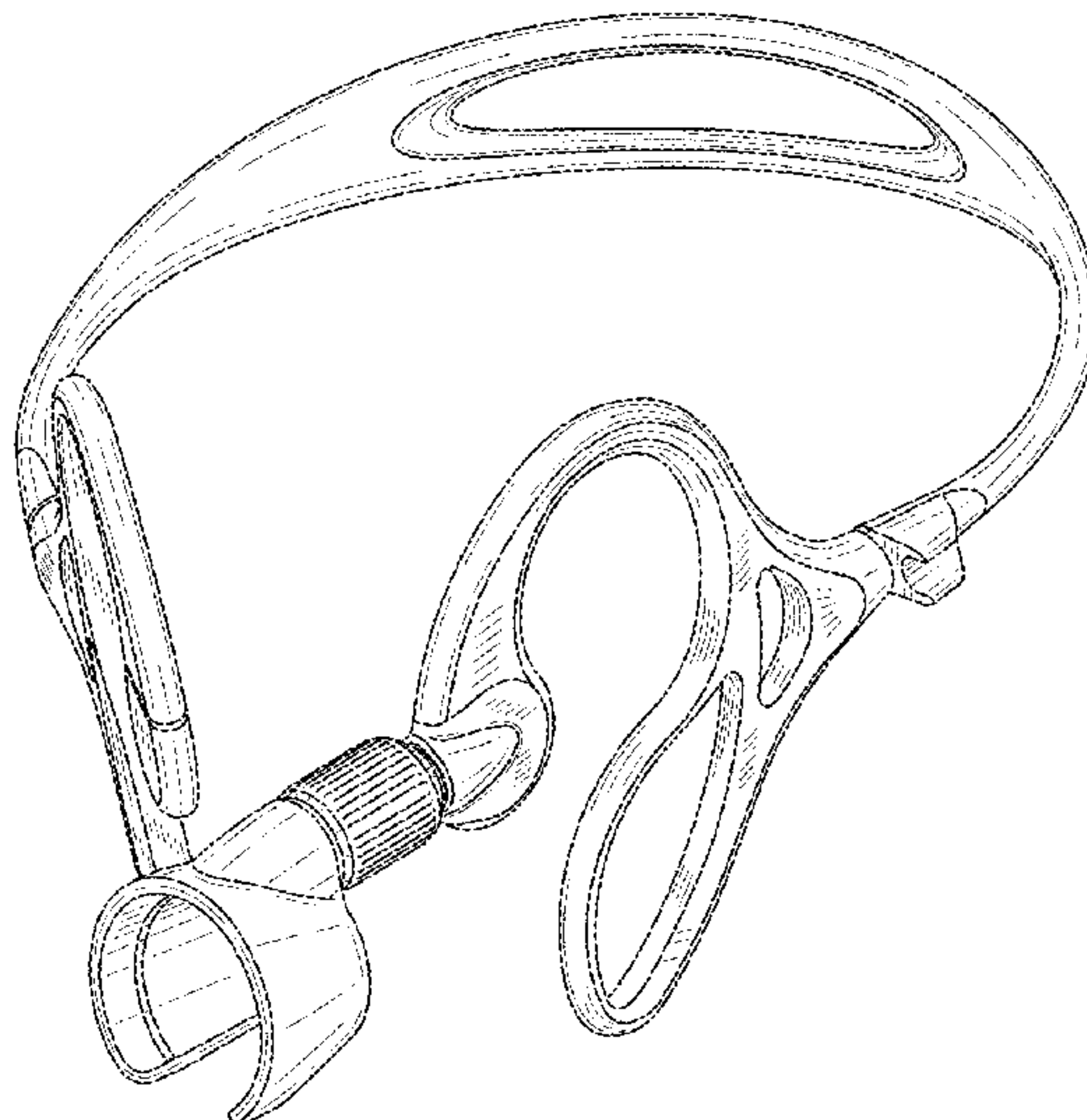

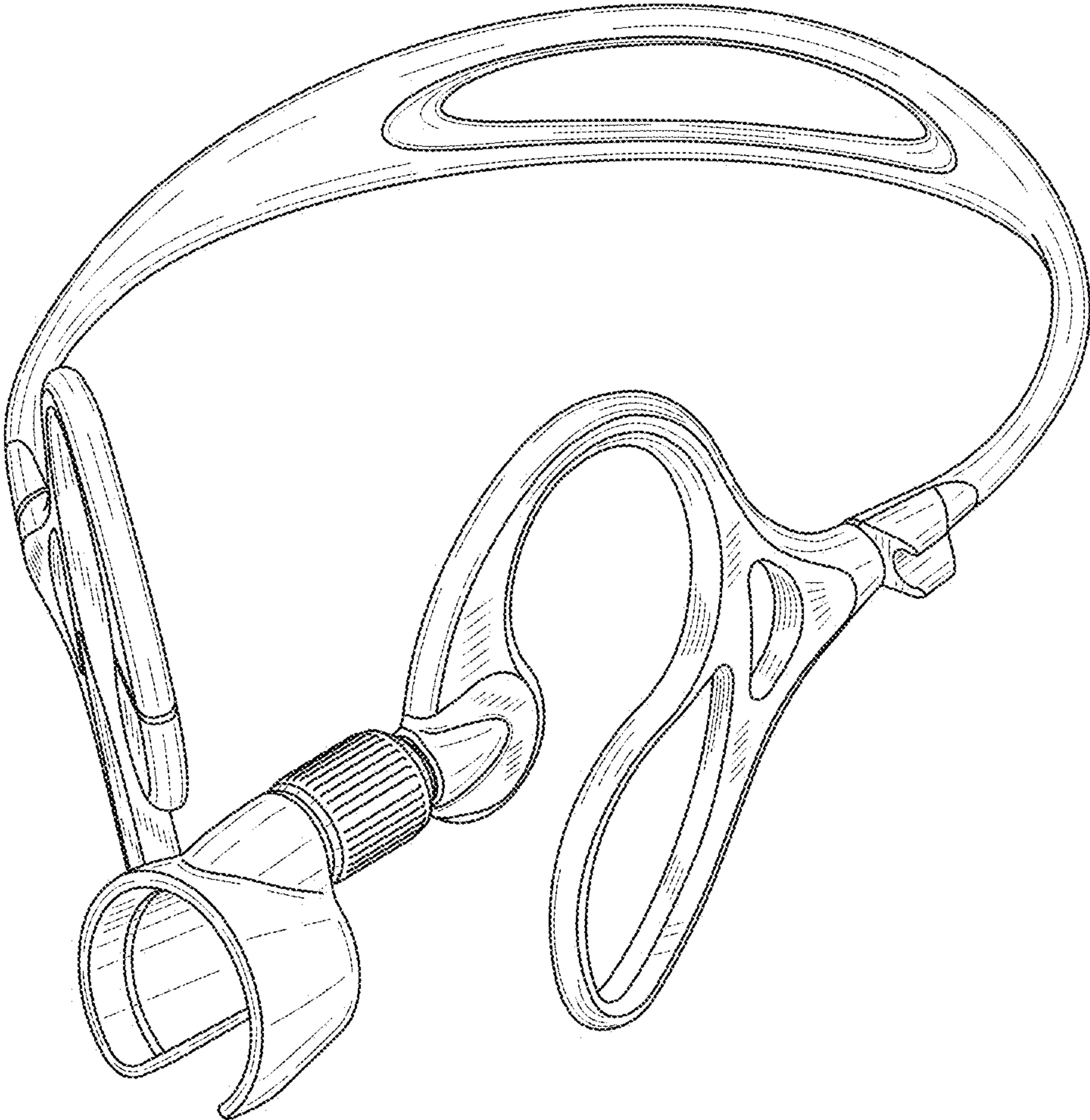

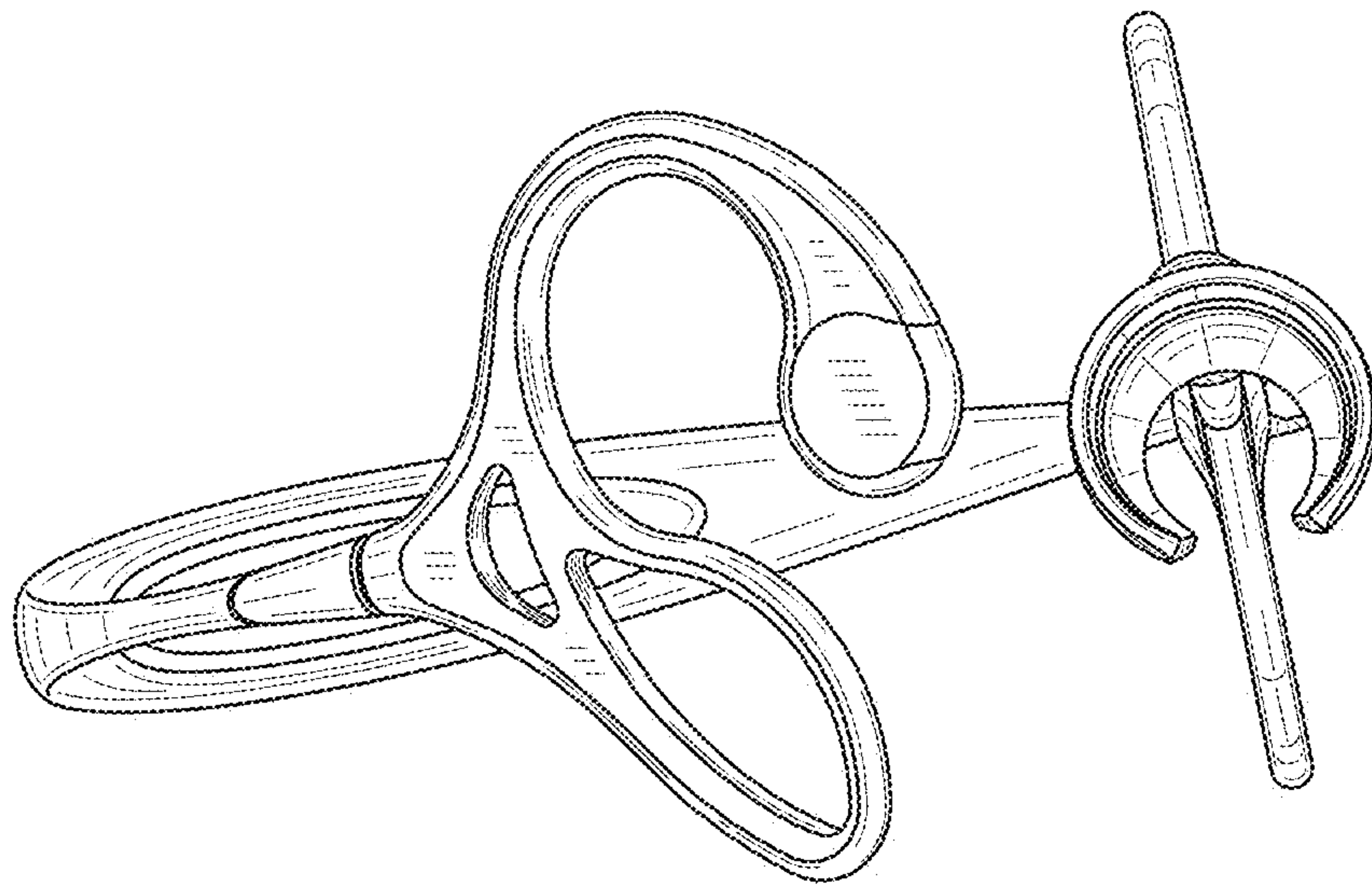

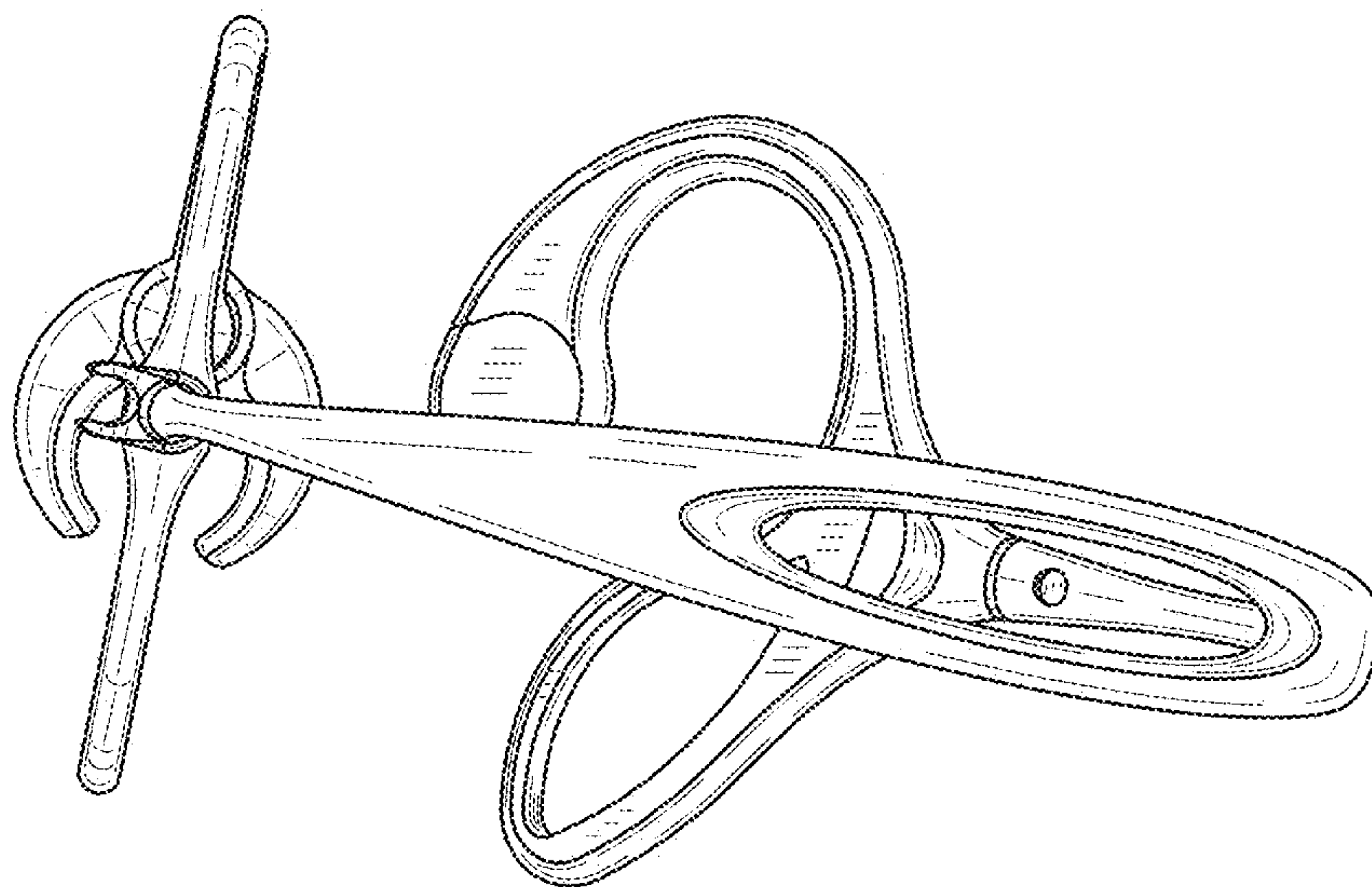

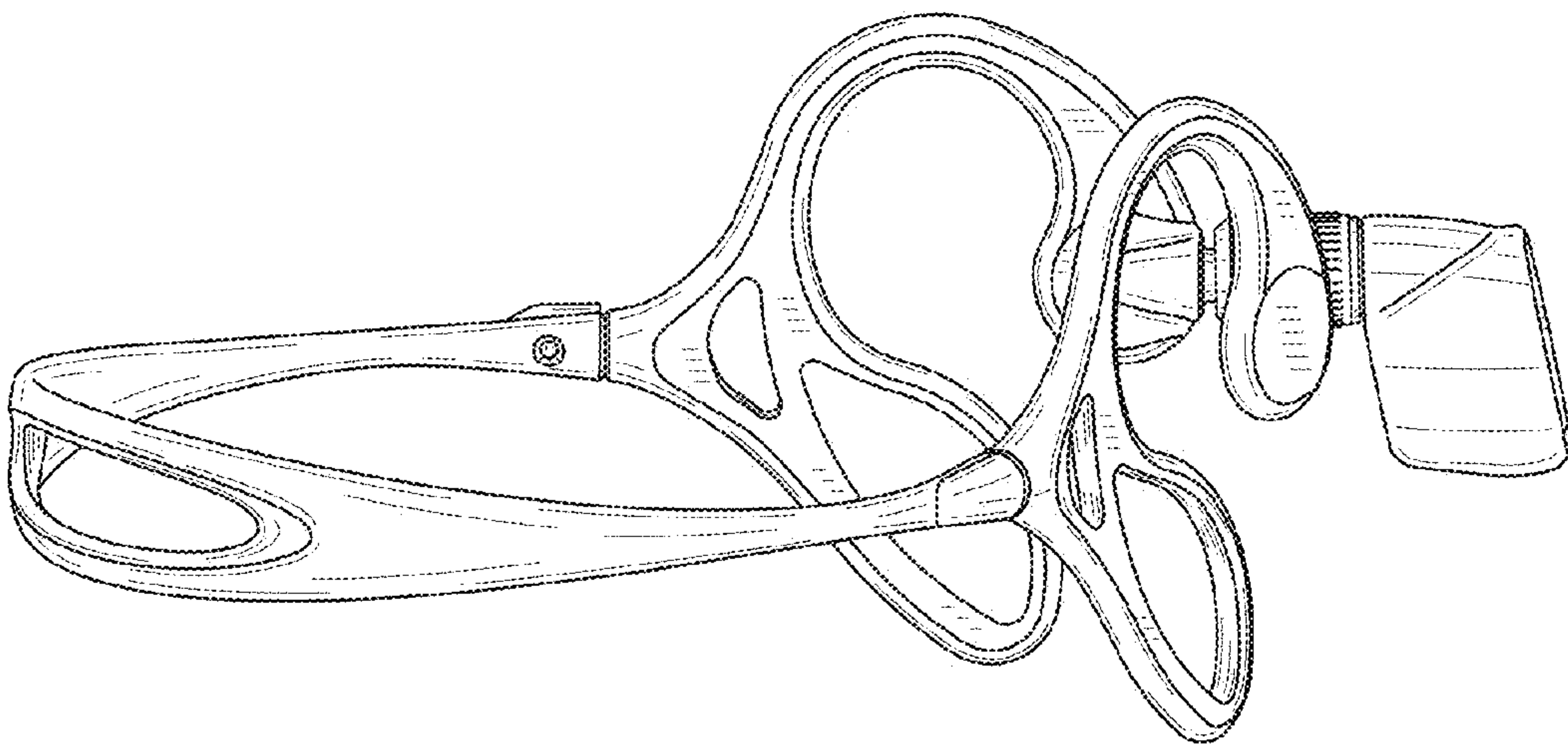

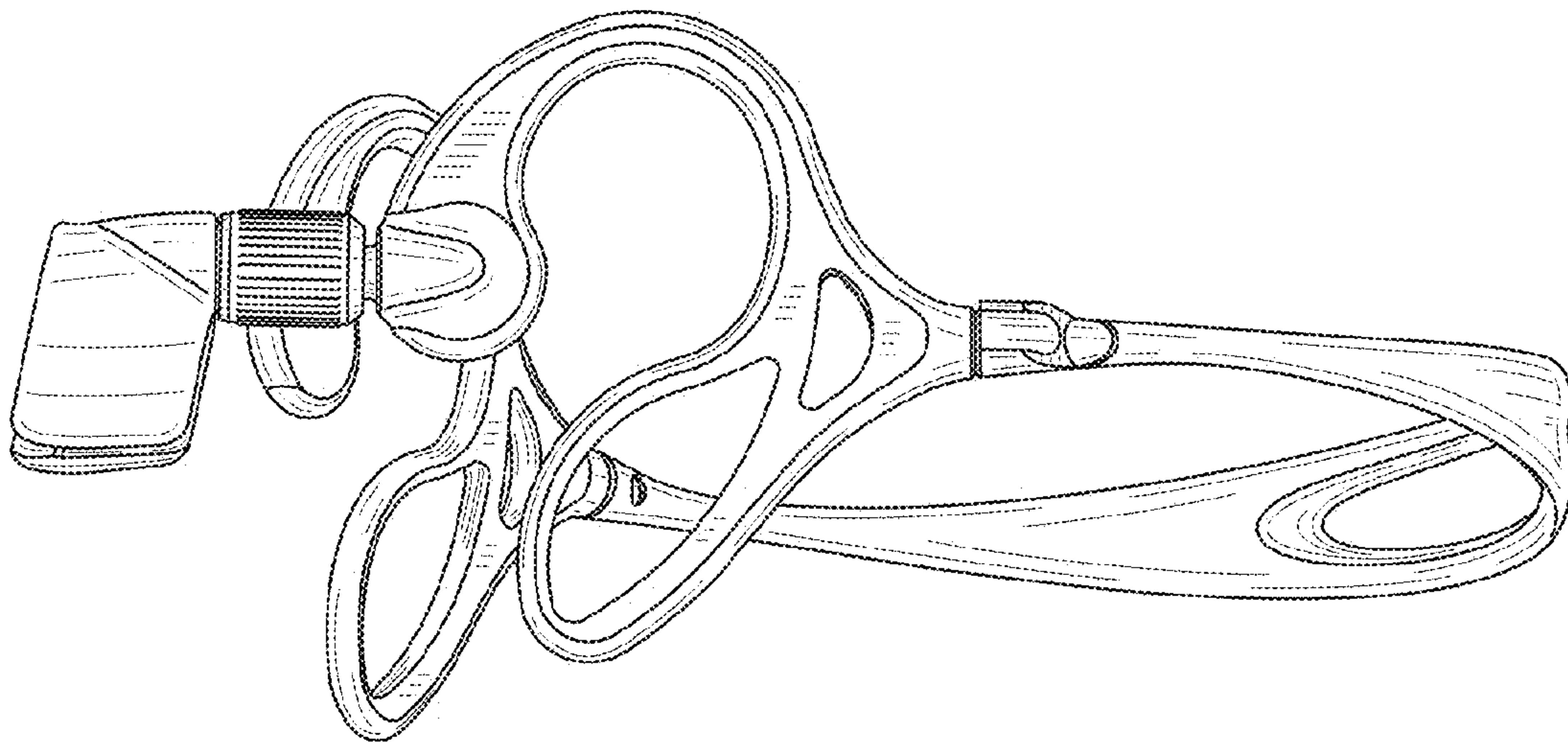

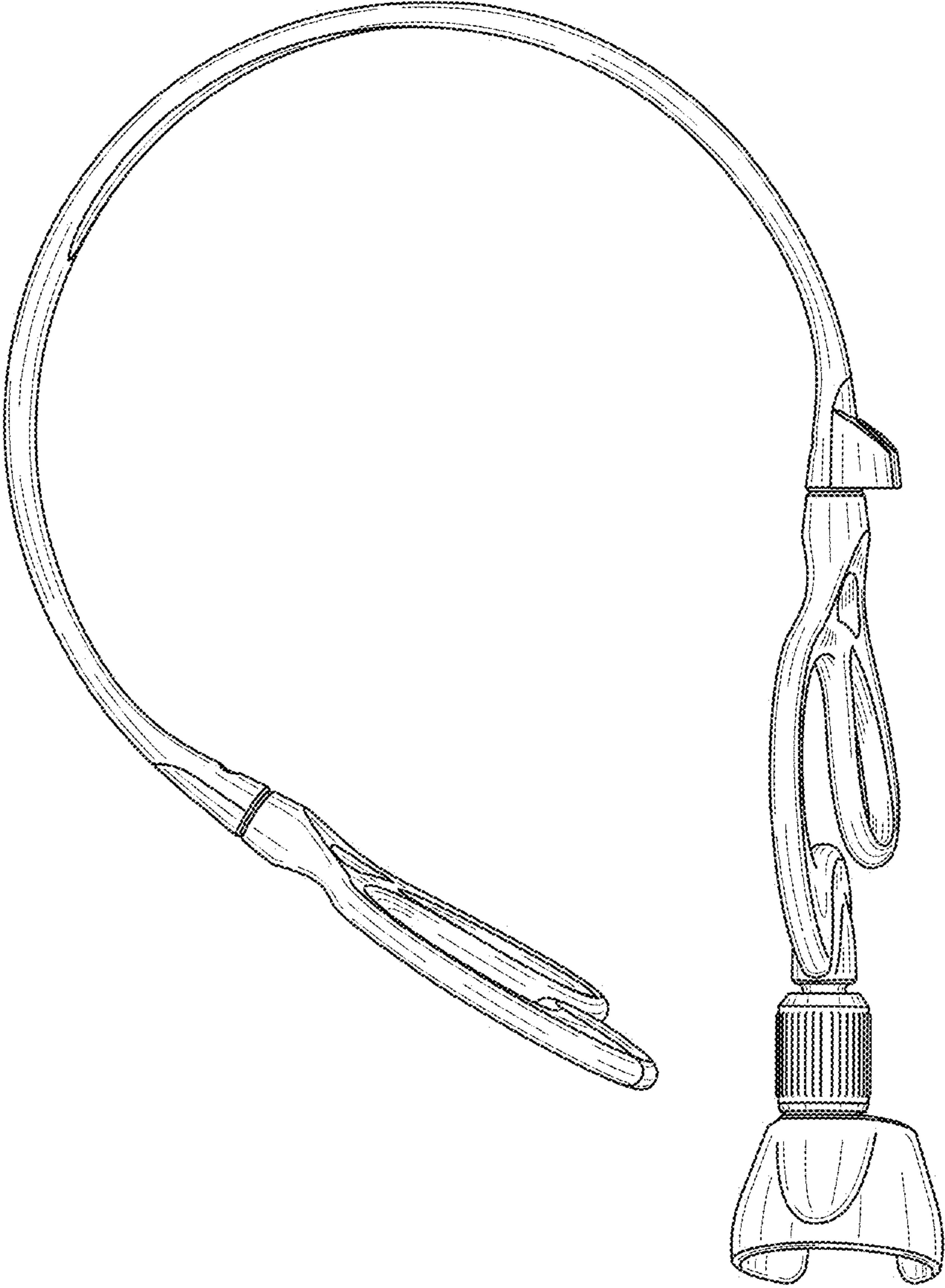

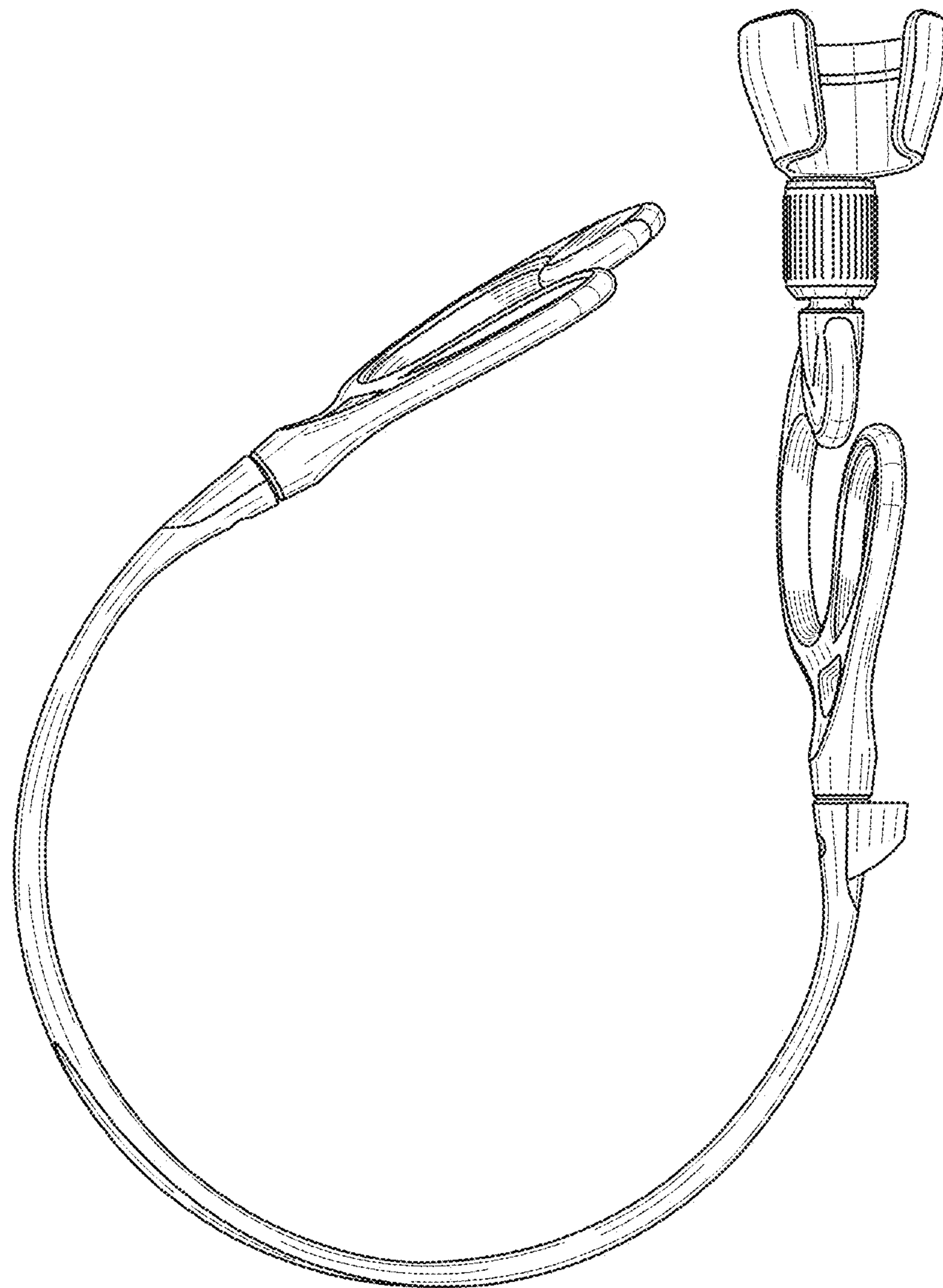
