(57) **CLAIM**

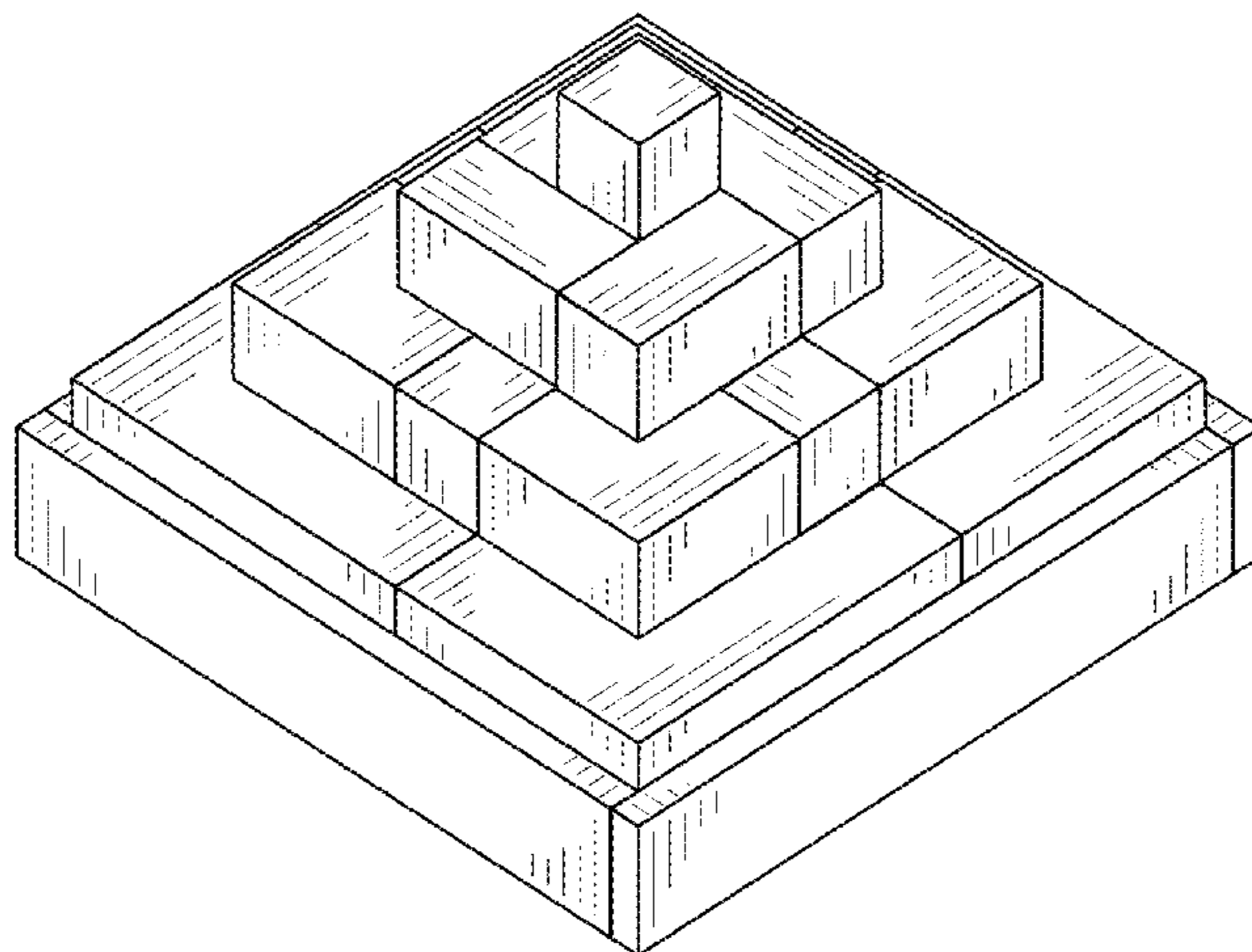
The ornamental design for a set of toy blocks, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a set of toy blocks, showing the new design in an assembled configuration;
FIG. 2 is a front elevational view thereof, a base omitted for clarity of illustration, the rear elevational view, left-side elevational view, and right-side elevational view all being a mirror image thereof;
FIG. 3 is a top plan view of FIG. 2;
FIG. 4 is a bottom plan view of FIG. 2;

FIG. 5 is a perspective view of the base, the blocks omitted for clarity of illustration;
FIG. 6 is a front elevational view of FIG. 5, the rear elevational view, left-side elevational view, and right-side elevational view all being a mirror image thereof;
FIG. 7 is a top plan view of FIG. 5;
FIG. 8 is a bottom plan view of FIG. 5;
FIG. 9 is a perspective view of a first block of the design, the remaining blocks and base omitted for clarity of illustration;
FIG. 10 is a front elevational view of FIG. 9;
FIG. 11 is a rear elevational view of FIG. 9;
FIG. 12 is a left-side elevational view of FIG. 9;
FIG. 13 is a right-side elevational view of FIG. 9;
FIG. 14 is a top plan view of FIG. 9, the bottom plan view being a mirror image thereof;
FIG. 15 is a perspective view of a second block of the design, the remaining blocks and base omitted for clarity of illustration;
FIG. 16 is a front elevational view of FIG. 15, the right-side elevational view being a mirror image thereof;
FIG. 17 is a left-side elevational view of FIG. 15, the rear elevational view being a mirror image thereof;
FIG. 18 is a top plan view of FIG. 15;
FIG. 19 is a bottom plan view of FIG. 15;
FIG. 20 is a perspective view of a third block of the design, the remaining blocks and base omitted for clarity of illustration;
FIG. 21 is a front elevational view of FIG. 20, the rear elevational view, left-side elevational view, and right-side elevational view all being a mirror image thereof;
FIG. 22 is a top plan view of FIG. 20, the bottom plan view being a mirror image thereof;
FIG. 23 is a perspective view of a fourth block of the design, the remaining blocks and base omitted for clarity of illustration;
FIG. 24 is a front elevational view of FIG. 23;
FIG. 25 is a rear elevational view of FIG. 23;
FIG. 26 is a left-side elevational view of FIG. 23;
FIG. 27 is a right-side elevational view of FIG. 23;
FIG. 28 is a top plan view of FIG. 23; and,
FIG. 29 is a bottom plan view of FIG. 23.
Portions of the set of toy blocks shown in broken lines in FIGS. 4 and 8 form no part of the claimed design.

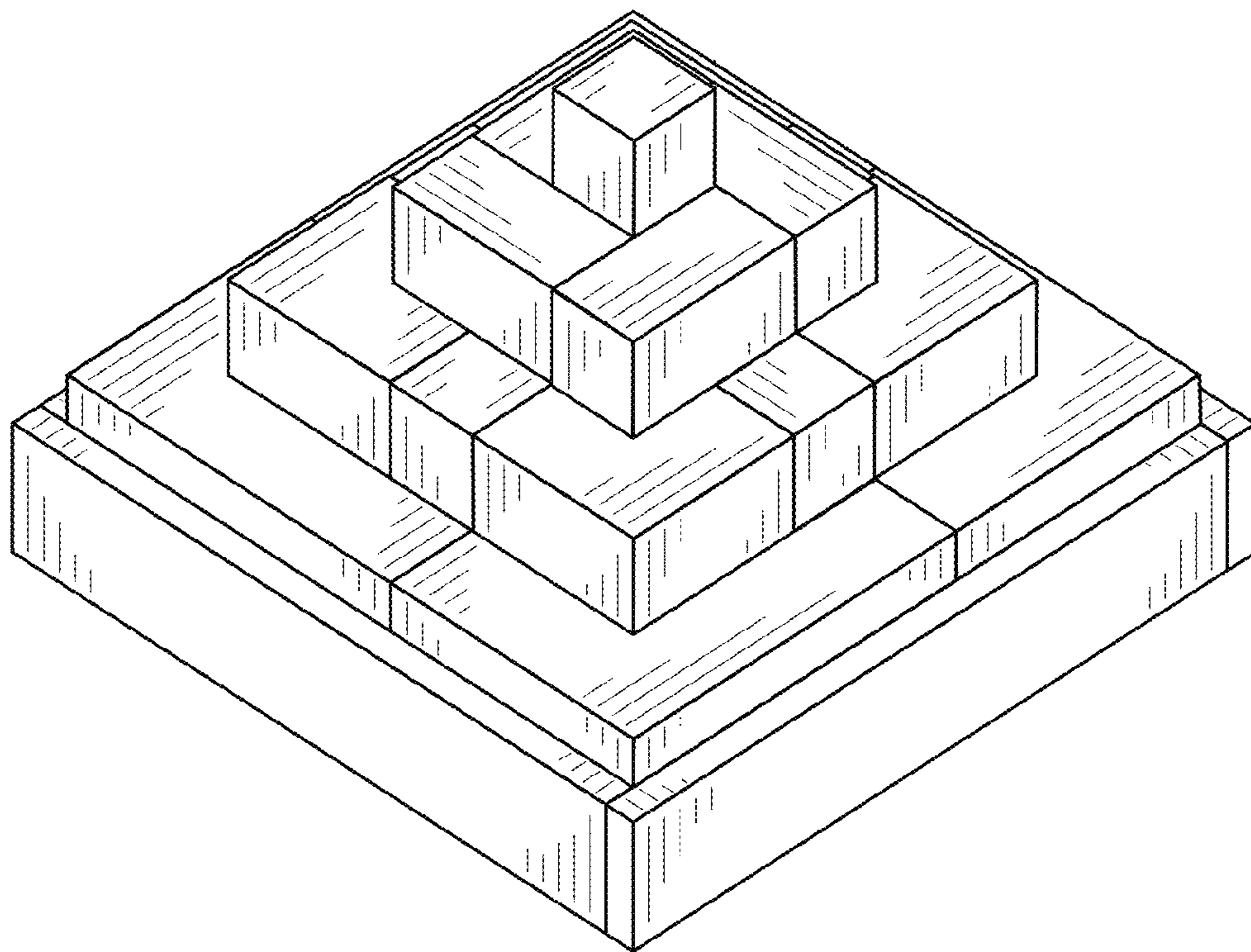

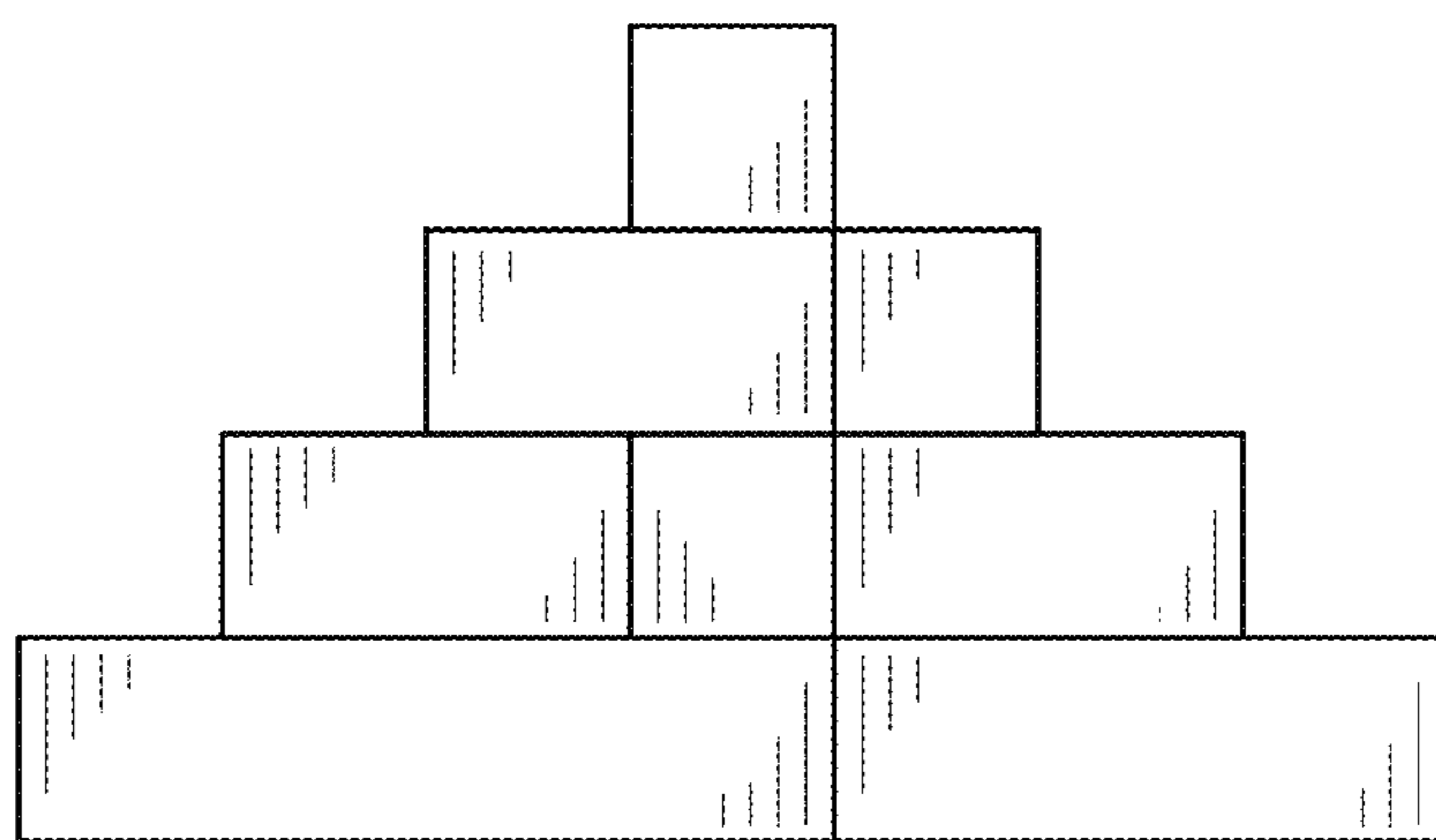

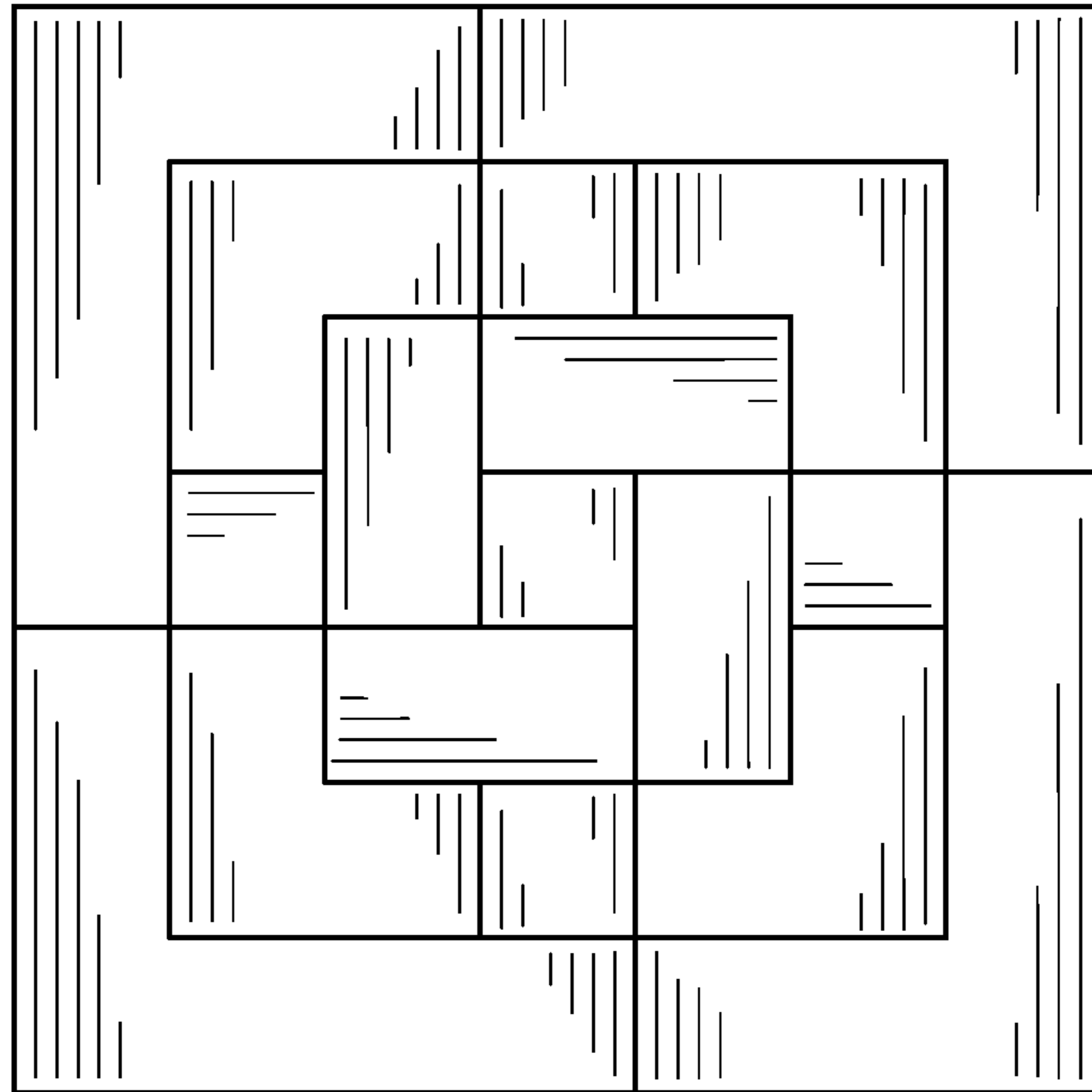

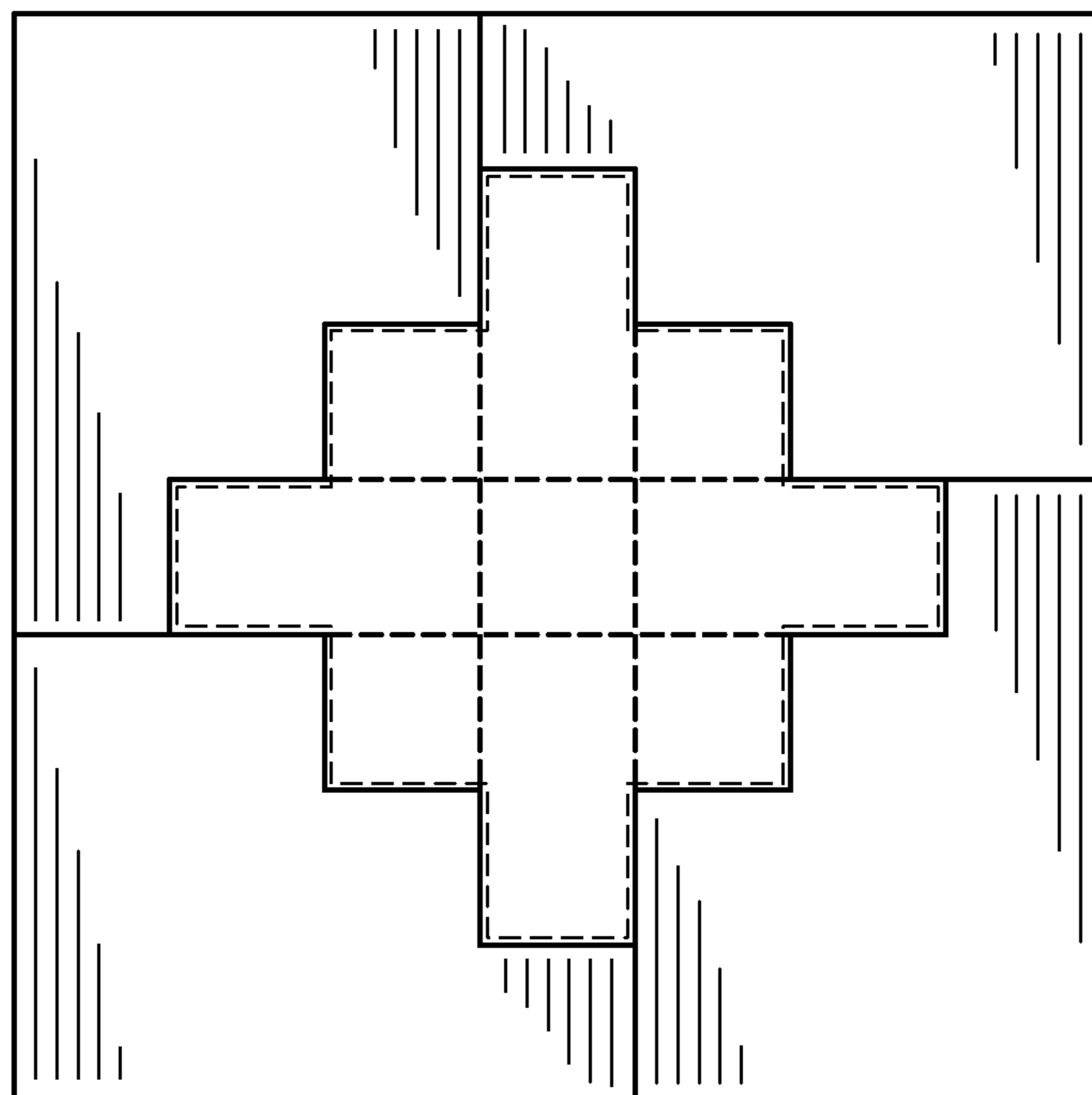

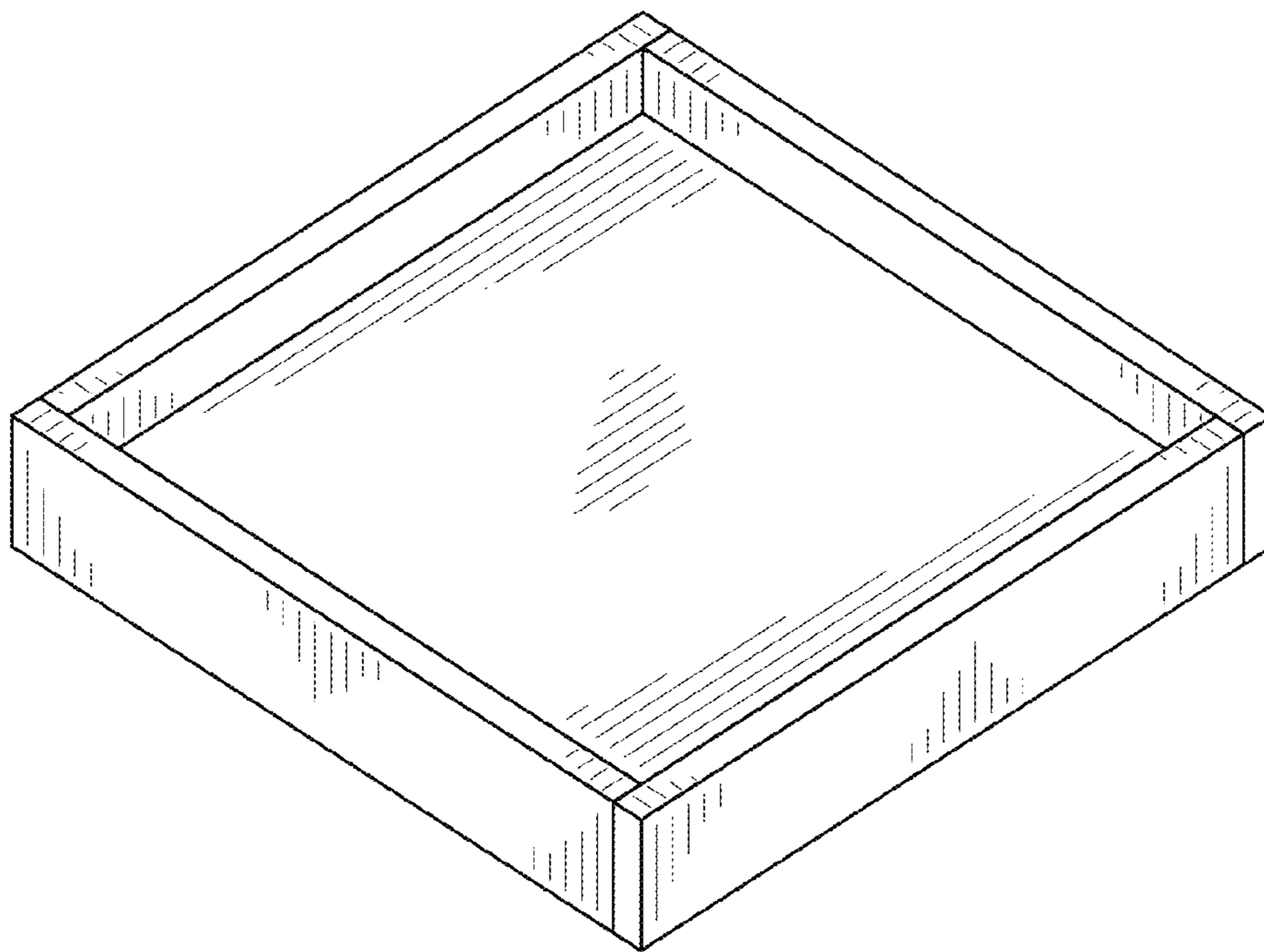

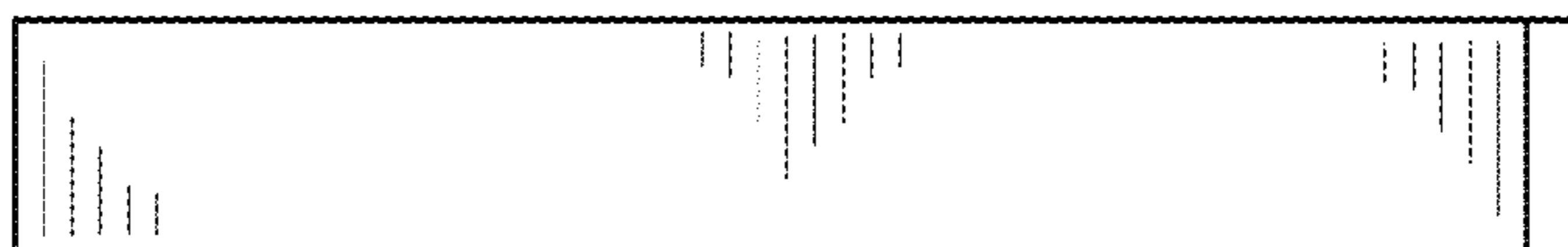

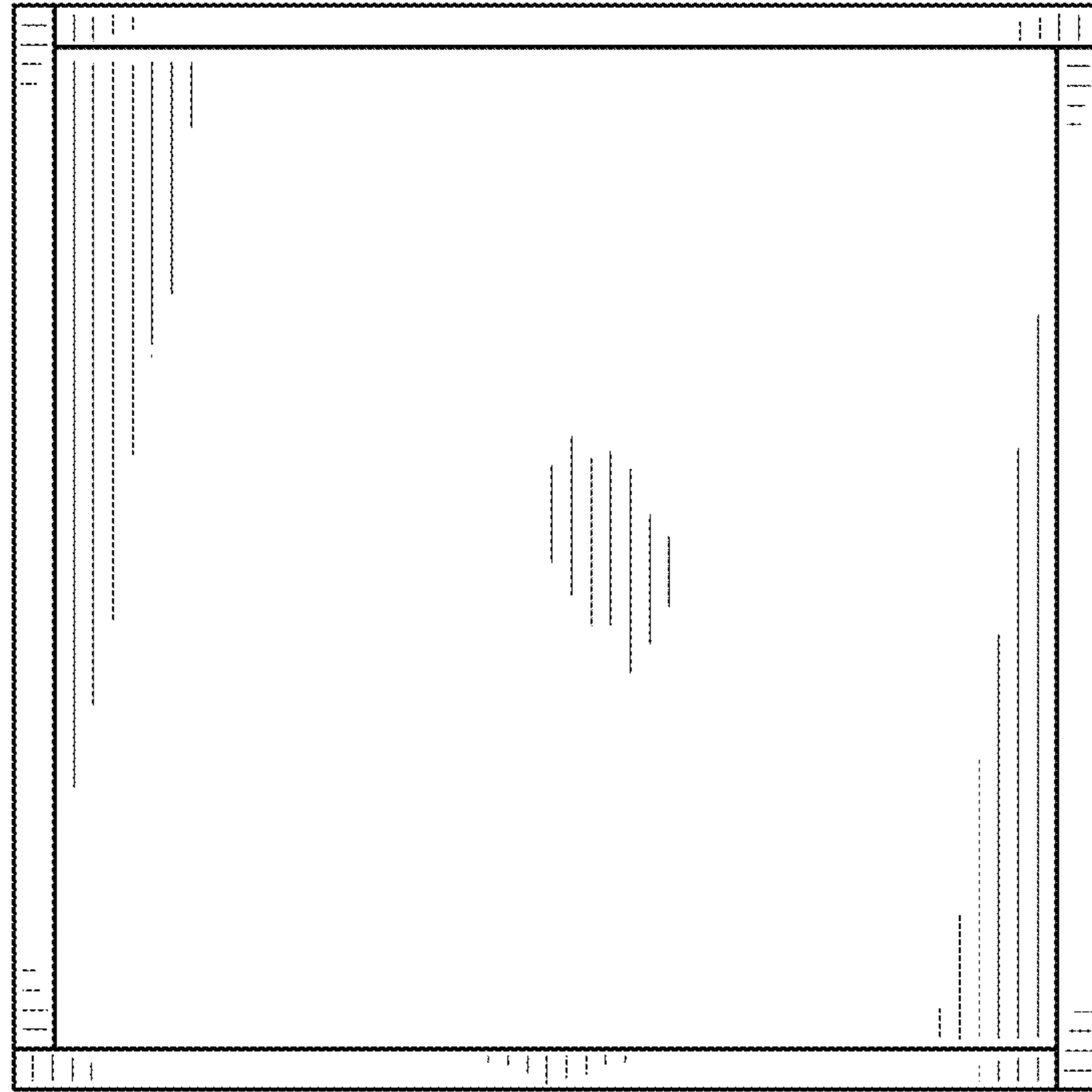

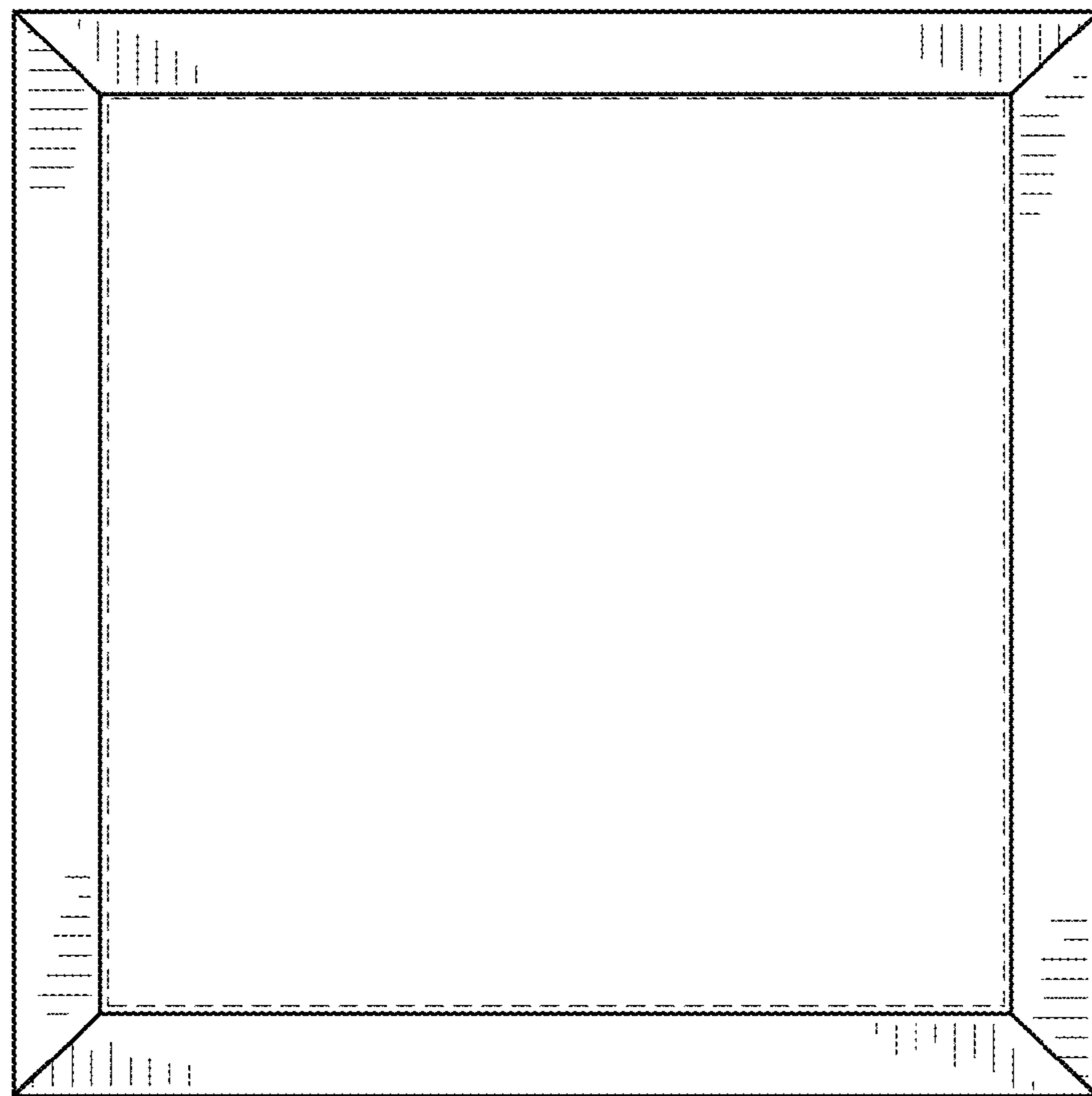

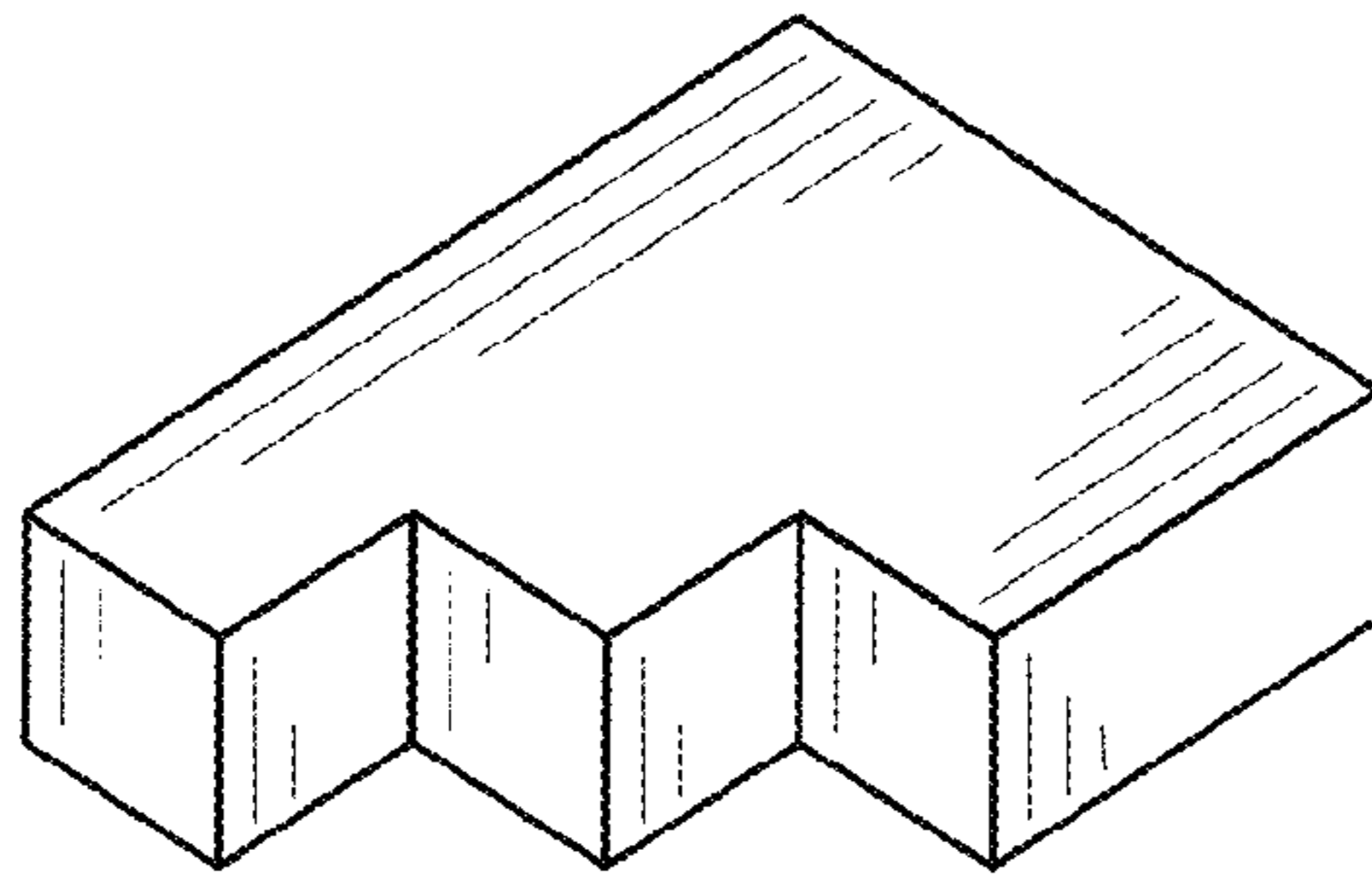

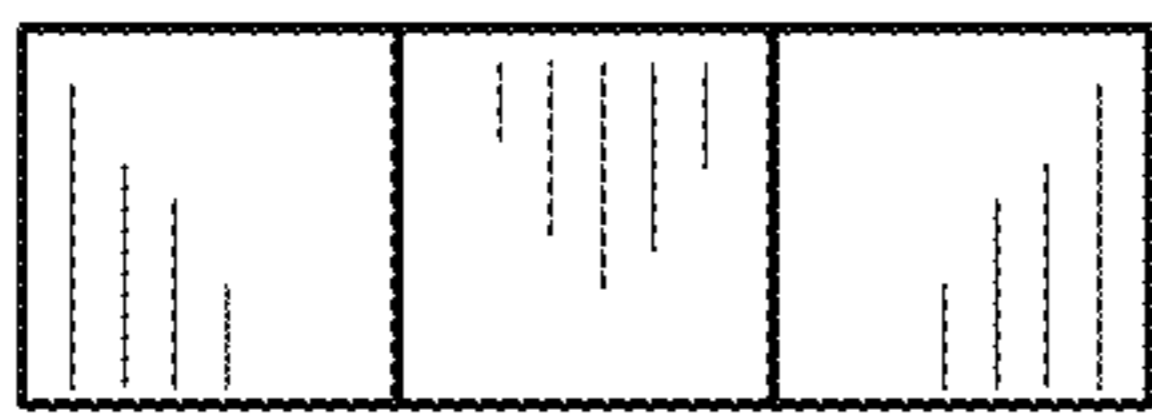

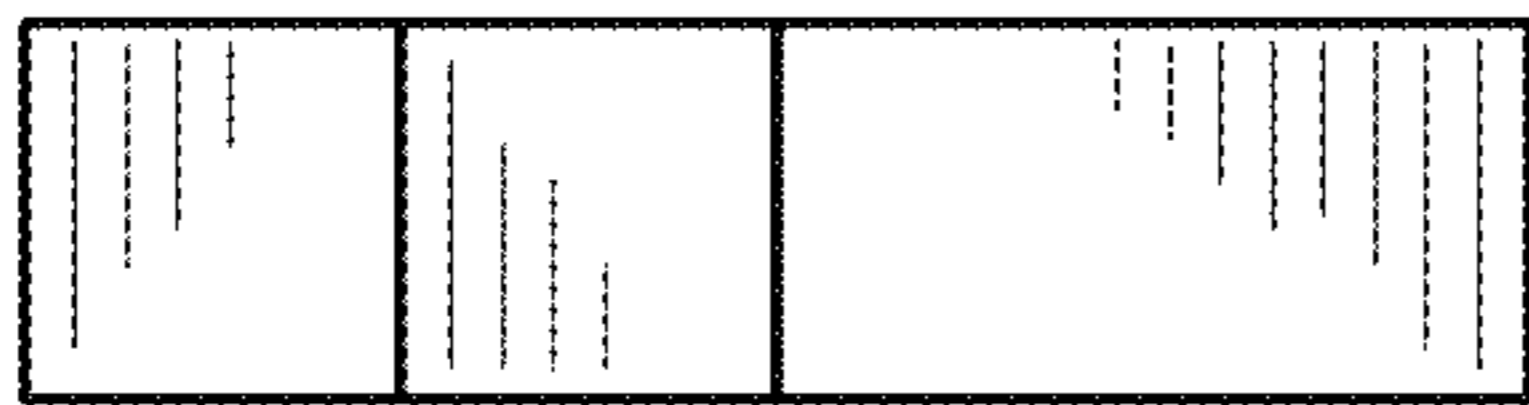

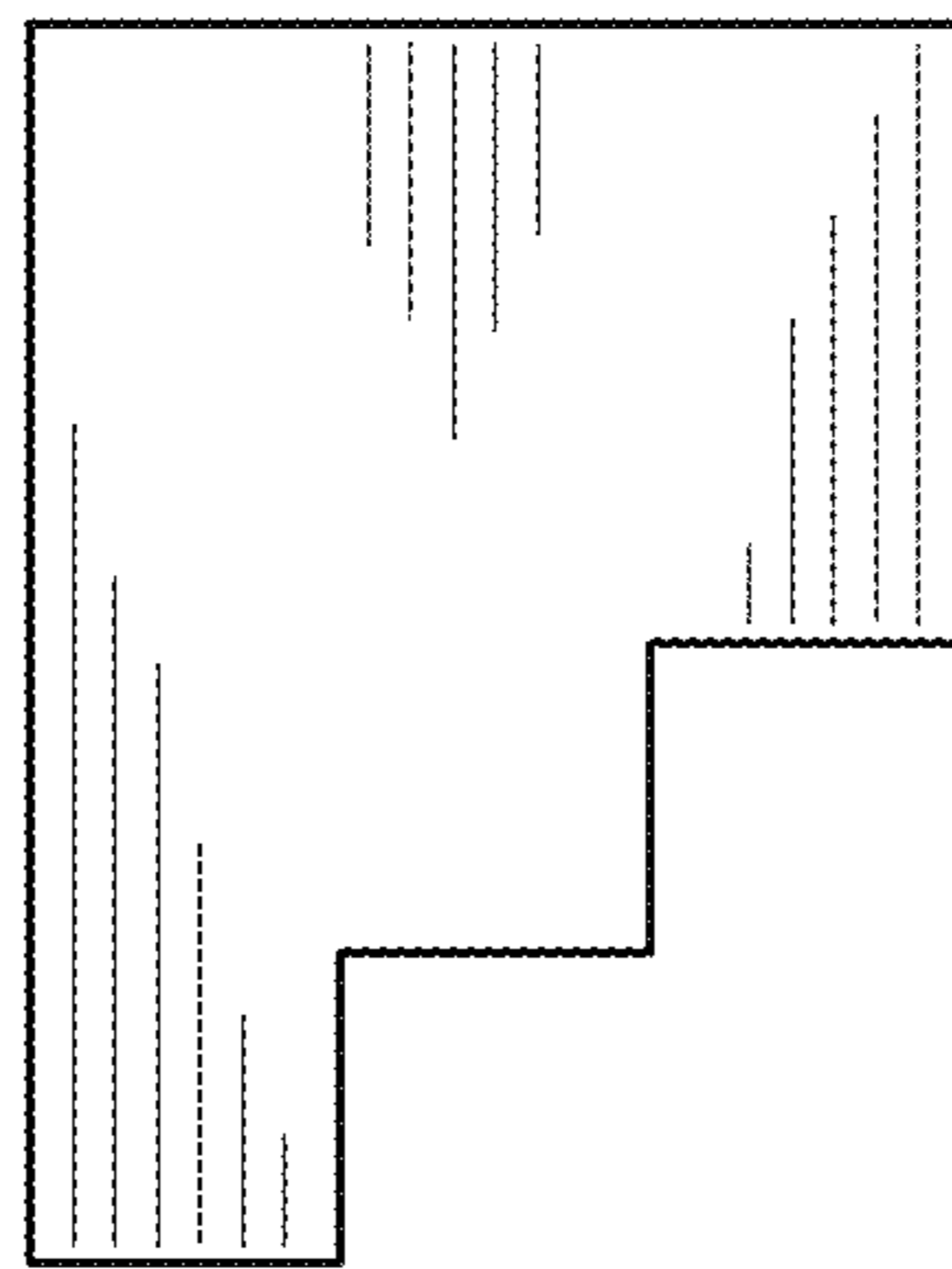

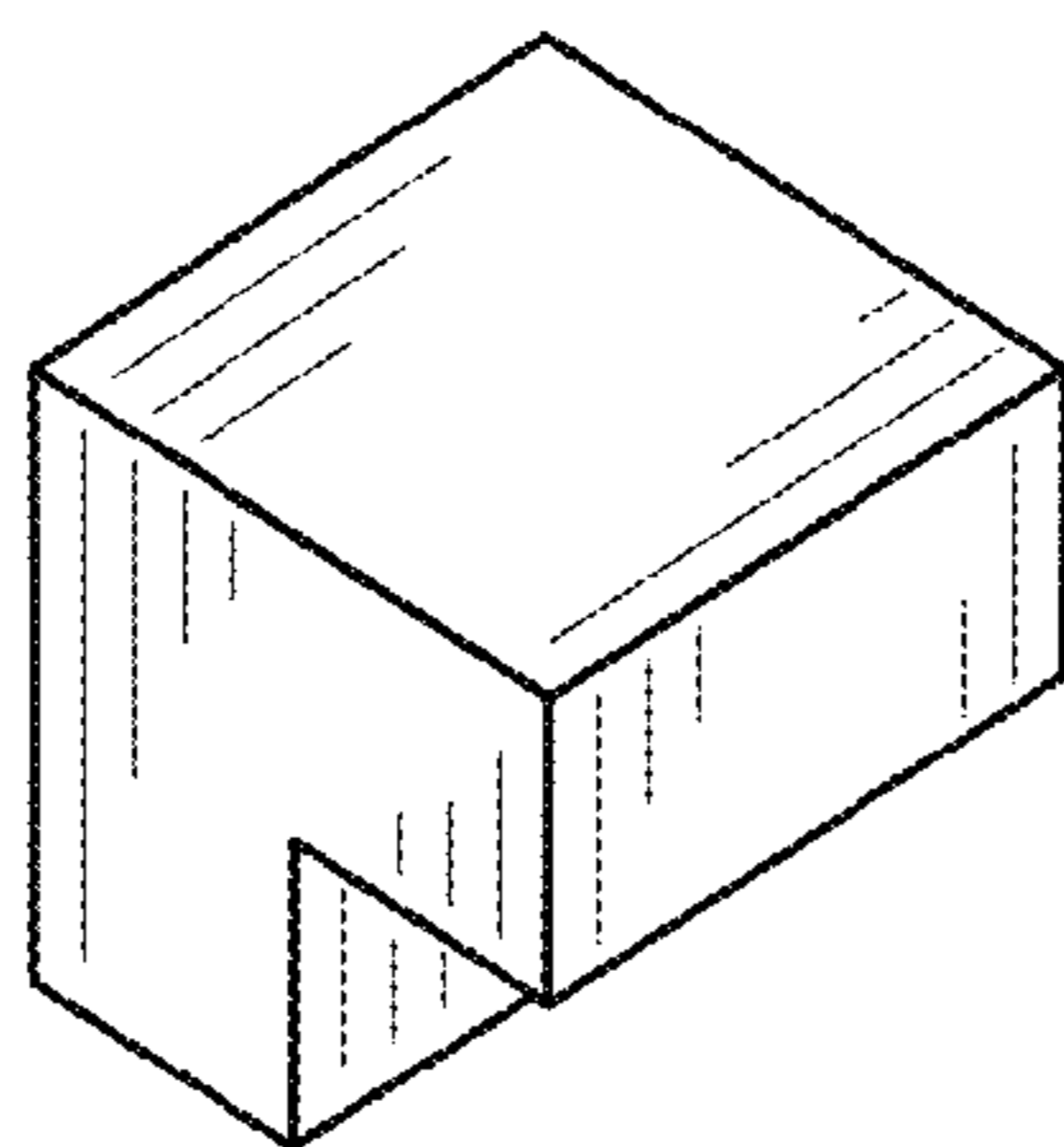

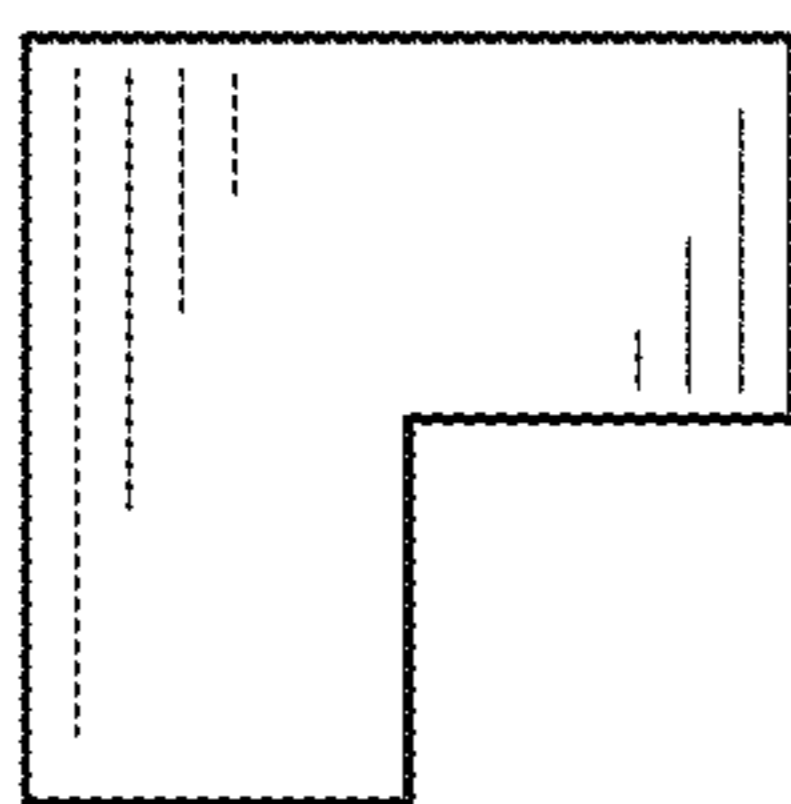

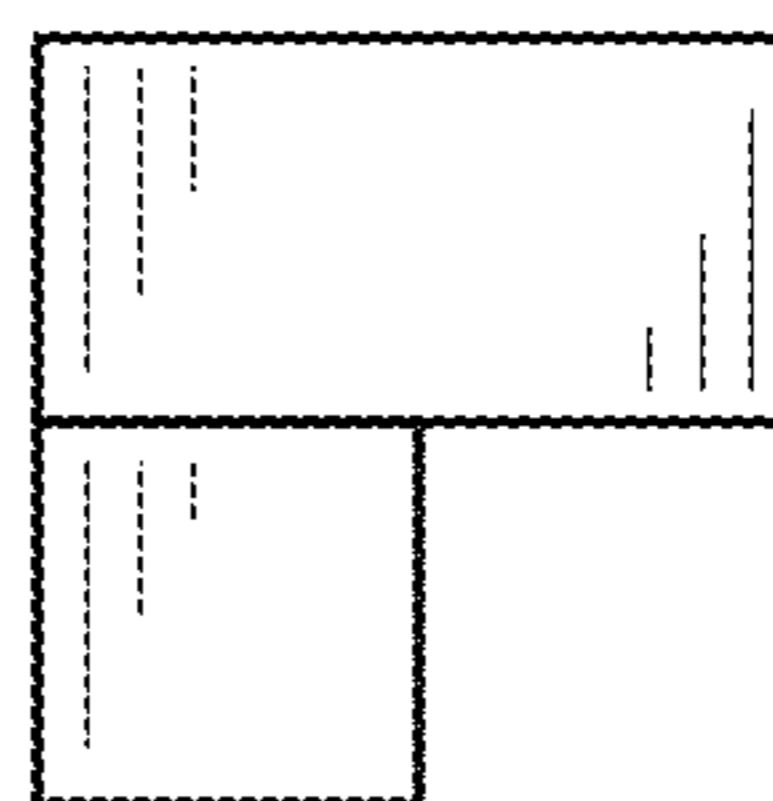

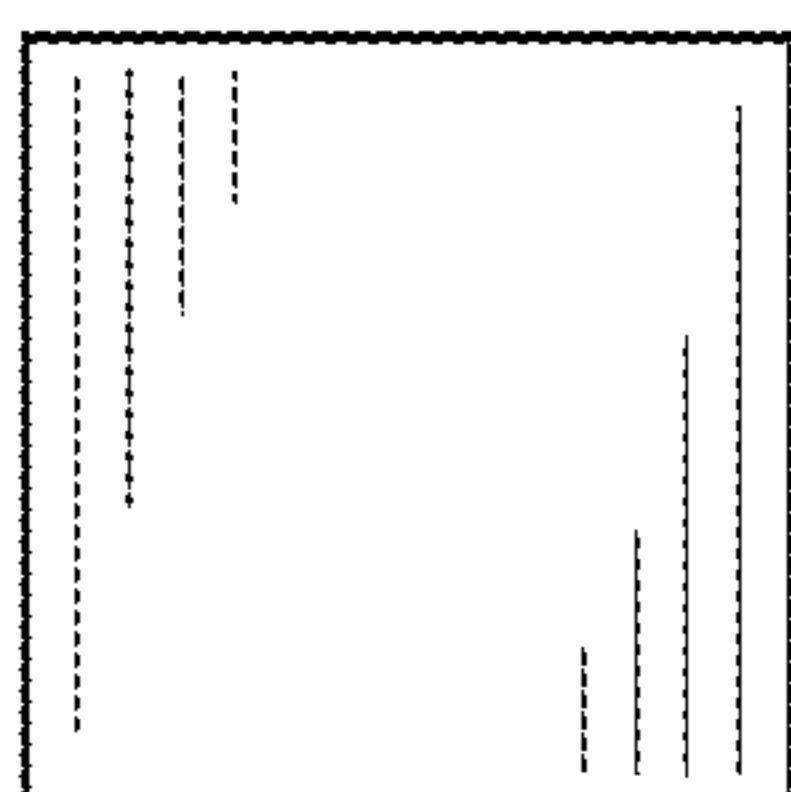

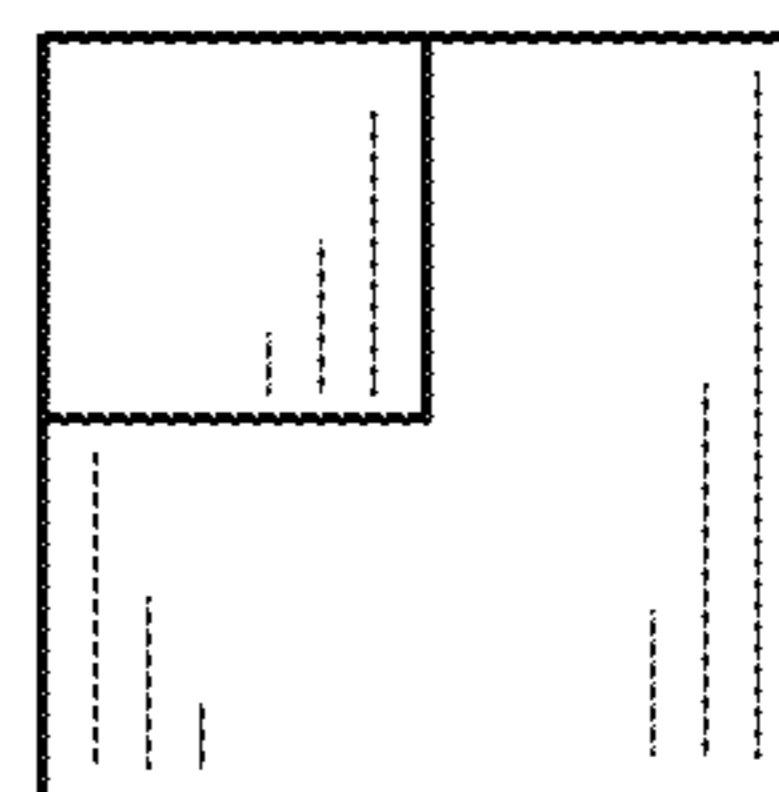

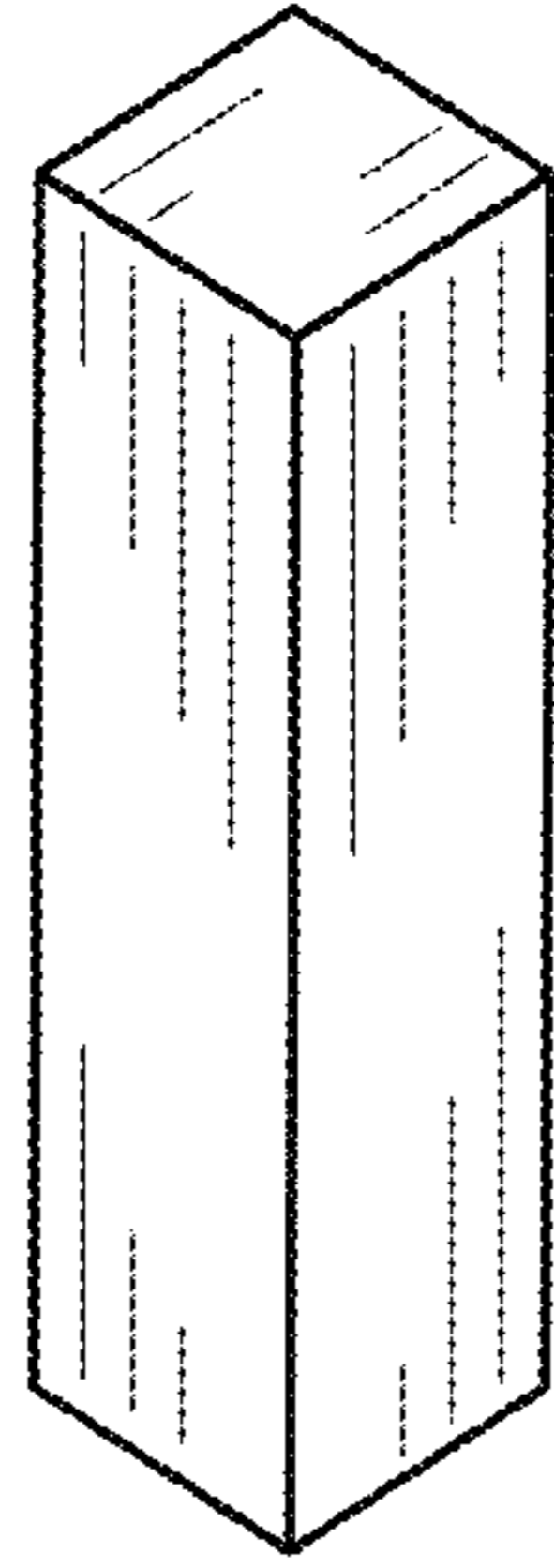

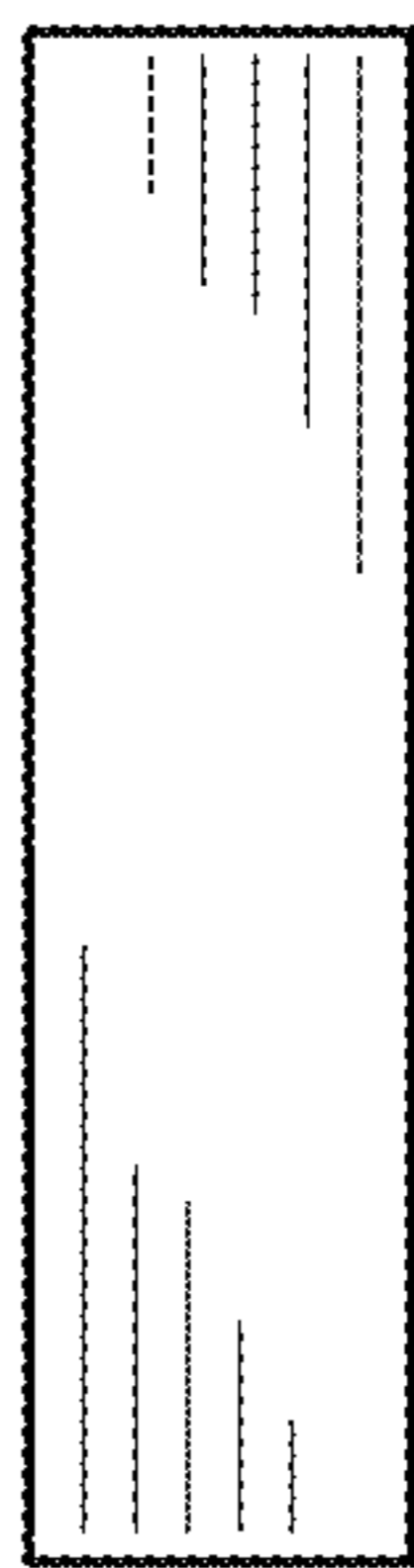

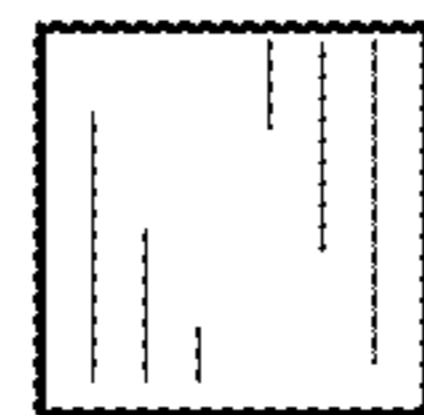

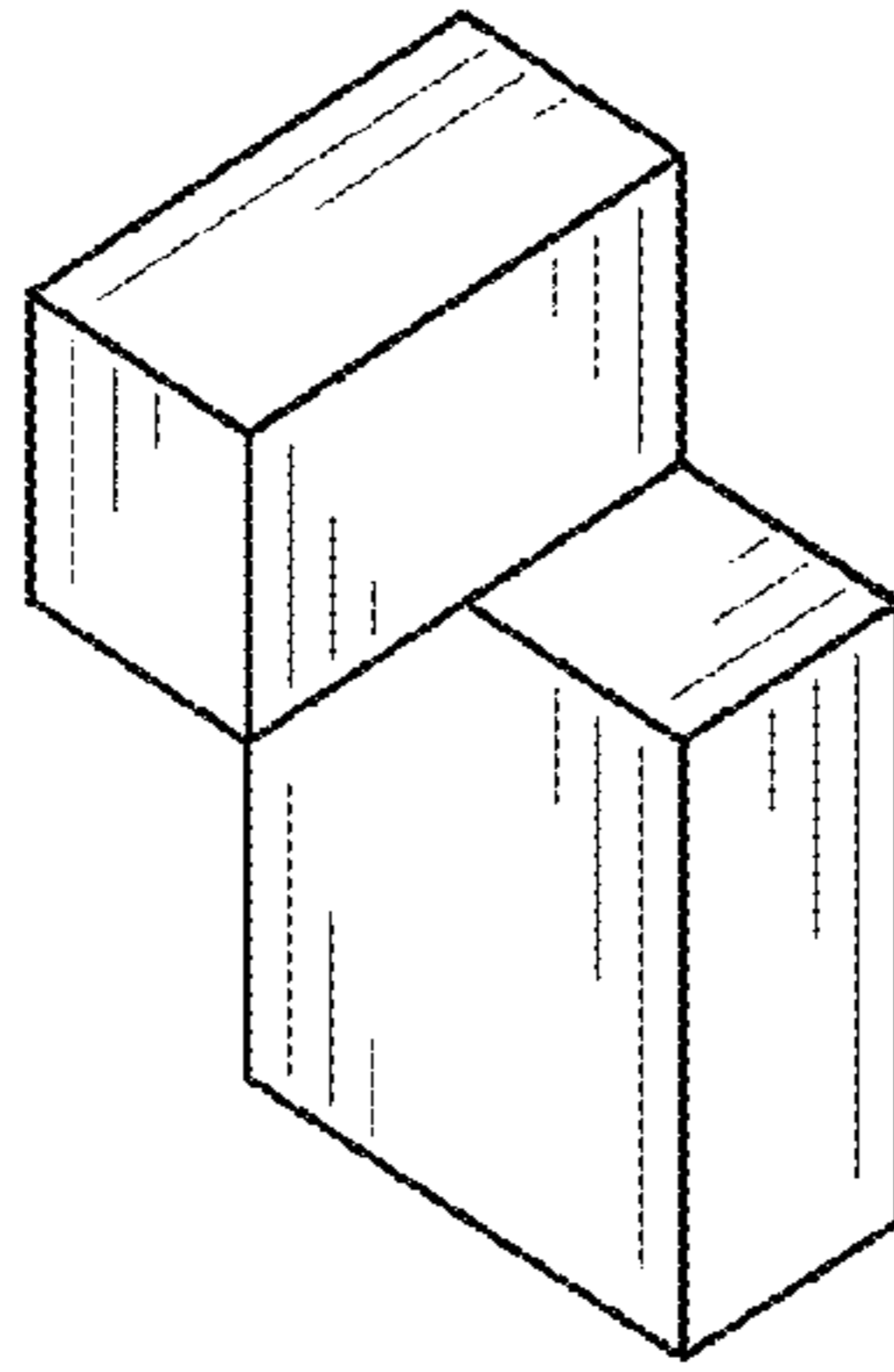

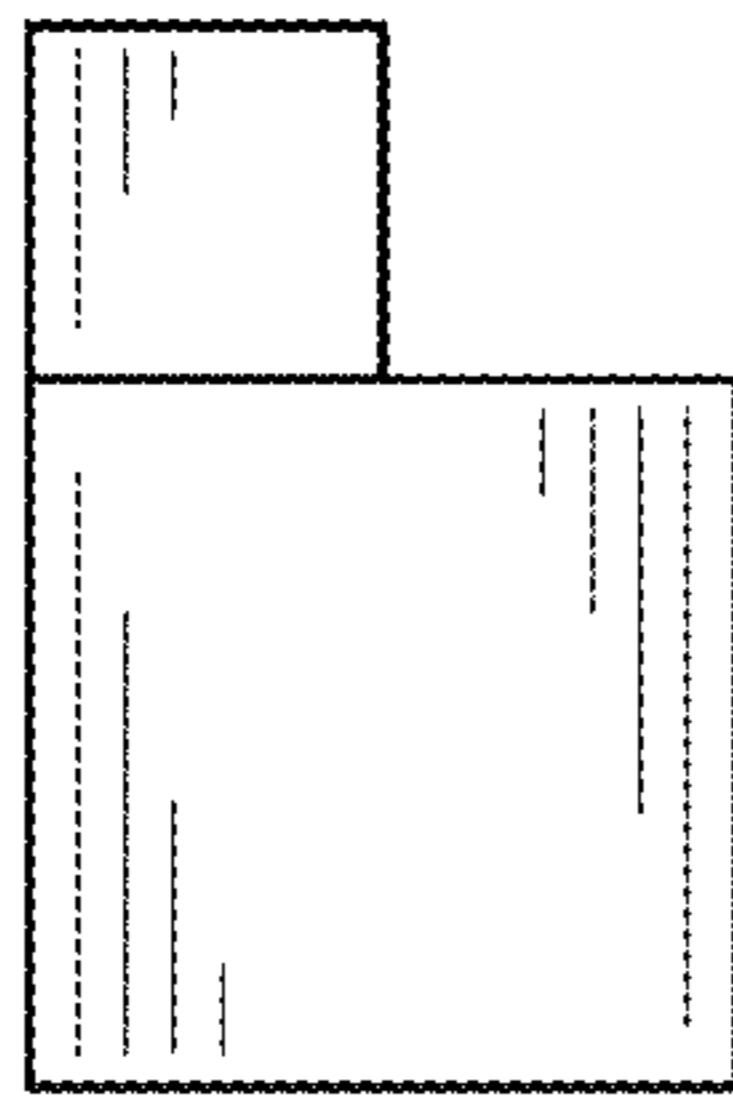

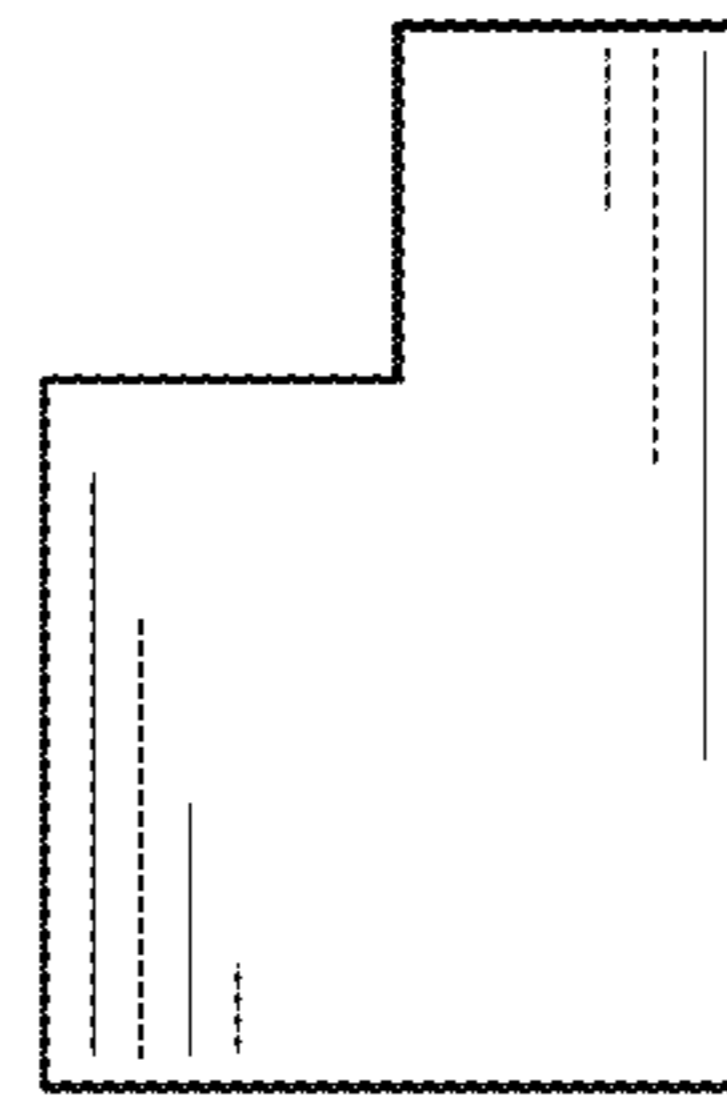

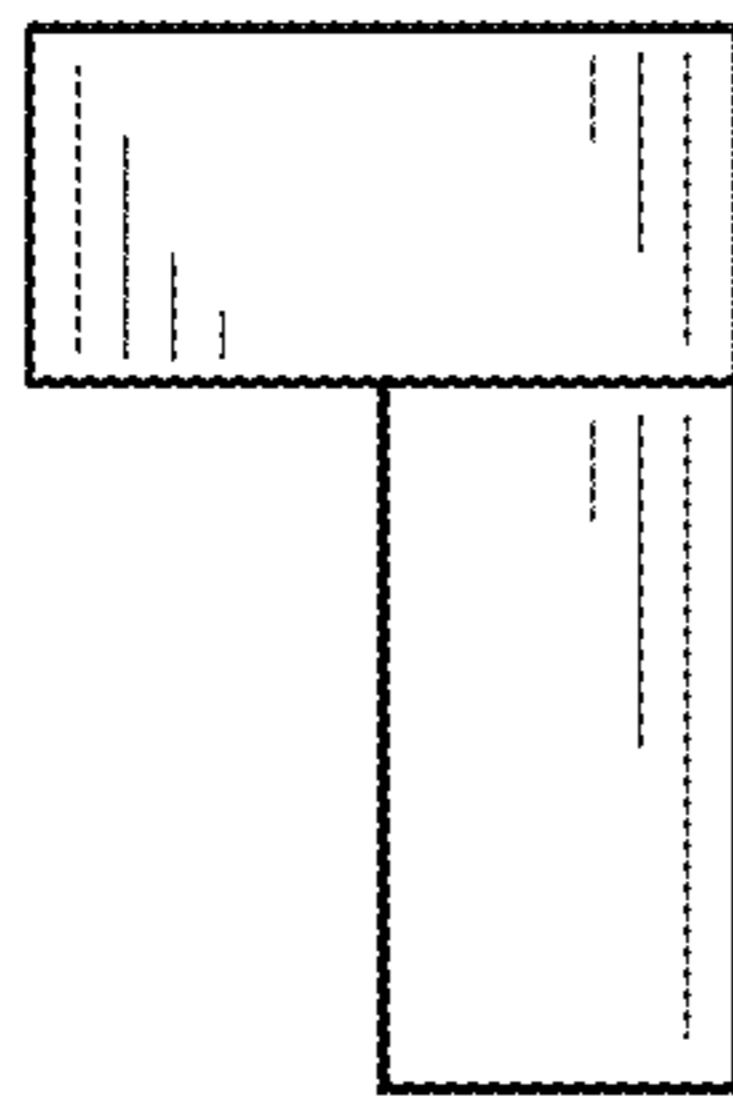

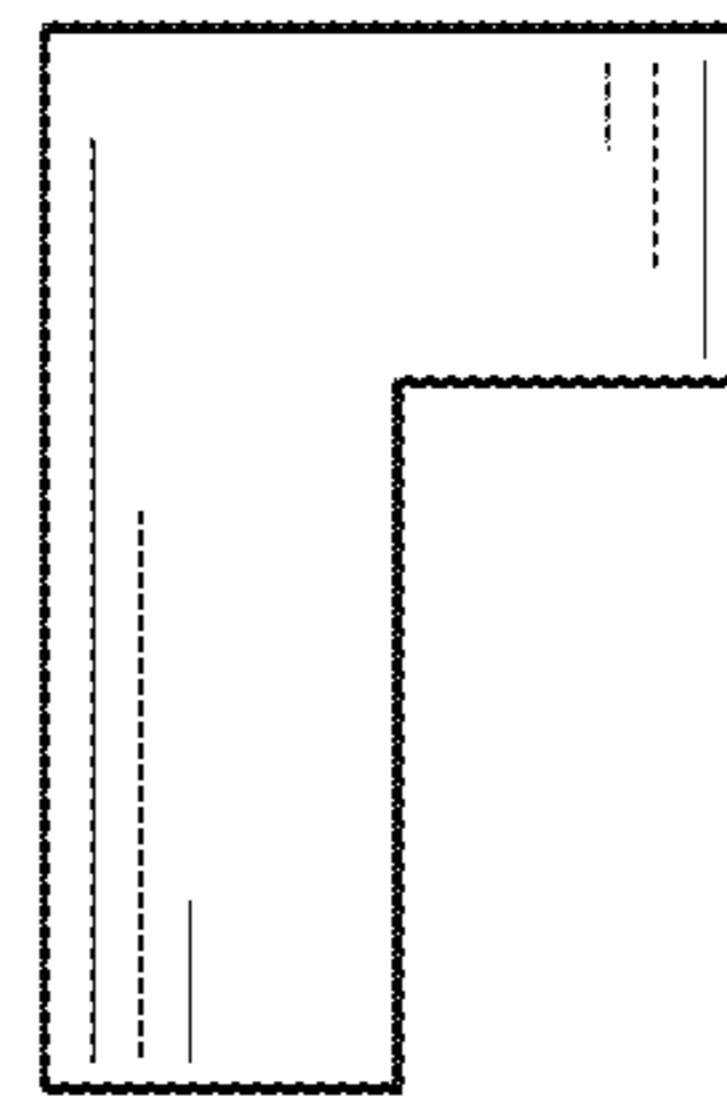

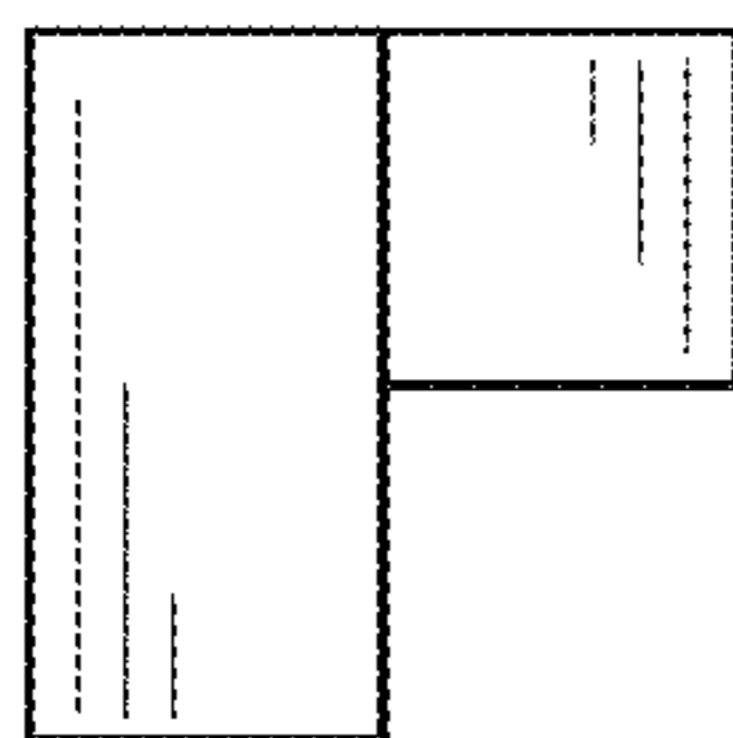

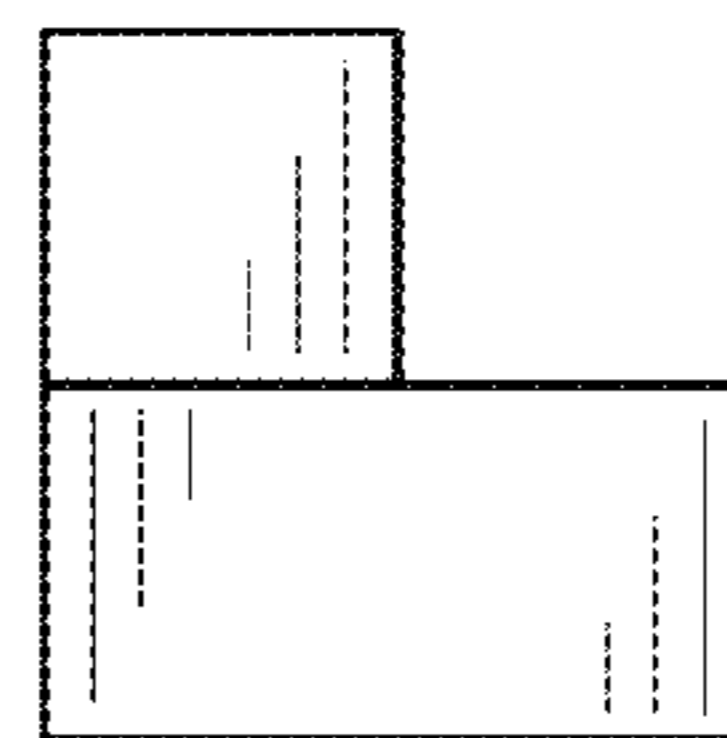
