(57) **CLAIM**

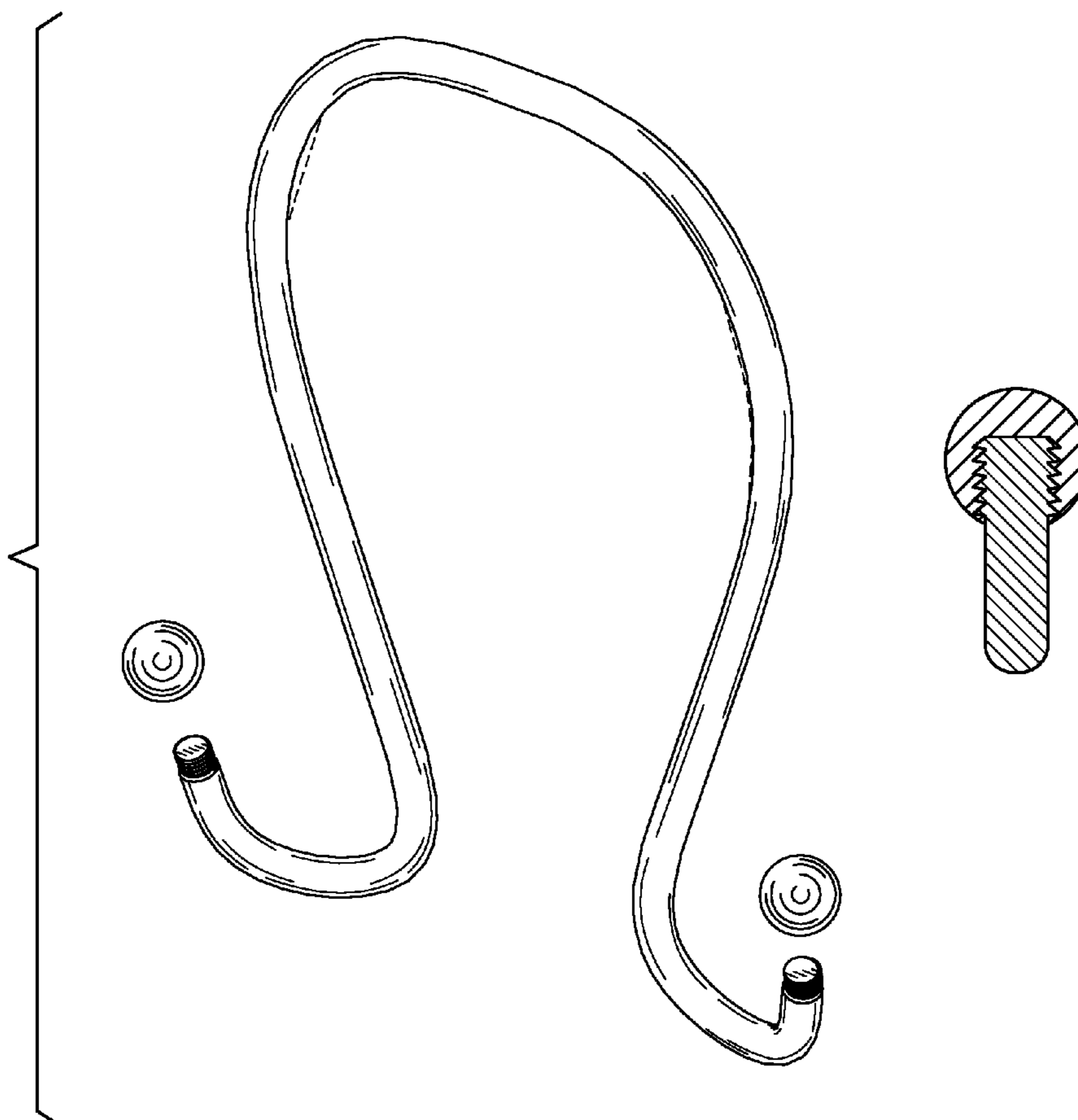
I claim the ornamental design for a male enhancement and testicle retraction prevention device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a male enhancement and testicle retraction prevention device, showing my new design; FIG. 2 is an exploded perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a cross-sectional view thereof, taken generally along lines 8-8 in FIG. 5.

The broken lines showing male genitalia in FIGS. 1 and 2 depict environmental matter and form no part of the claimed design.

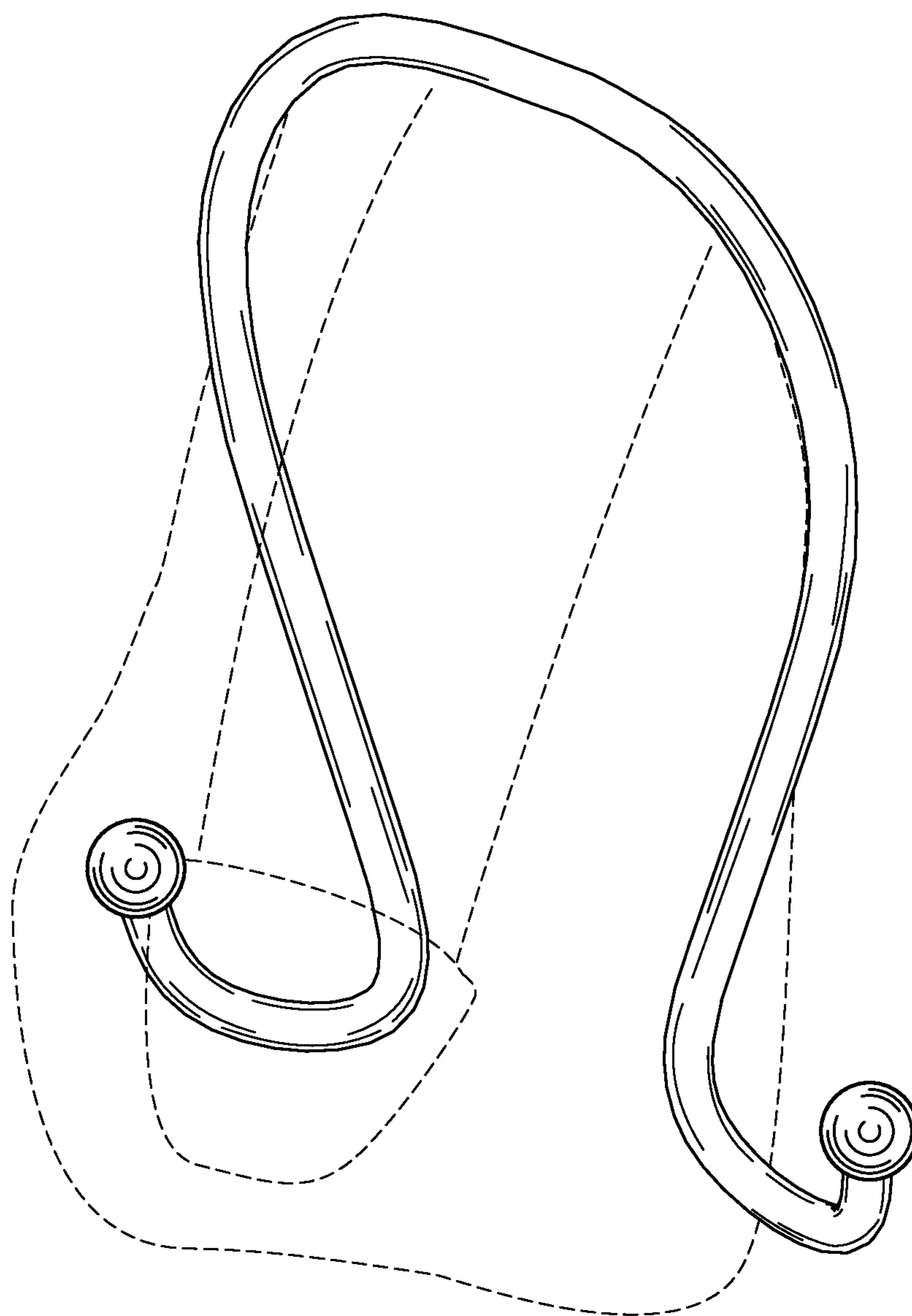

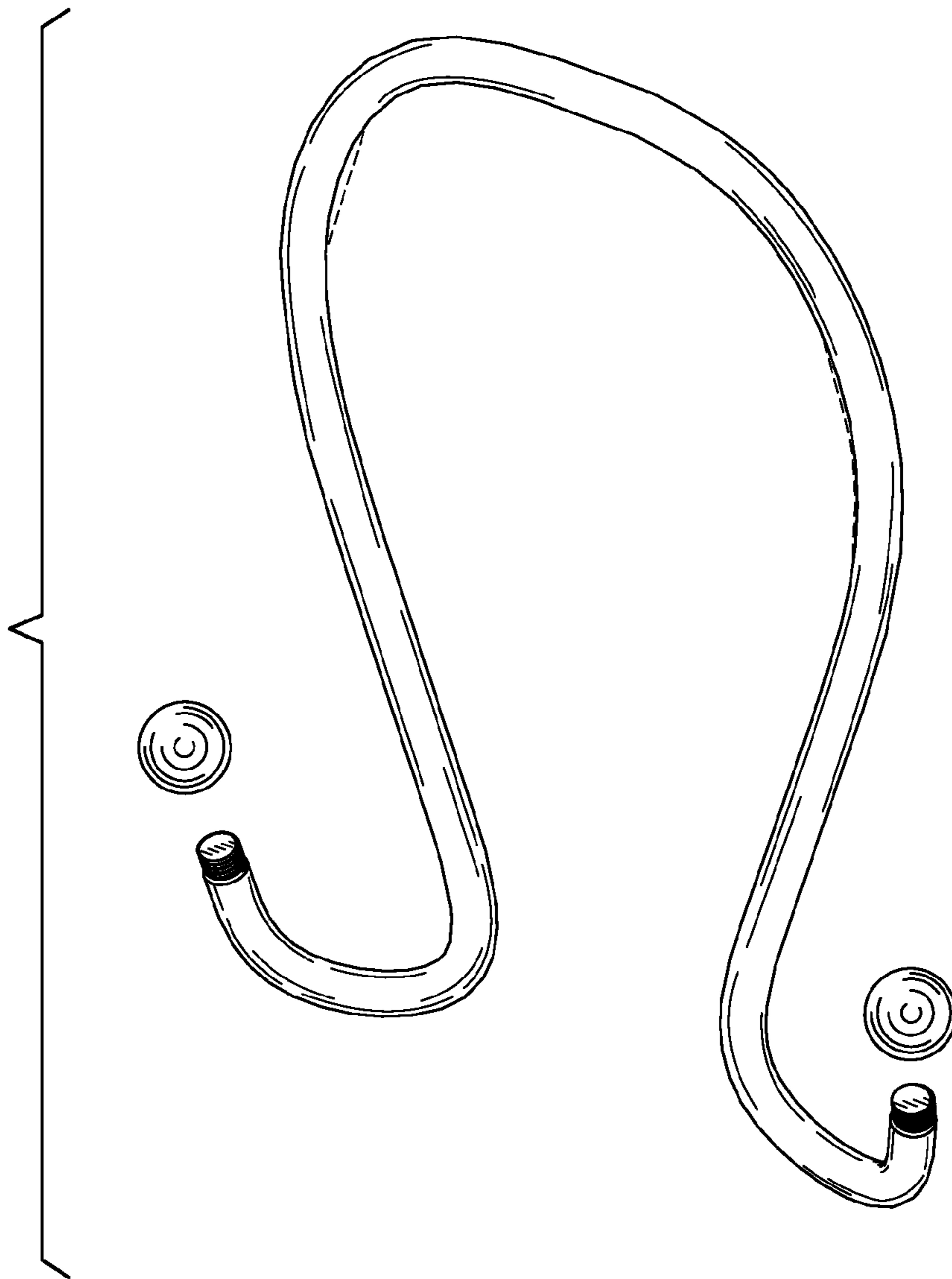

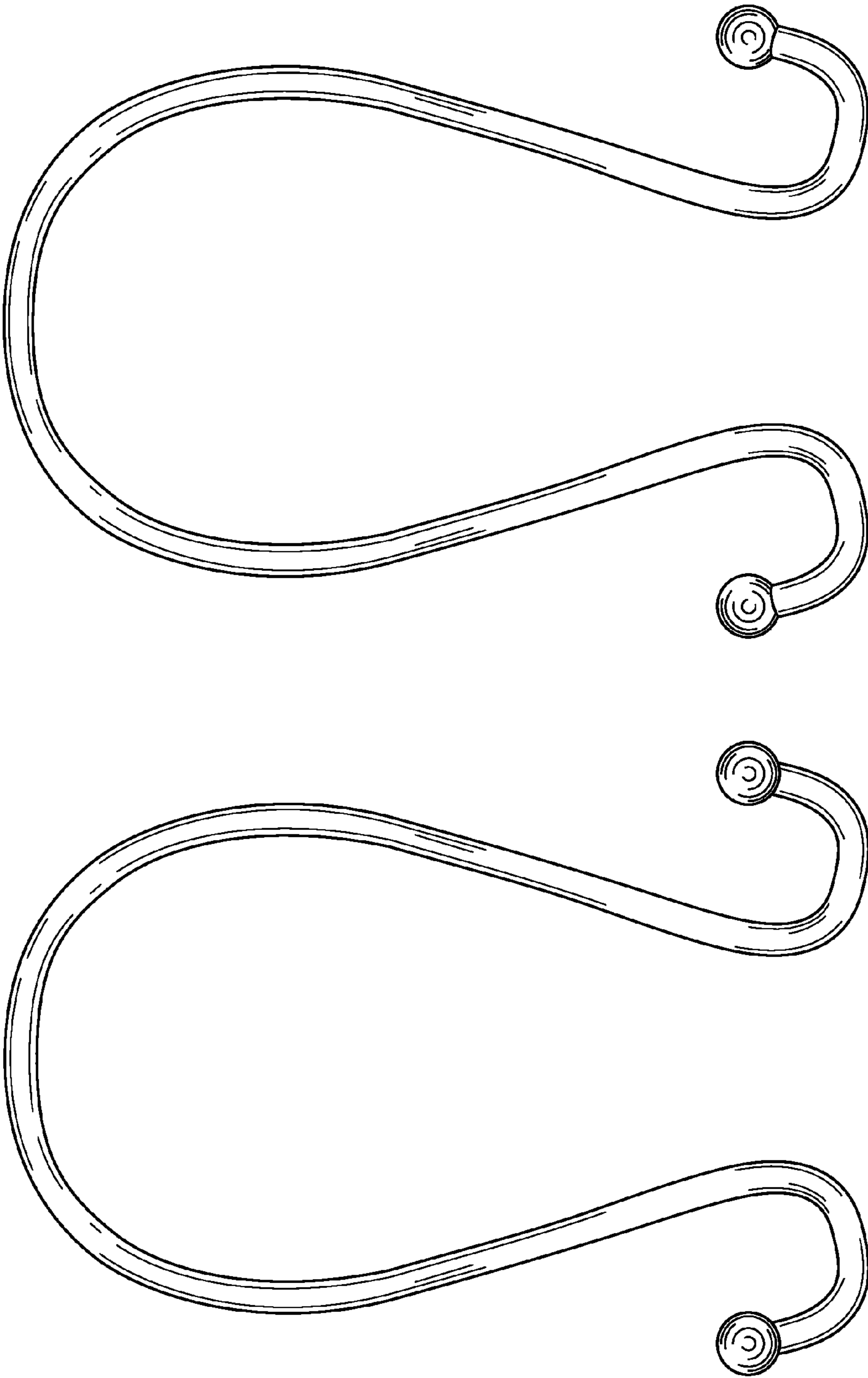

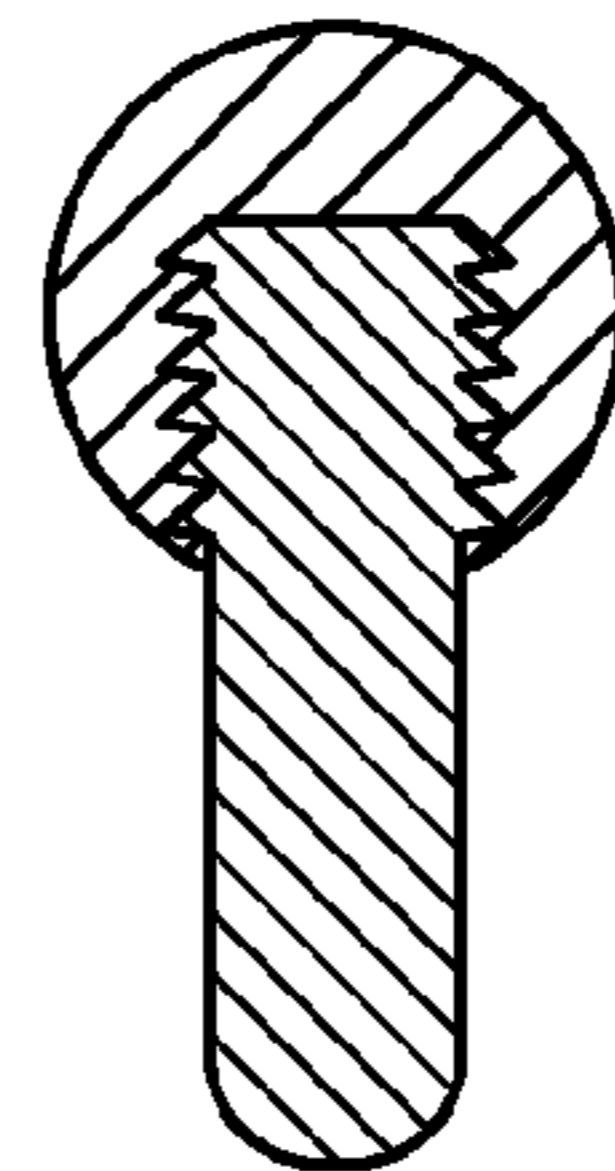
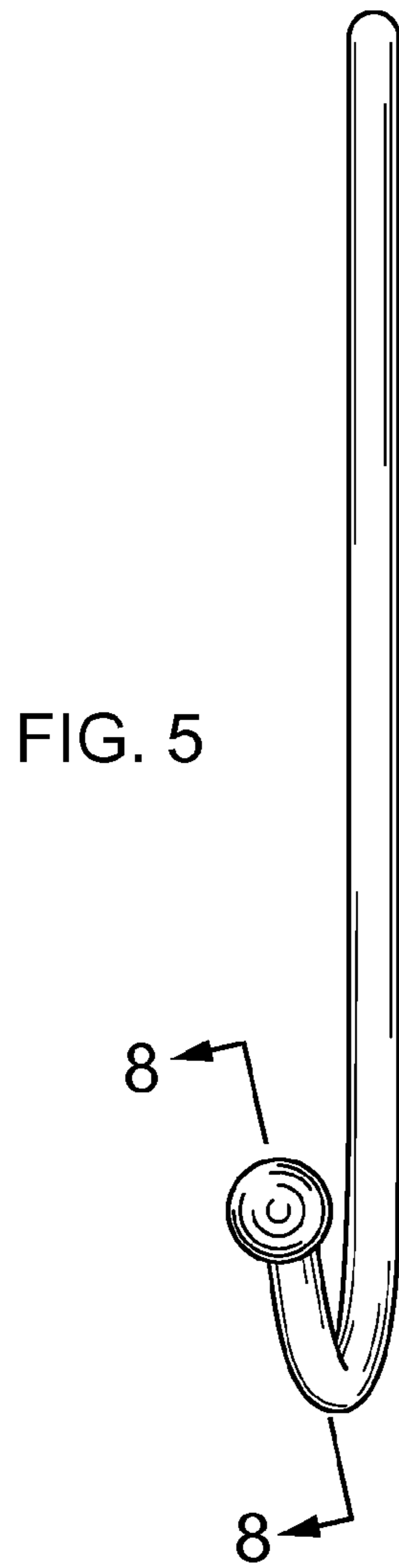
