FIG. 1 is a first side elevational view of a knee brace showing our design.

FIG. 3 is a rear elevational view of the knee brace of FIG. 1.

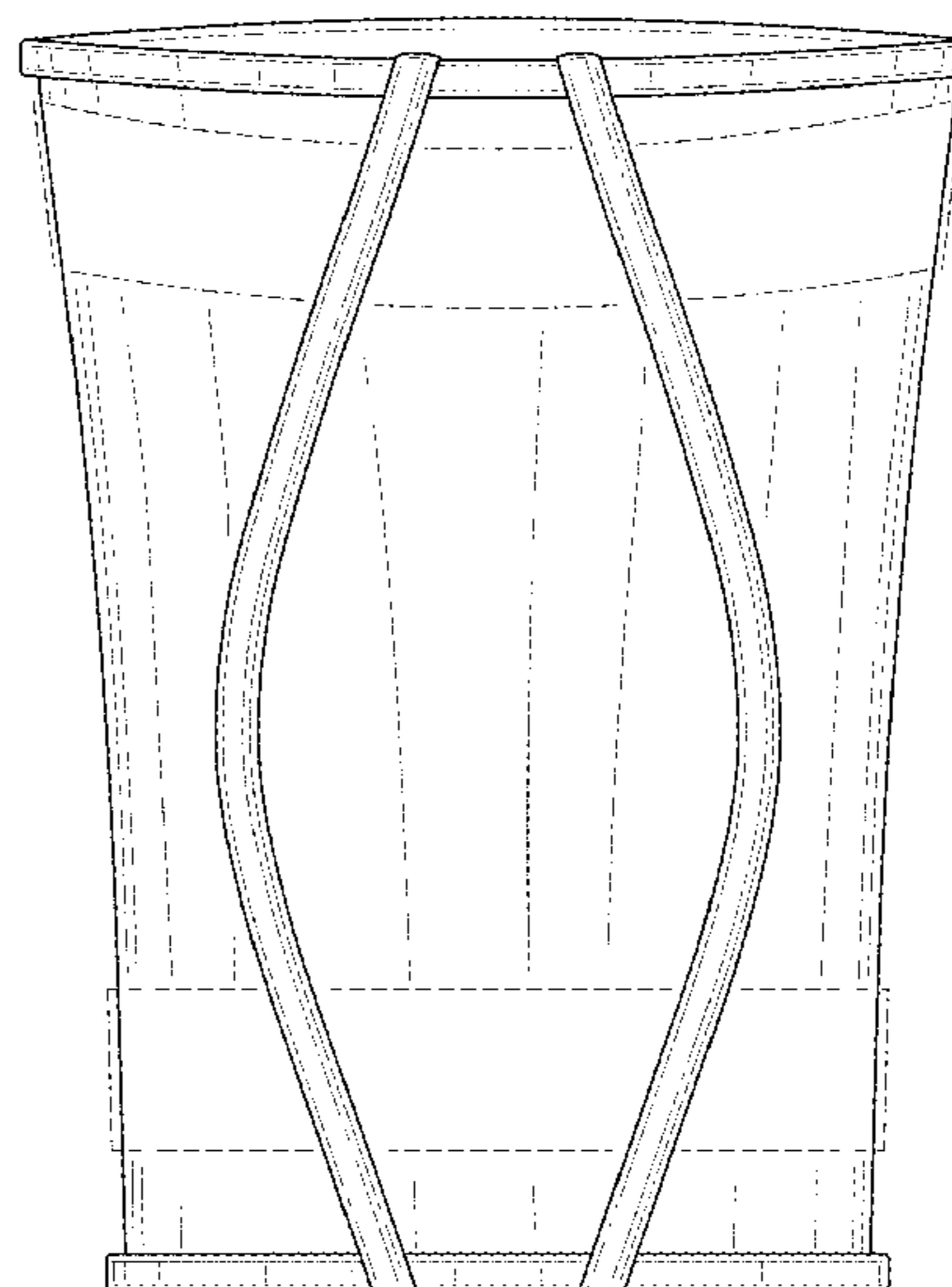
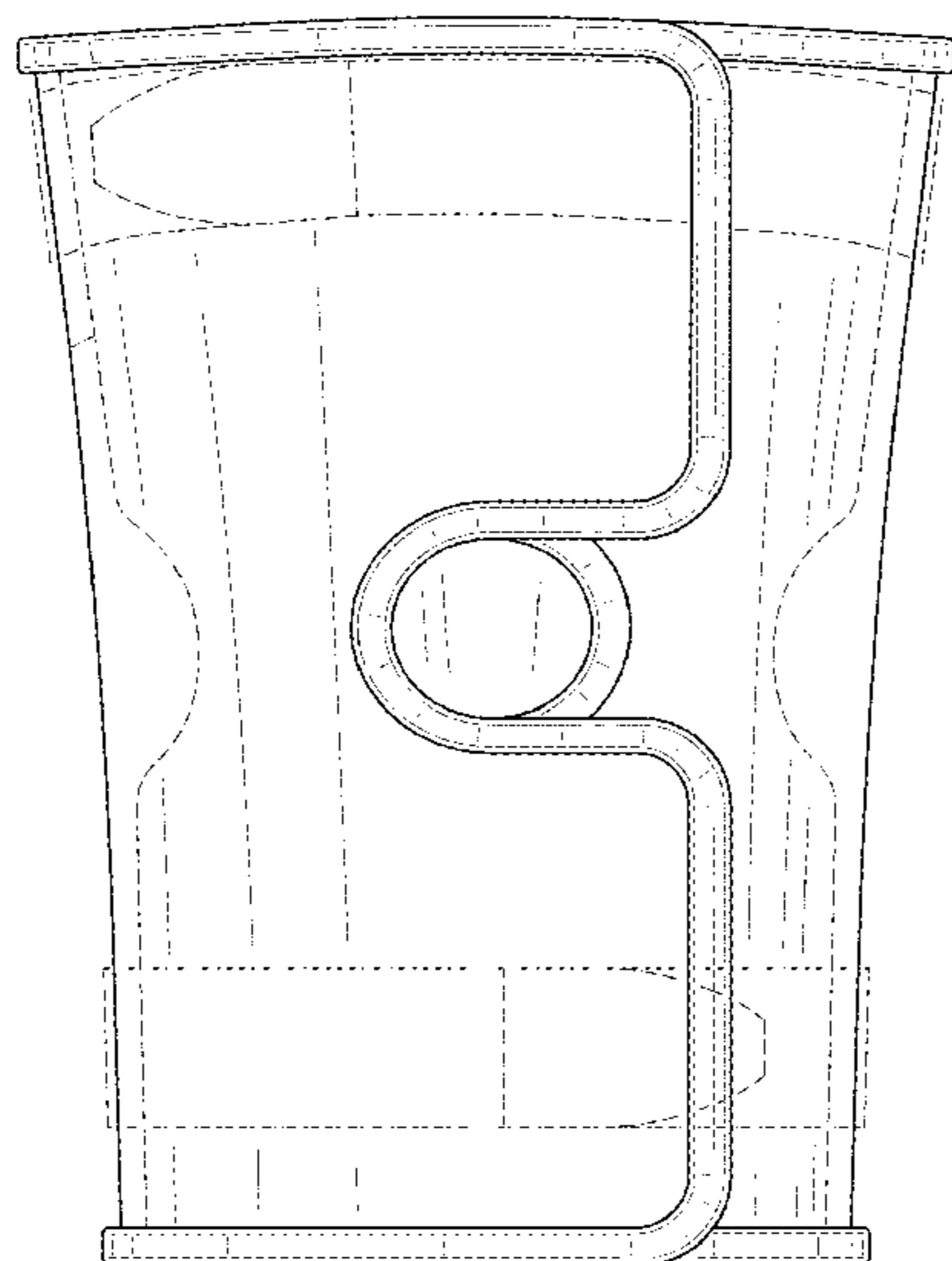
FIG. 4 is a second side elevational view of the knee brace of FIG. 1.

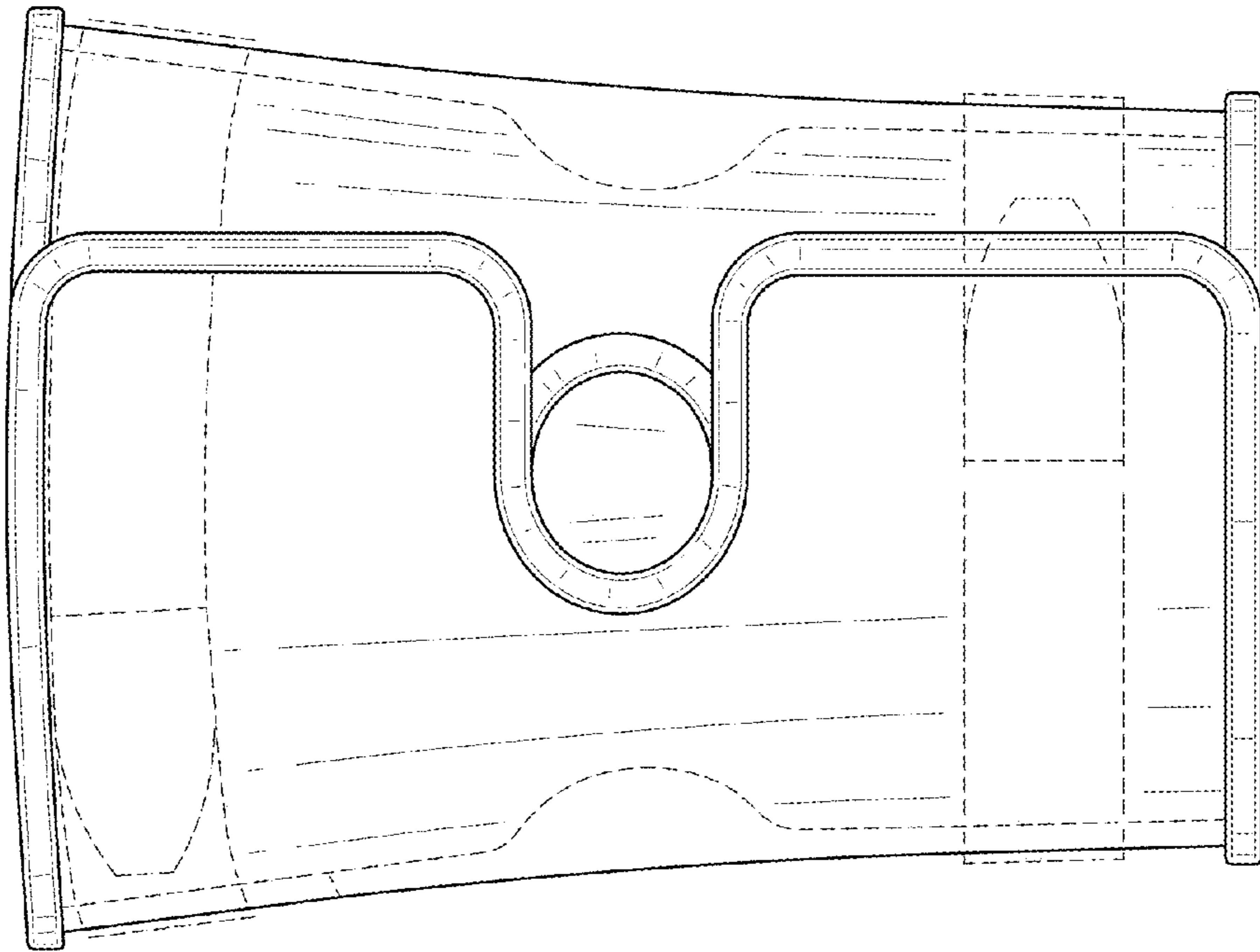

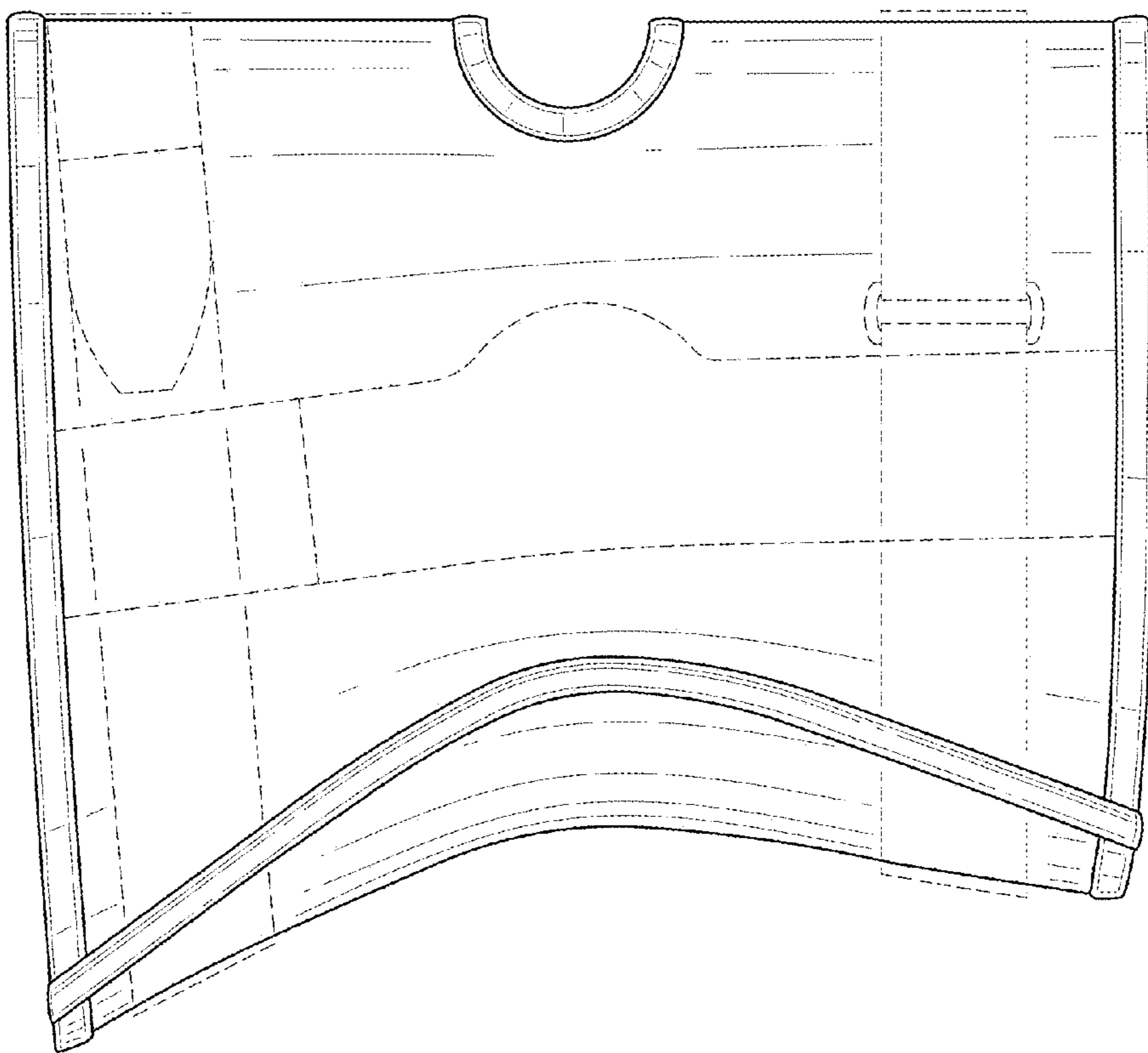

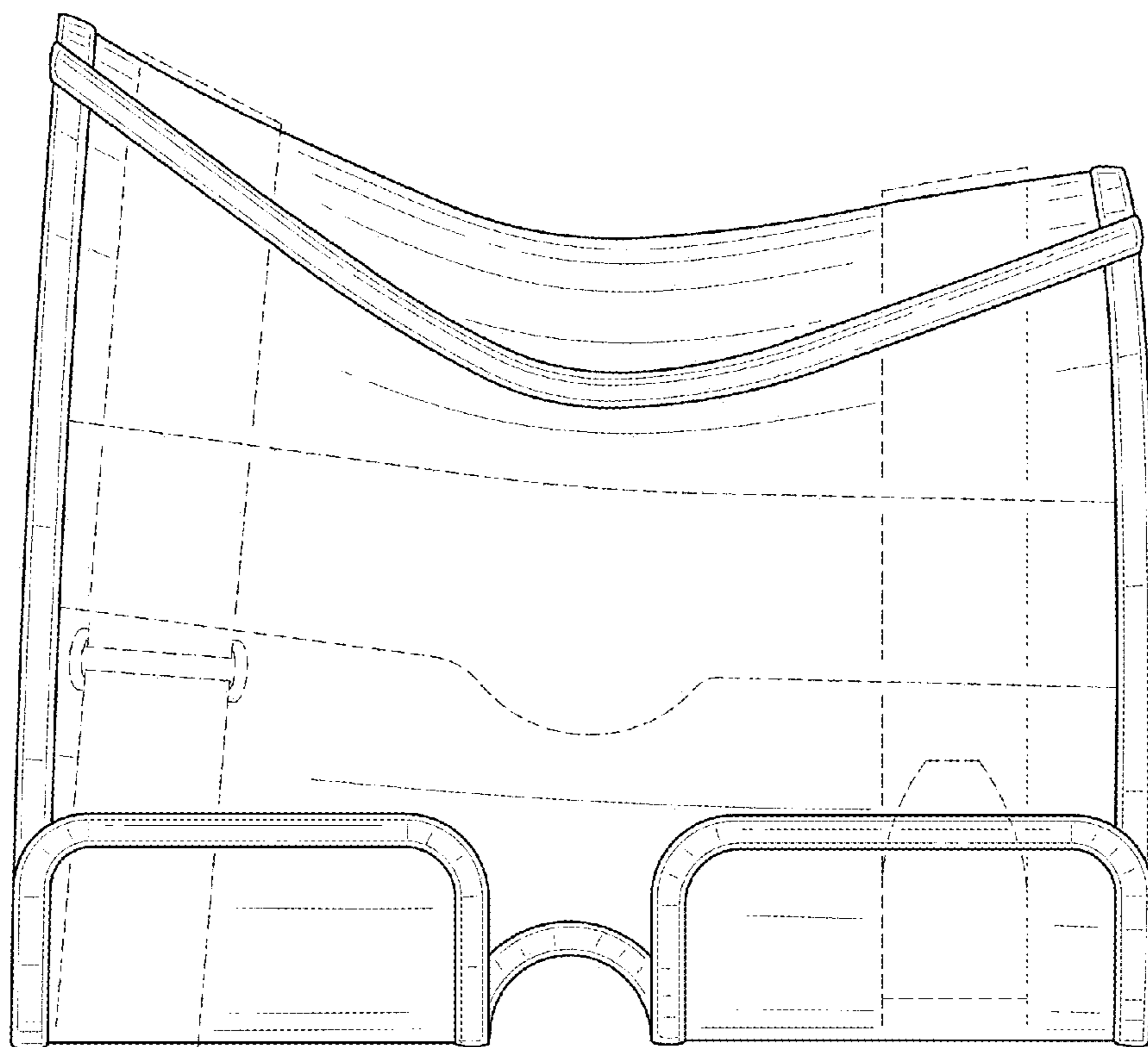

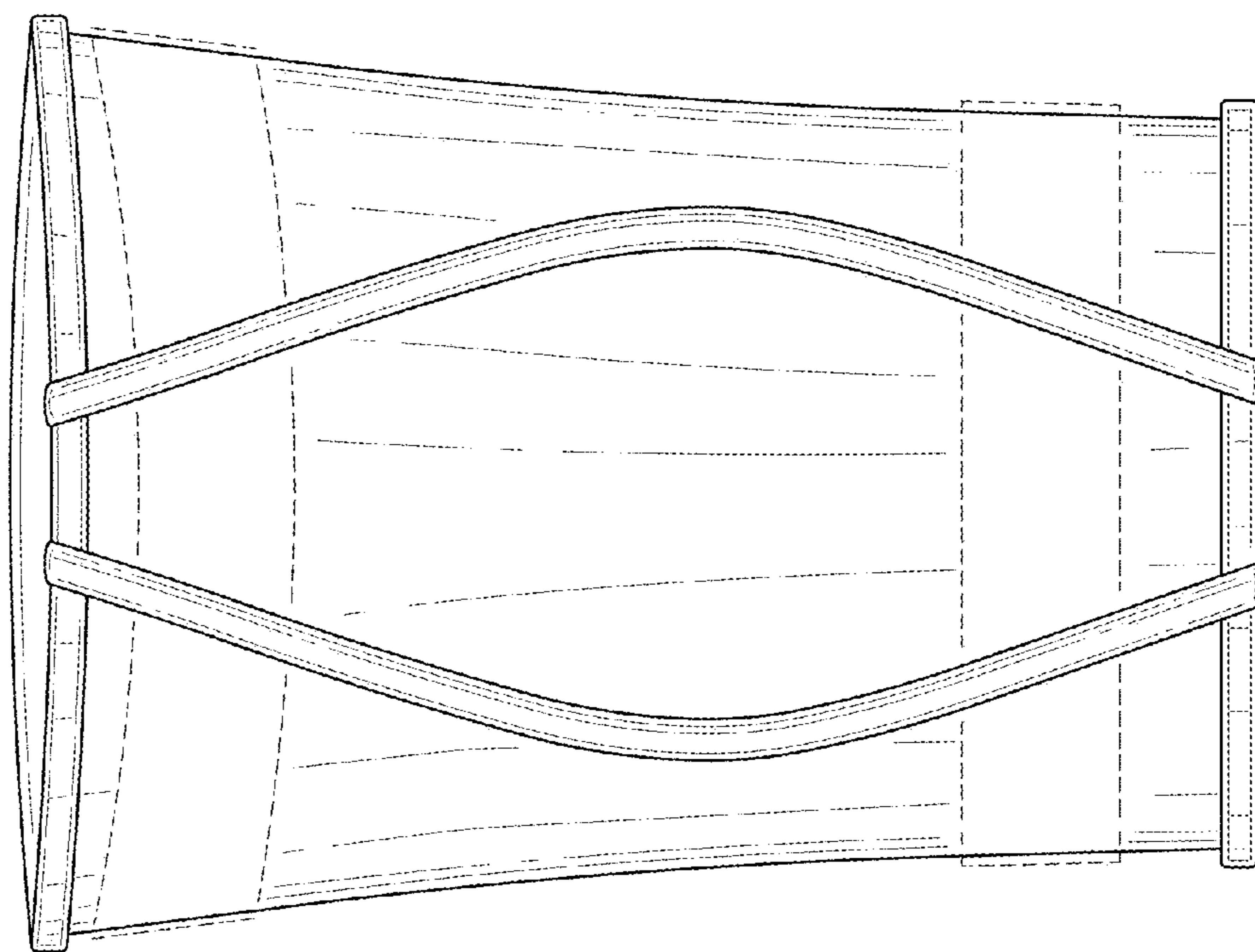

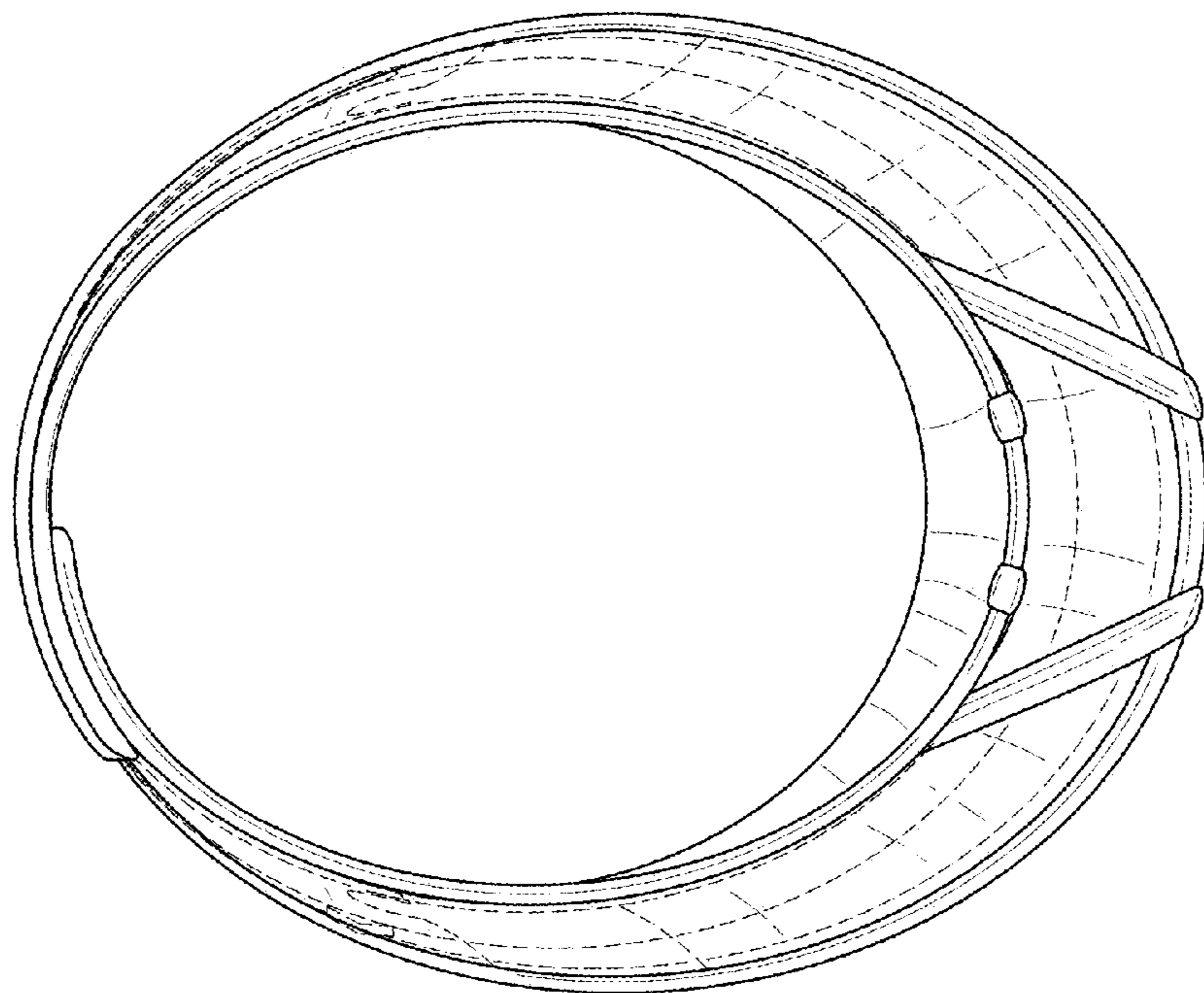

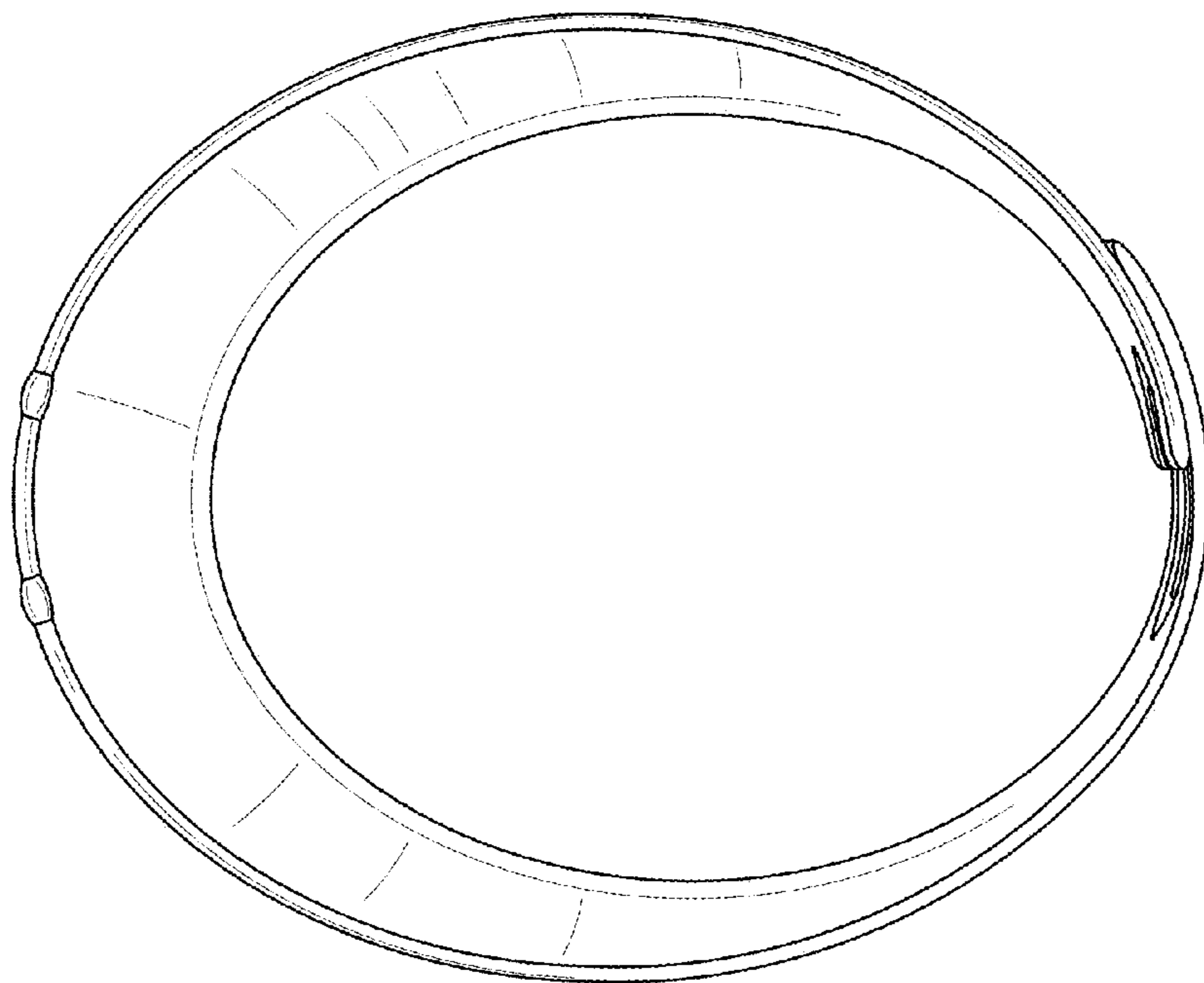
