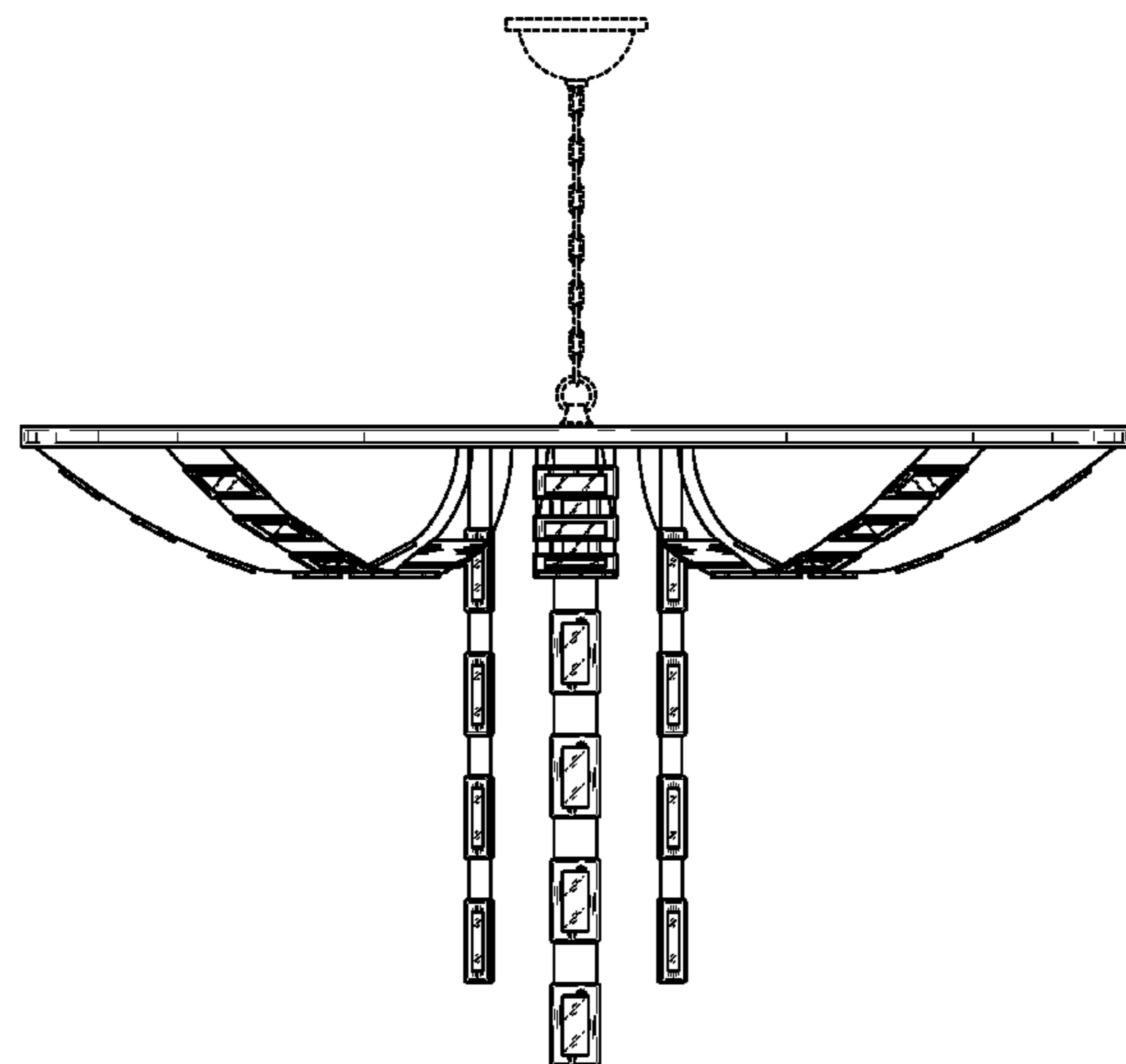
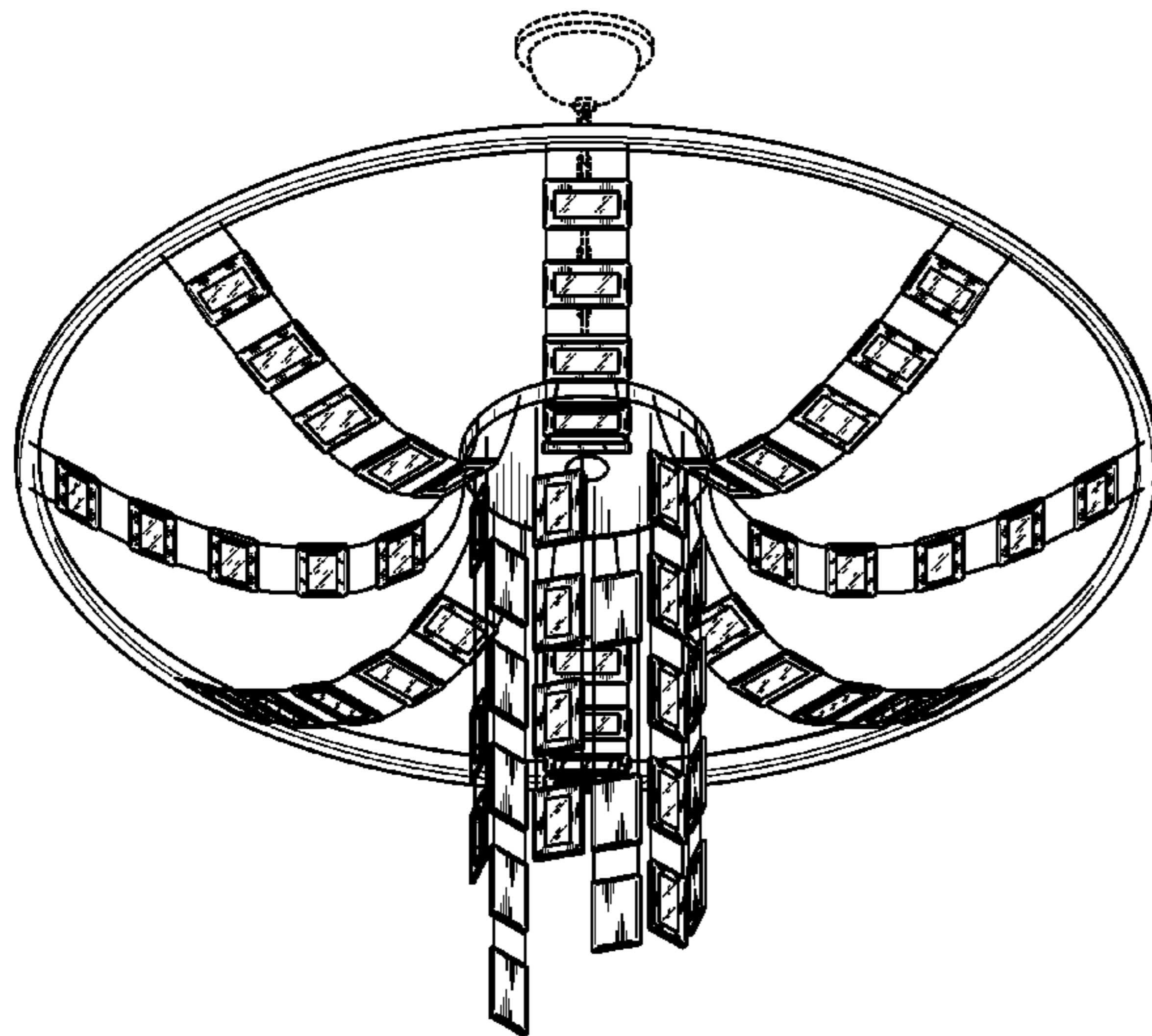
The ornamental design for an OLED chandelier, as shown and described.

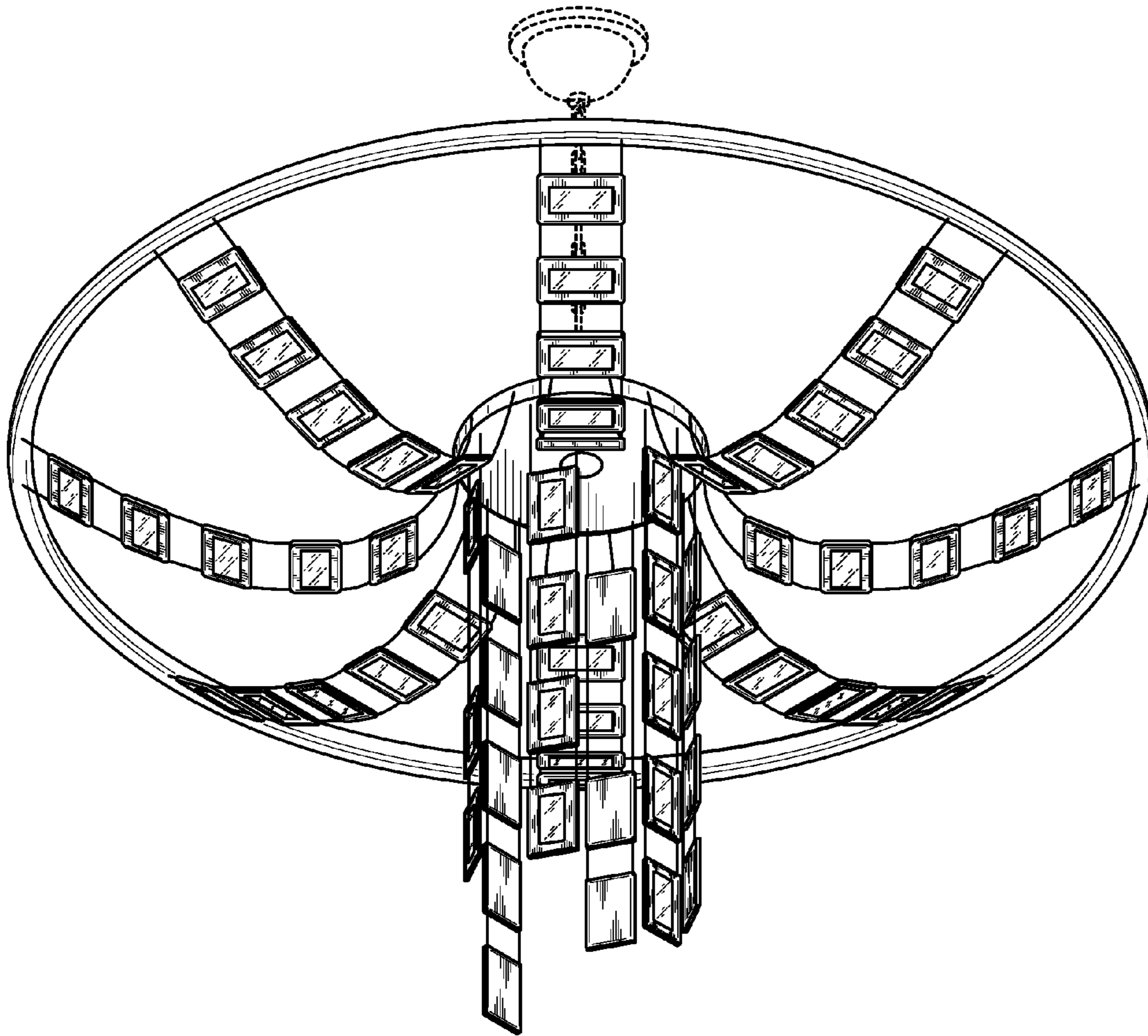
**DESCRIPTION**

FIG. 7 is a bottom plan view thereof.

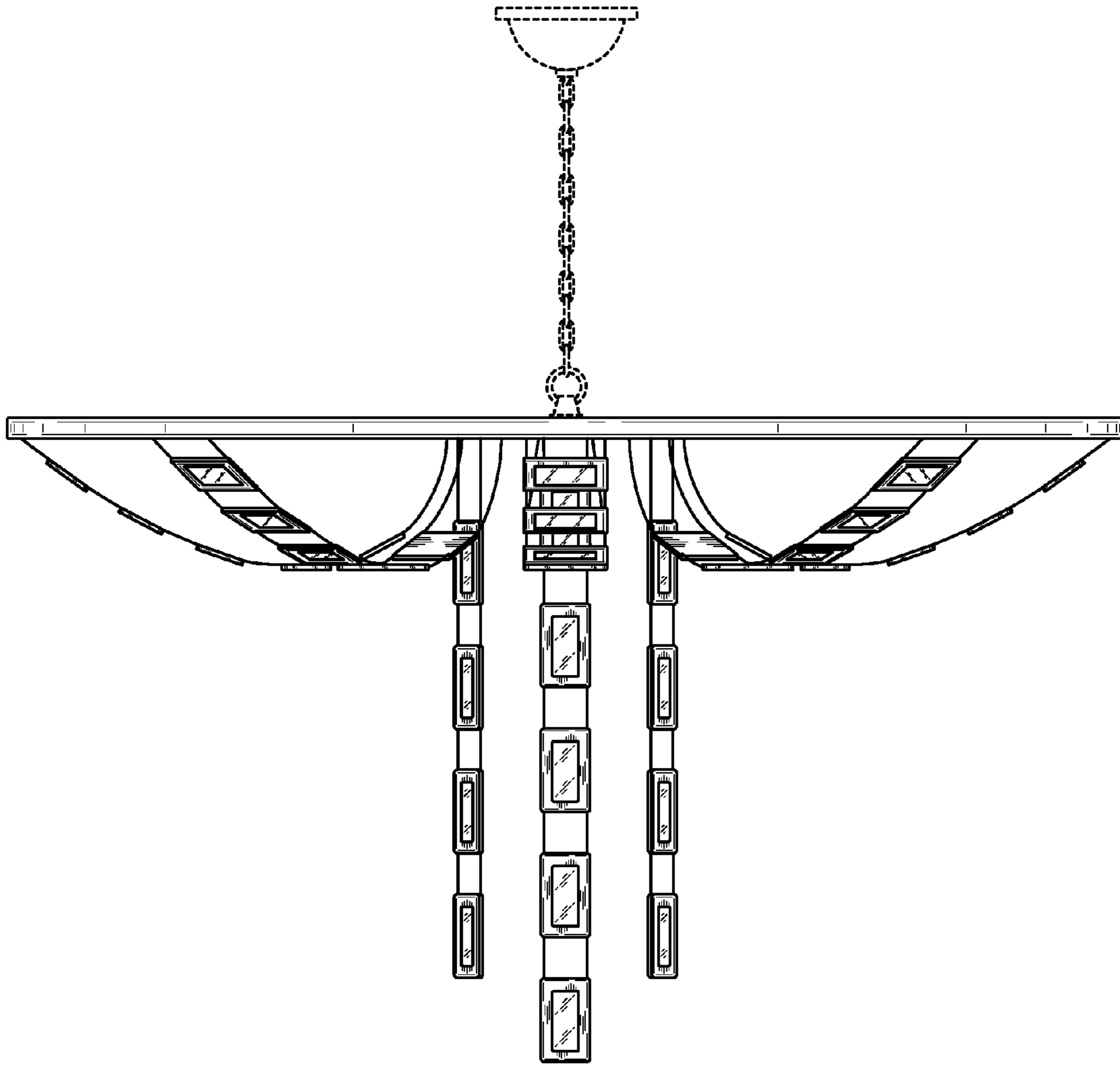

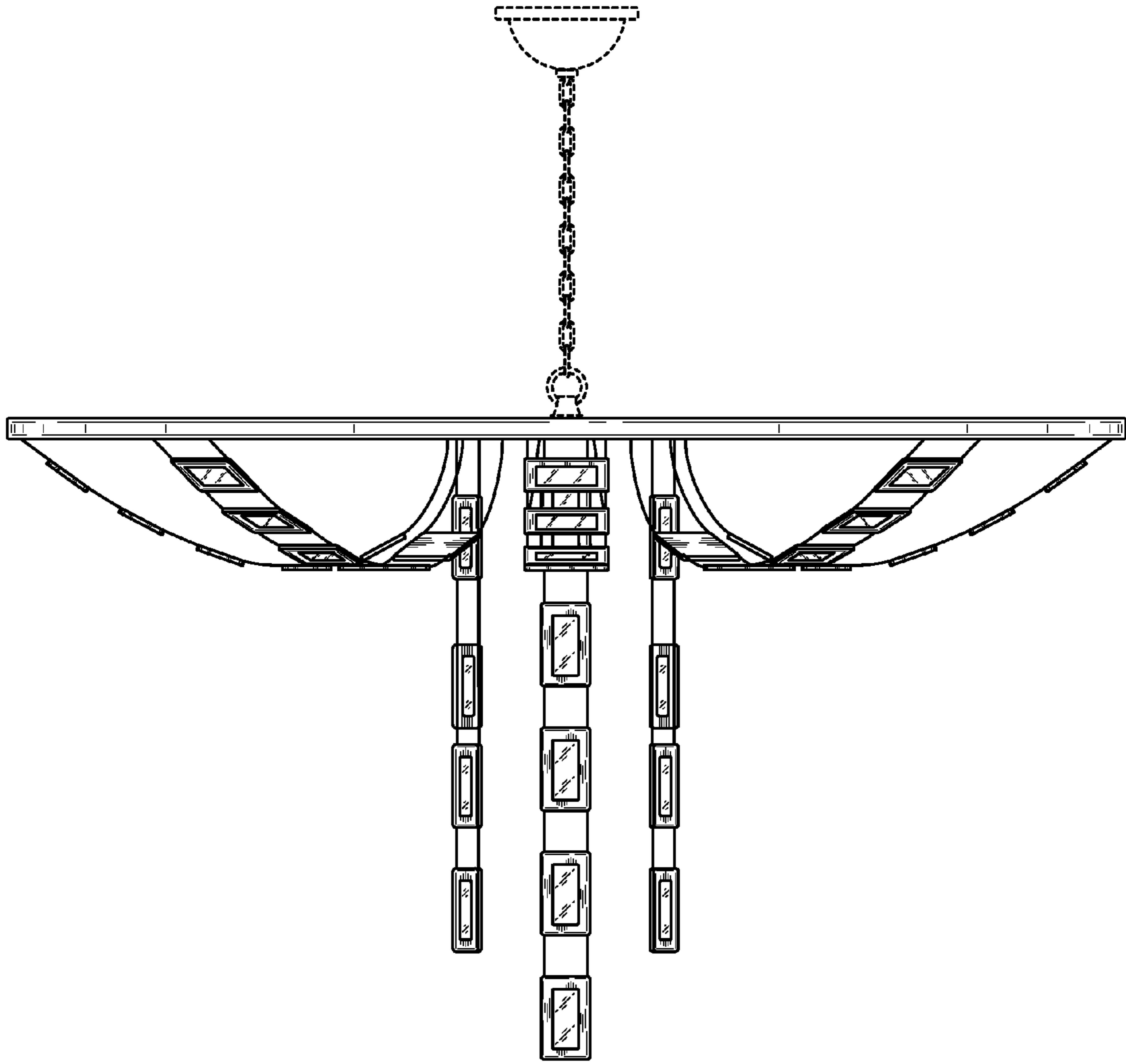




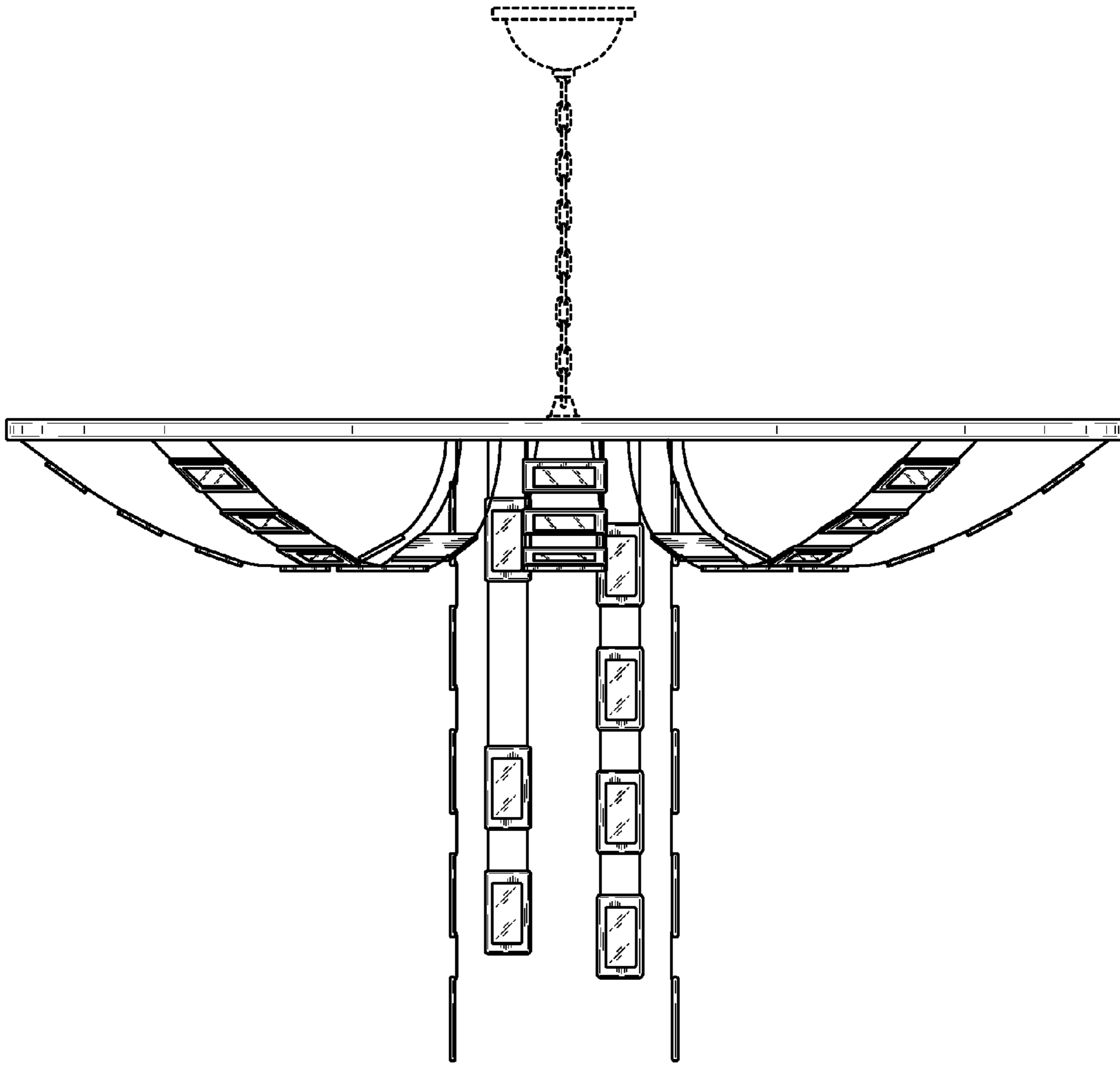

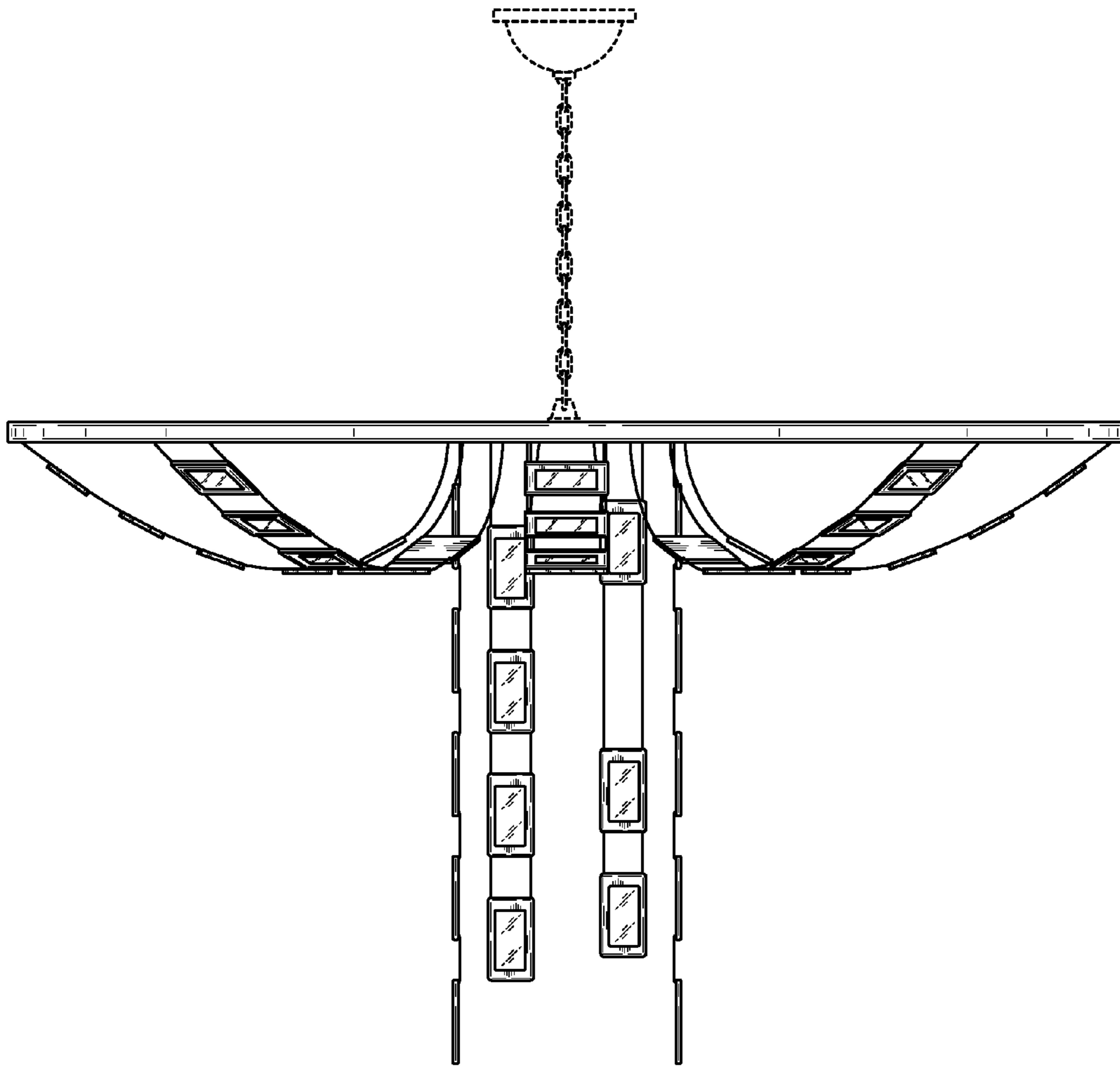

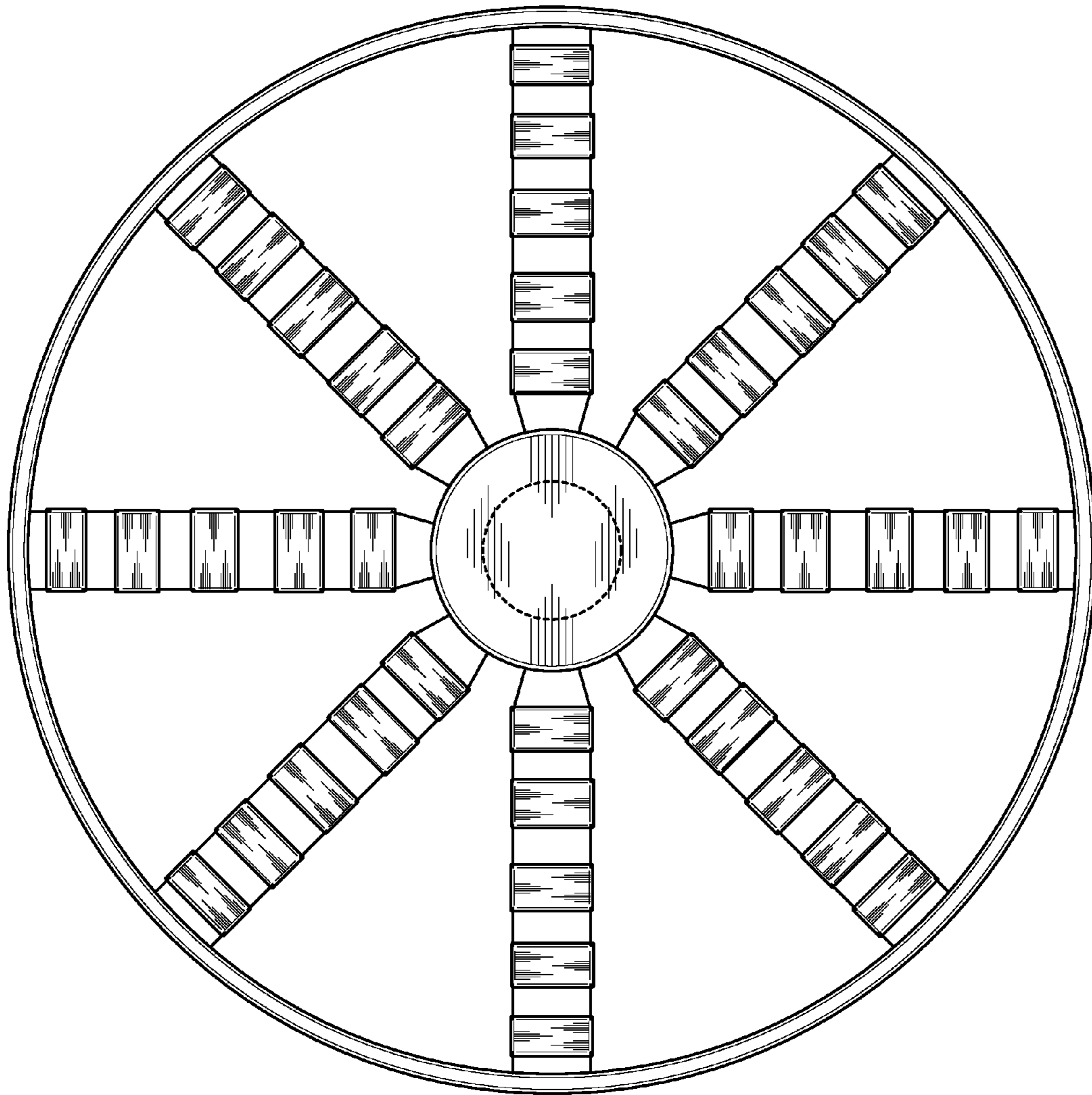

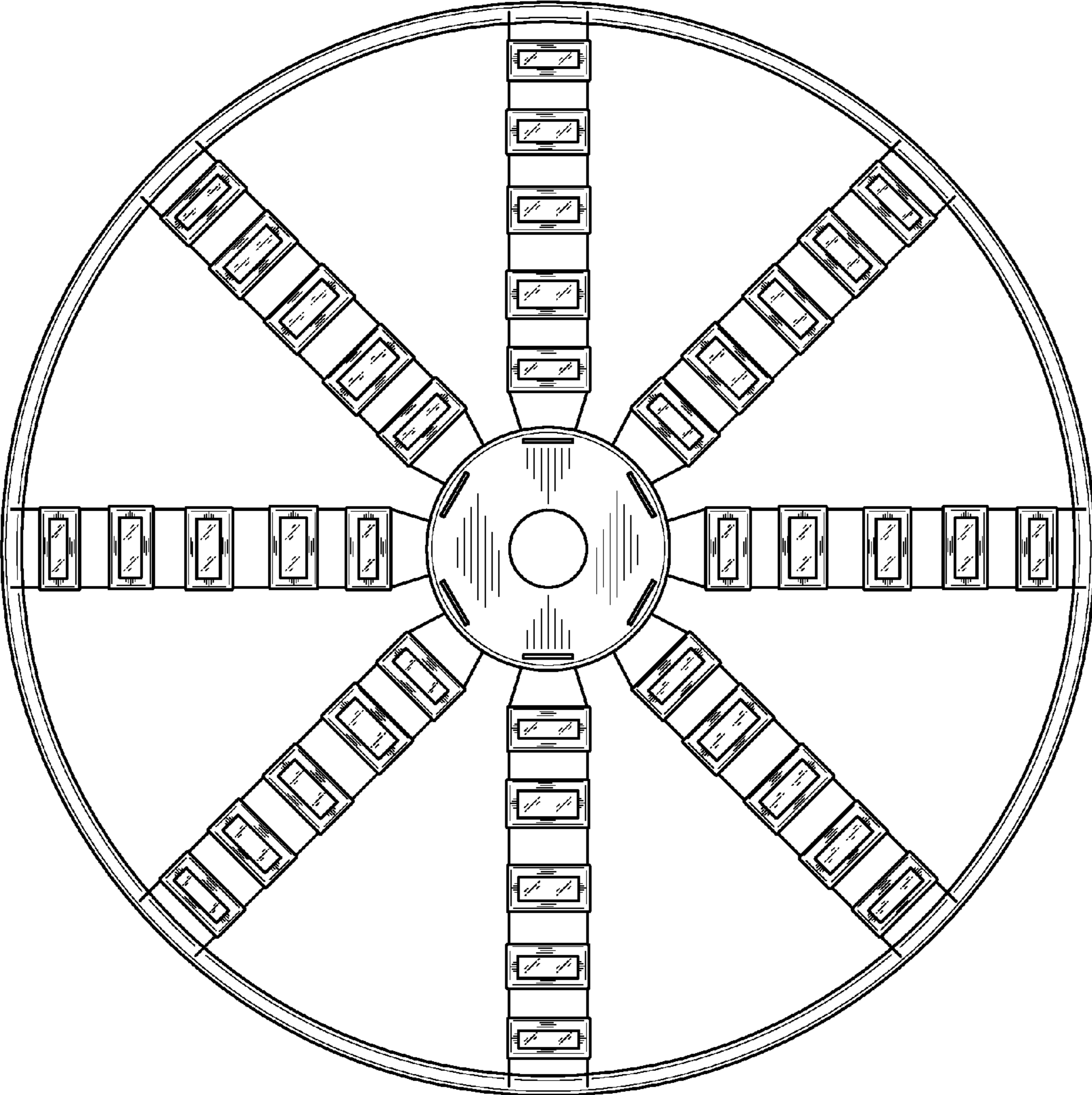
