The ornamental design for a chandelier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the chandelier of the present invention;

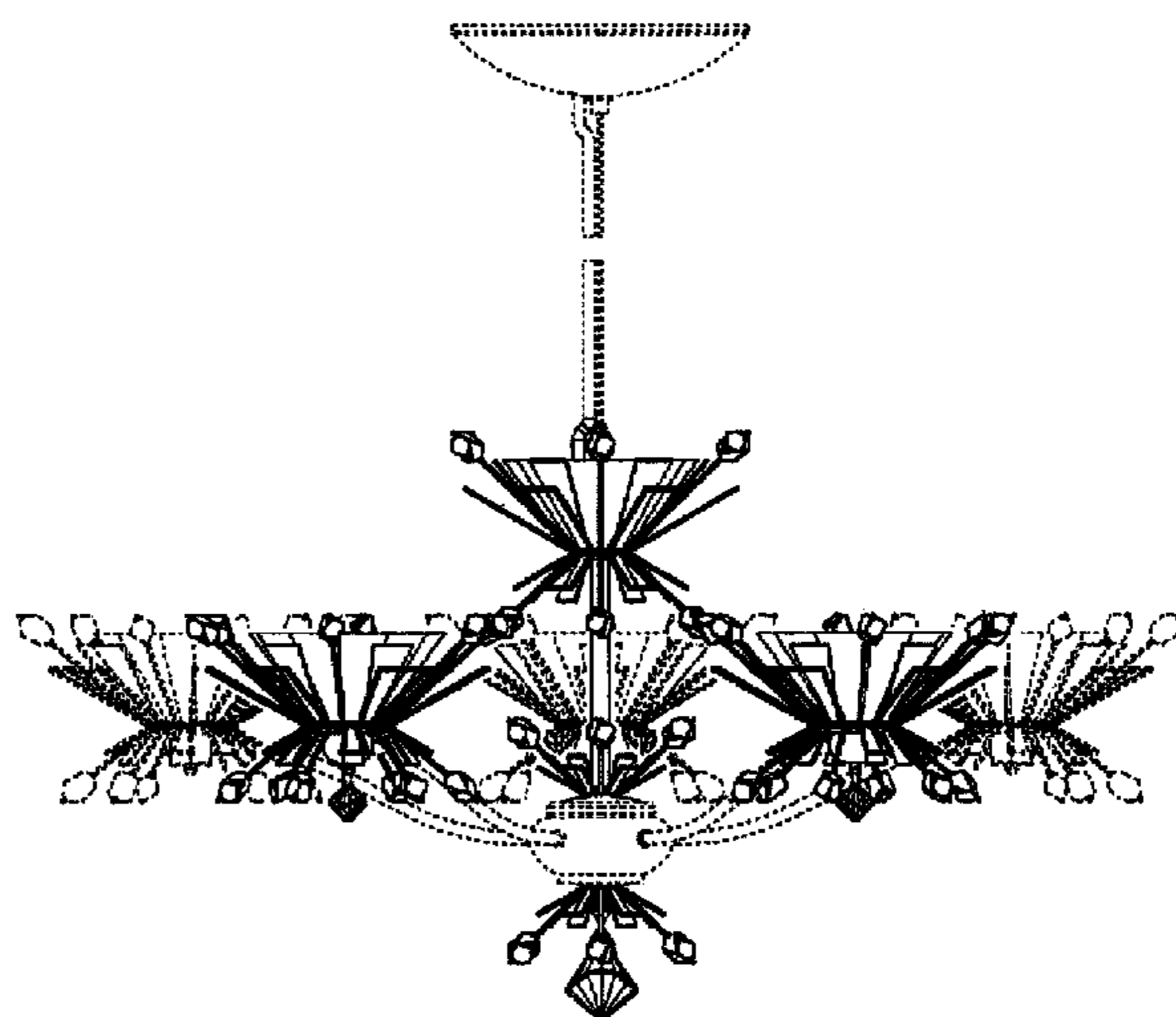
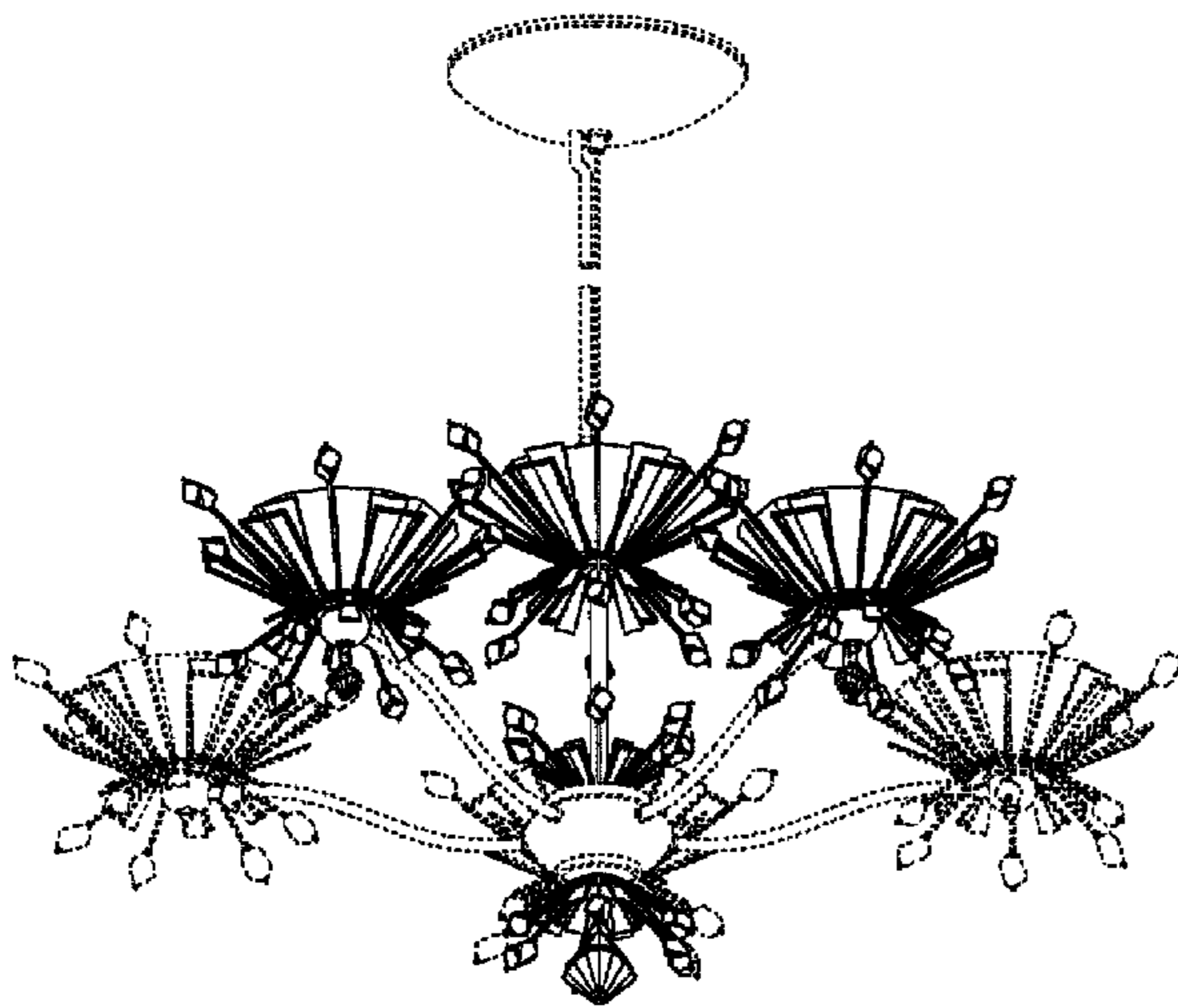

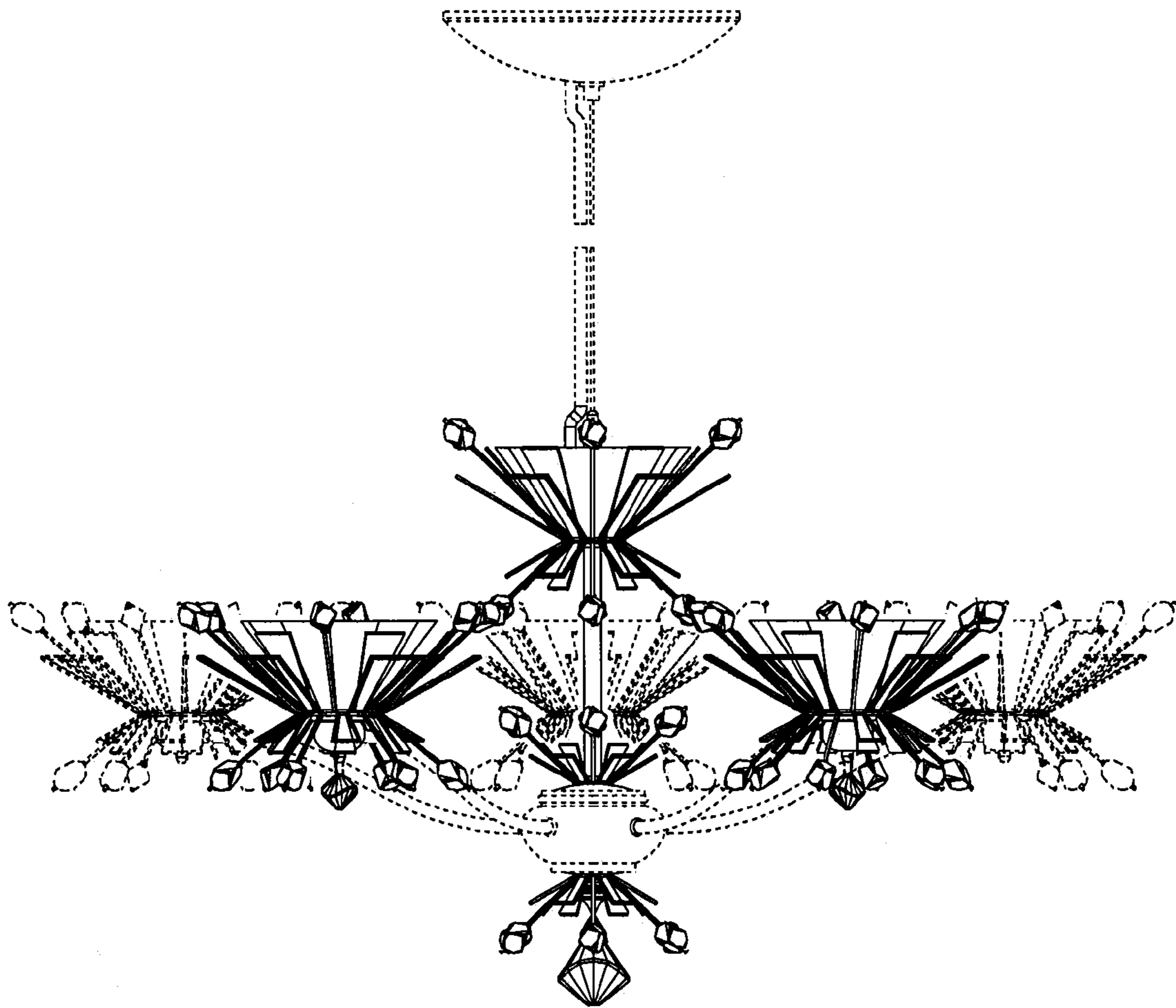

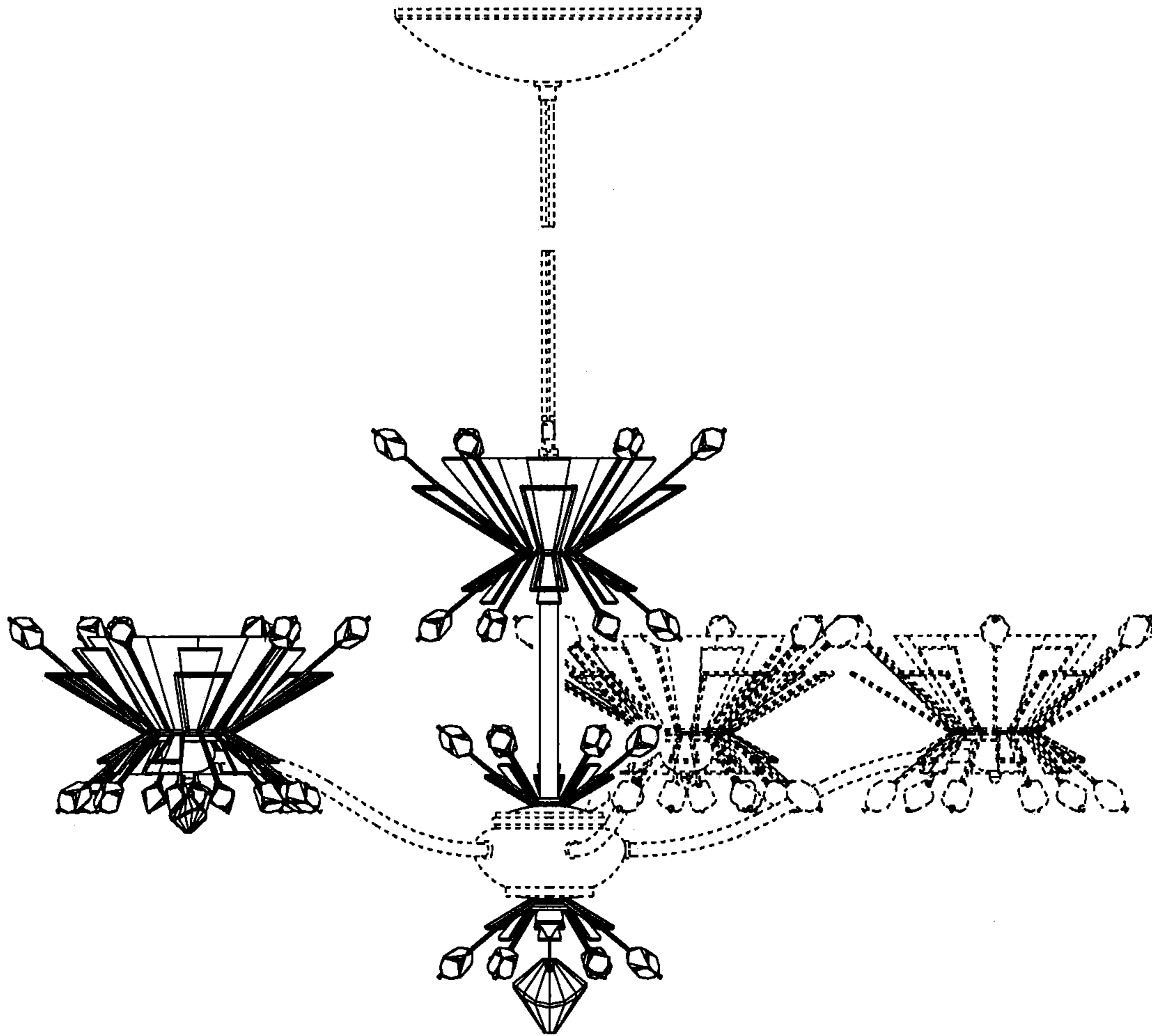

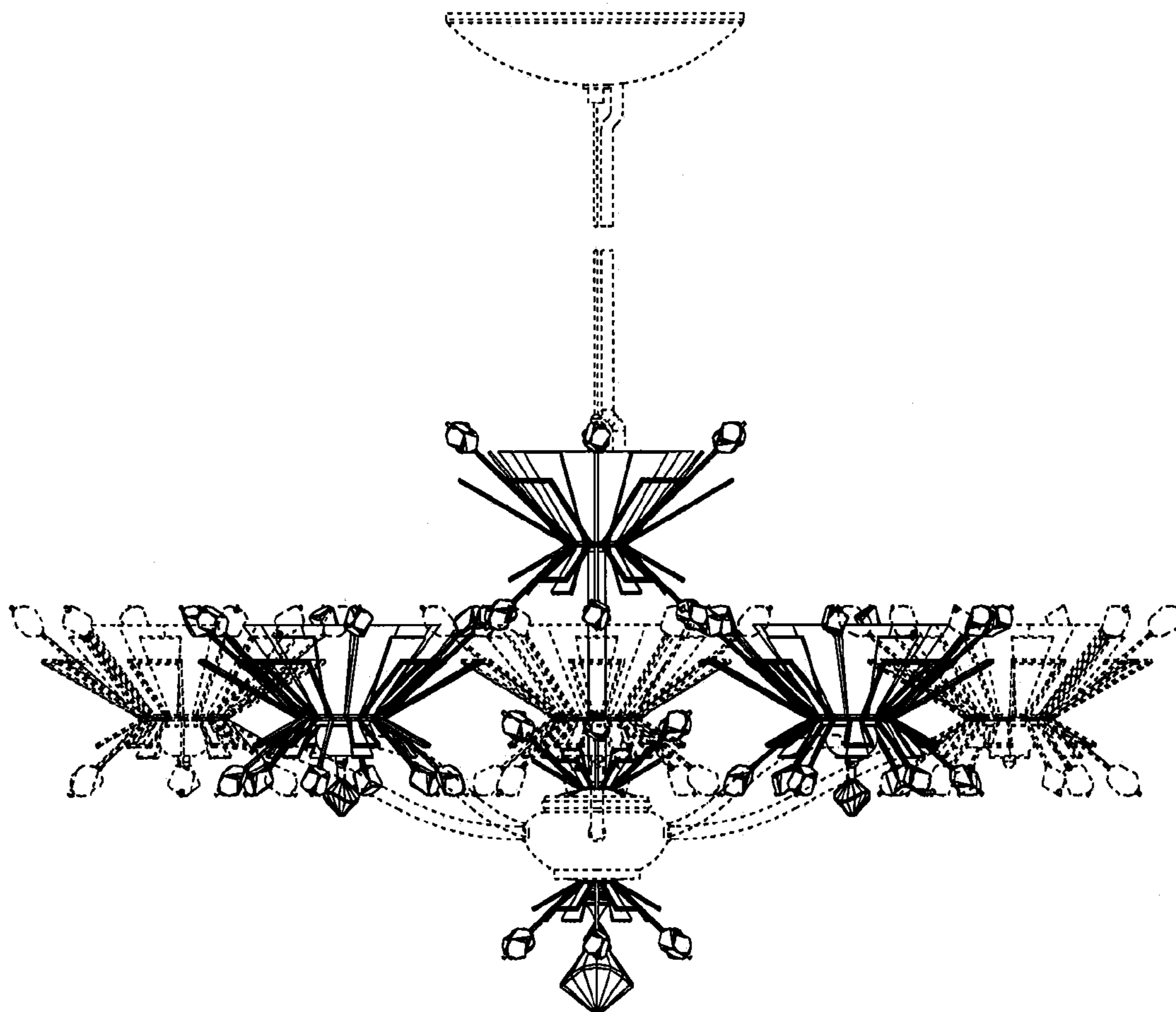

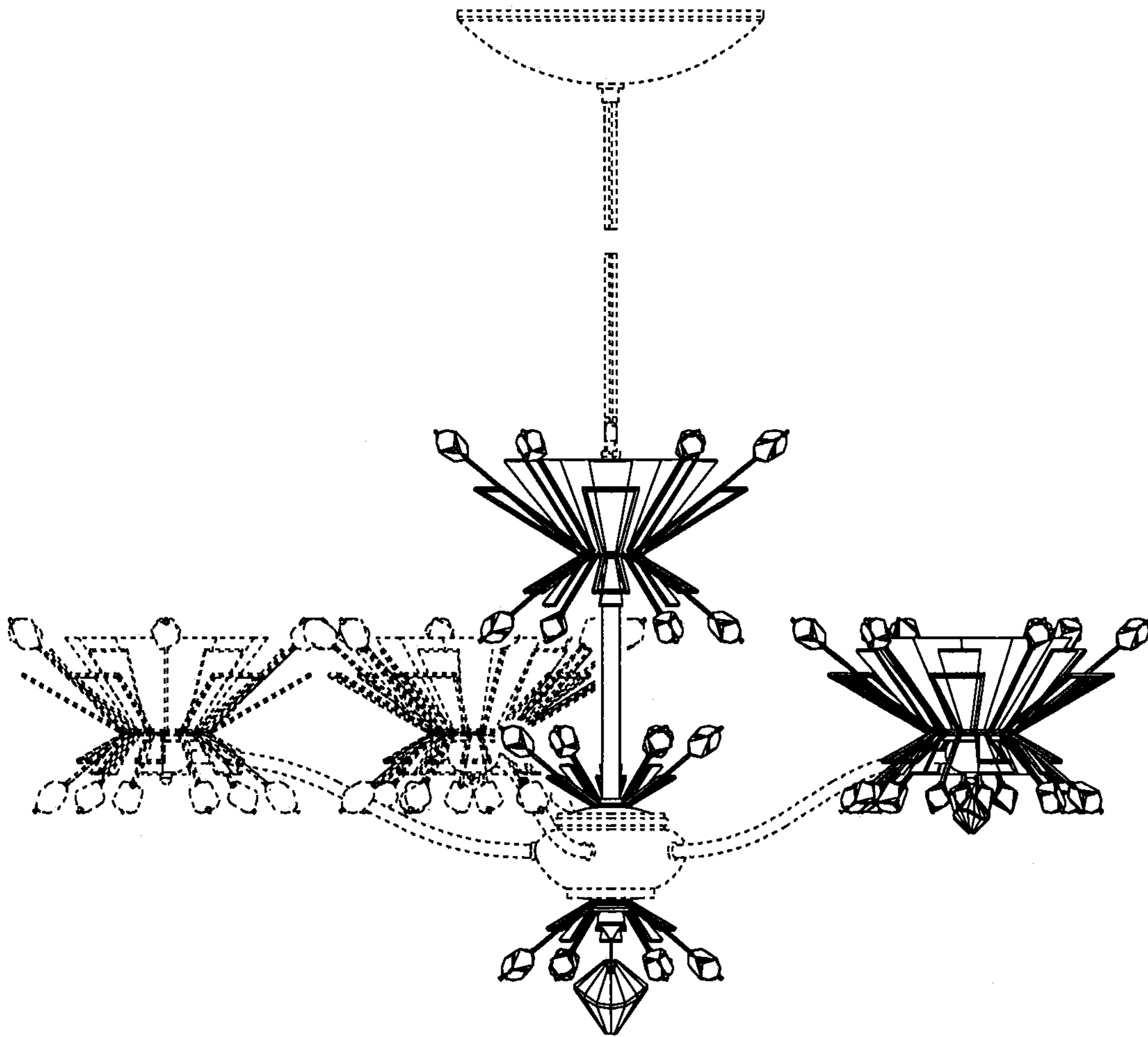

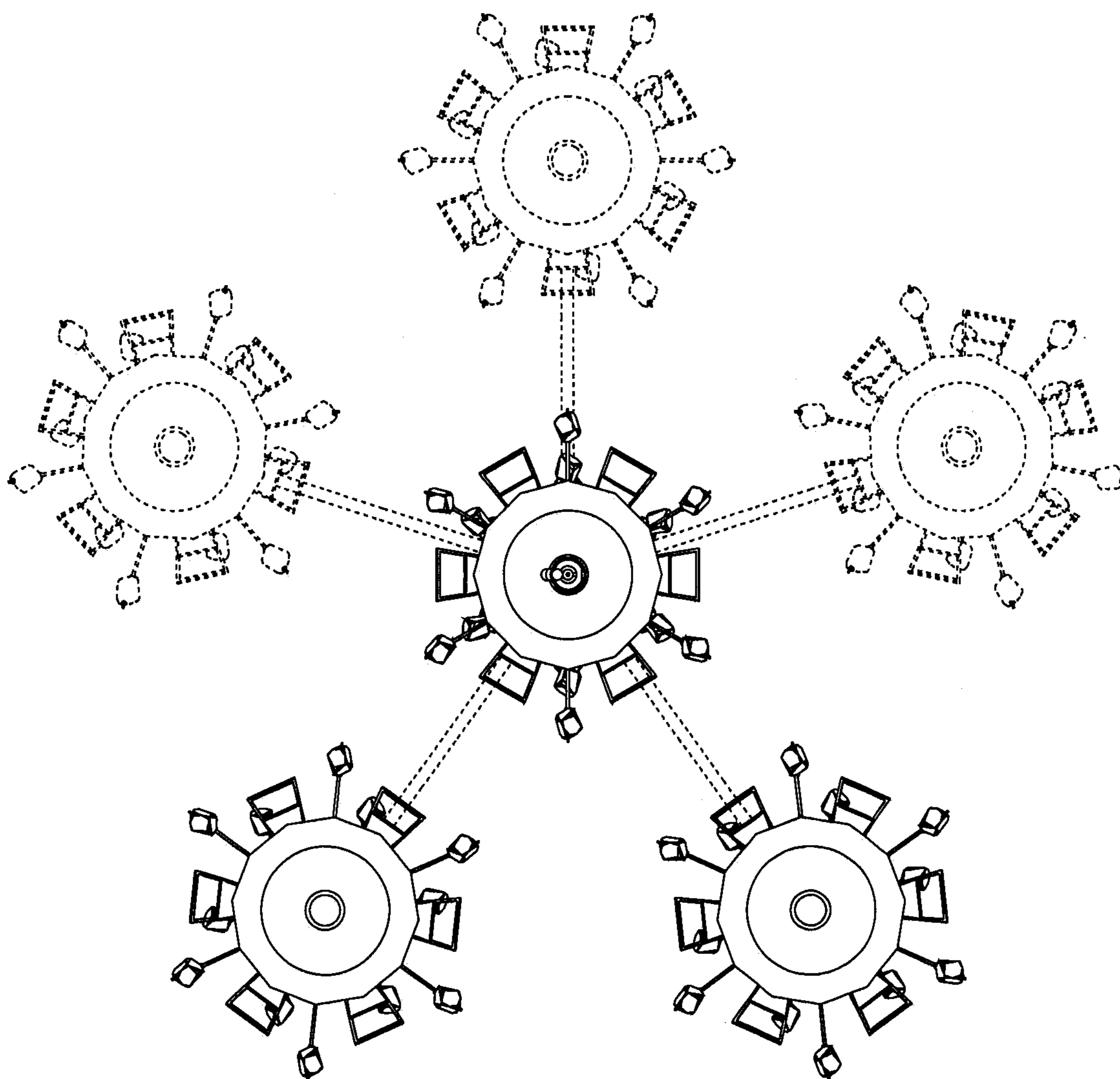

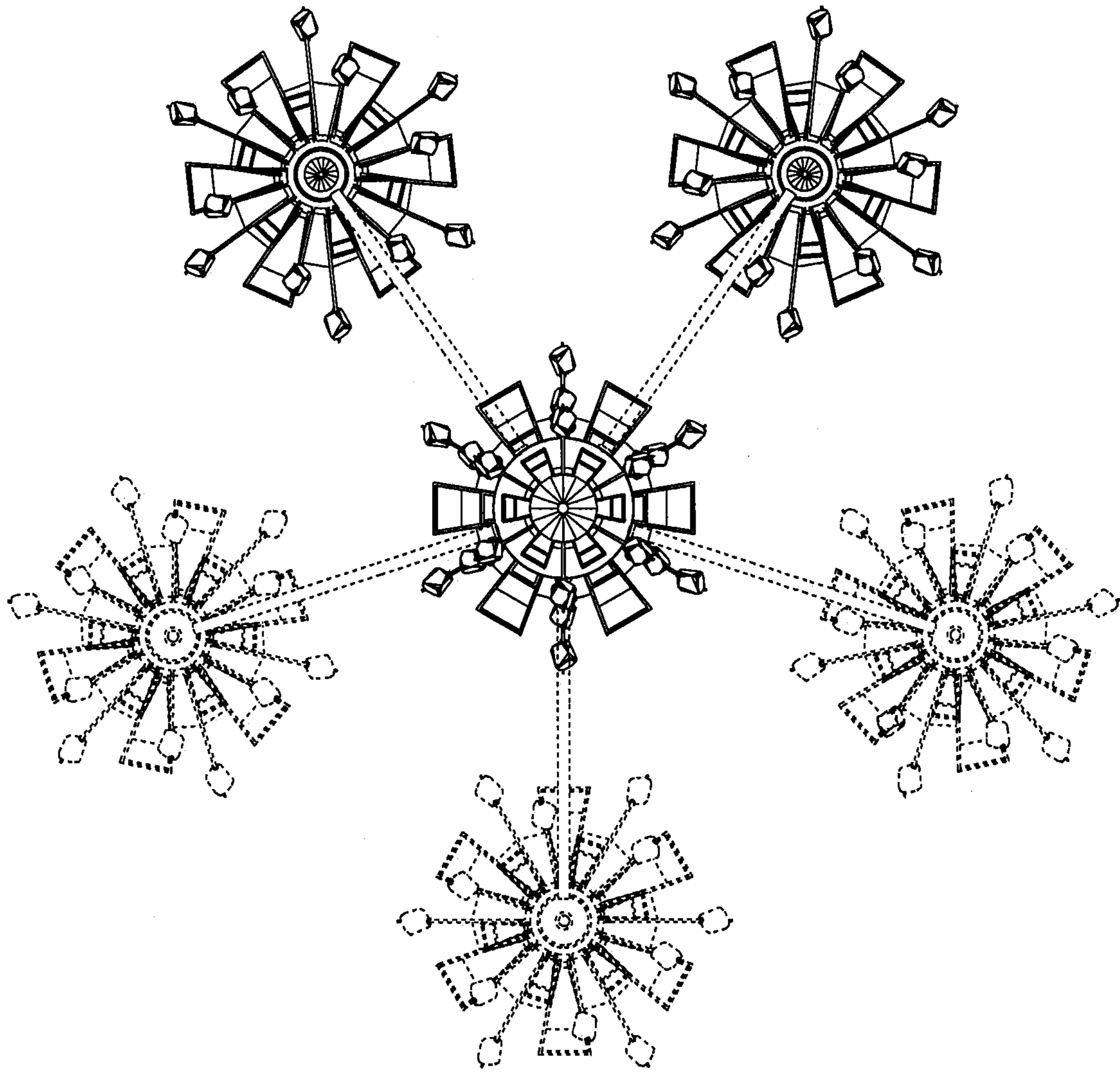

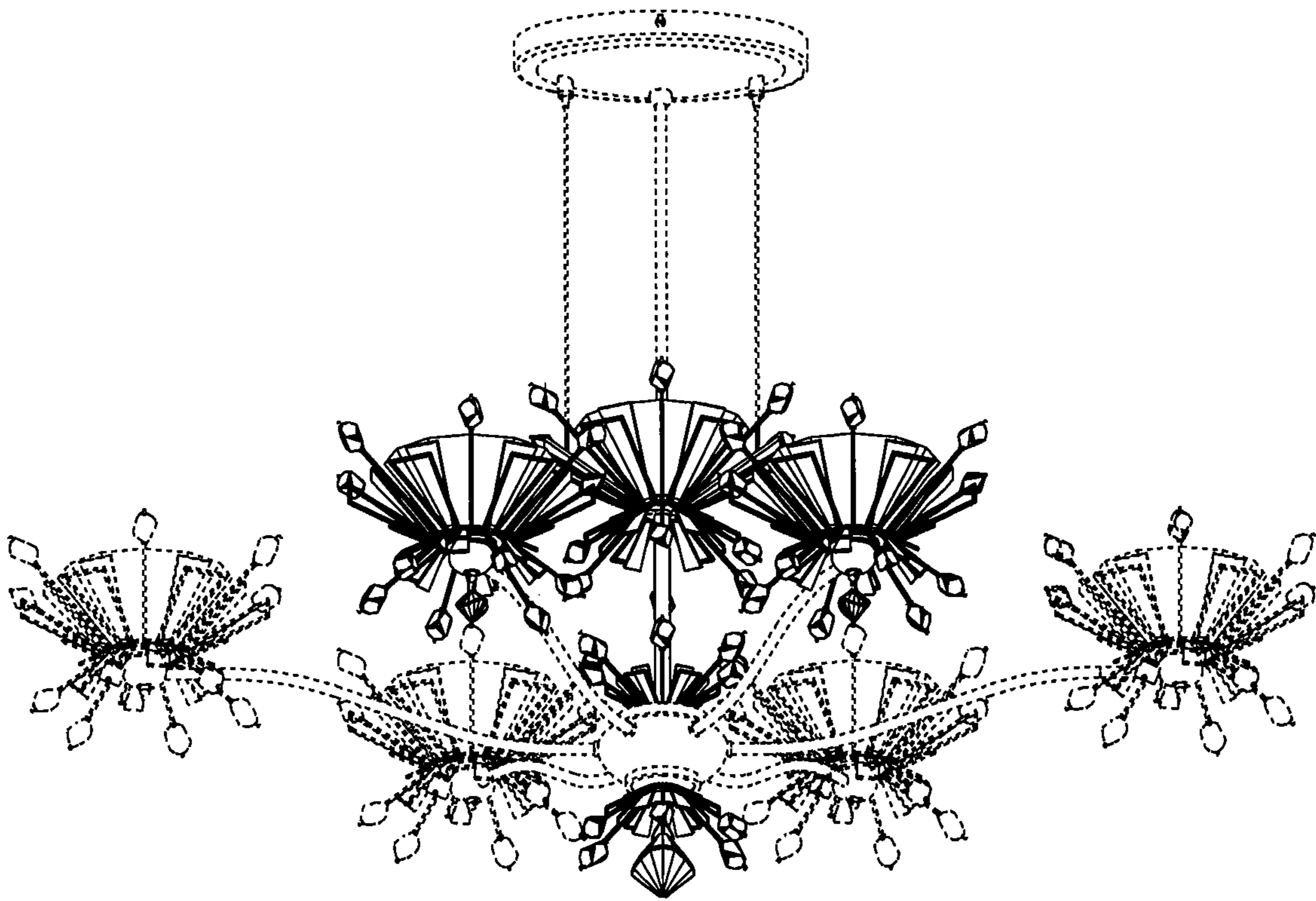

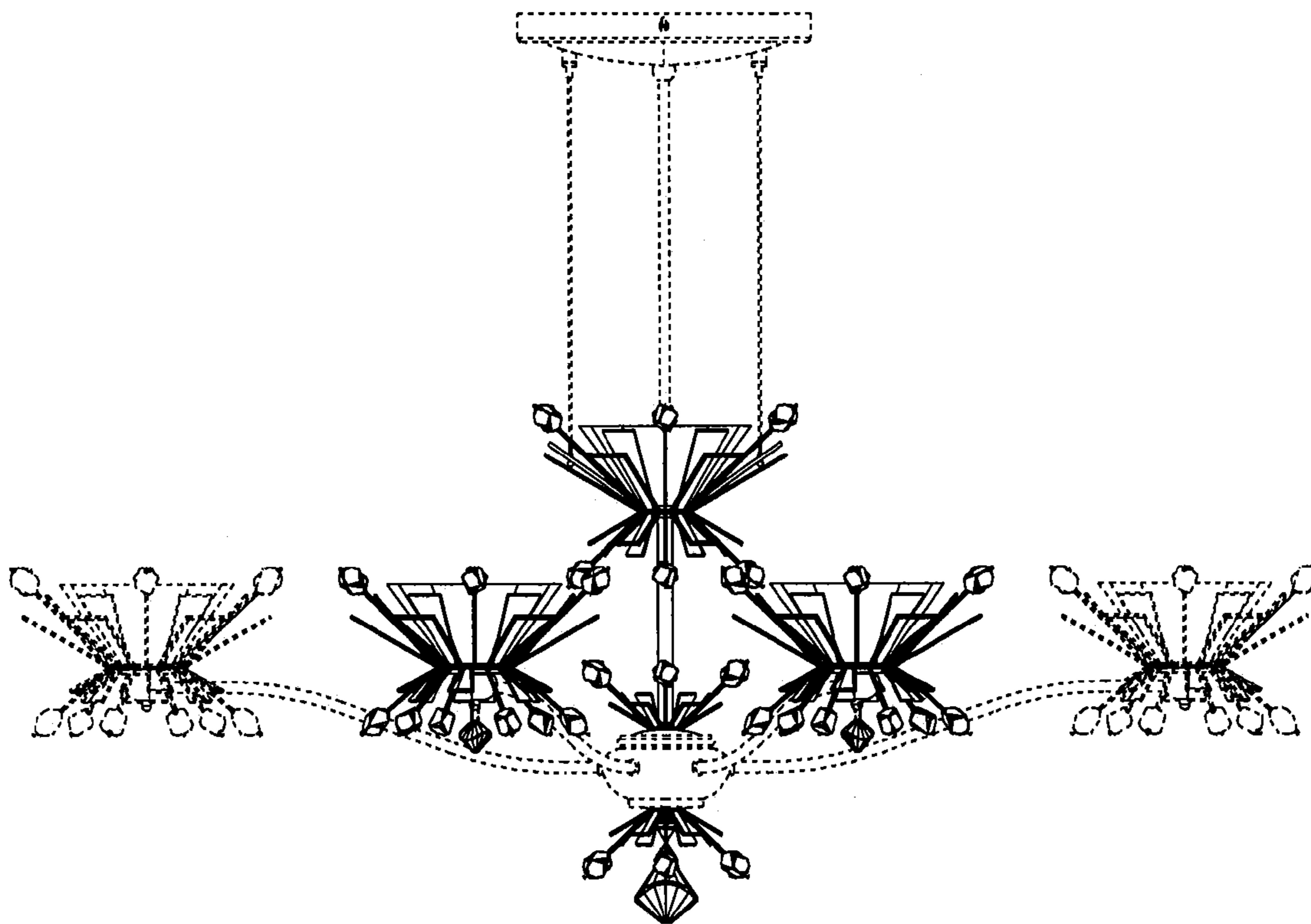

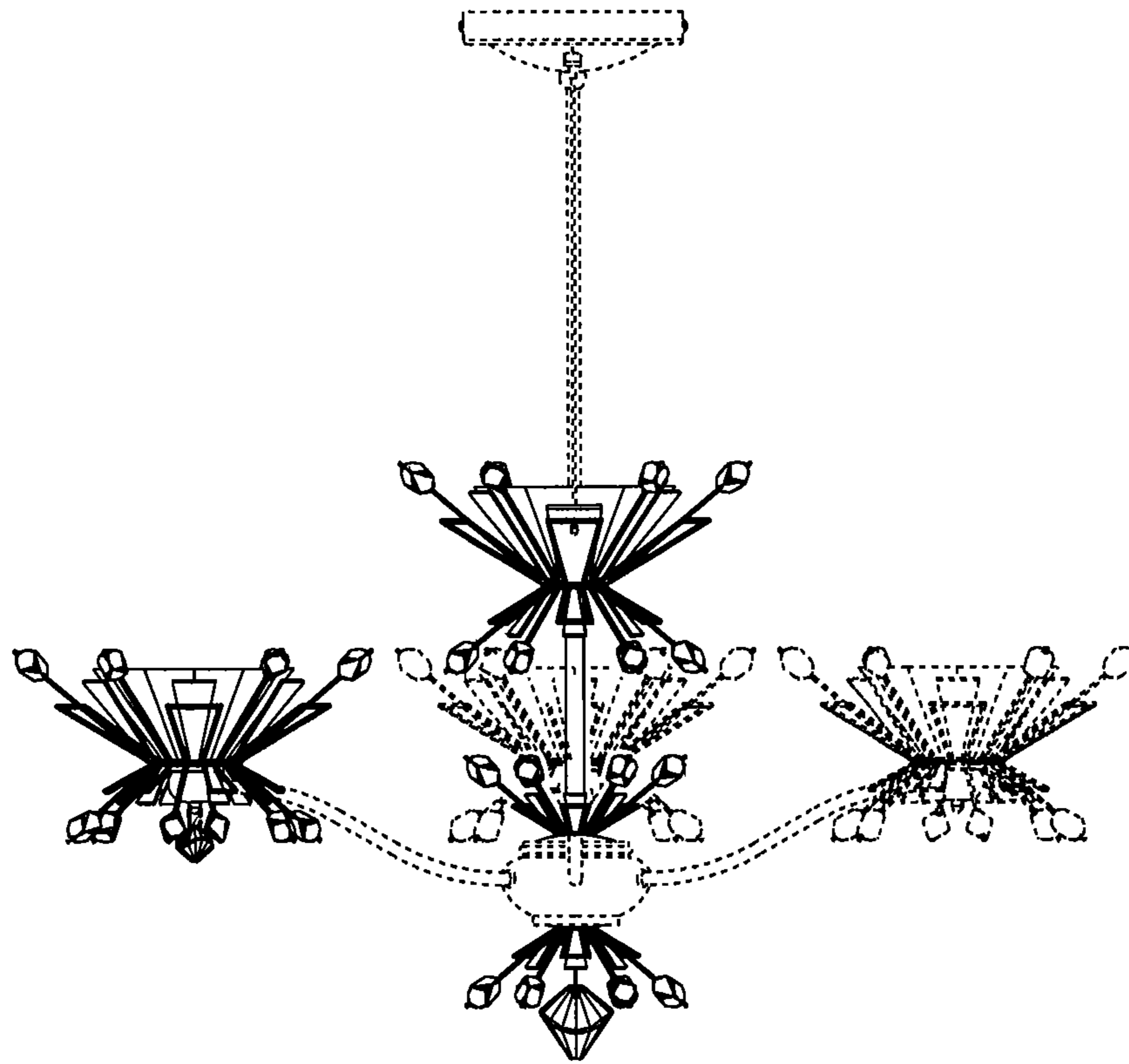

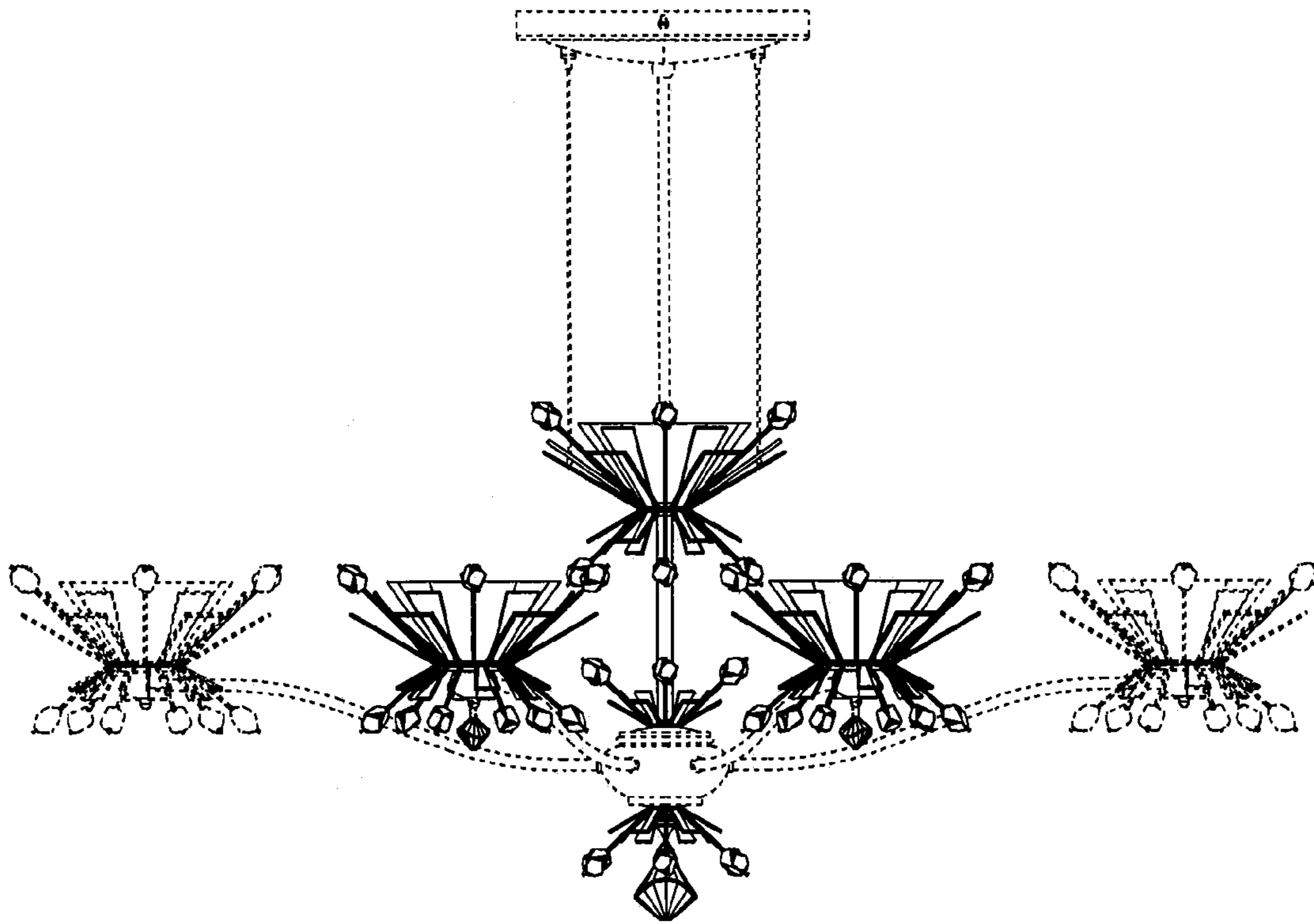

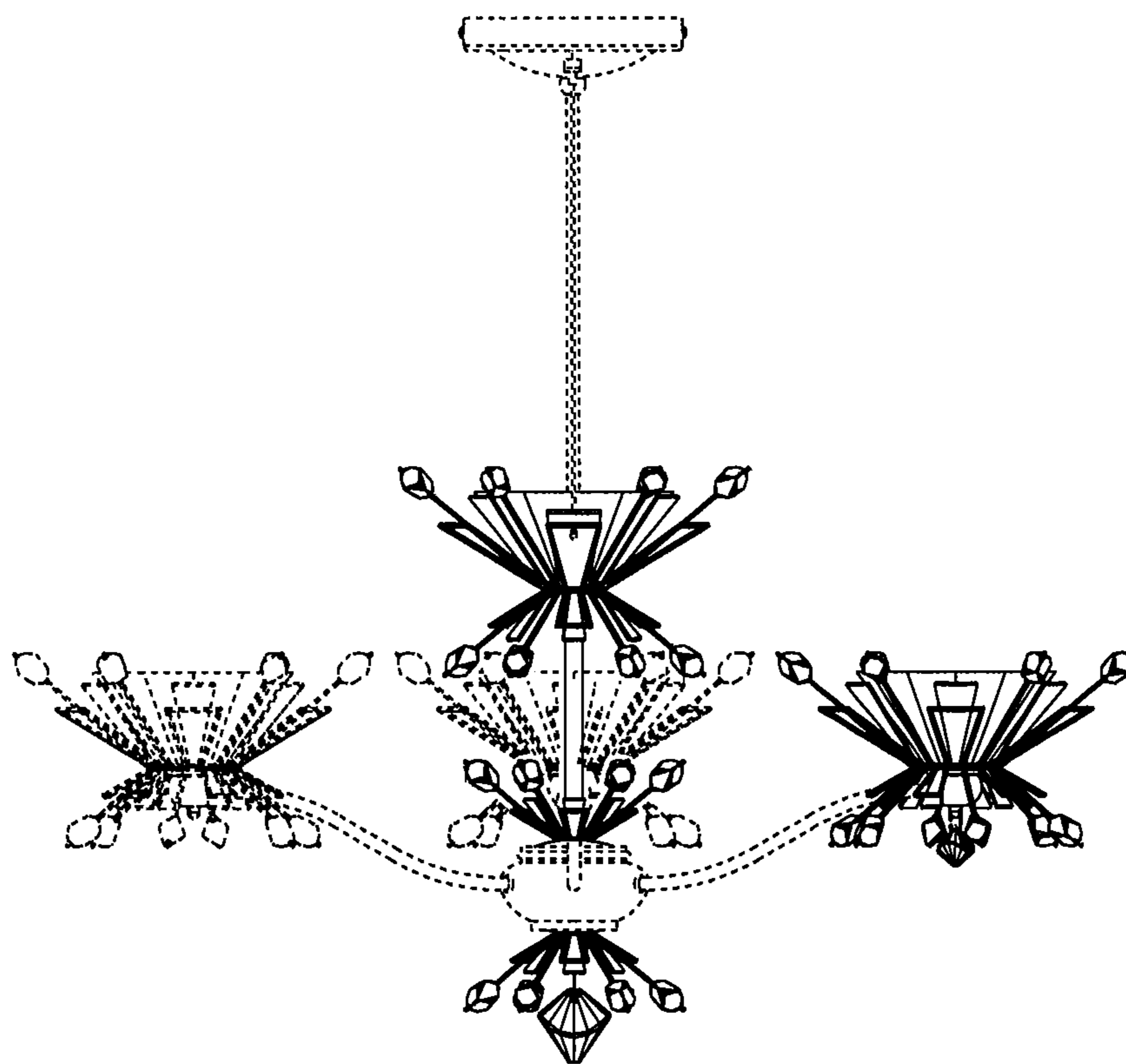

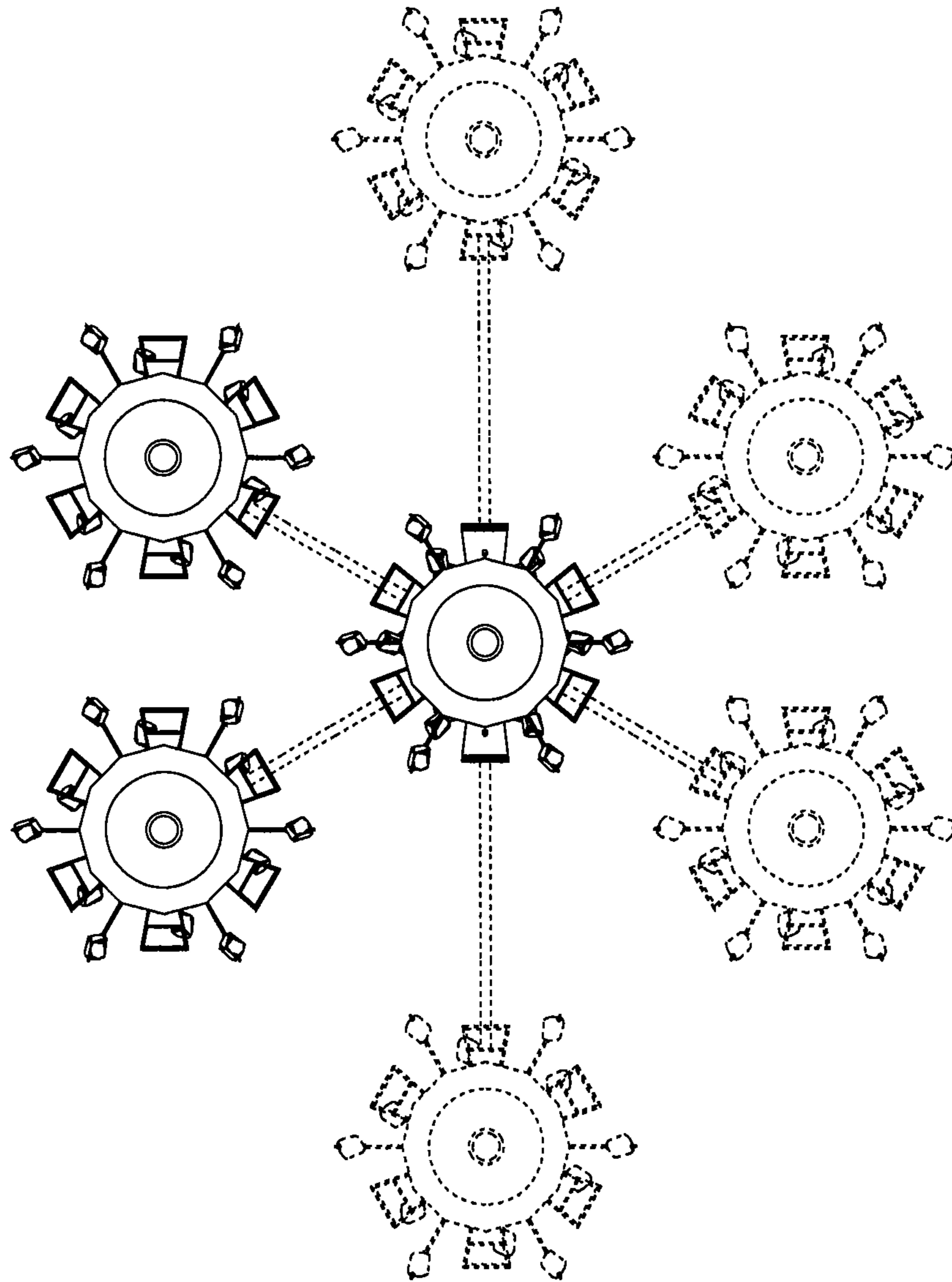

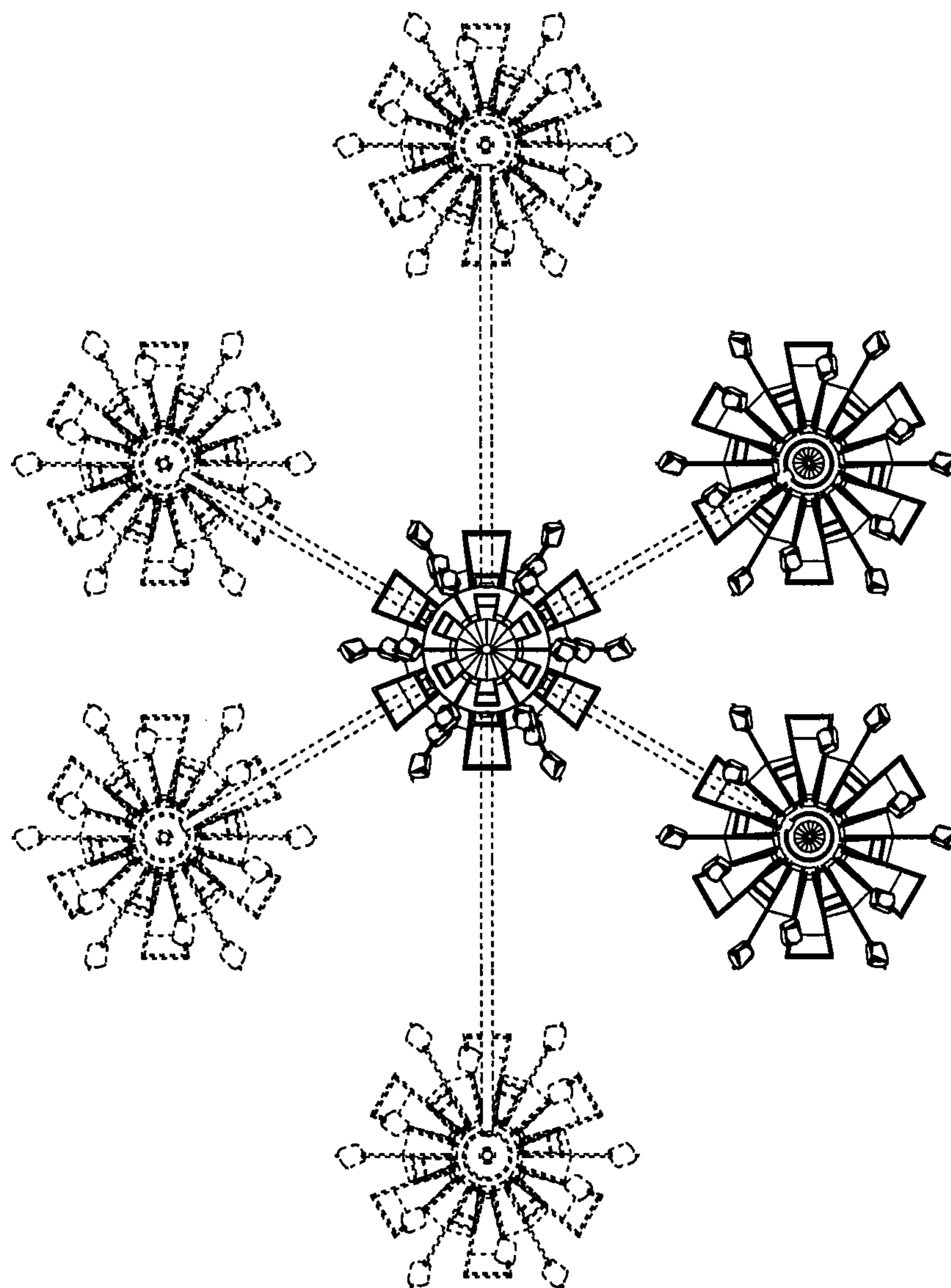
