(57) **CLAIM**

The ornamental design for a hummingbird feeder, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hummingbird feeder in  
accordance with the present invention, wherein a perspective  
view from the opposite side is substantially a mirror image of  
FIG. 1;

FIG. 2 is a front elevation view of the hummingbird feeder of  
FIG. 1;

FIG. 3 is a right elevation view of the hummingbird feeder of  
FIG. 1;

FIG. 4 is a rear elevation view of the hummingbird feeder of

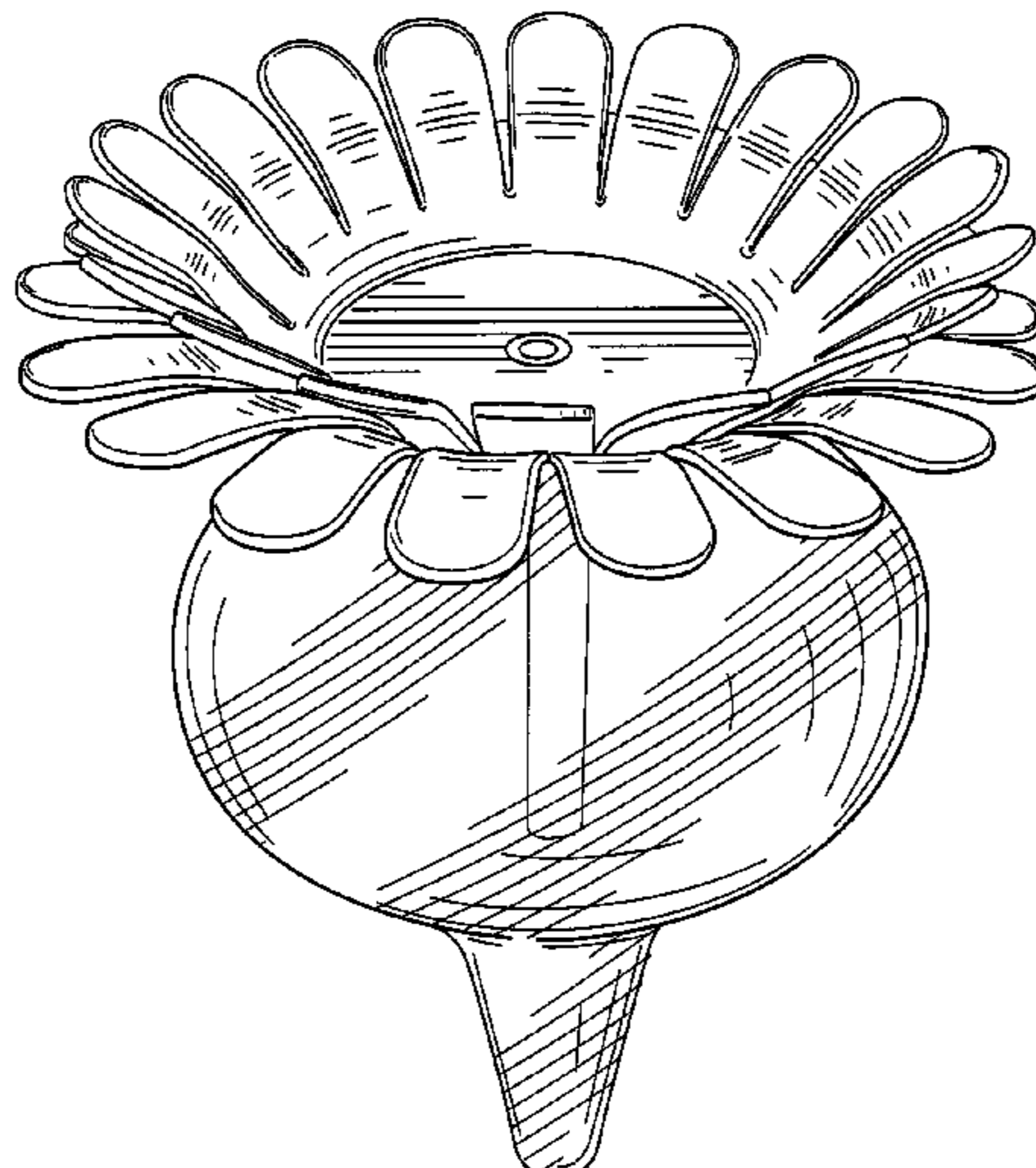

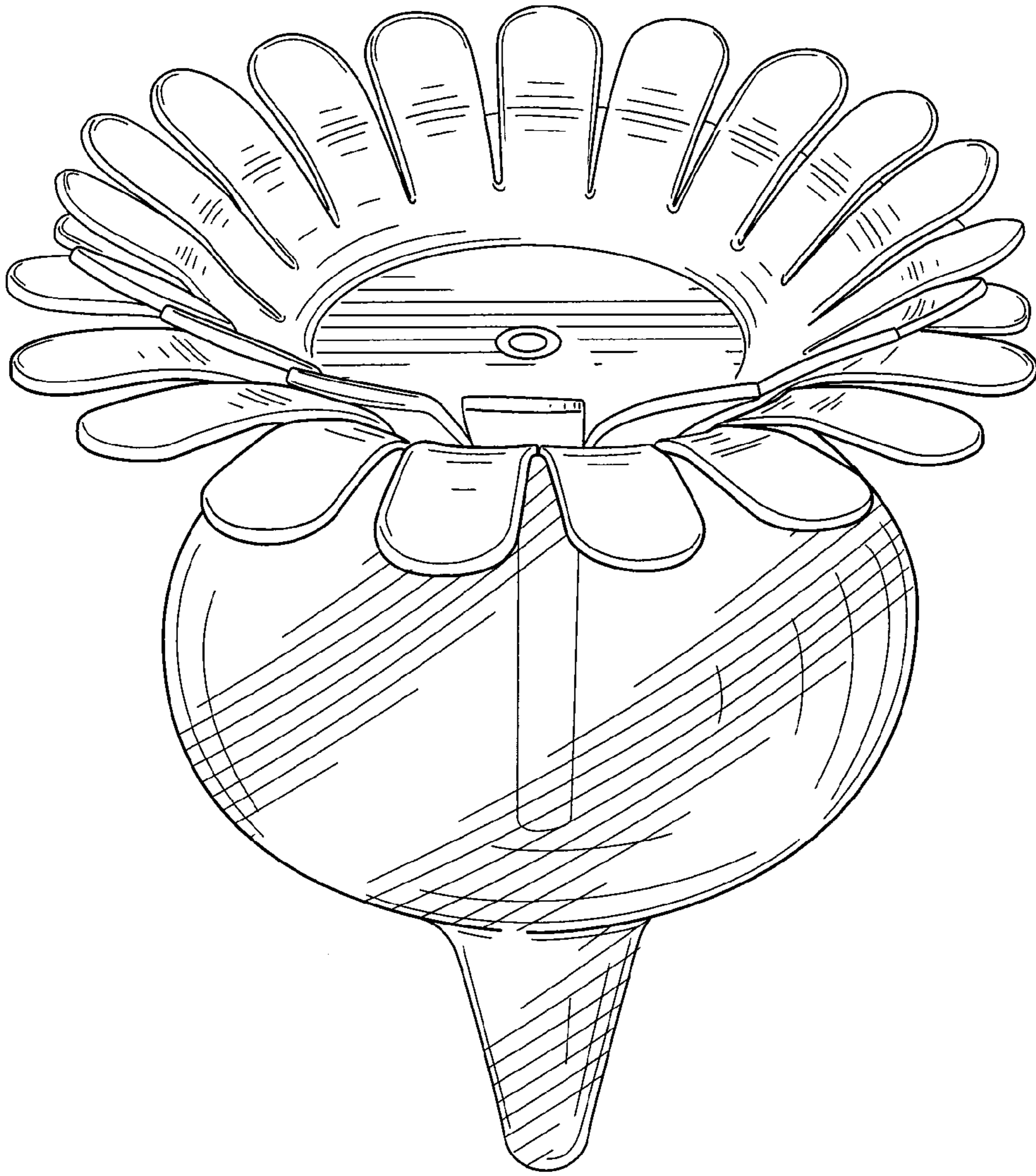

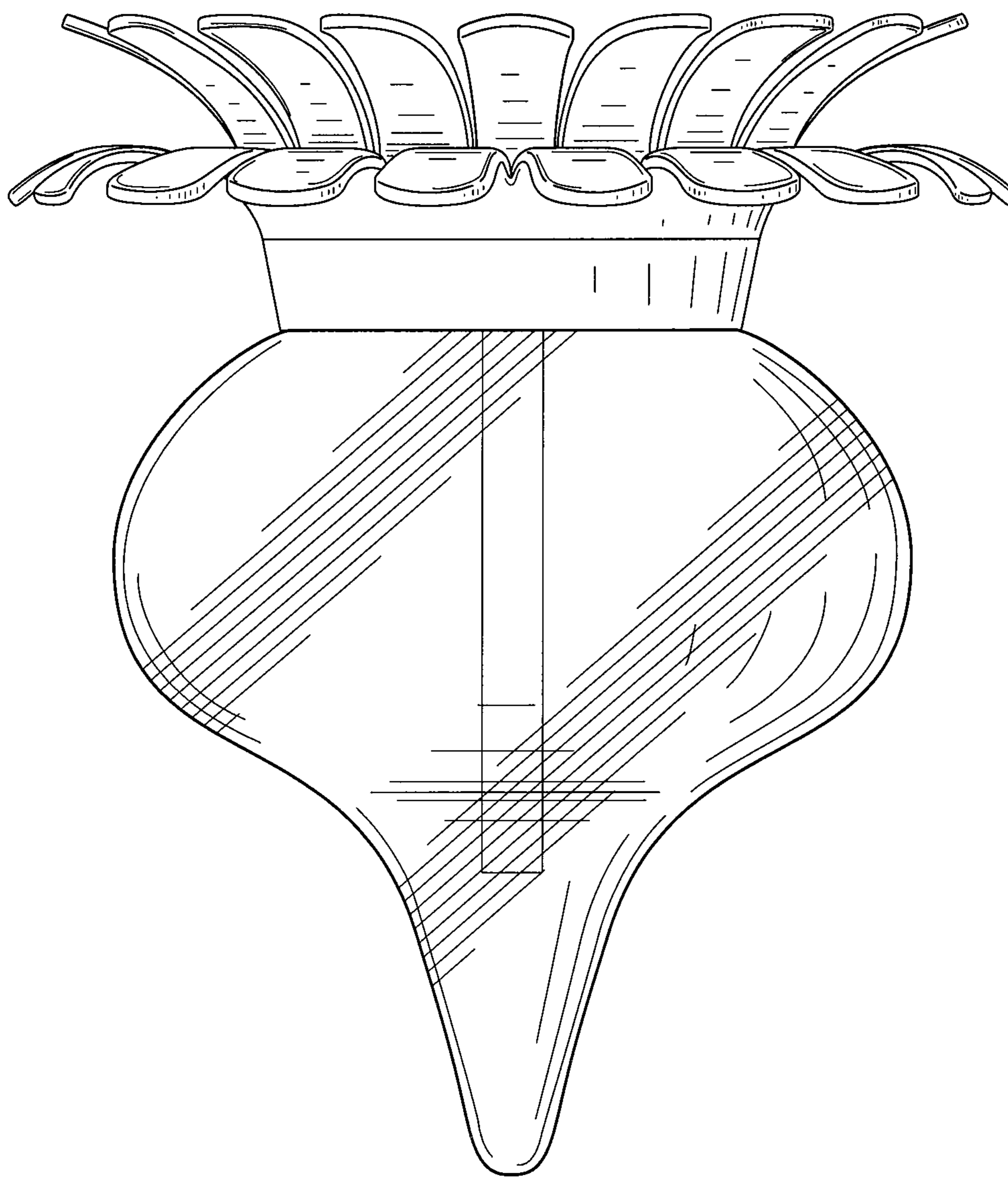

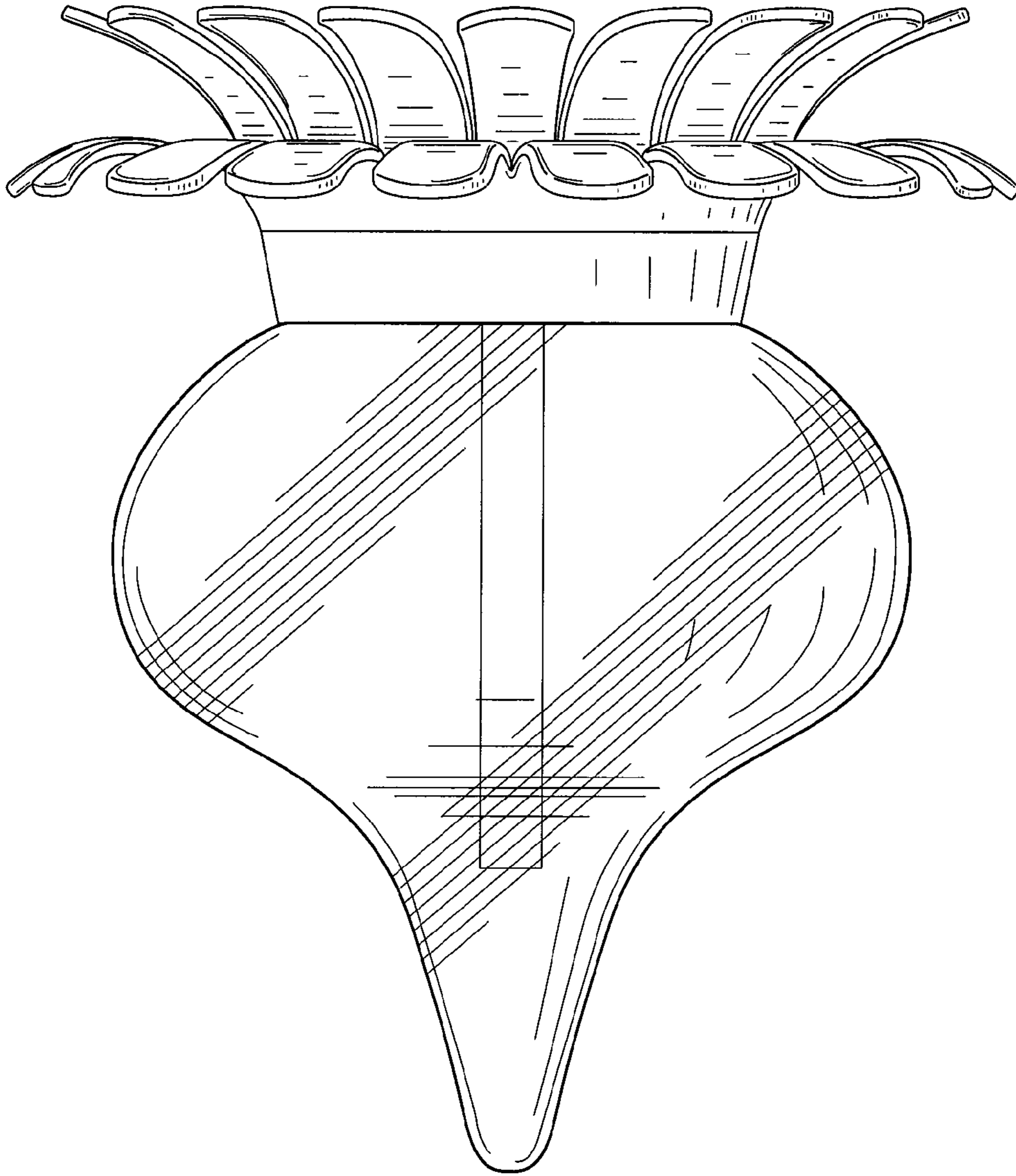

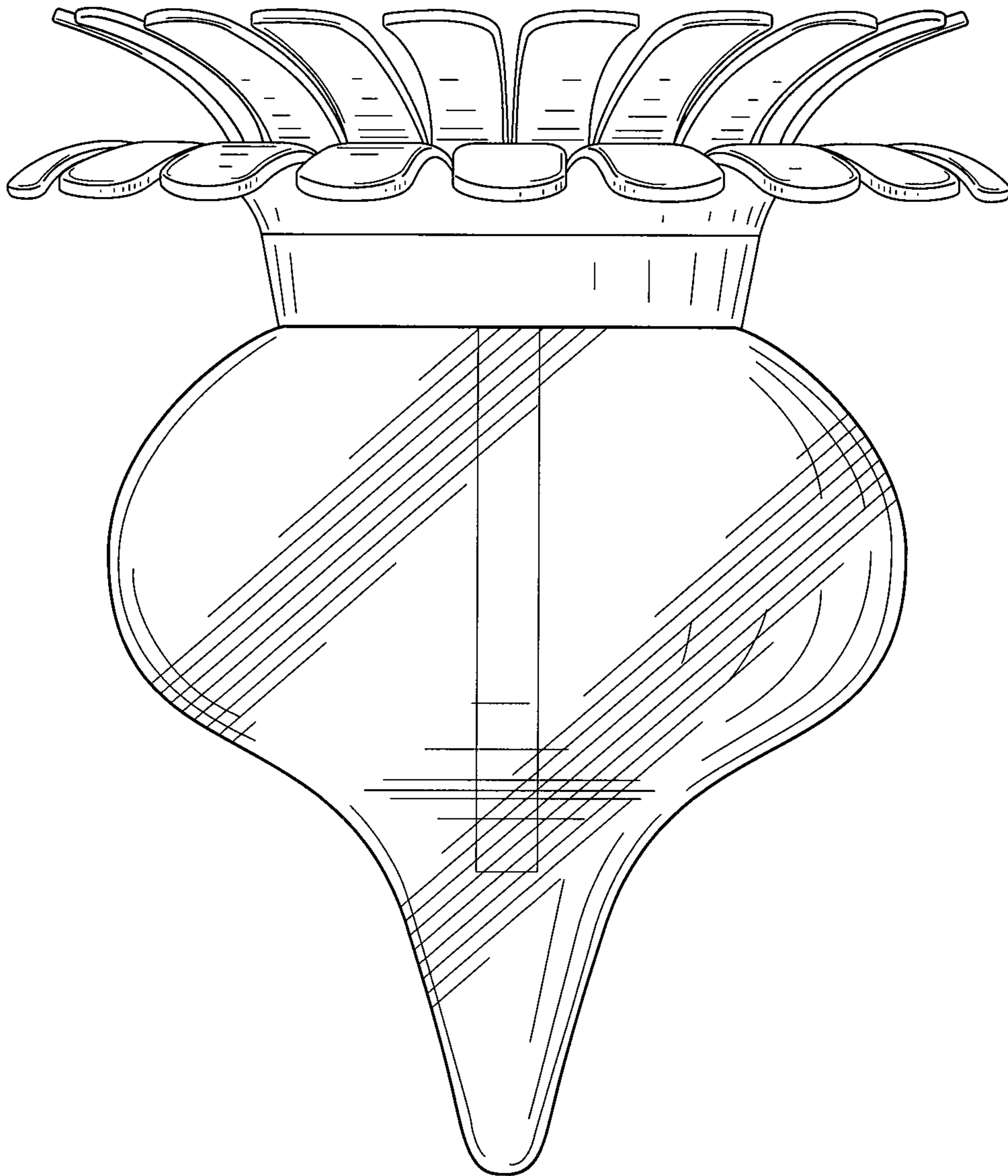
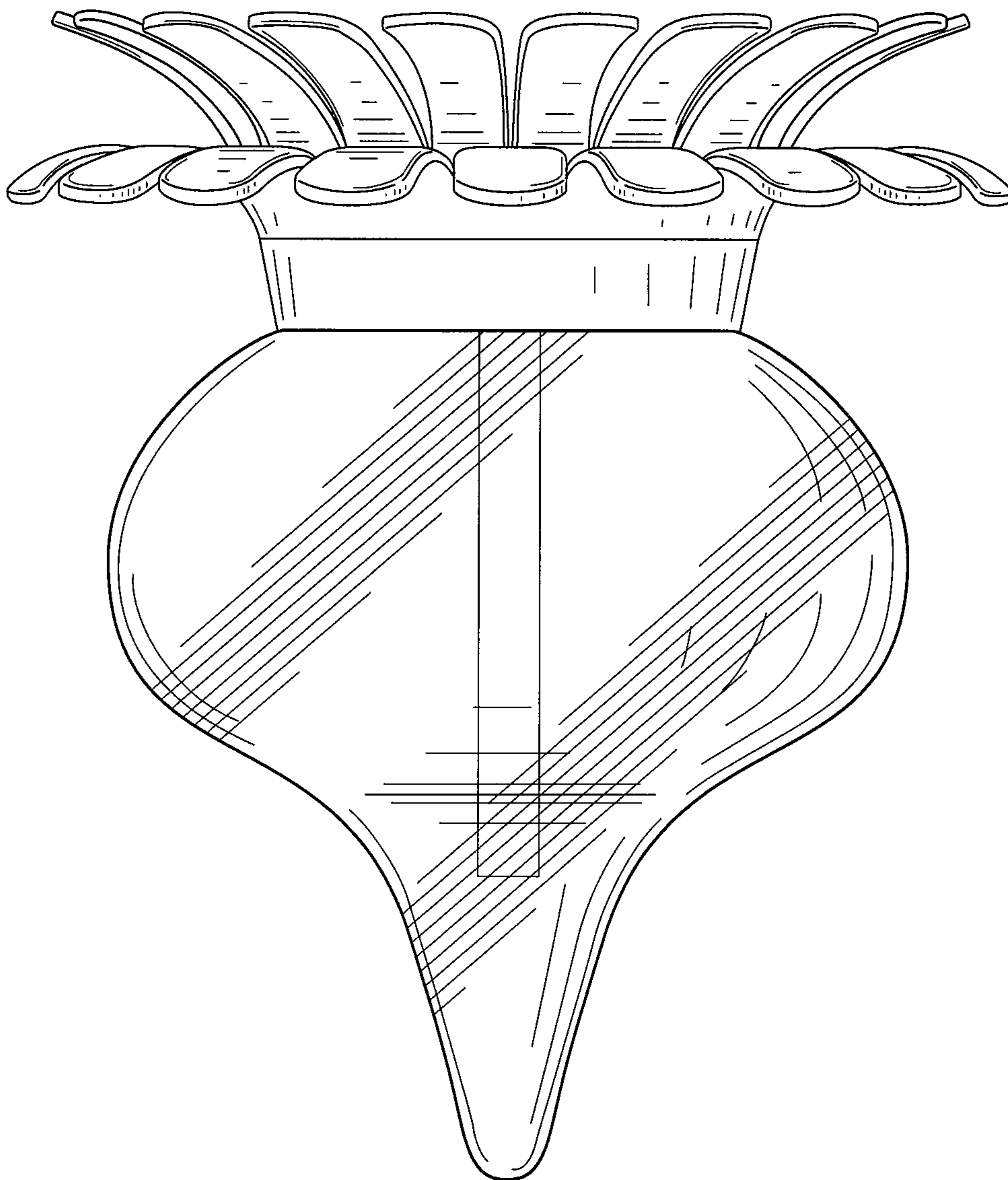

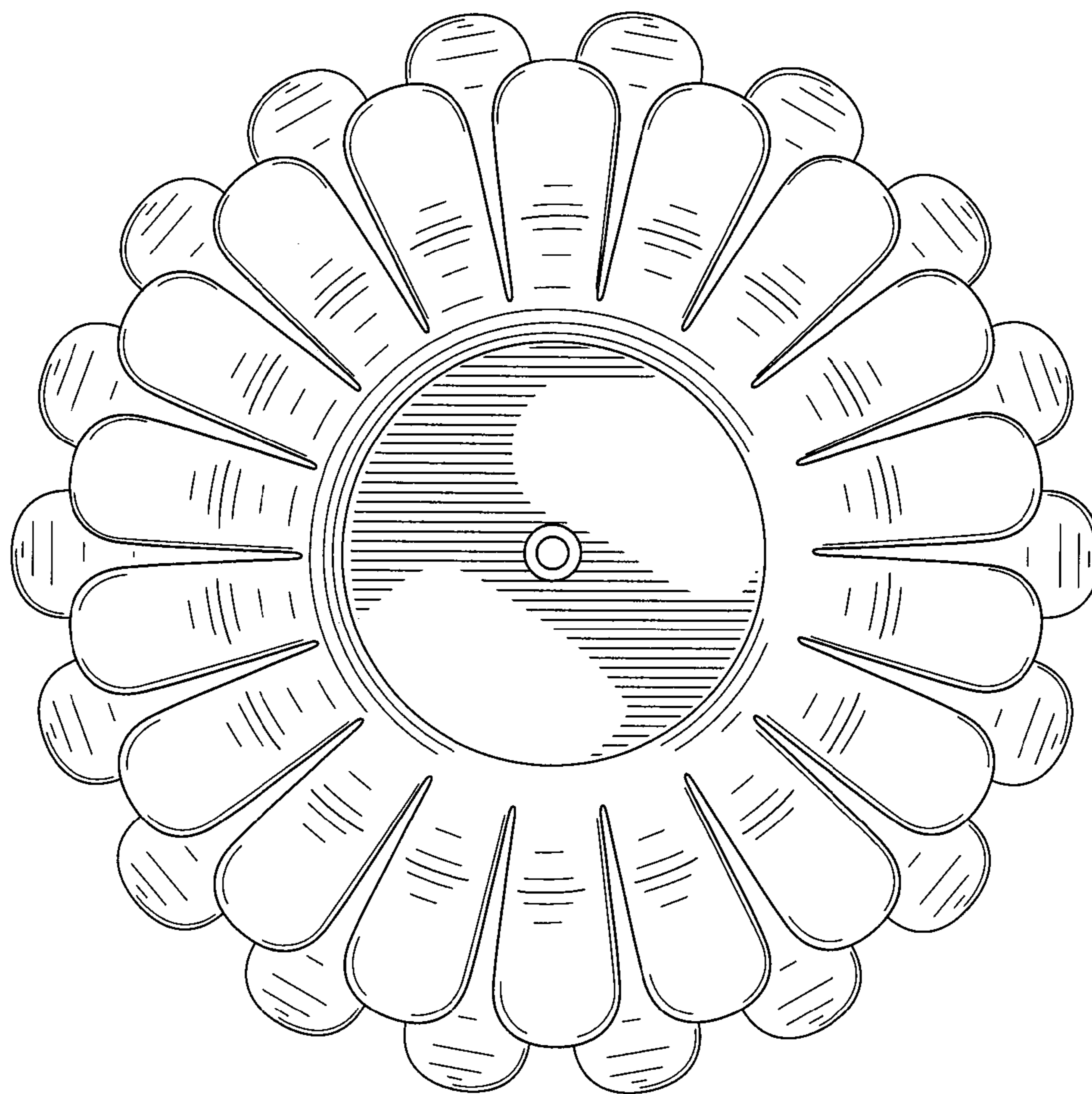
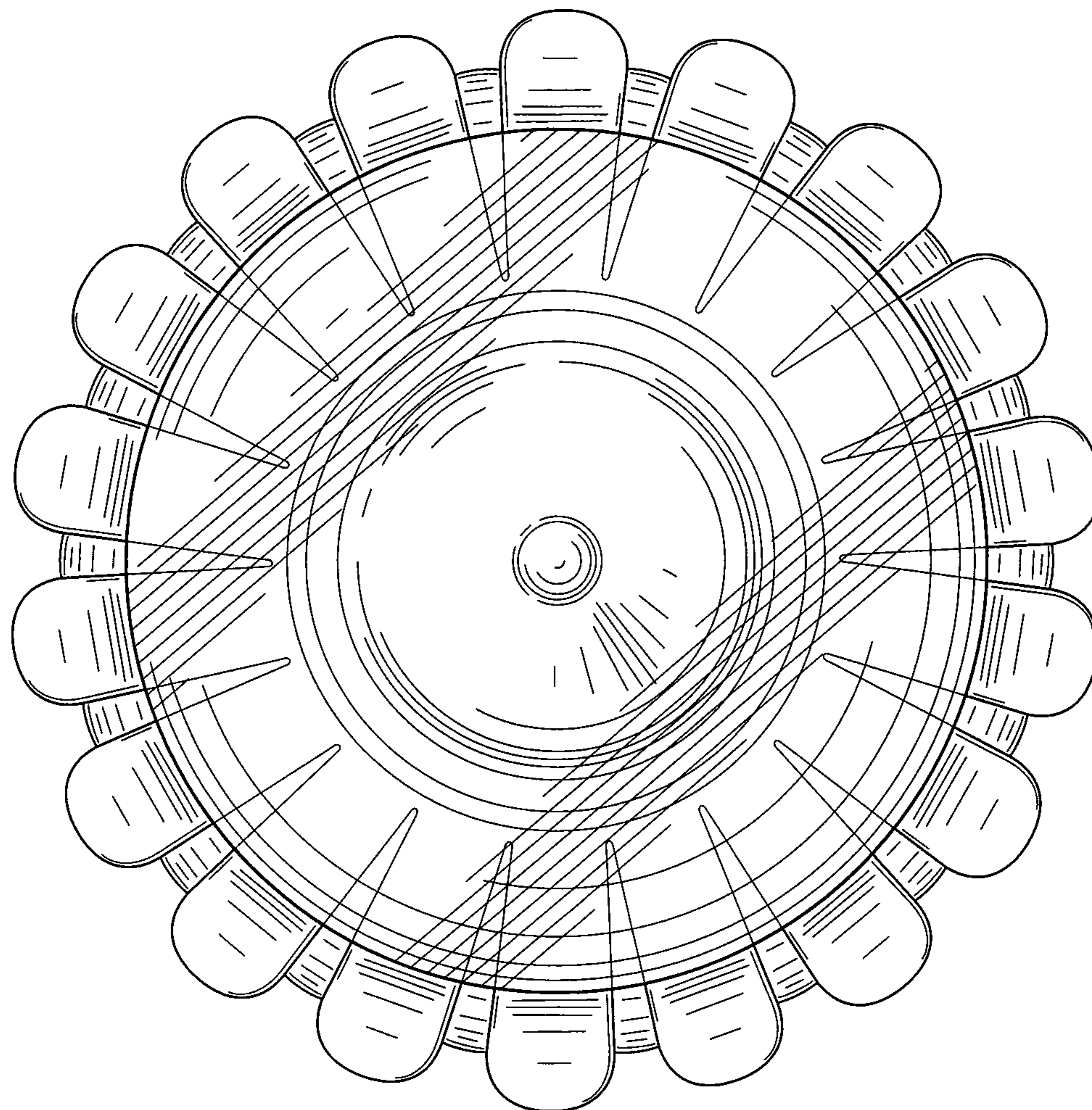

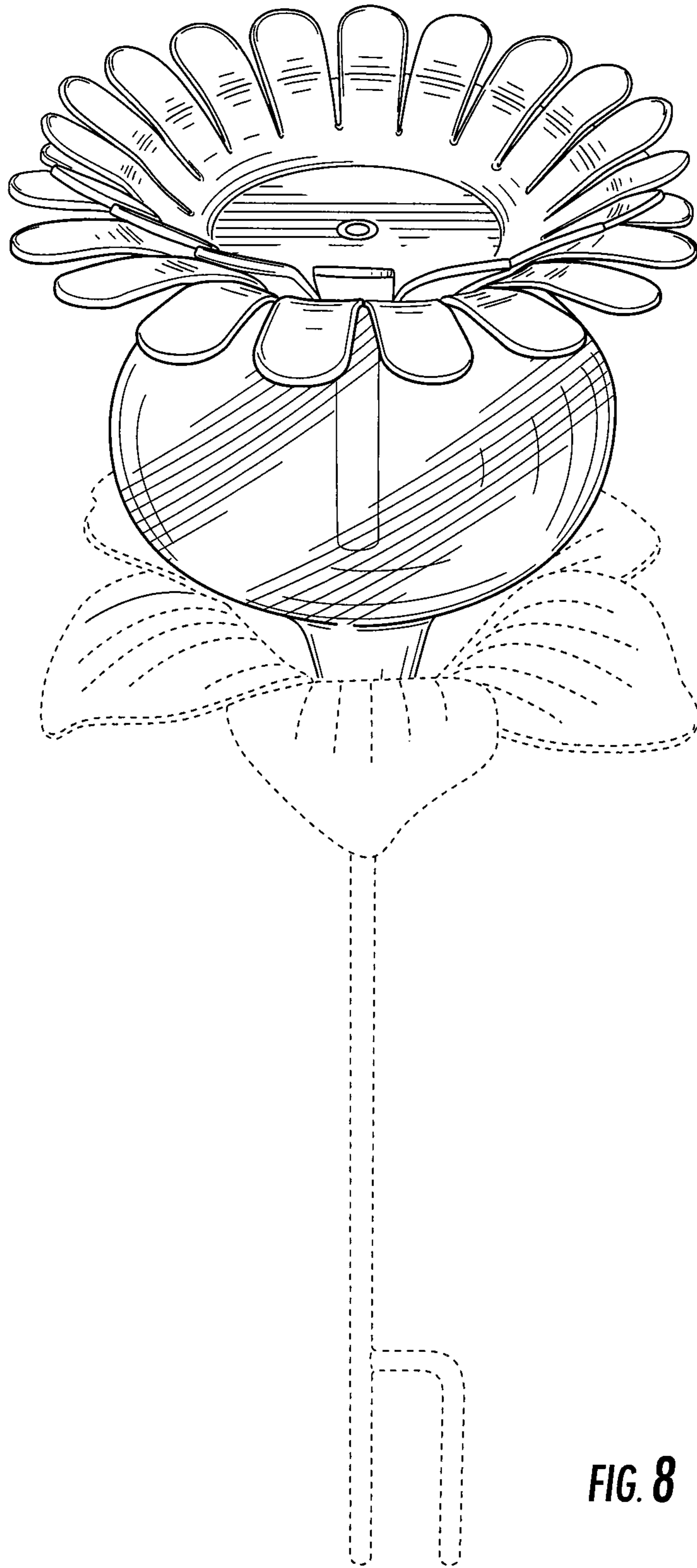
