DESCRIPTION

FIG. 1 is a frontal isometric view of our trailer leveling block; FIG. 2 is a bottom isometric view thereof; FIG. 3 is a front plan view thereof; FIG. 4 is a rear plan view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is a longitudinal sectional view taken generally along line 9-9 of FIG. 7 showing depth of internal orifices for compliance with 35 USC Sec. 112.

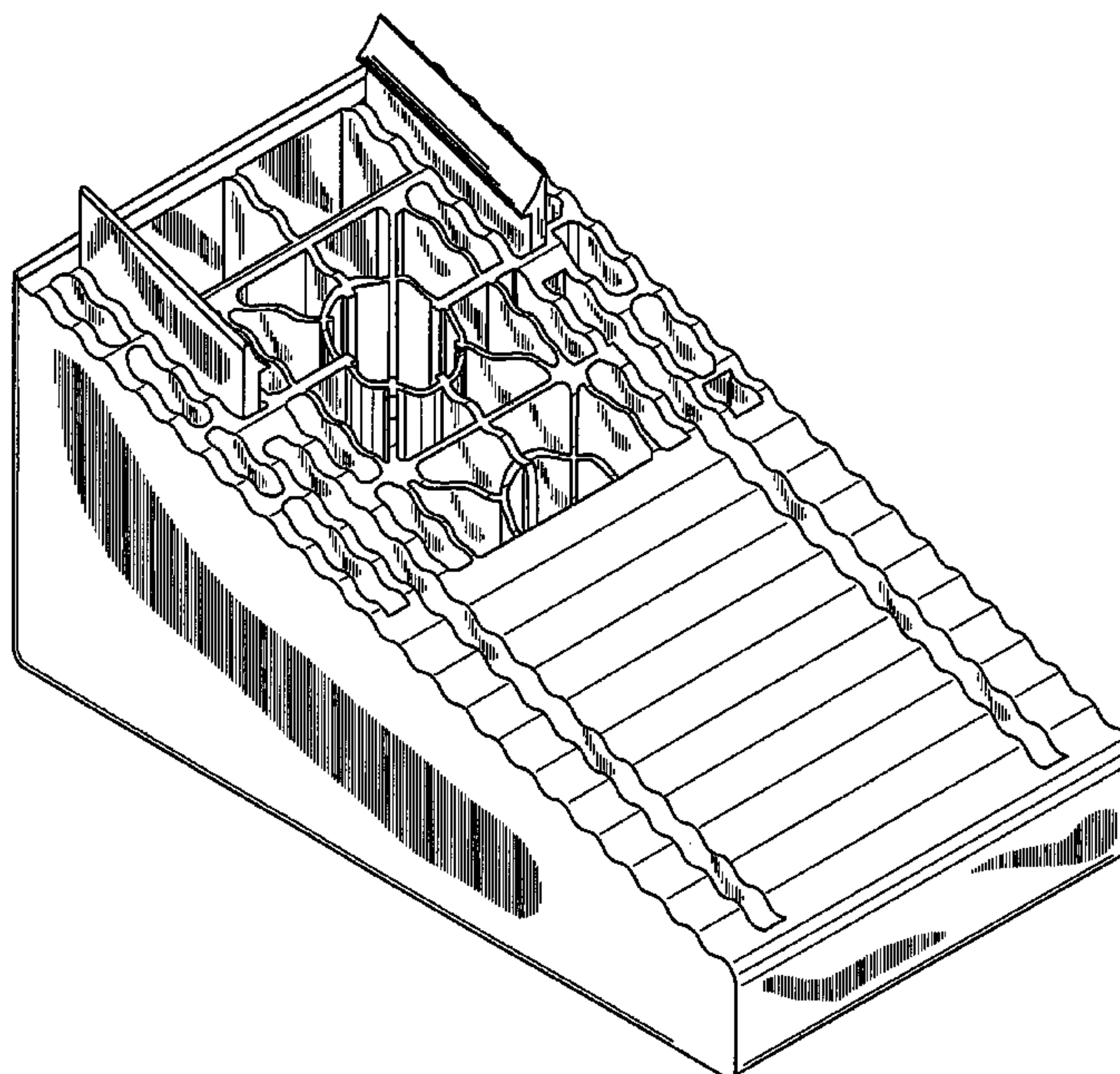

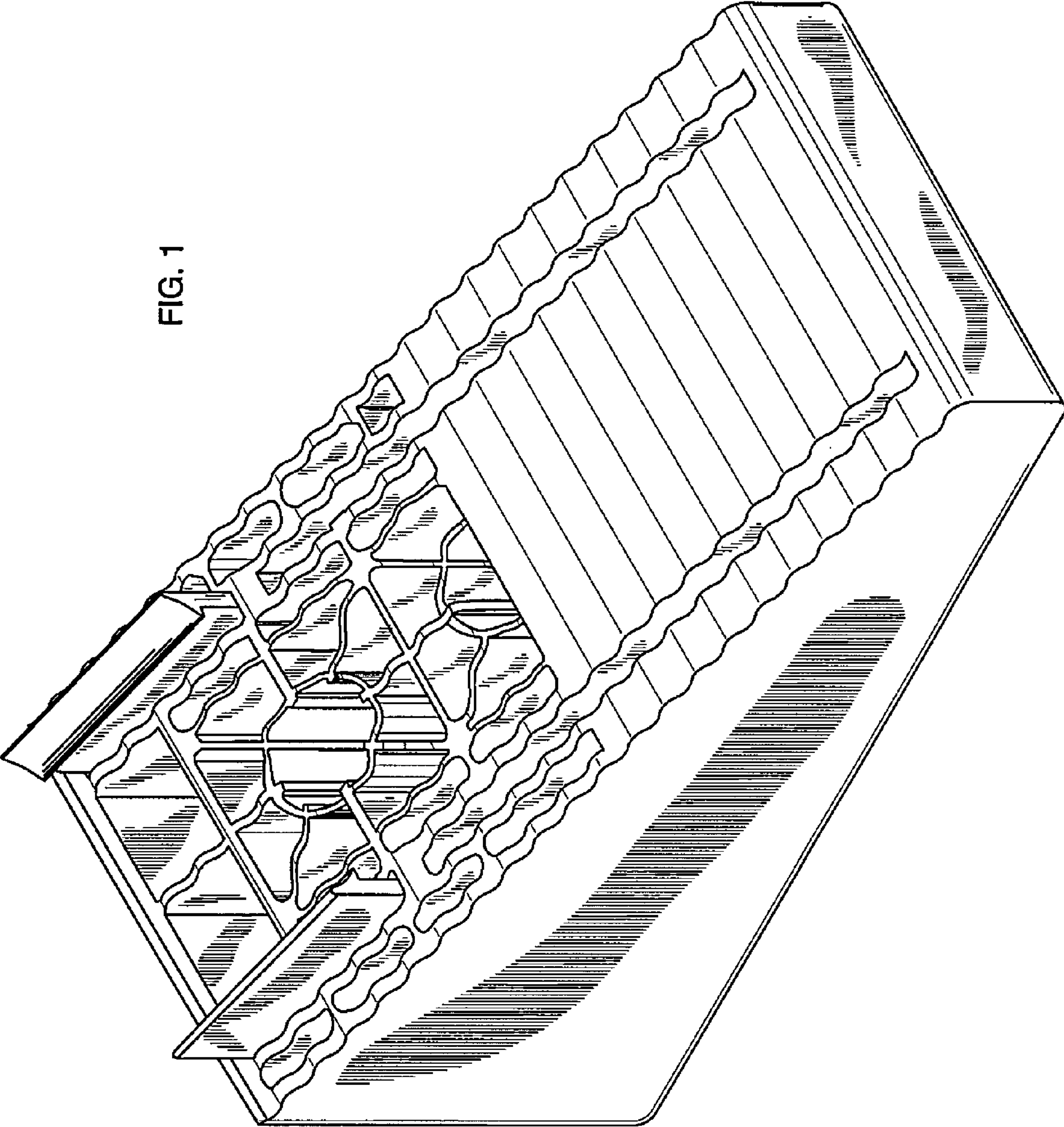

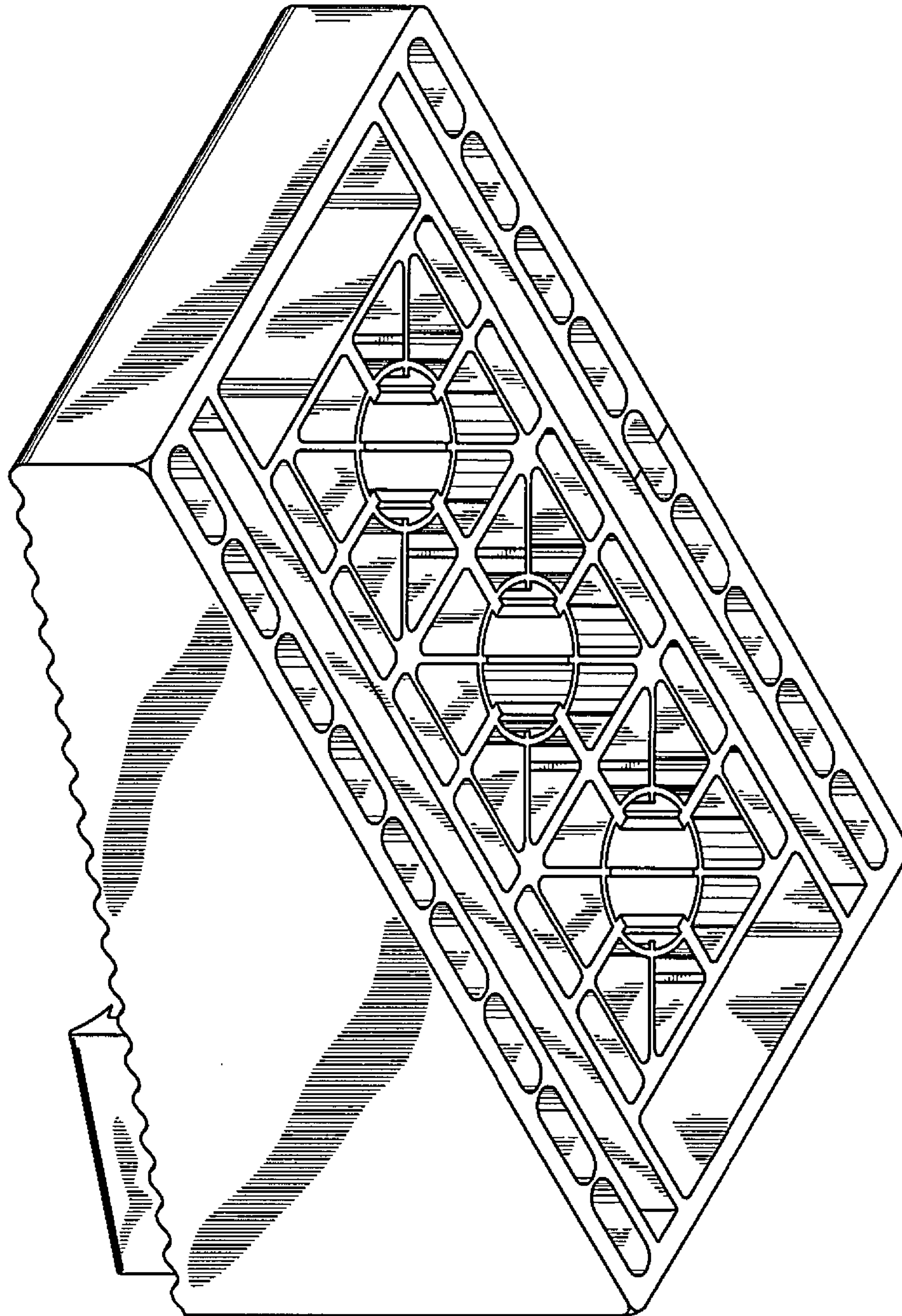

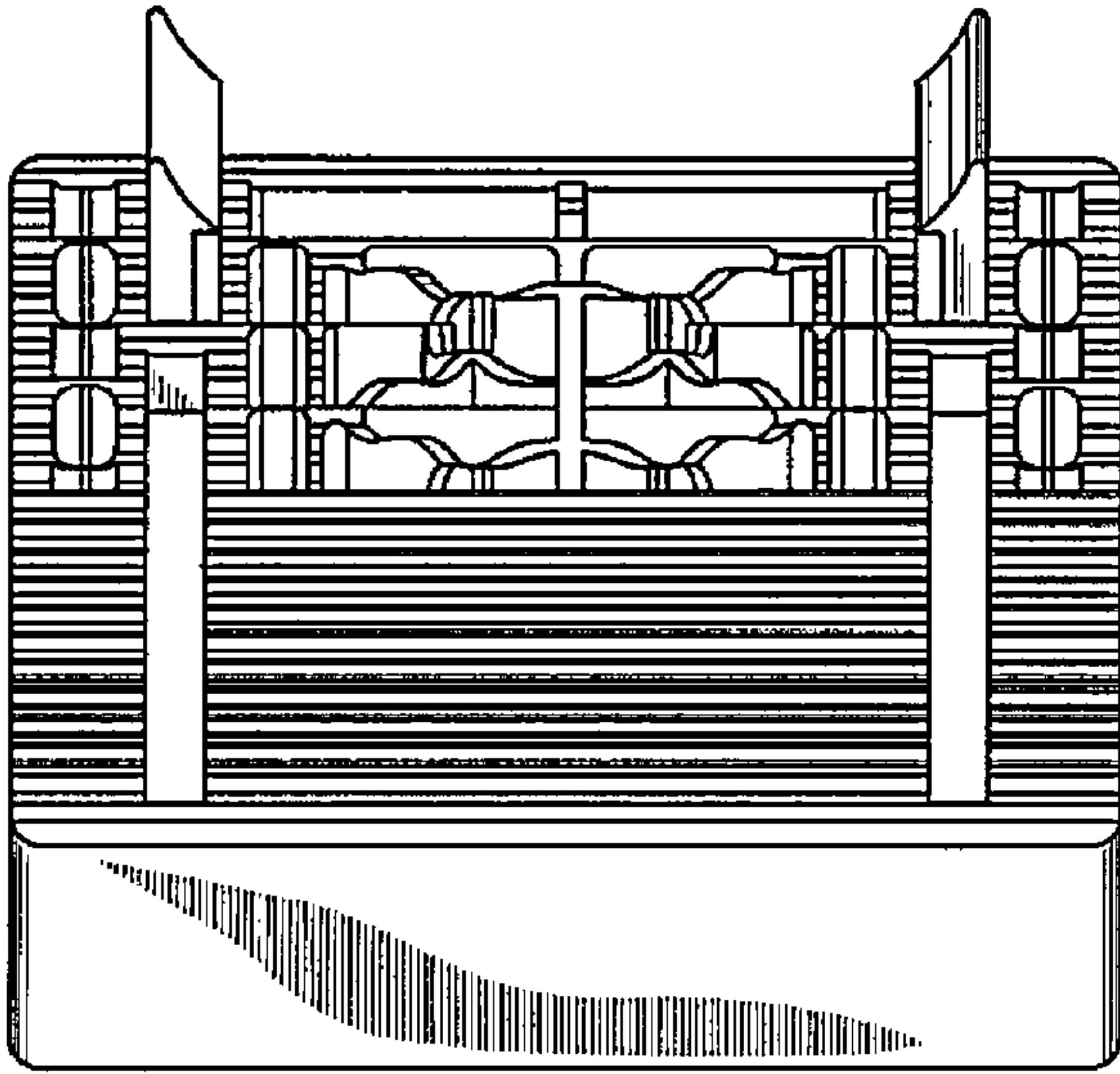
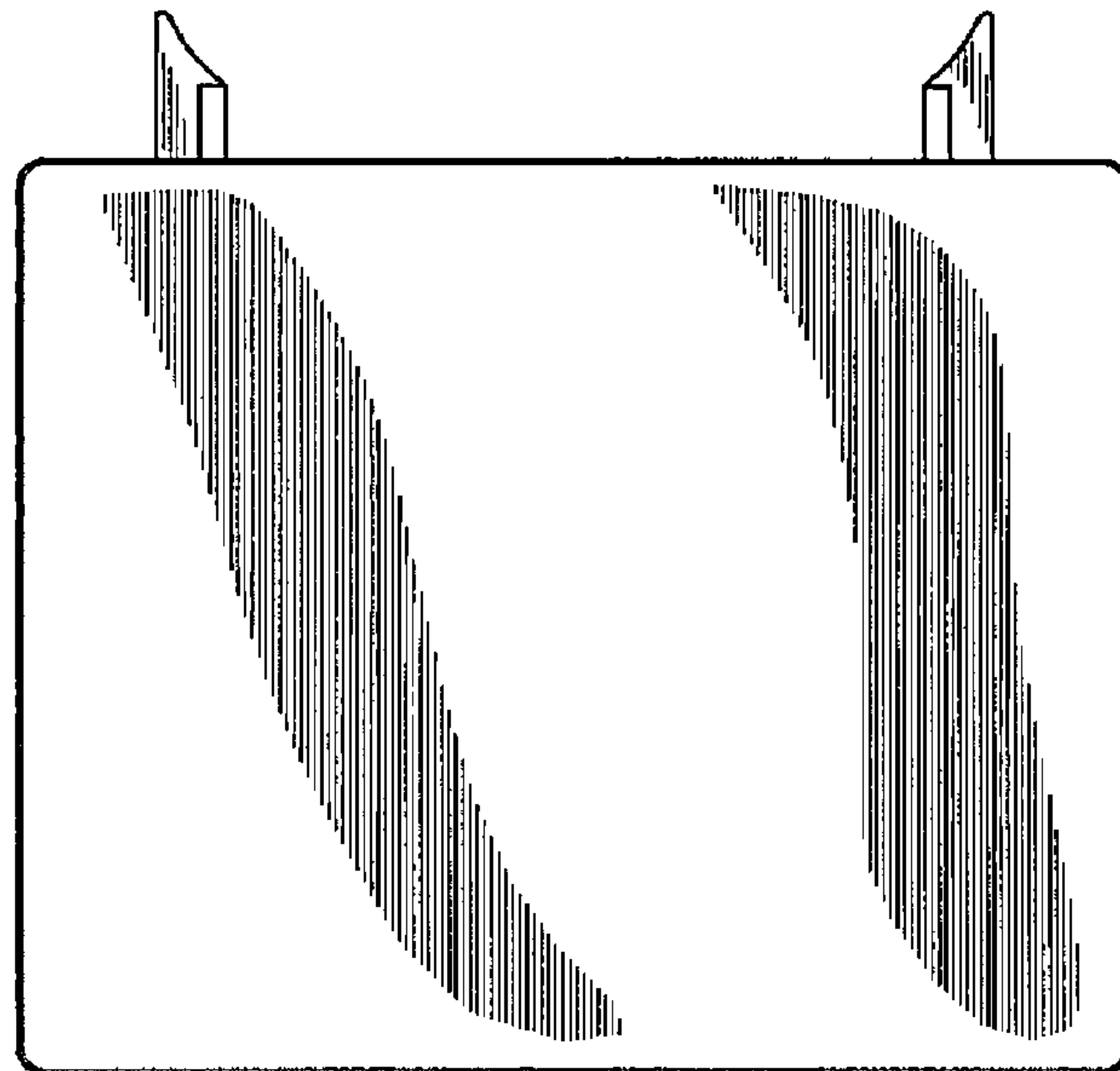

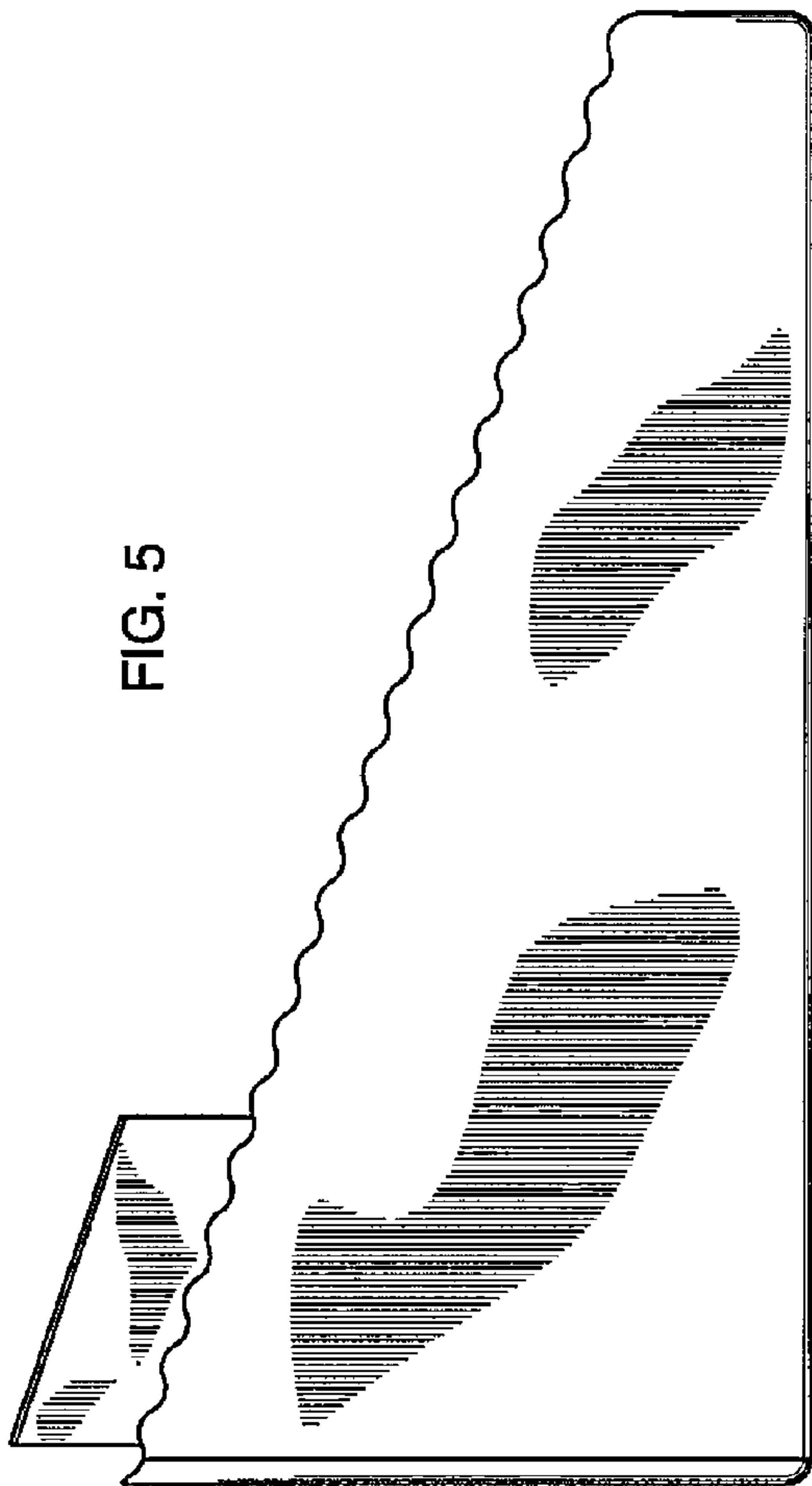

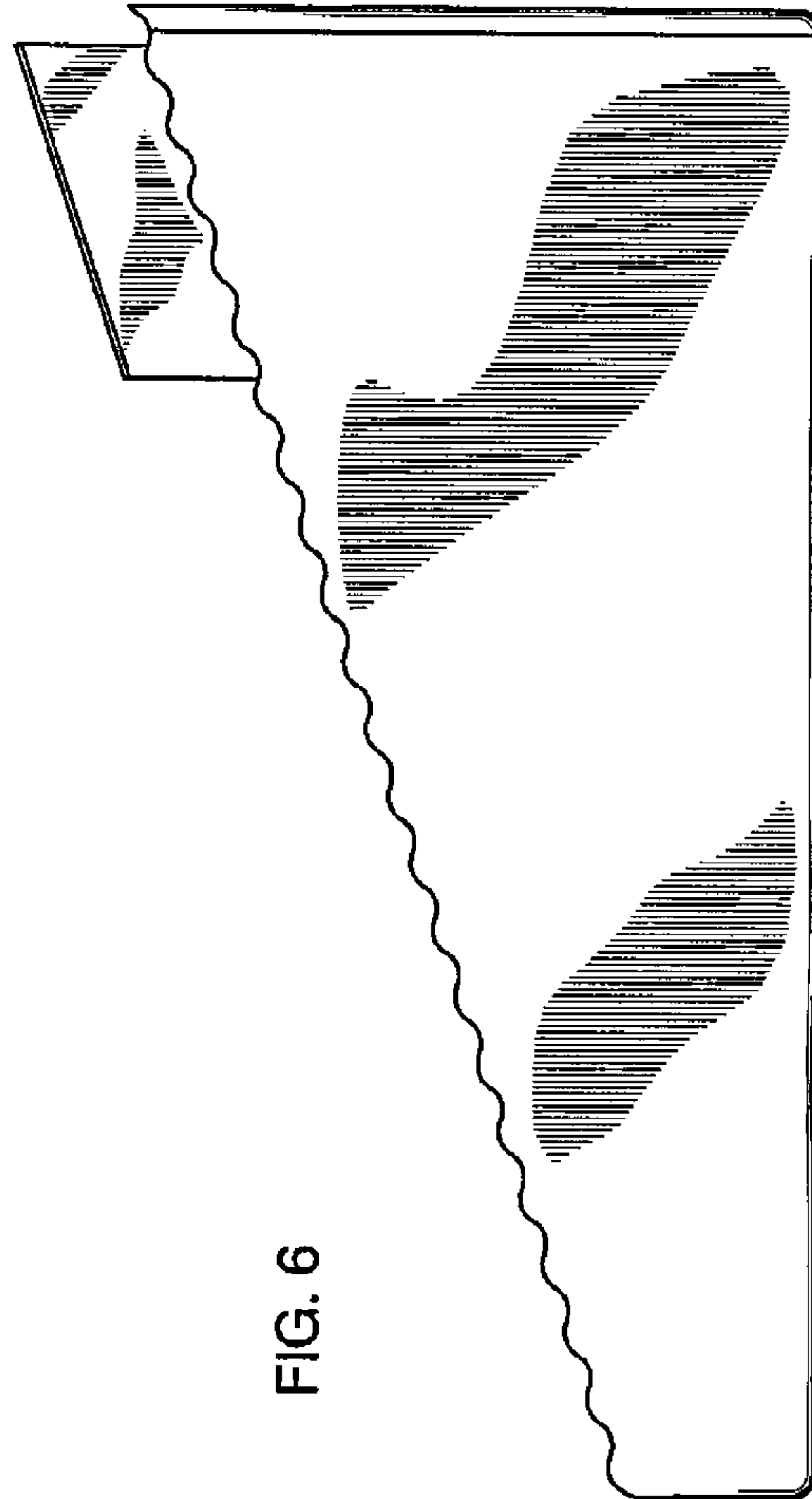

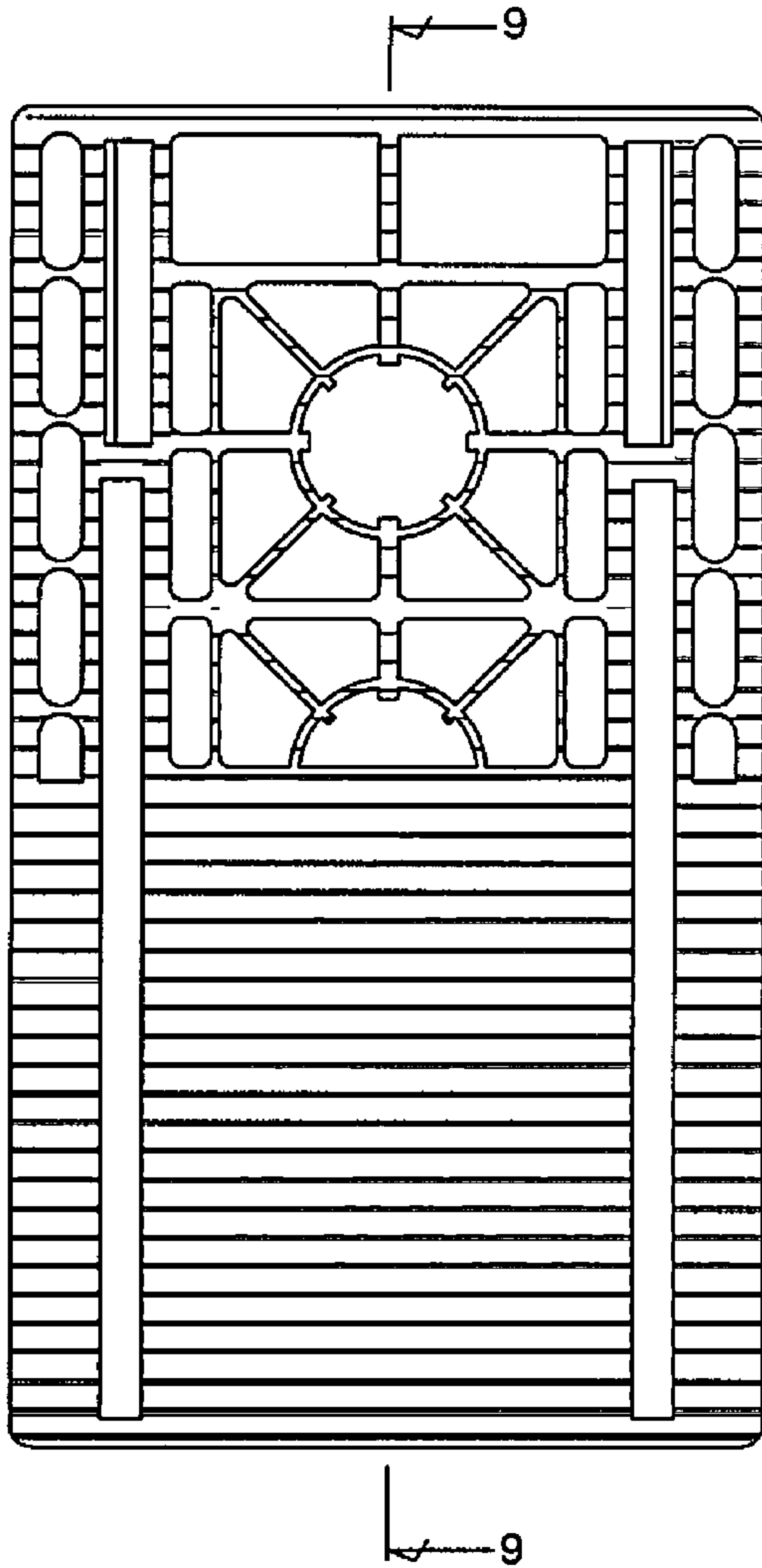

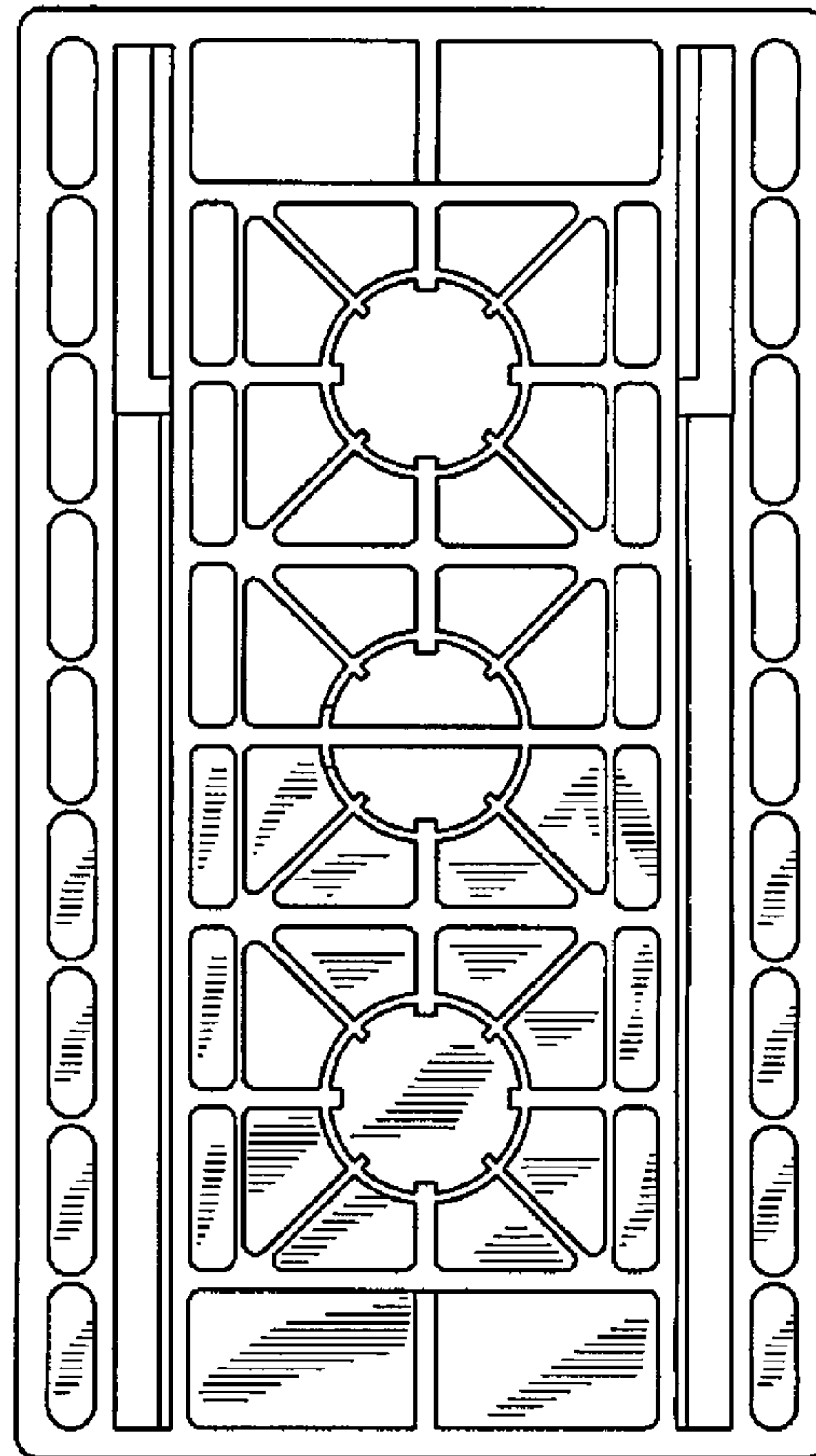
