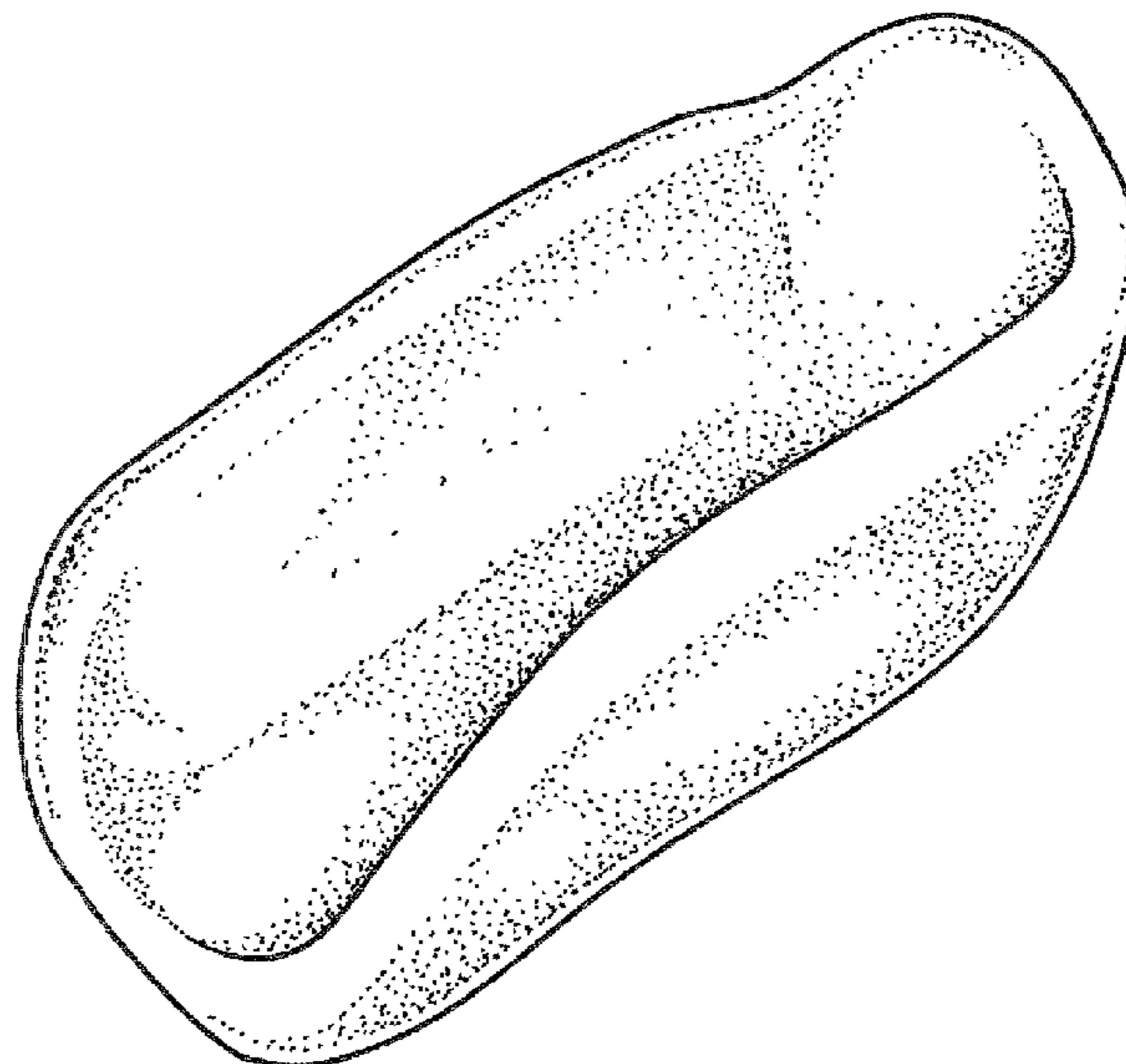
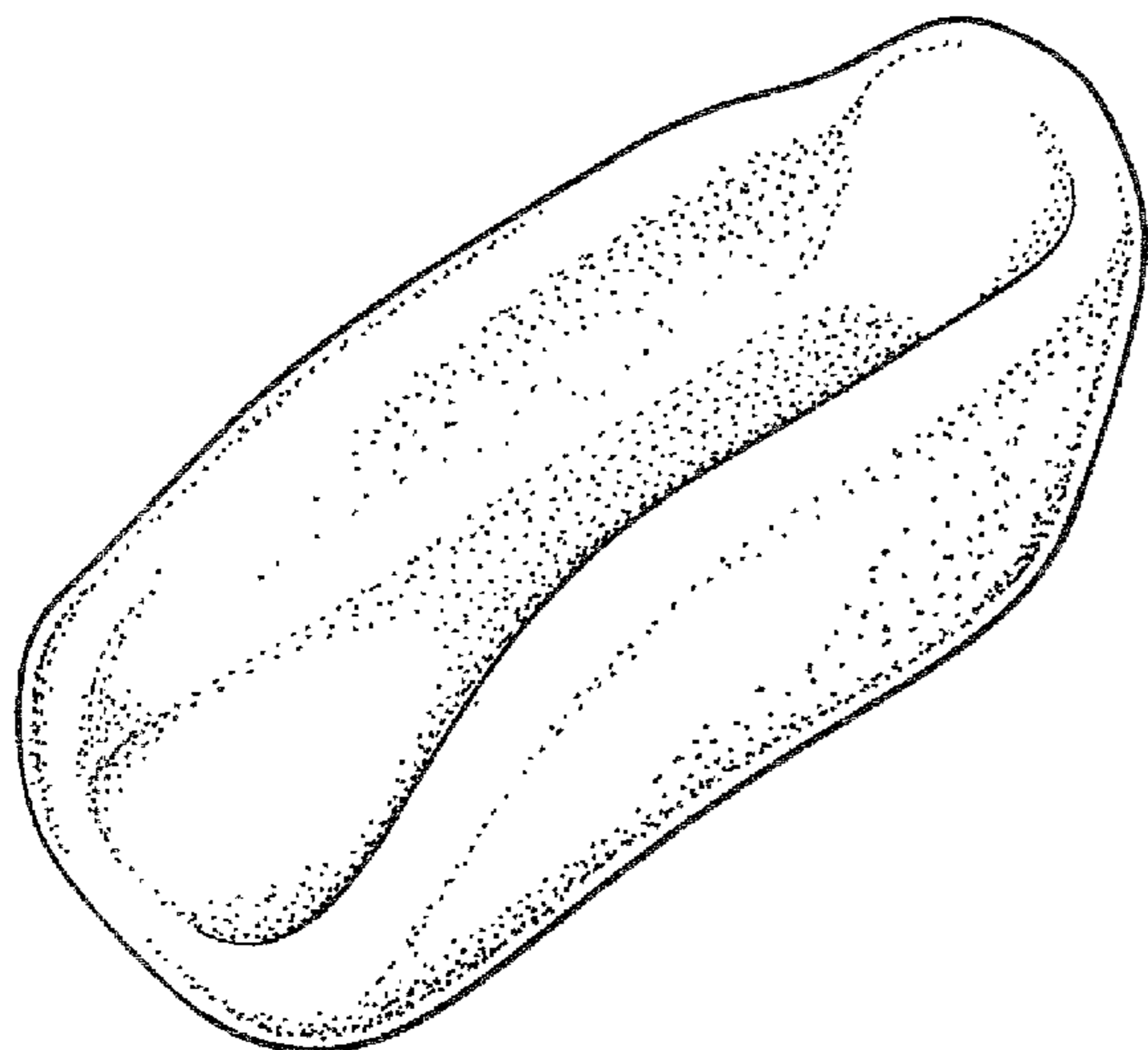
(57) **CLAIM**

The ornamental design for an edible shell for holding of comestible products, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an edible shell for holding of comestible products, showing my new design;

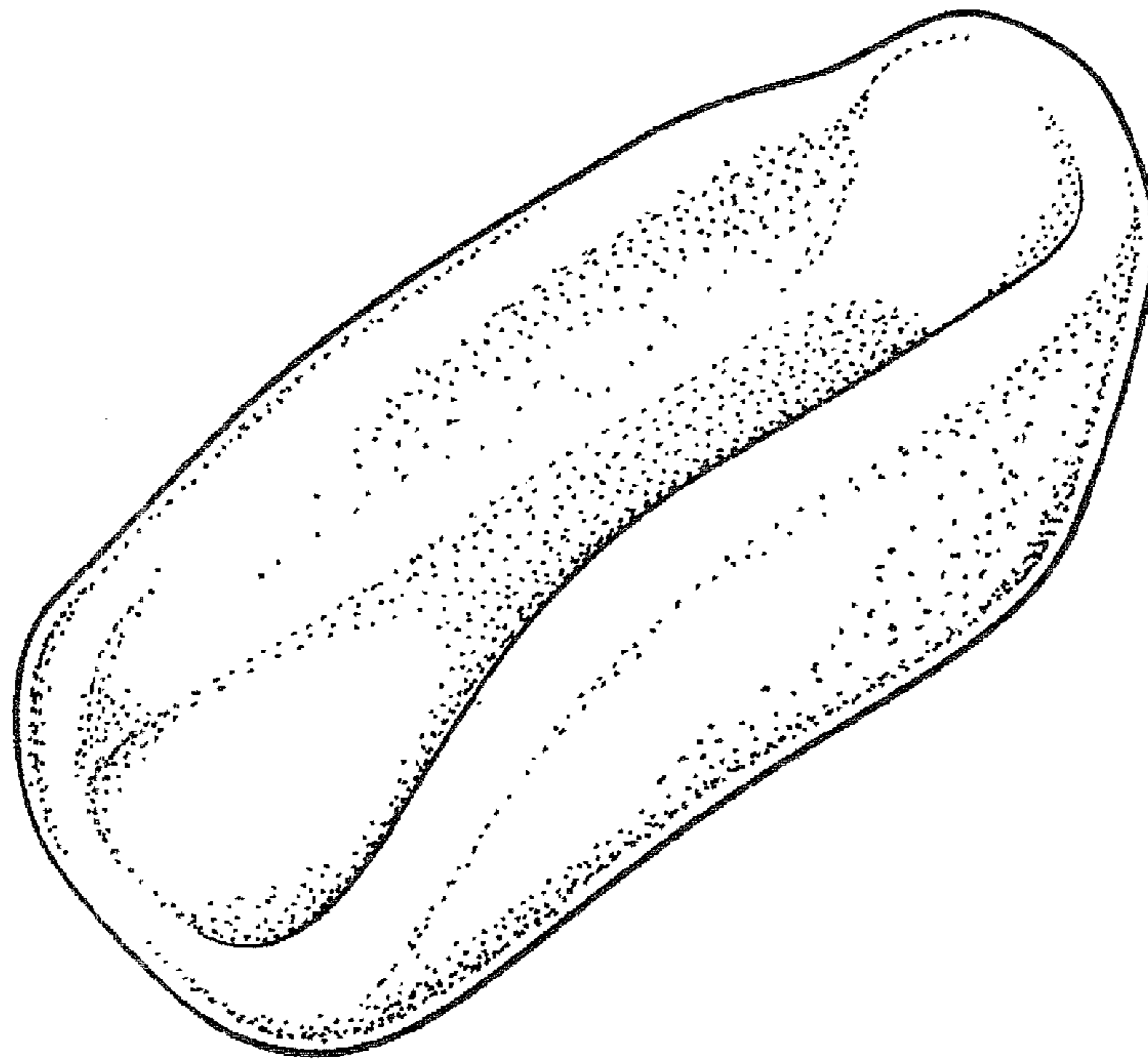

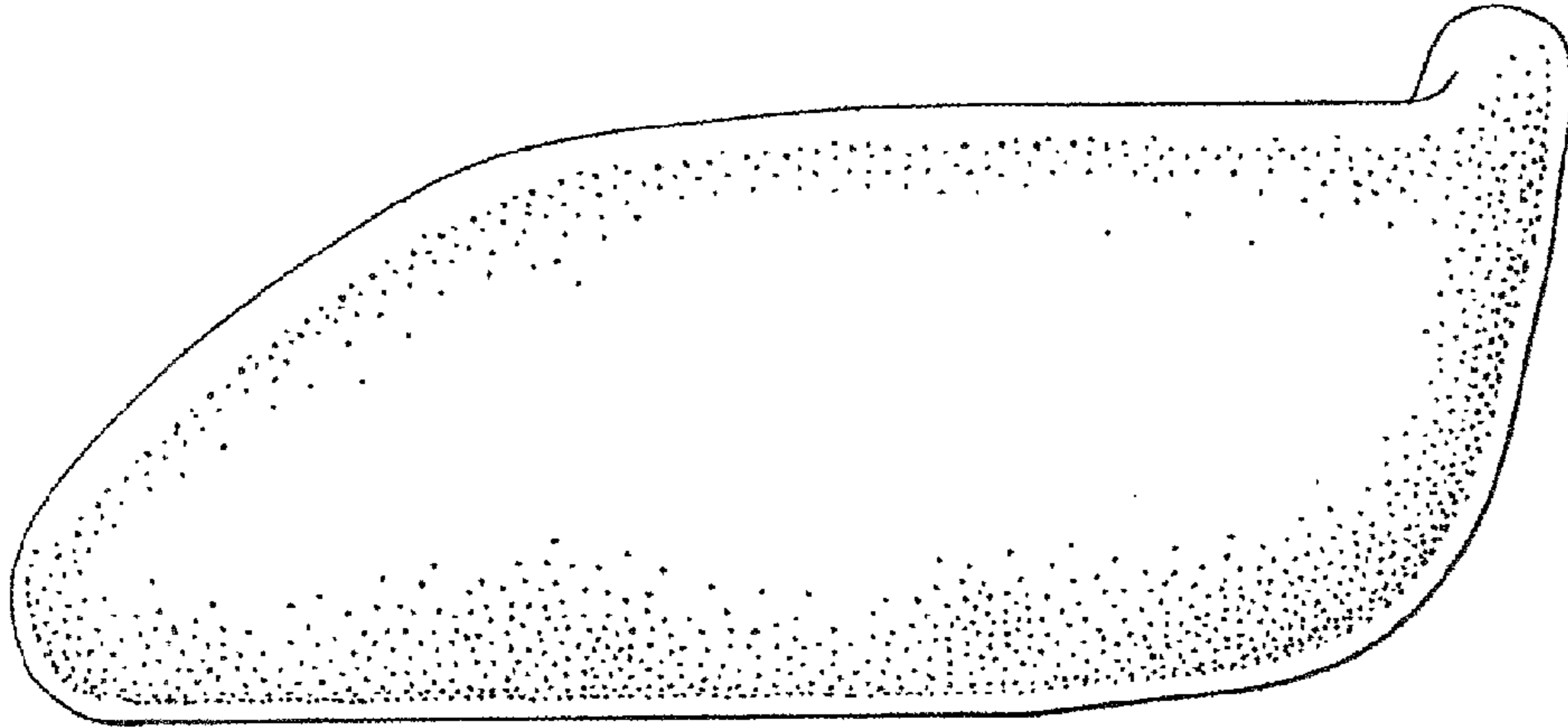

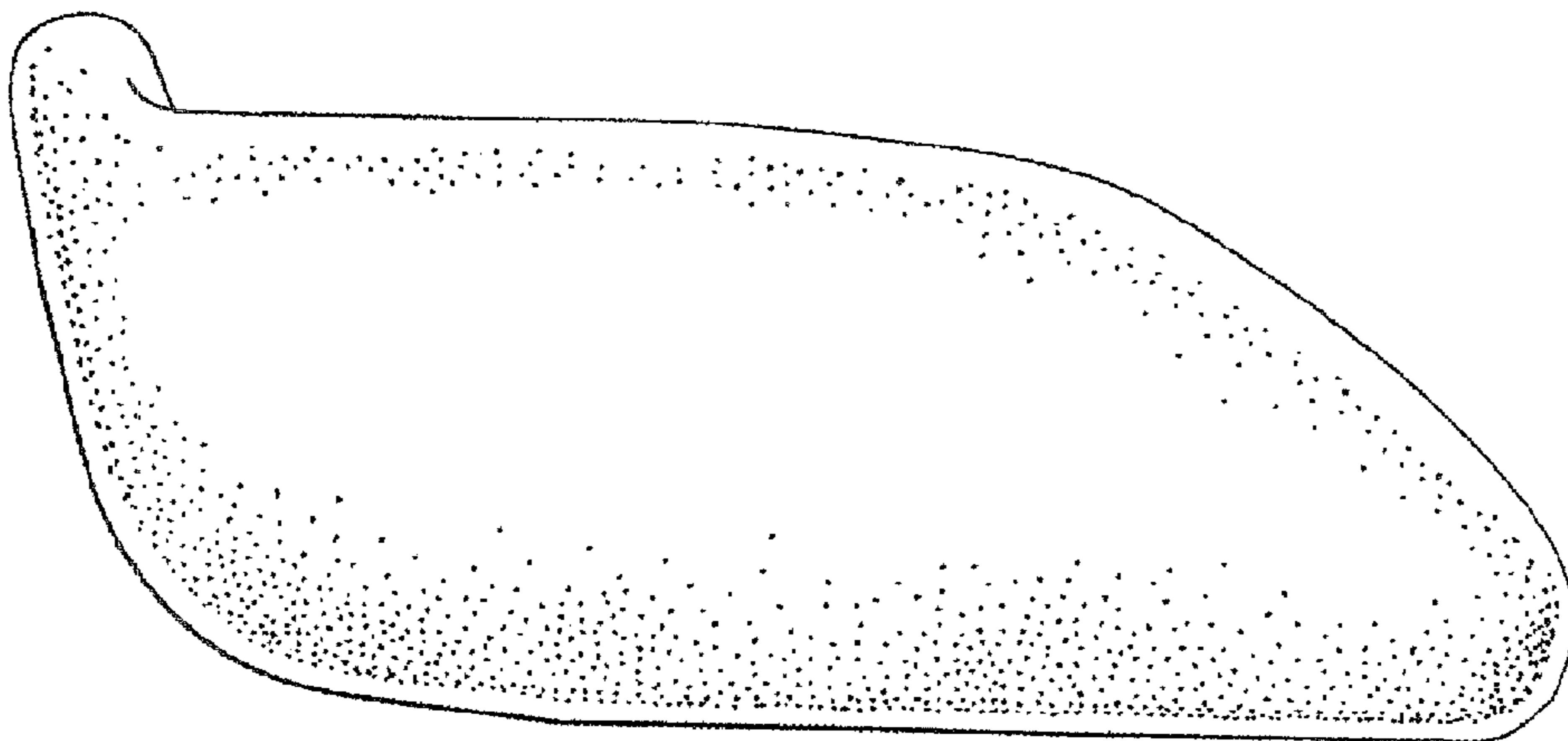

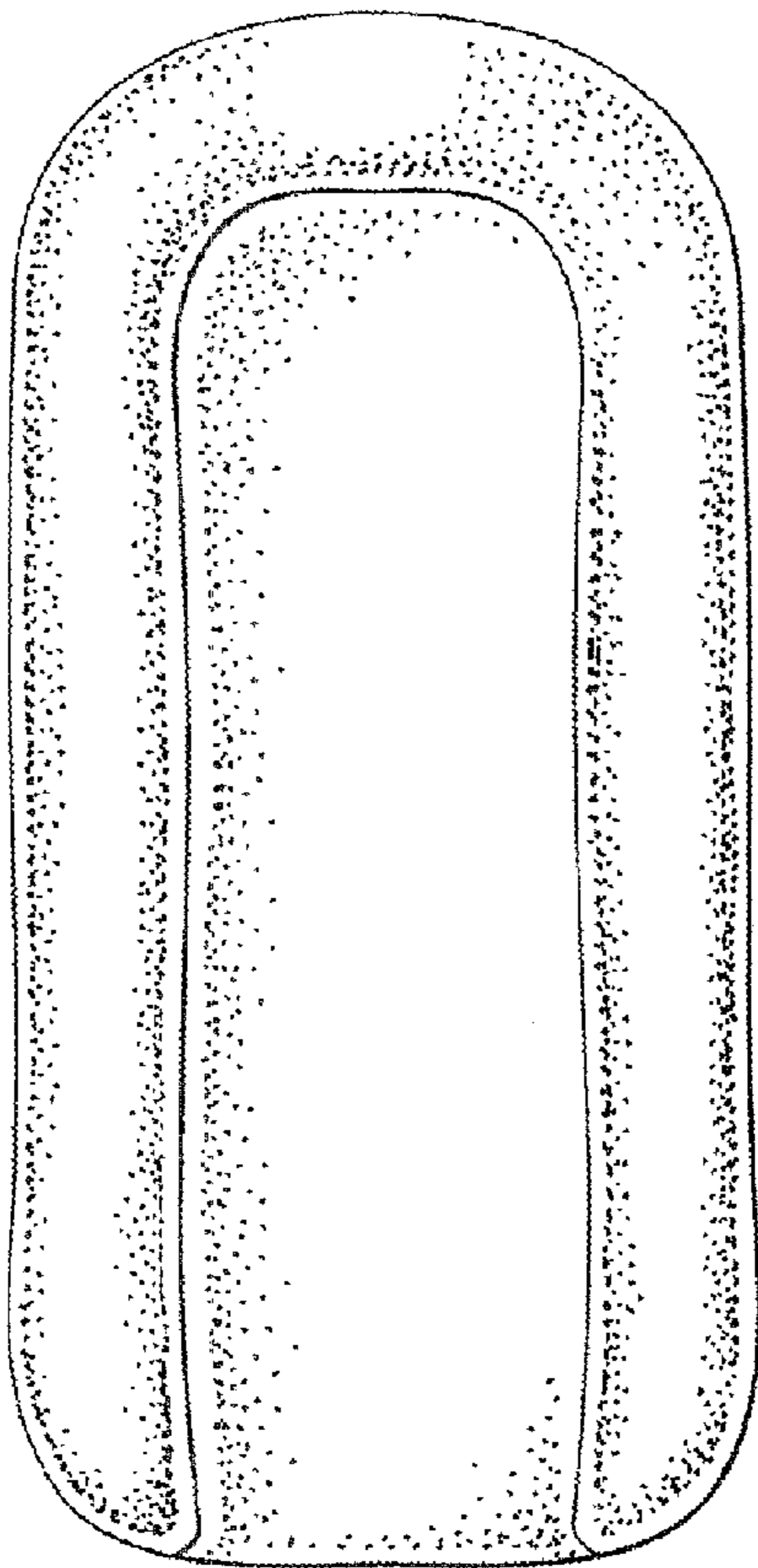

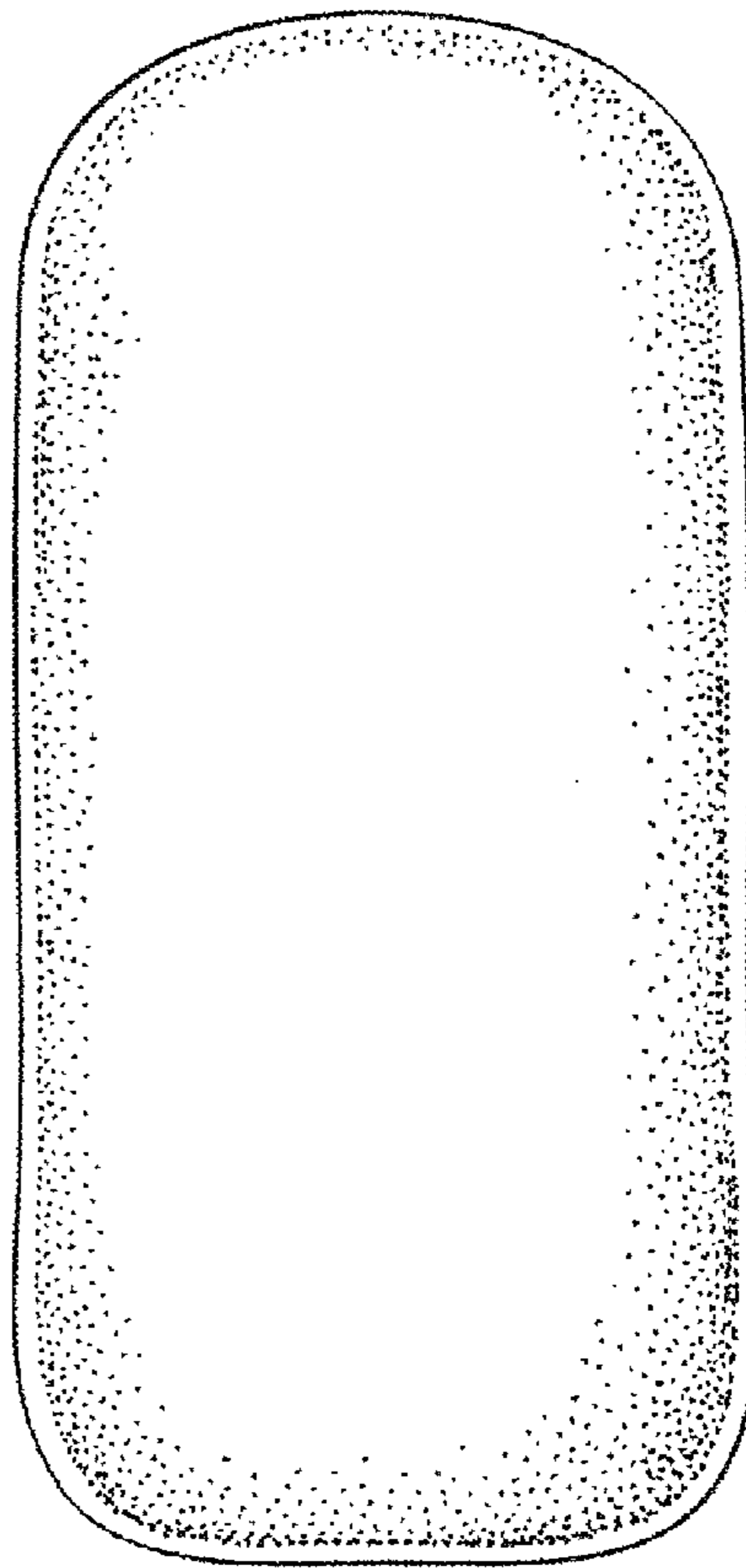

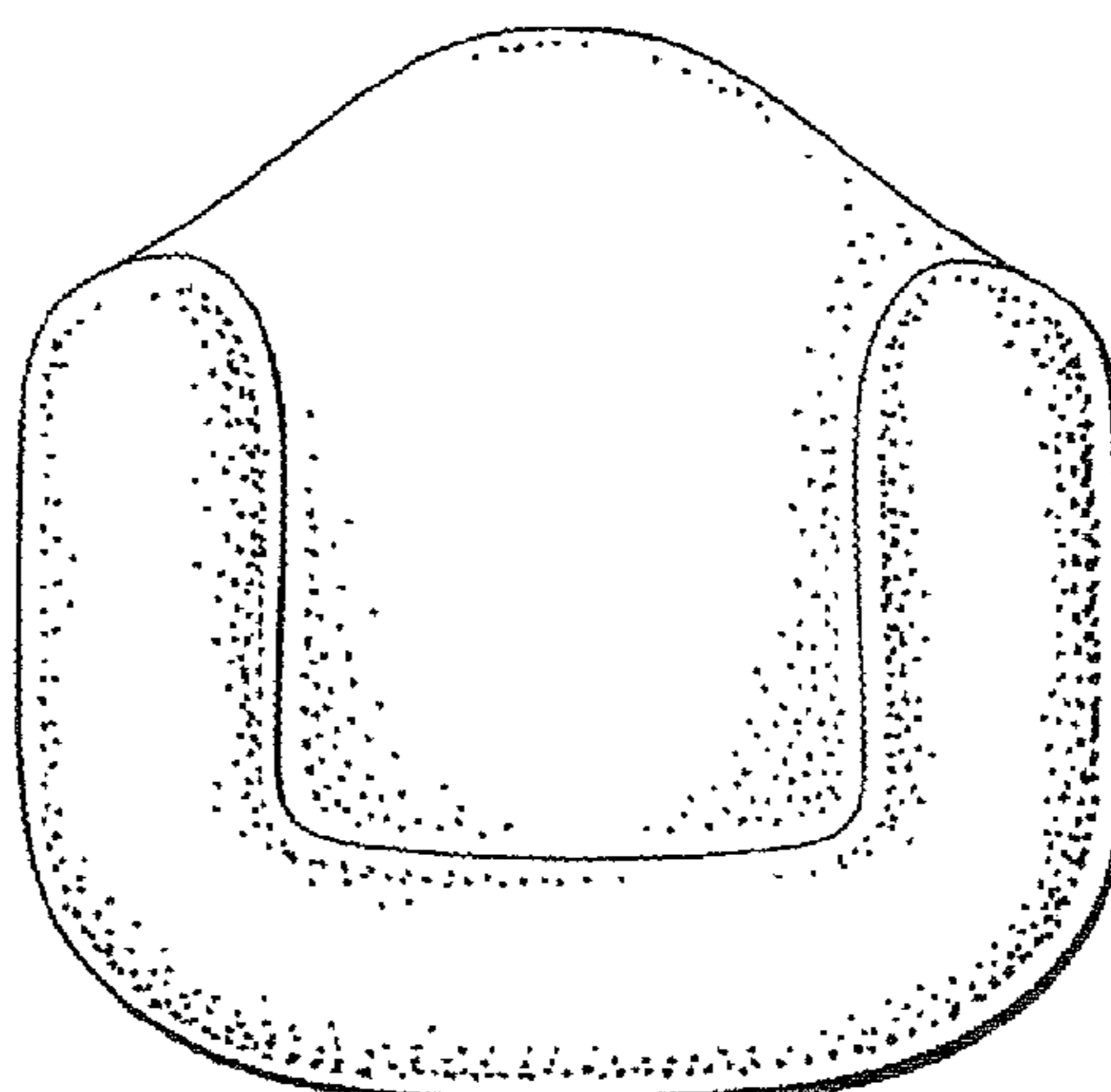

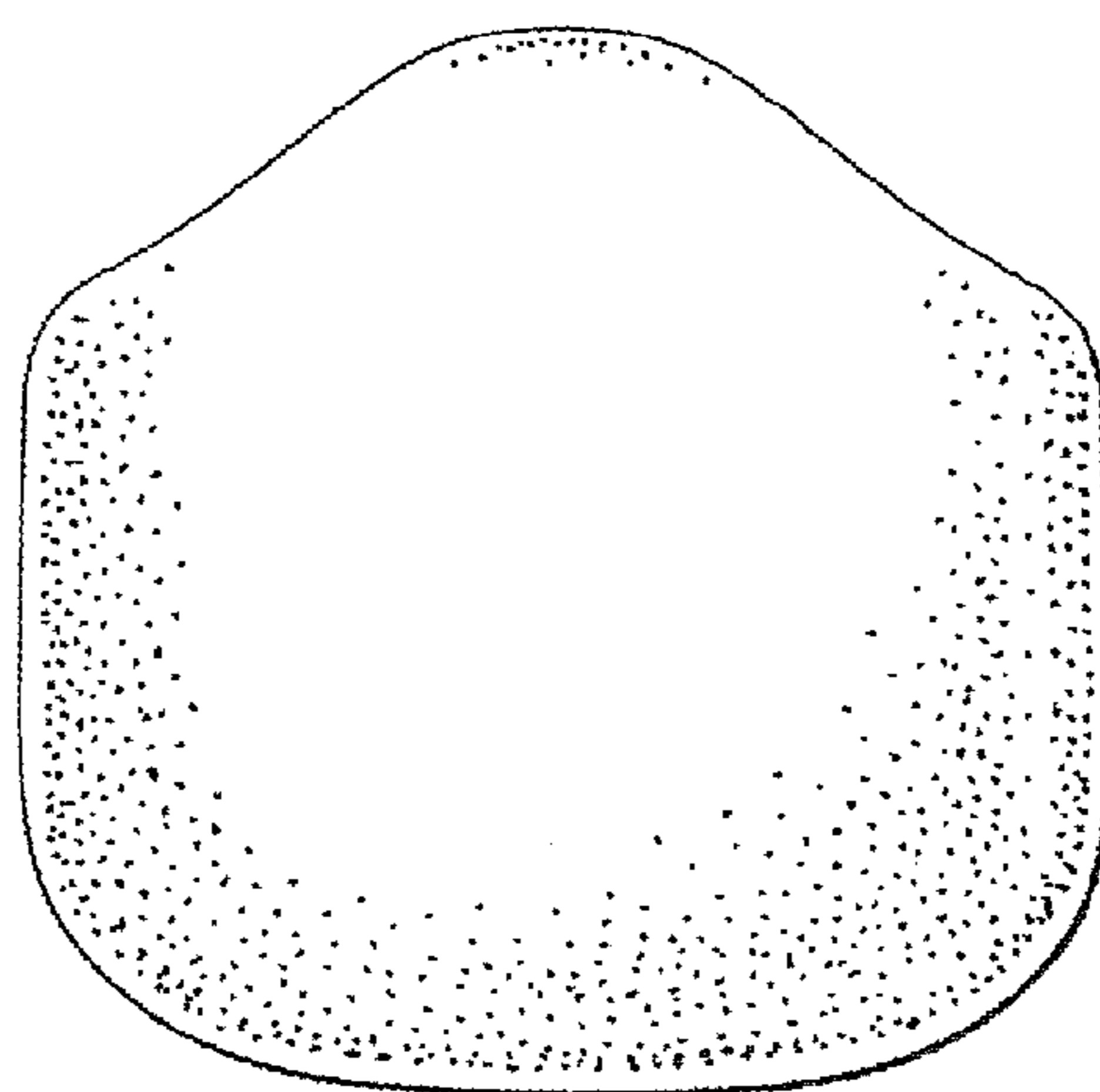

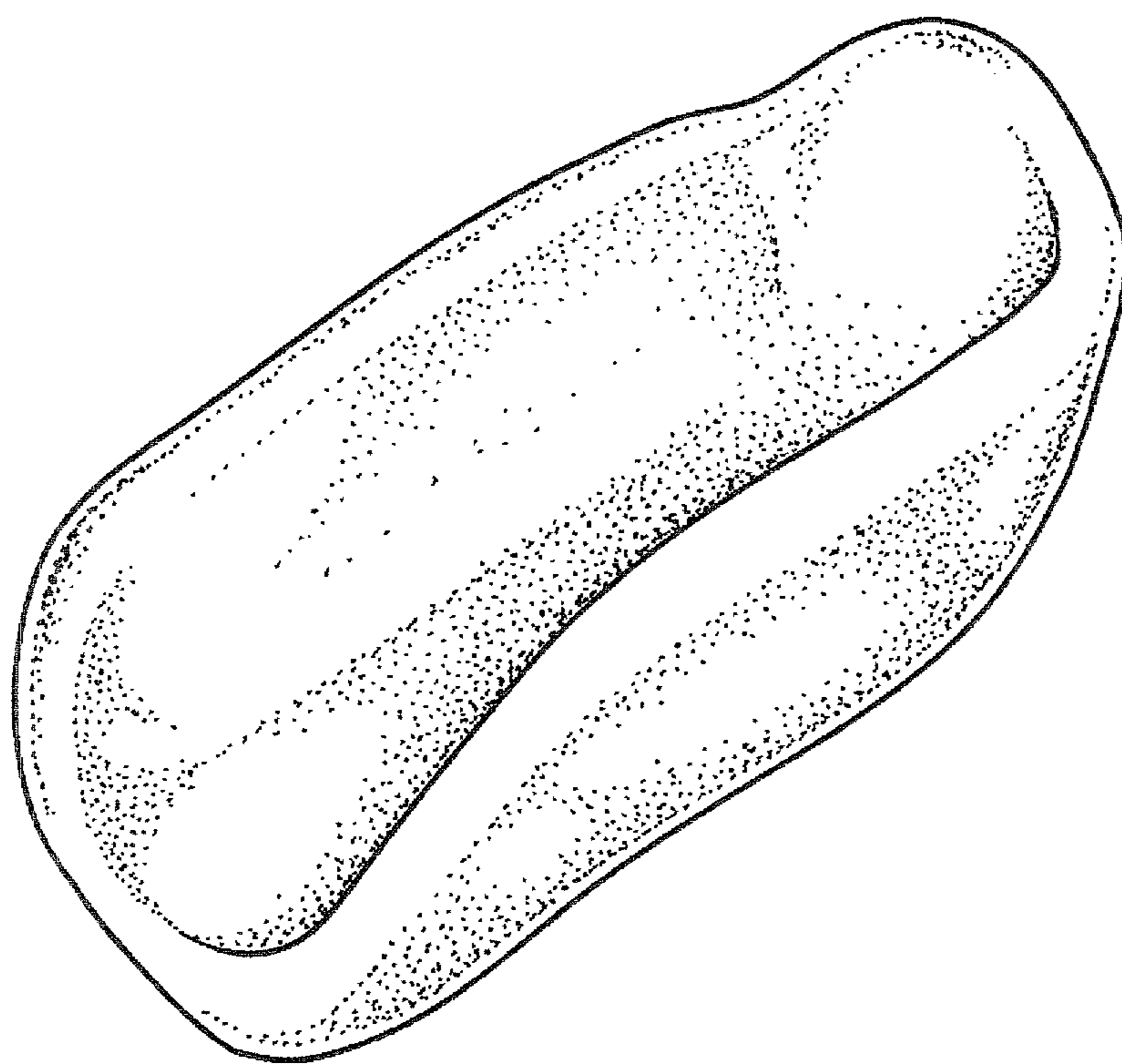

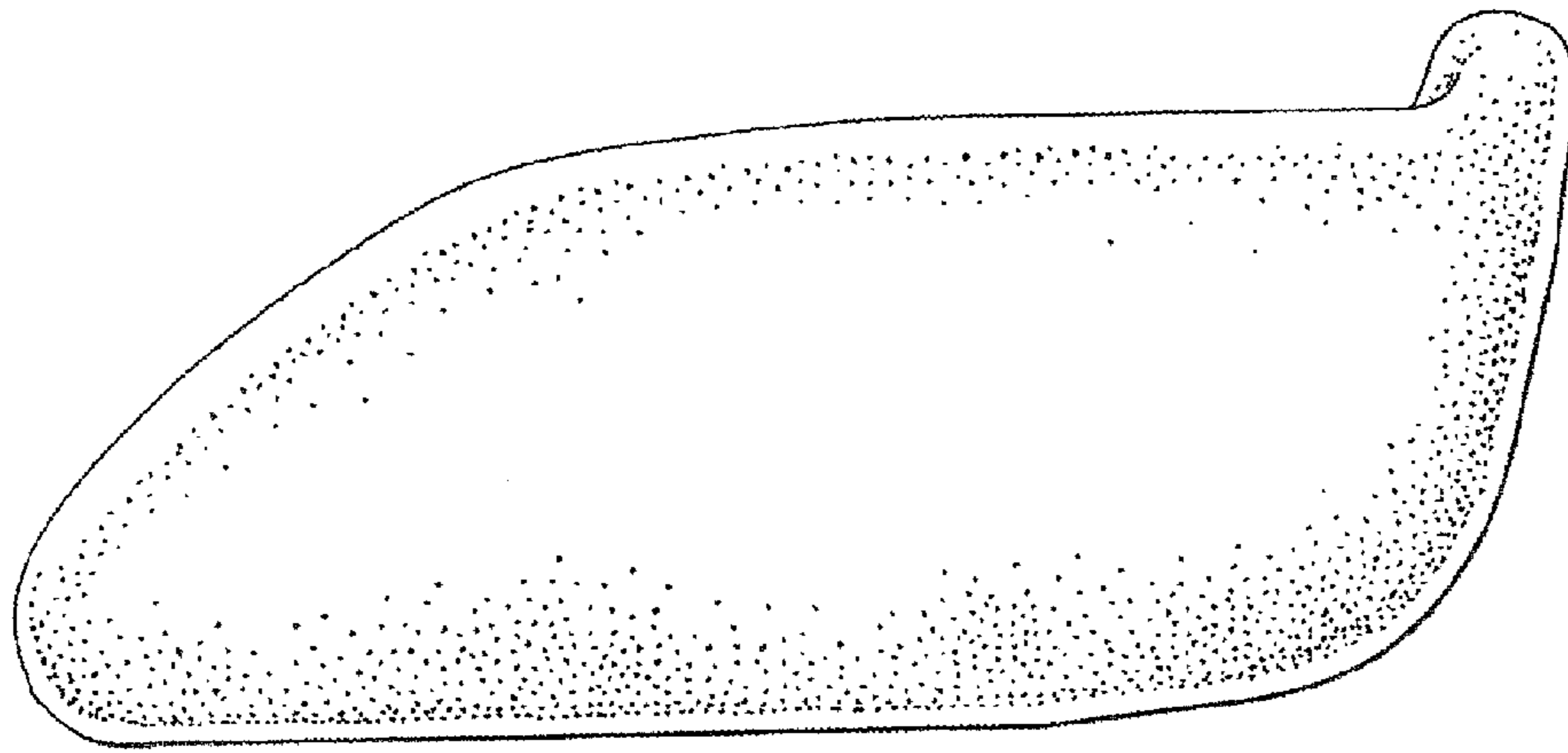

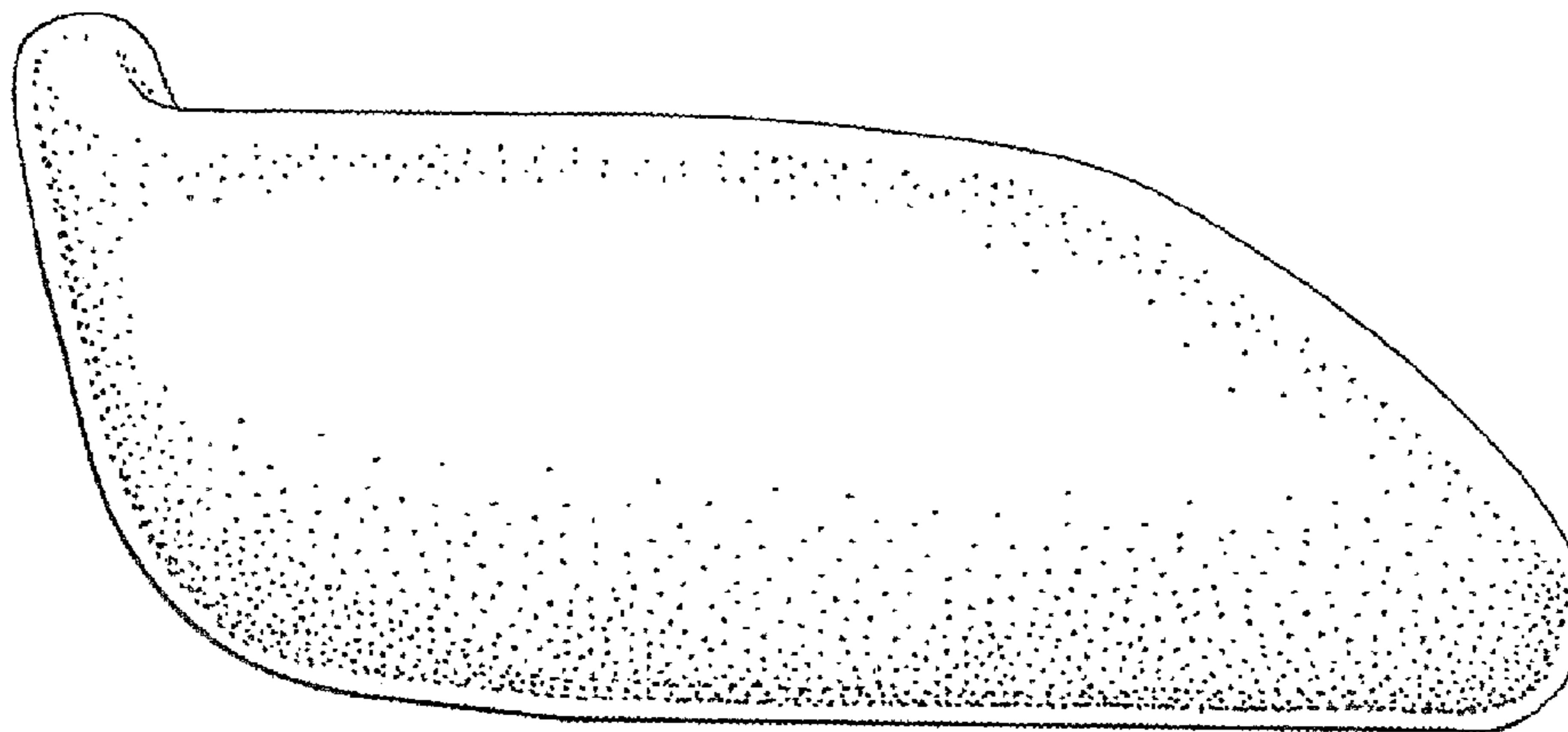

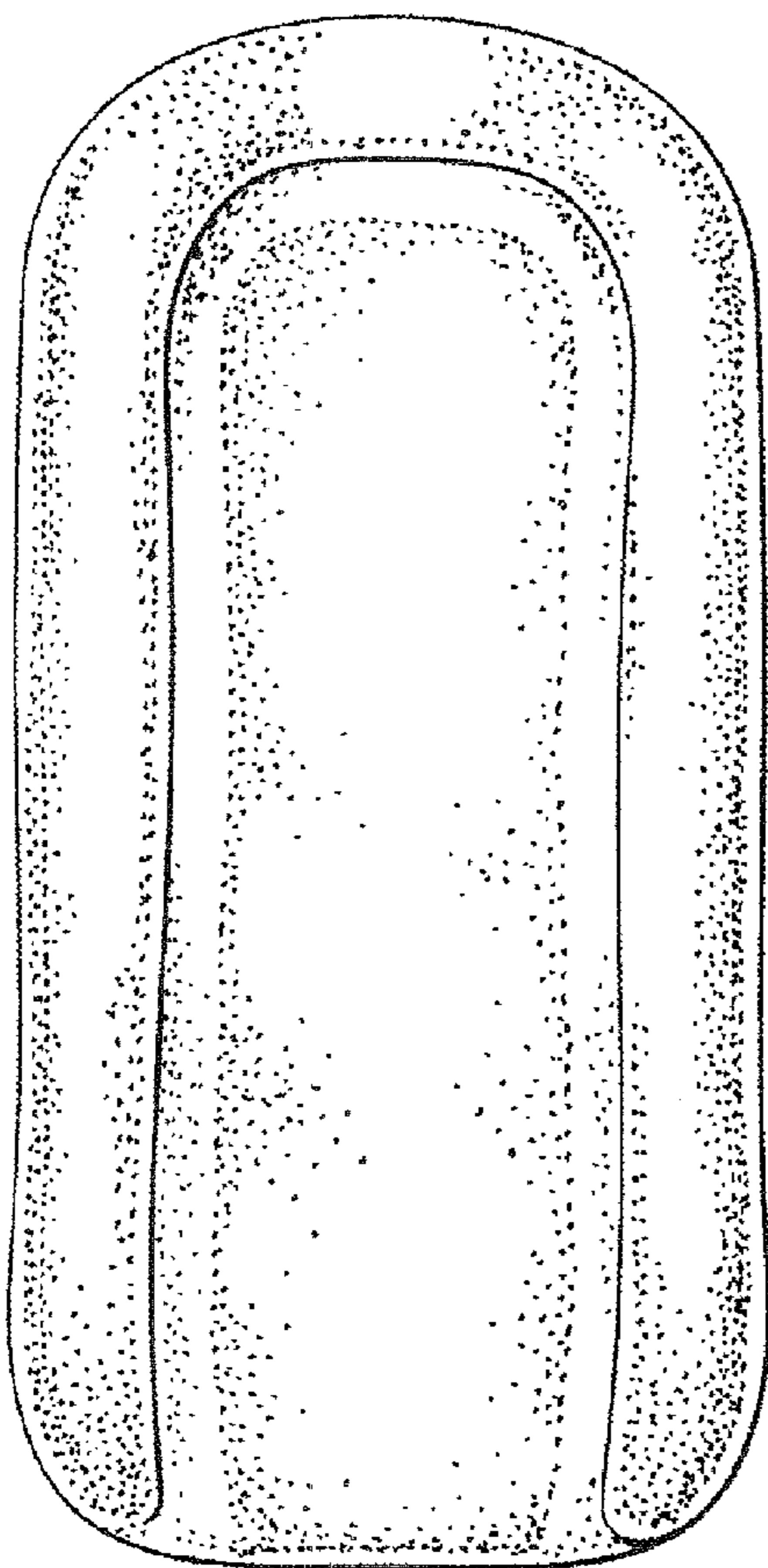

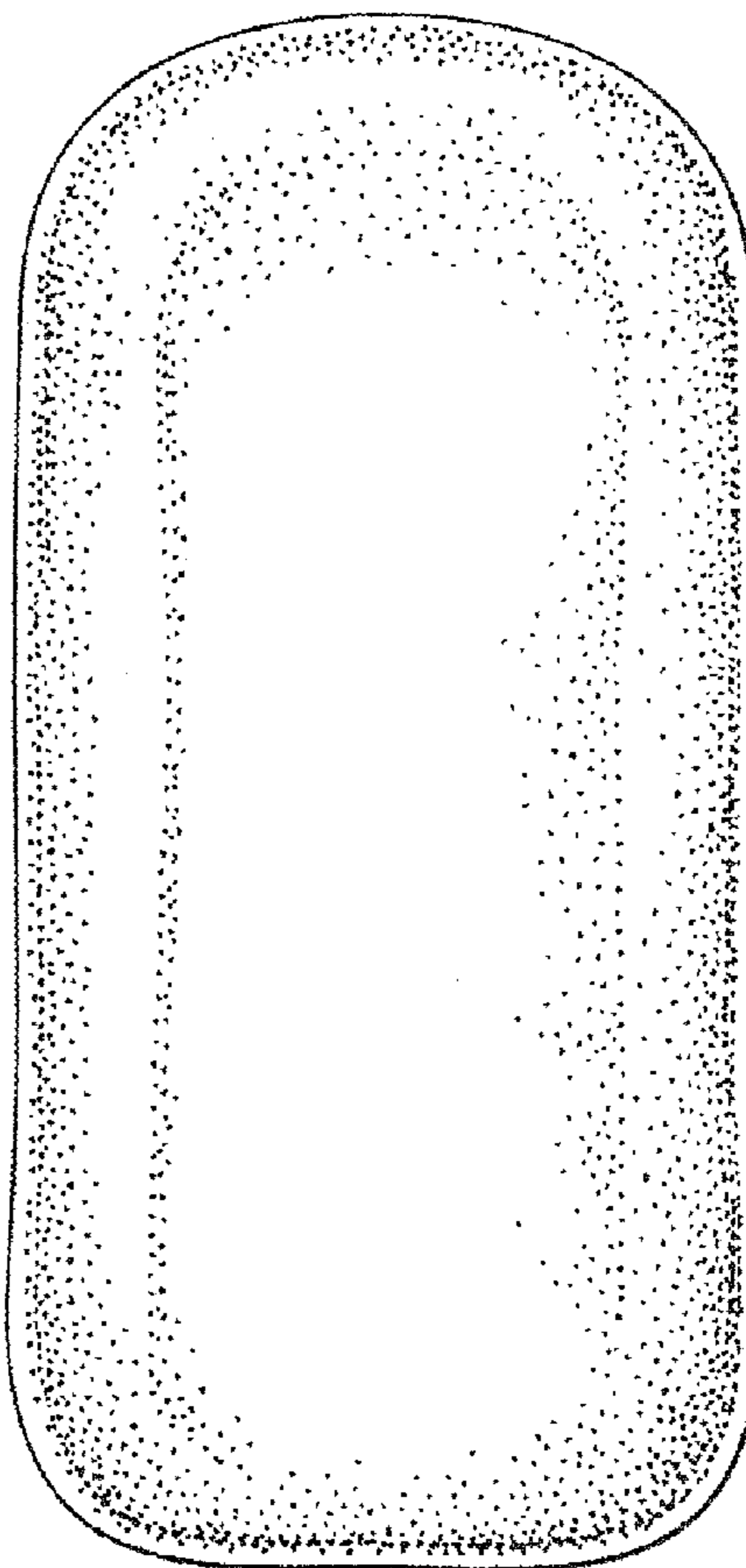

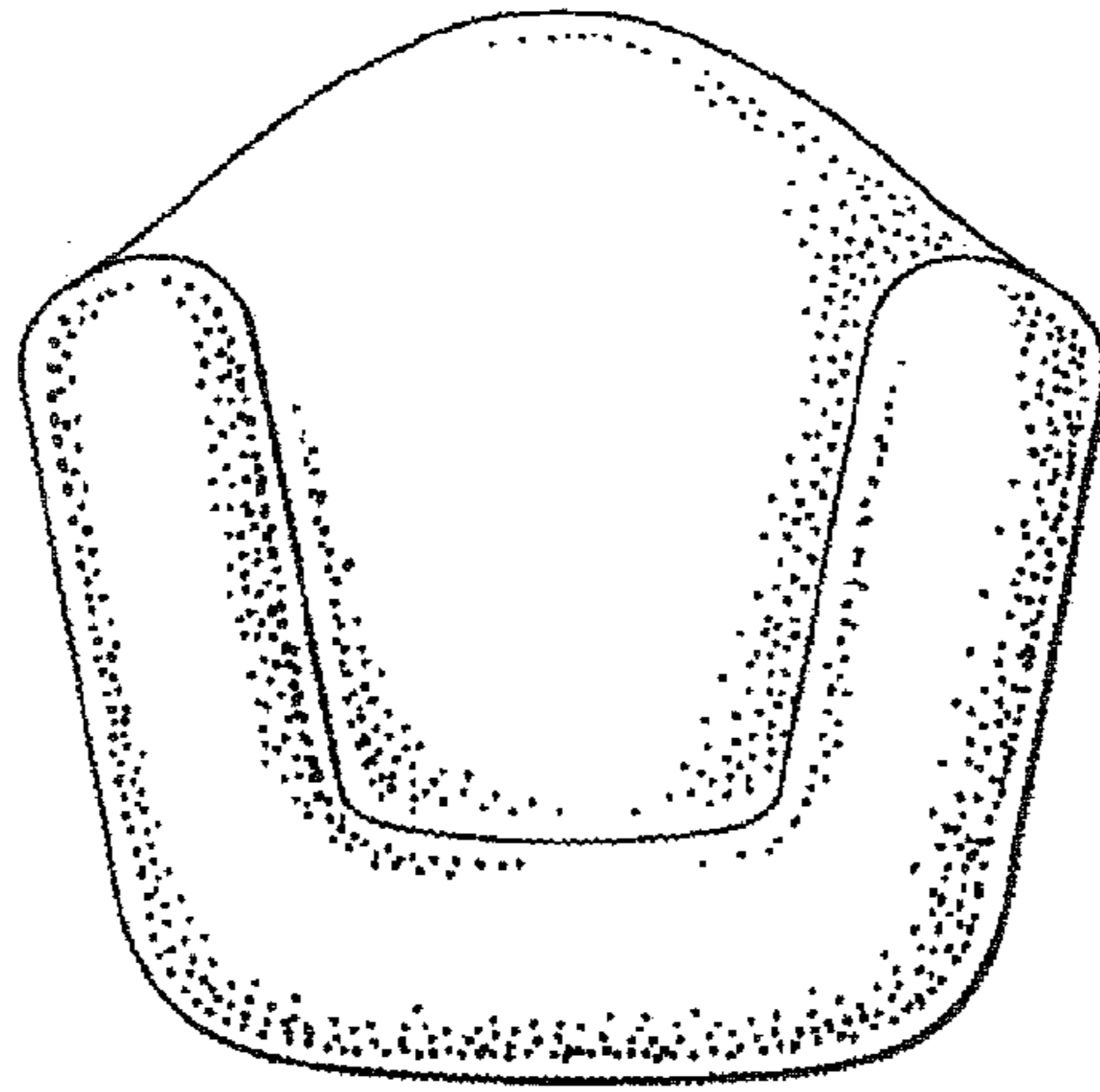

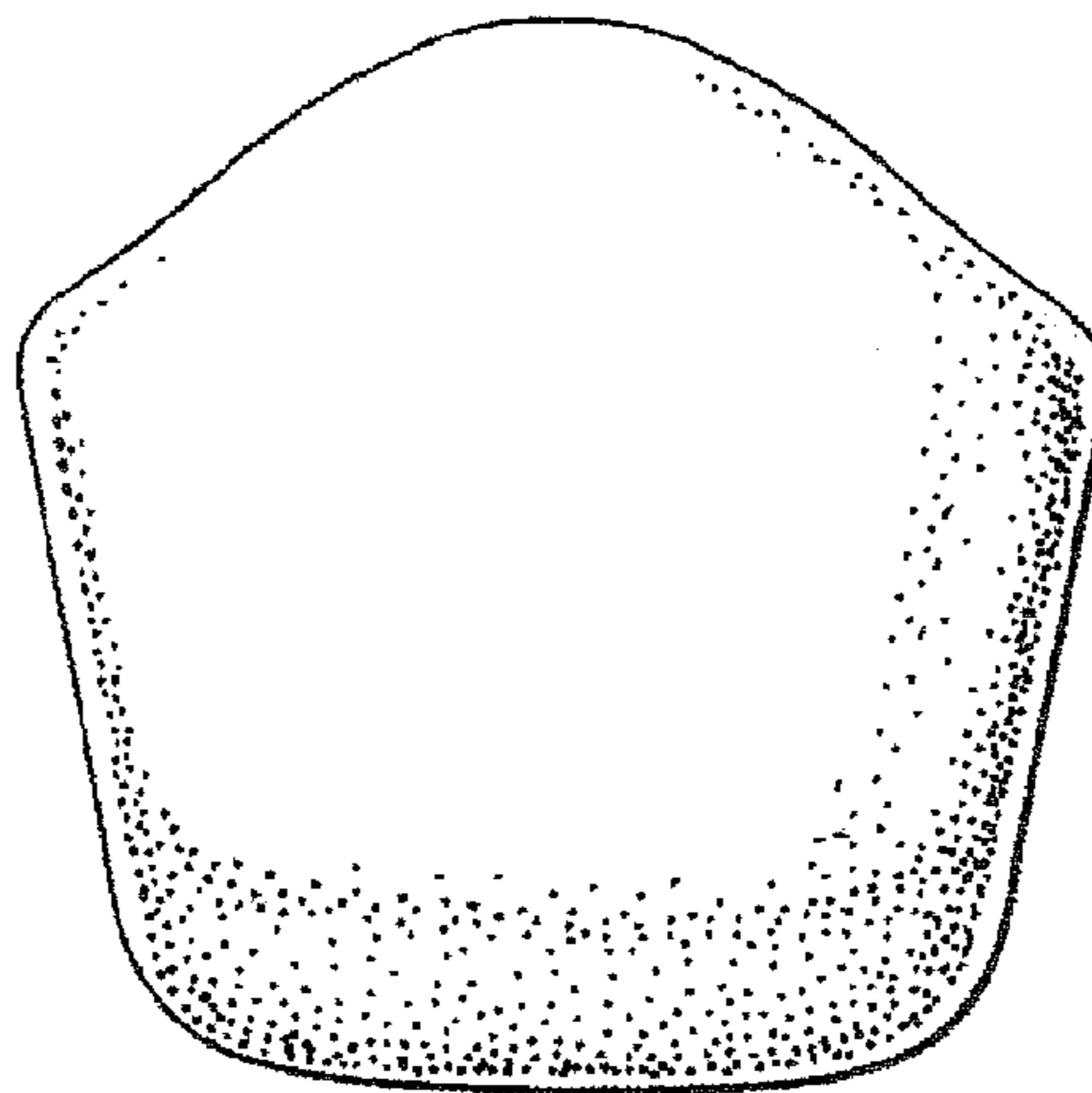
