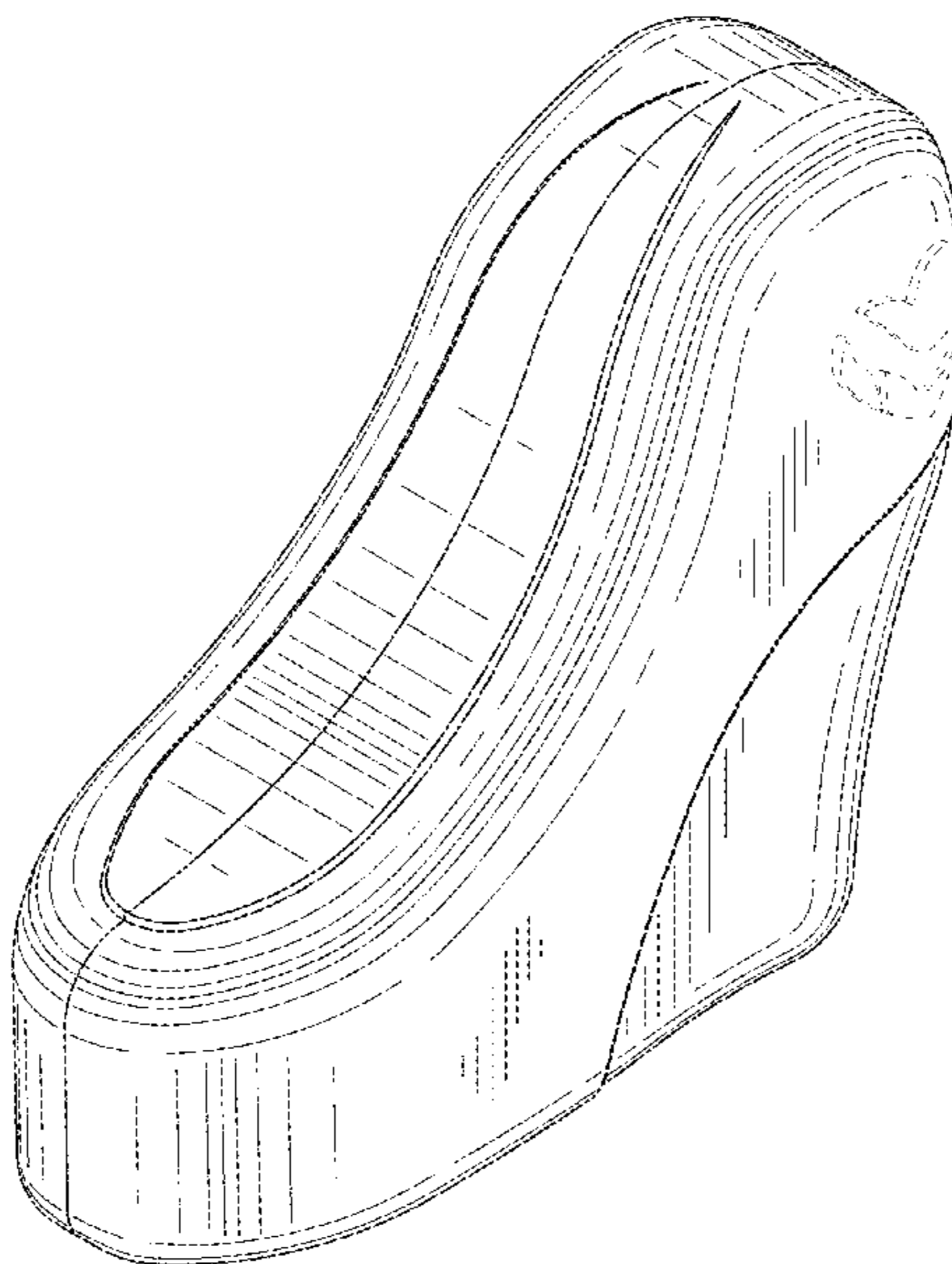
(57) **CLAIM**

We claim the ornamental design for a shoe case, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a shoe case; FIG. 2 is a bottom, rear perspective view of the shoe case shown in FIG. 1; FIG. 3 is a left side view of the shoe case shown in FIG. 1; FIG. 4 is a front view of the shoe case shown in FIG. 1; FIG. 5 is a rear view of the shoe case shown in FIG. 1; FIG. 6 is a top view of the shoe case shown in FIG. 1; and, FIG. 7 is a bottom view of the shoe case shown in FIG. 1. 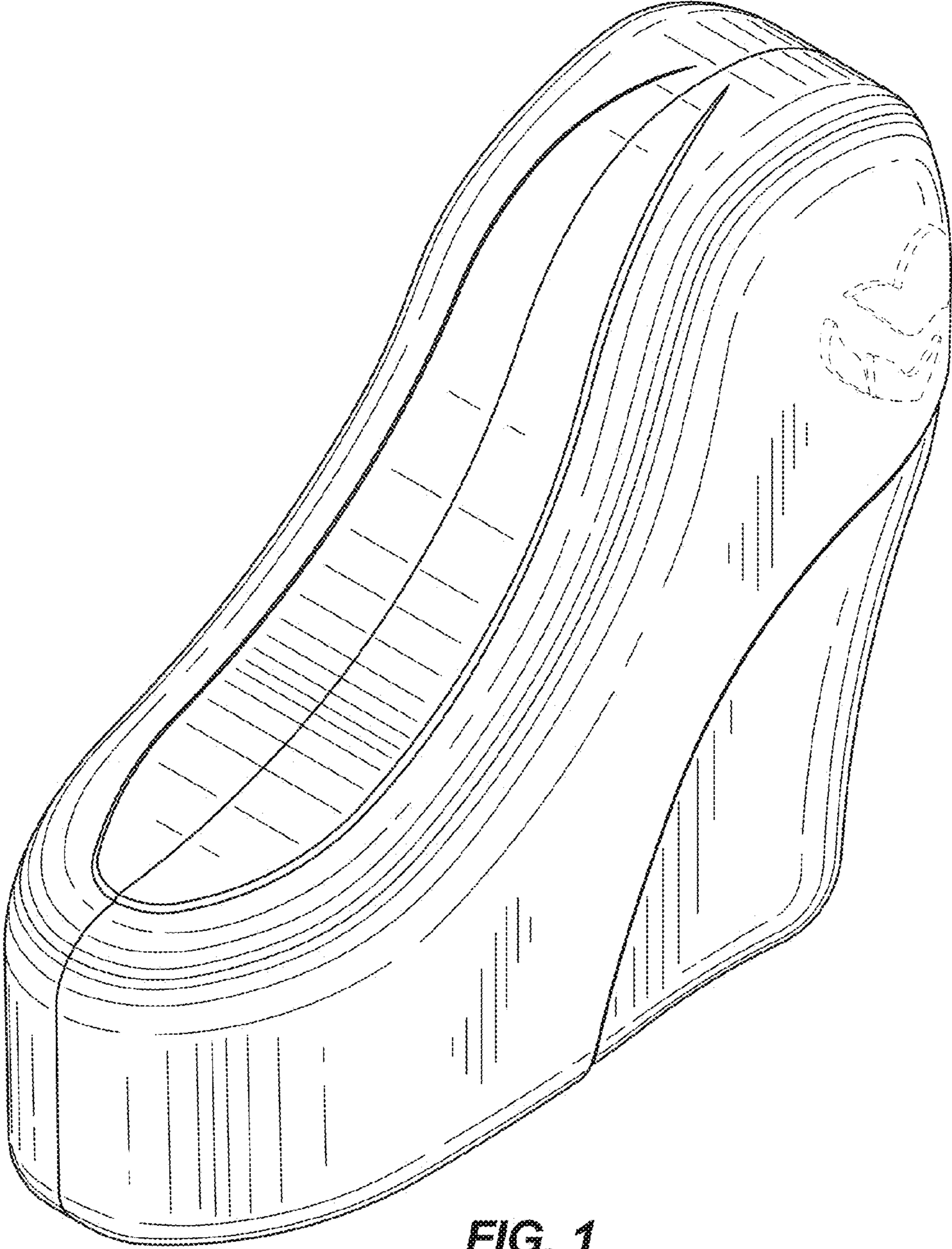

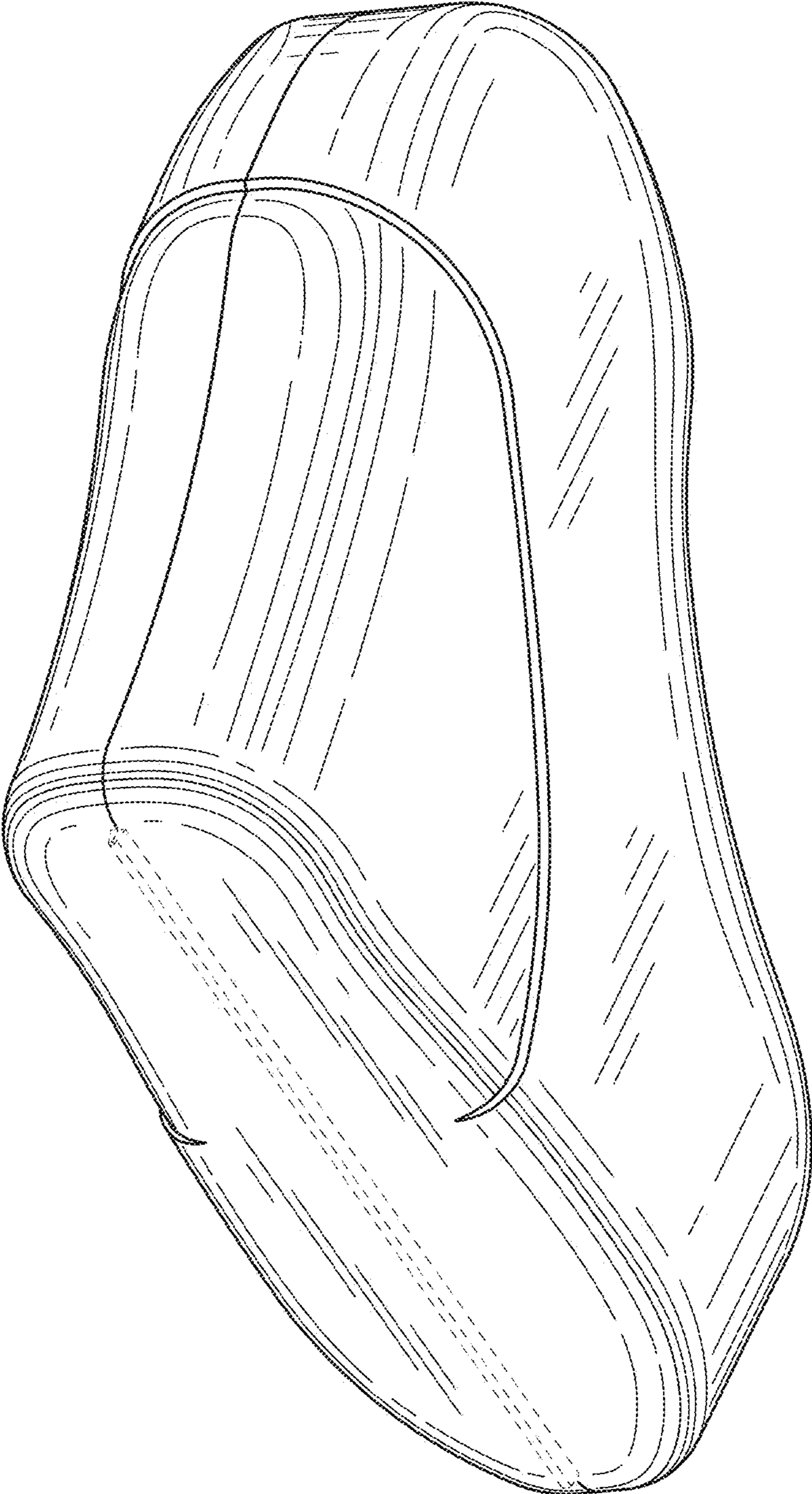

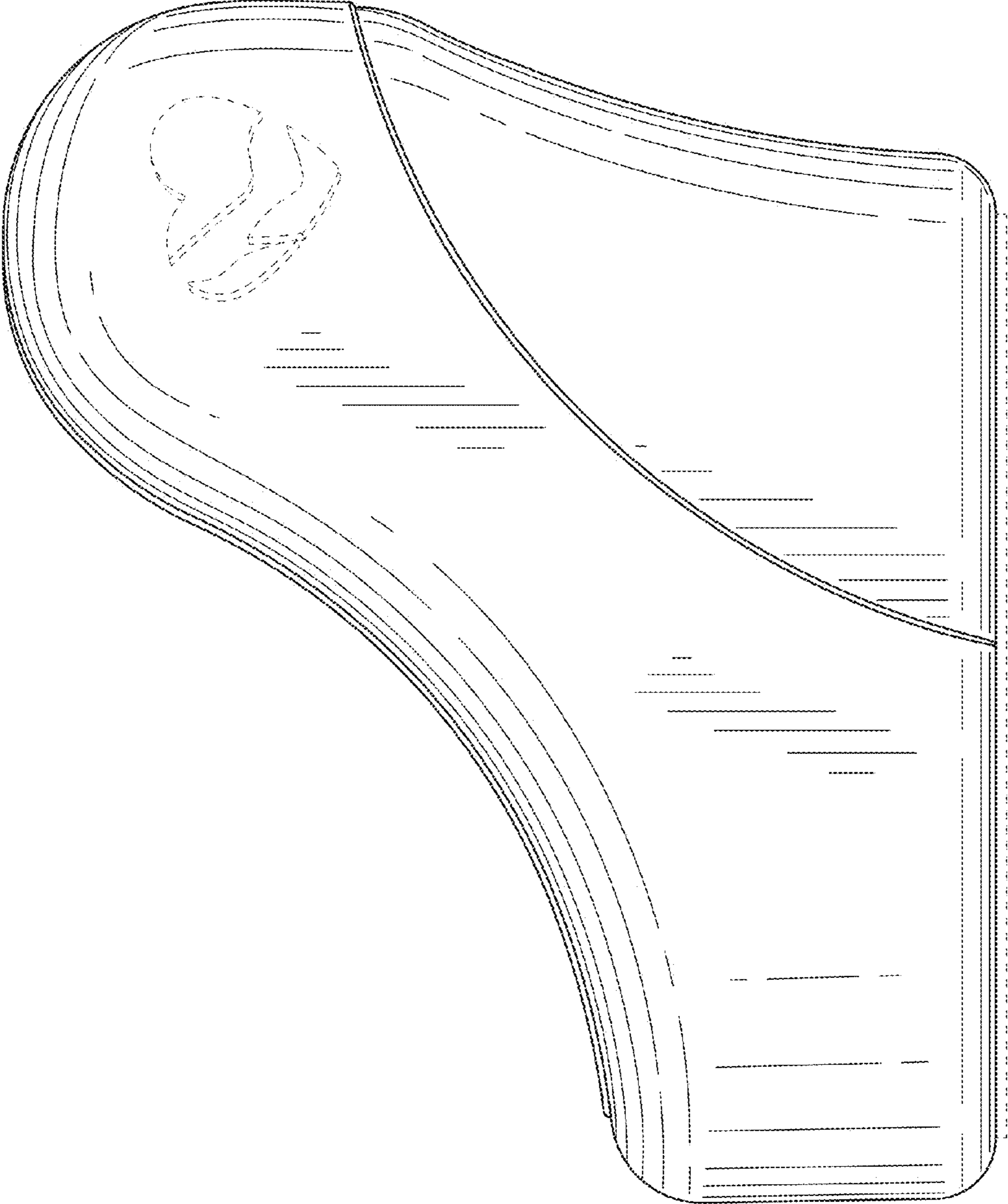

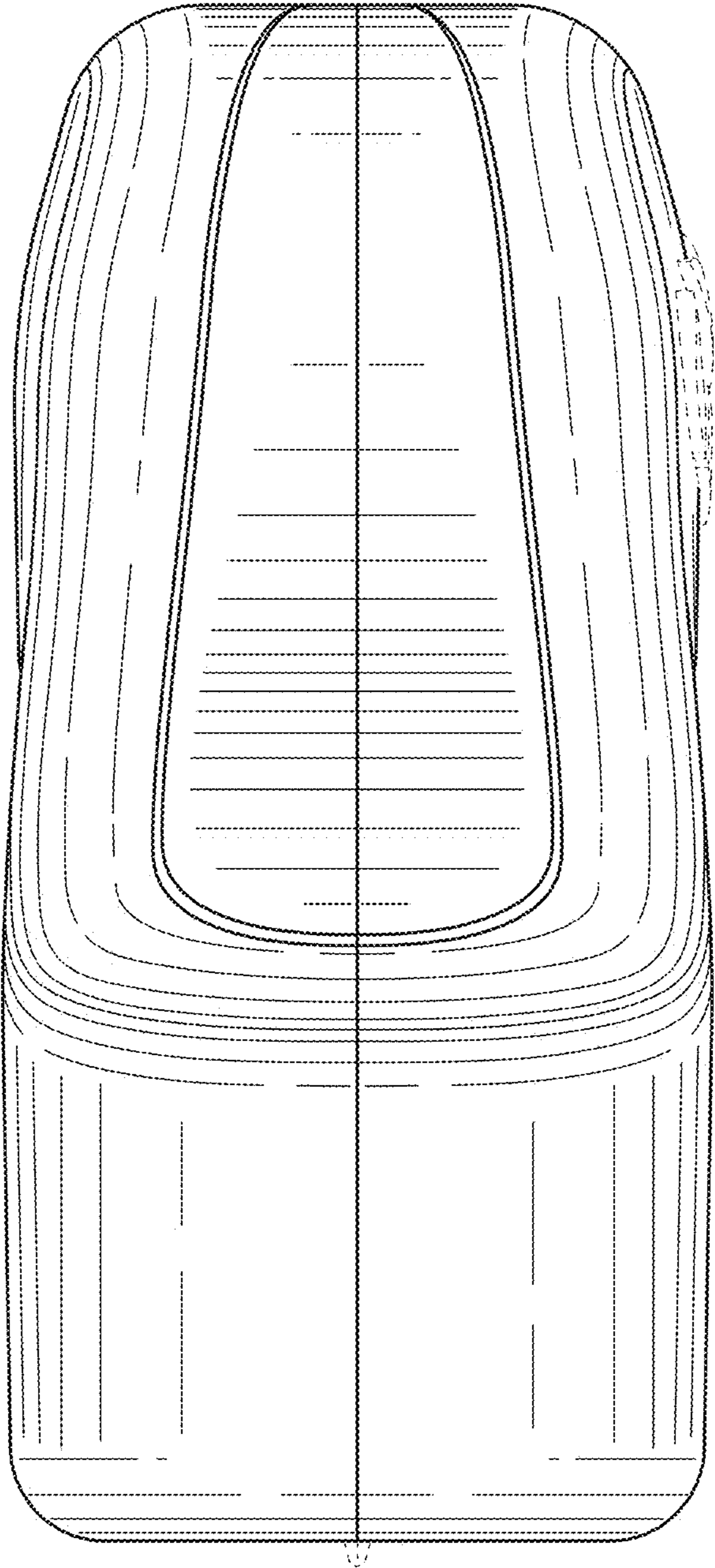

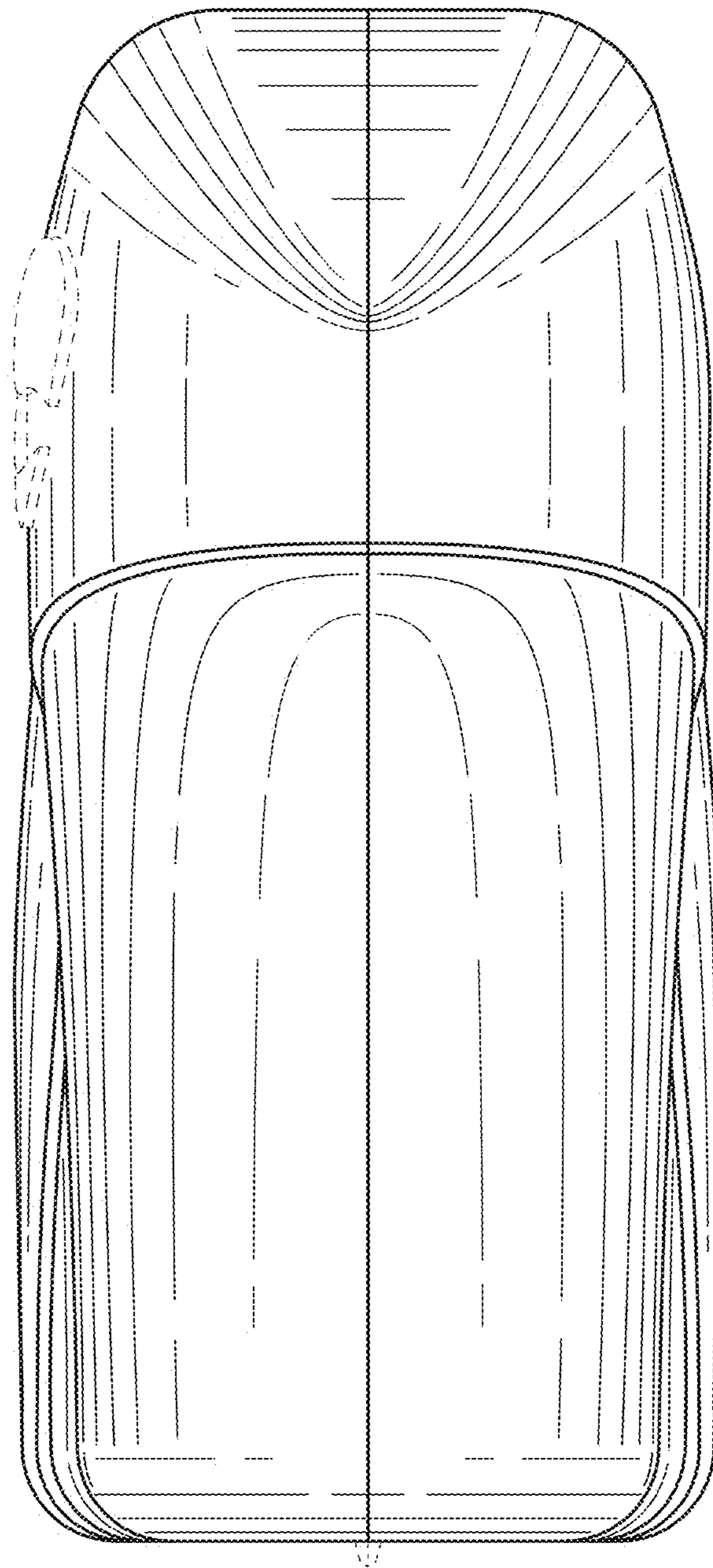

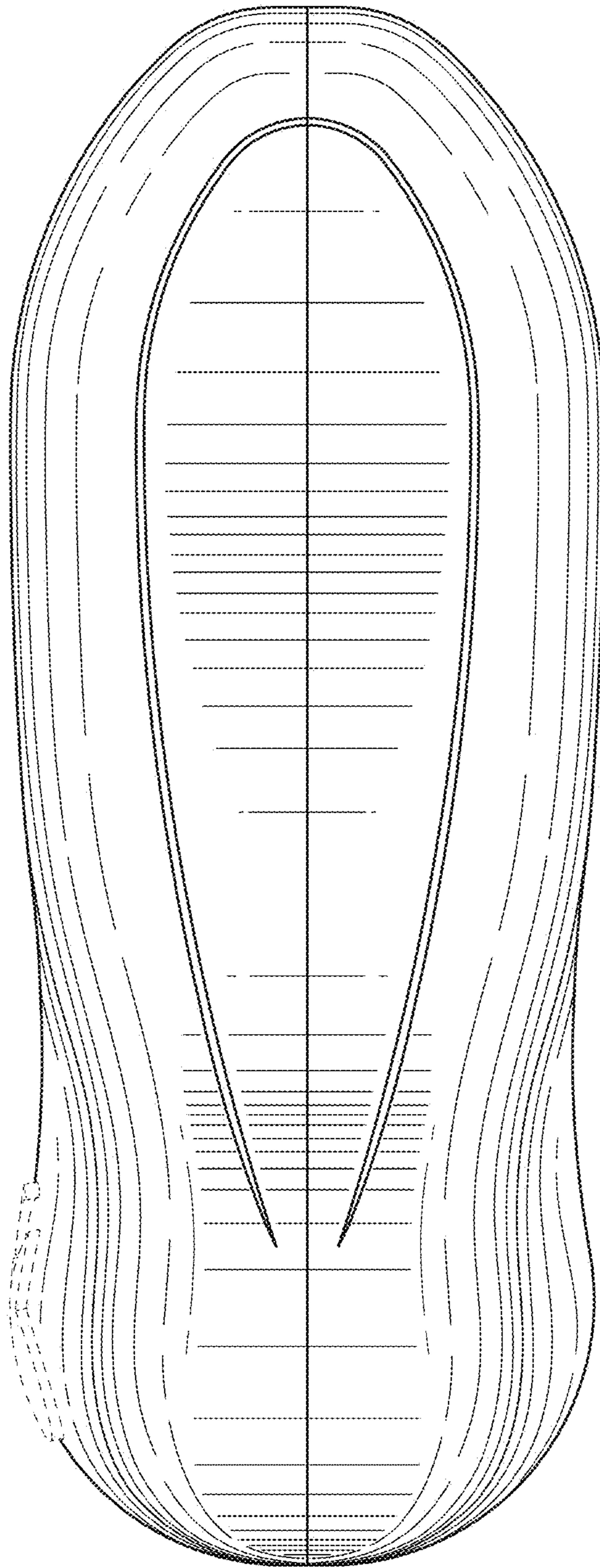

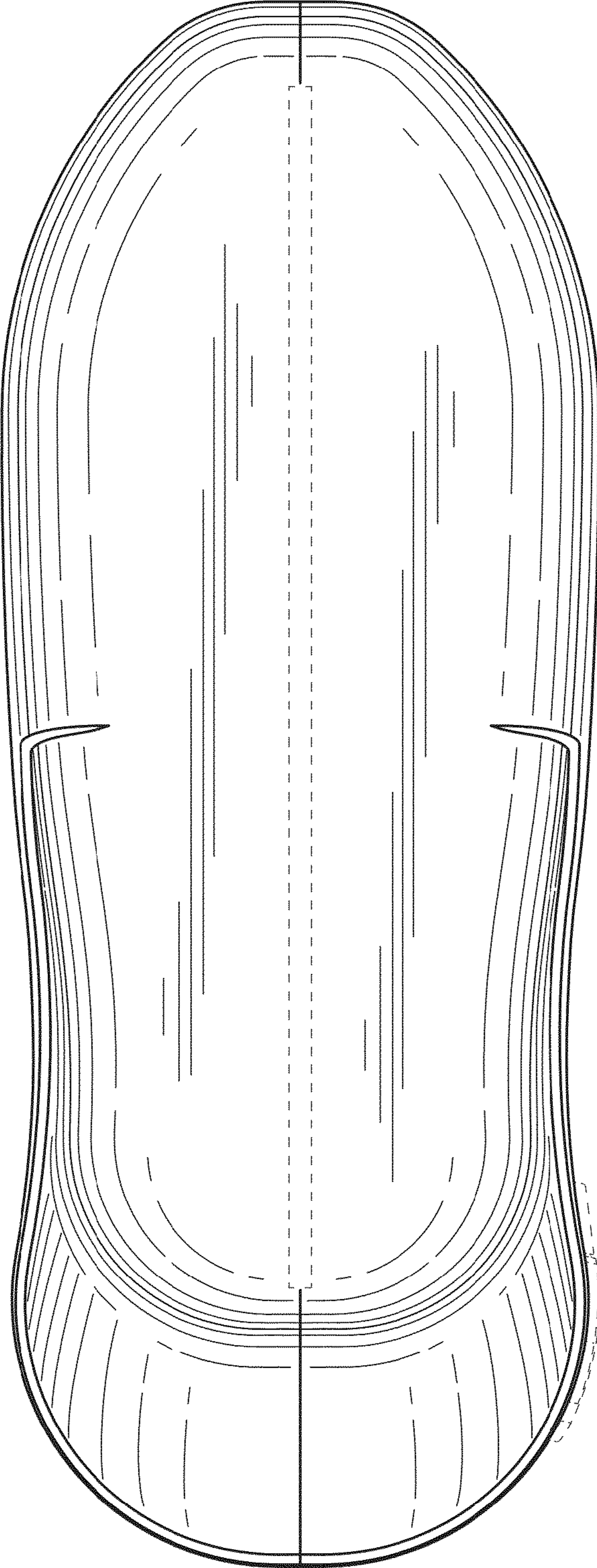
