(57) **CLAIM**

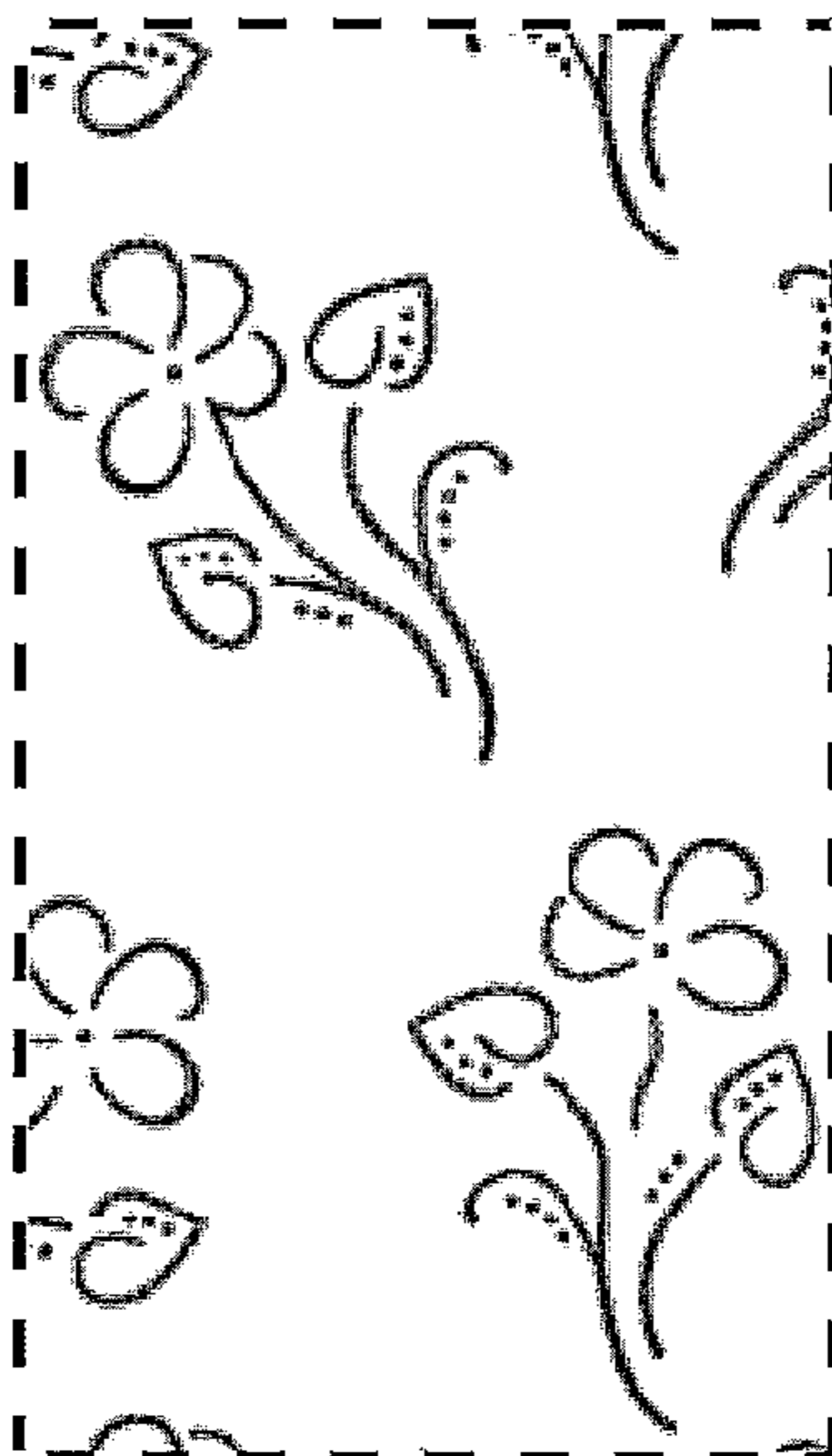
The ornamental design for an paper product, as shown and
