(57) **CLAIM**

The ornamental design for a car backrest foam and seat foam, as shown and described.

DESCRIPTION

FIG. 1 depicts a perspective view of a car backrest foam and a perspective view of a car seat foam, of the invention.

FIG. 2 depicts a front view of the car backrest foam.

FIG. 3 depicts a side view of the car backrest foam.

FIG. 4 depicts a top view of the car backrest foam.

FIG. 5 depicts a front view of the car seat foam.

FIG. 6 depicts a side view of the car seat foam; and,

FIG. 7 depicts a top view of the car seat foam.

FIGS. 2-7 show the car seat foam or the car backrest foam separately for ease of illustration.

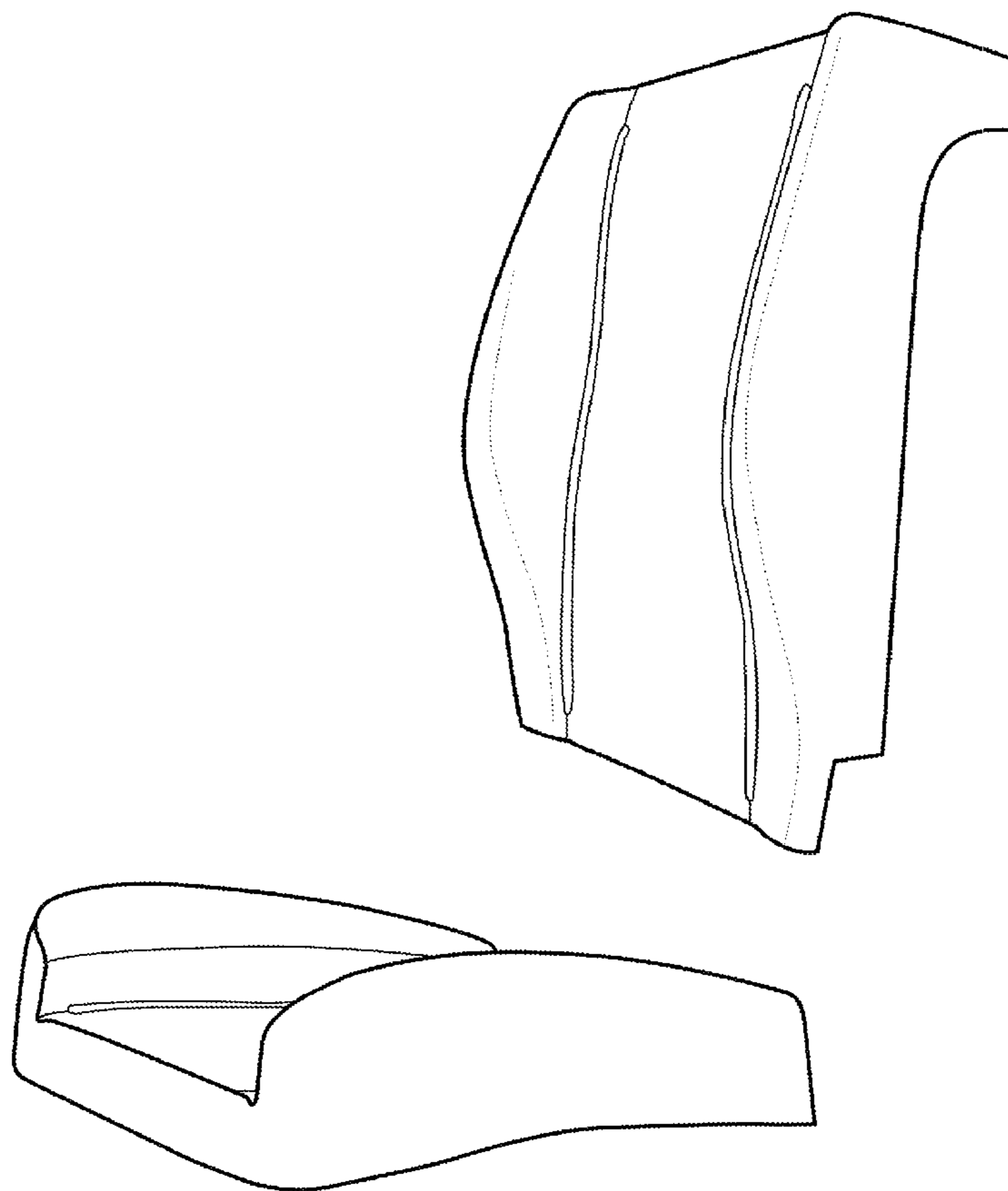
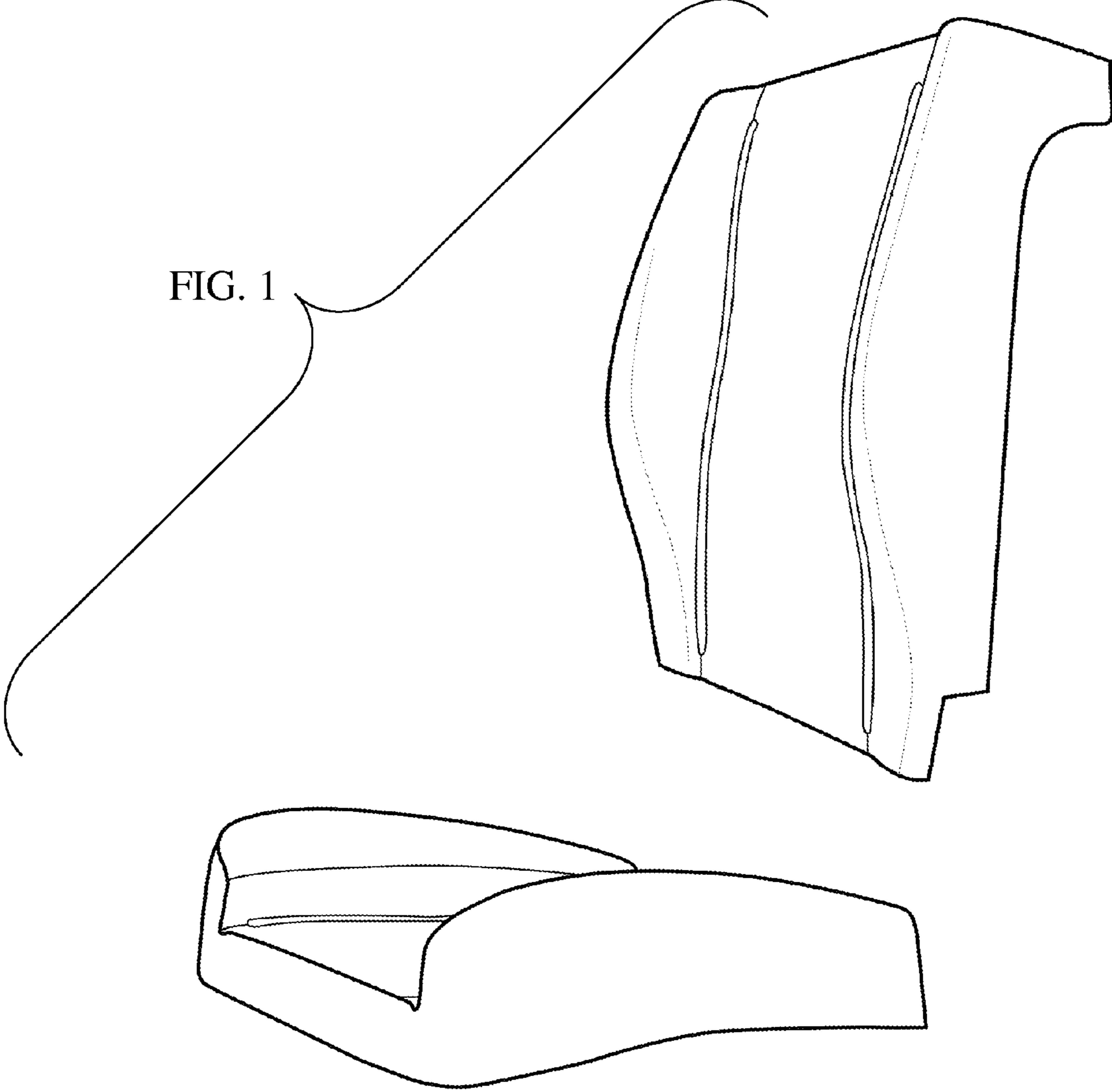

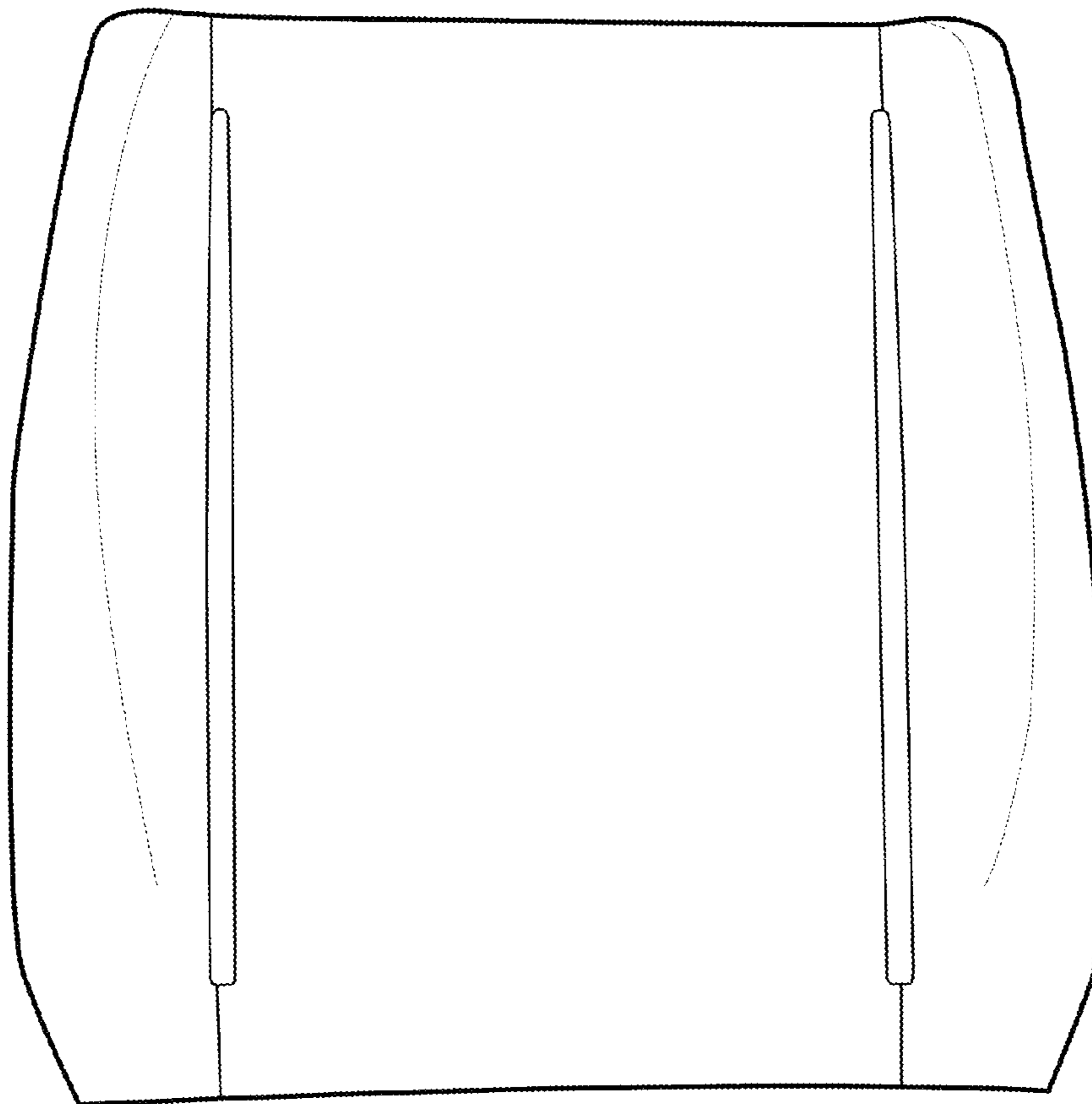

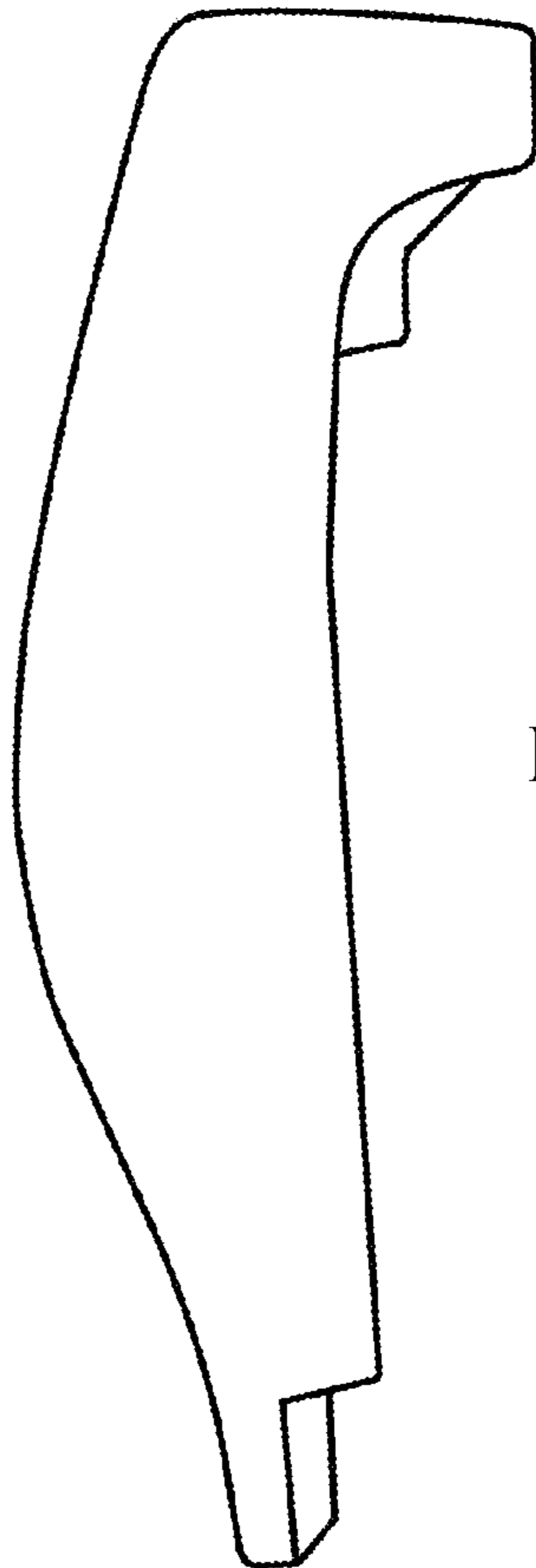

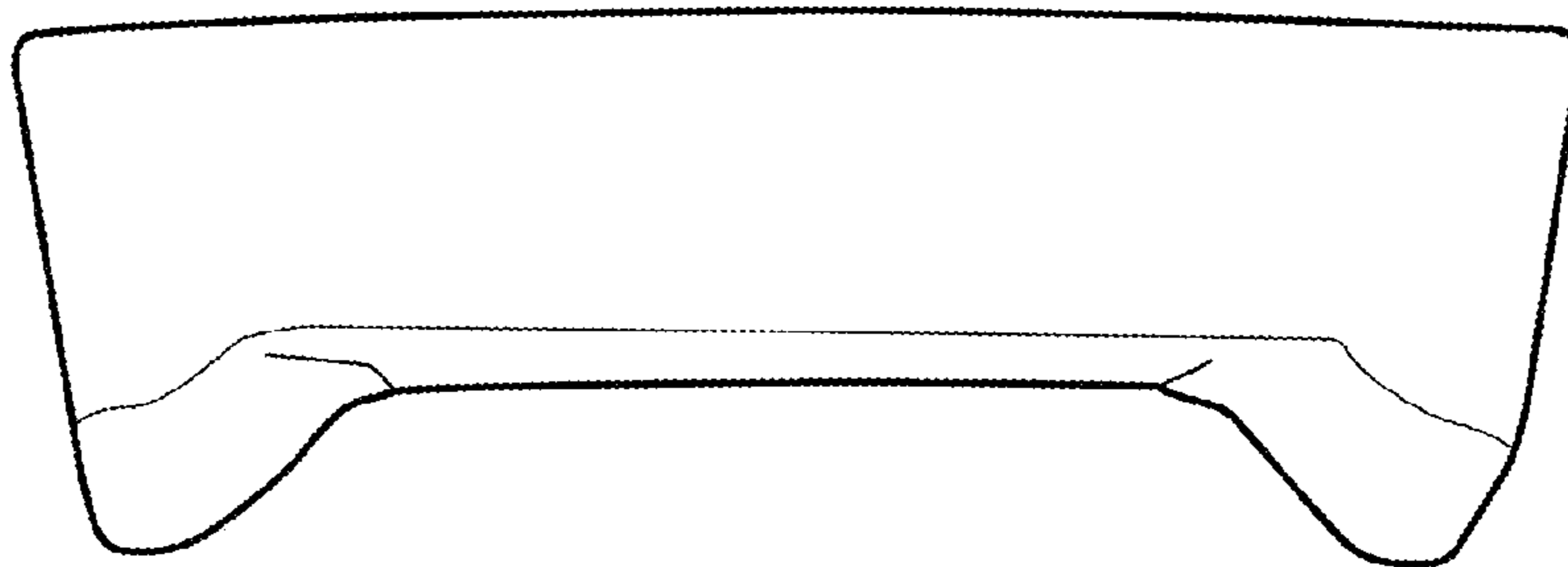

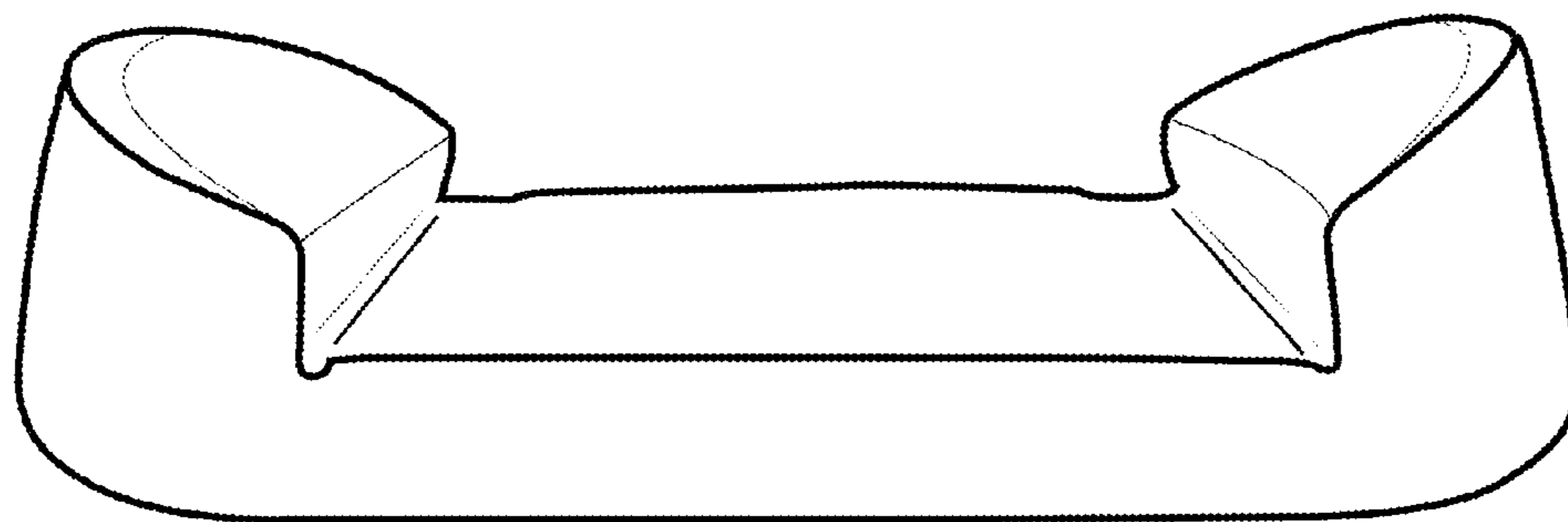

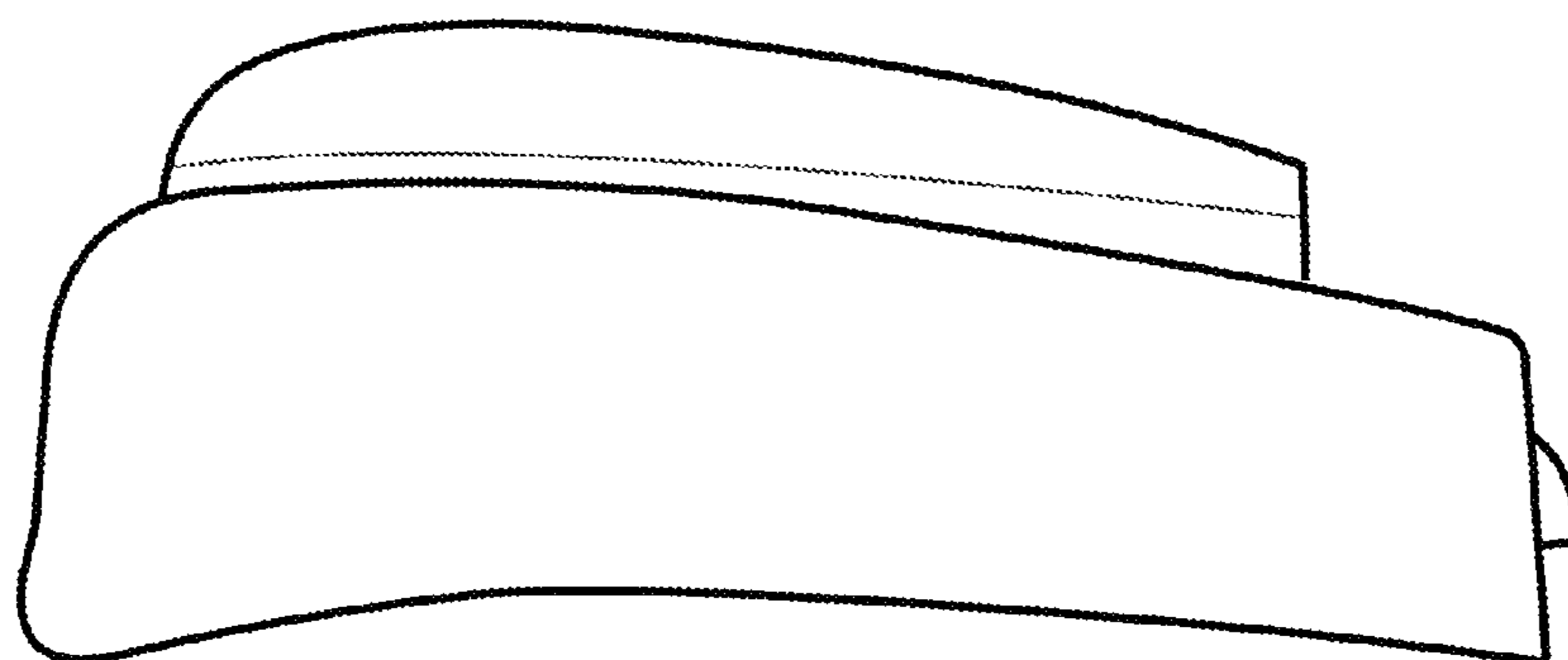

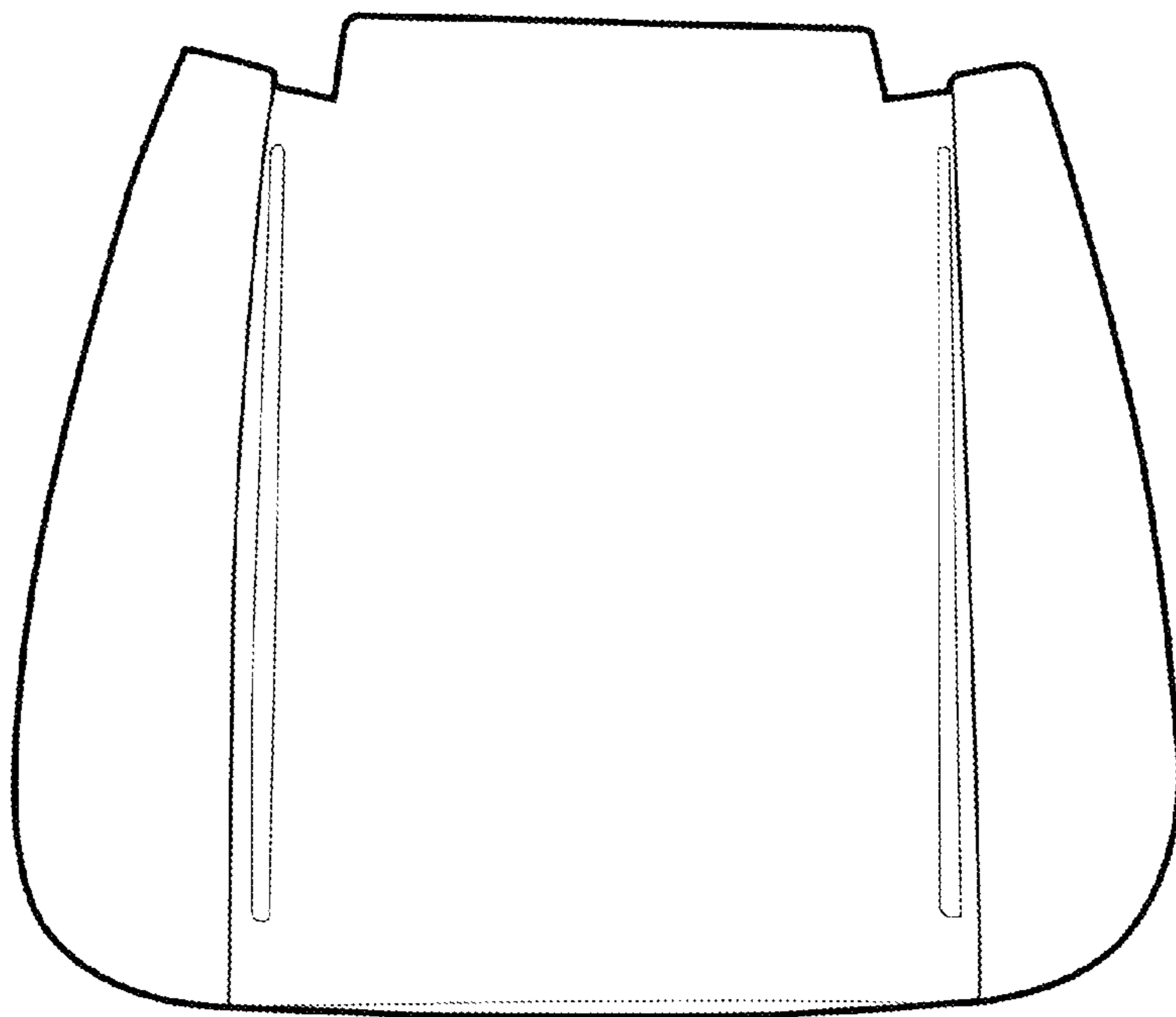
