The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of rear and right side of a chair showing our new design;
FIG. 2 is a front perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom view thereof; and,
FIG. 9 is a cross section view omitting interior mechanism at 9-9 shown in FIG. 7 thereof.

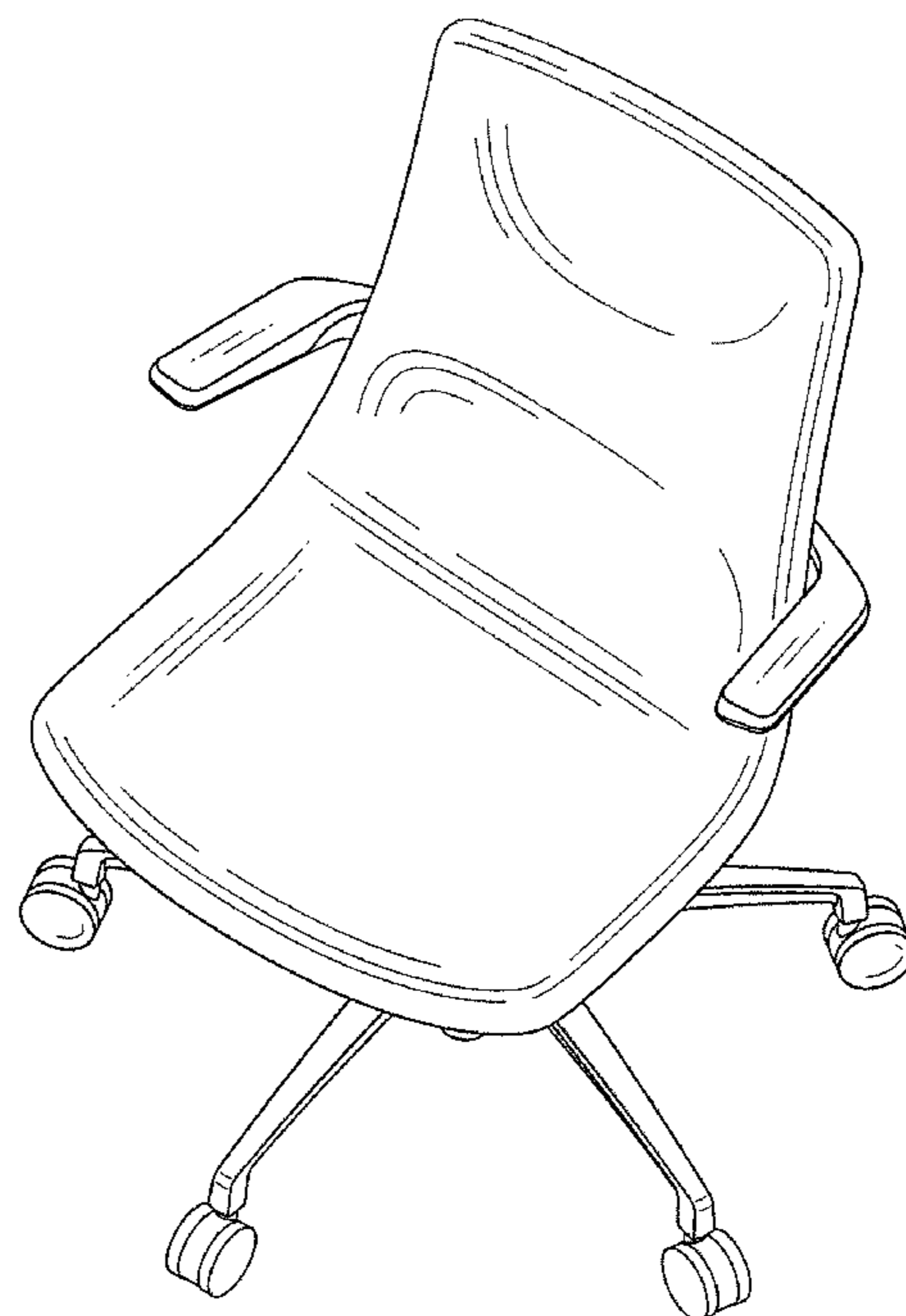

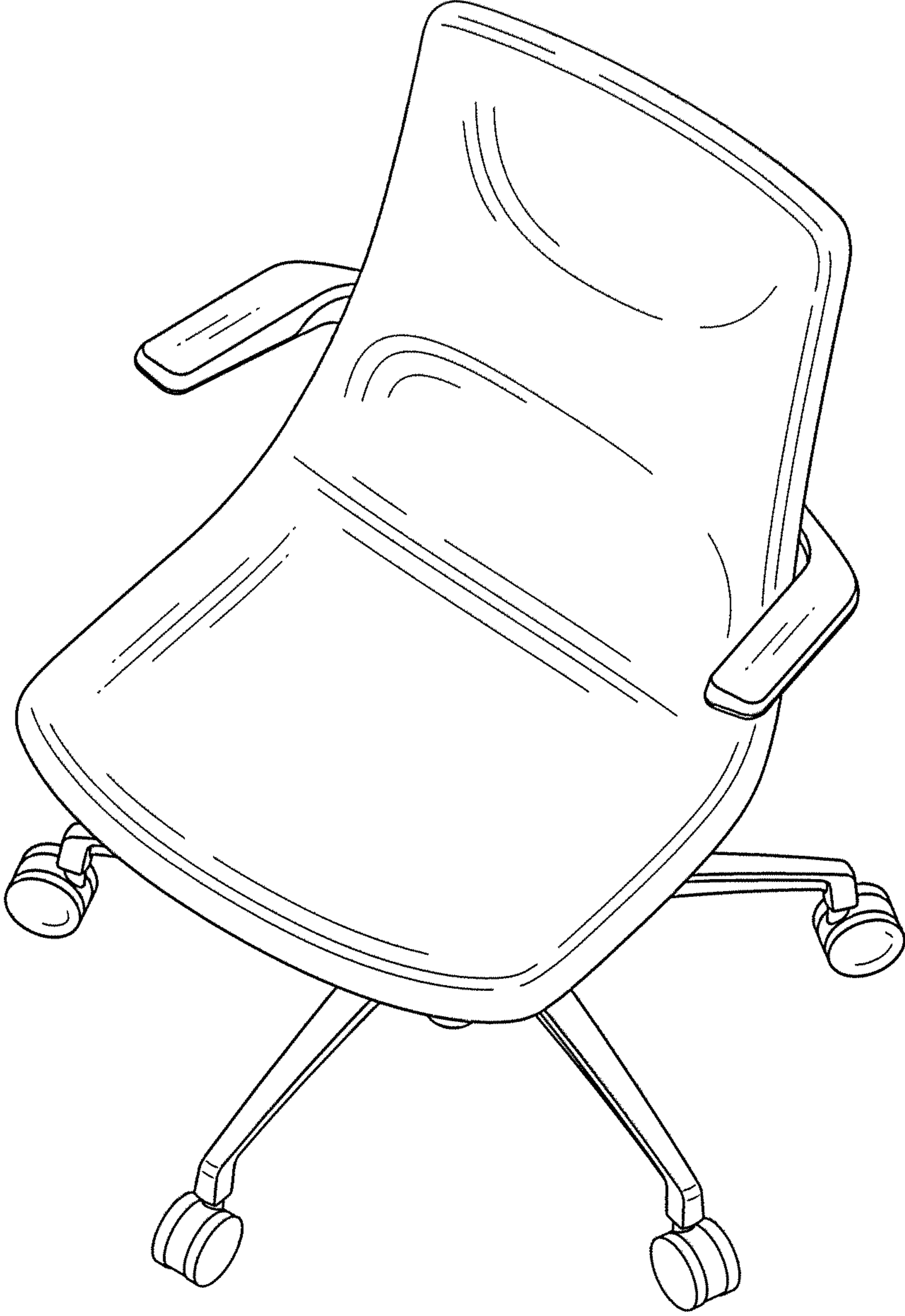

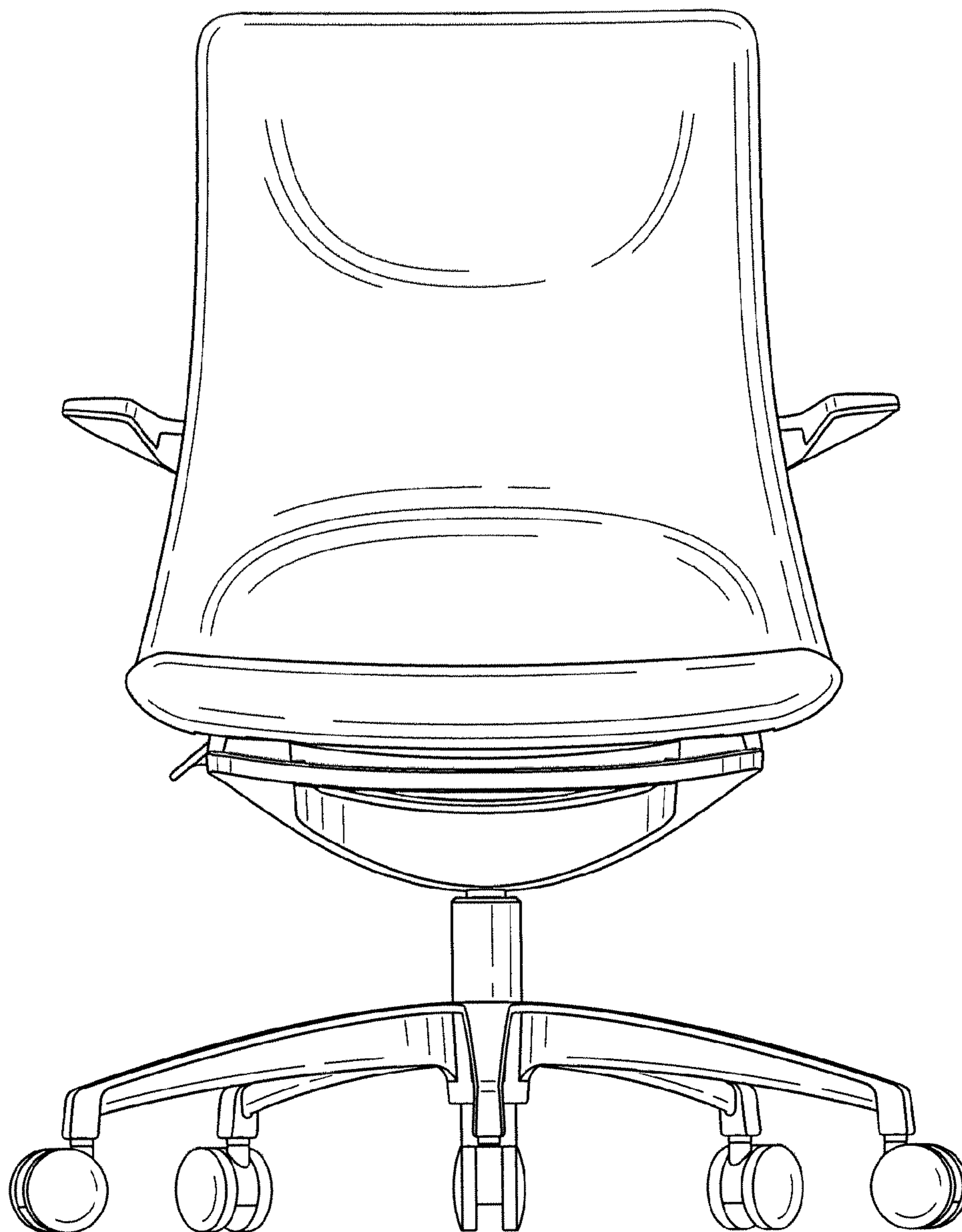

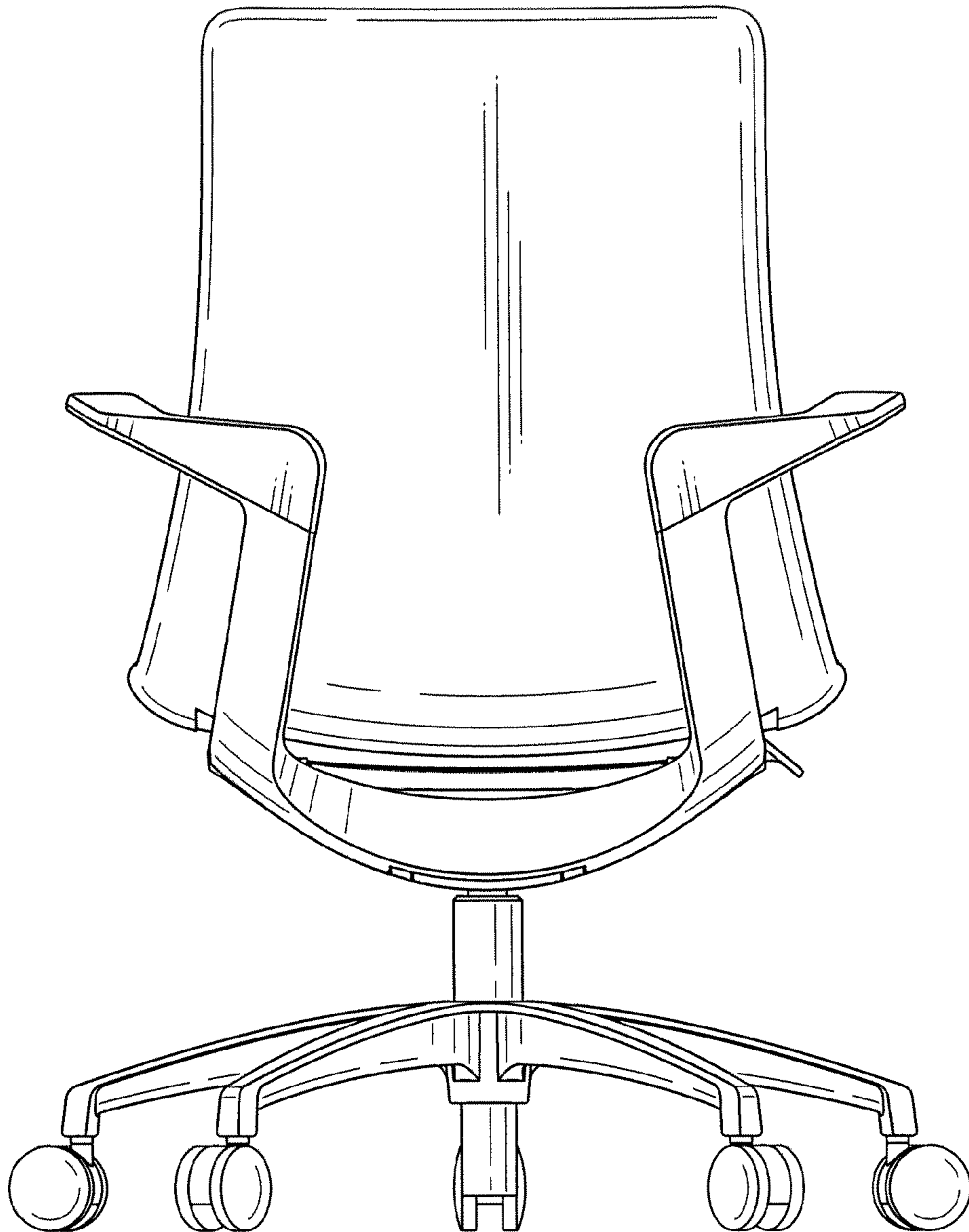

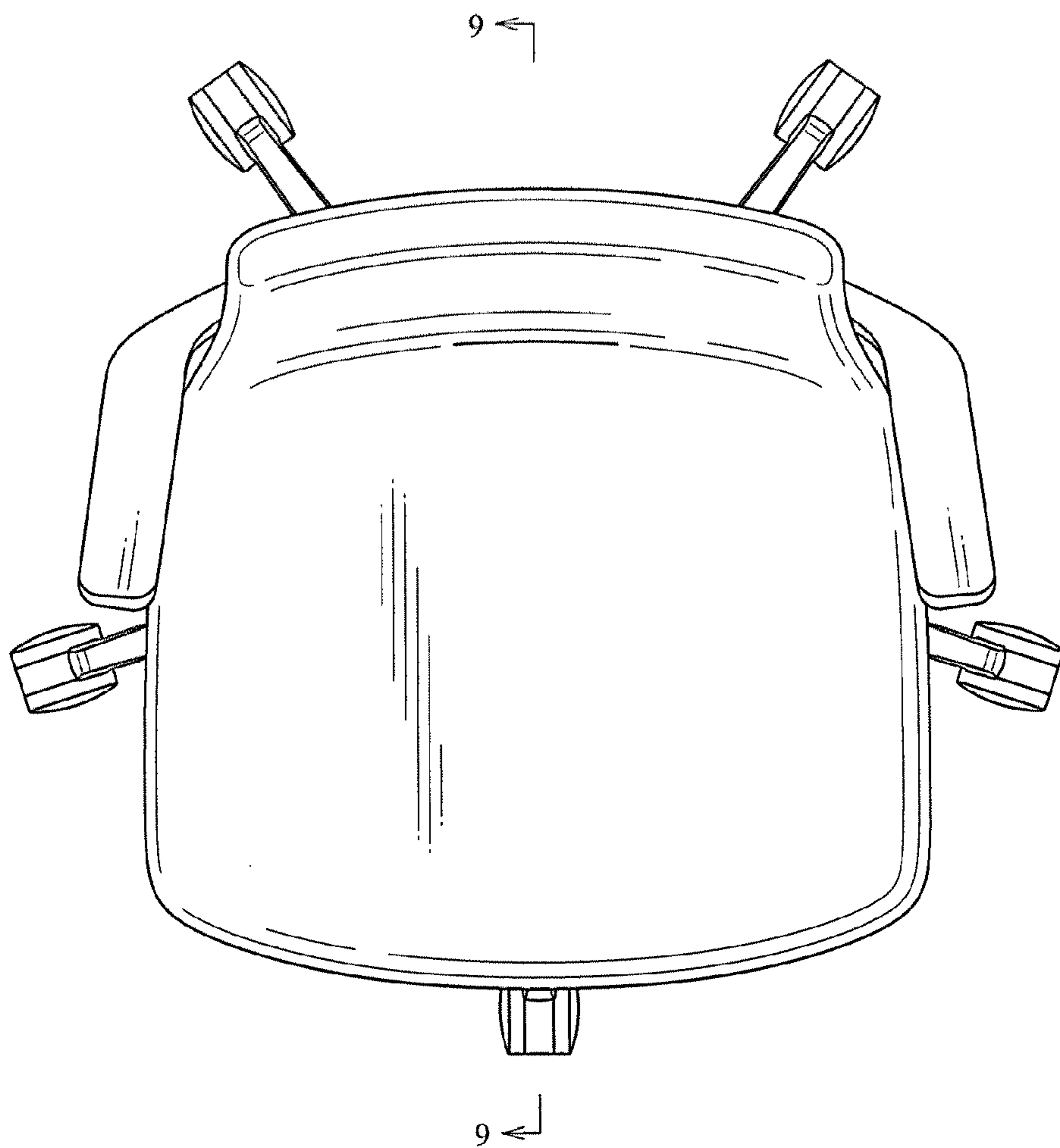

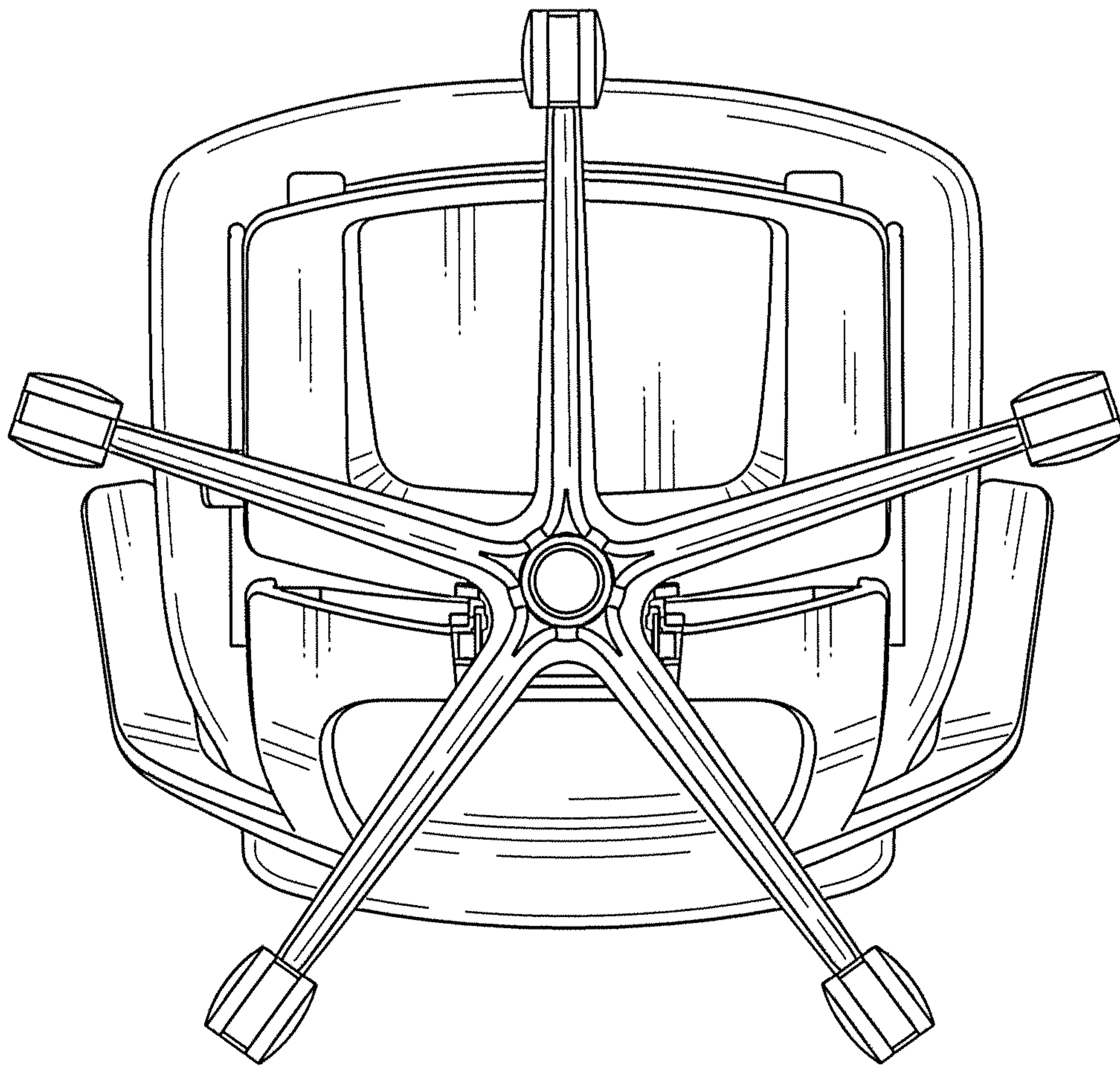
