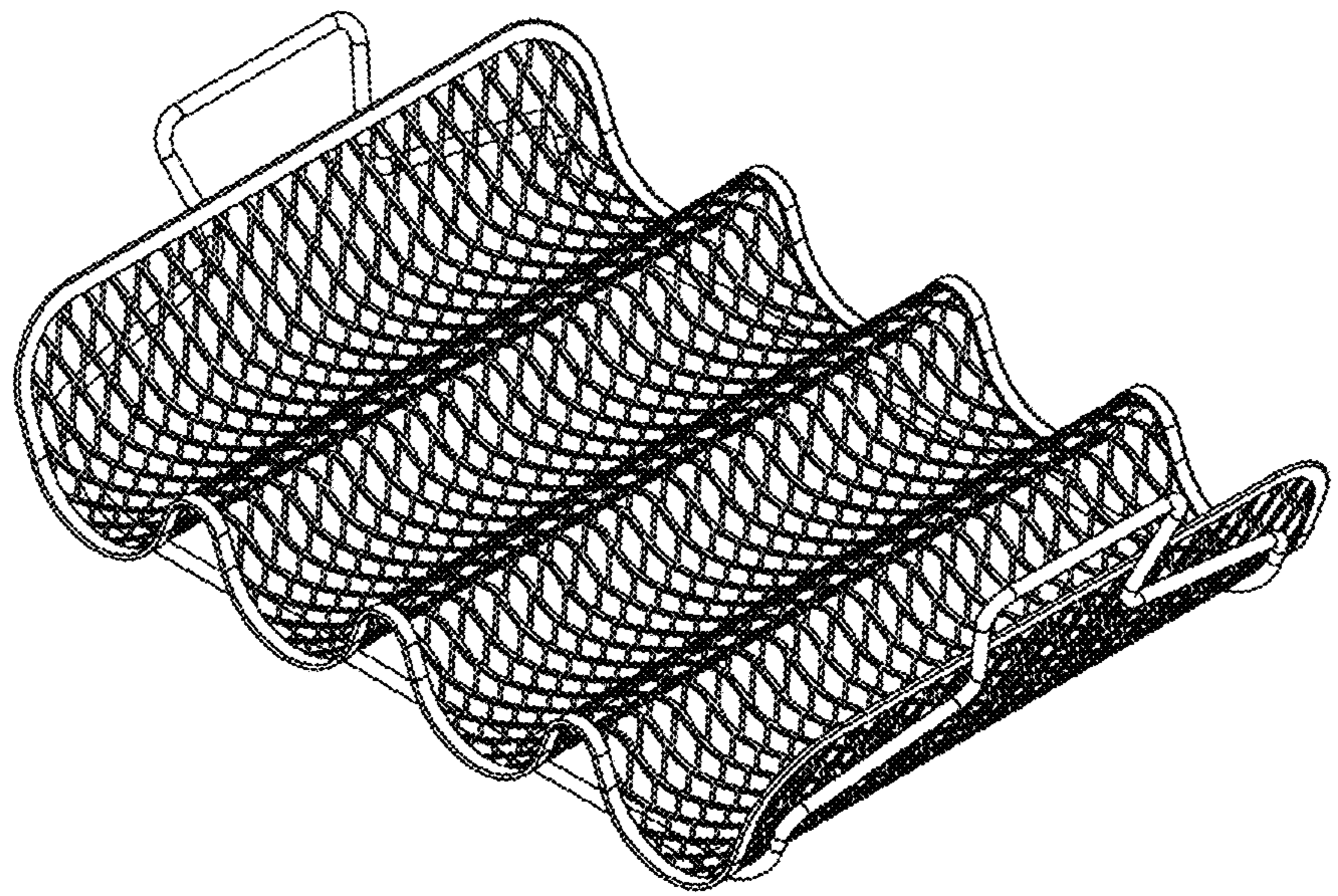

(57) **CLAIM**
The ornamental design for a wave BBQ mesh cookware, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the wave BBQ mesh cookware thereof. FIG. 2 is a bottom isometric view thereof. FIG. 3 is a top isometric view thereof. FIG. 4 is an end view with the opposing end view being a mirror image thereof. FIG. 5 is a side view with the opposing side view being a mirror image thereof; and, FIG. 6 is a bottom view thereof. Any broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

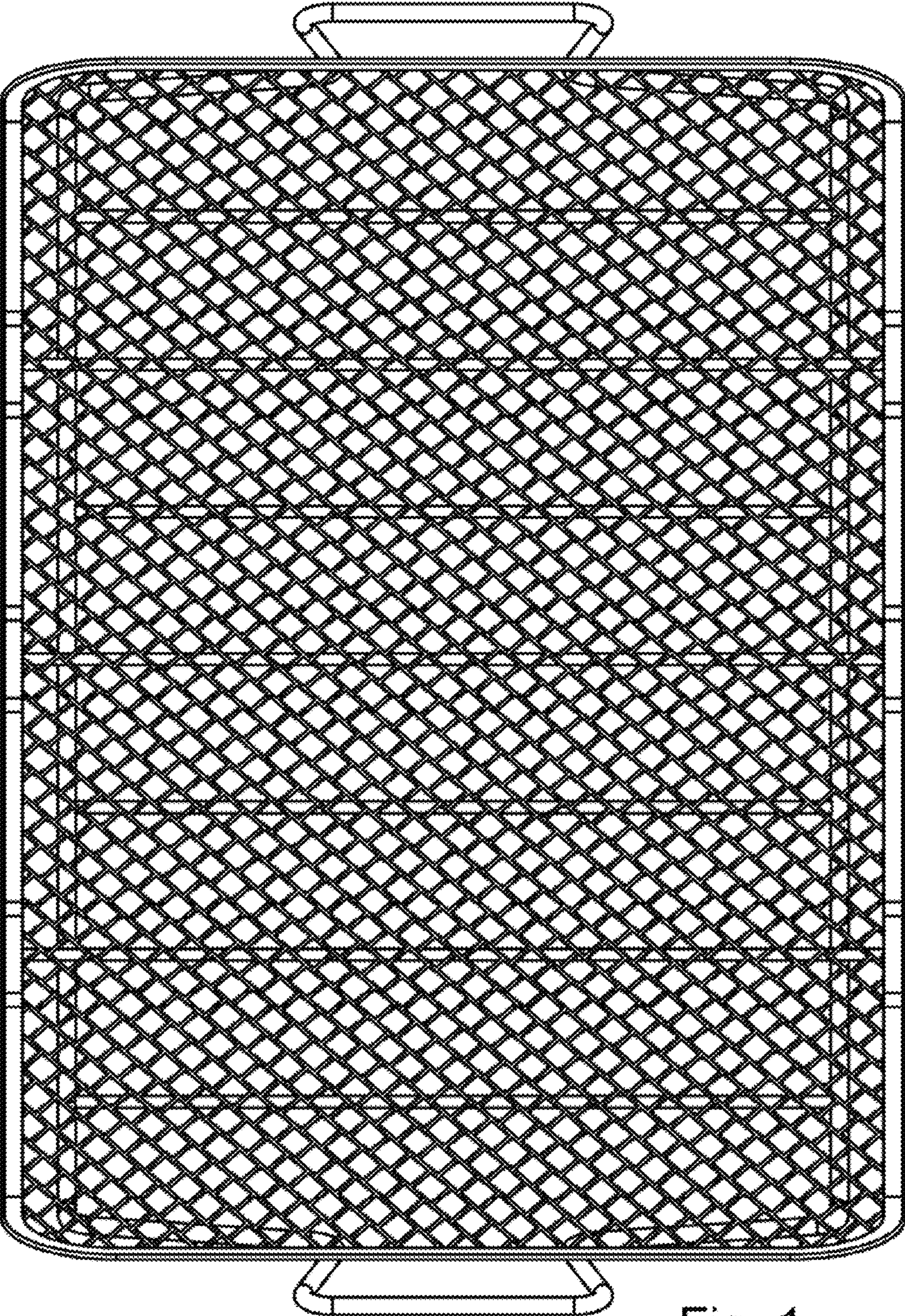

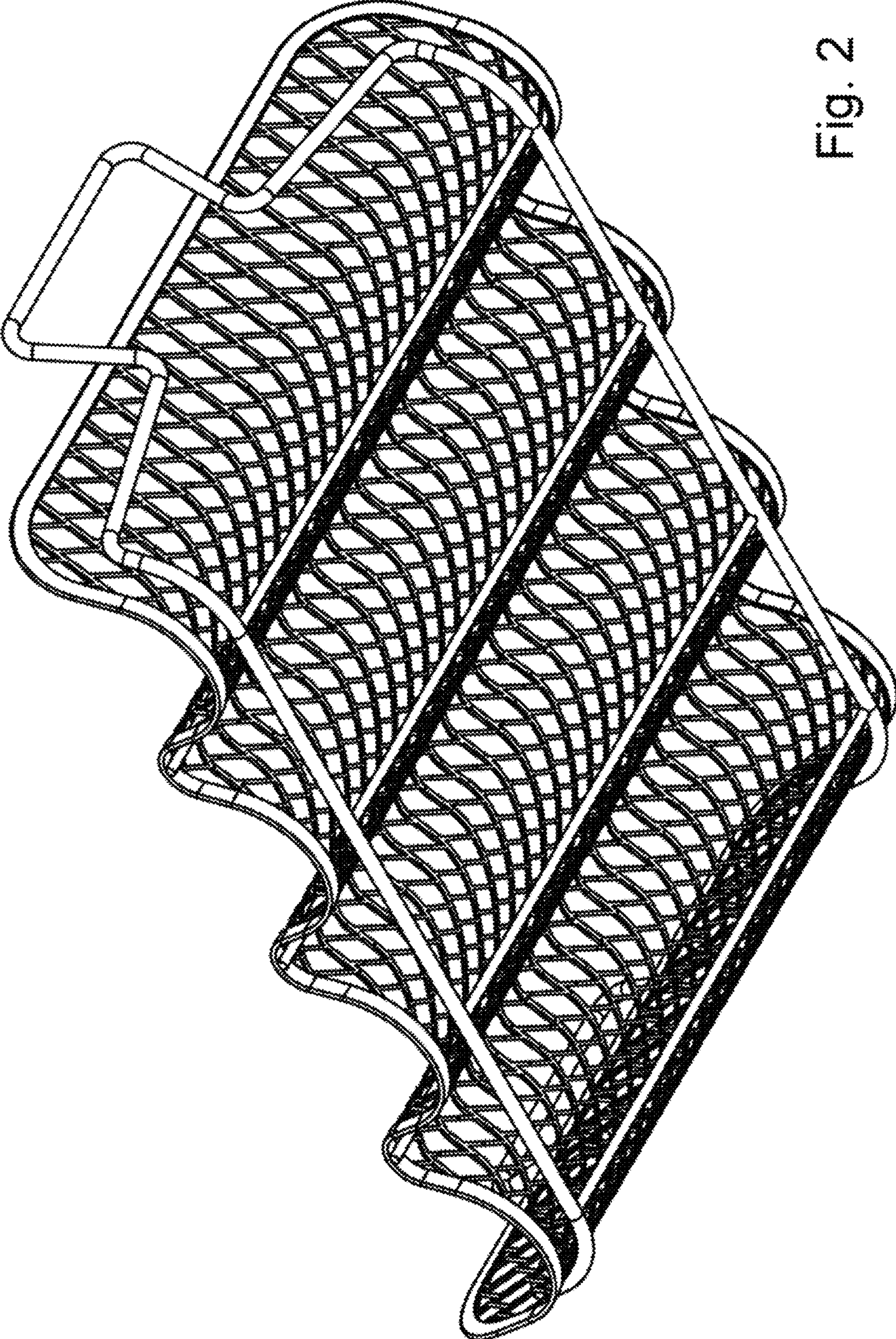

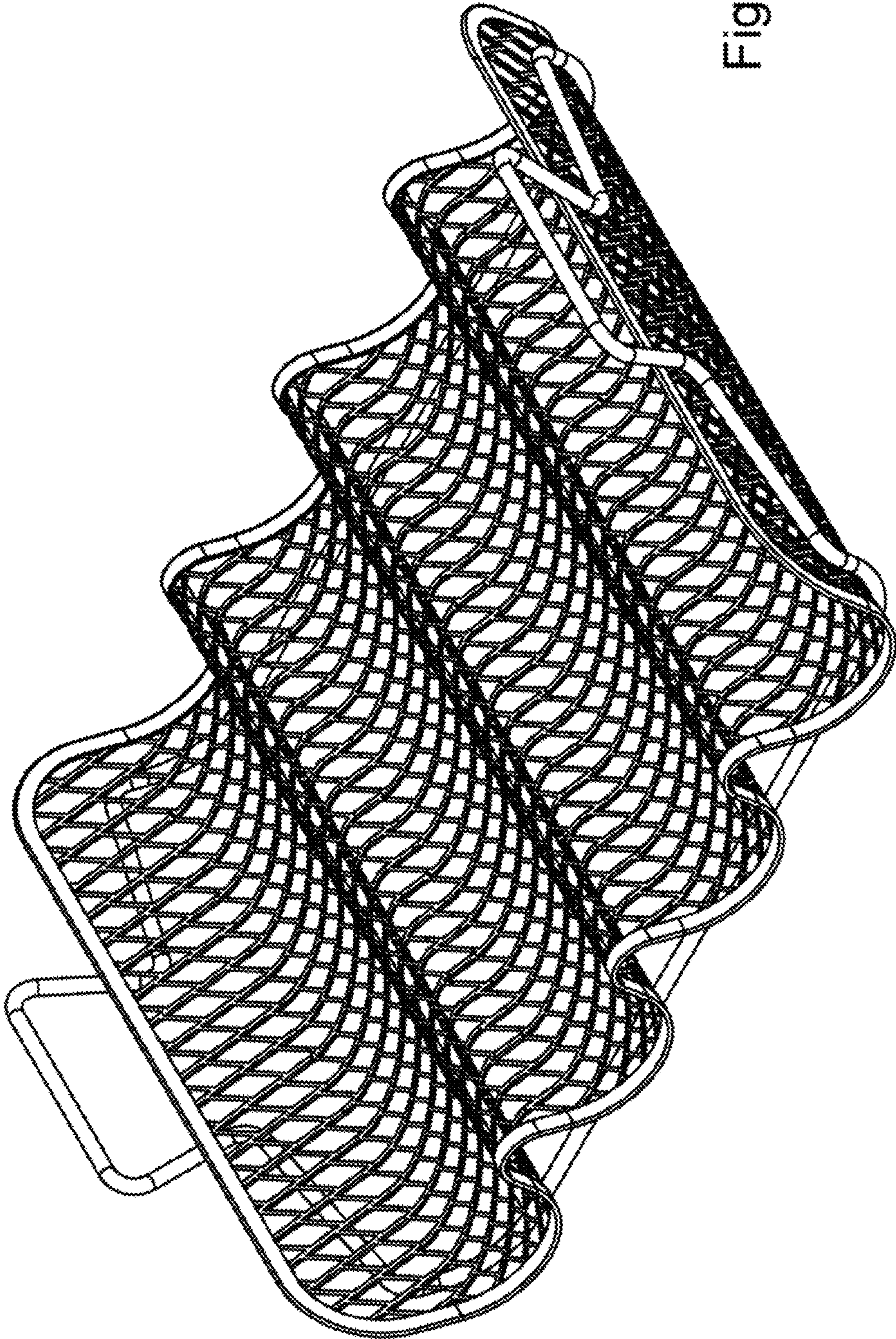

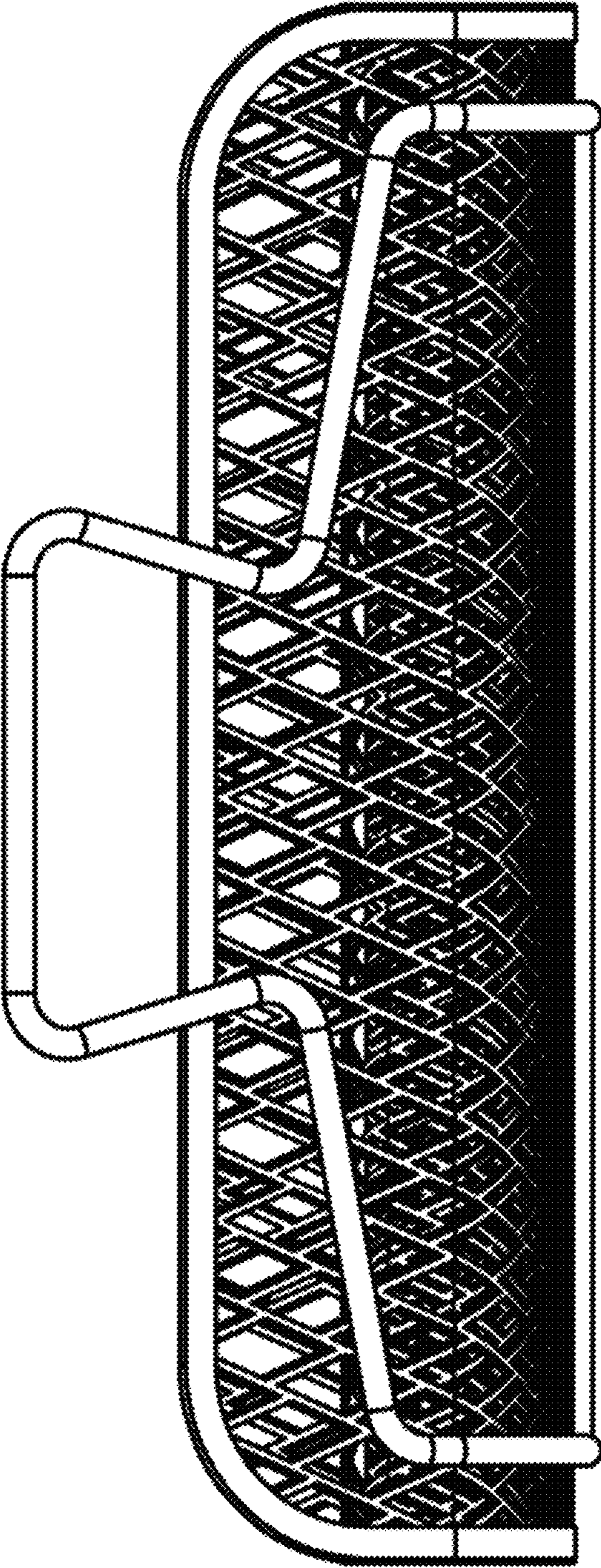

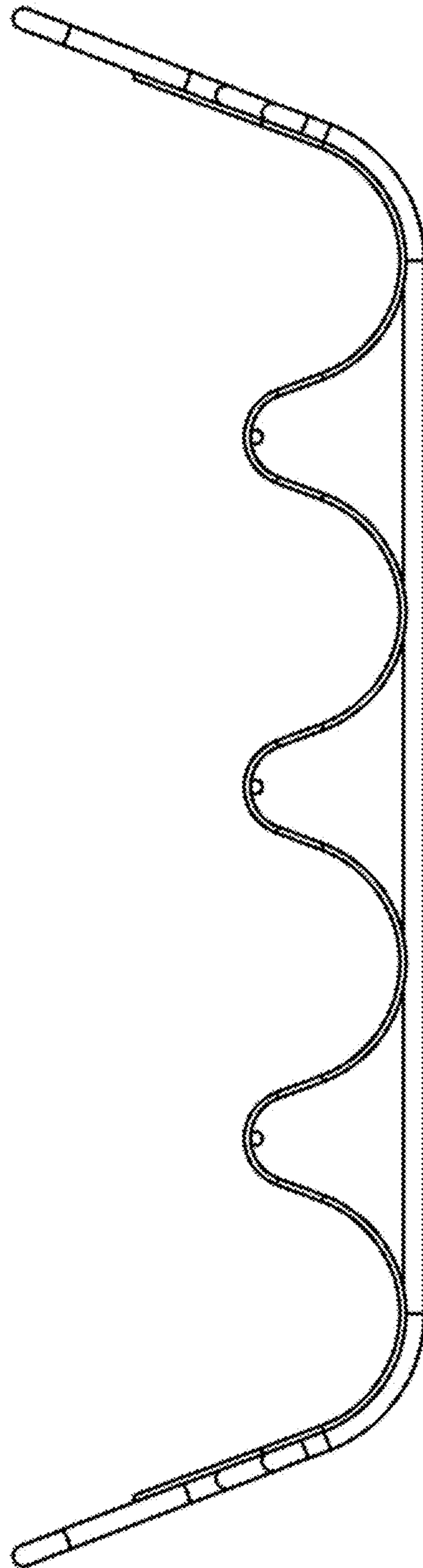

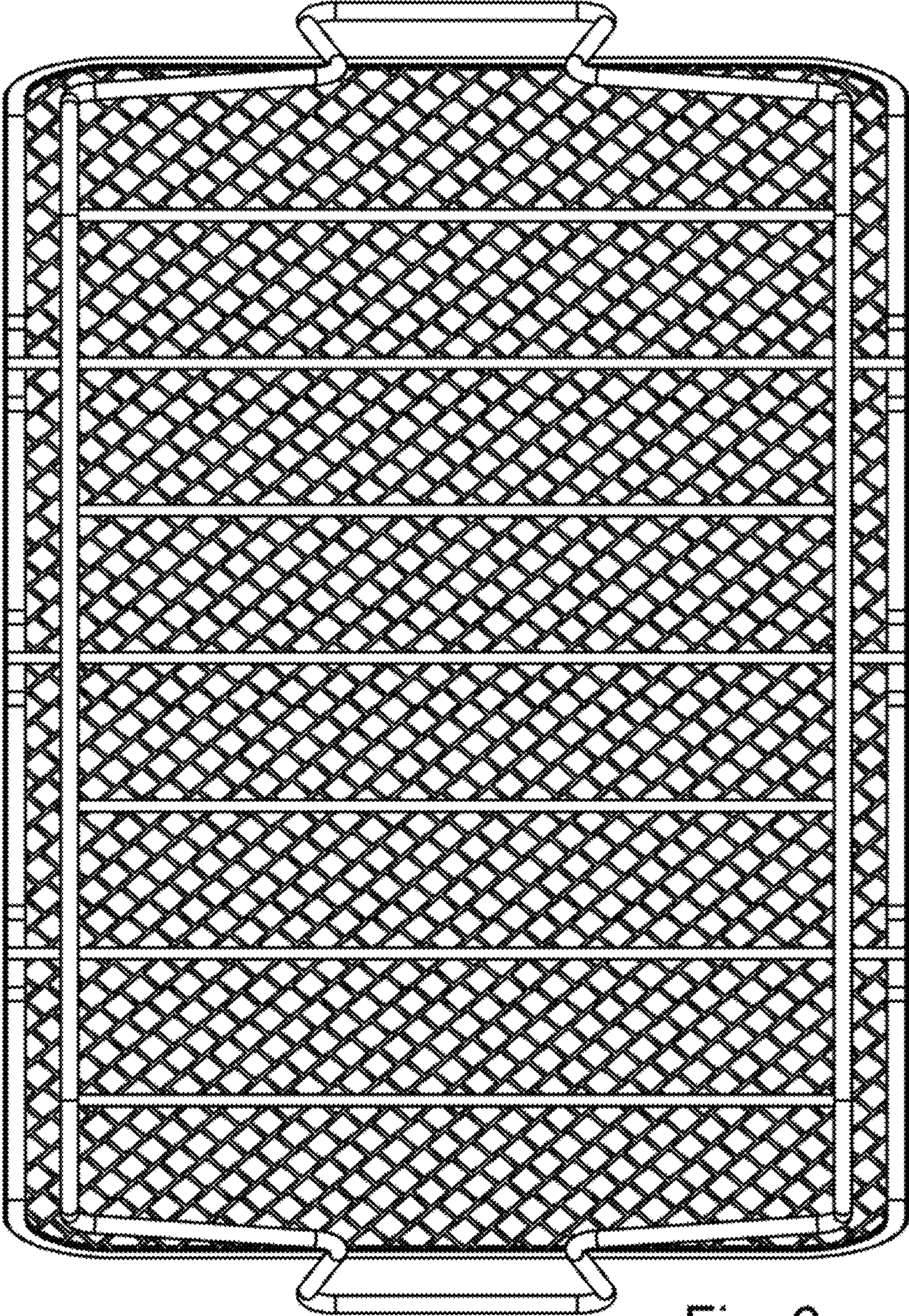
