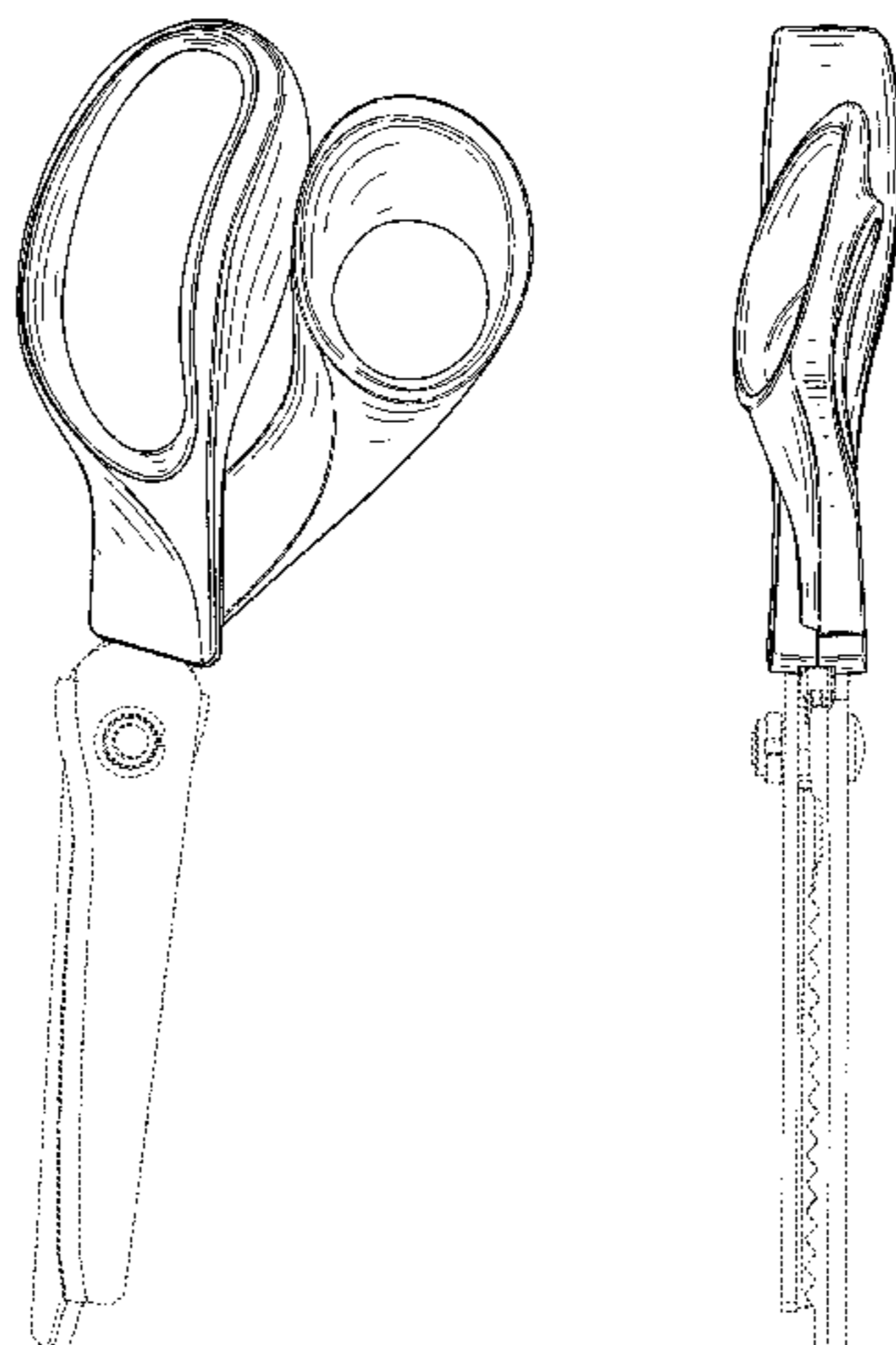

(57) **CLAIM**

We claim the ornamental design for scissor handles, as shown and described.

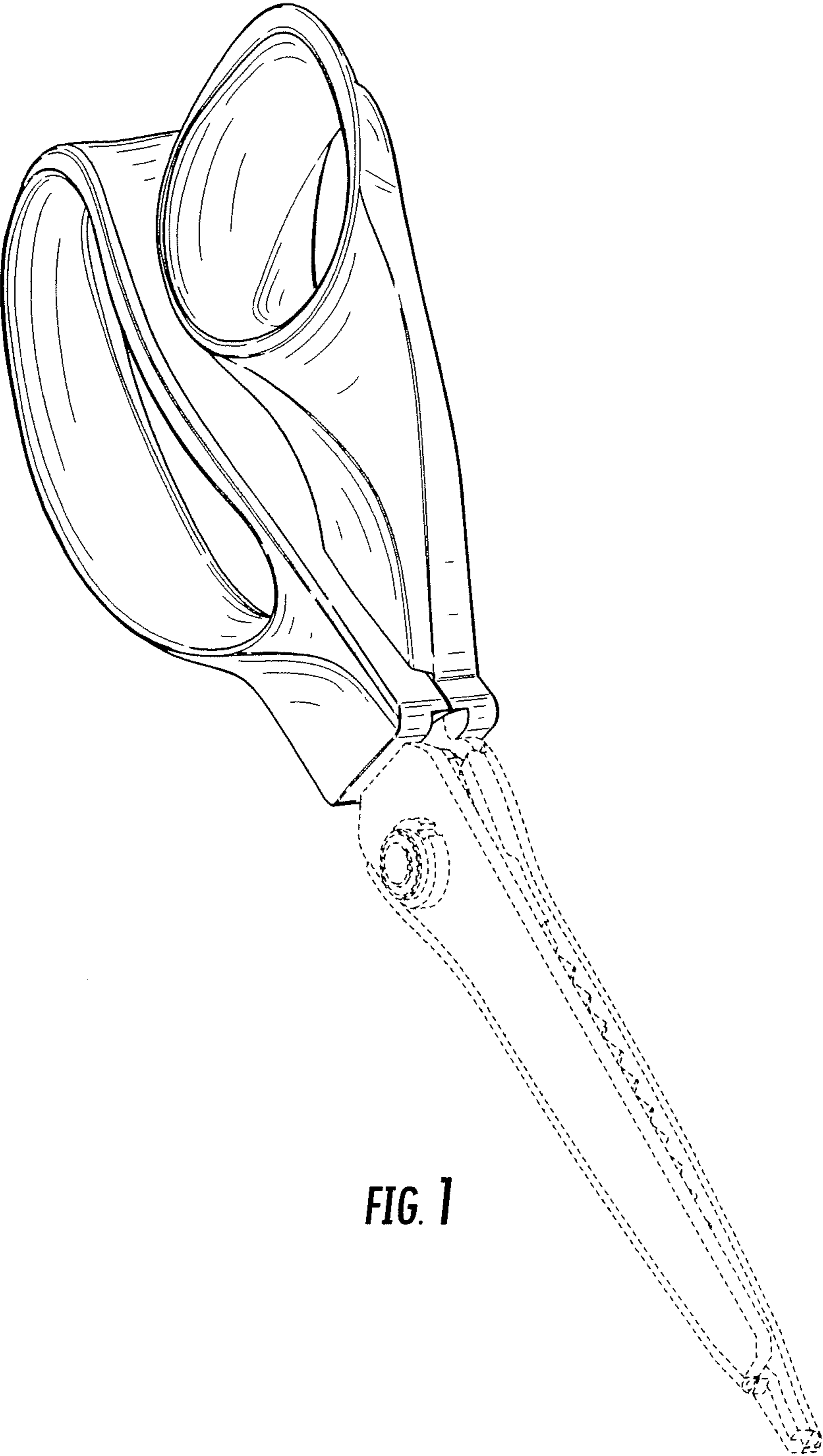

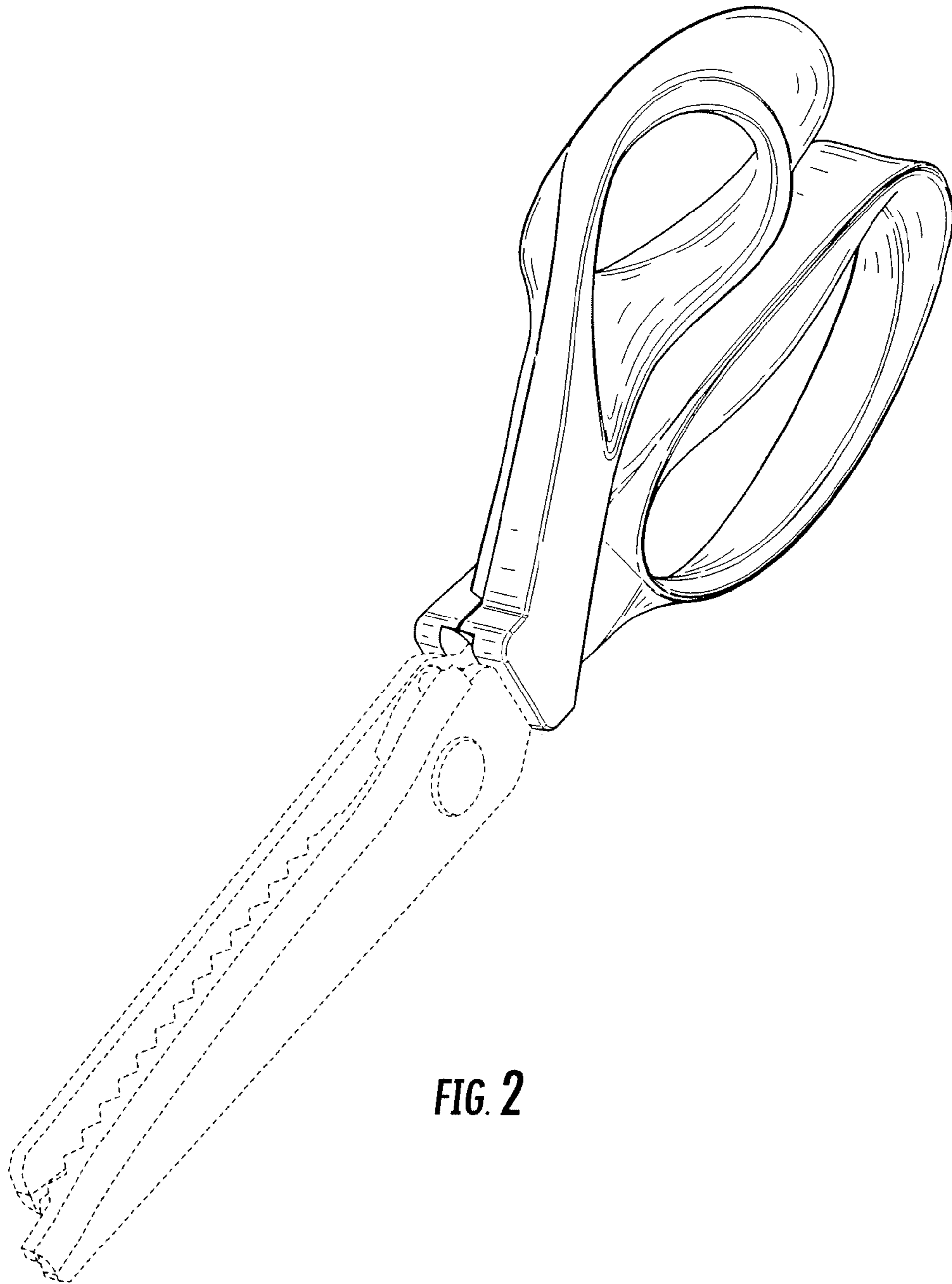
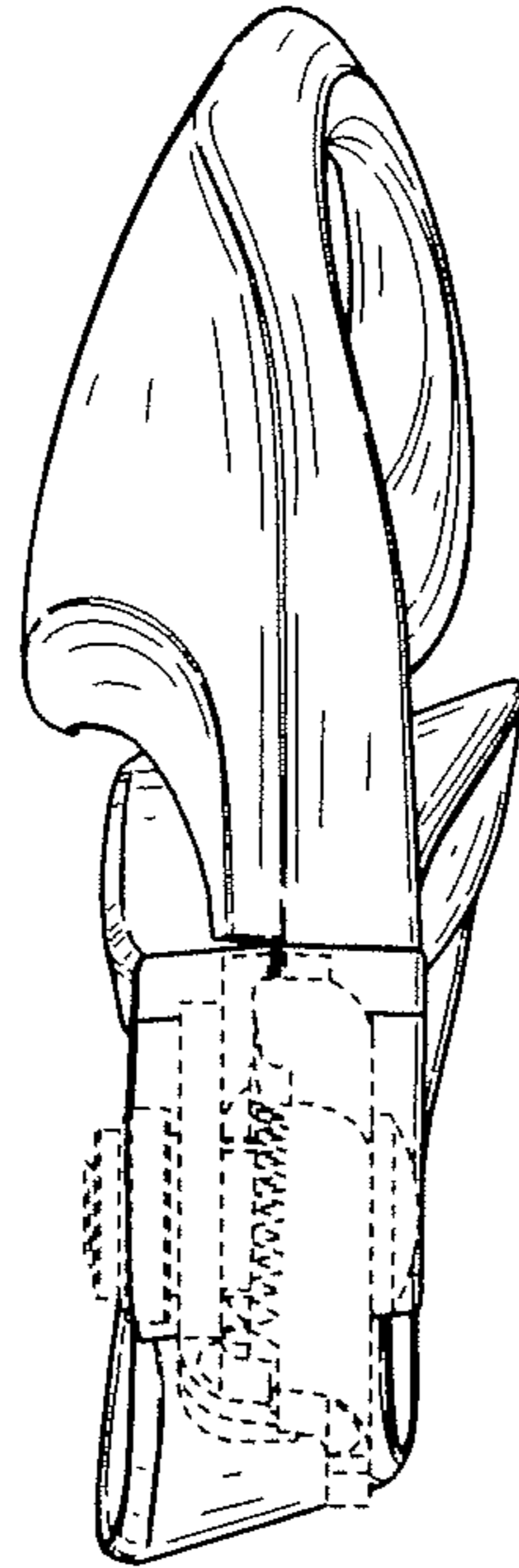
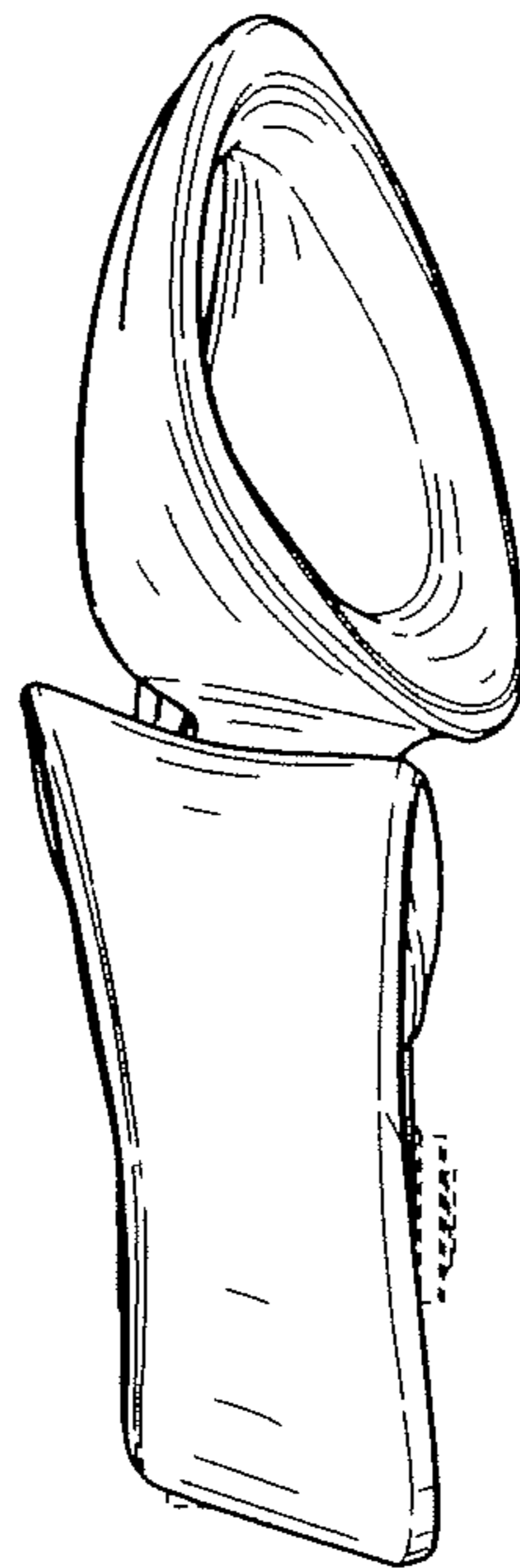

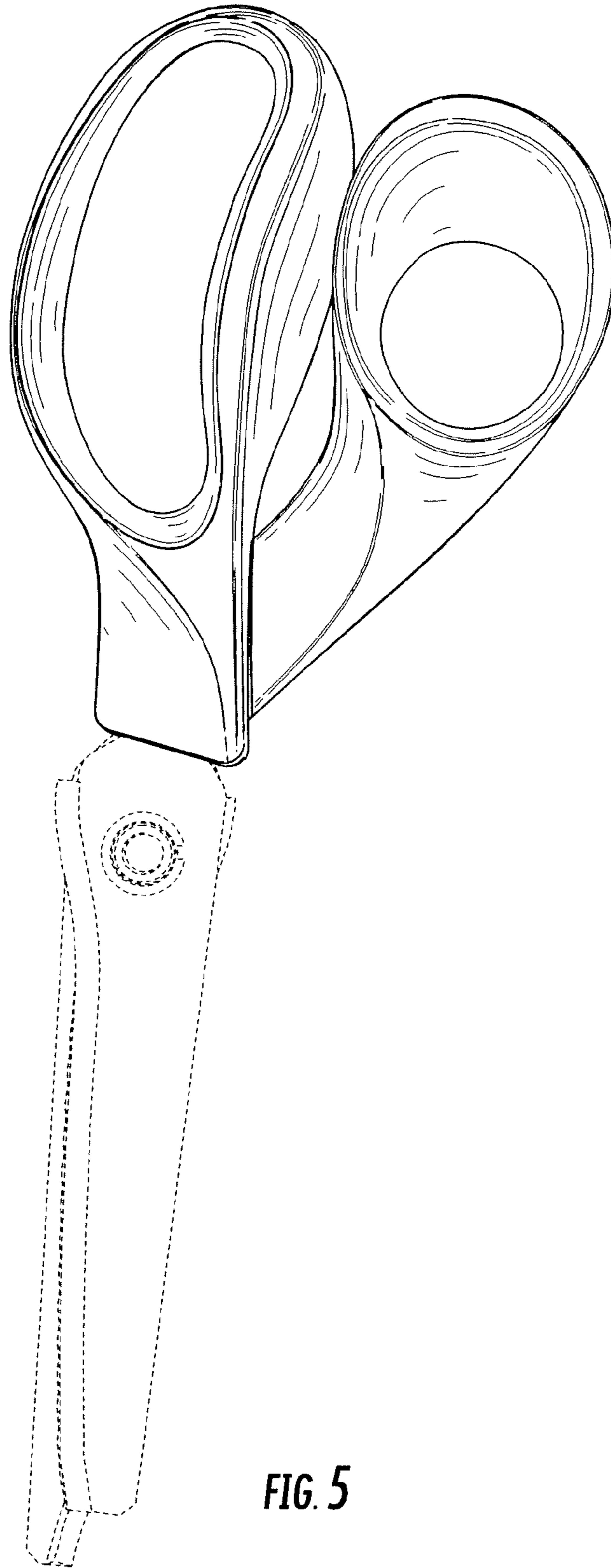
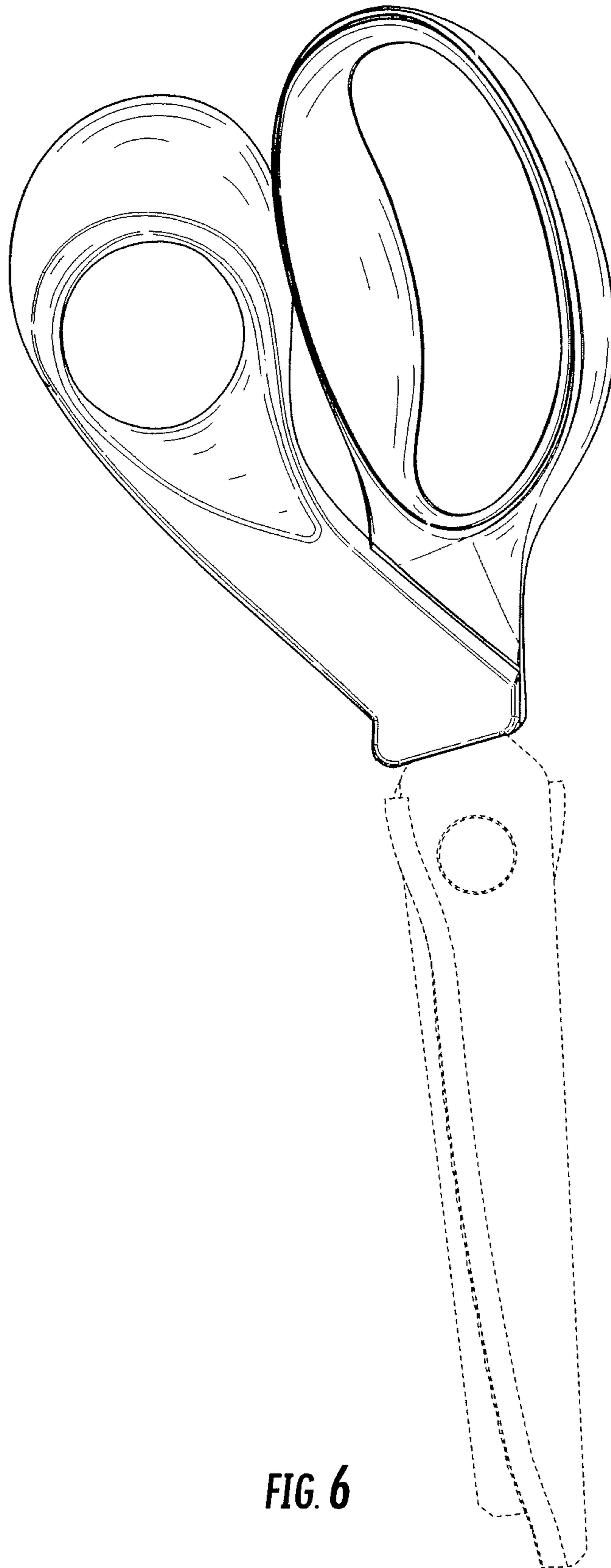
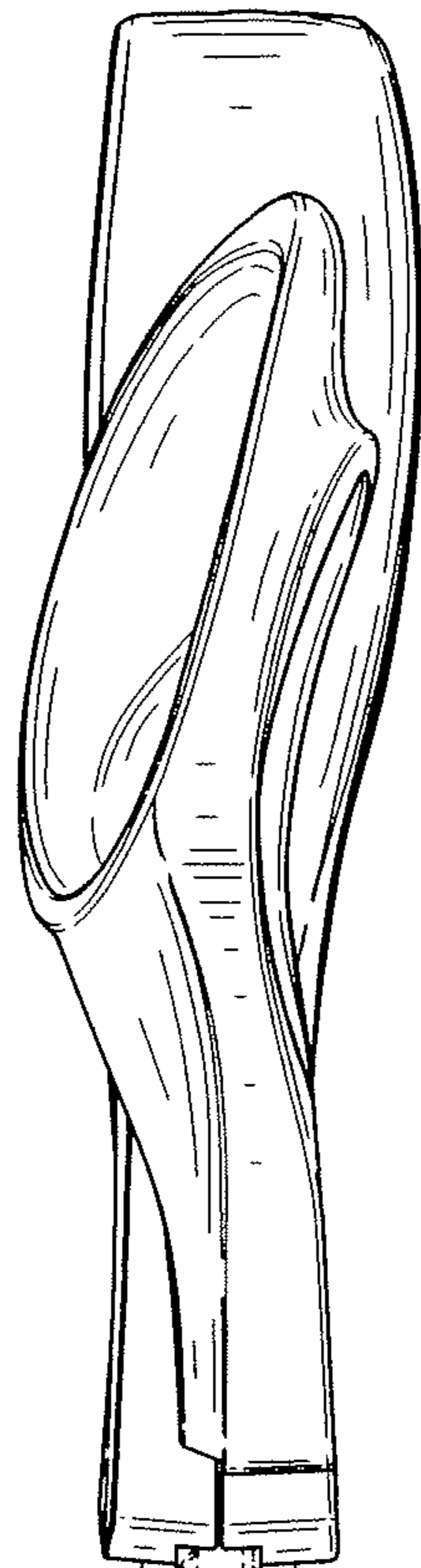


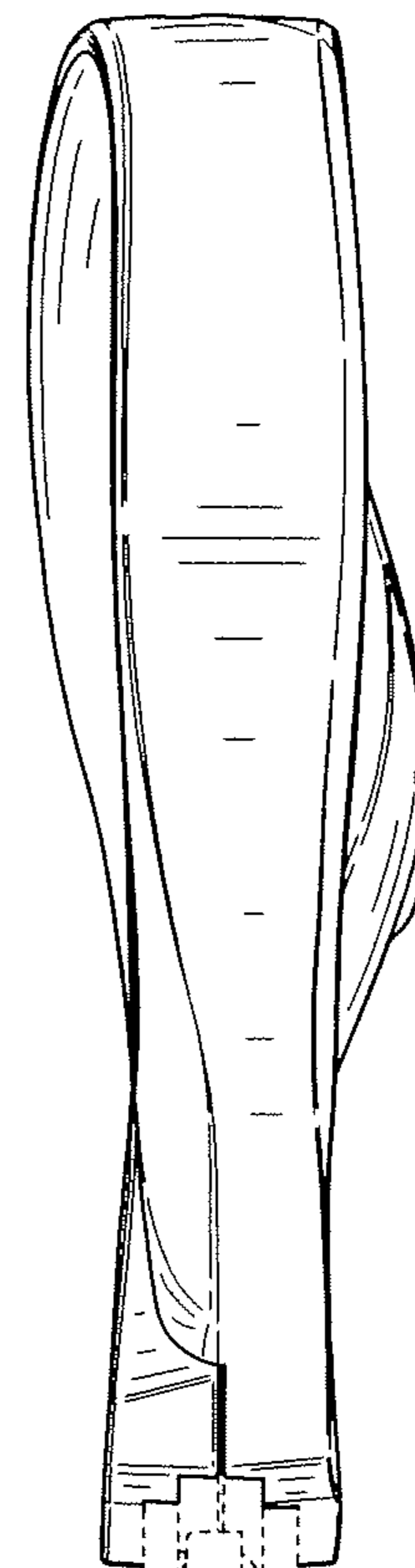

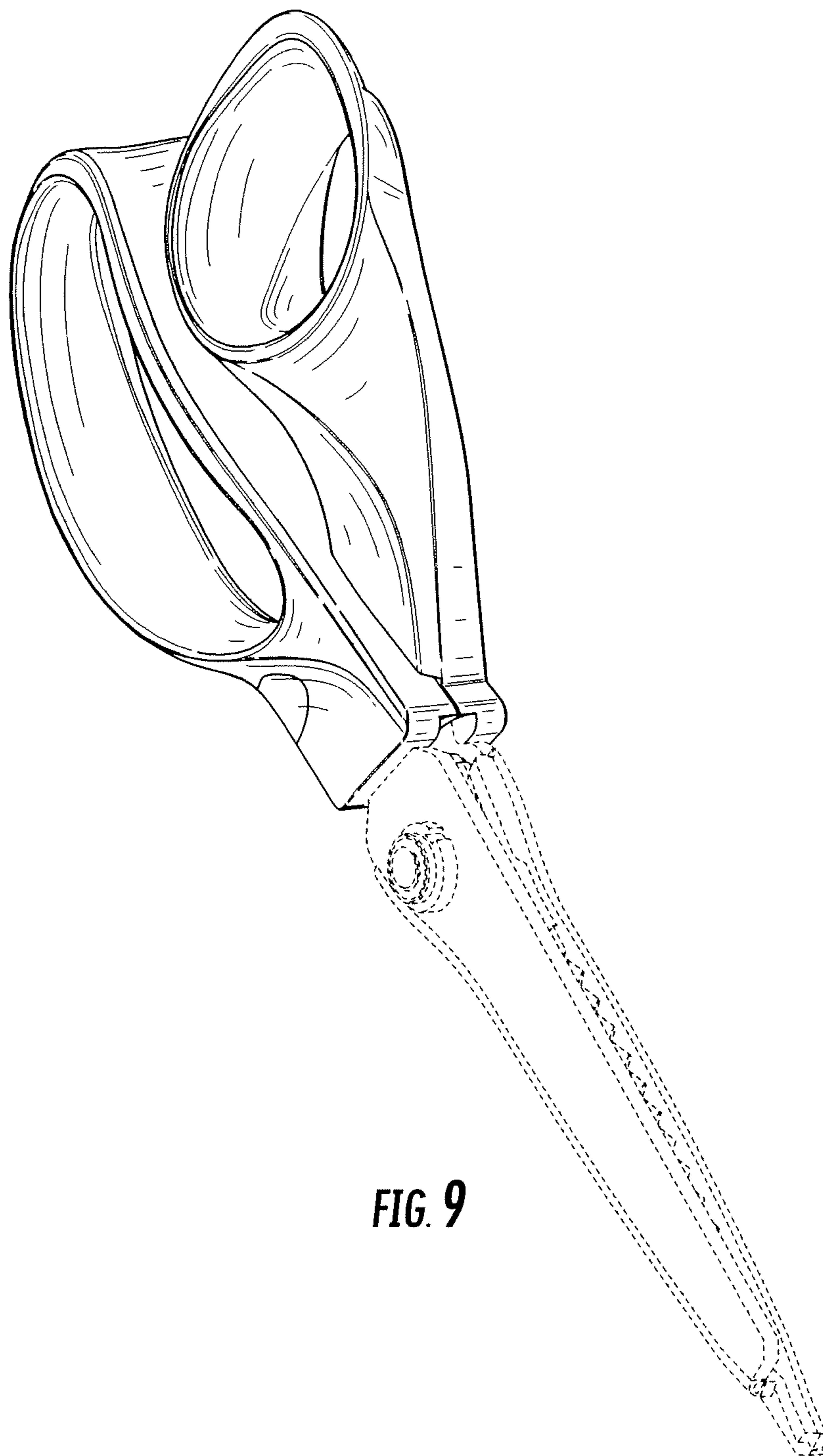


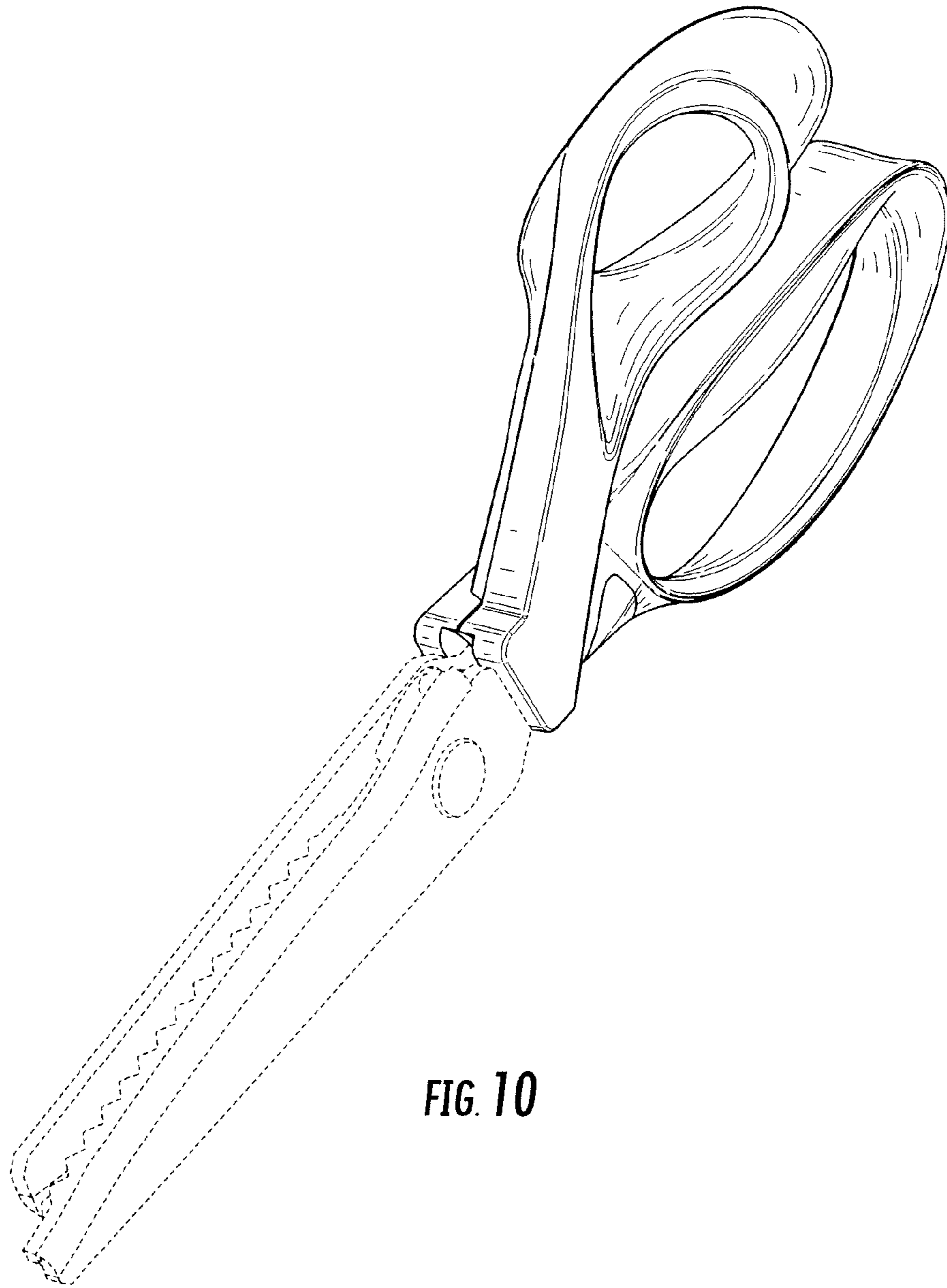

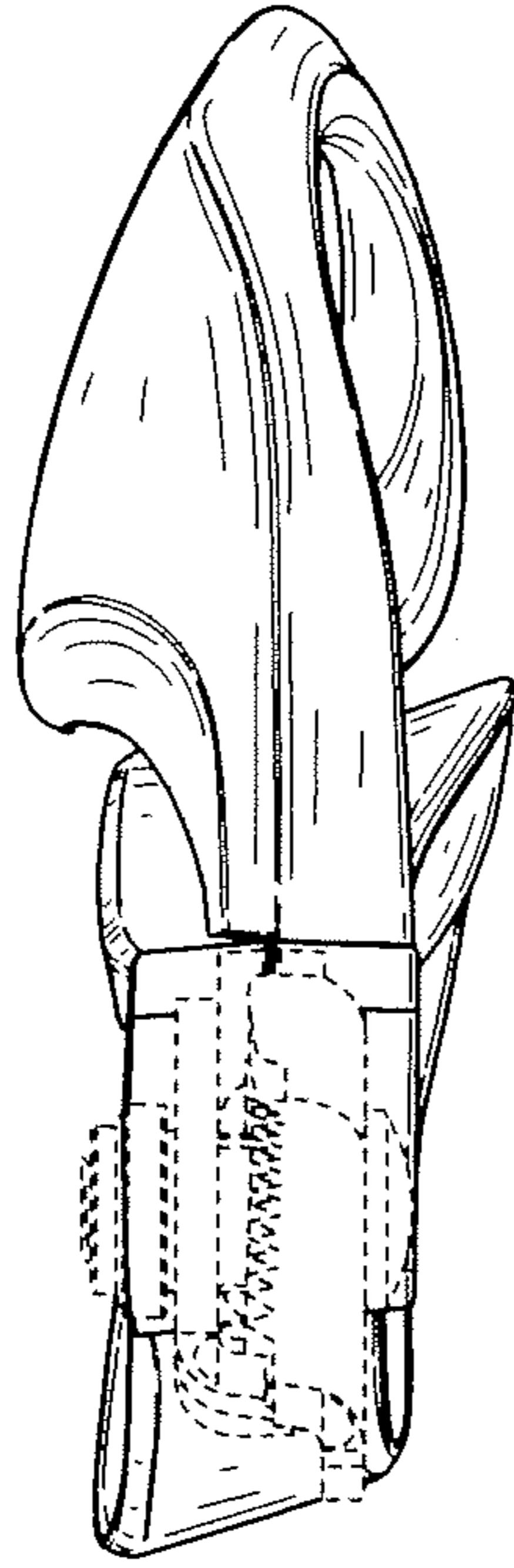

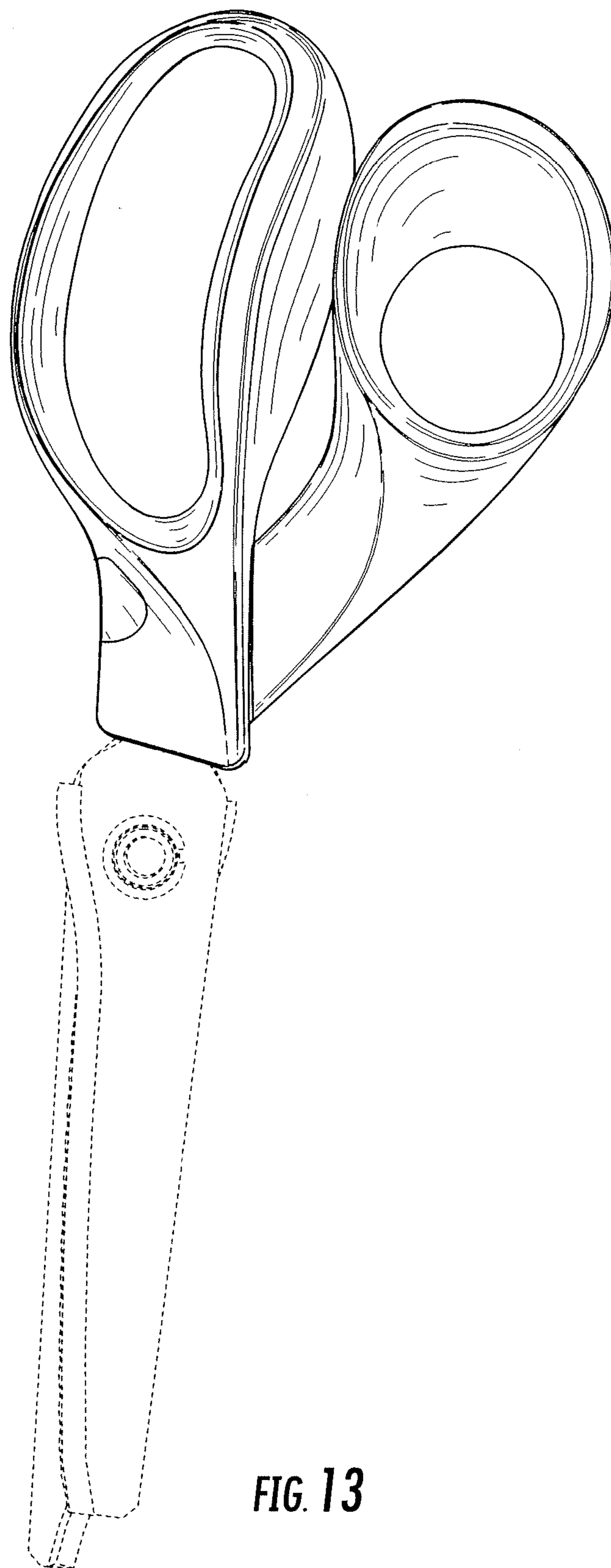

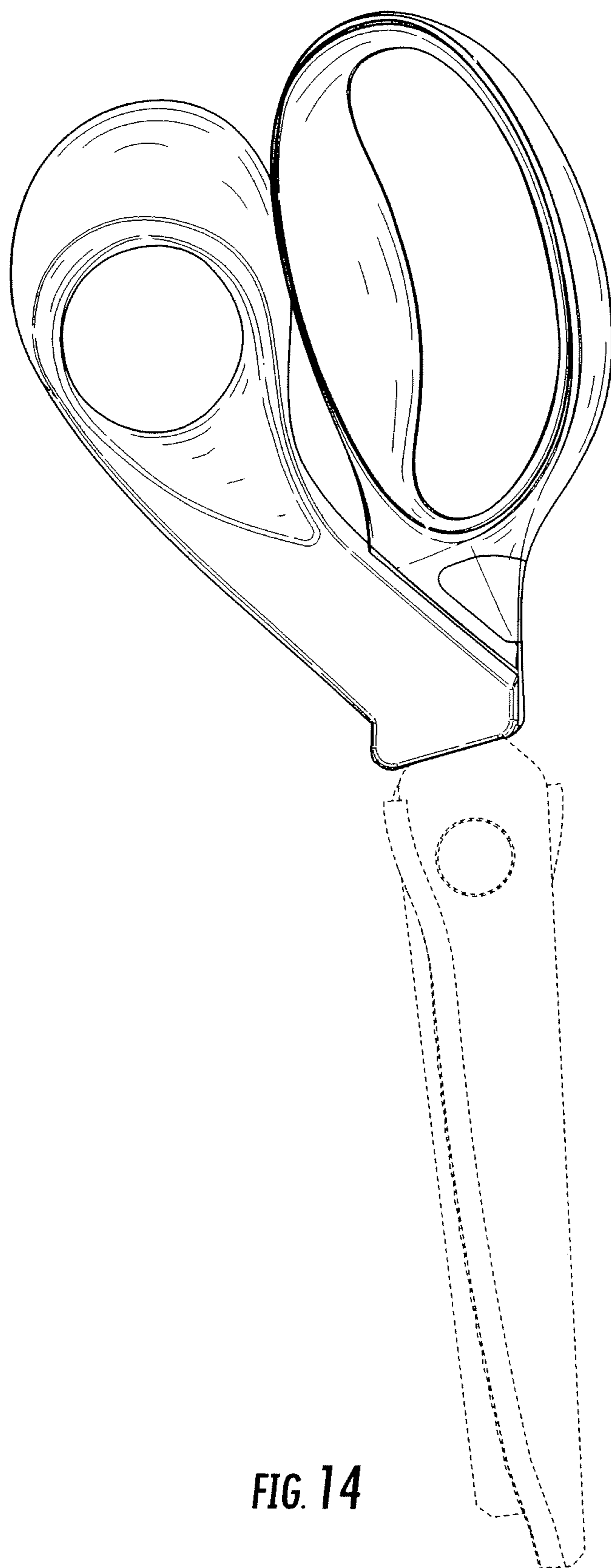
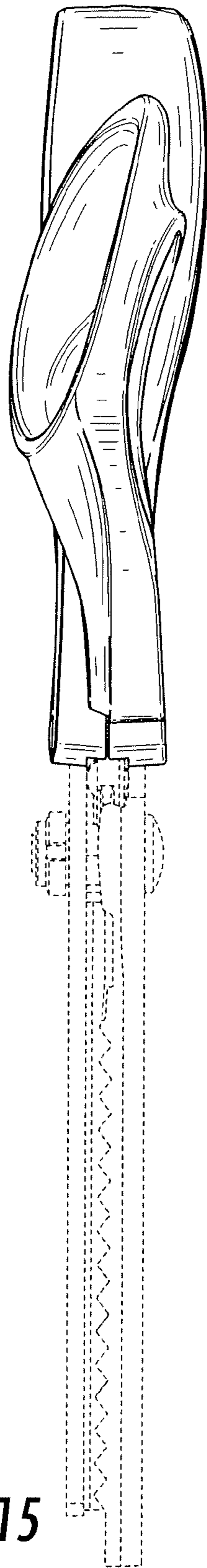
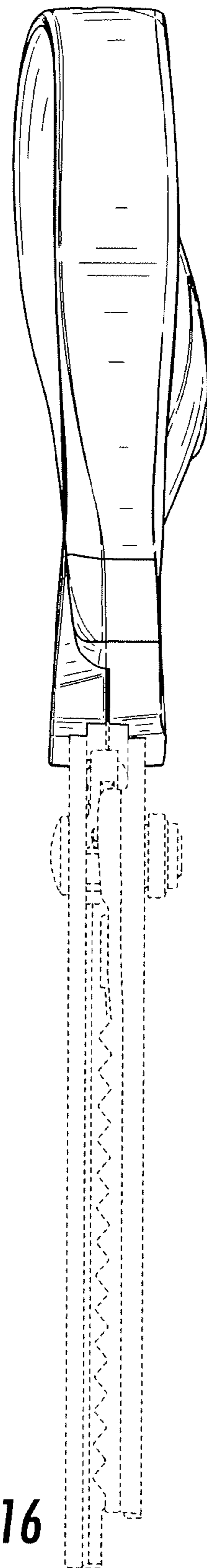


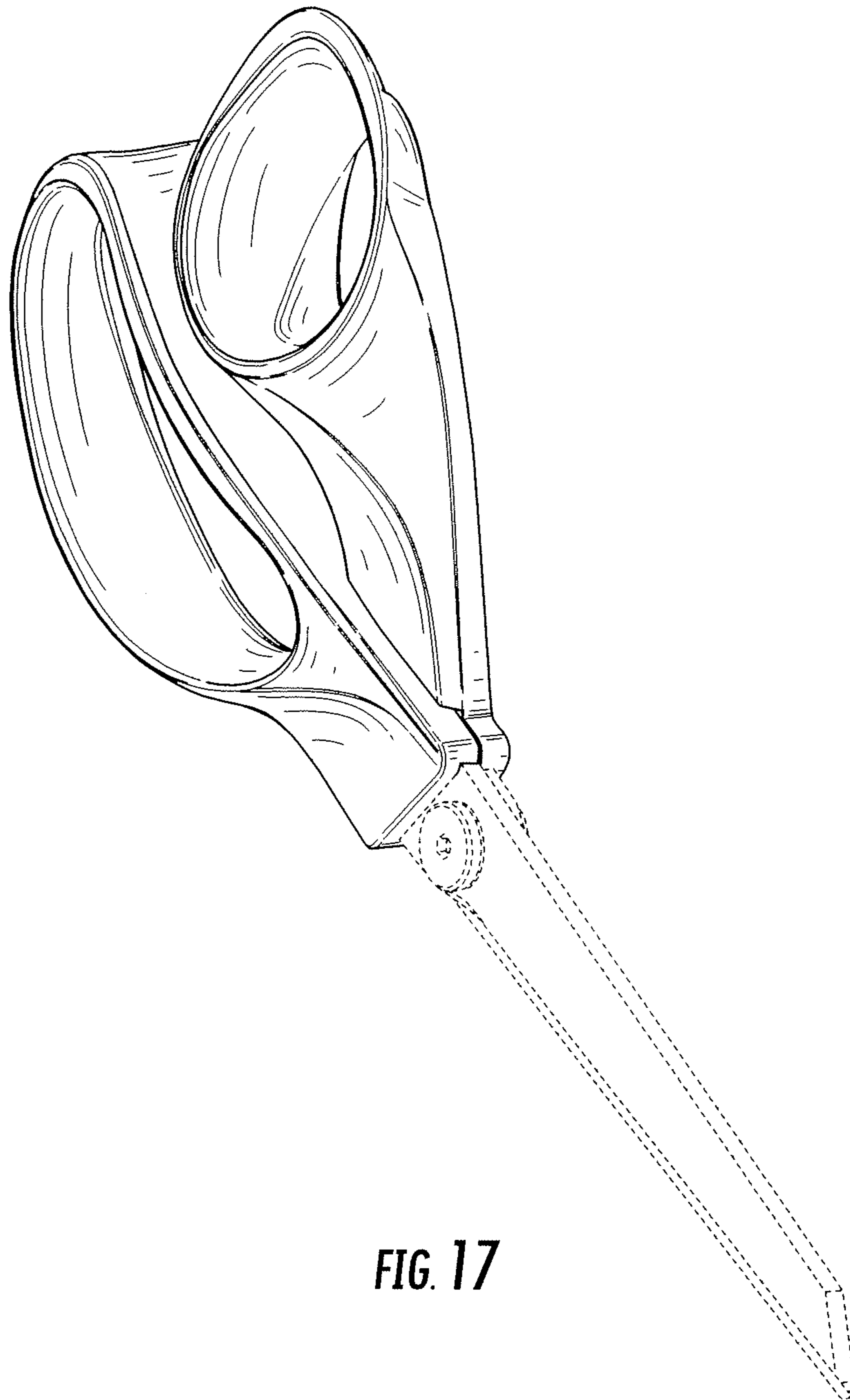

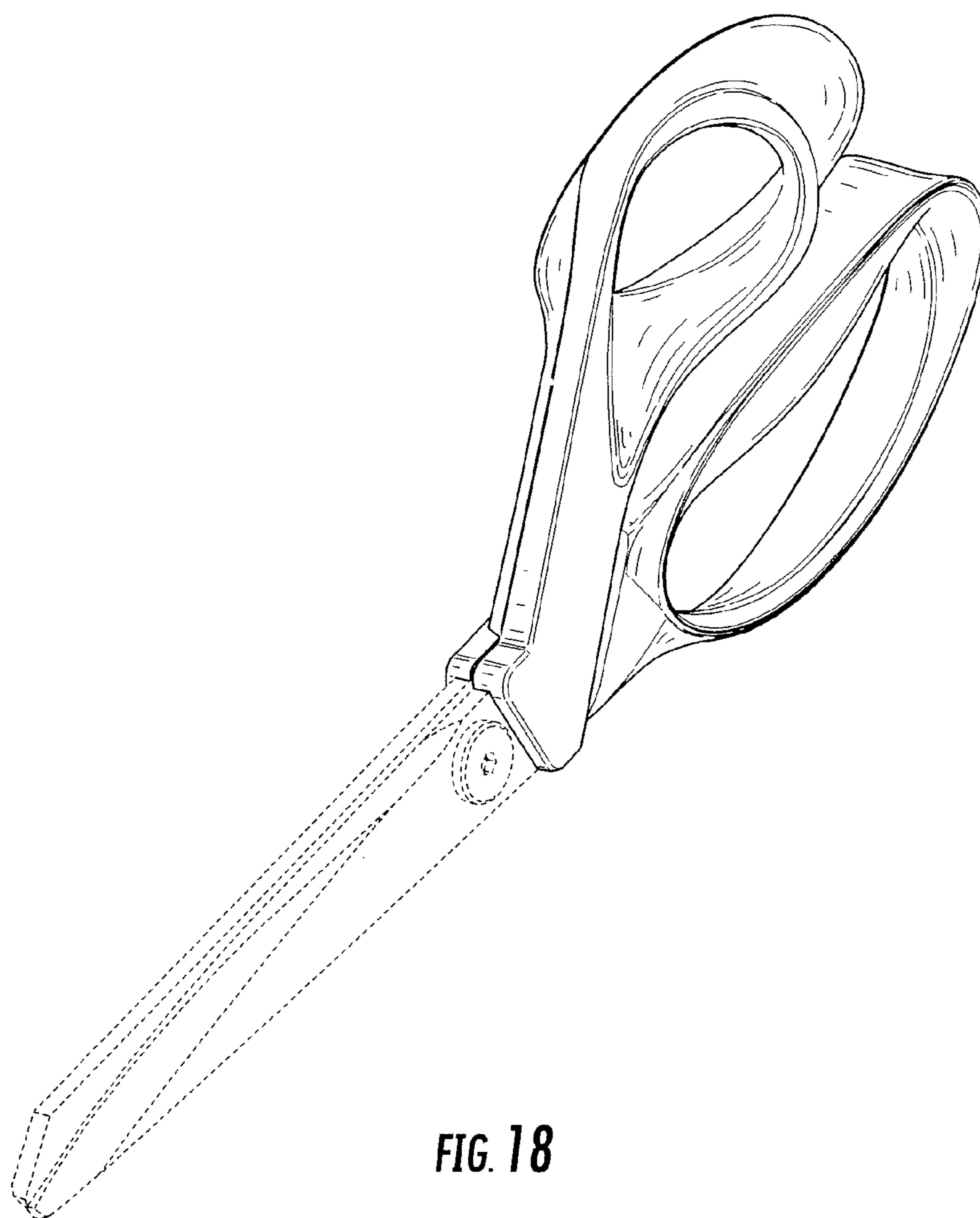

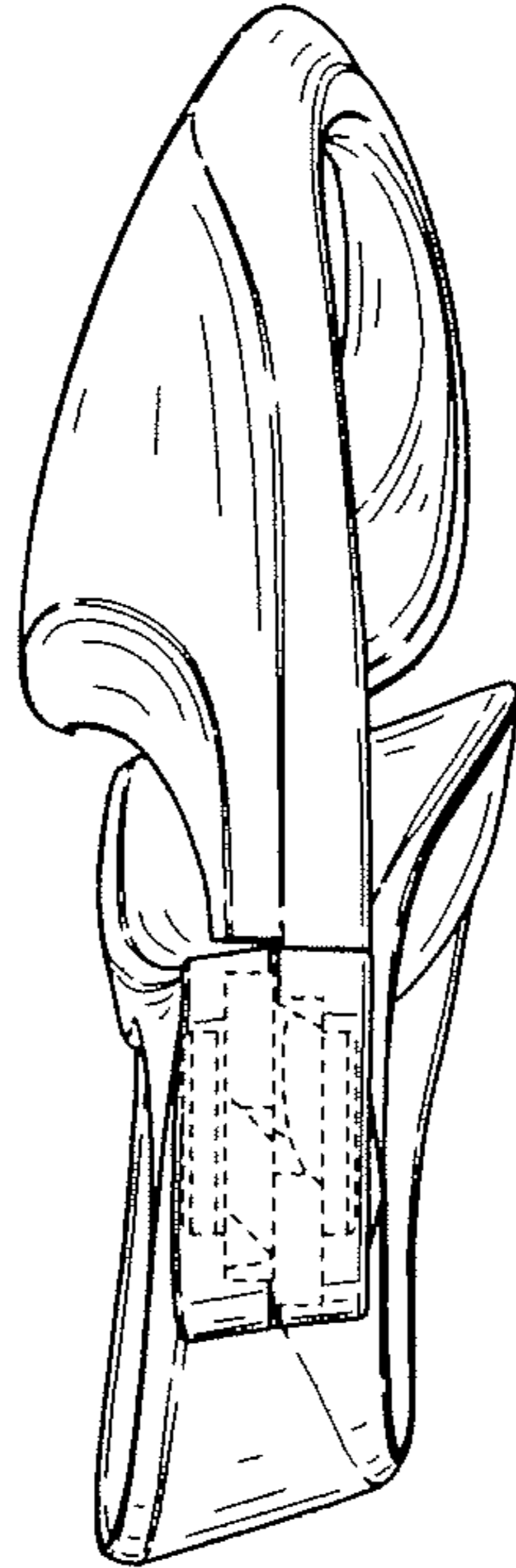

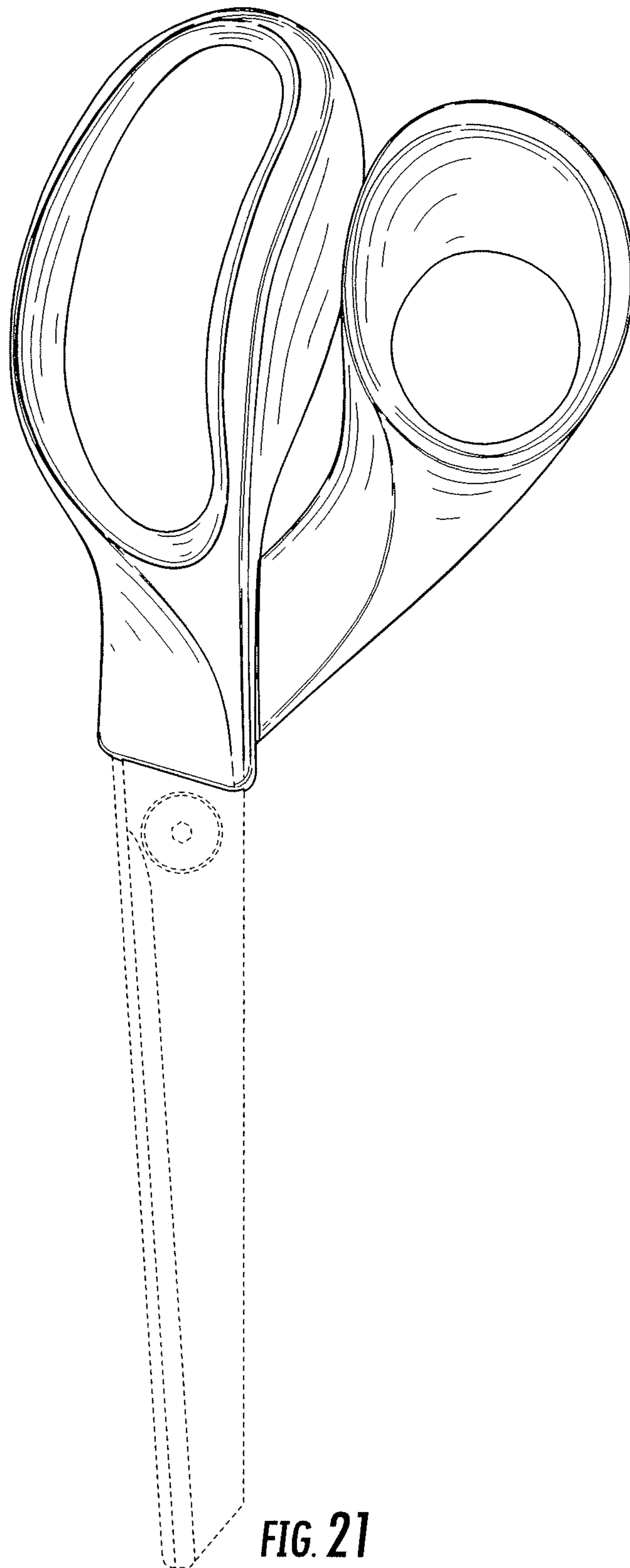

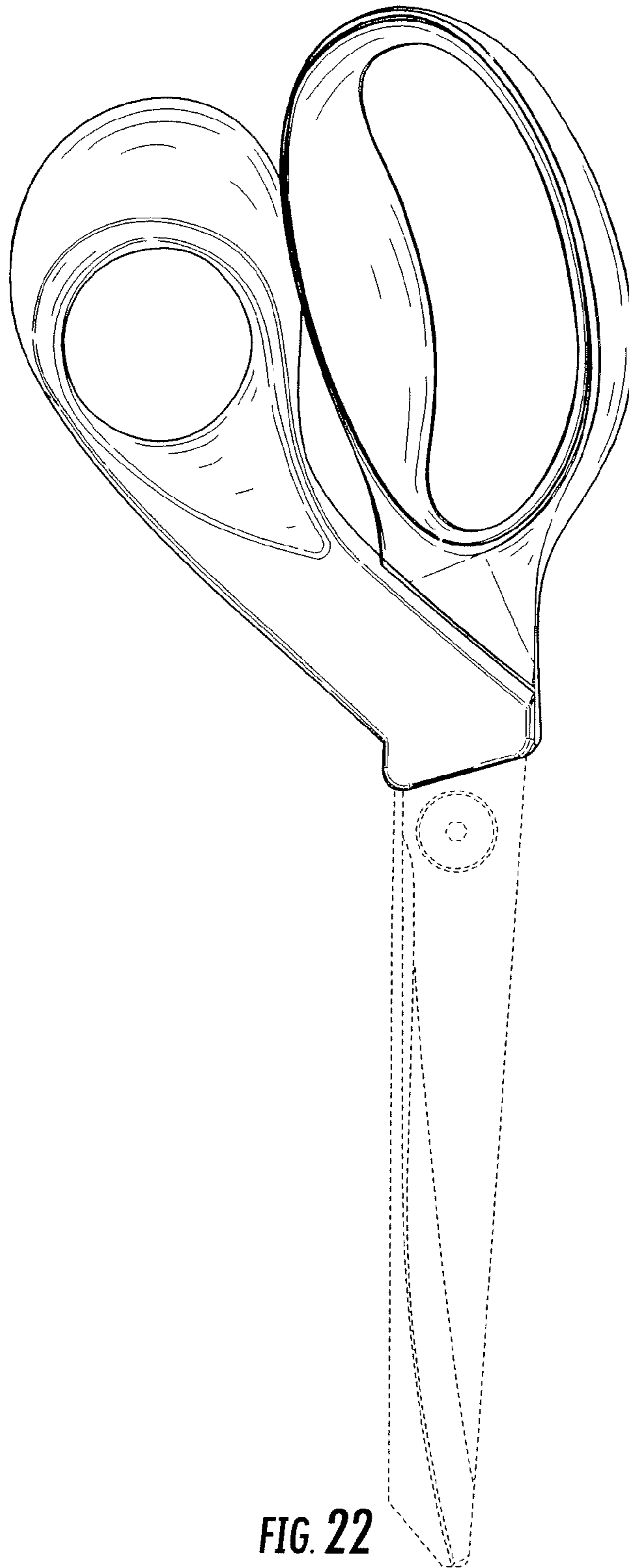

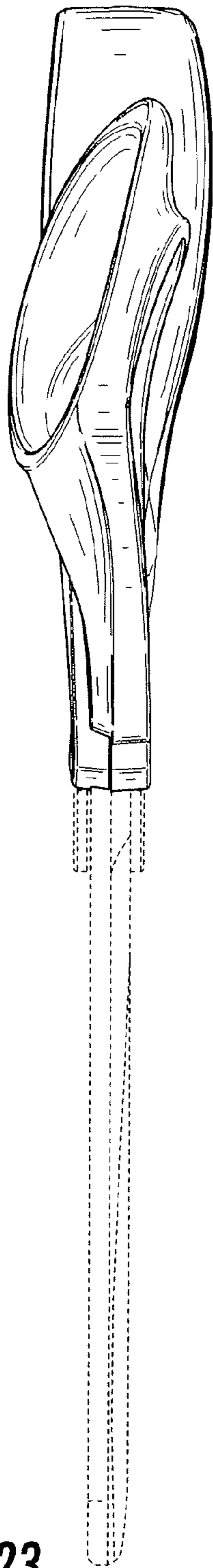

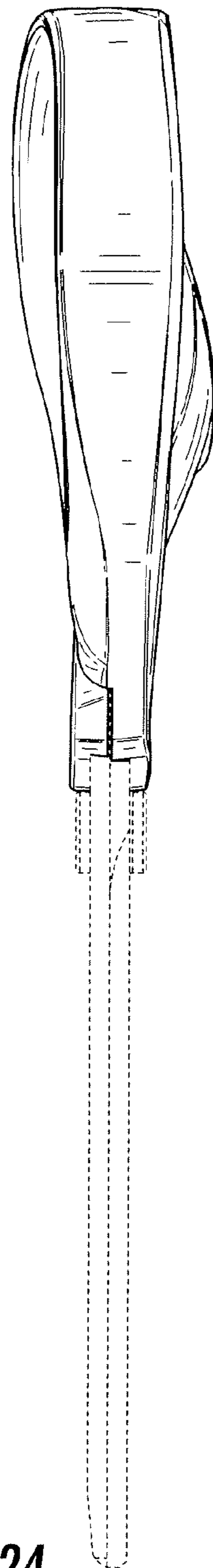

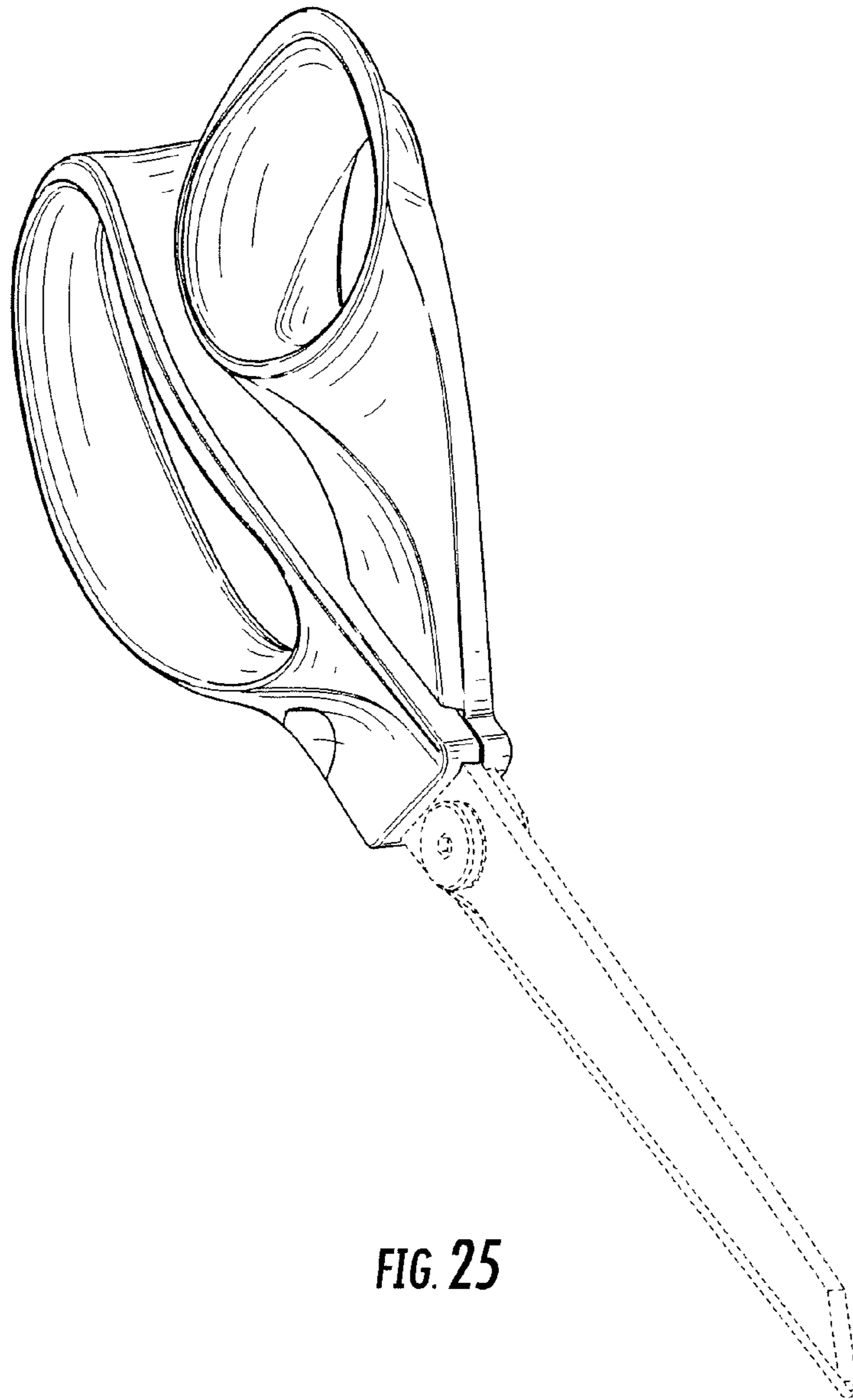

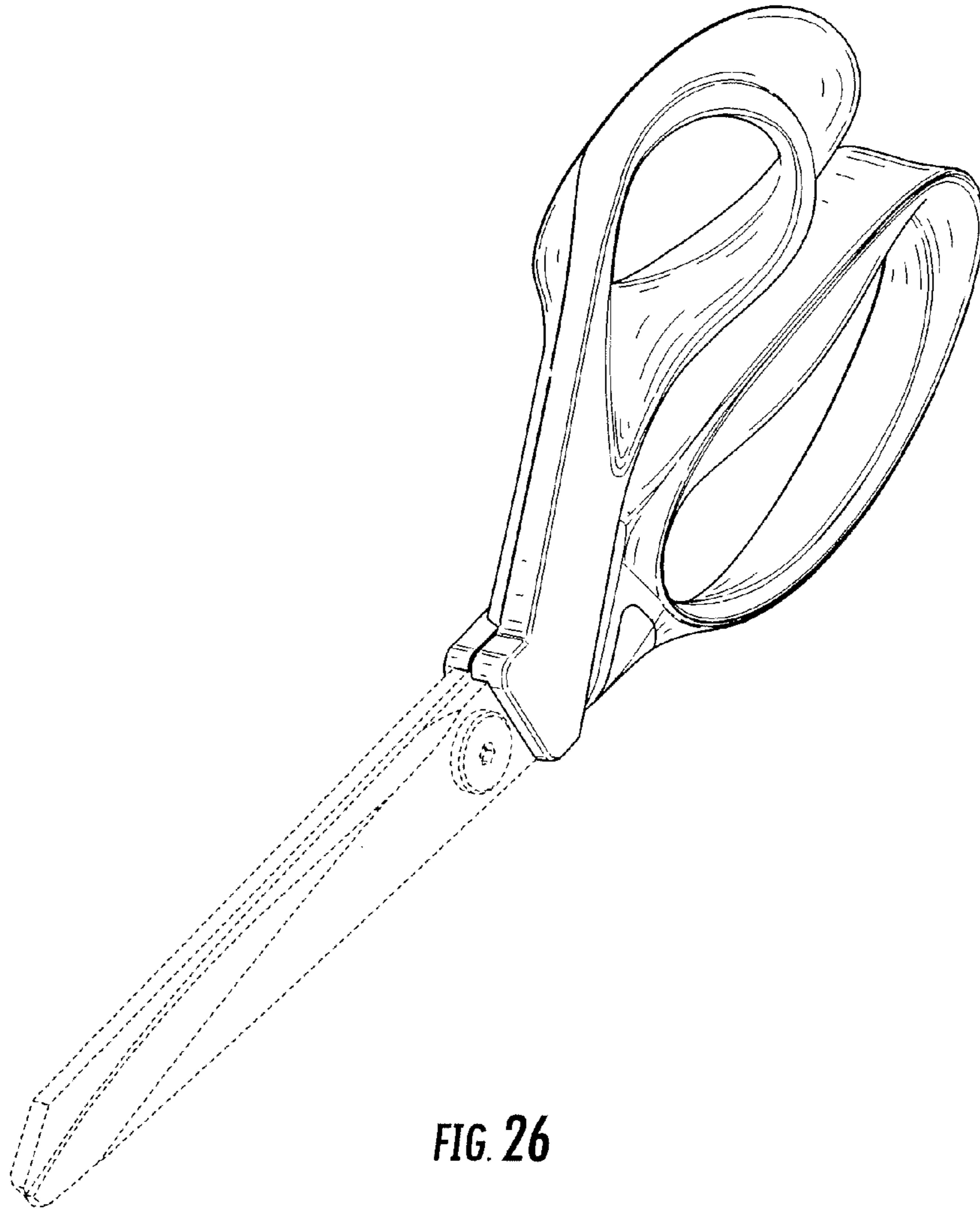
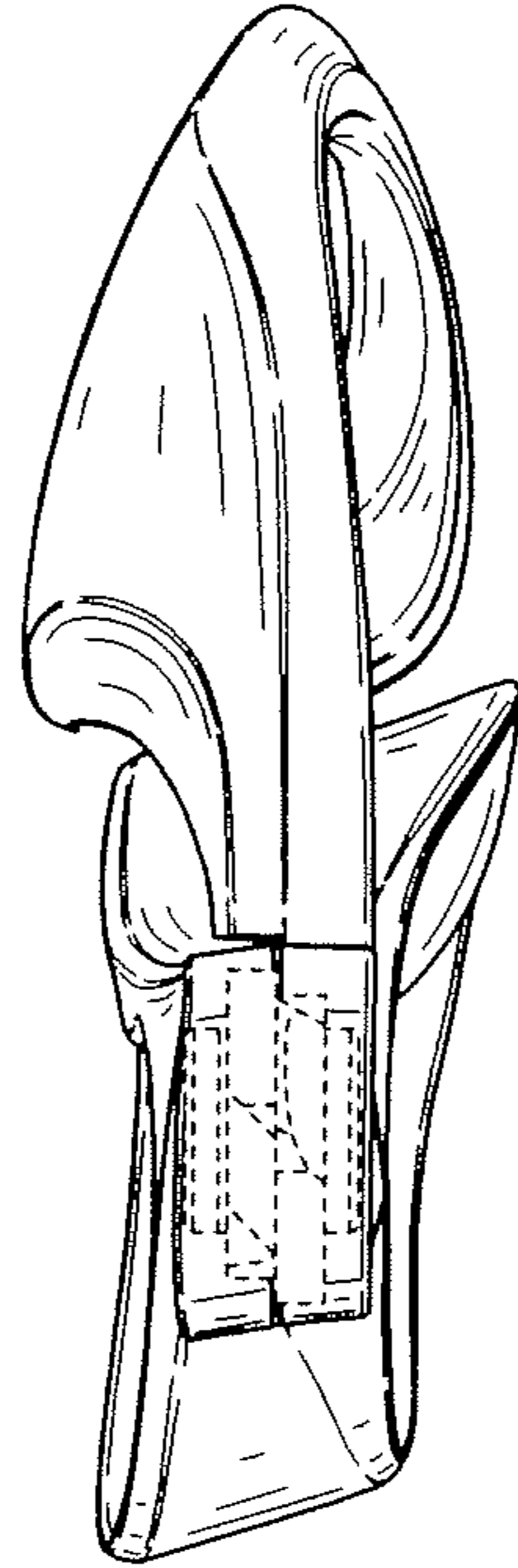

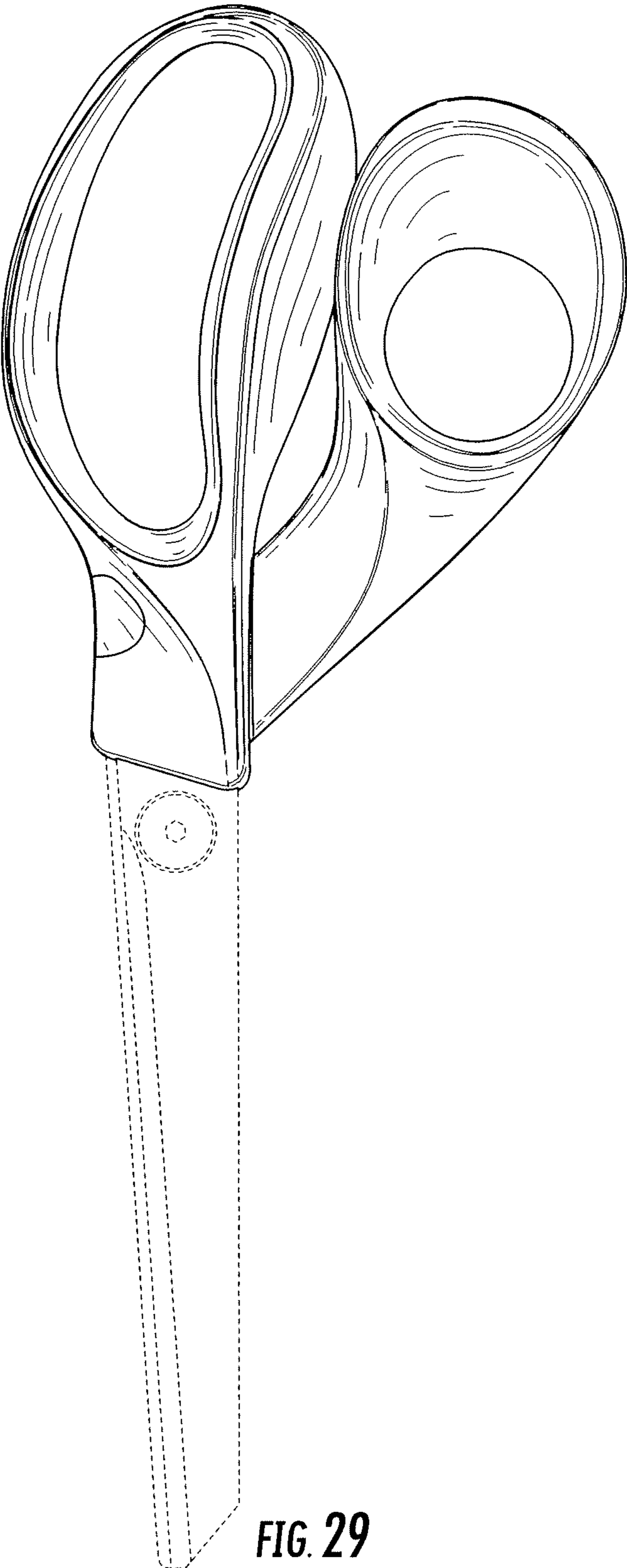
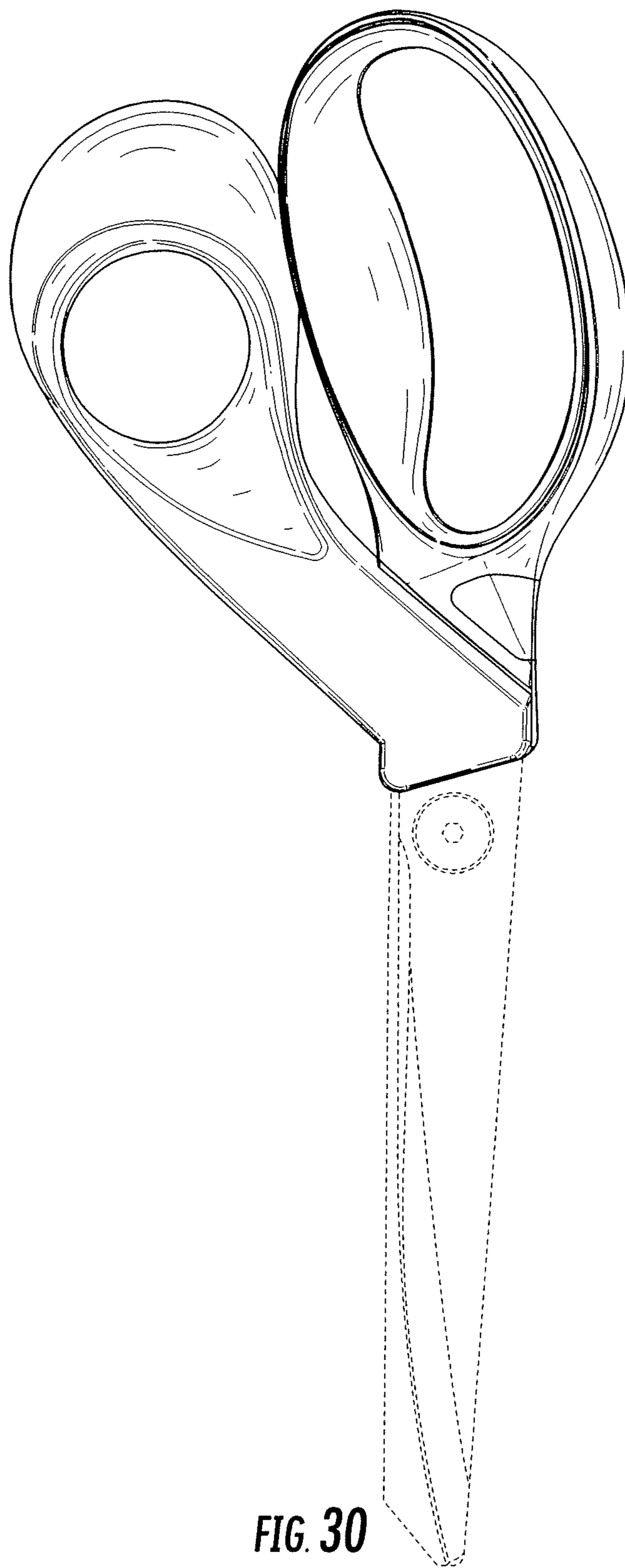
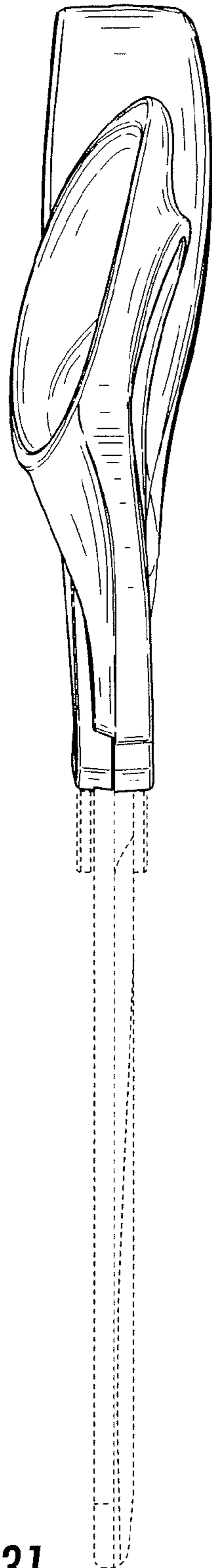

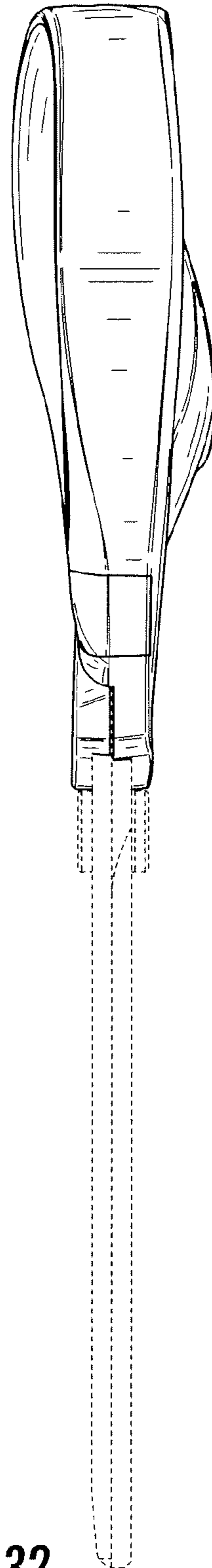
