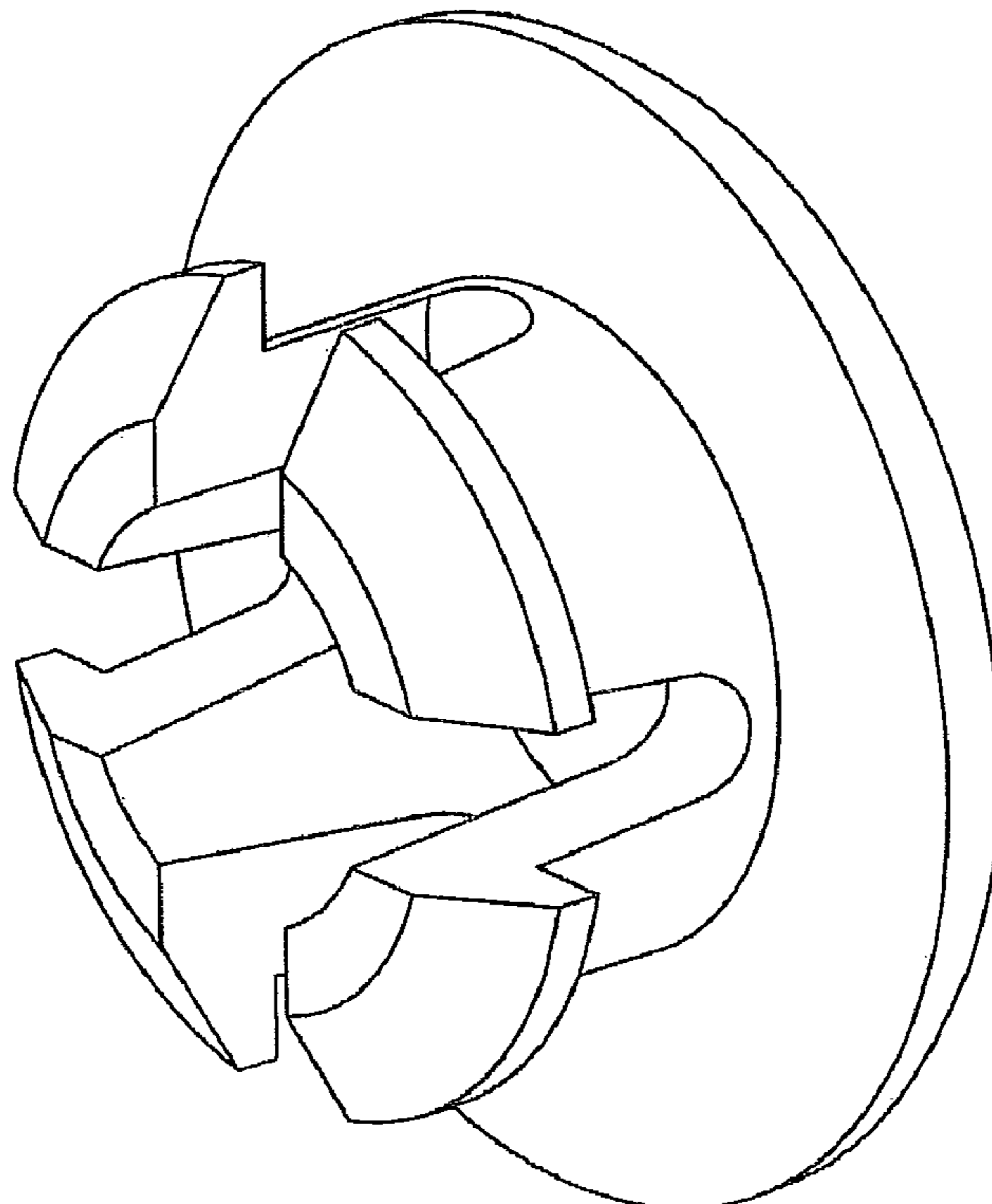
(57) **CLAIM**

The ornamental design for a grommet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a grommet in accordance with my invention;
FIG. 2 is a side view of FIG. 1, the opposite side view being a mirror image thereof;
FIG. 3 is a second side view of FIG. 1, the opposite side view being a mirror image thereof;
FIG. 4 is a cross-sectional view of FIG. 3 taken along line 3-3;
FIG. 5 is a bottom plan view of FIG. 1; and,
FIG. 6 is a top plan view of FIG. 1.

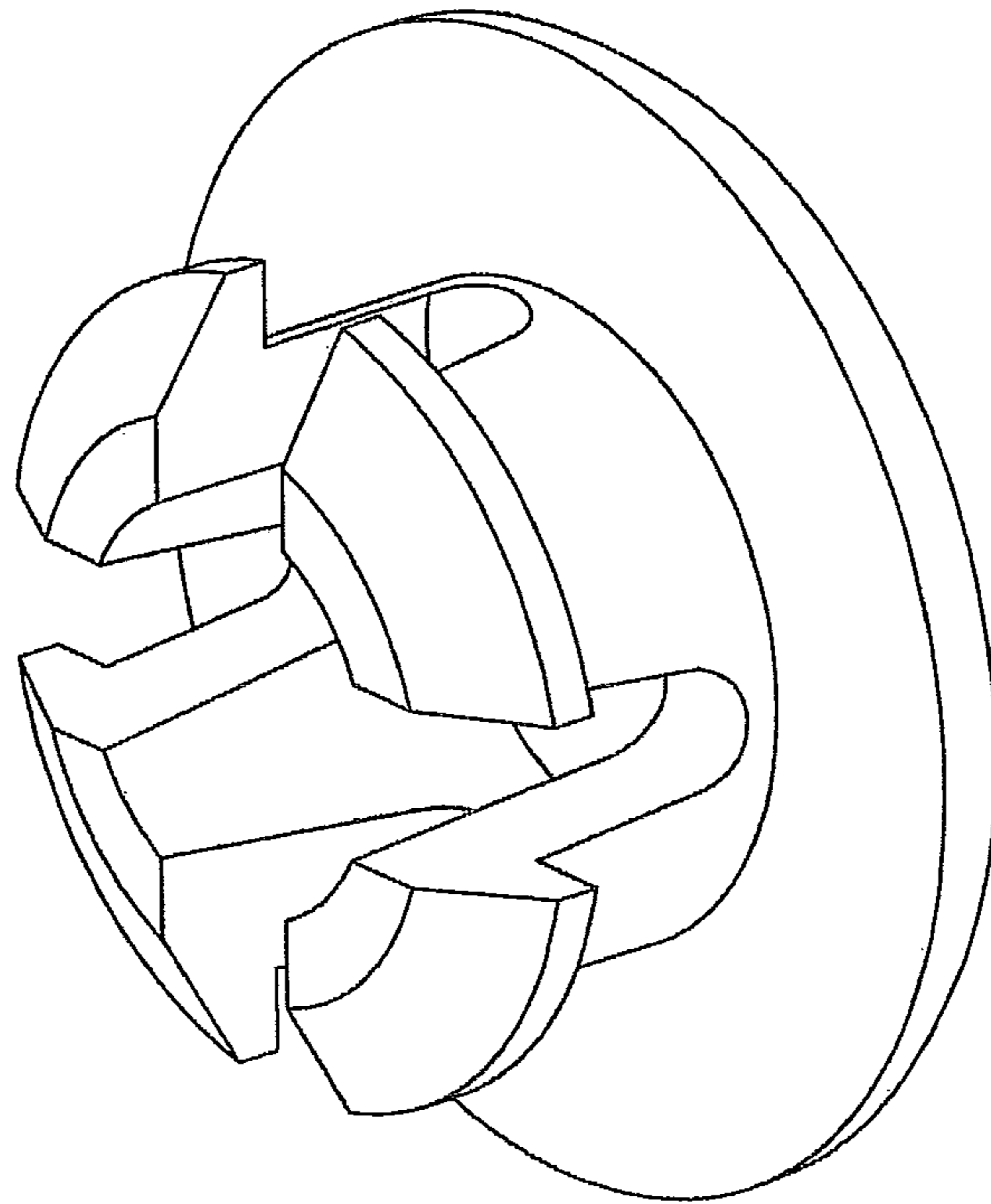

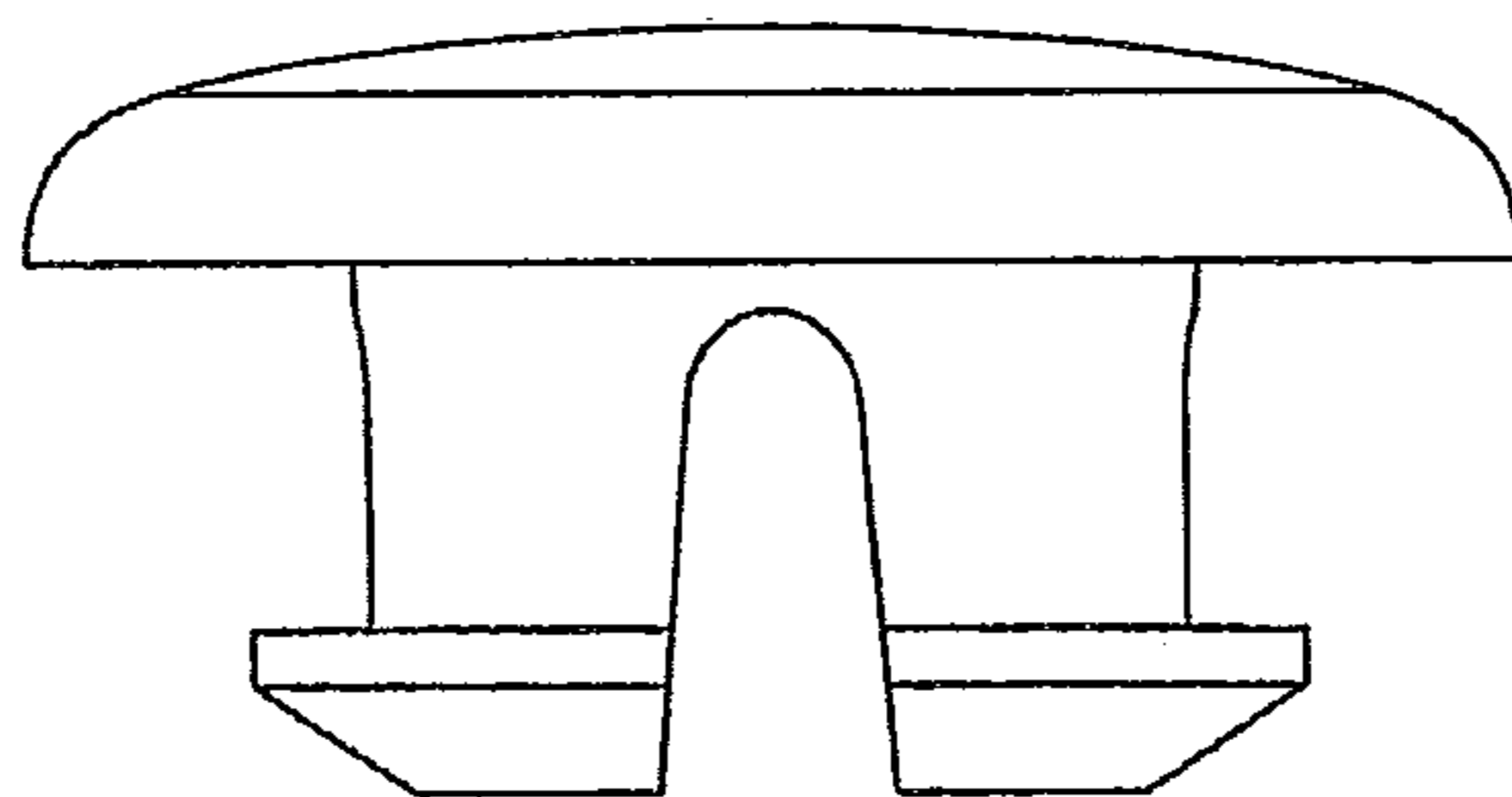

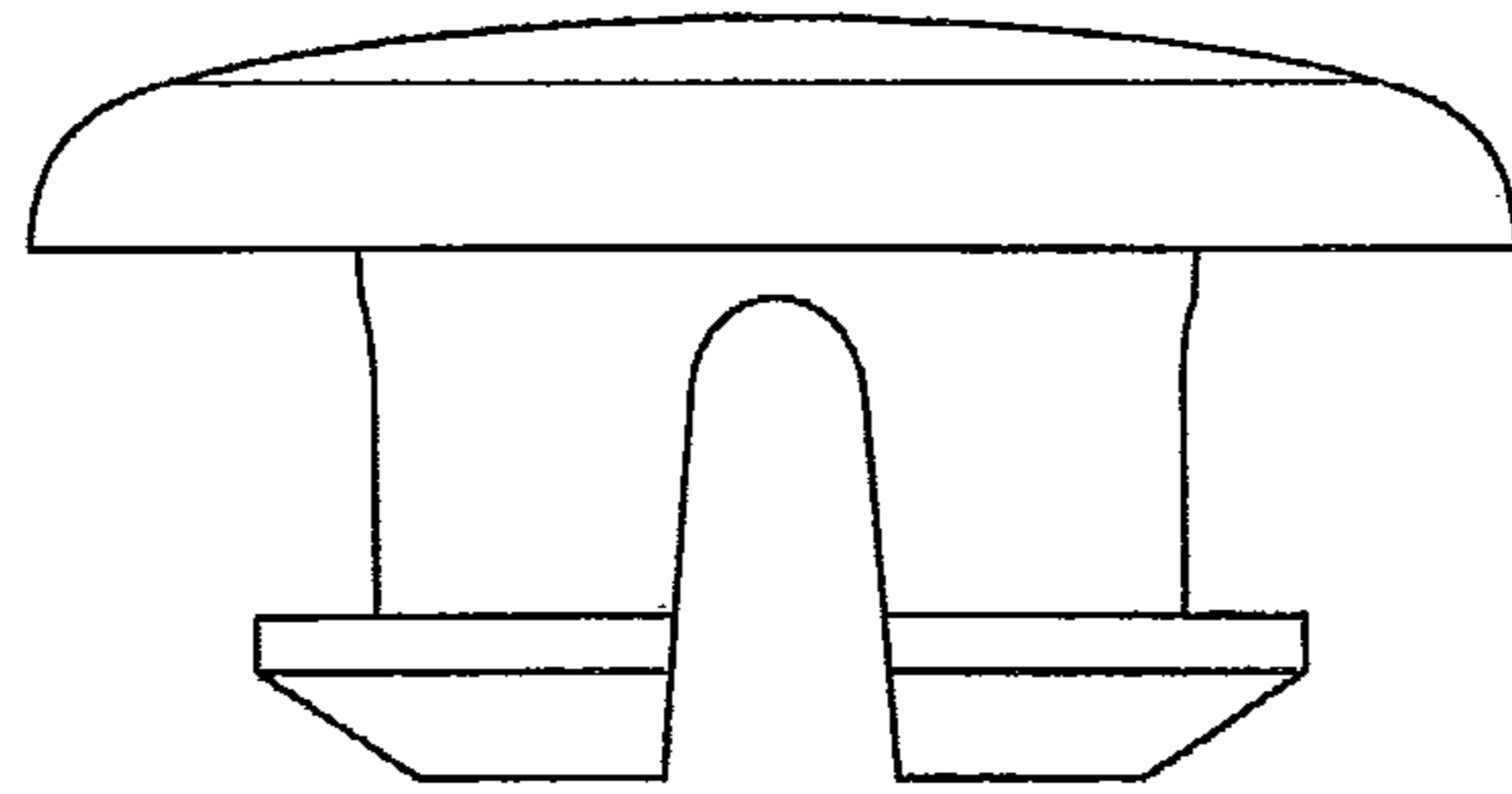

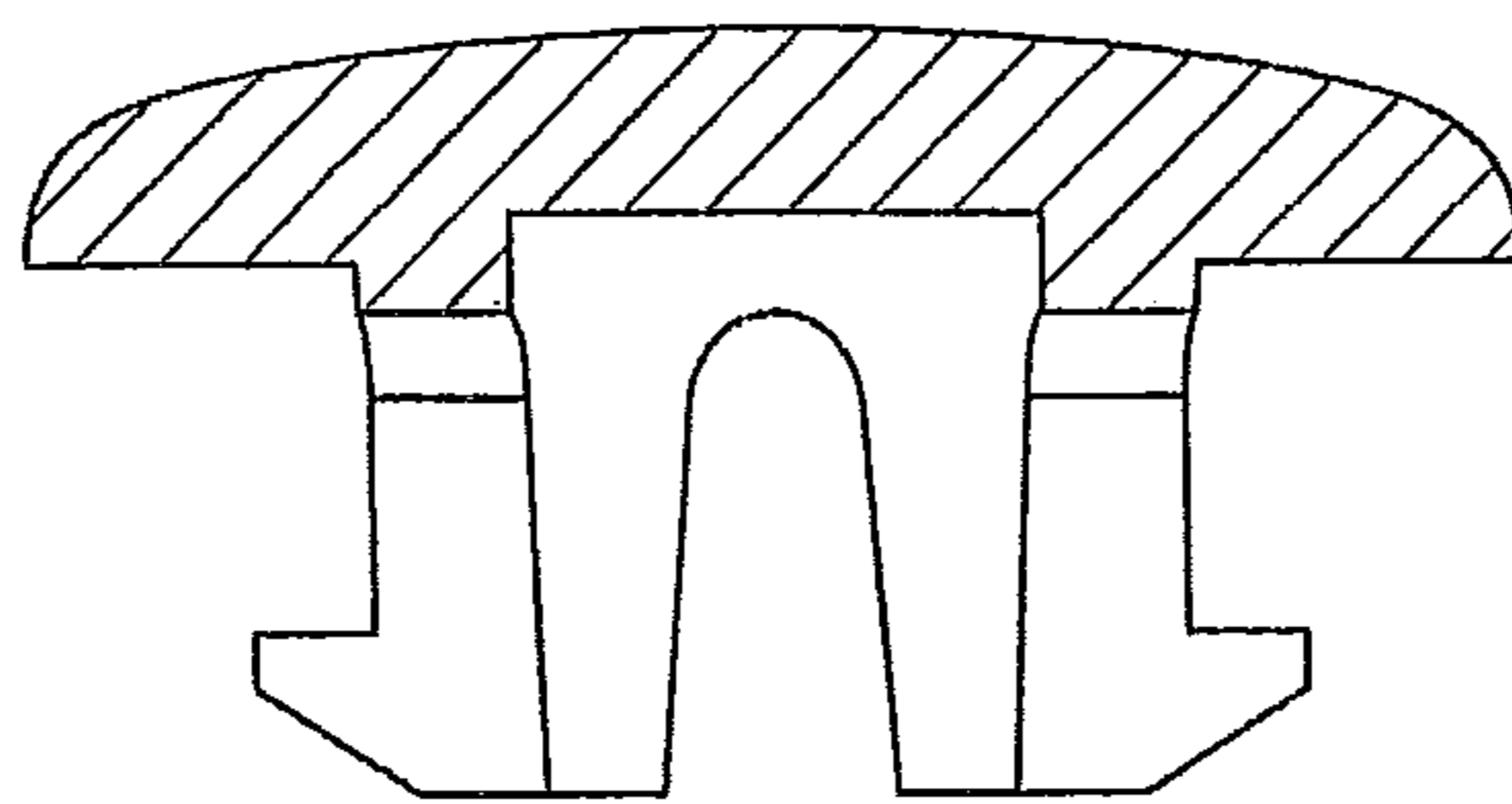

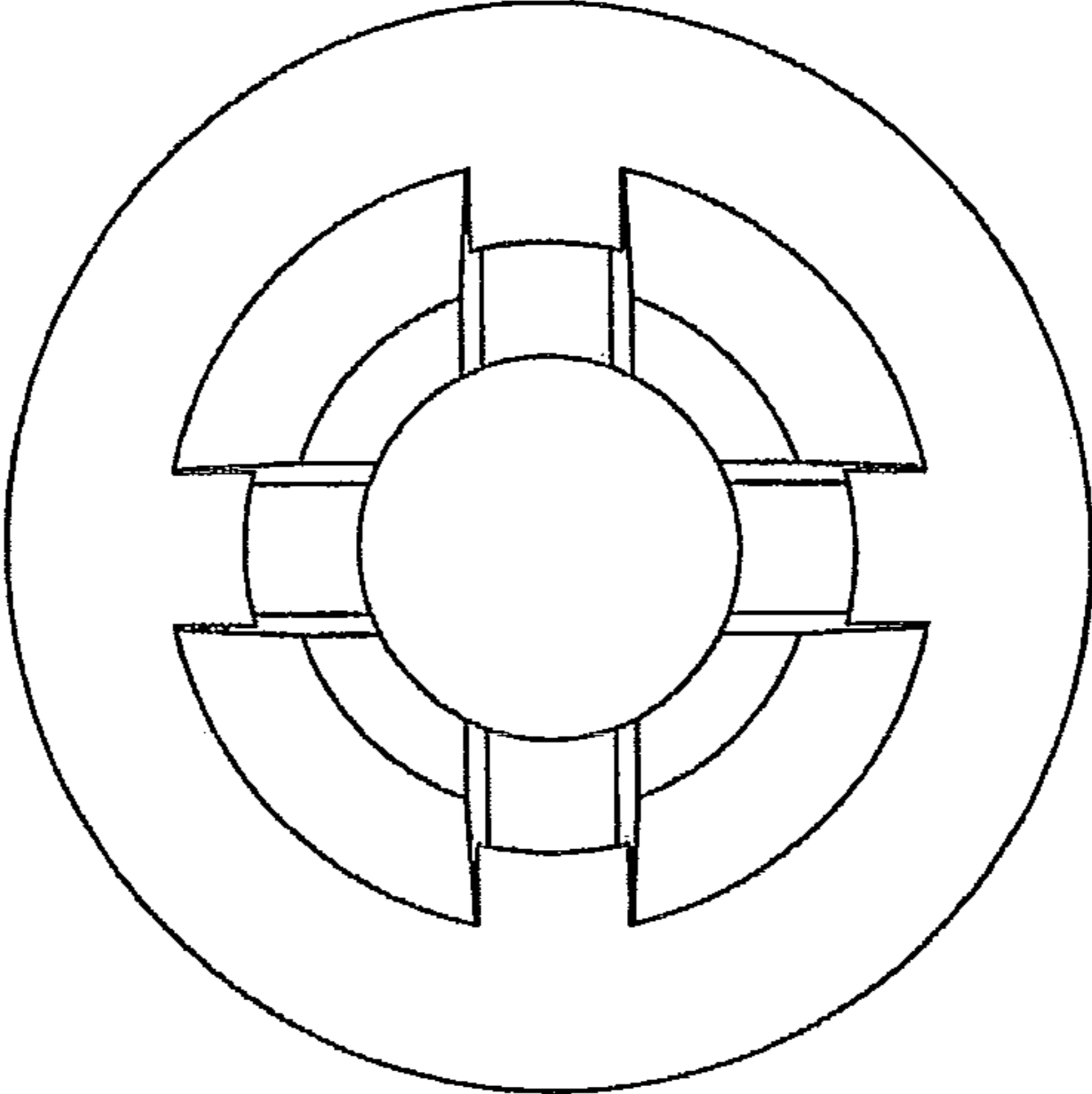

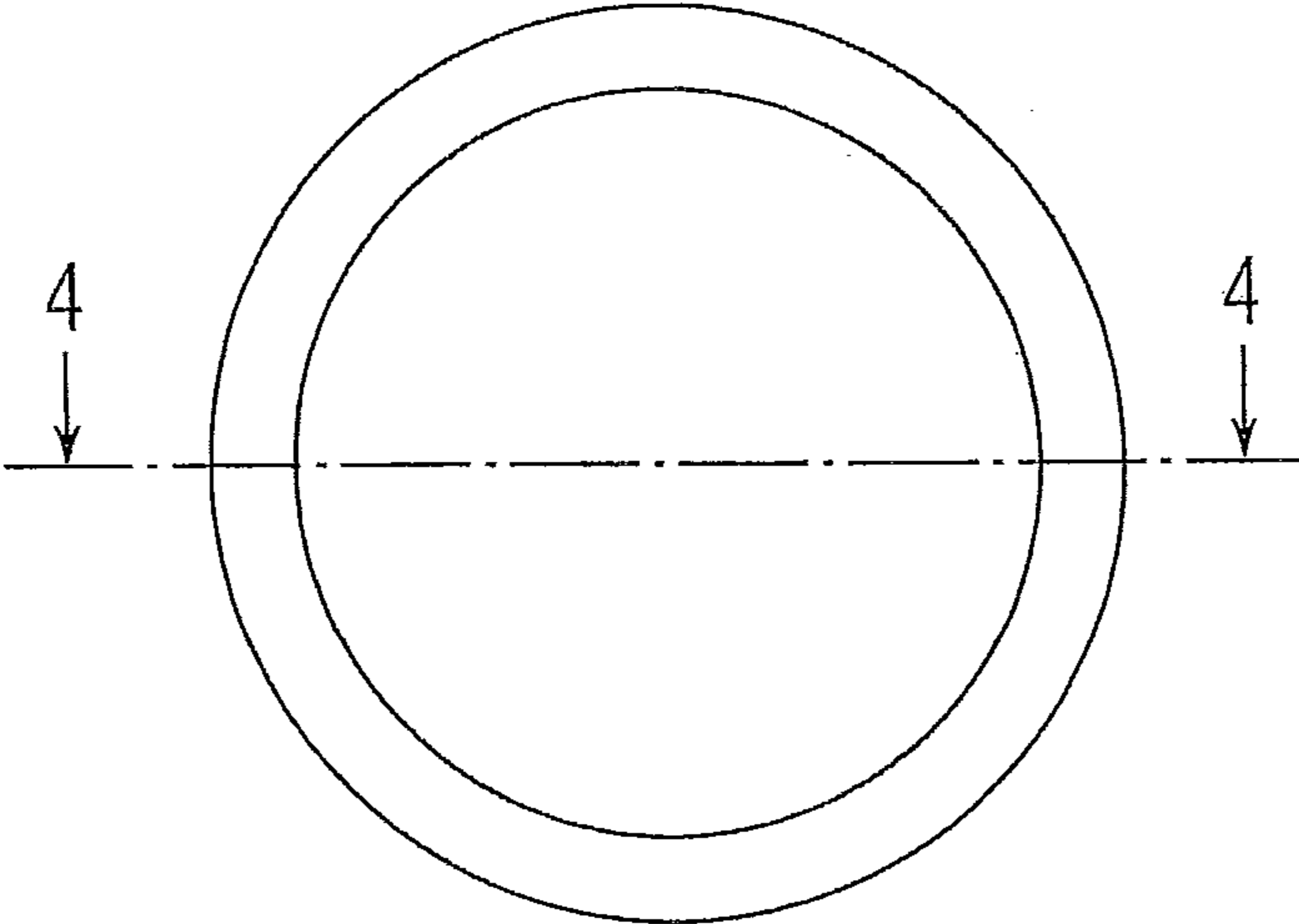
