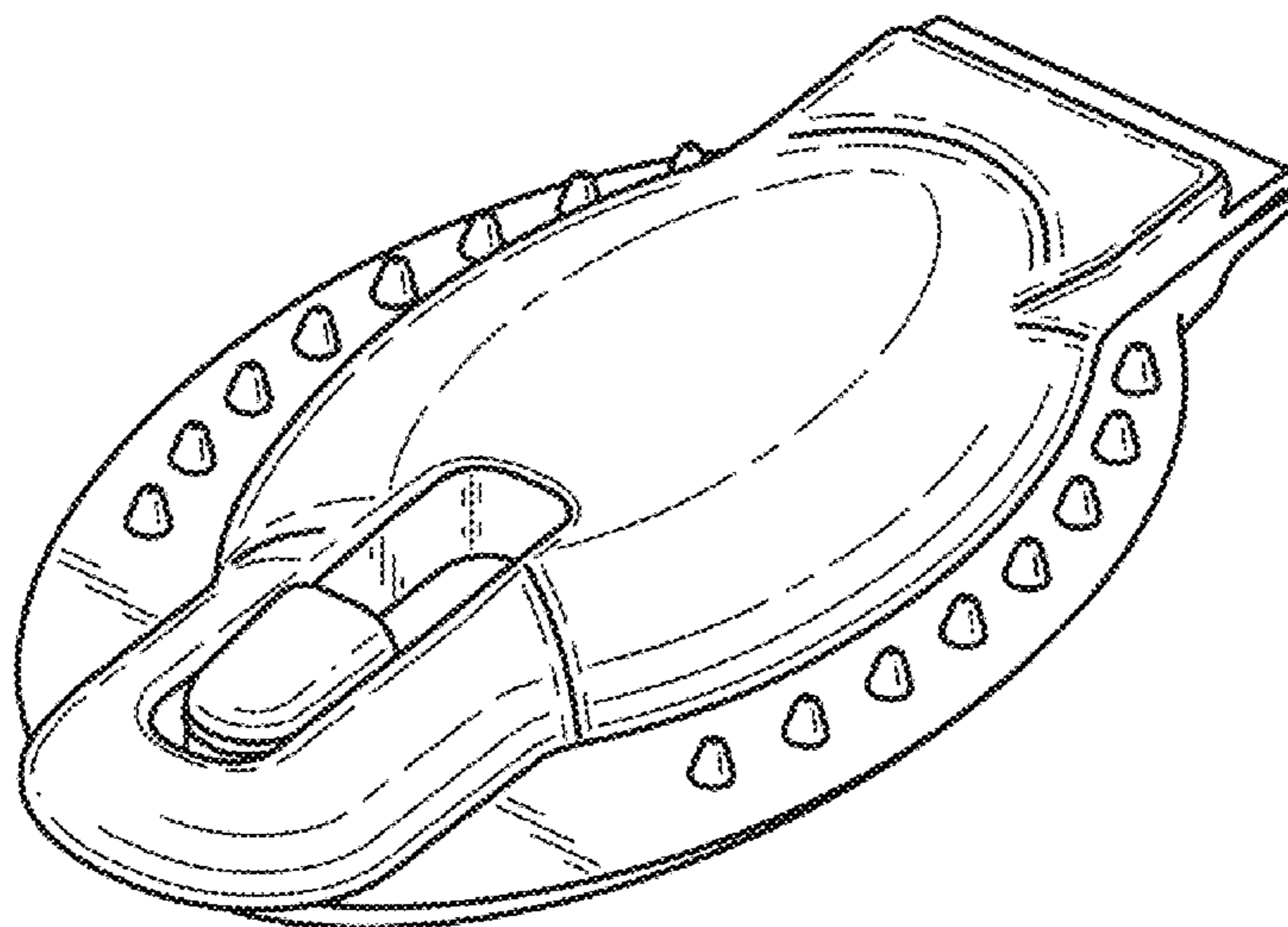

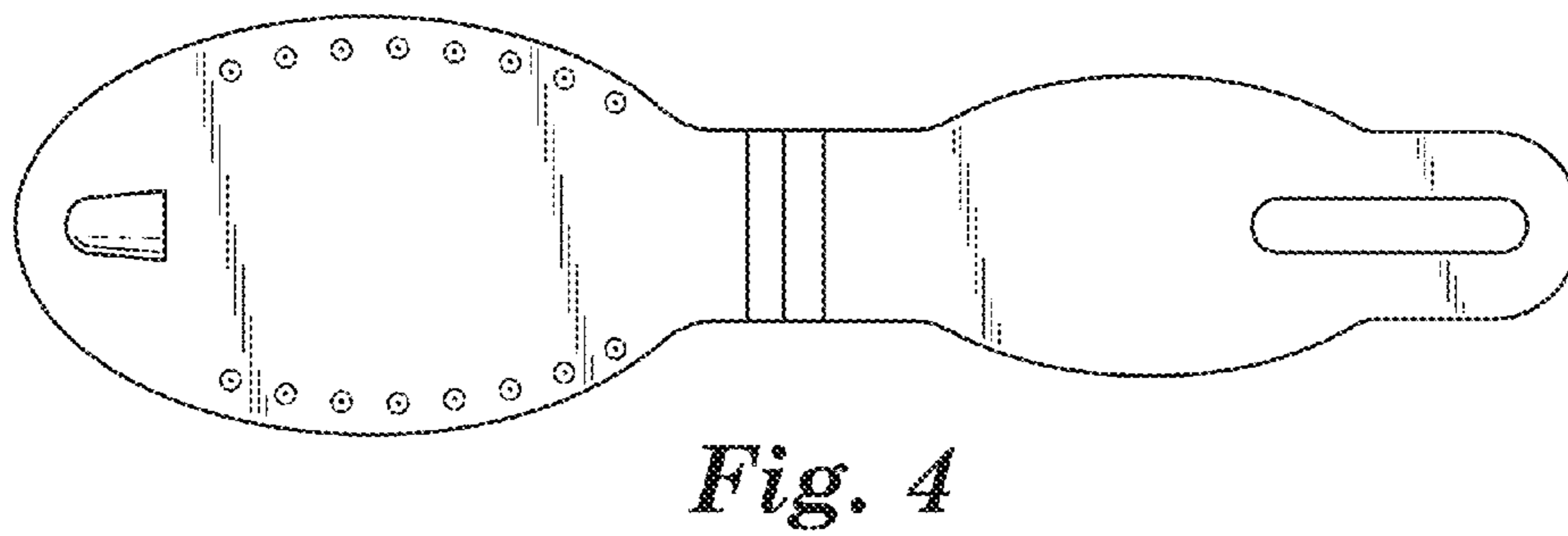
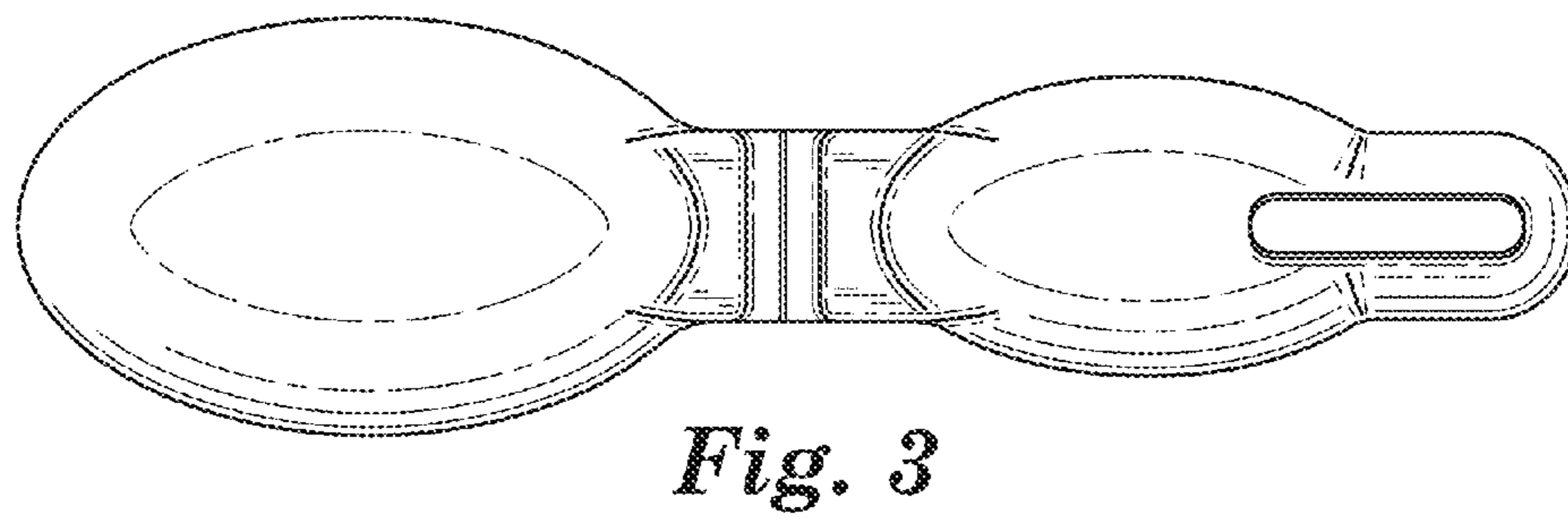
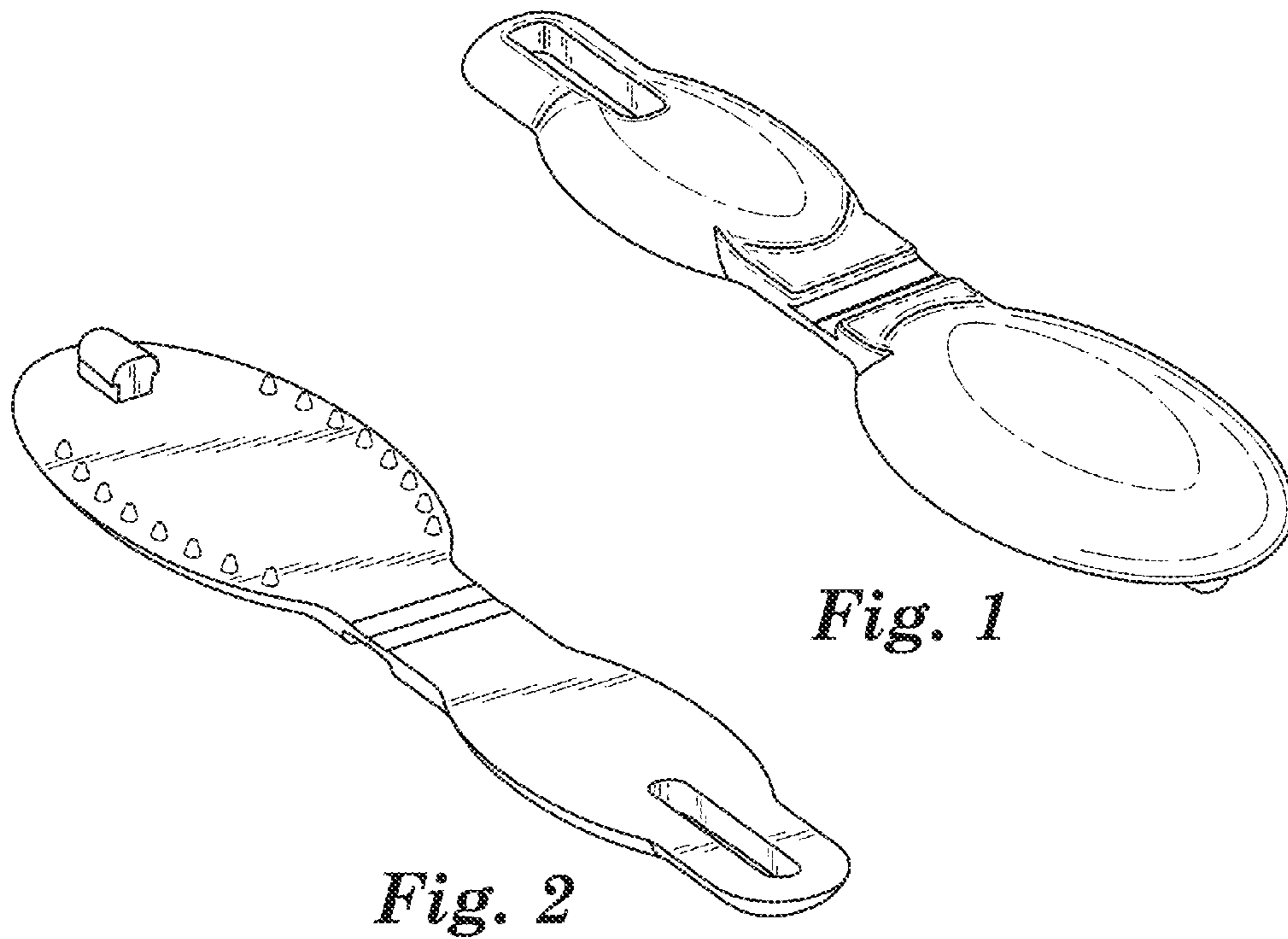
The ornamental design for a strap clip, as shown and described.

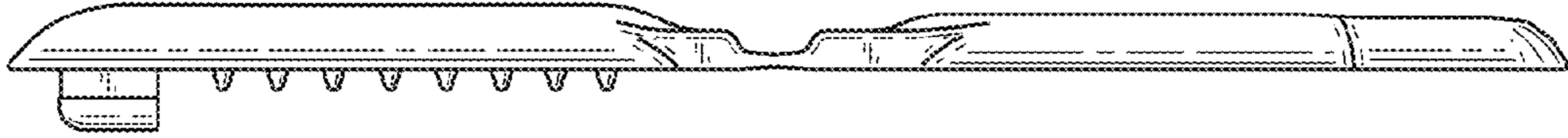
**DESCRIPTION**

FIG. 1 is a perspective view showing the new design for a strap clip;  
FIG. 2 is another perspective view thereof;  
FIG. 3 is a top view thereof;

FIG. 5 is a front view thereof, the rear view being a mirror image thereof;  
FIG. 6 is a left view thereof;

The surface shading illustrated in the drawings is provided merely to highlight the contour of design; it is not intended to be illustrative of texture or gloss.

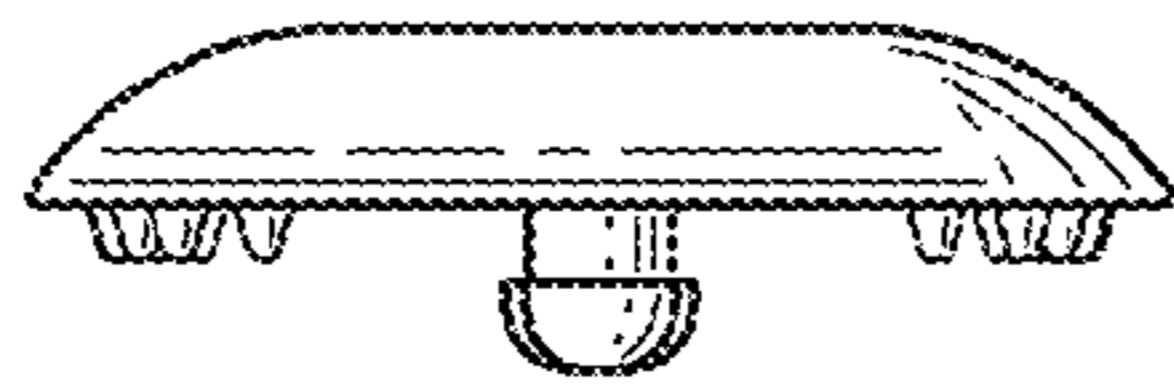

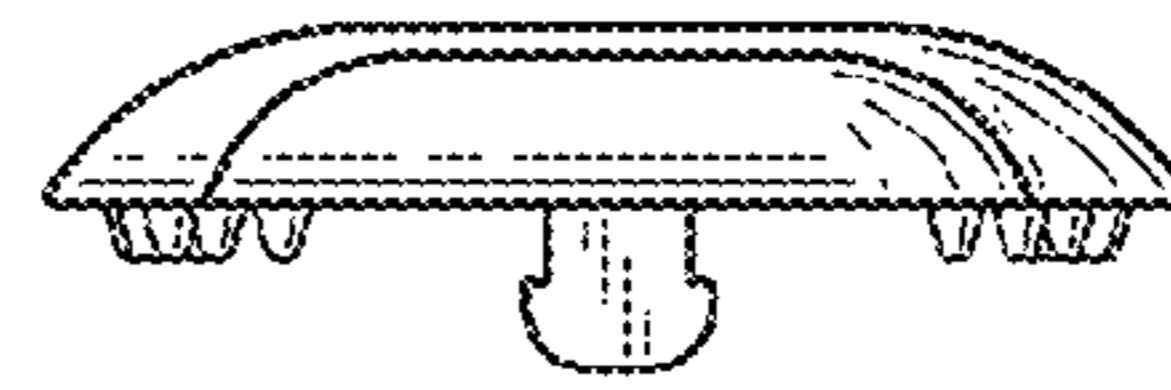




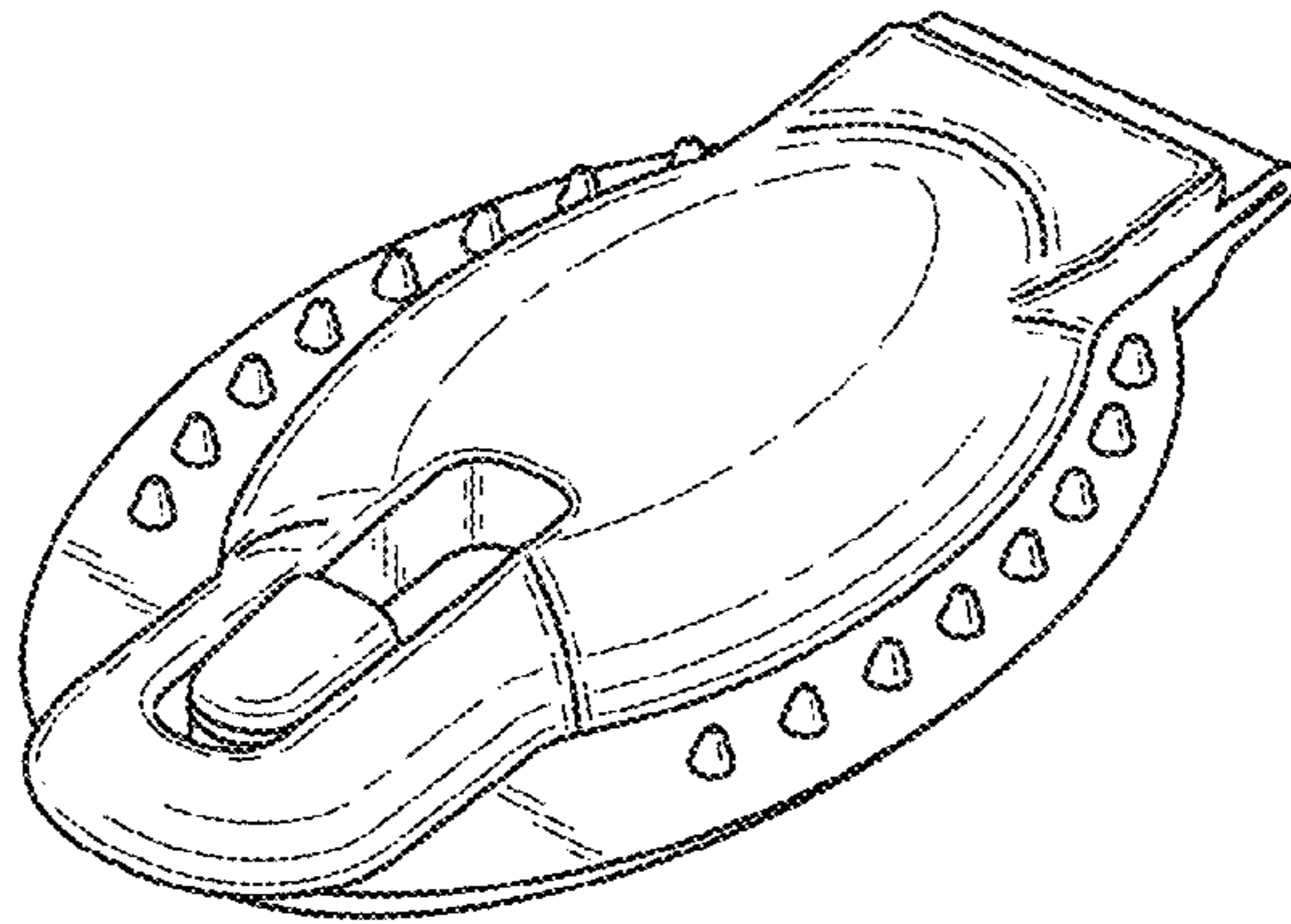
