(57) **CLAIM**

The ornamental design for a motorcycle air cleaner cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of my new design for a motorcycle air cleaner cover shown in position of use on a motorcycle;

FIG. 2 is an enlarged perspective view of my new motorcycle air cleaner cover;

FIG. 3 is an enlarged front elevational view thereof;

FIG. 4 is an enlarged rear elevational view thereof;

FIG. 5 is an enlarged left side elevational view thereof;

FIG. 6 is an enlarged right side elevational view thereof;

FIG. 7 is an enlarged top plan view thereof; and,

FIG. 8 is an enlarged bottom view thereof.

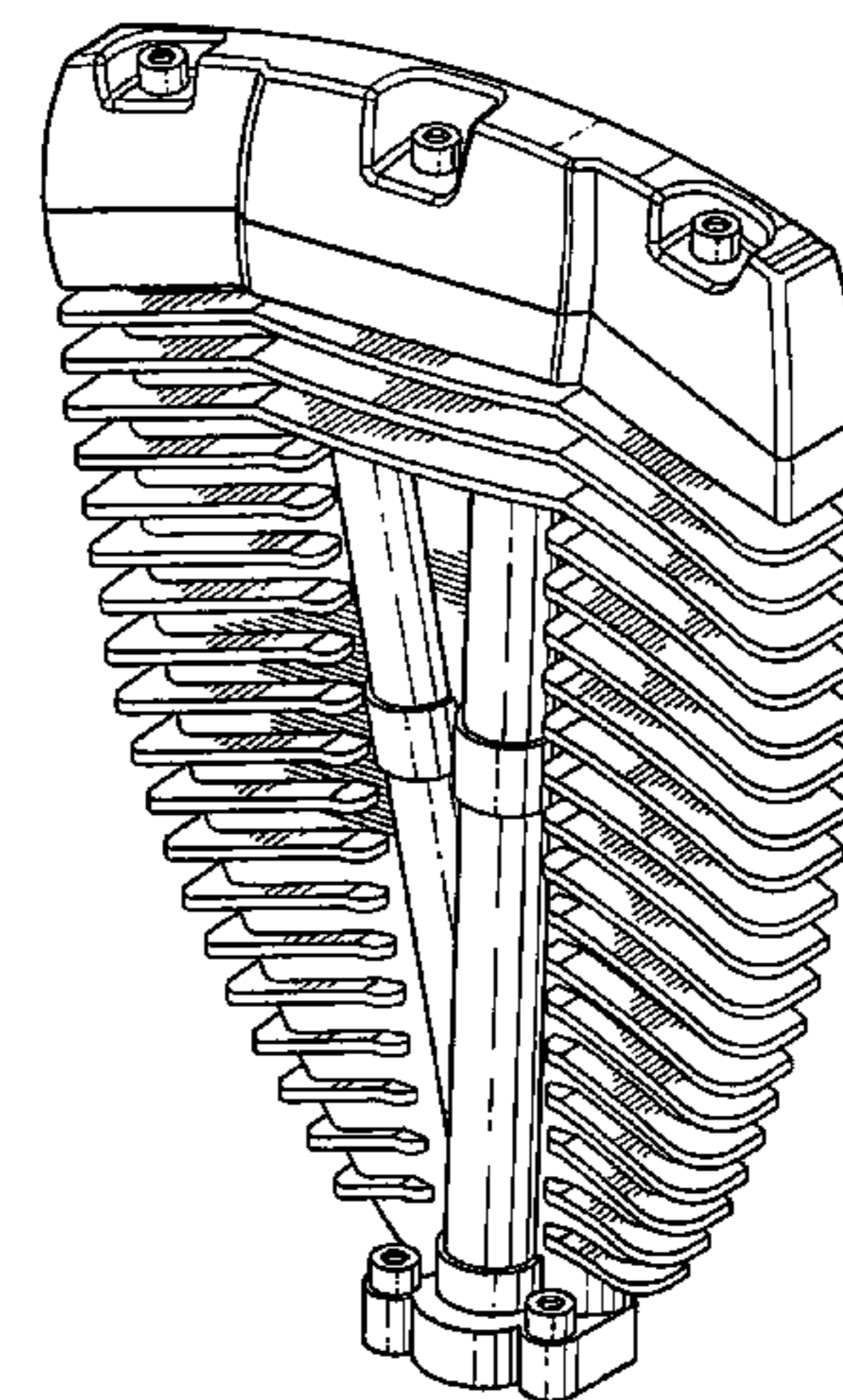
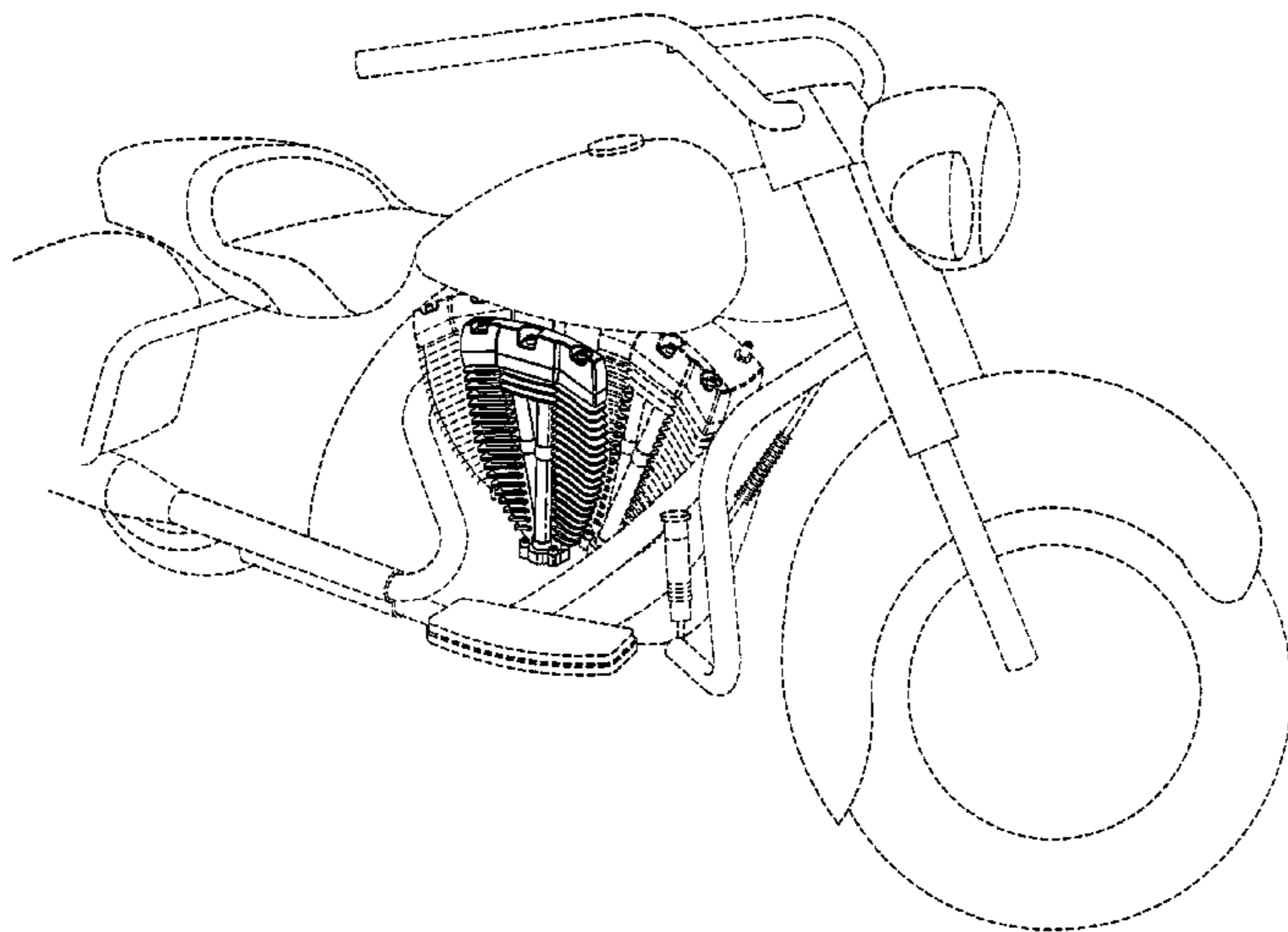

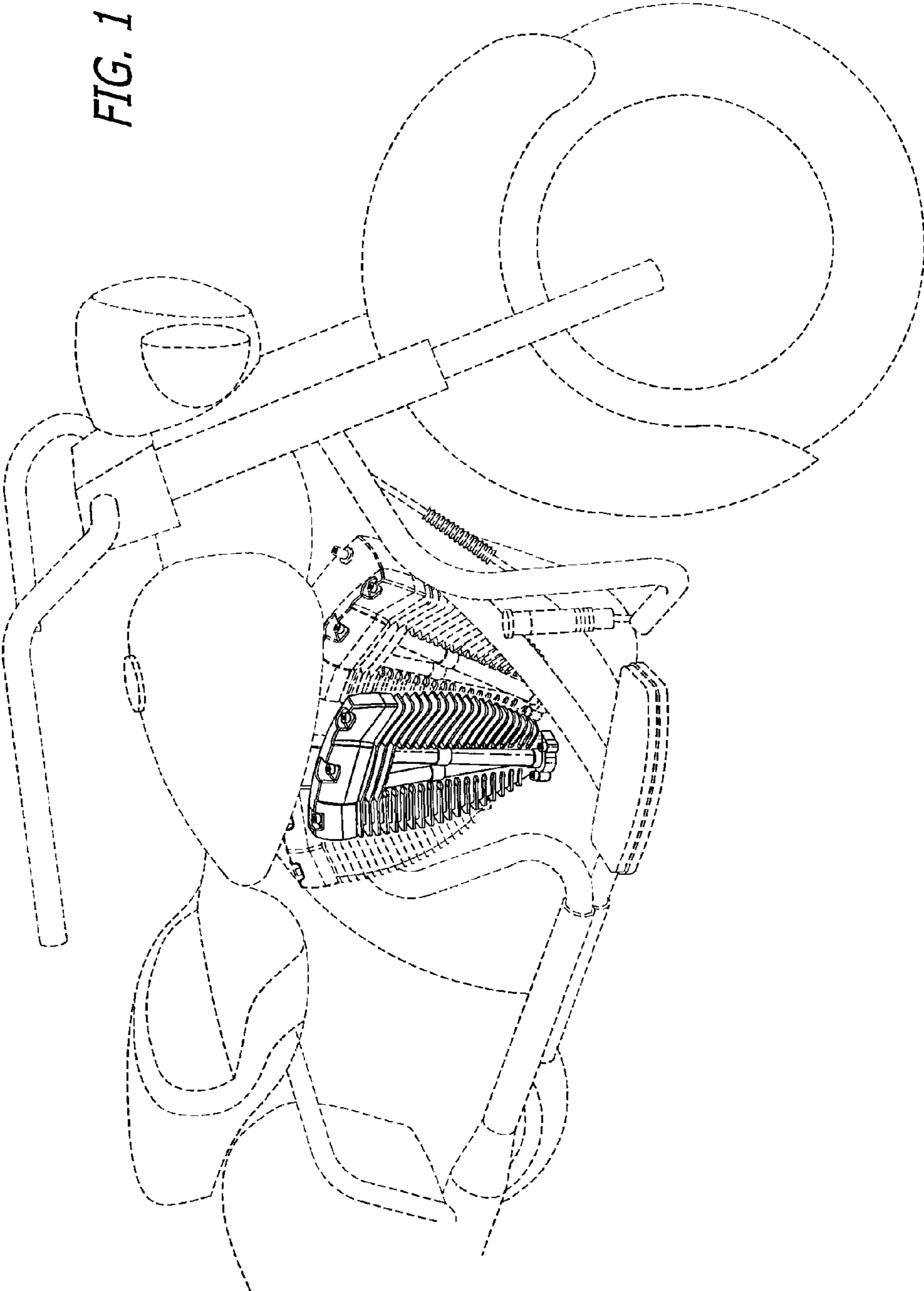
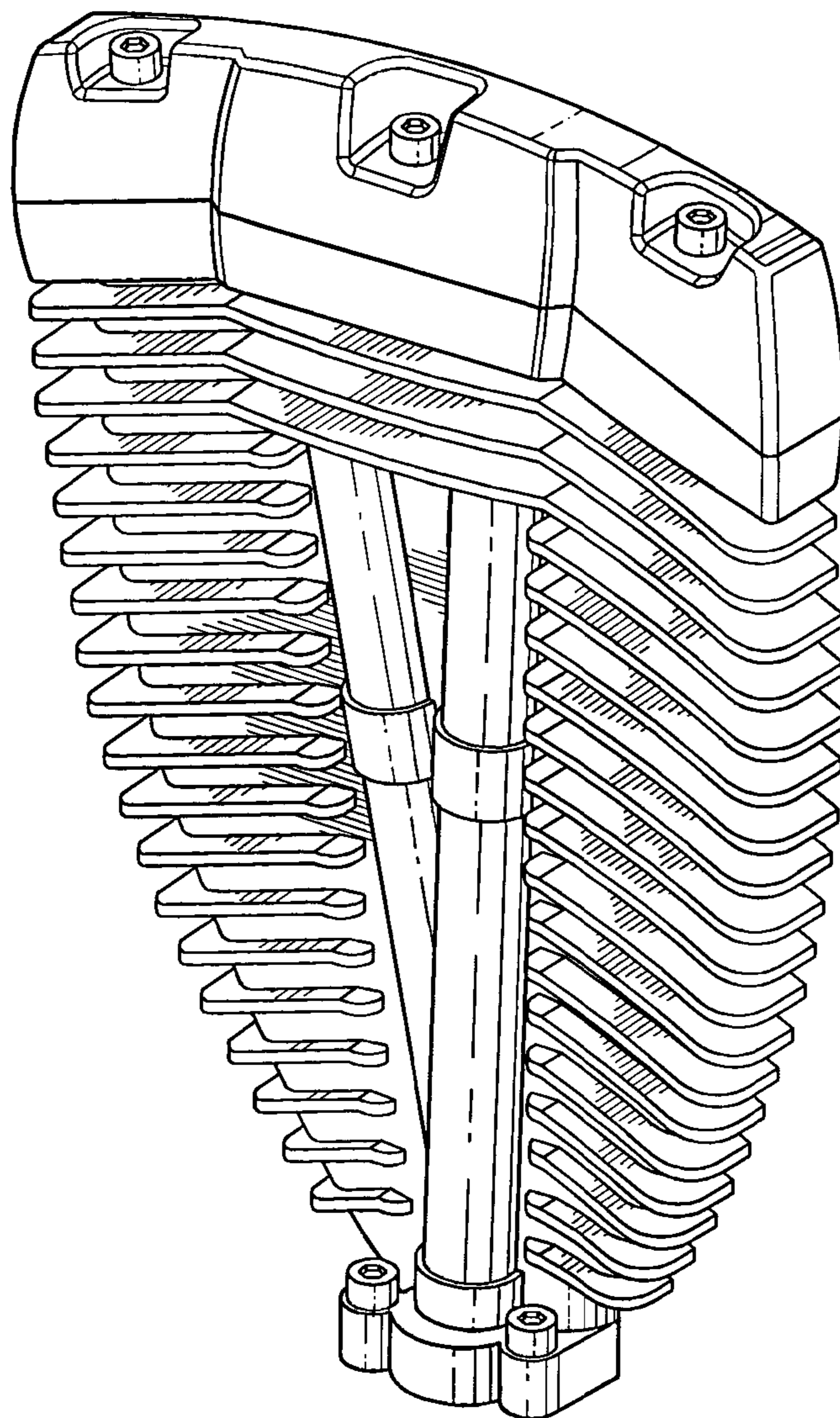

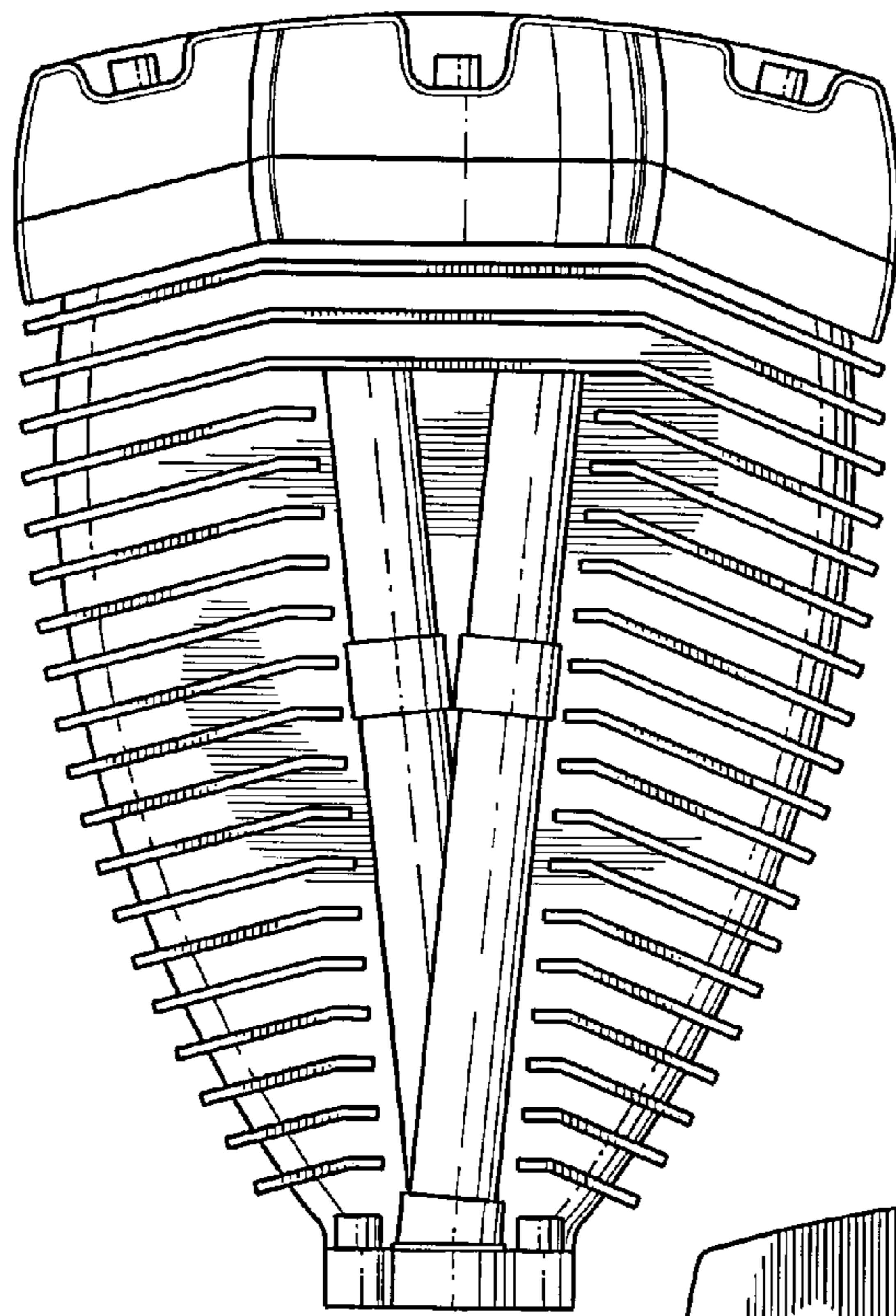

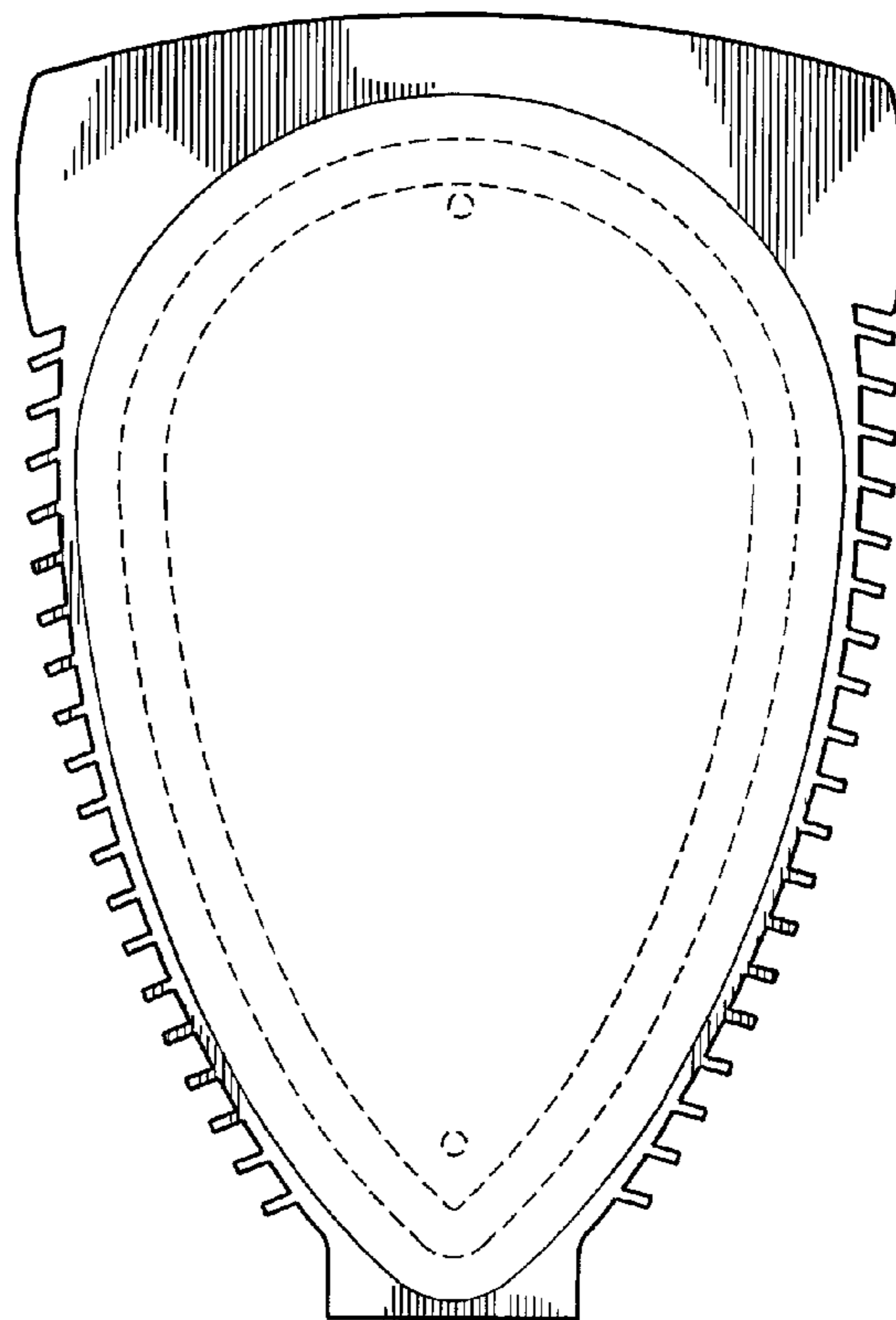
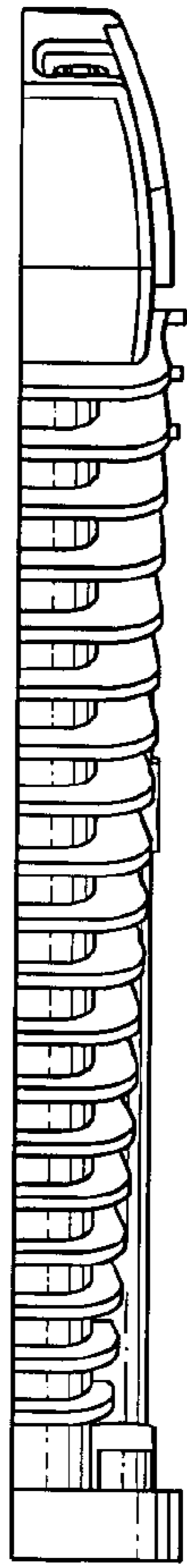
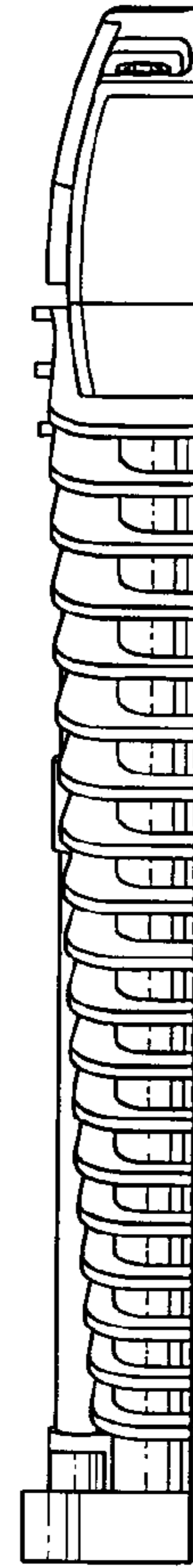


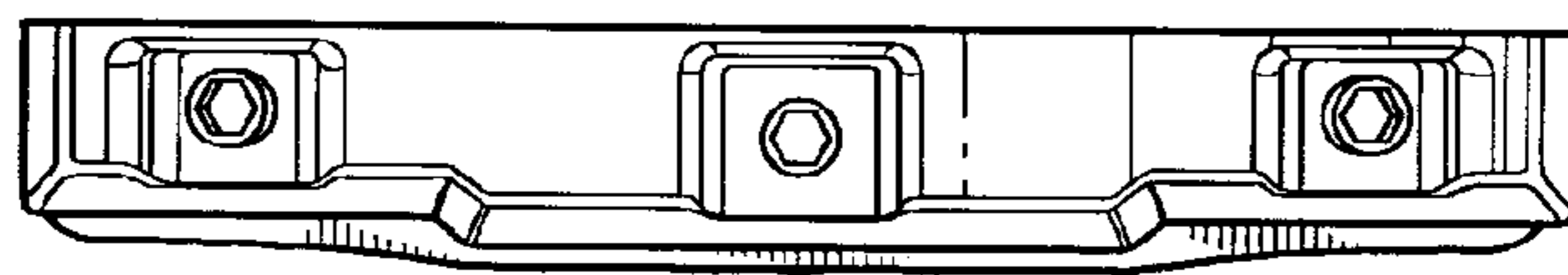

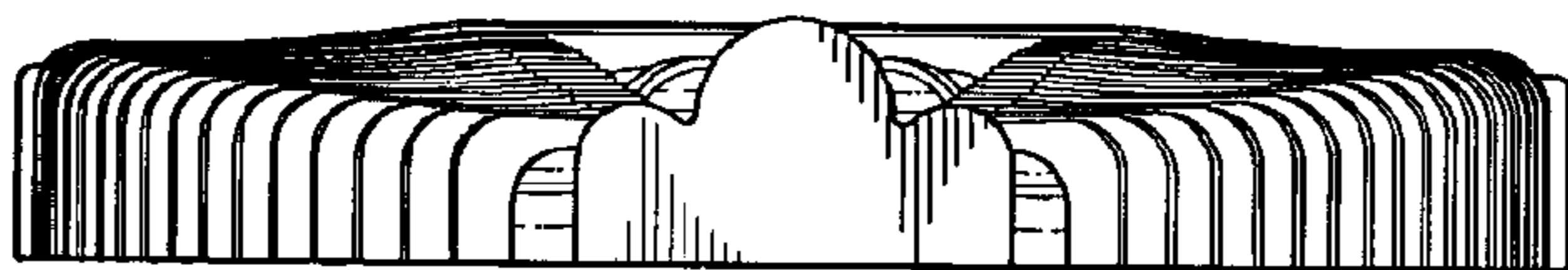
