FIG. 4 is a right side view thereof;

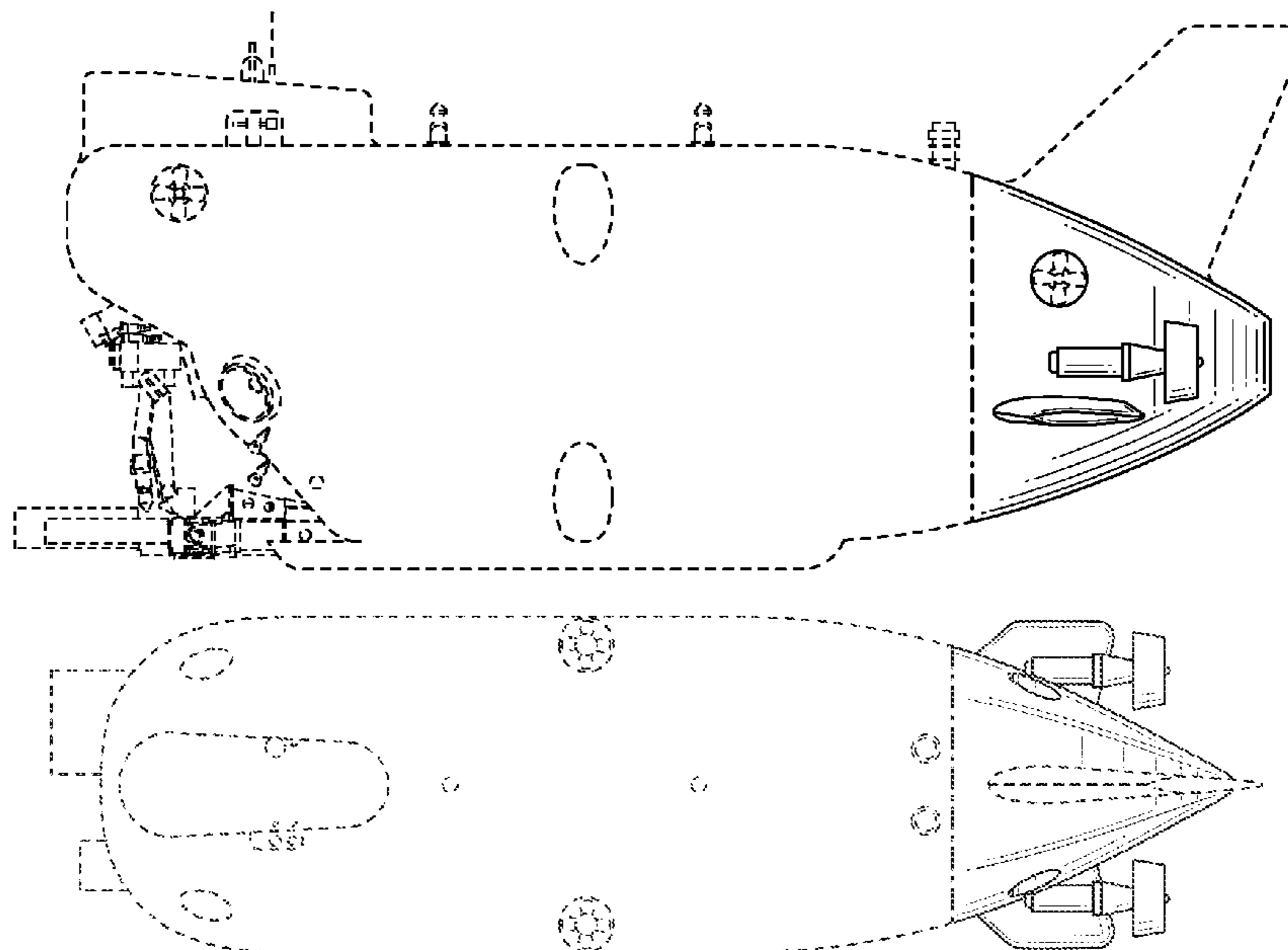
FIG. 5 is a top plan view thereof; and,

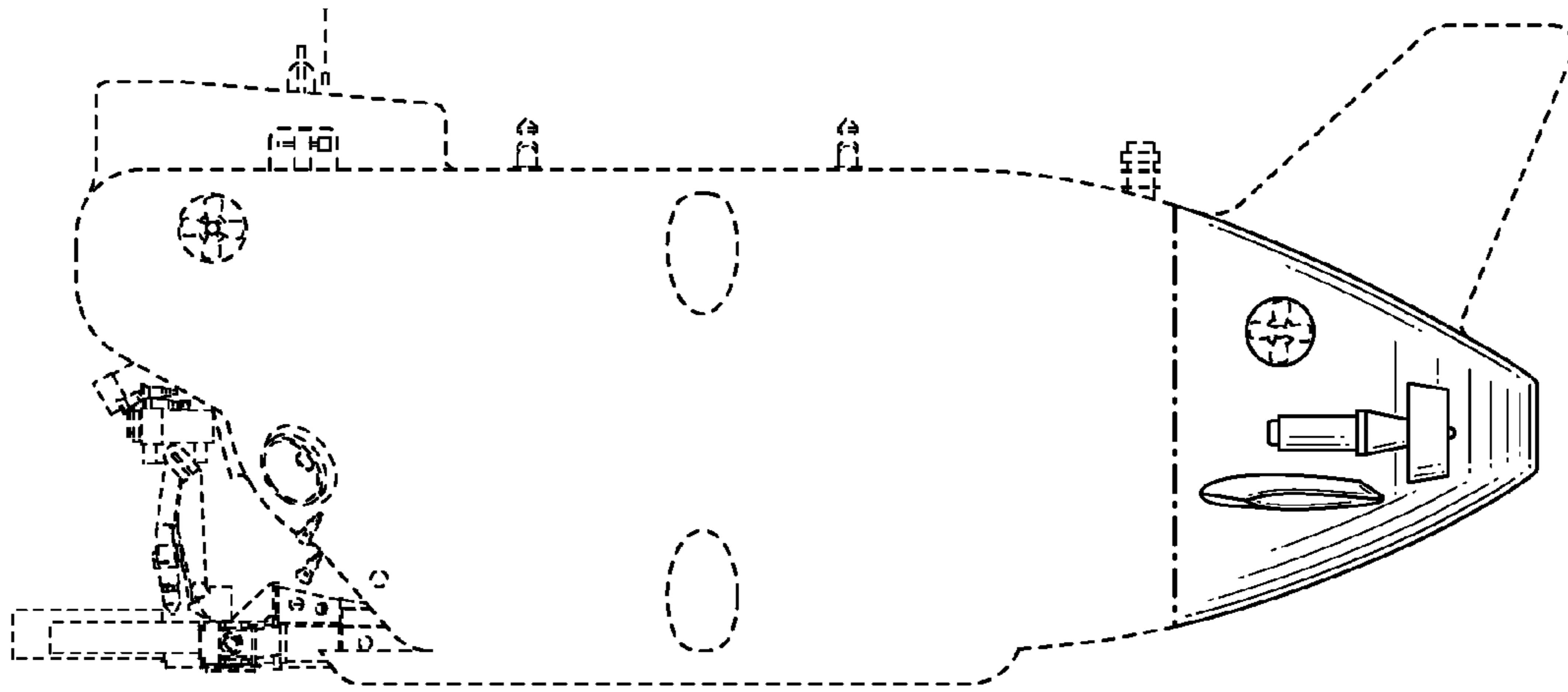
FIG. 6 is a bottom plan view thereof.

The dashed broken lines illustrate environmental structure and form no part of the claimed design.

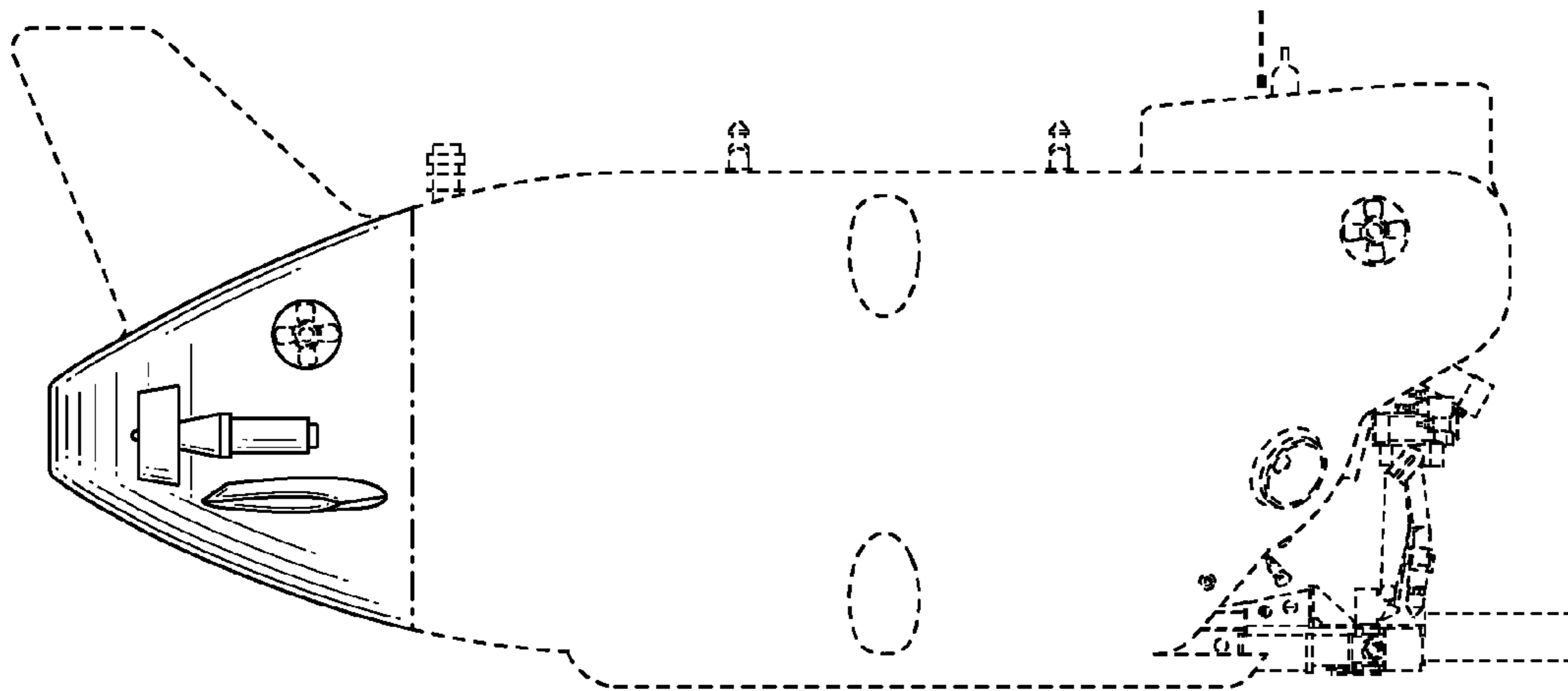
The dot-dash broken lines represent a boundary that forms no part of the claimed design.

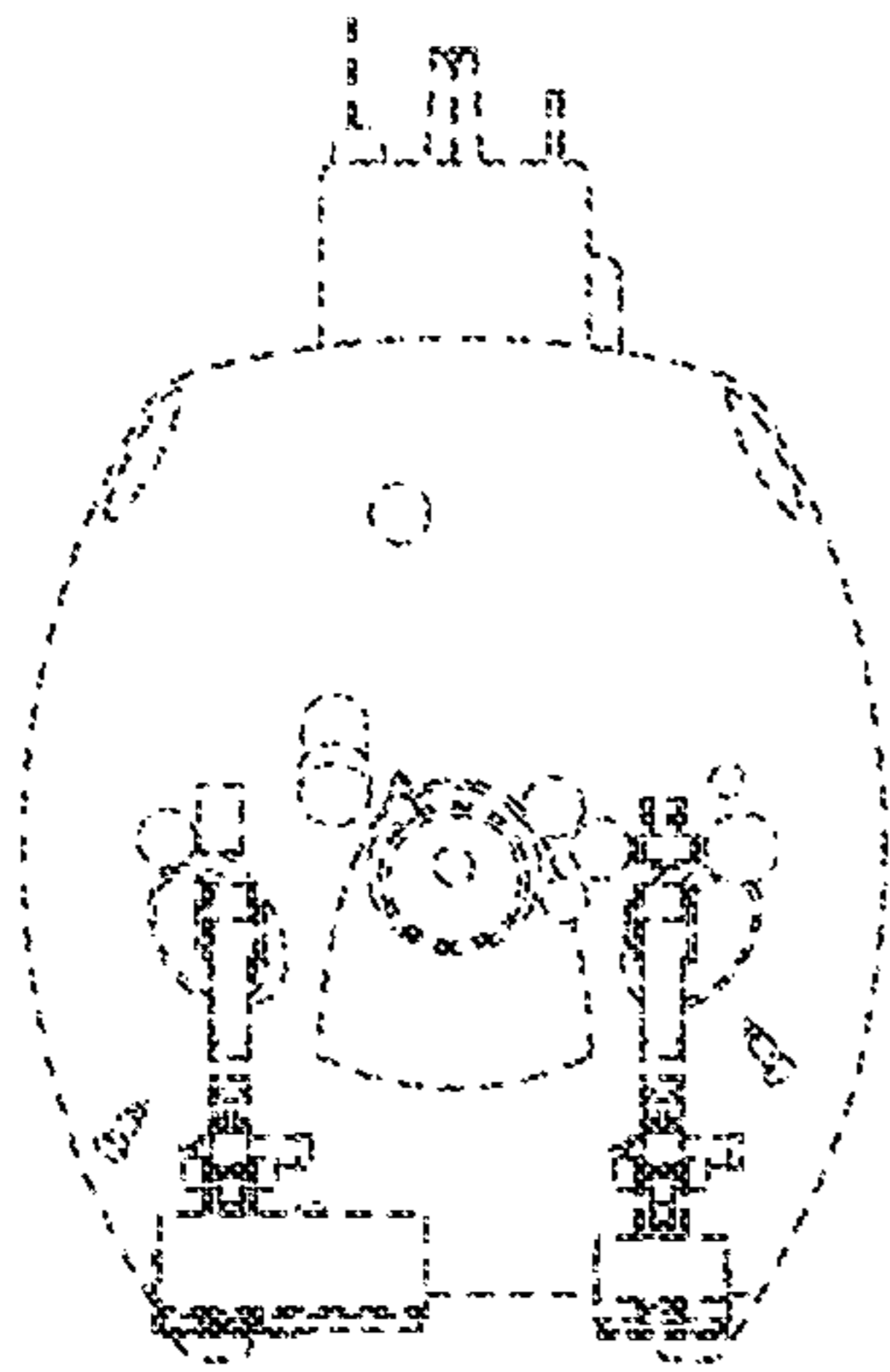




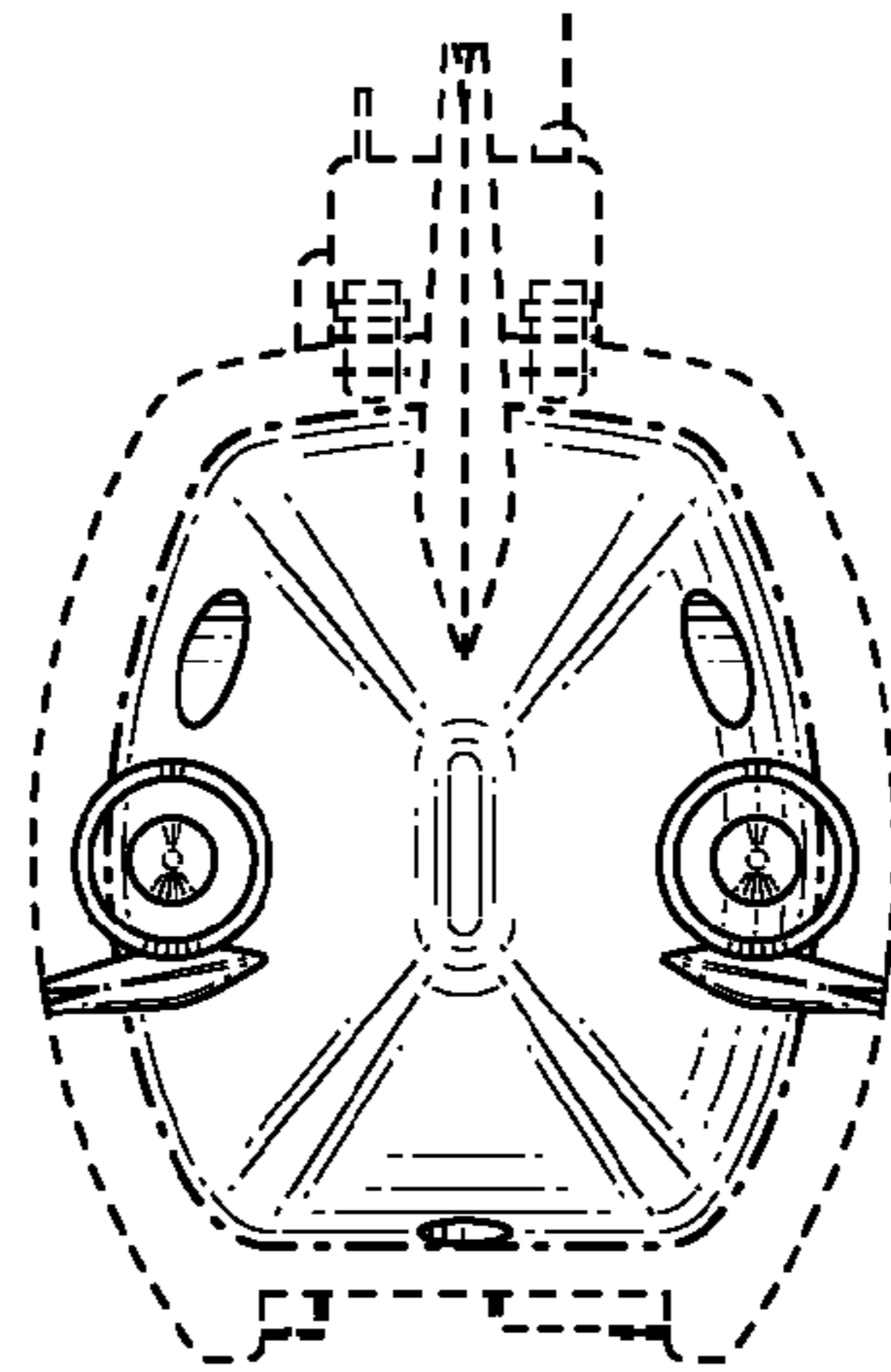

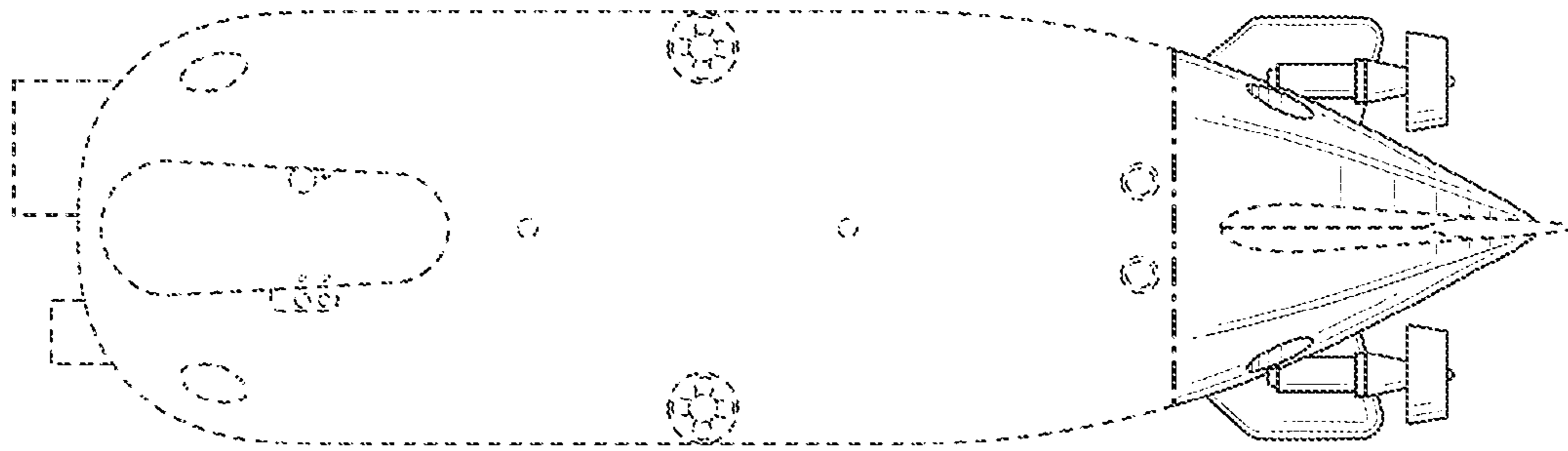

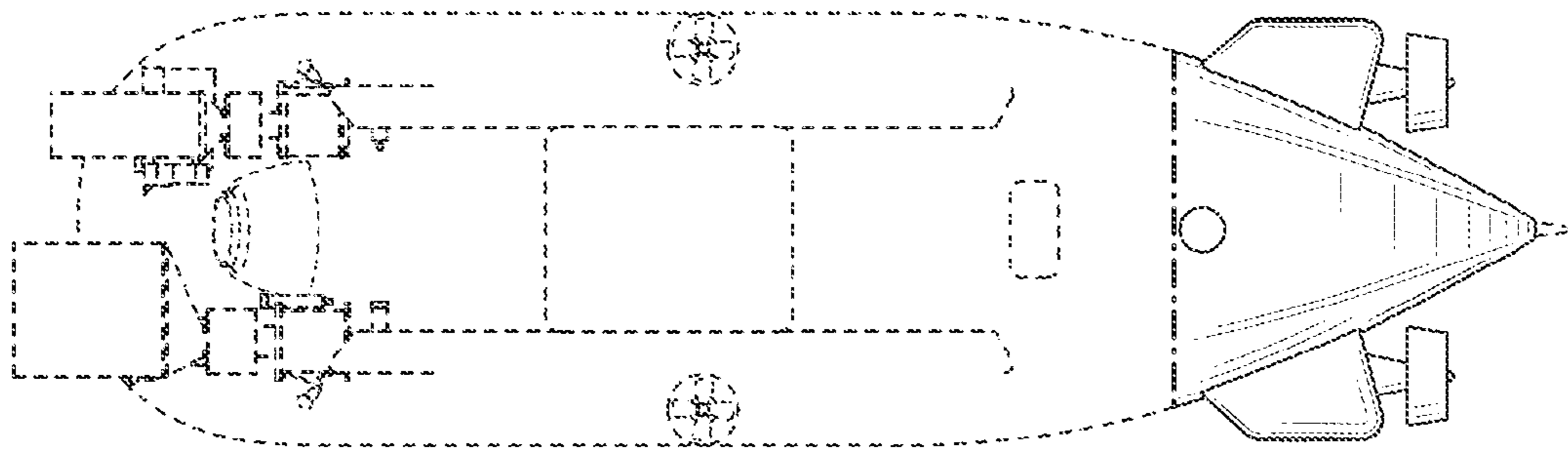
