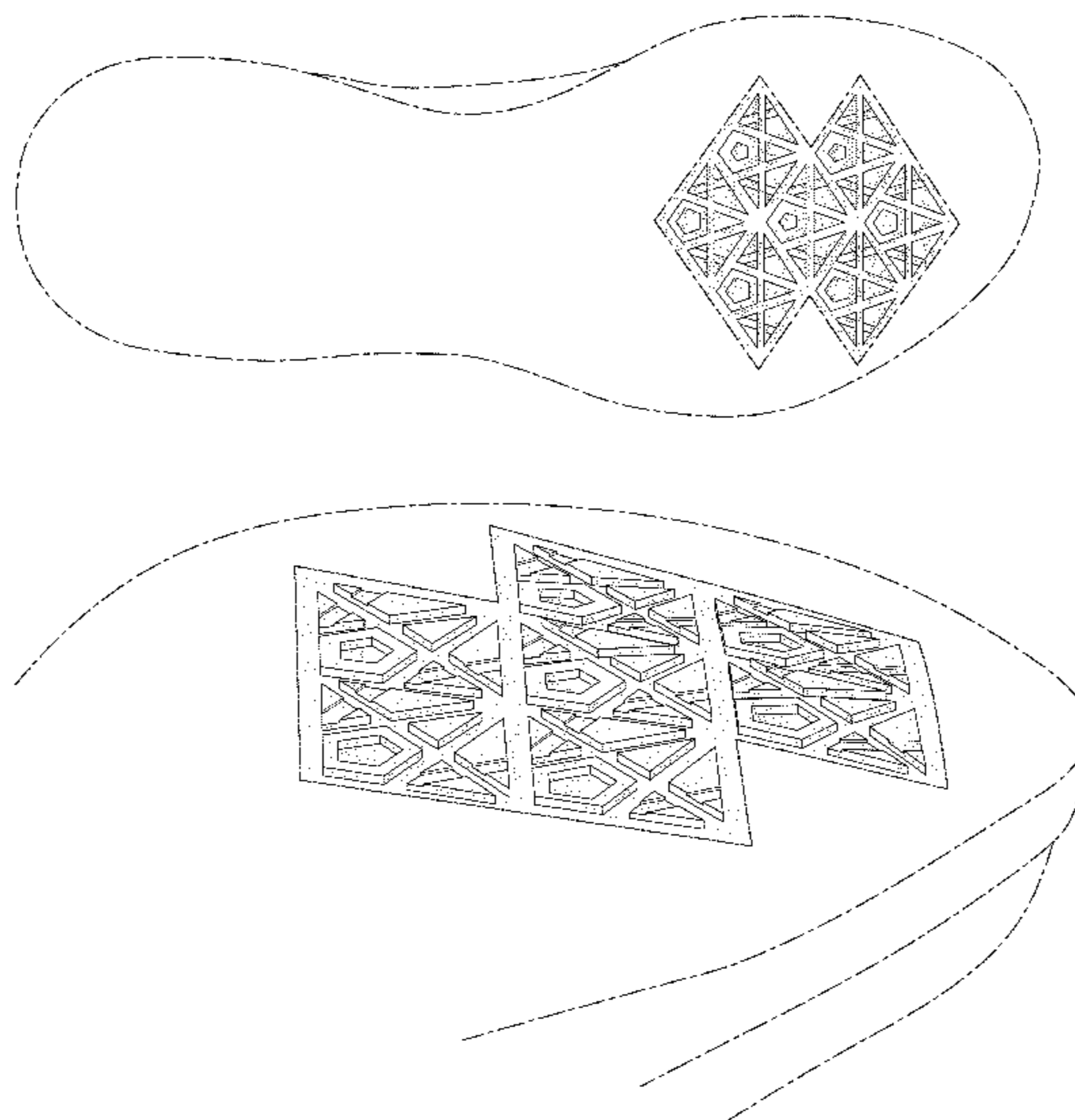
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a shoe that shows my new design for a shoe outsole;
FIG. 2 is an enlarged front perspective view thereof in which a portion of the shoe has been omitted for clarity; and,
FIG. 3 is an enlarged rear perspective view thereof in which an unclaimed portion has been omitted for clarity.
The uneven length broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The uneven length broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

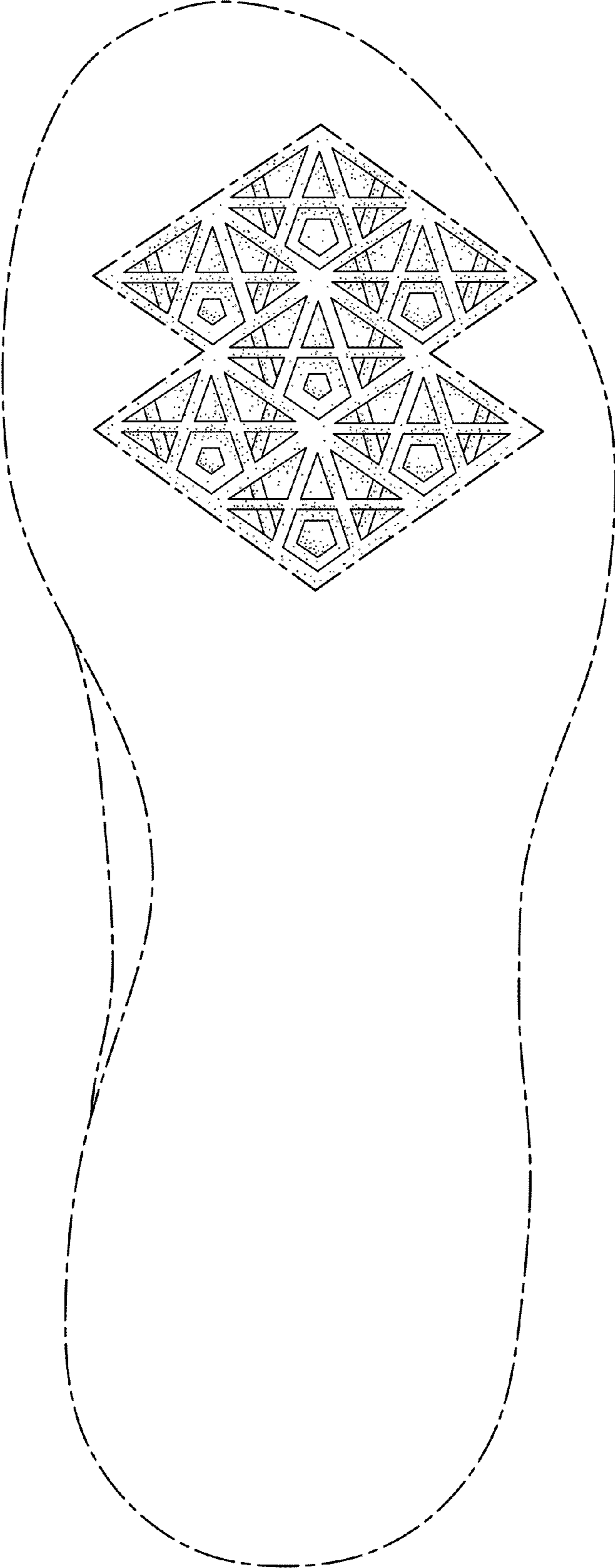

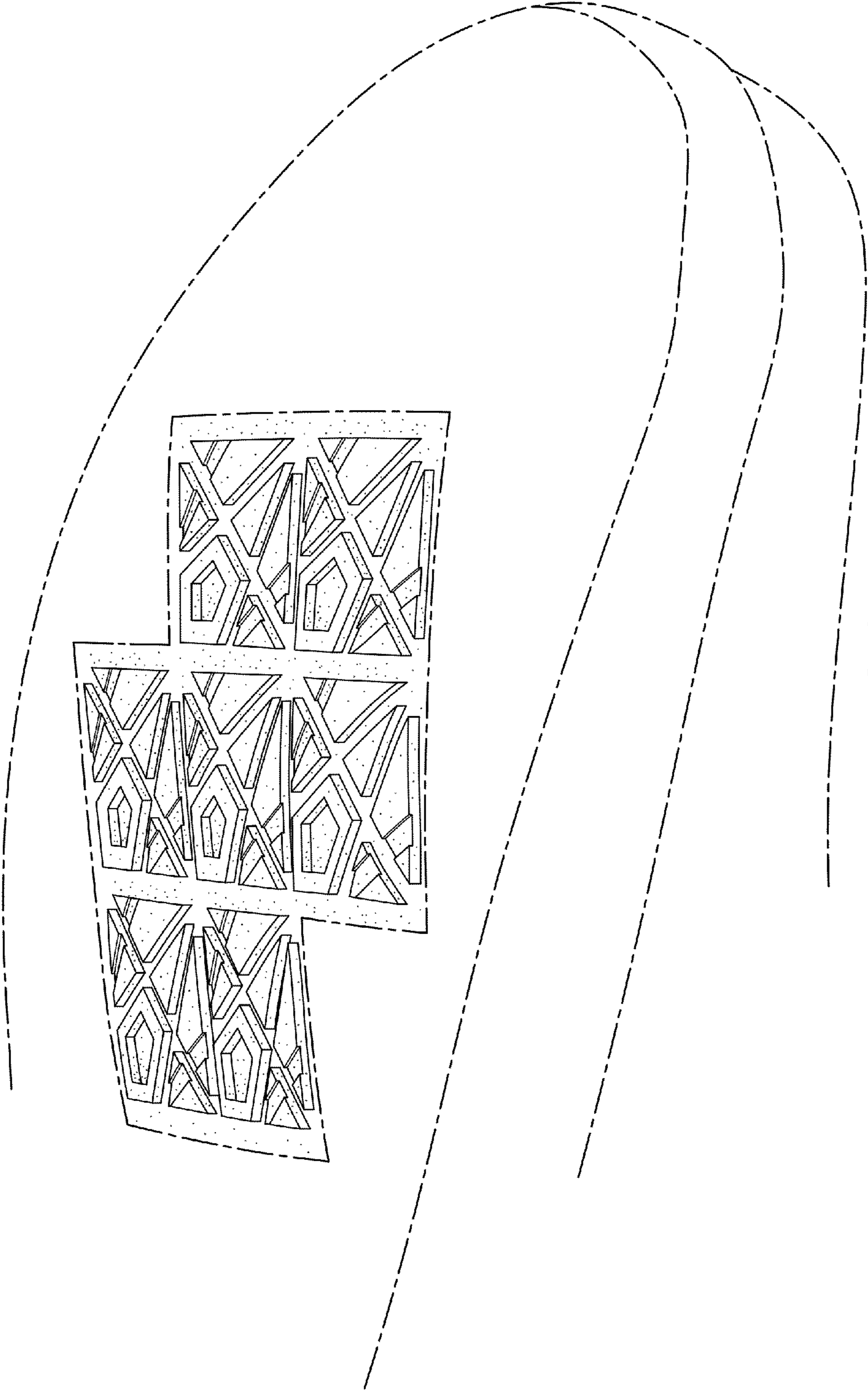

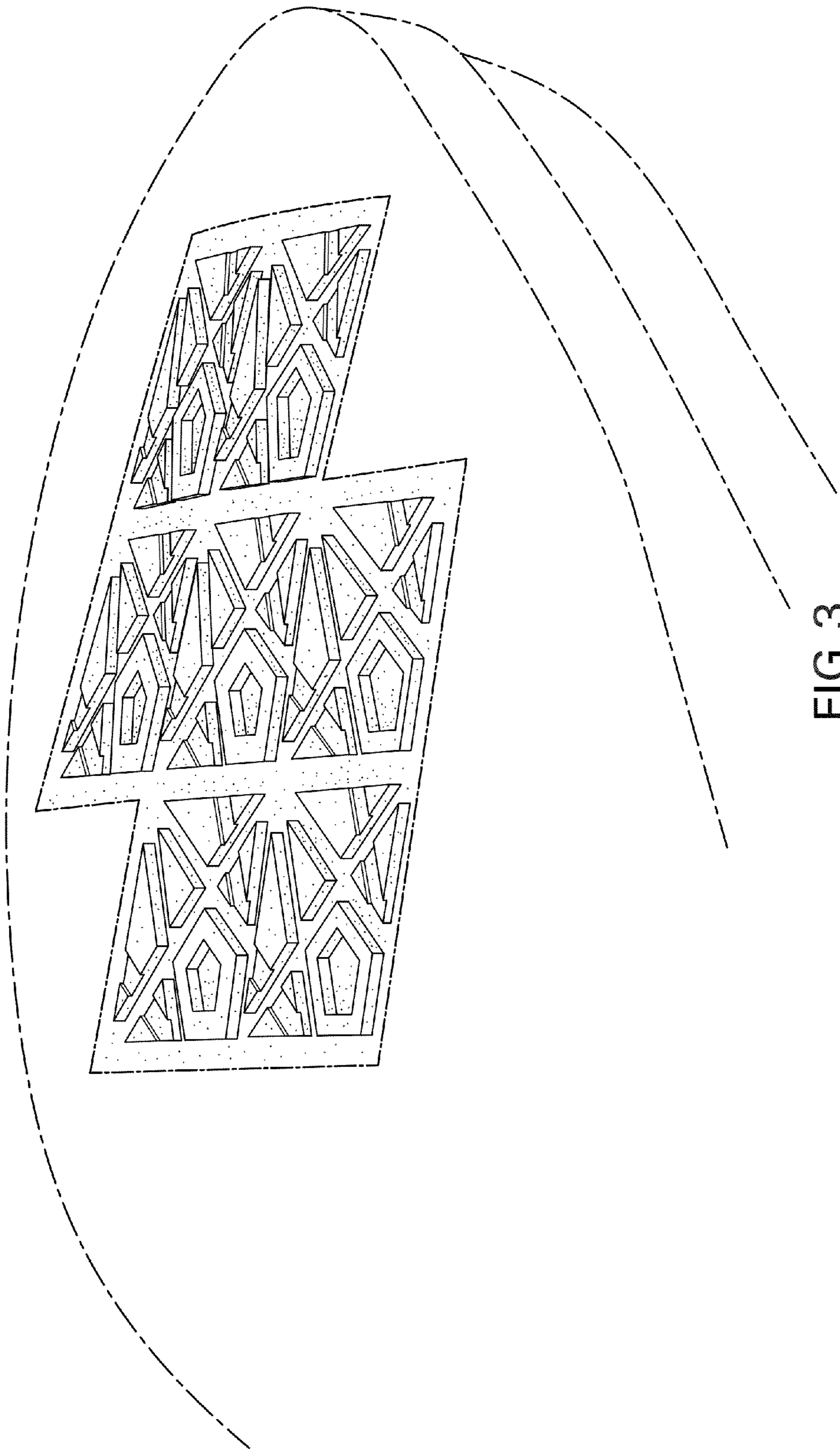
