(57) **CLAIM**

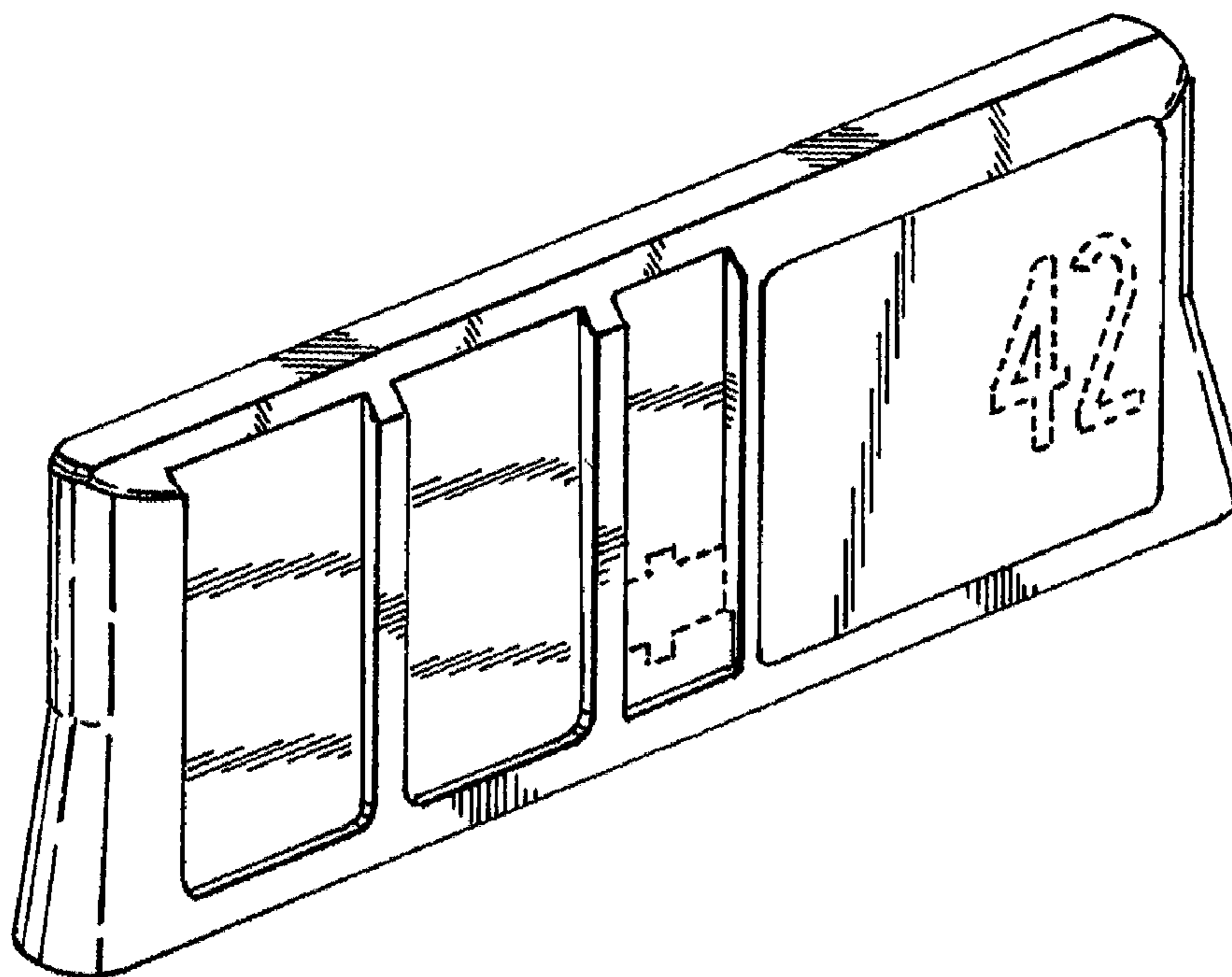
The ornamental design for a top sizer, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and side perspective view of a top sizer showing my new design;
FIG. 2 is a front elevation view thereof;

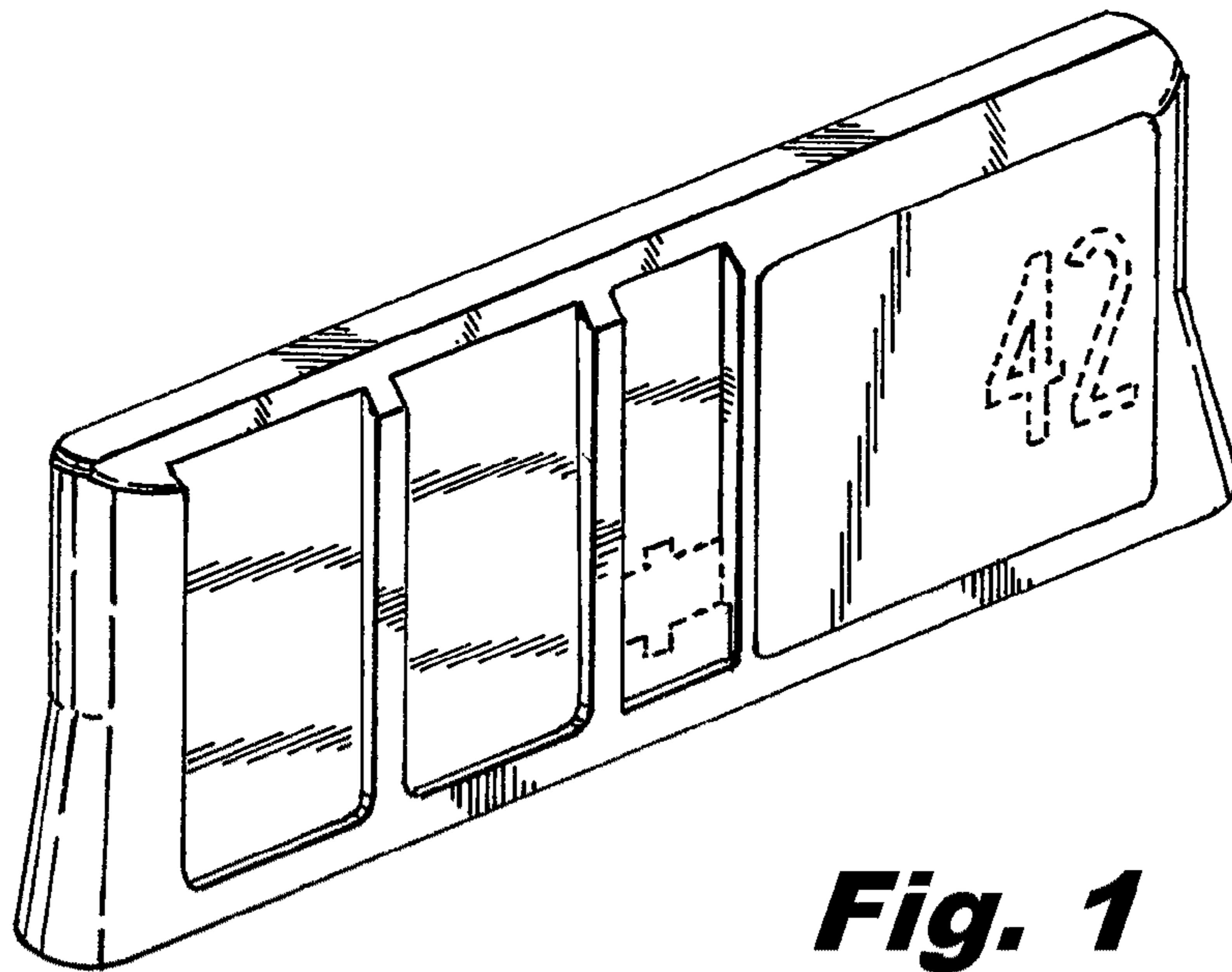

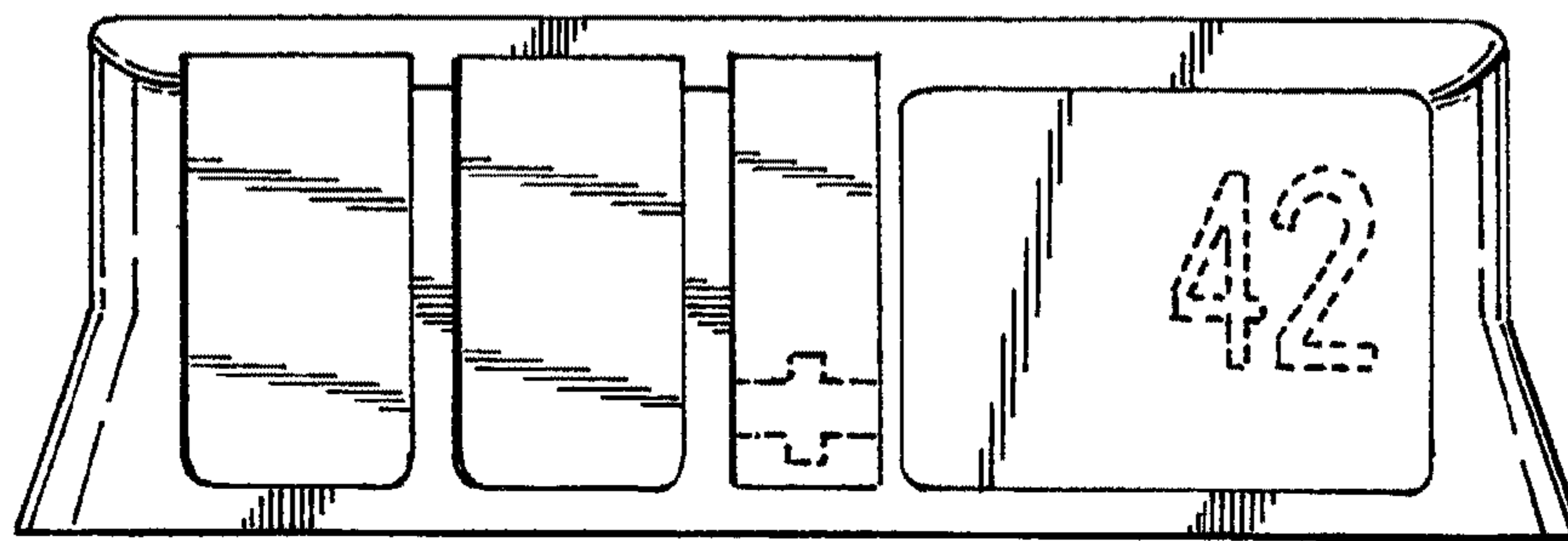

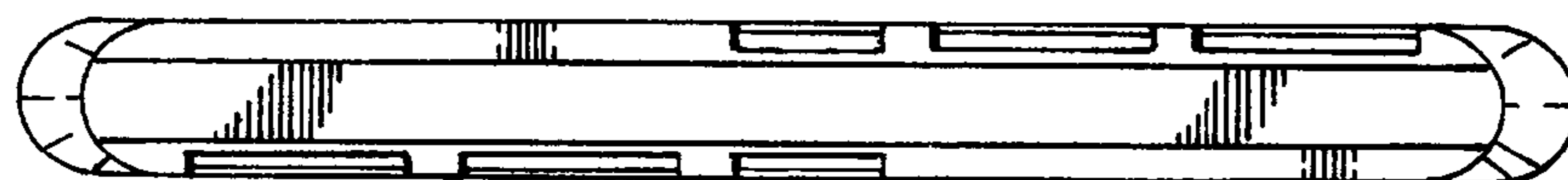

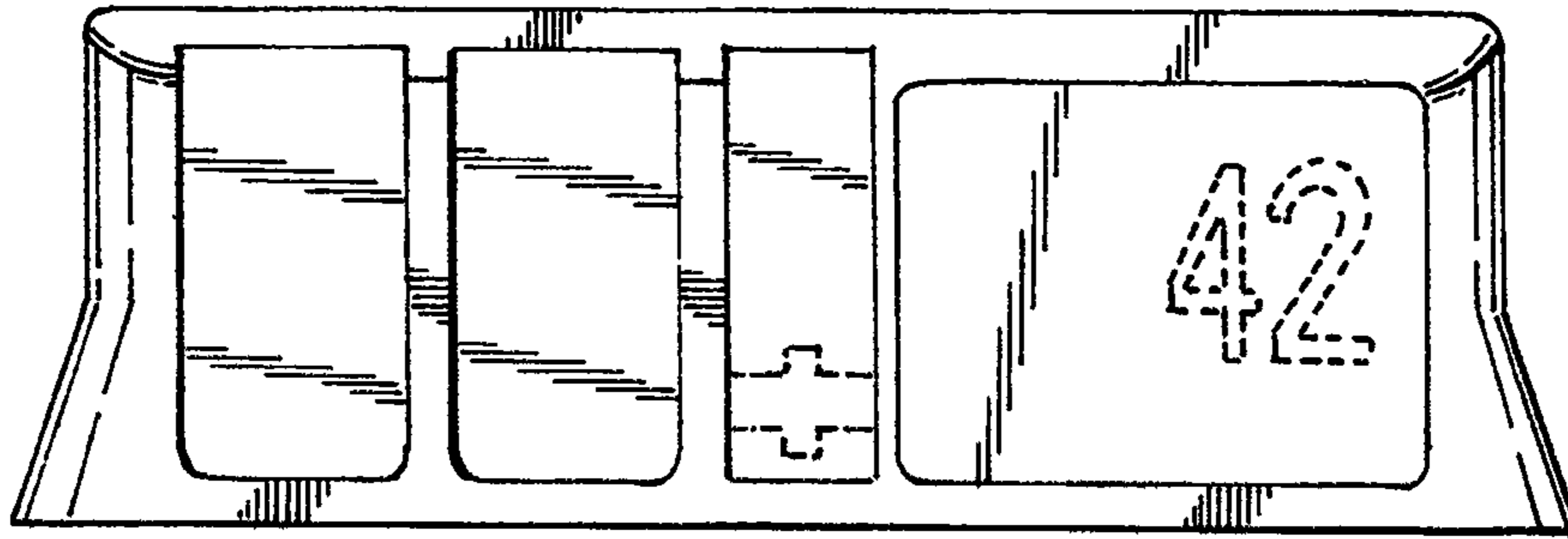

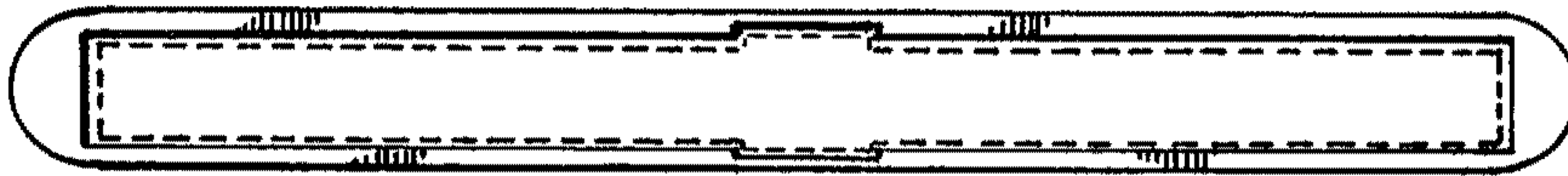

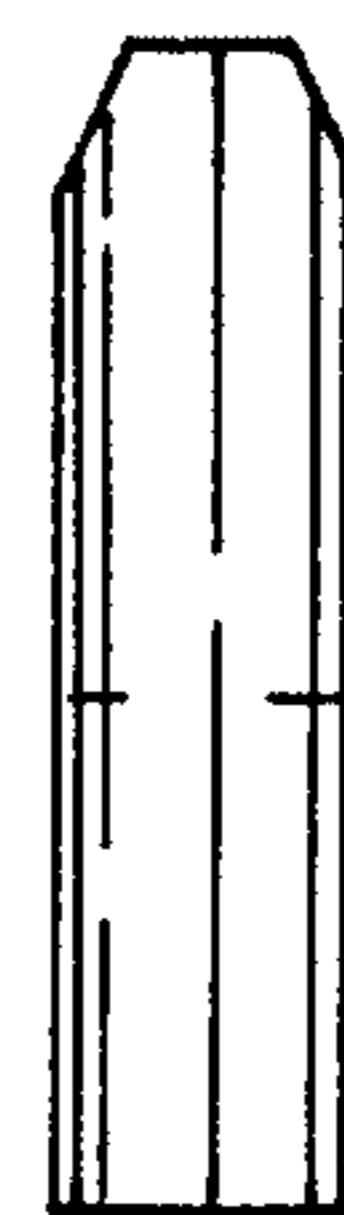
