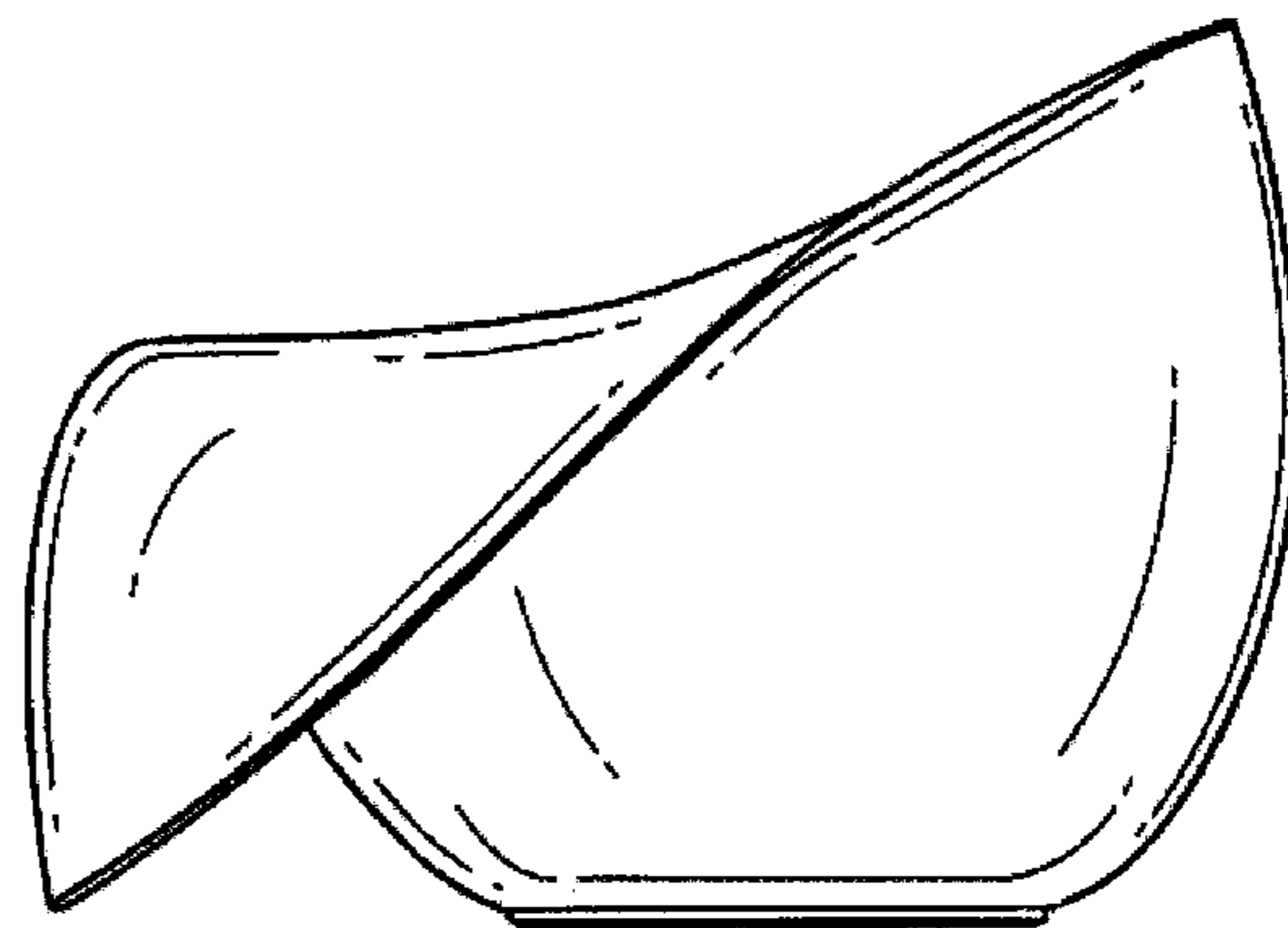
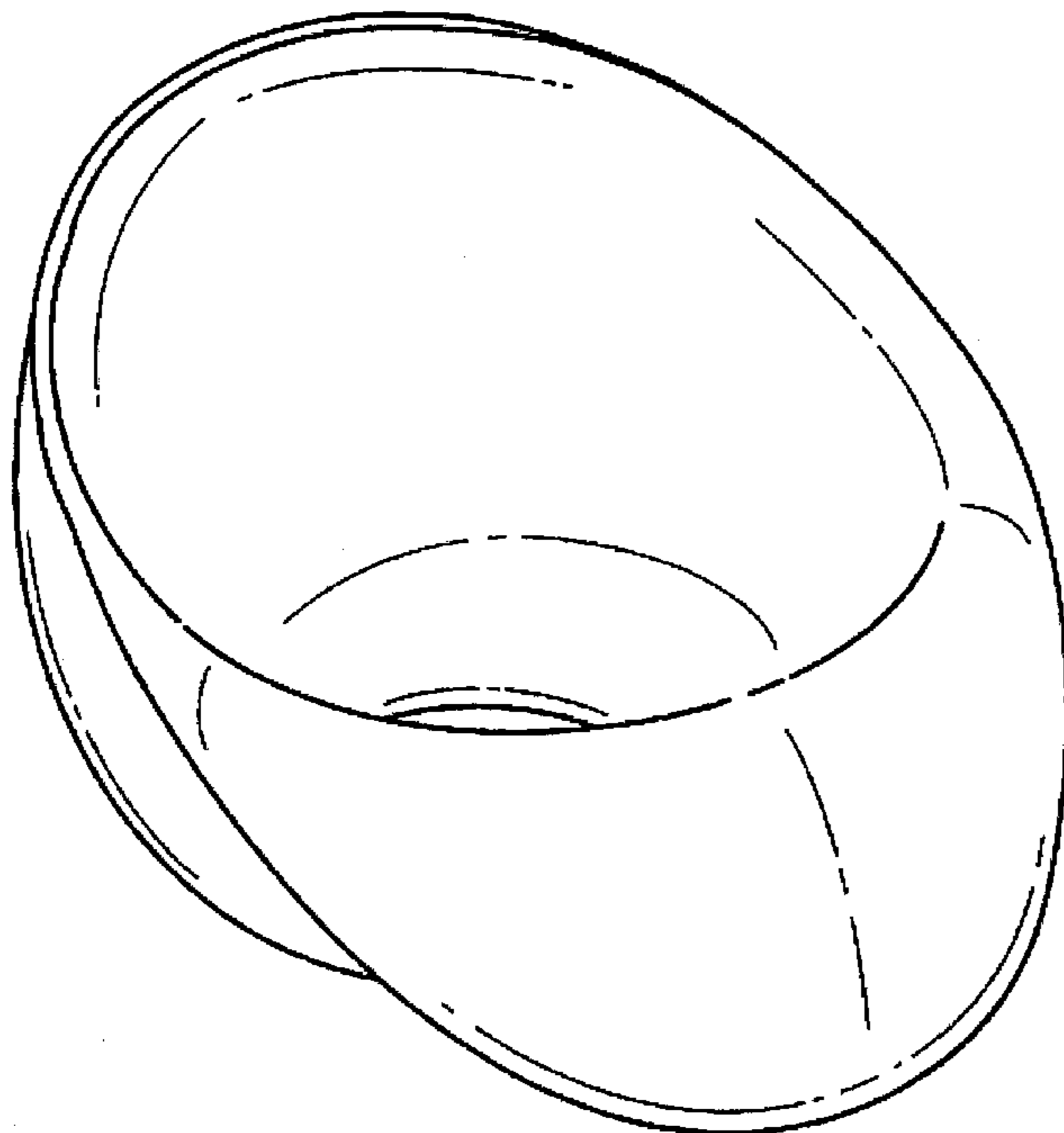
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the bowl;
FIG. 2 is top plan view of the bowl;

FIG. 5 is the rear view of the bowl of FIG. 2;

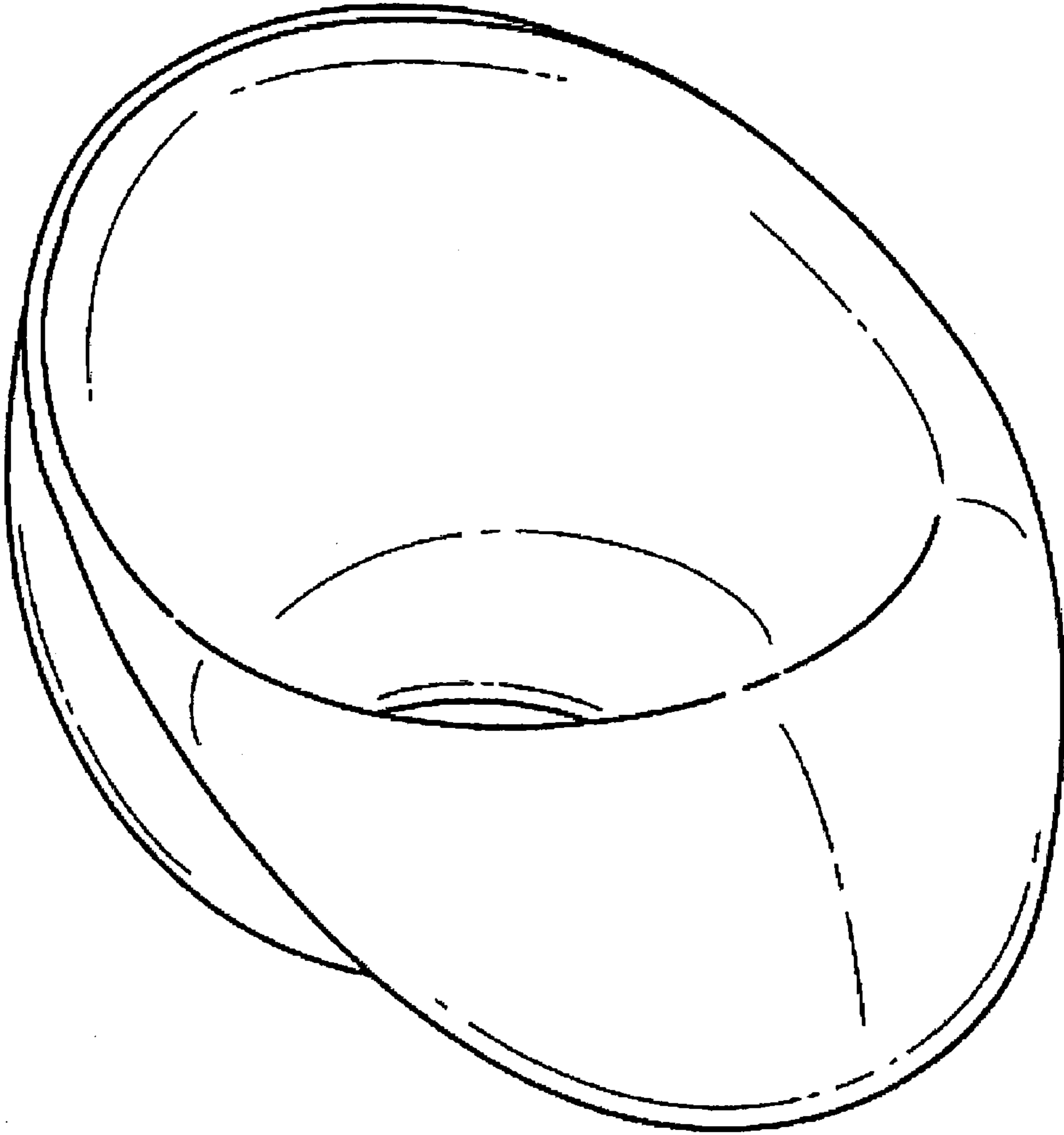

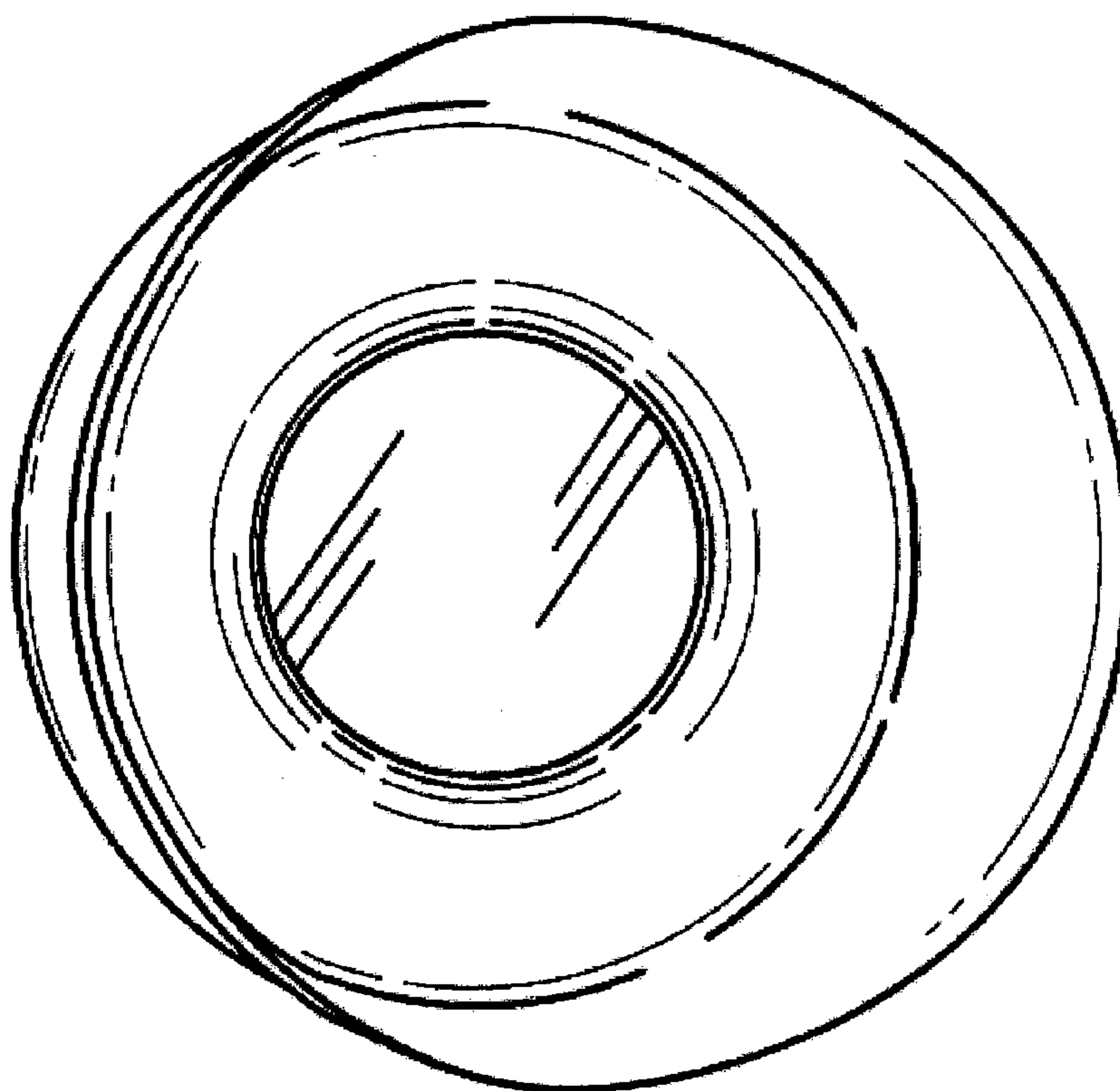

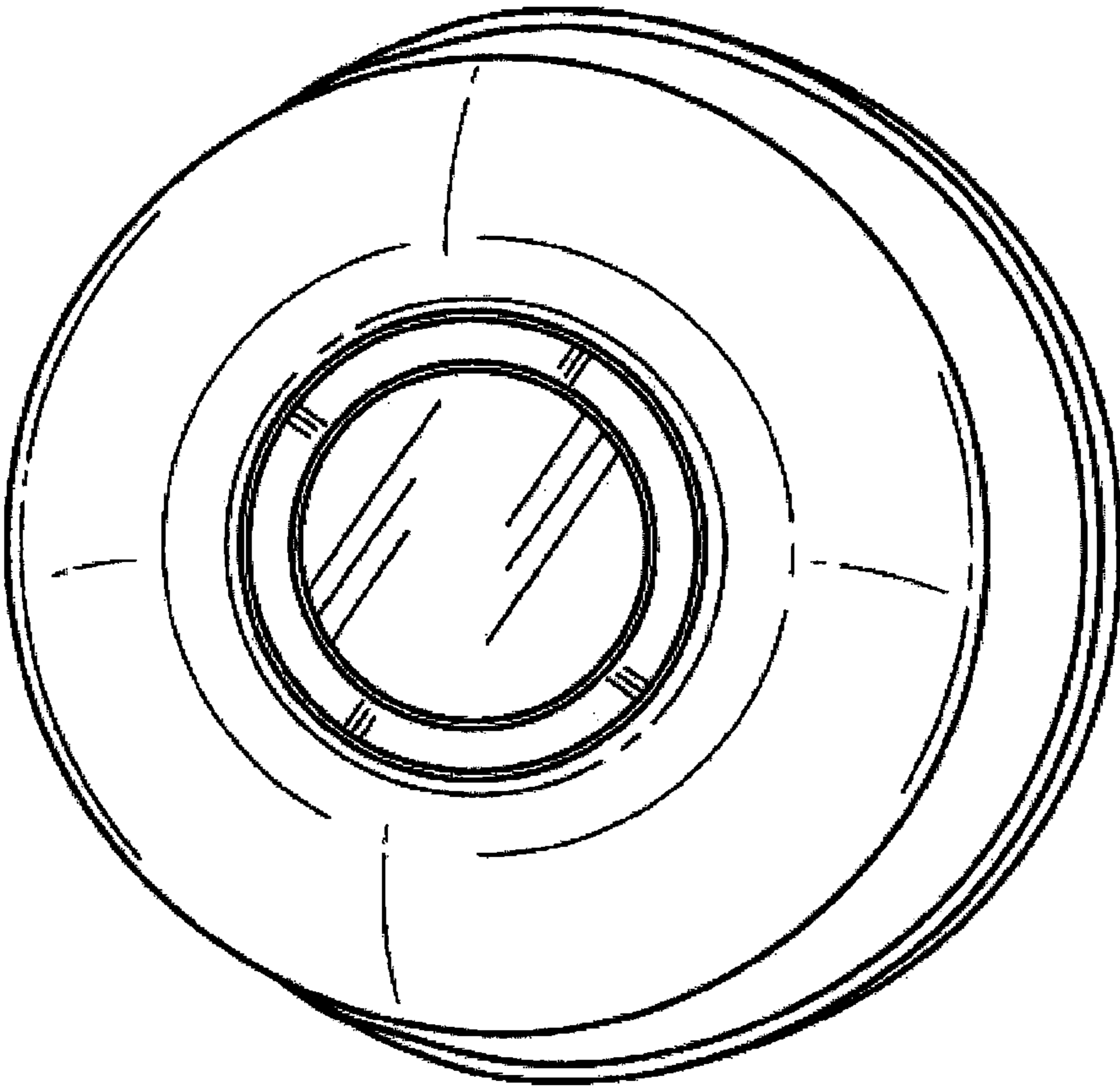

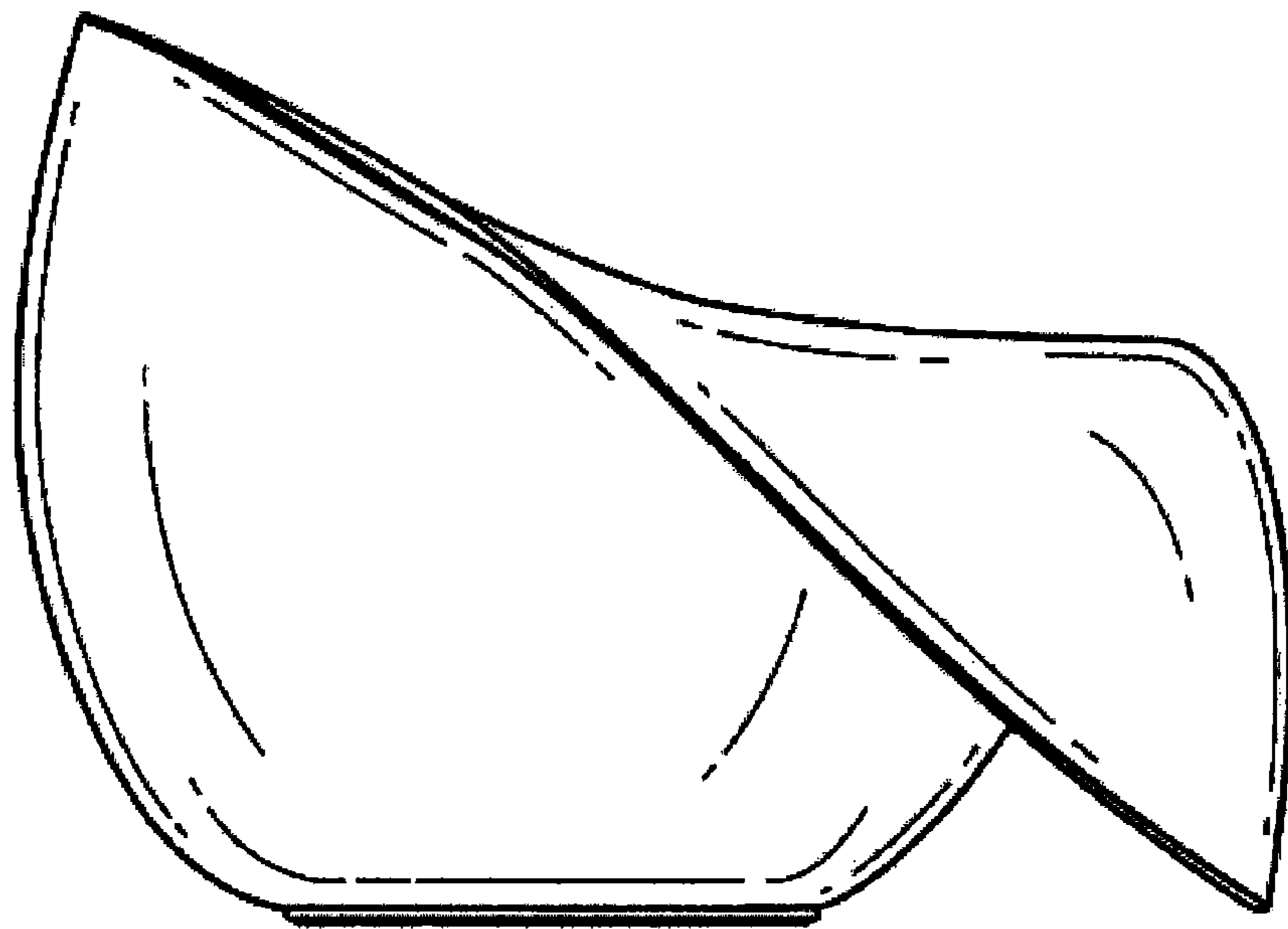

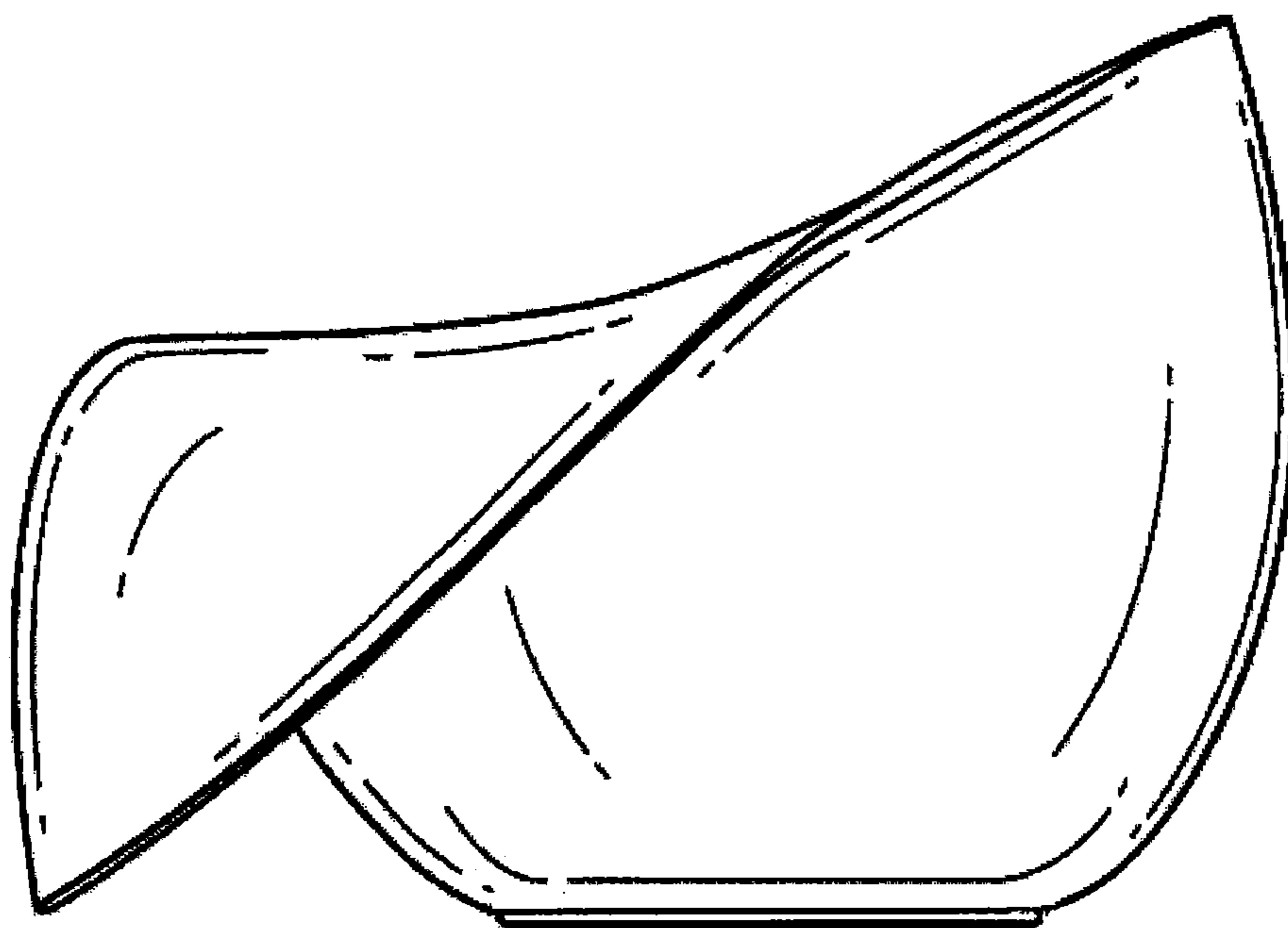

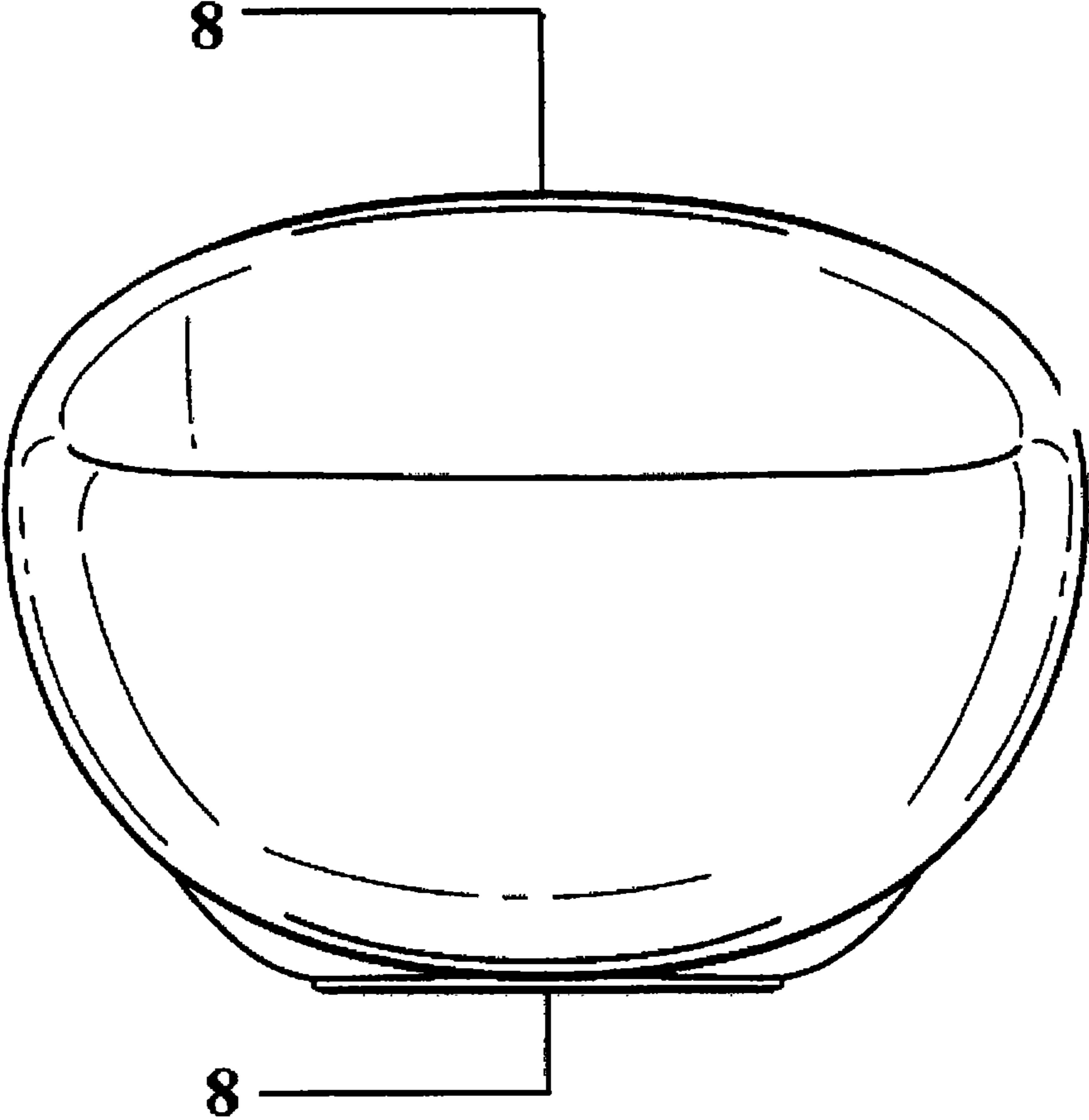

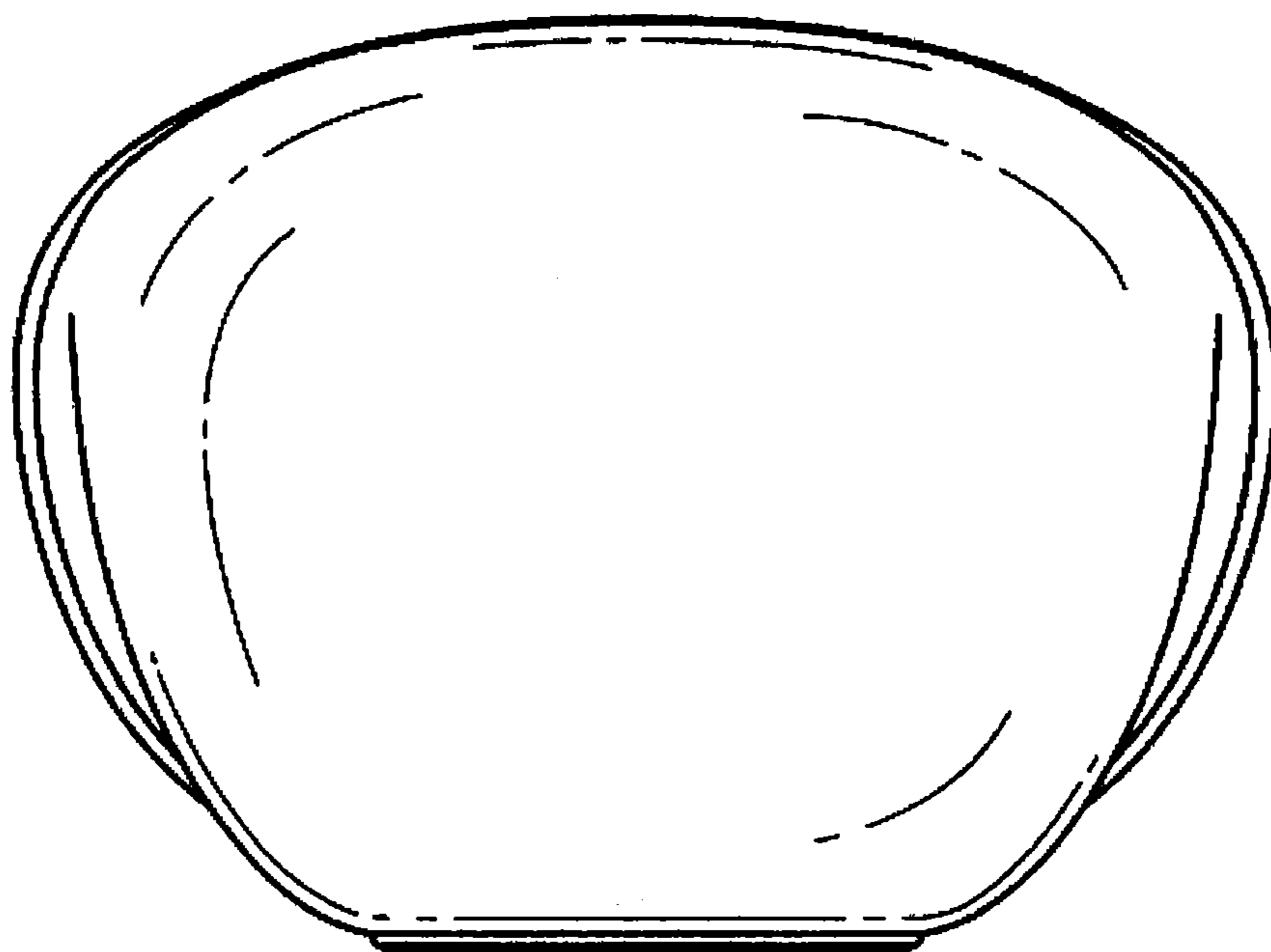

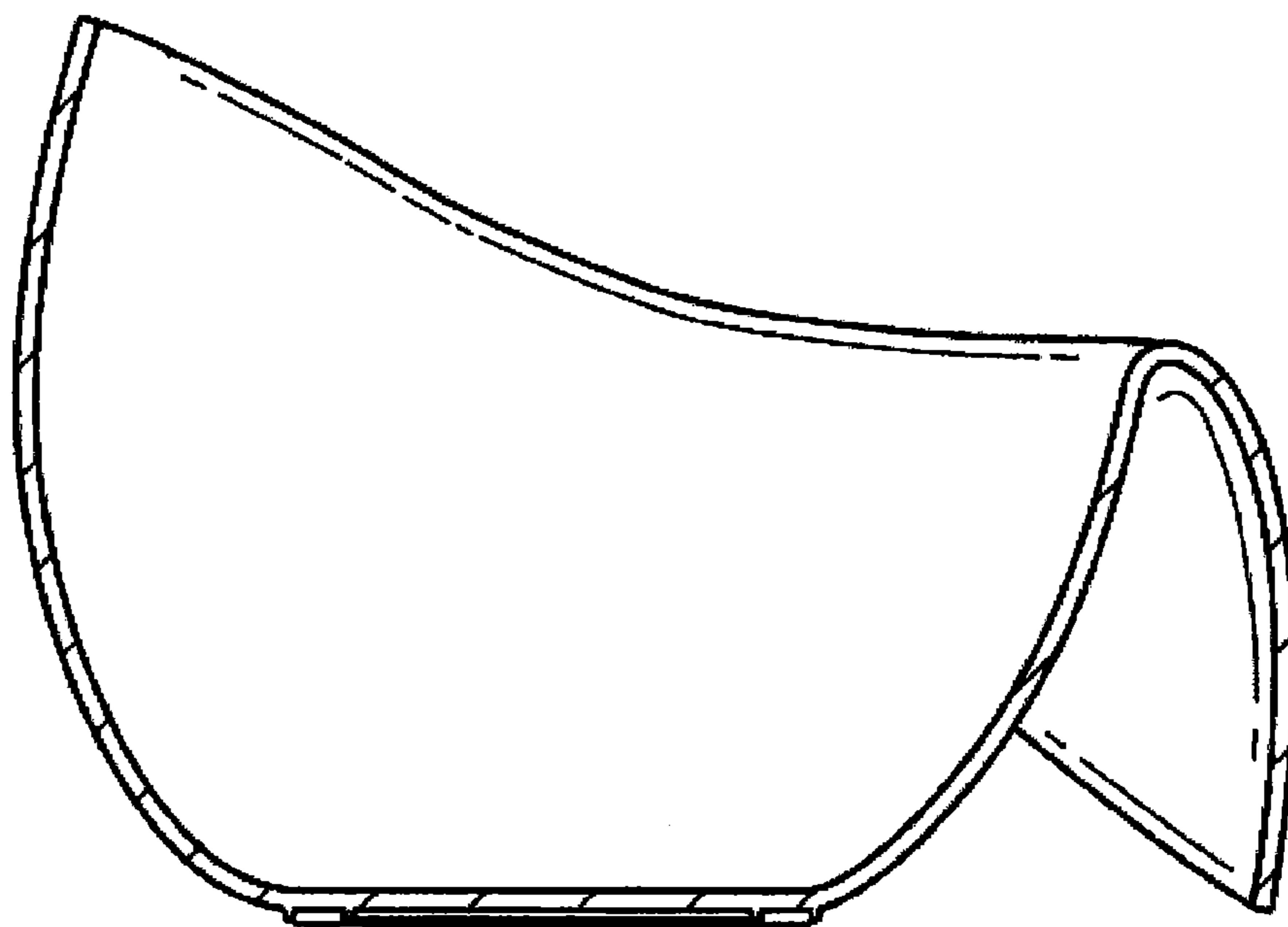
