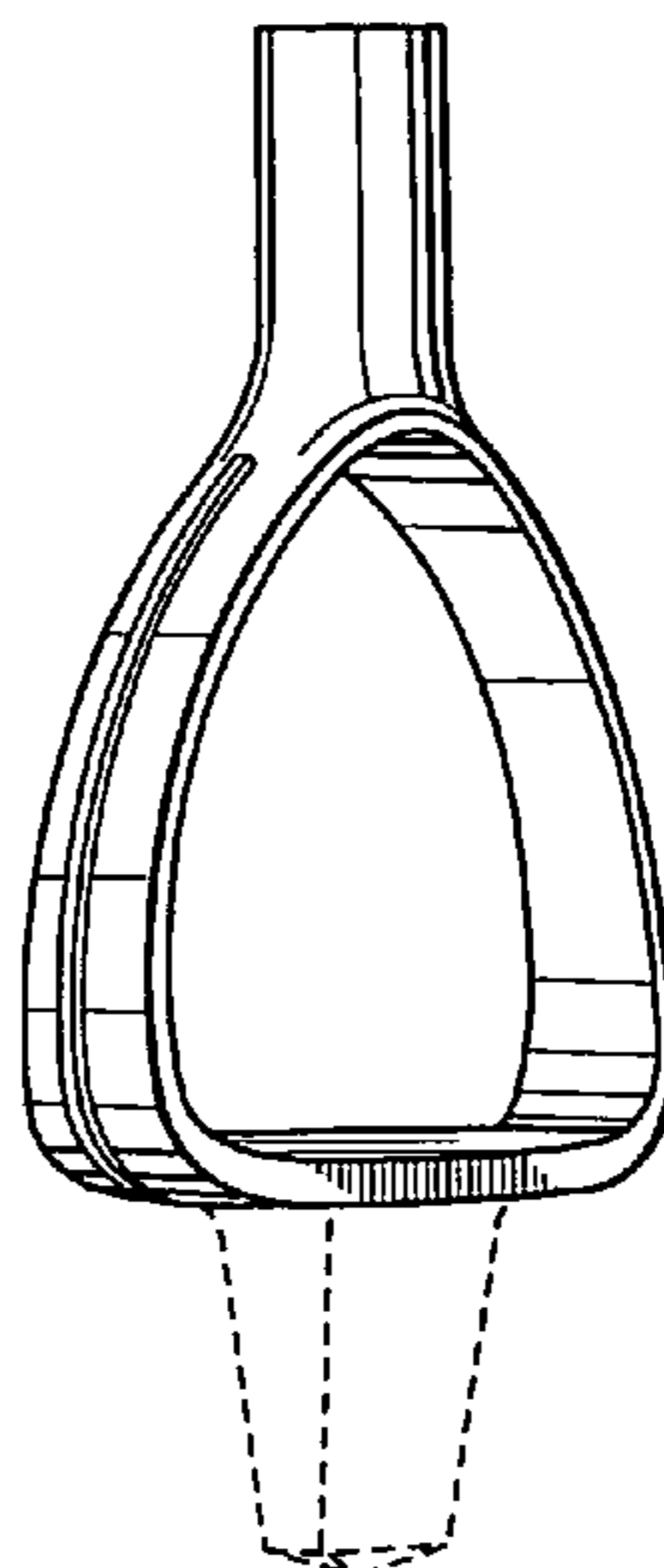

FIG. 1 is a perspective view of the planting tool showing my new design;
FIG. 2 is a front view with the rear view being a mirror image thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a right side view with the left side view being a mirror image thereof; and,
FIG. 6 is a perspective view including a handle shown in phantom view.
The broken lines showing the handle and plunger show portions of the article and form no part of the claimed design.

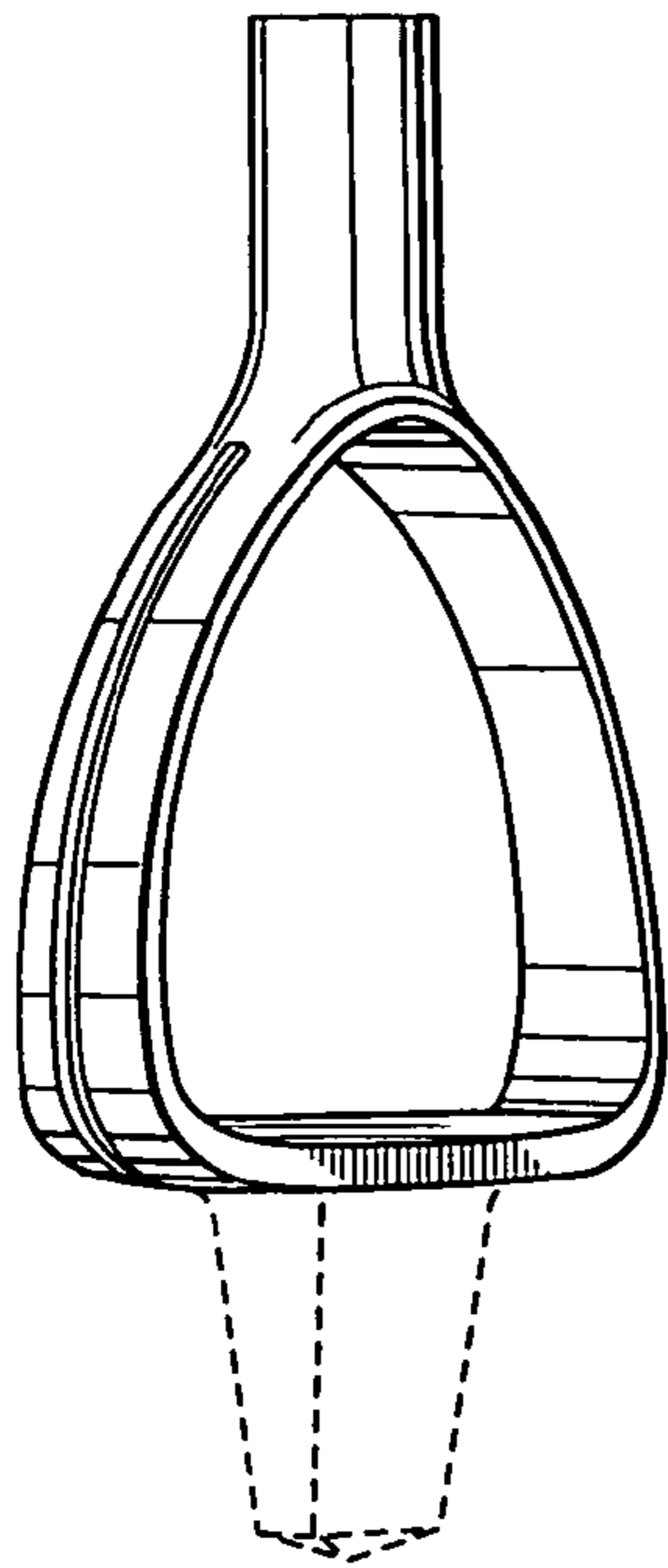

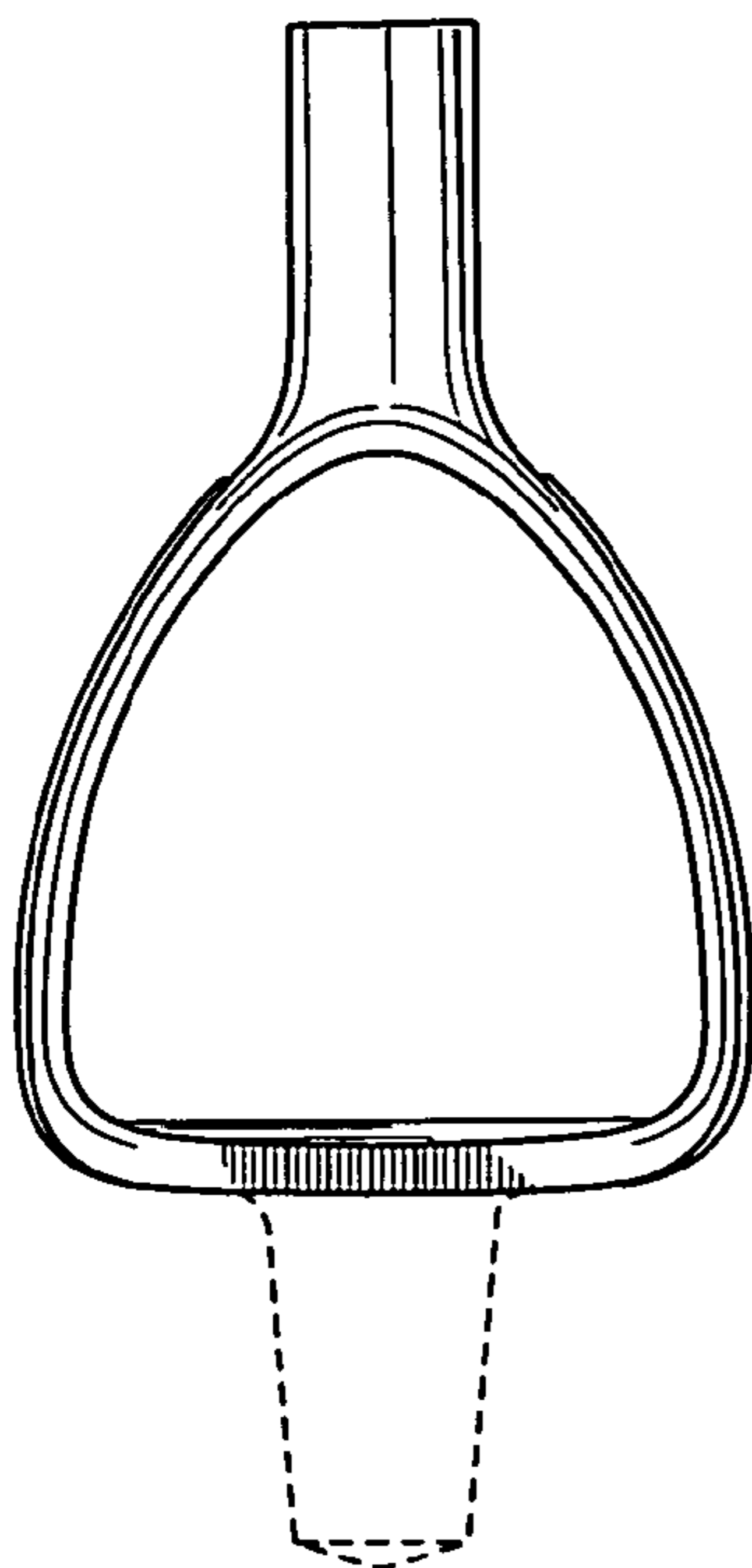

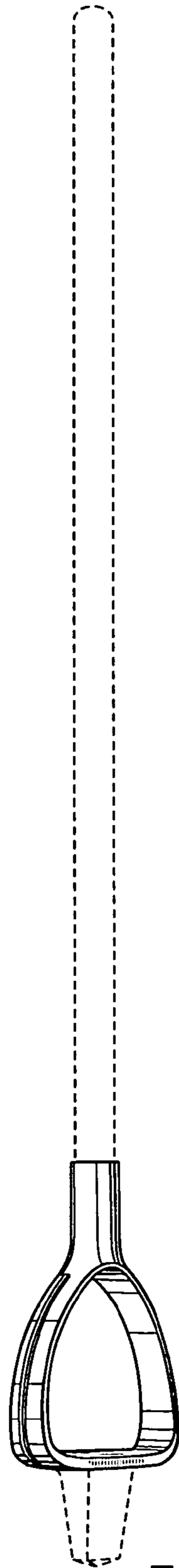

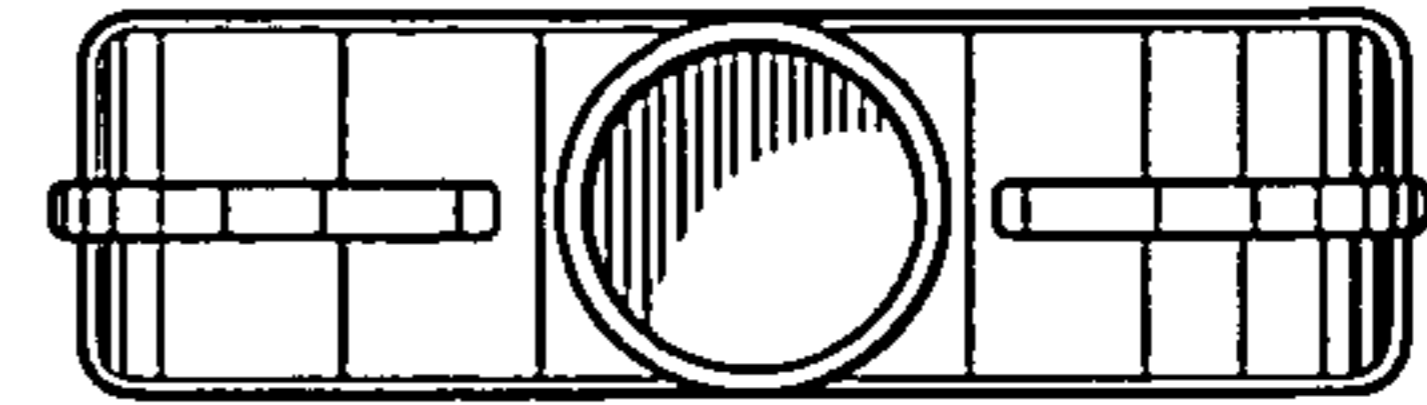

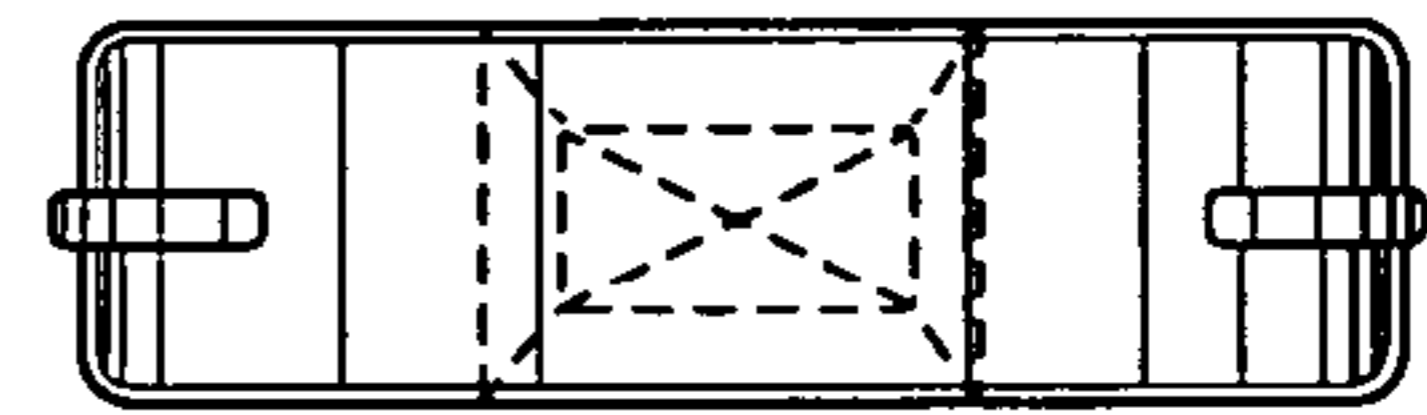

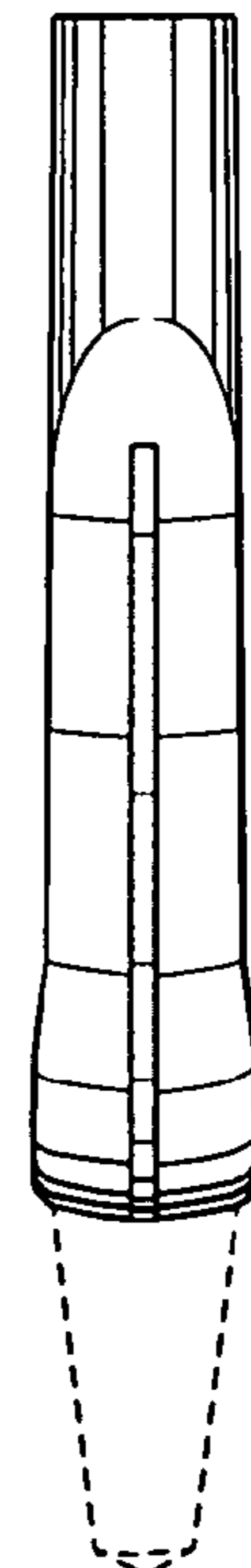
